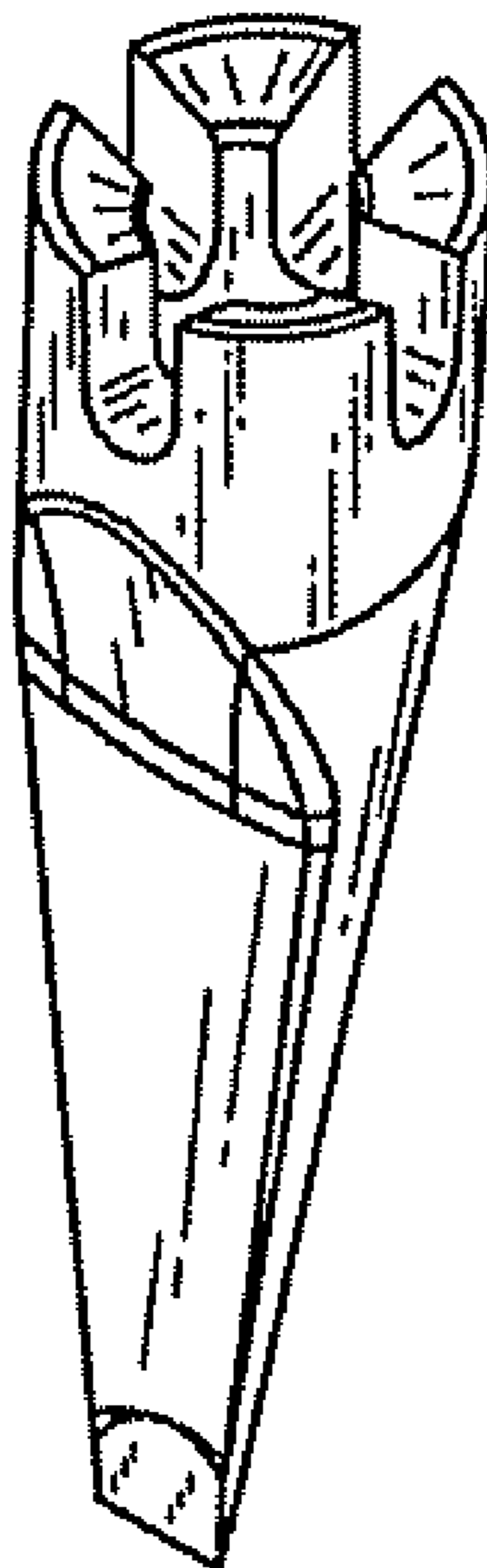
The broken line shown in FIG. 4 is included for the purpose of illustrating a portion of the golf tee that forms no part of the claimed design.

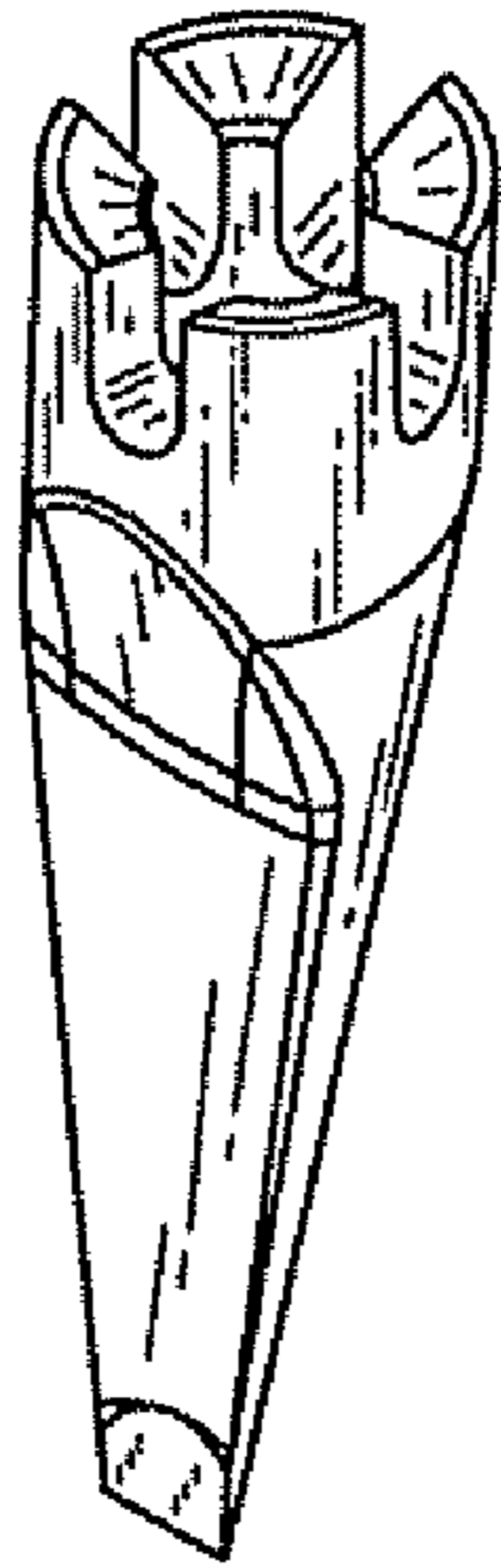

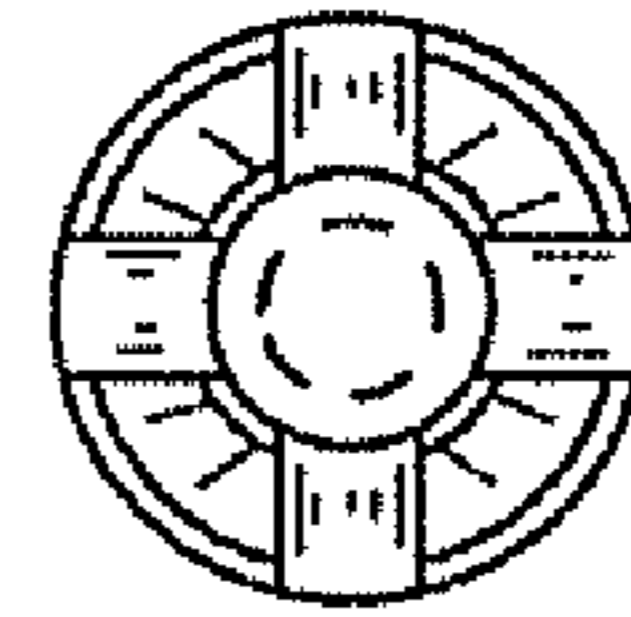

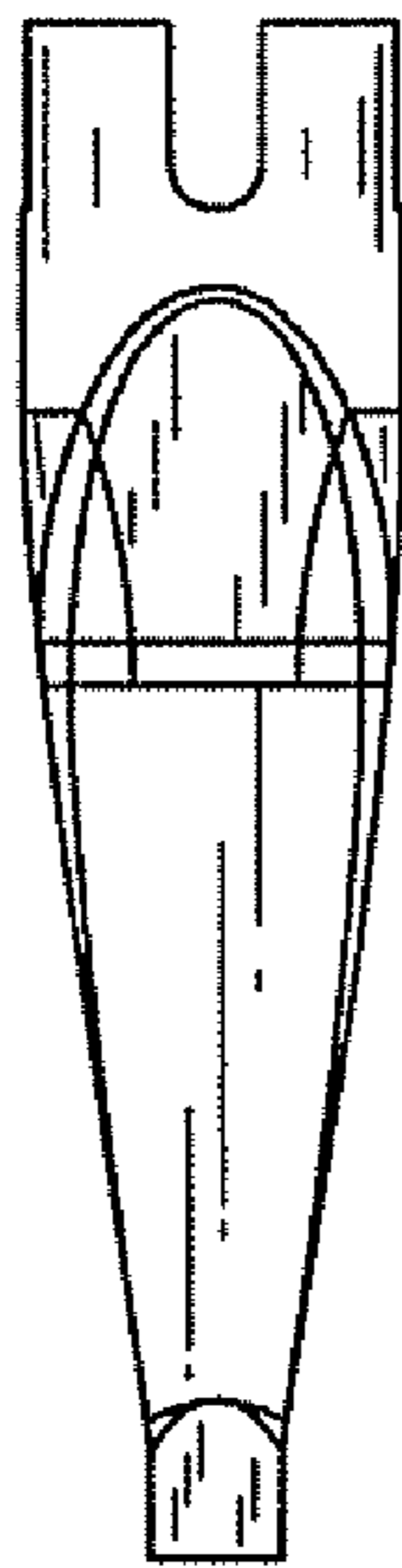

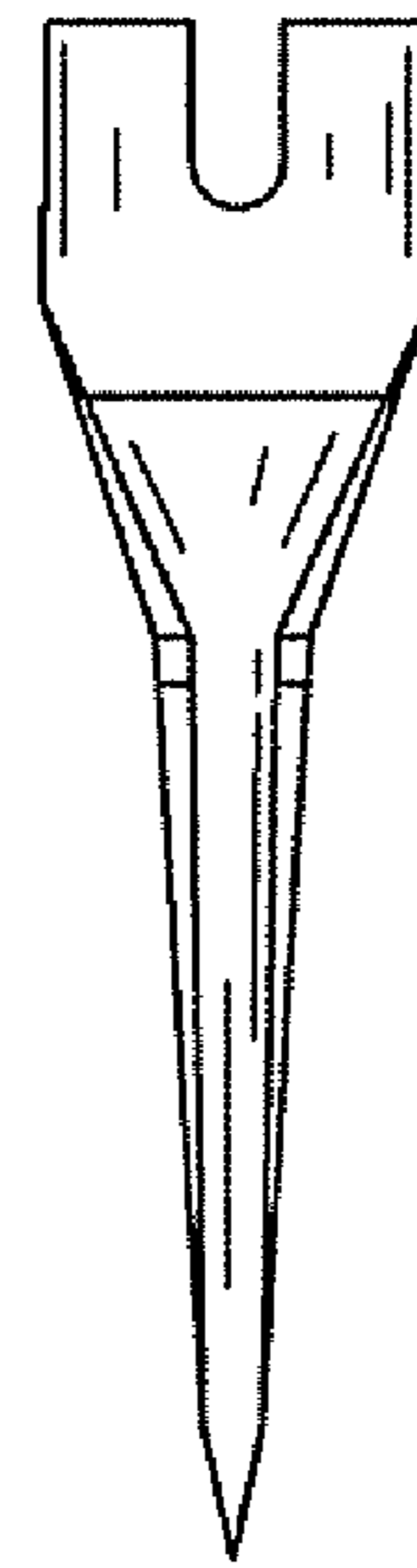

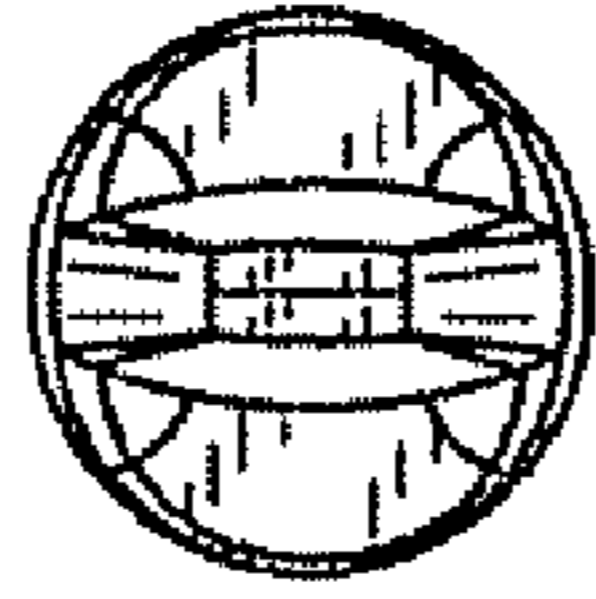

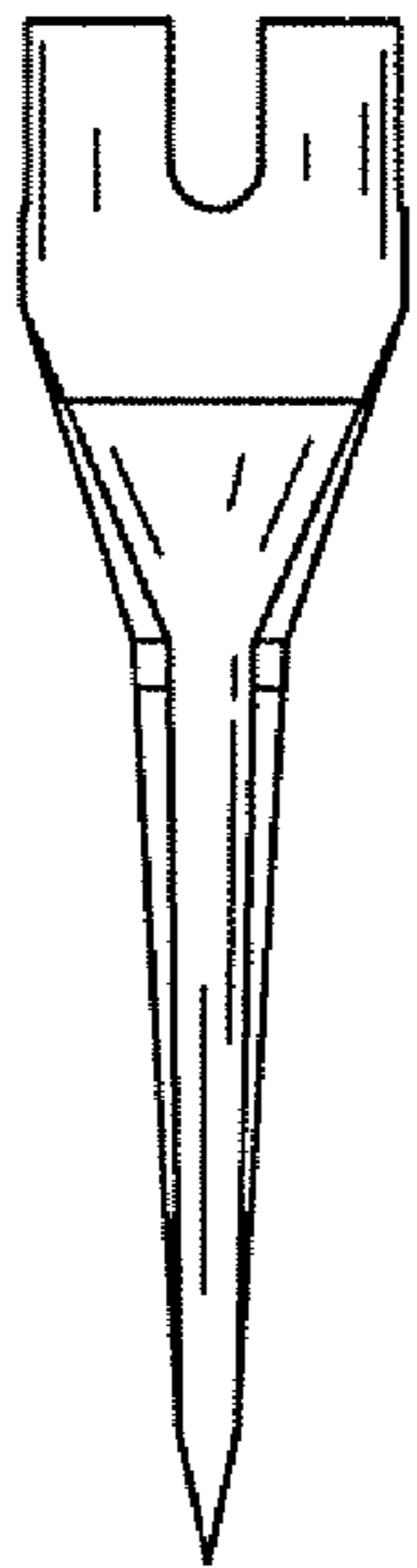

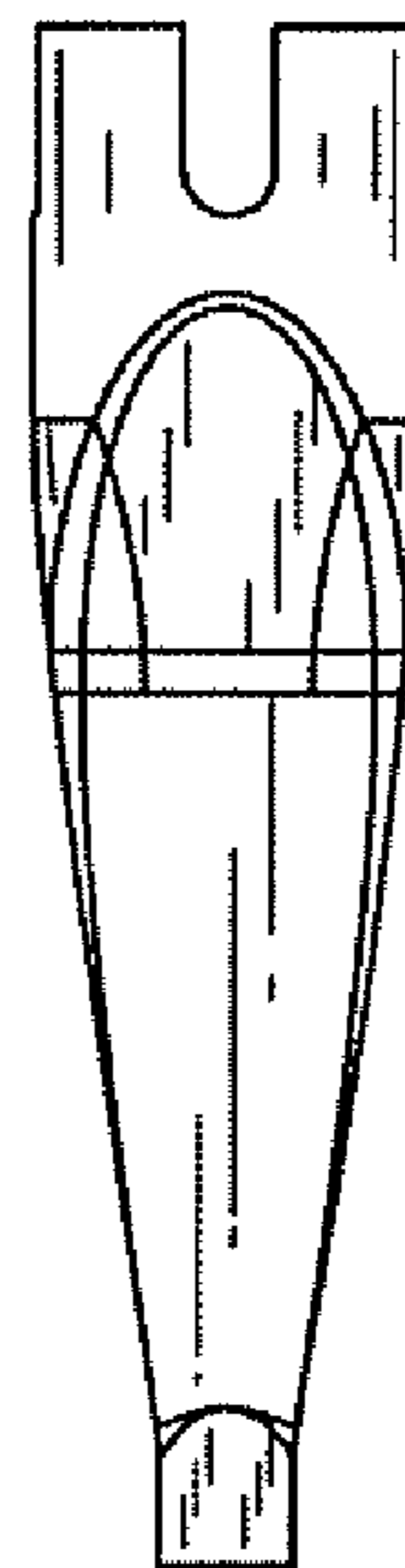
