FIG. 4 is an elevation view of the right side thereof;

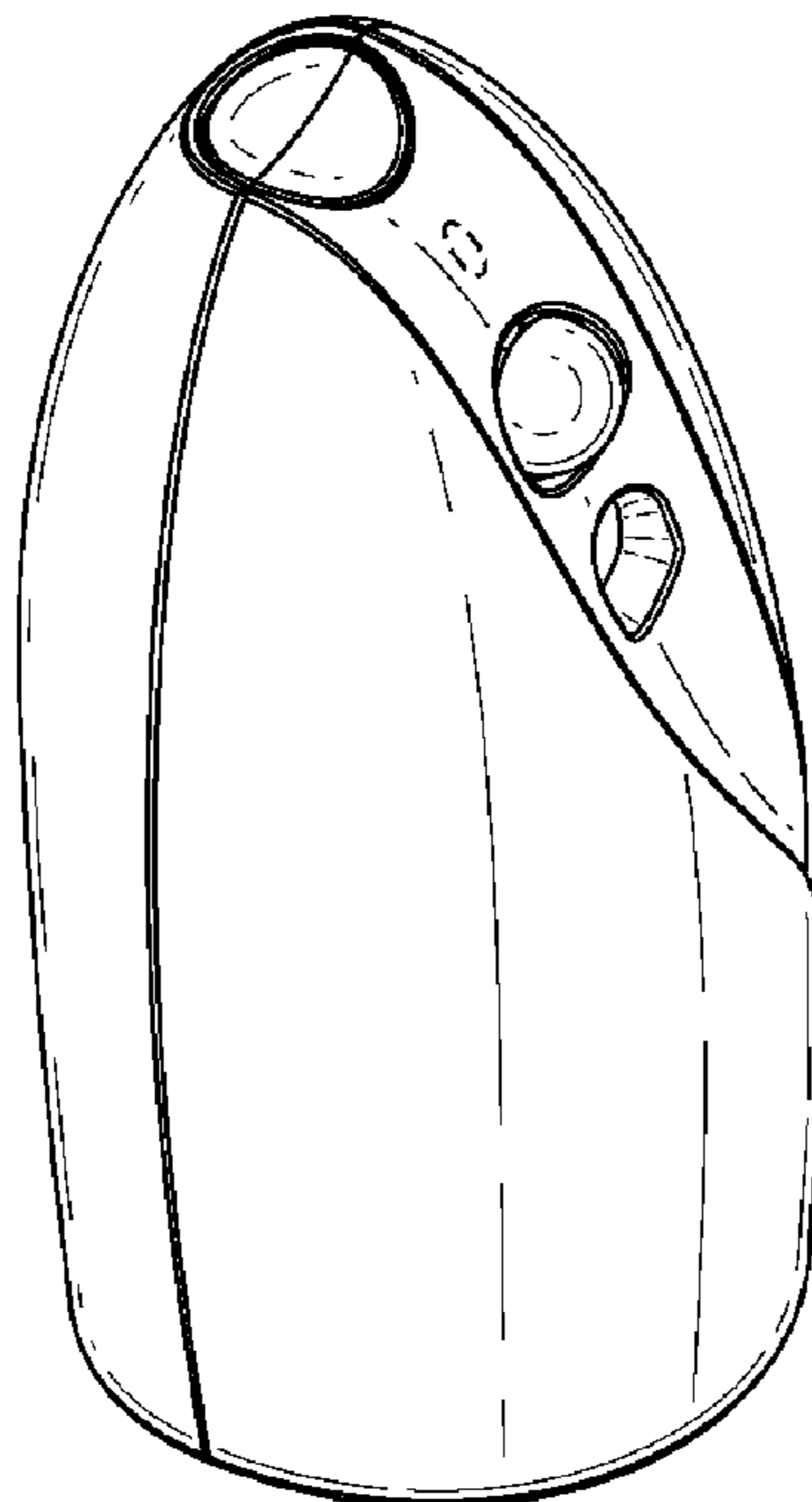
FIG. 5 is an elevation view of the left side thereof;

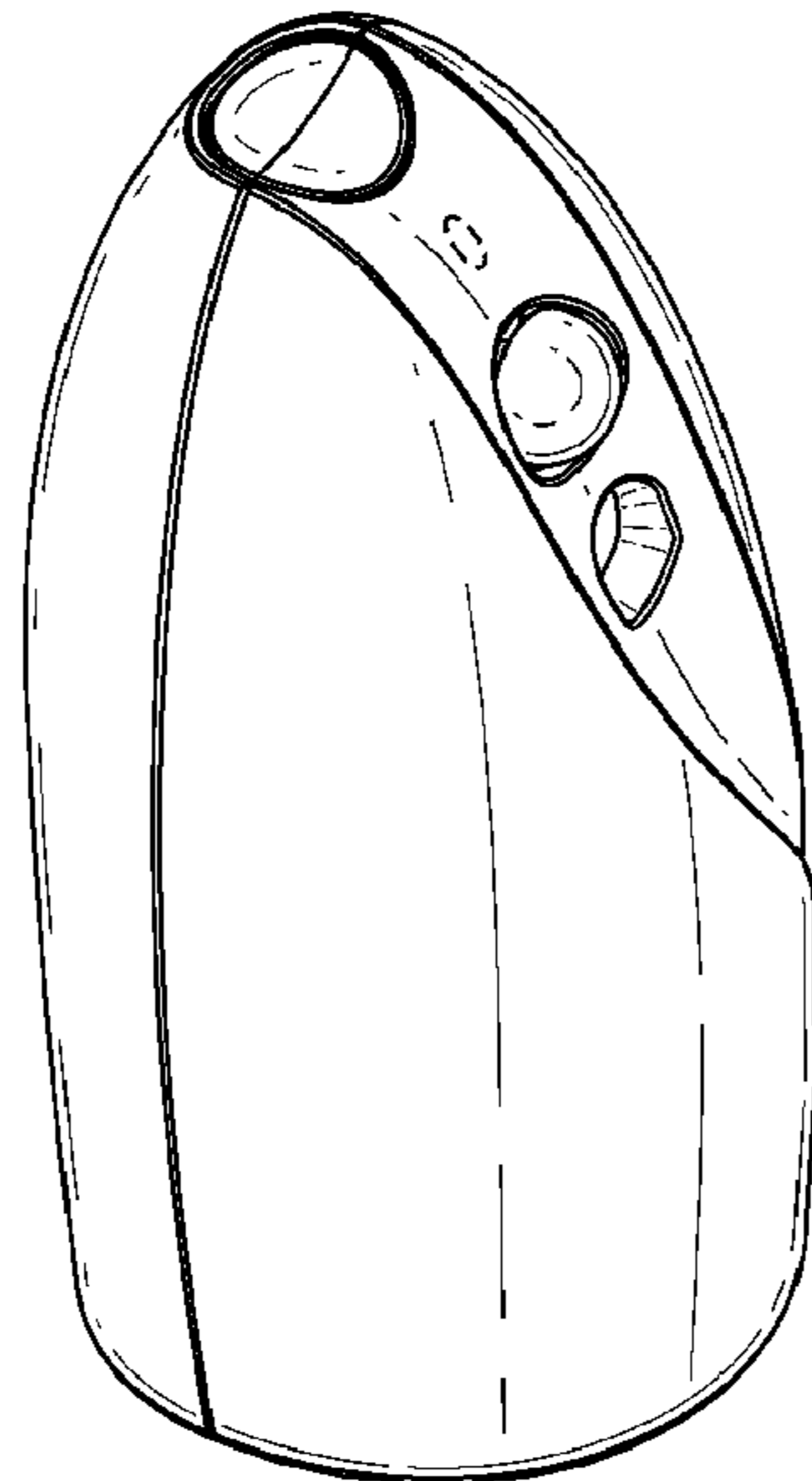

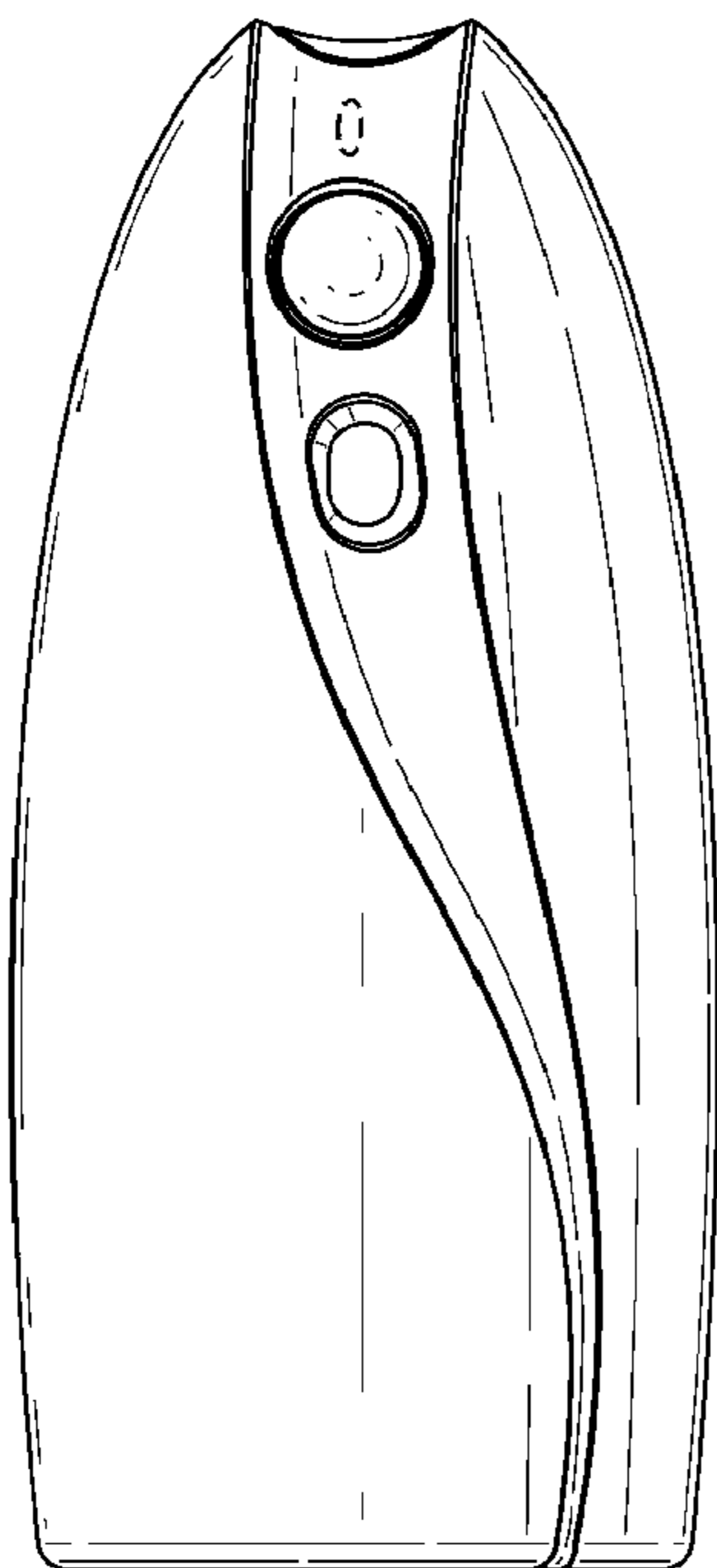

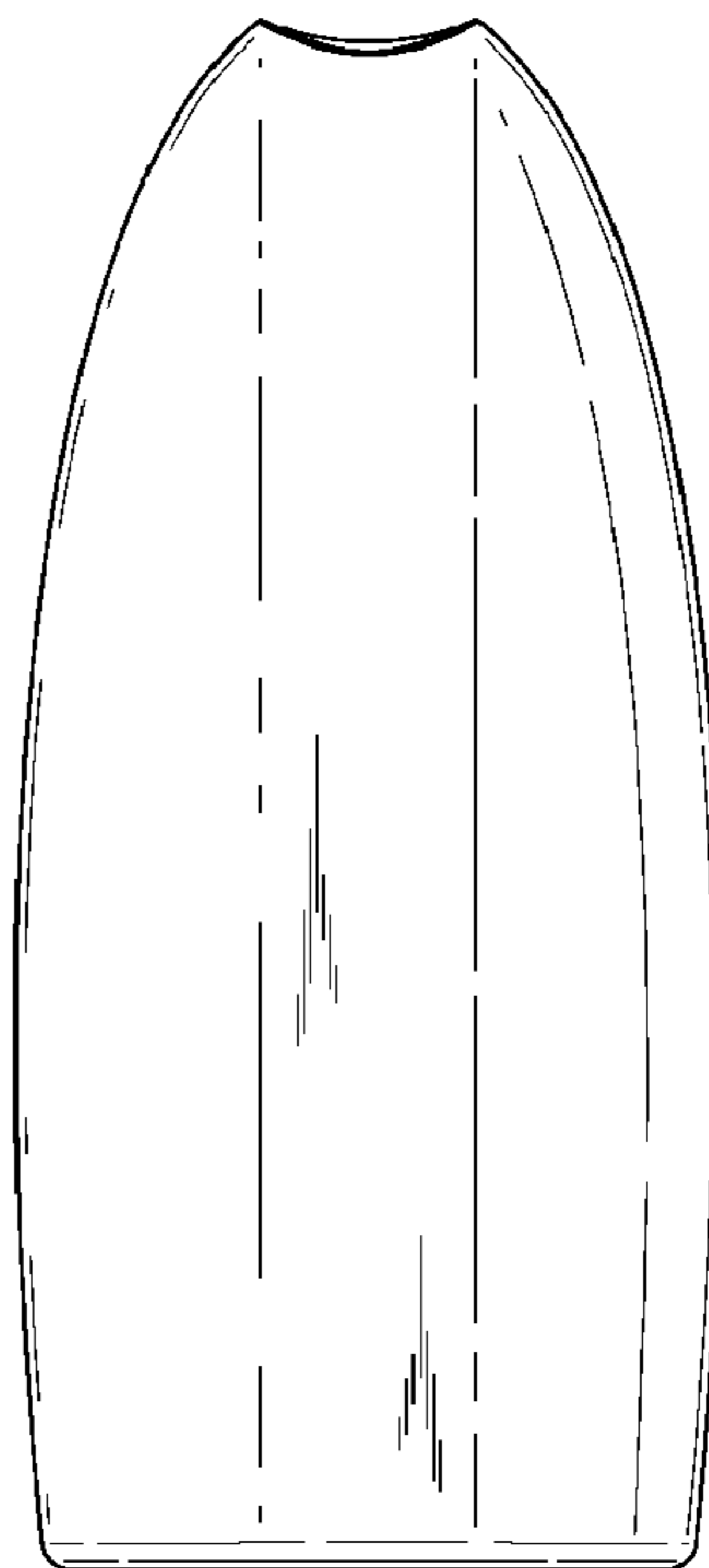

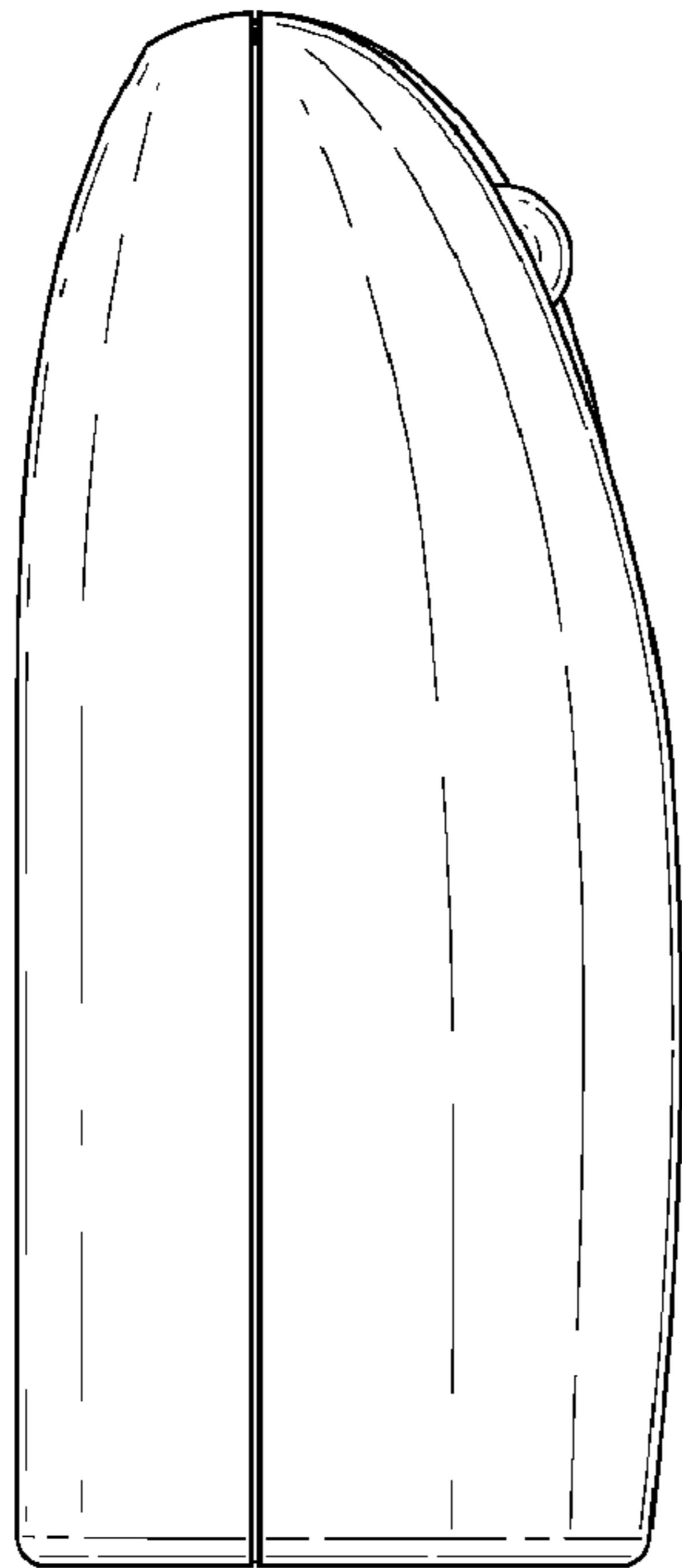

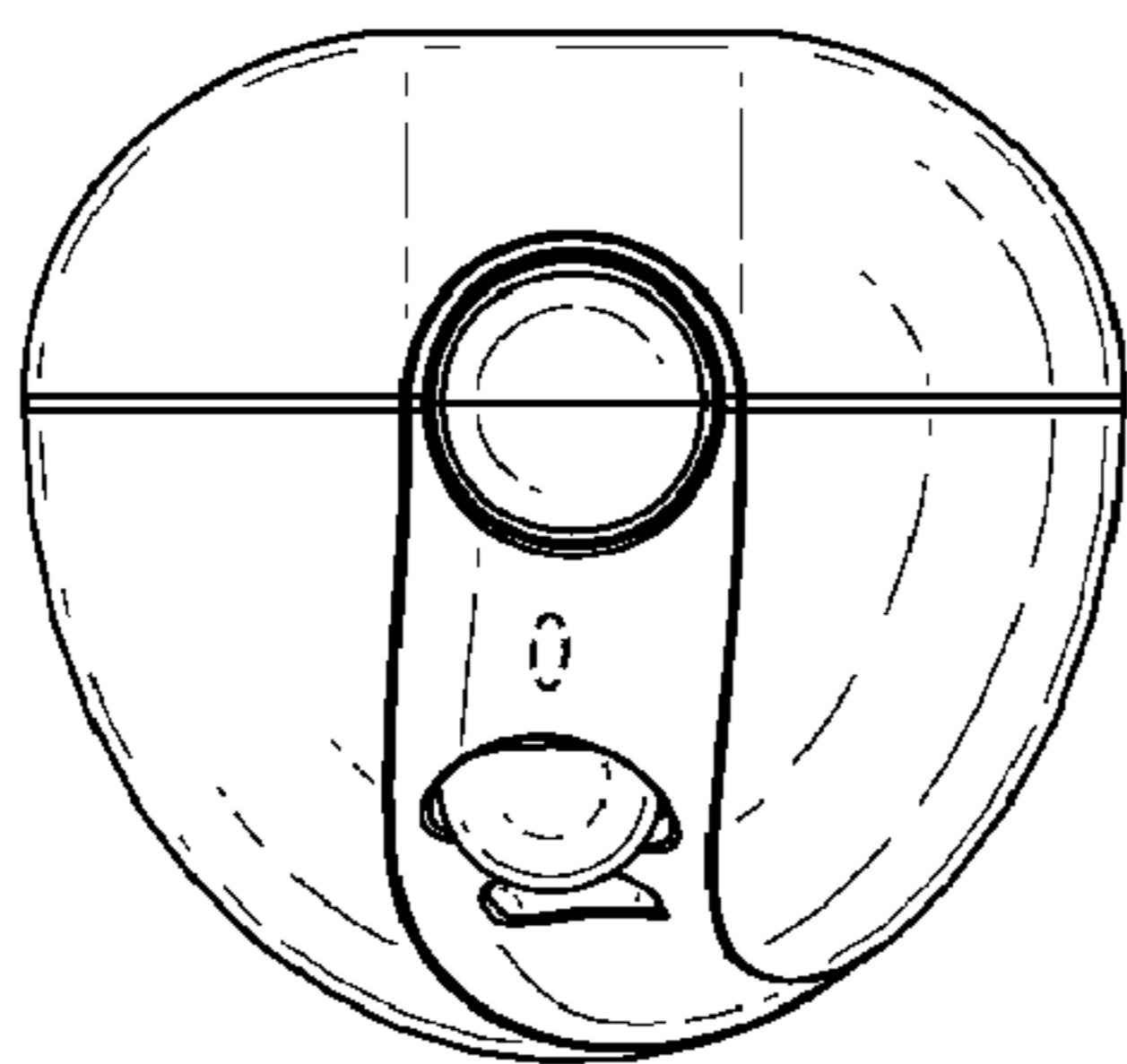

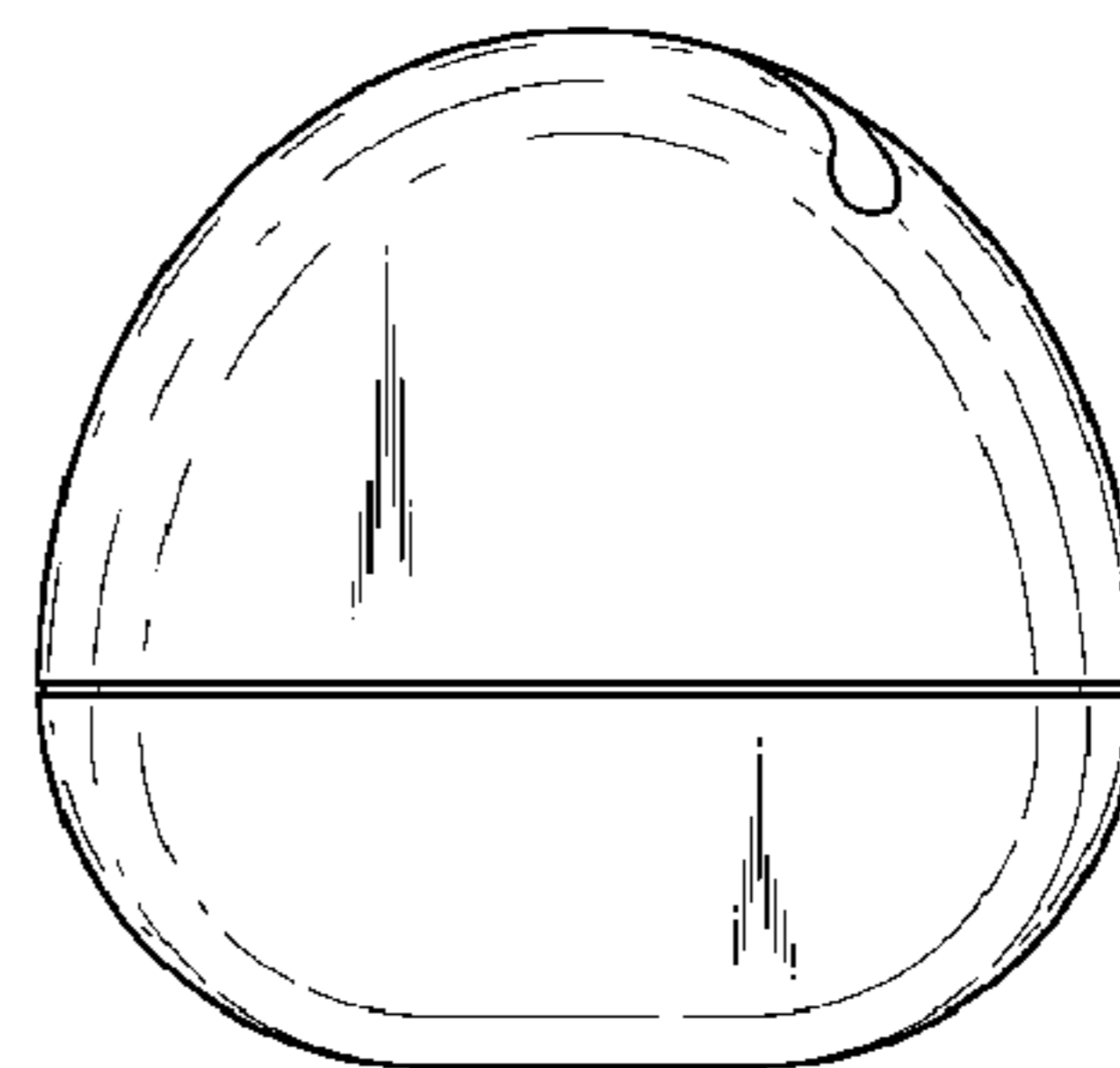
