invention; and,

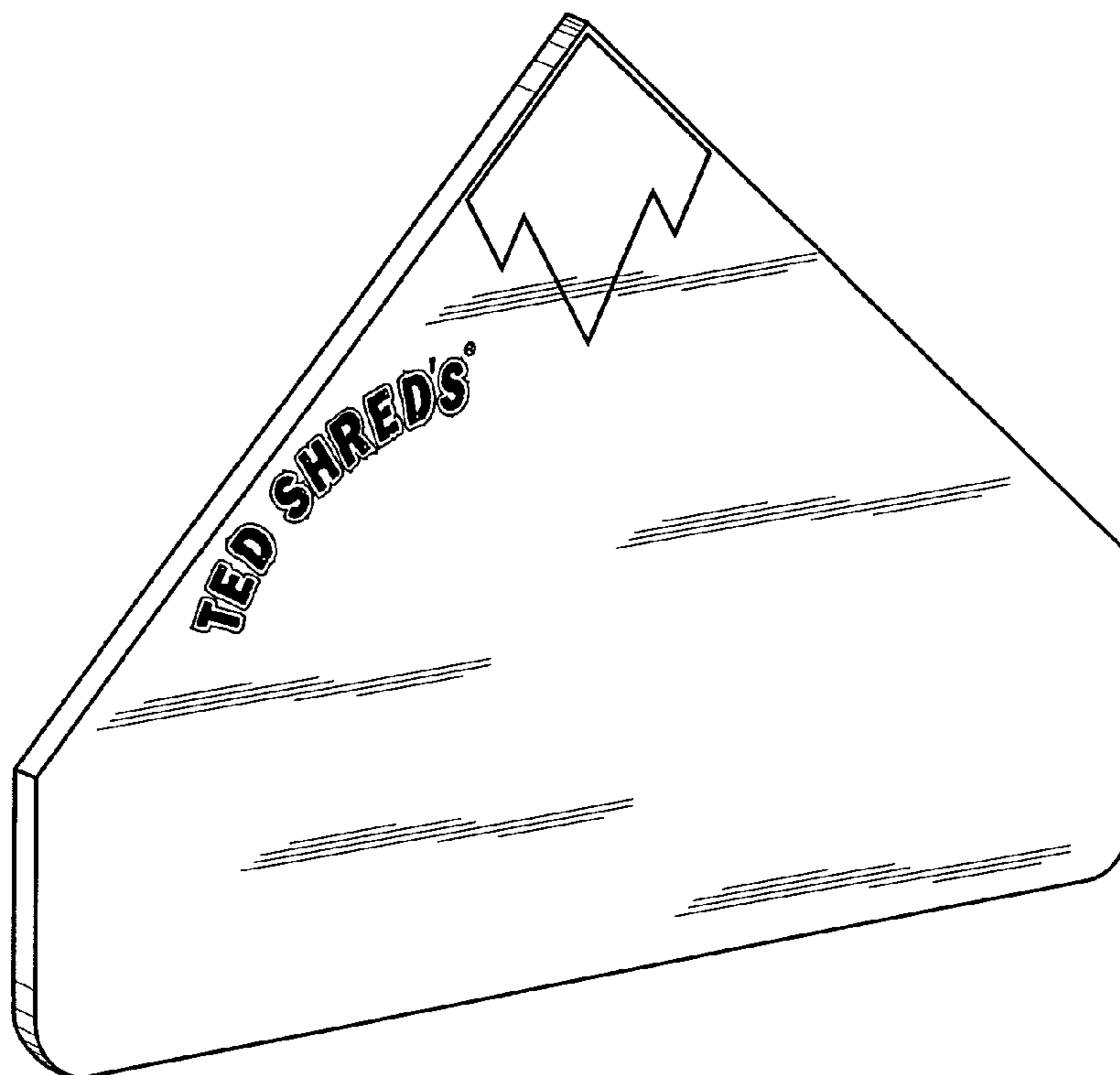
FIG. 7 is a bottom plan view of the air freshener of the present

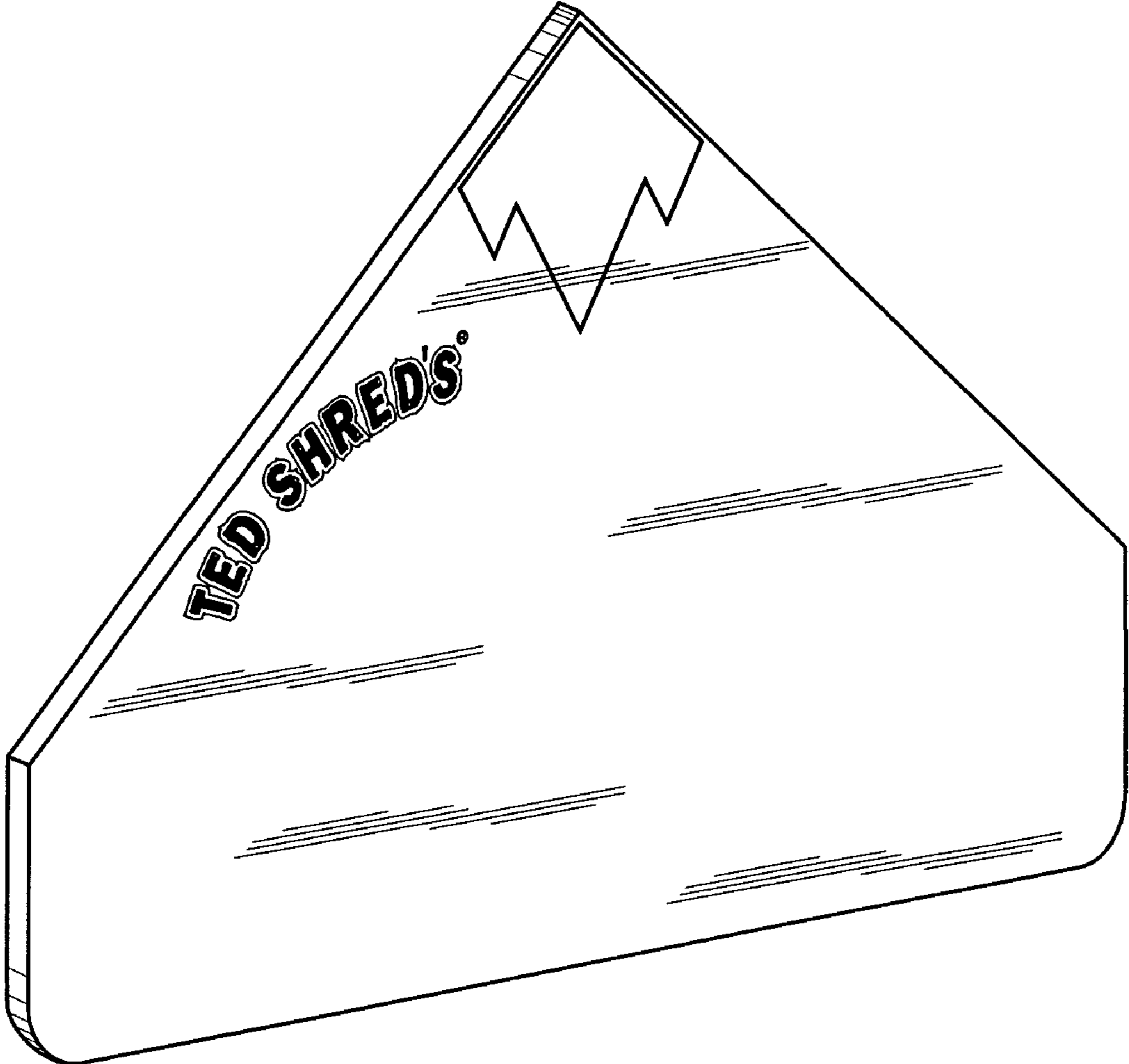

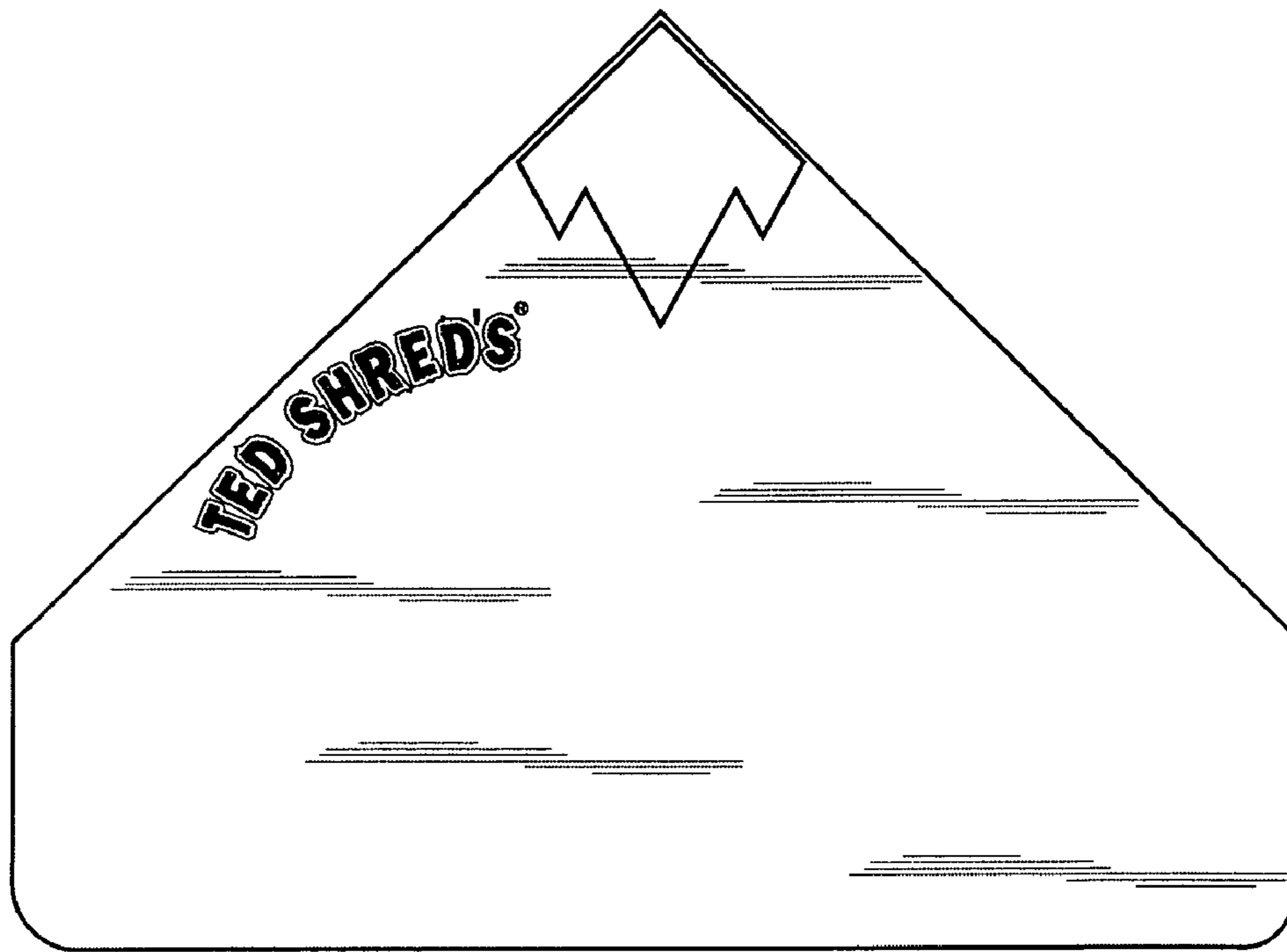

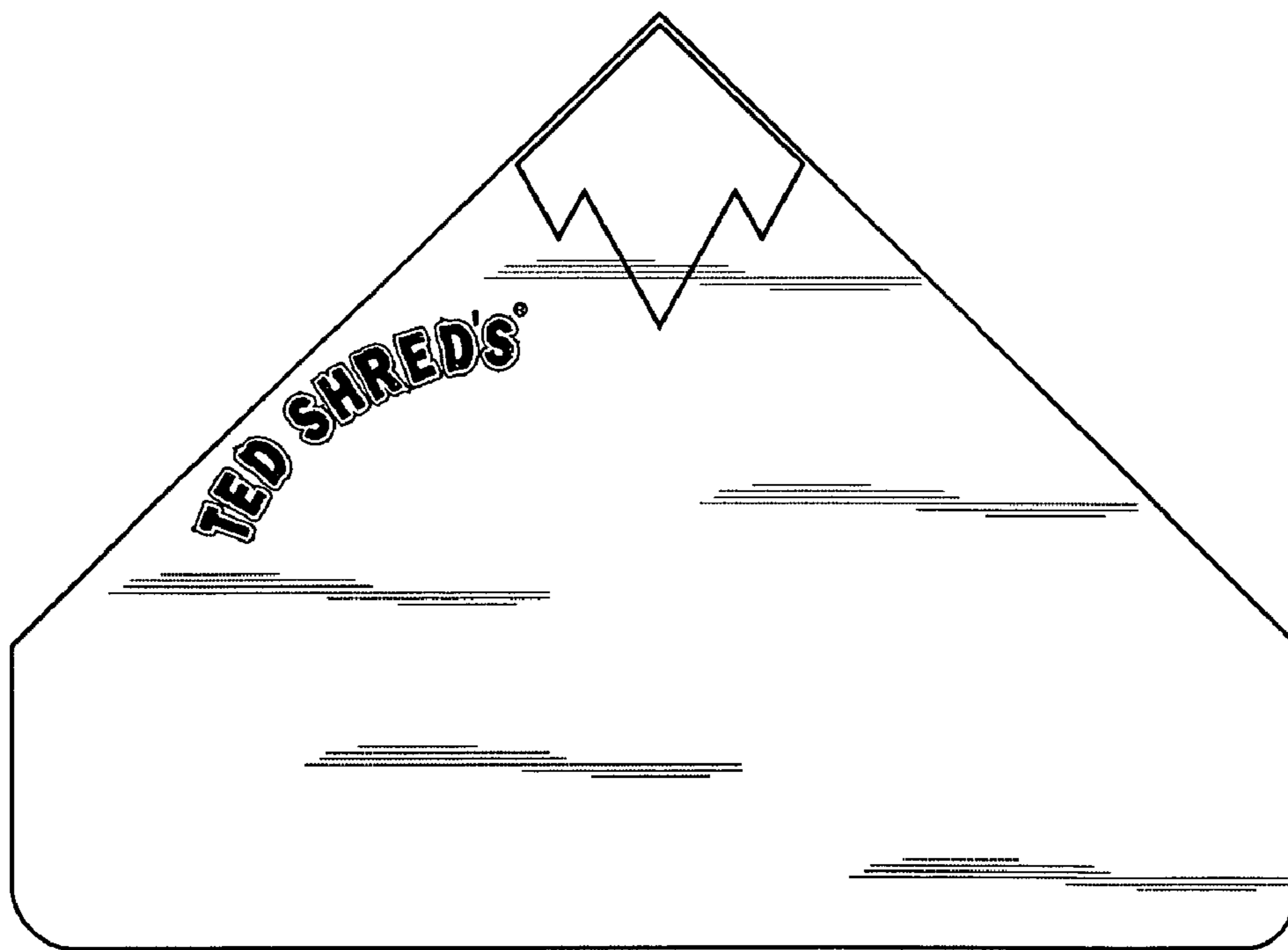
