DESCRIPTION

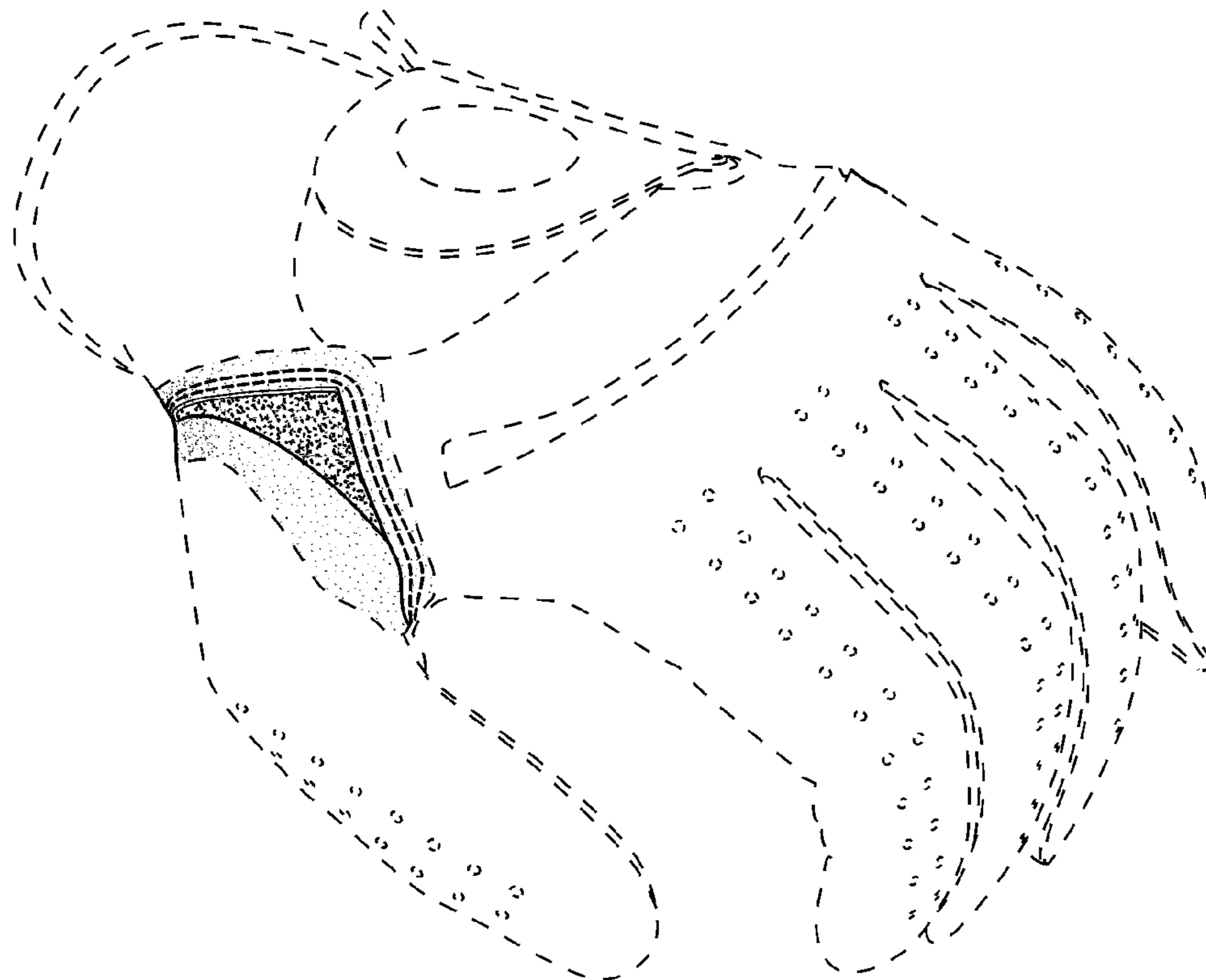
FIG. 1 is a perspective view of the back portion of the glove.

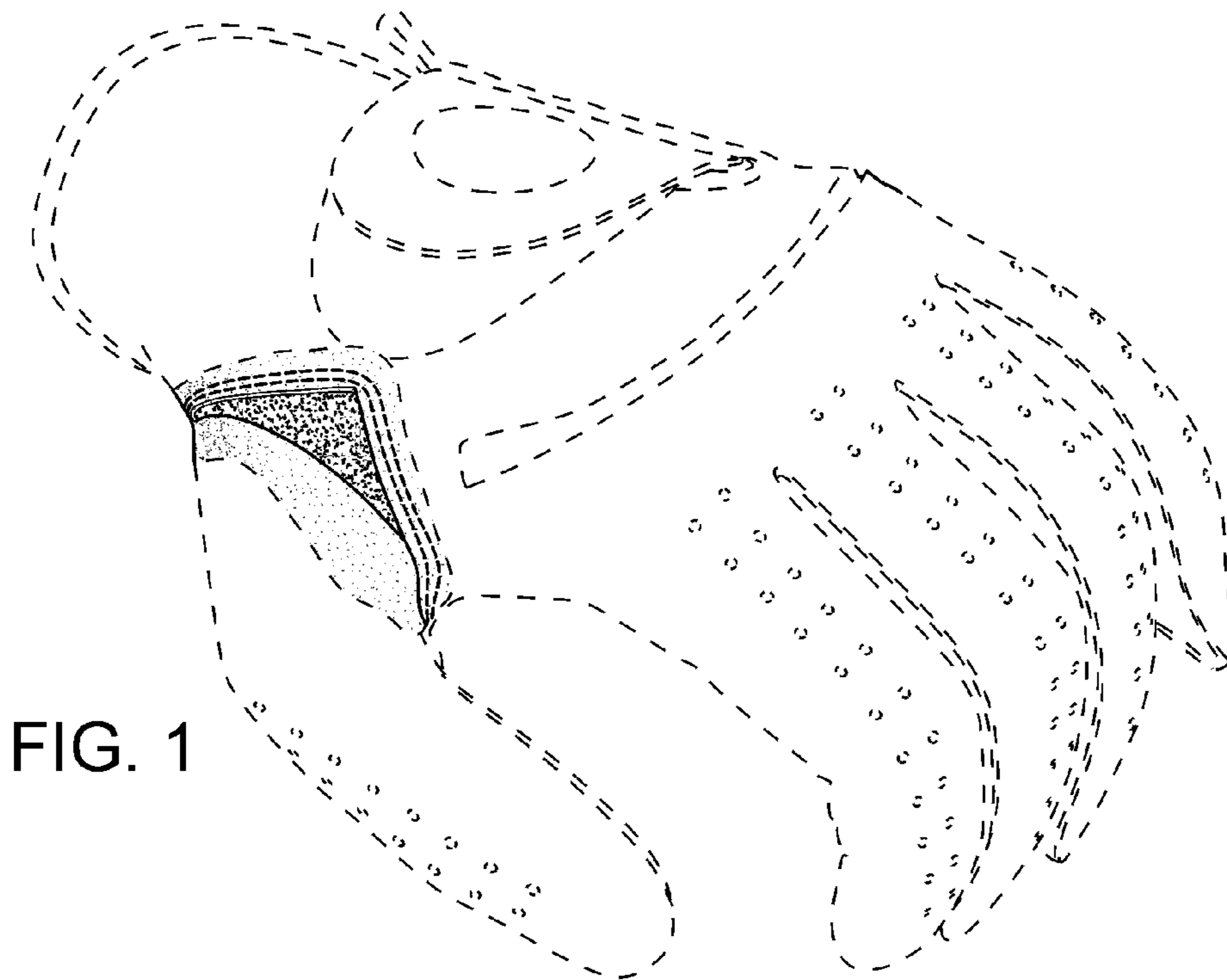

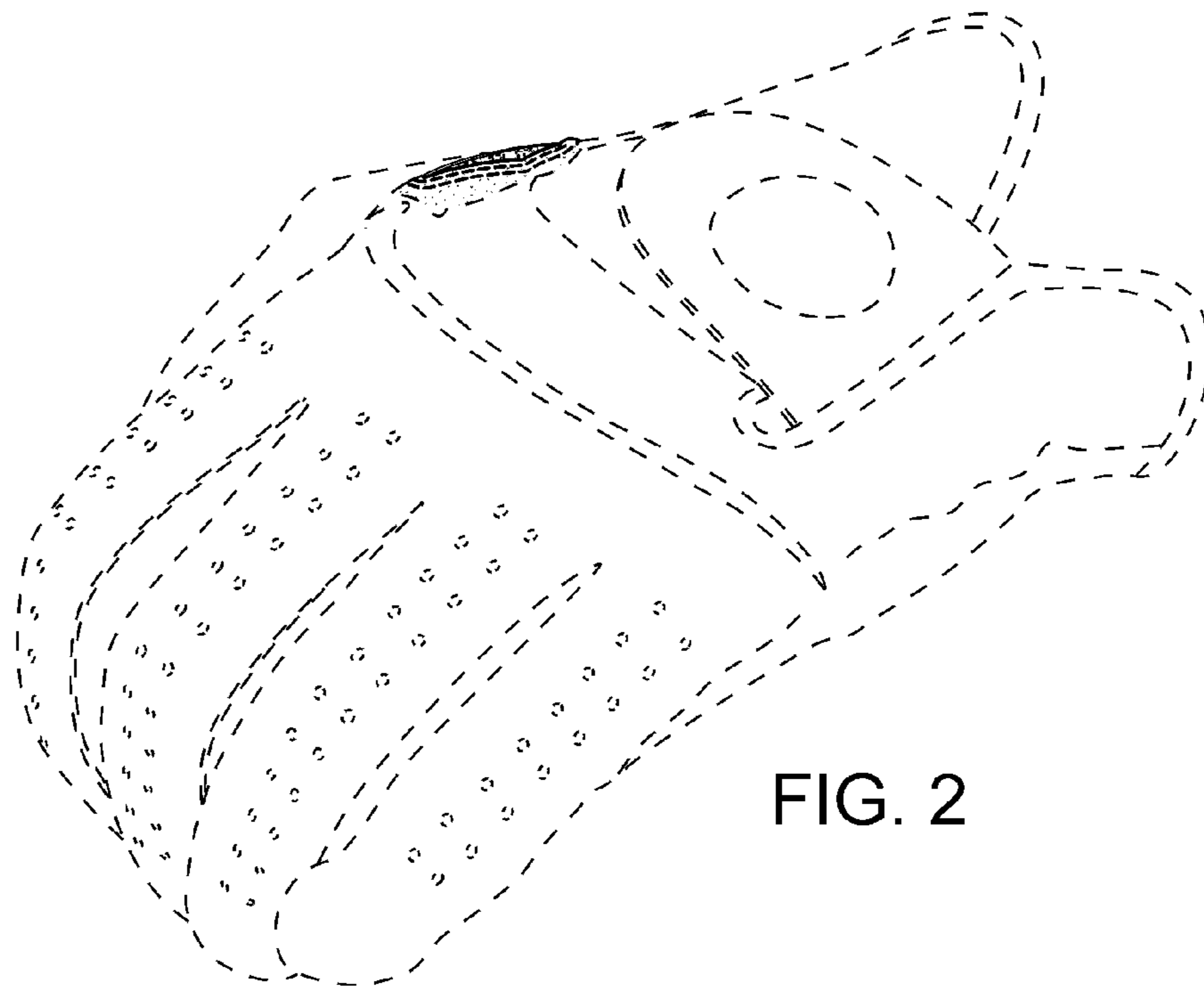

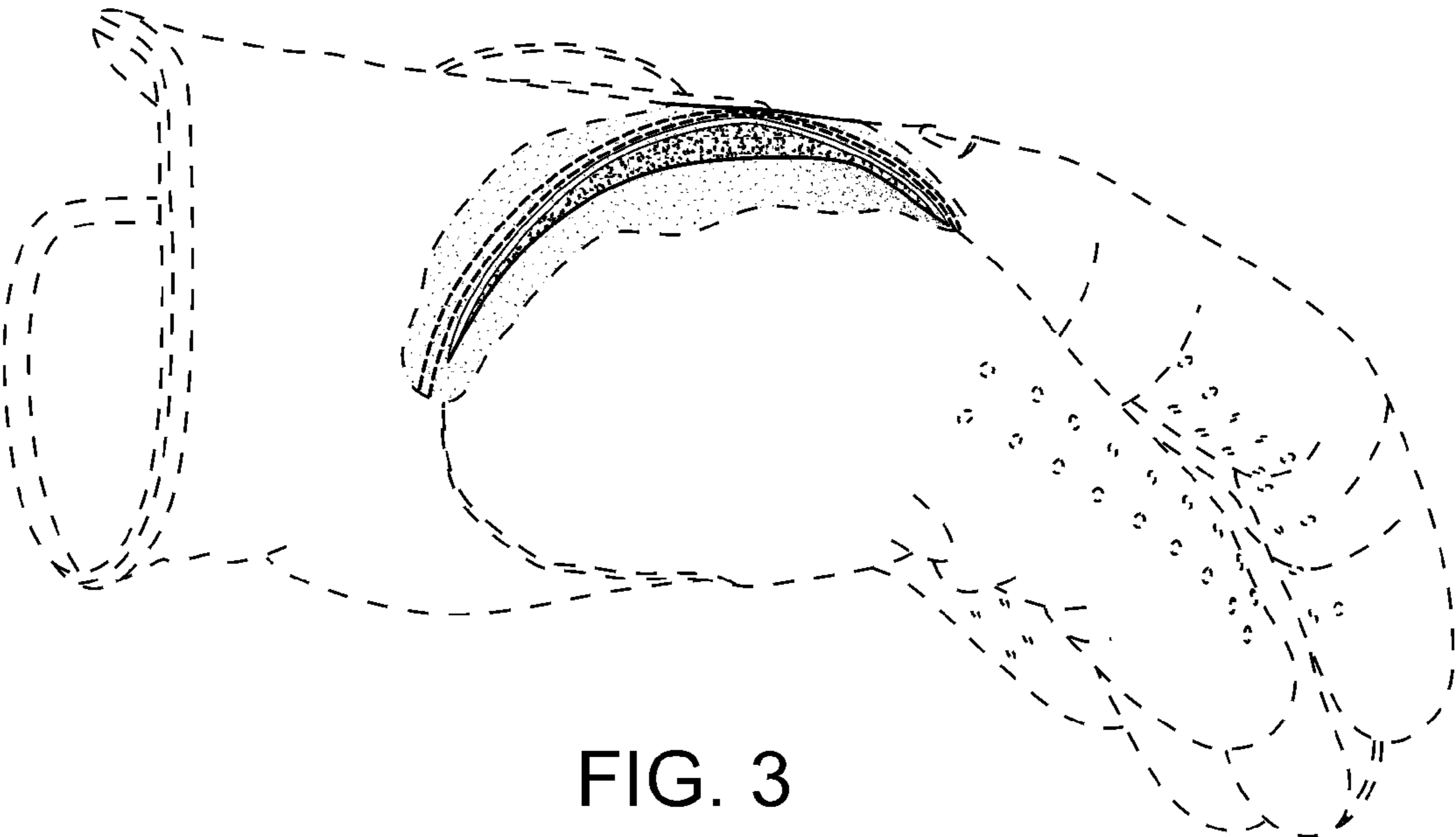
