The ornamental design for a pair of sport shin-guards, as shown and described.

**DESCRIPTION**

FIG. 2 is a rear perspective view of the pair of sport shin-guards (left and right shin-guards, respectively, which are in slightly different perspective positions);

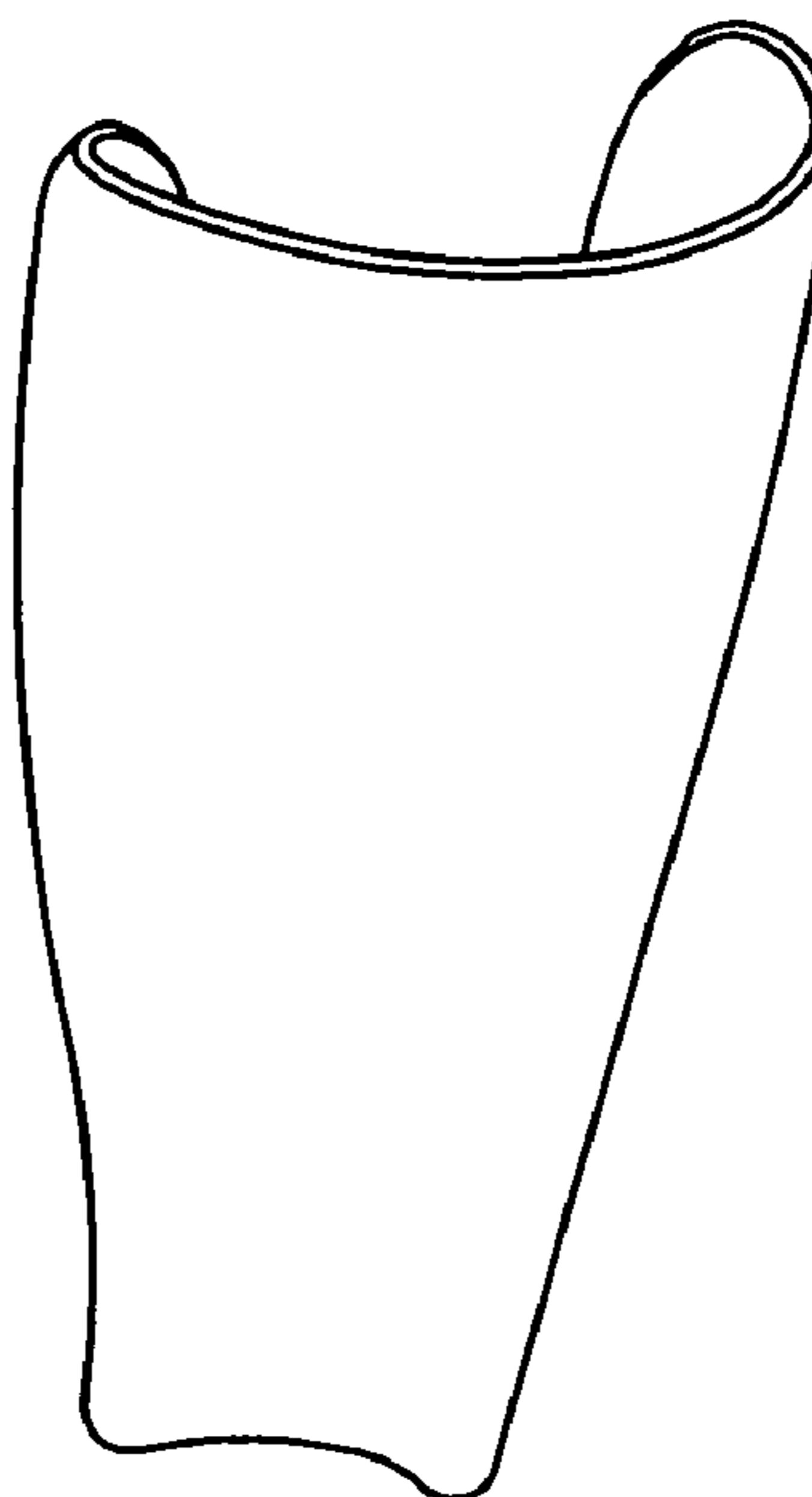
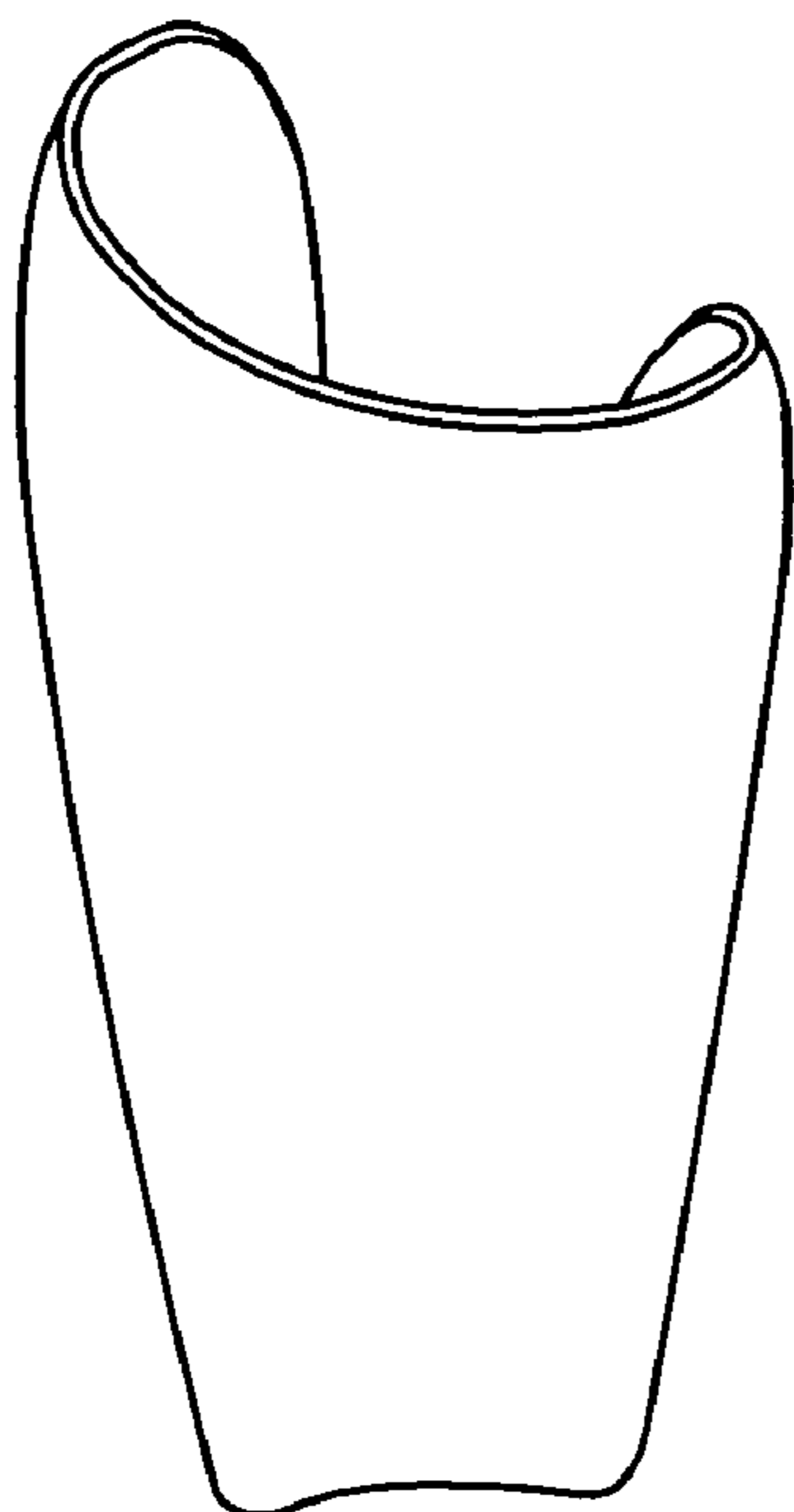
FIG. 3 is a left perspective view thereof;

FIG. 4 is a right perspective view thereof;

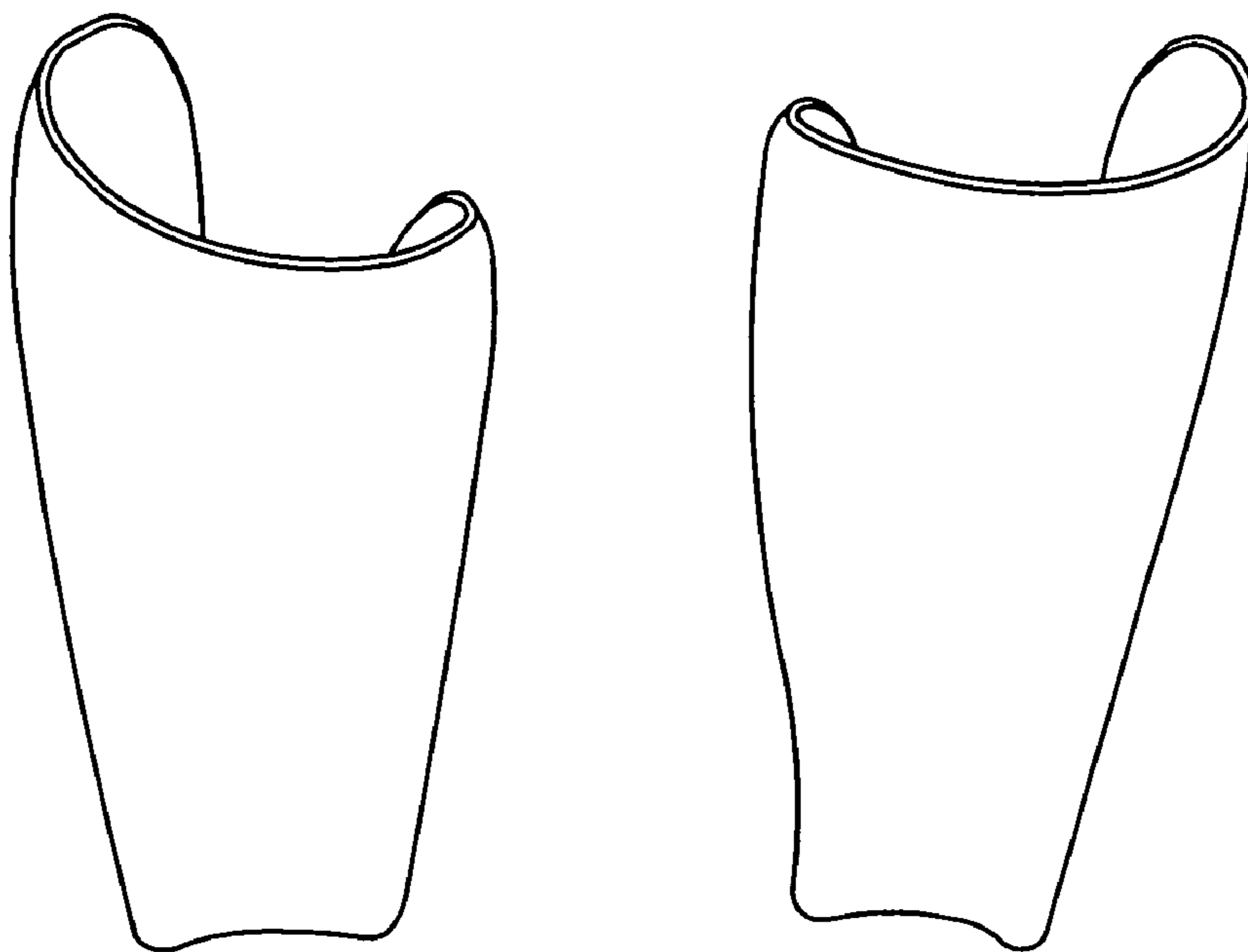
FIG. 5 is a top plan view thereof; and,

FIG. 6 is a bottom plan view thereof.

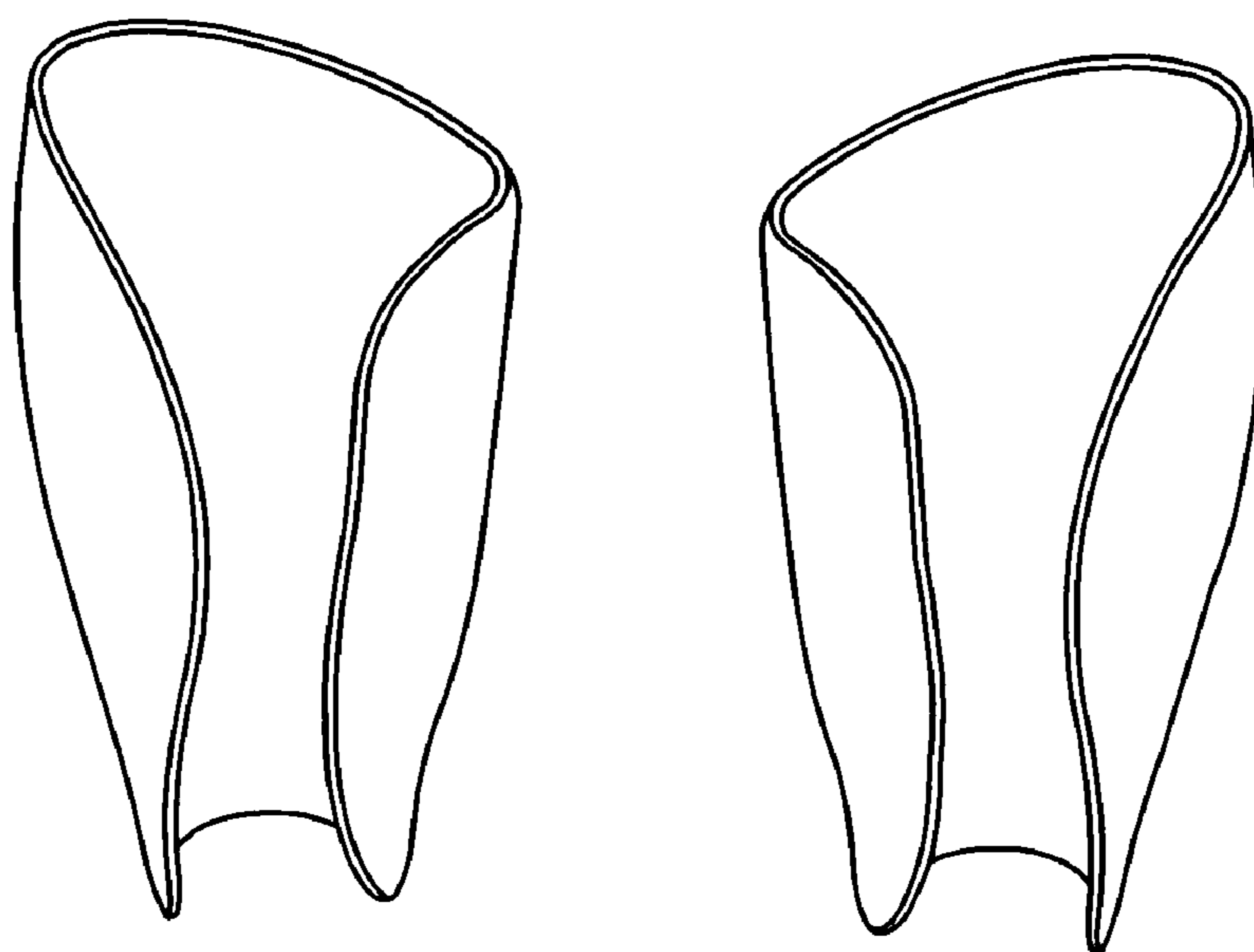

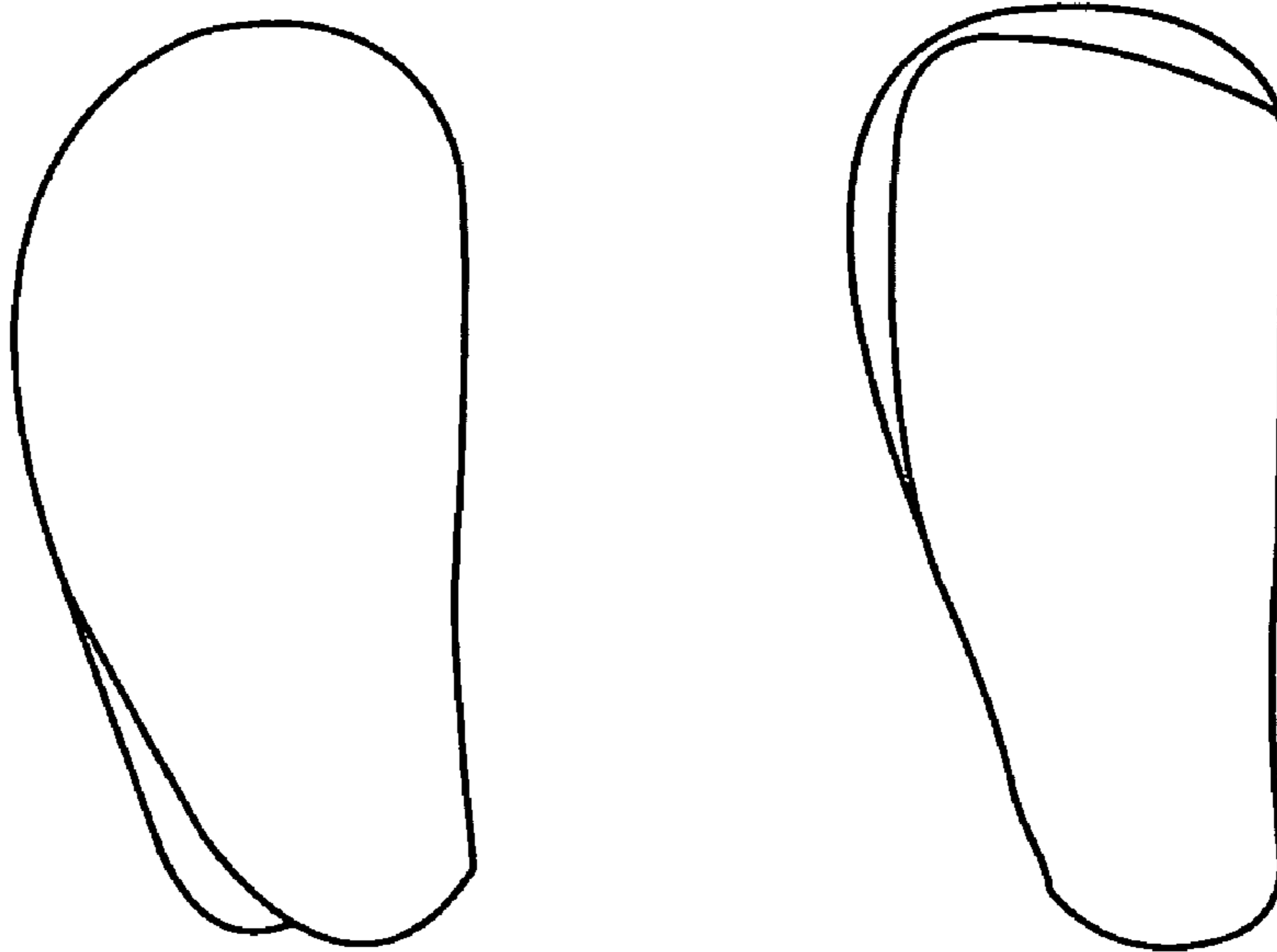

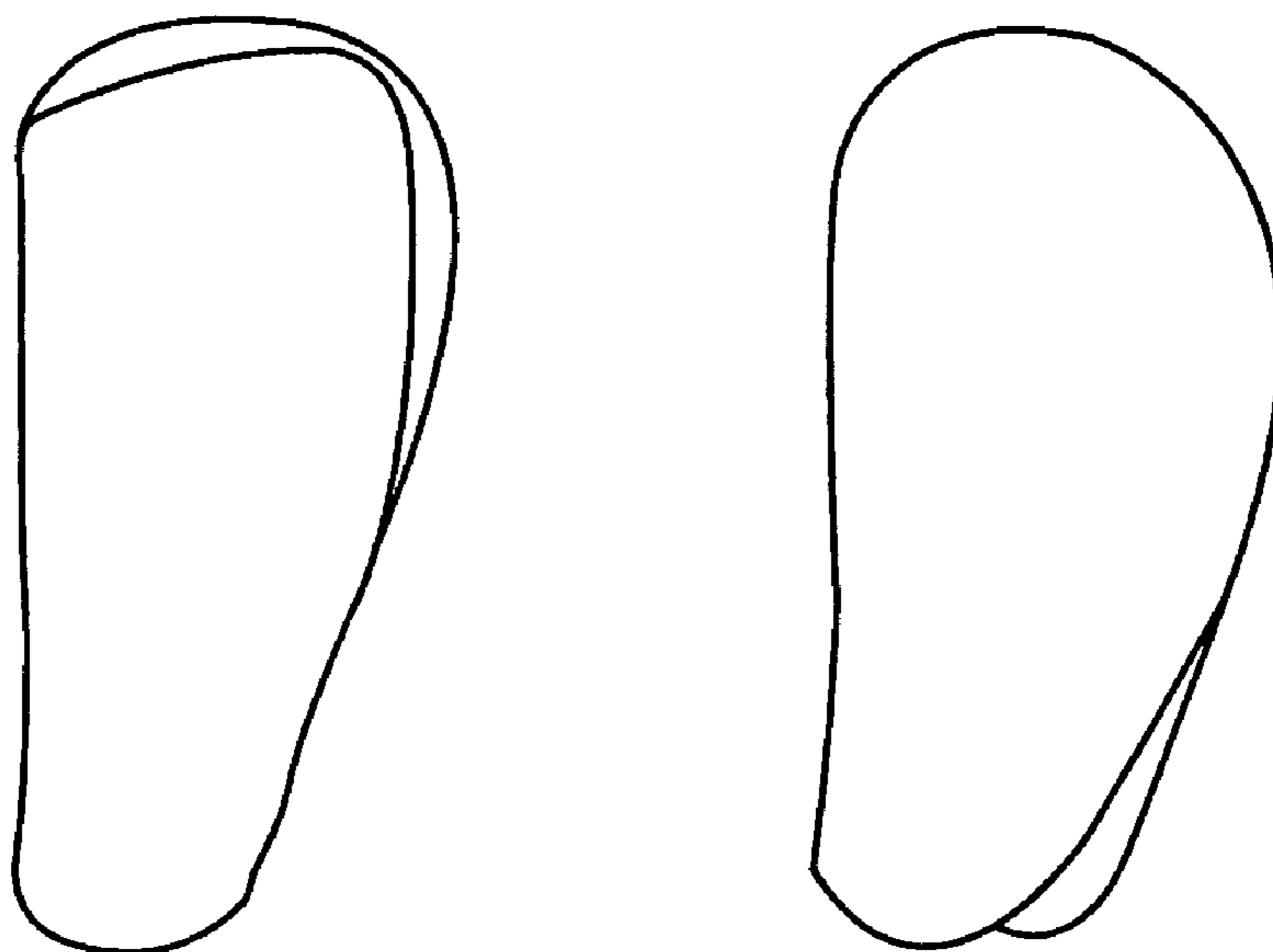

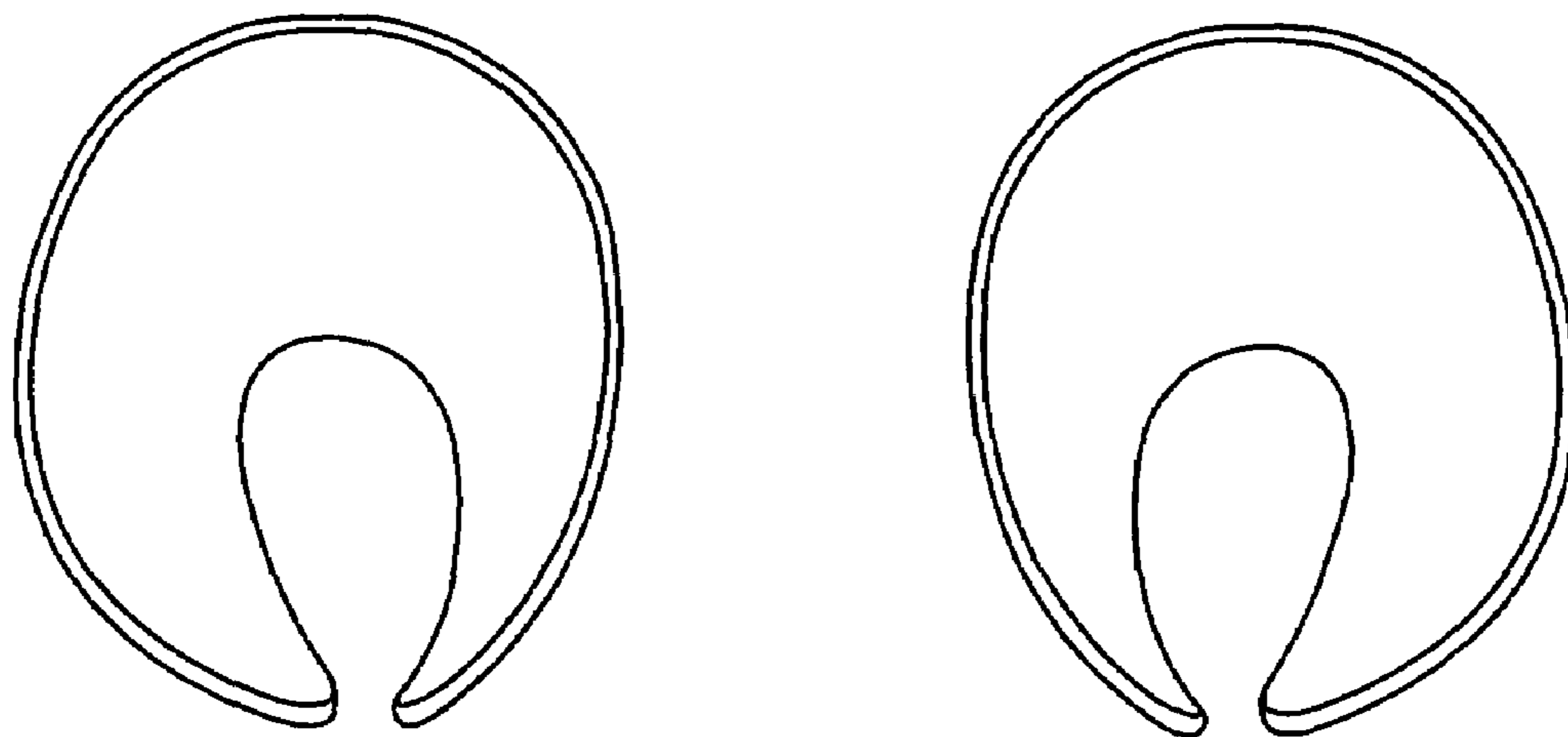
