FIG. 3 is an alternative side view thereof;

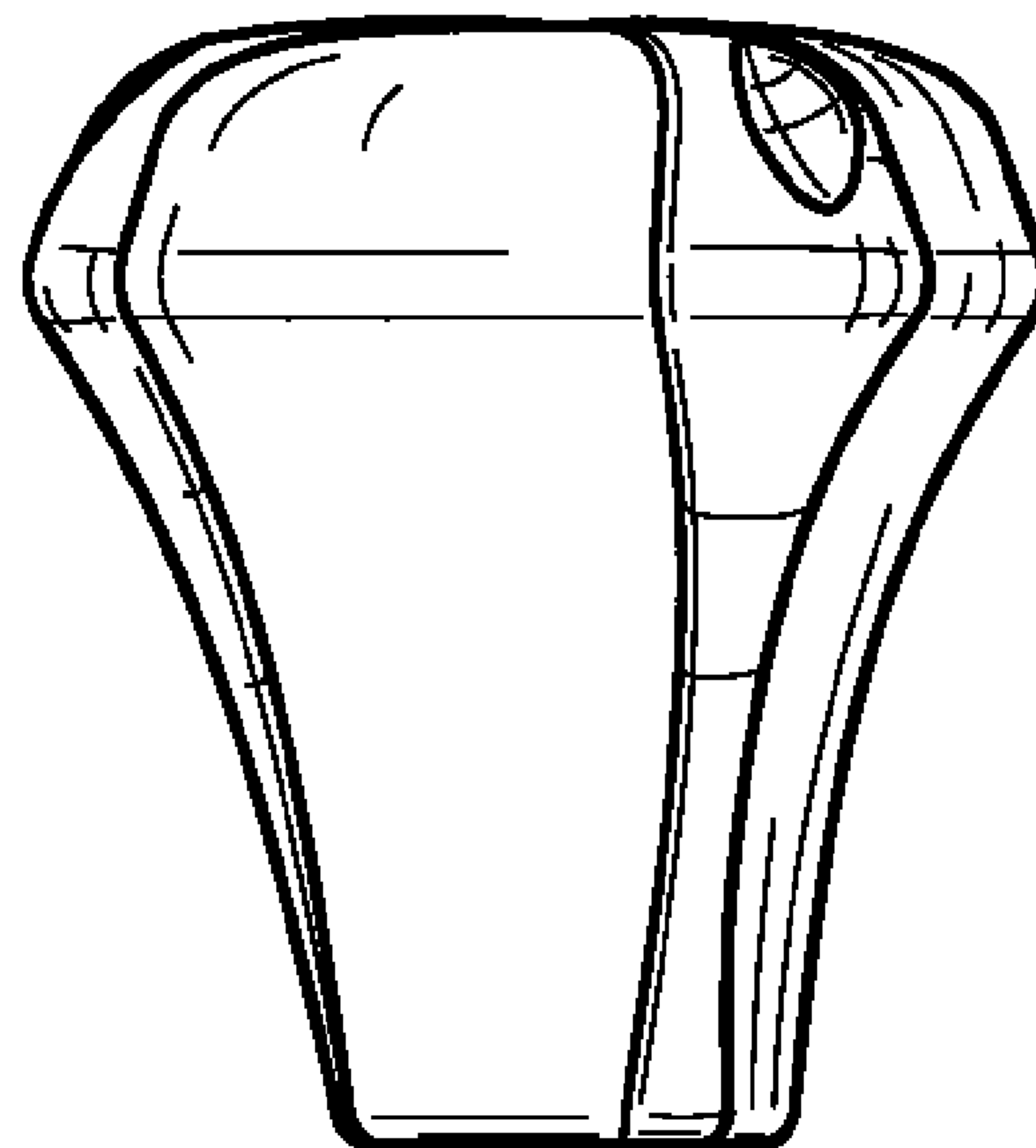
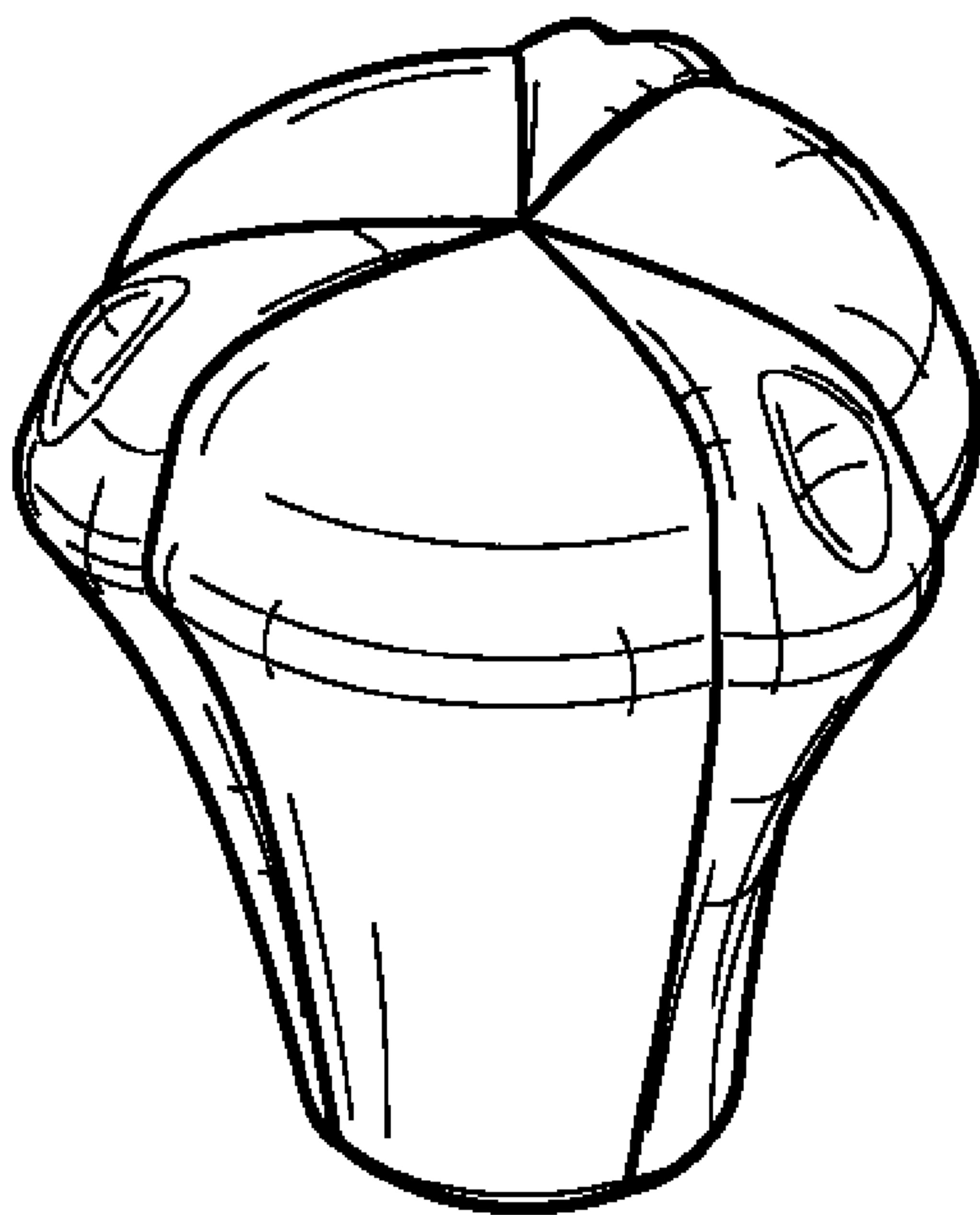
FIG. 4 is an alternative side view thereof;

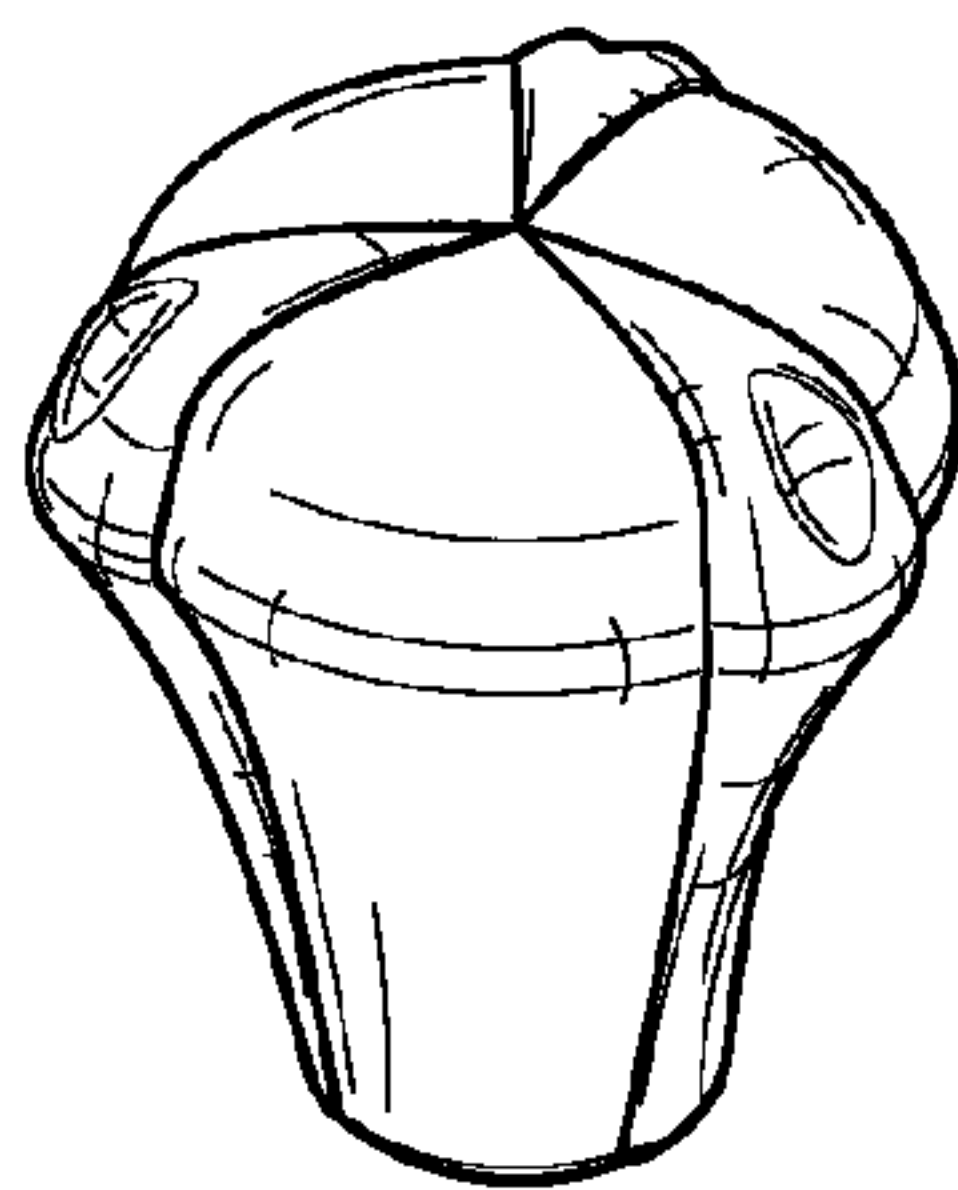

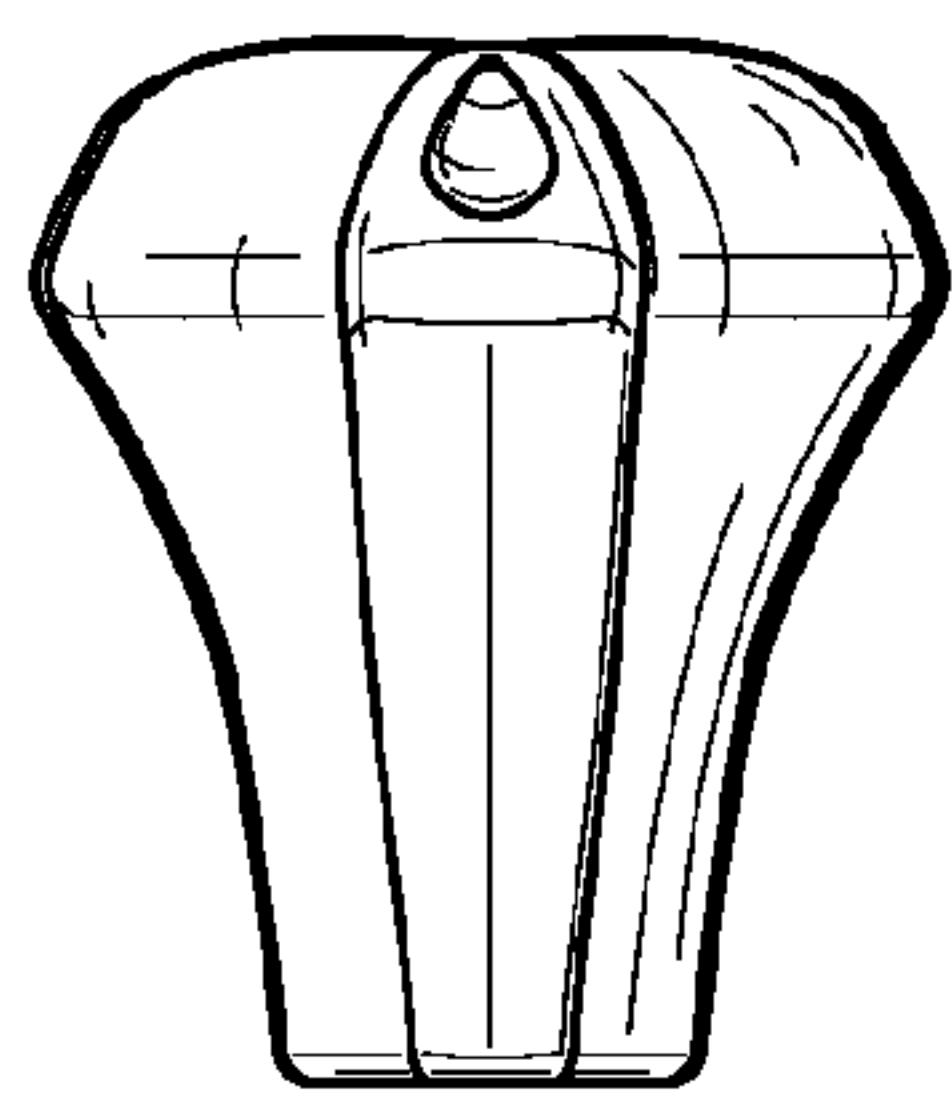

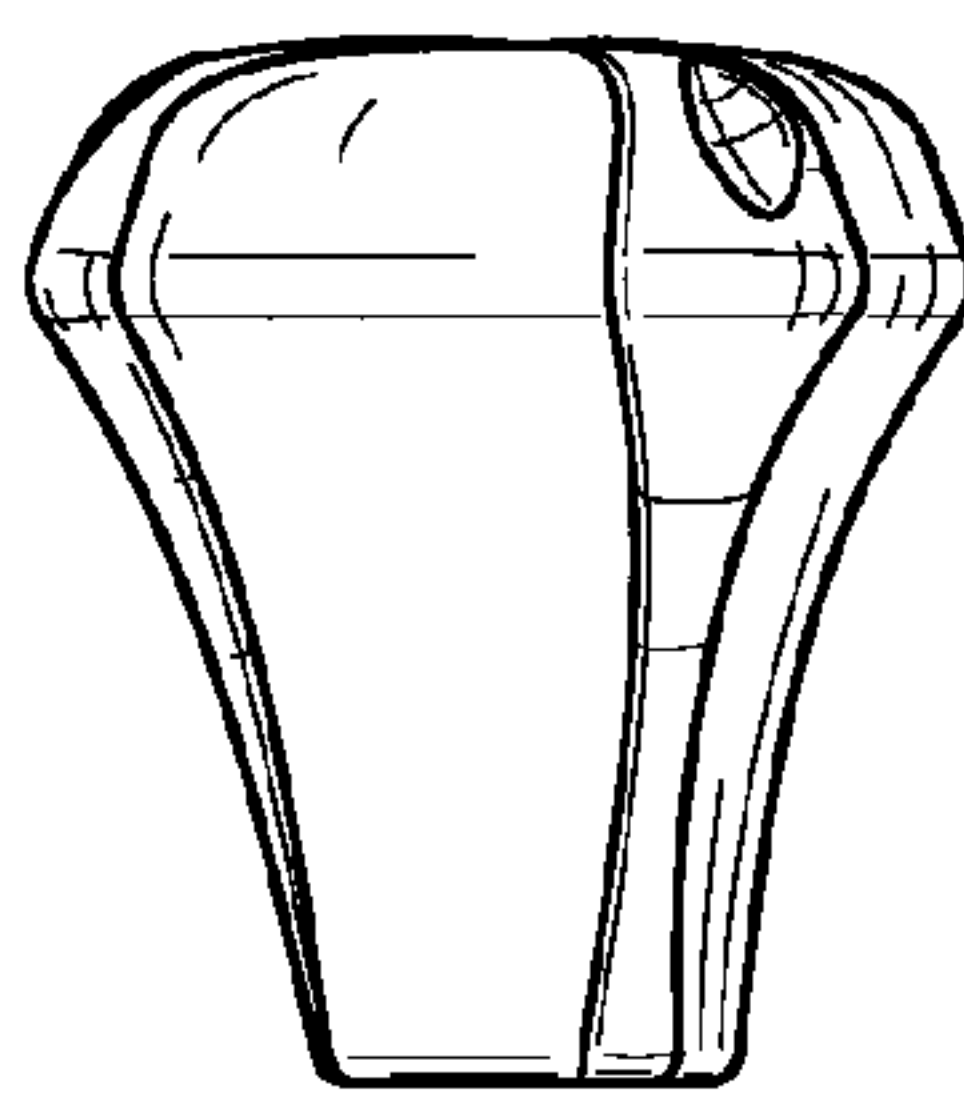

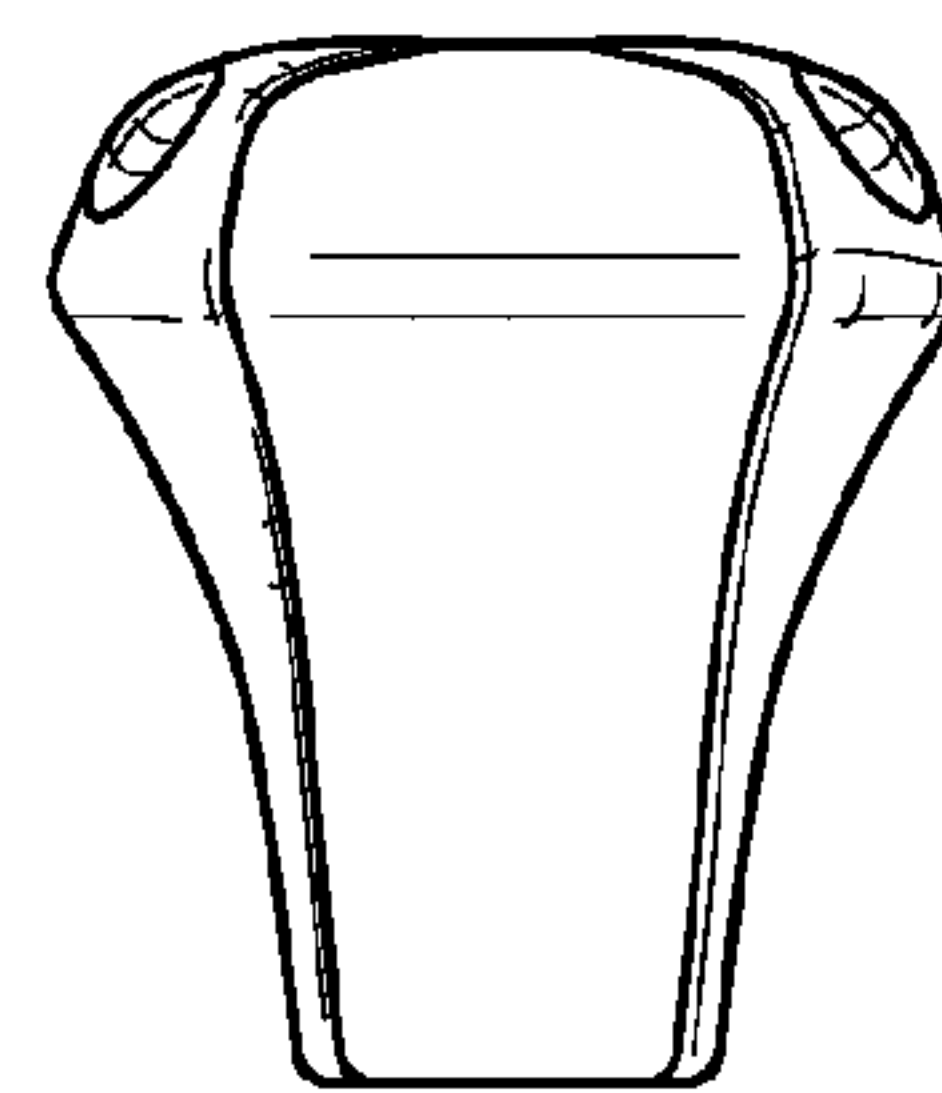

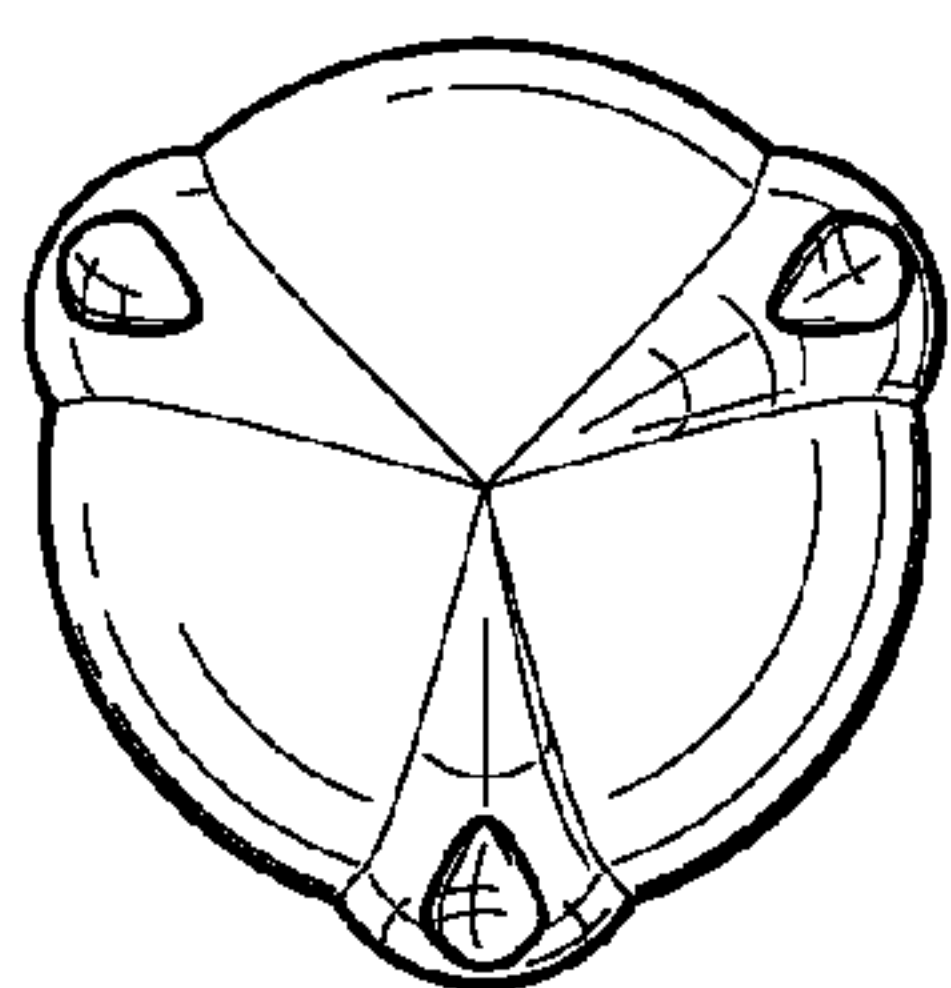

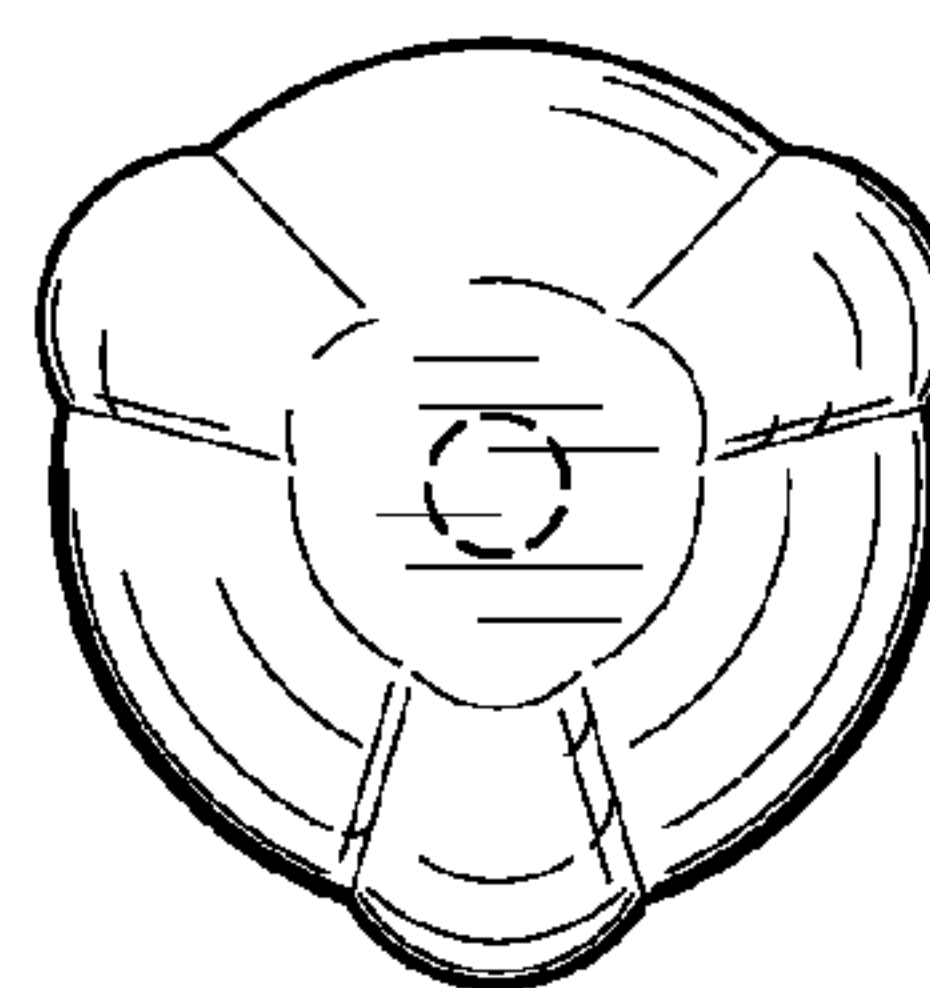
