FIG. 19 is a bottom plan view of FIG. 16; and,

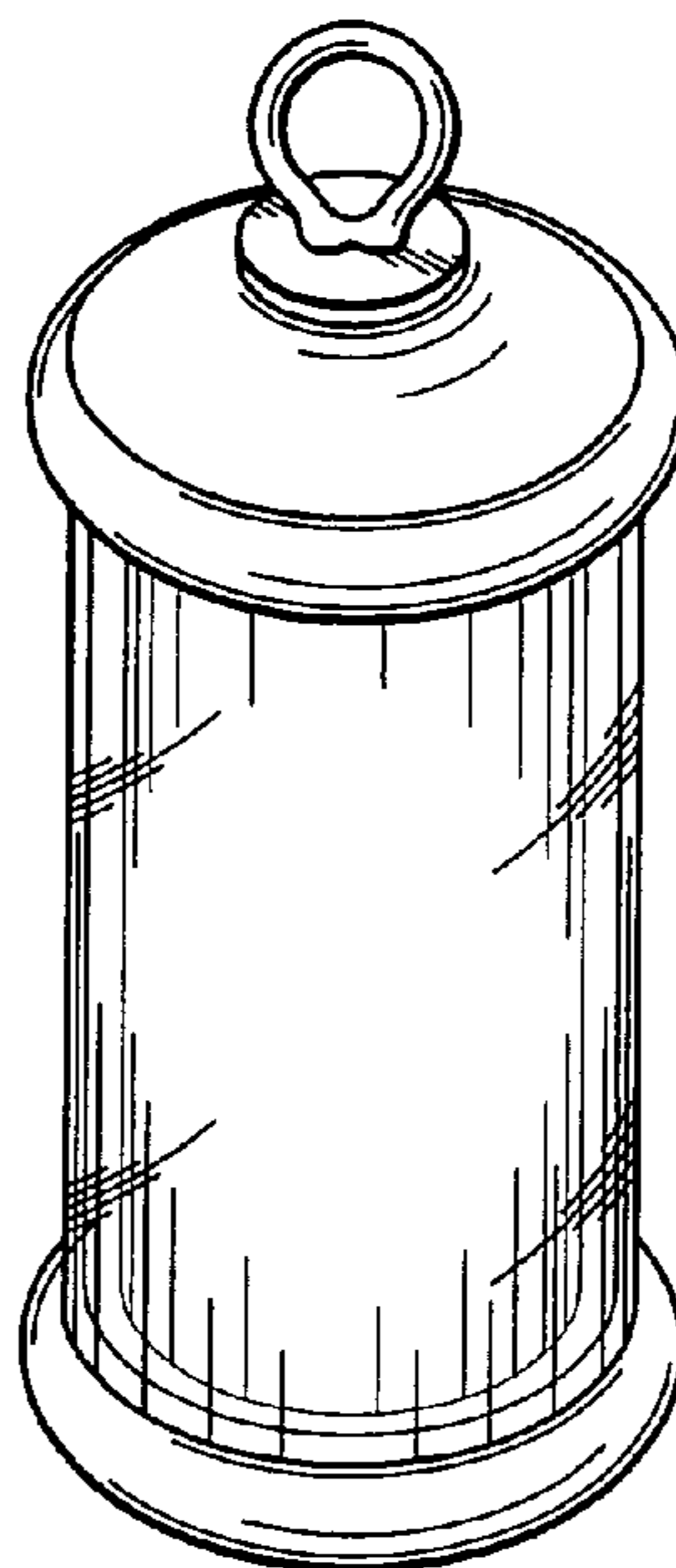
FIG. 20 is a top plan view of FIG. 16.

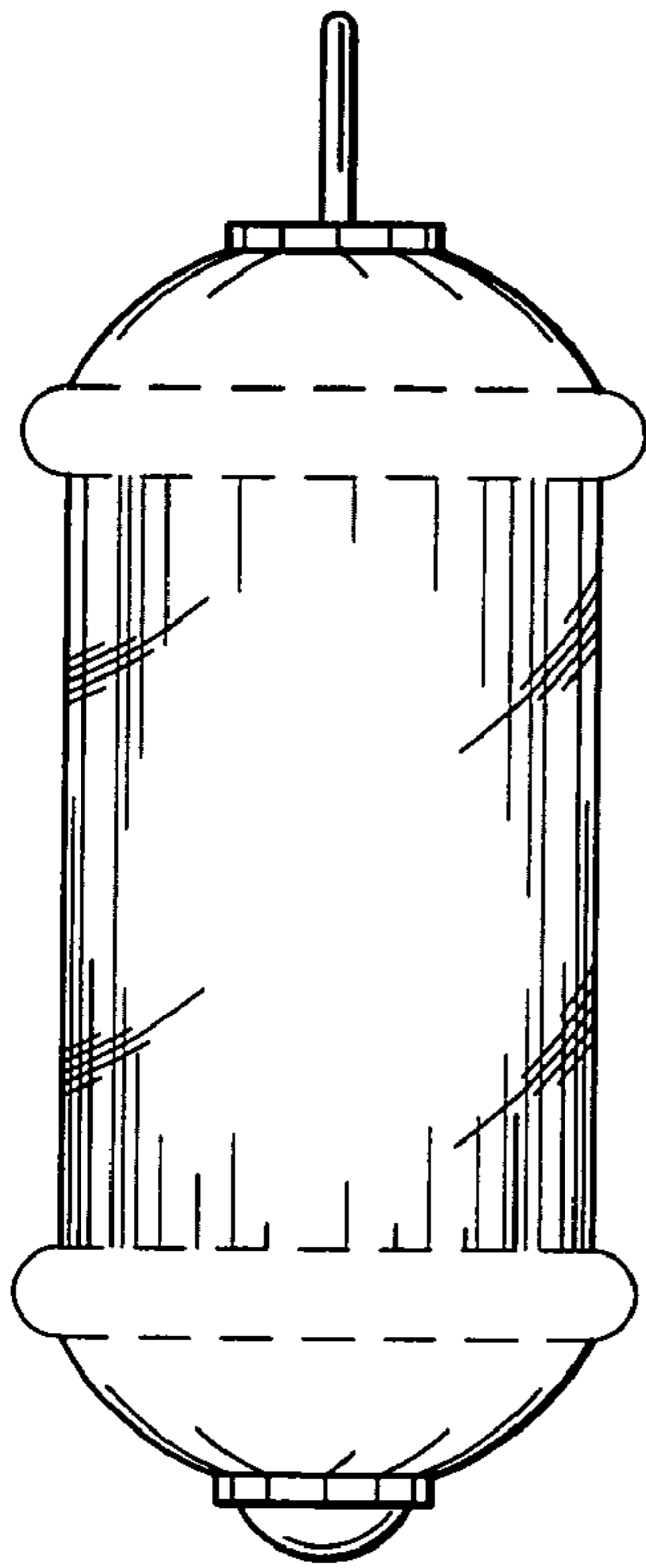

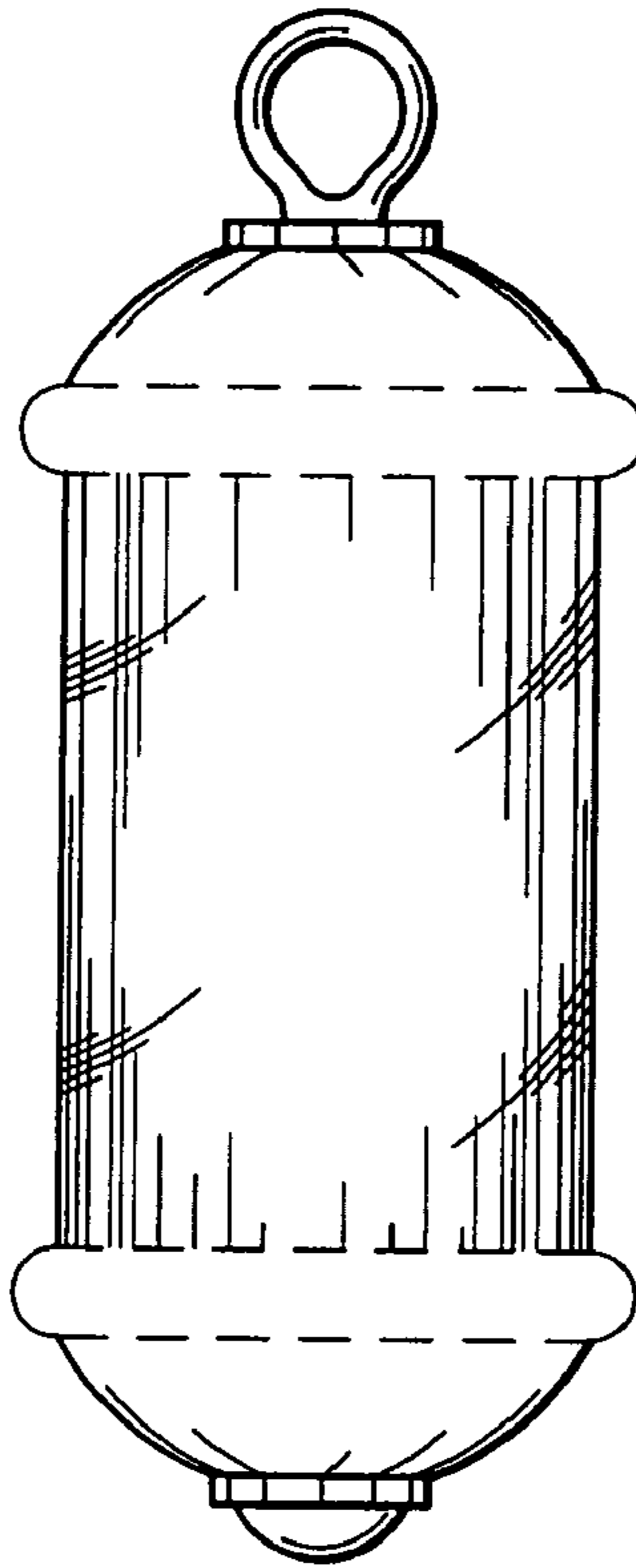

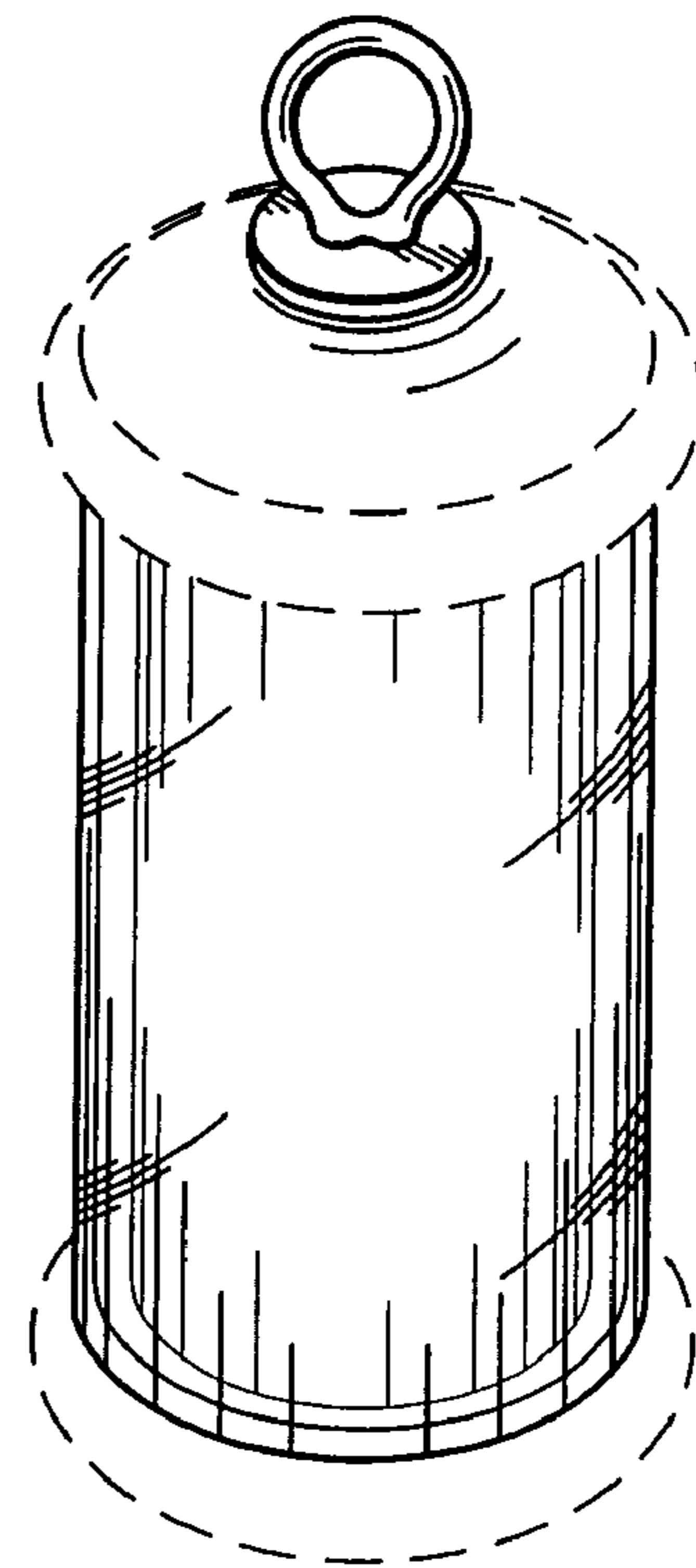

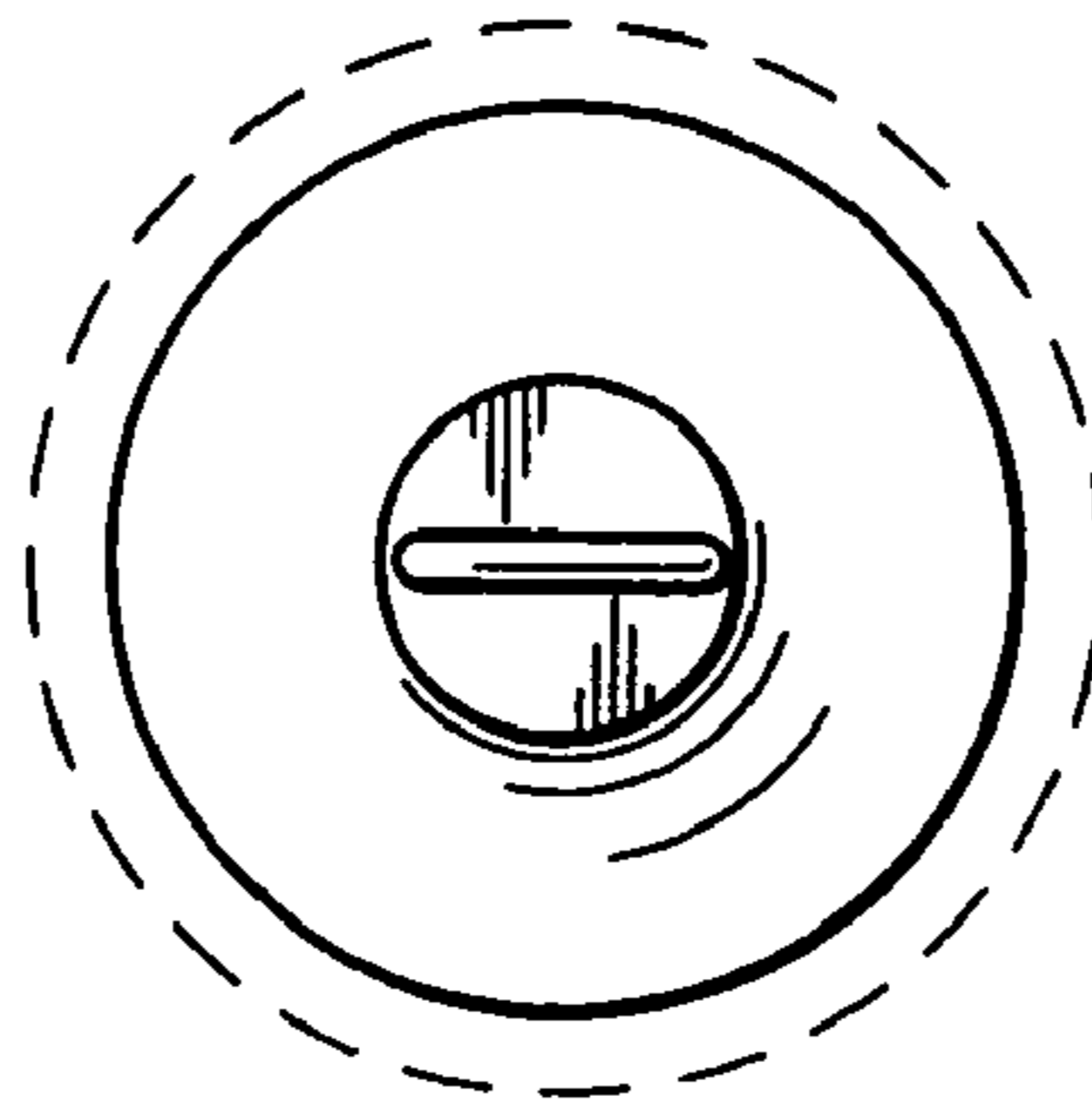

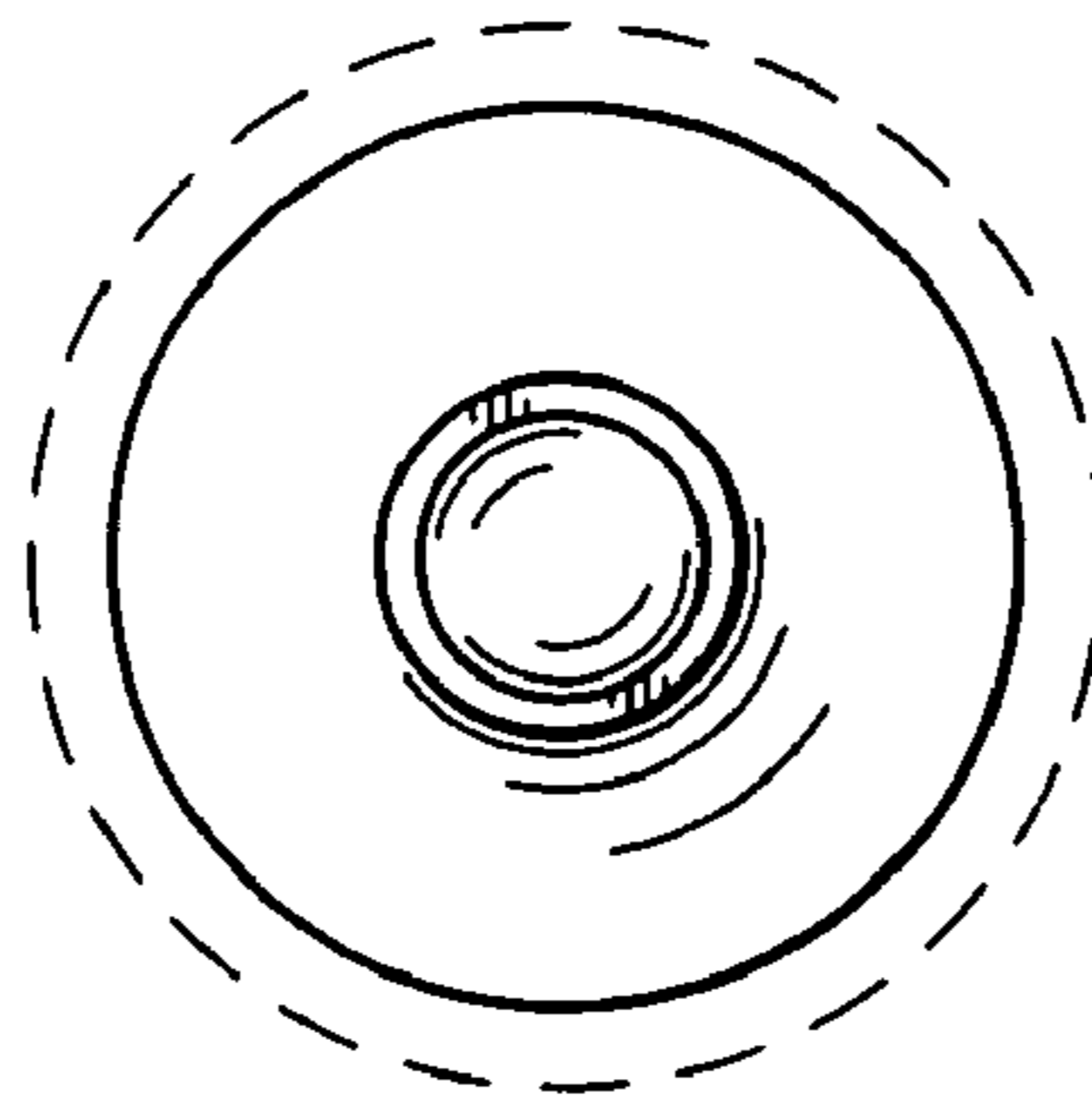

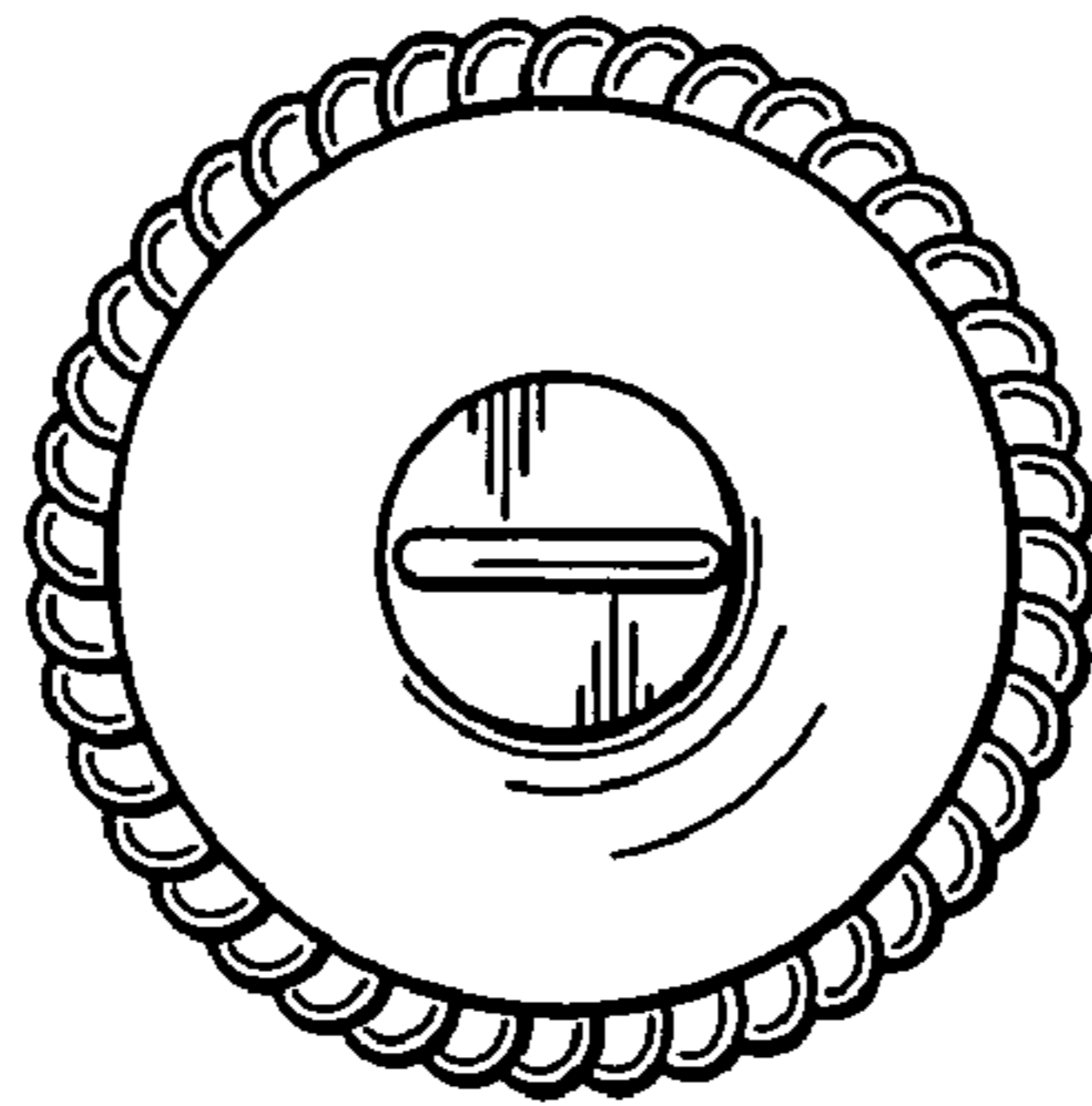

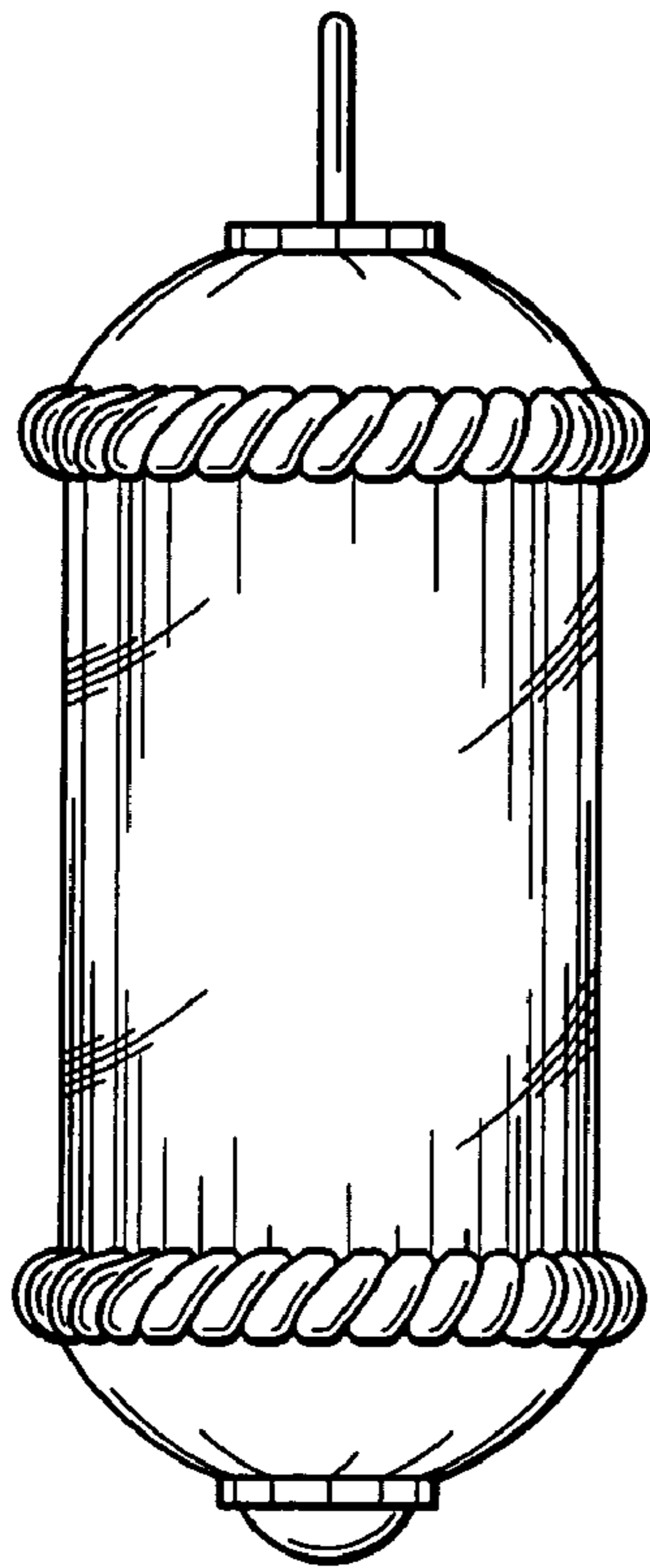

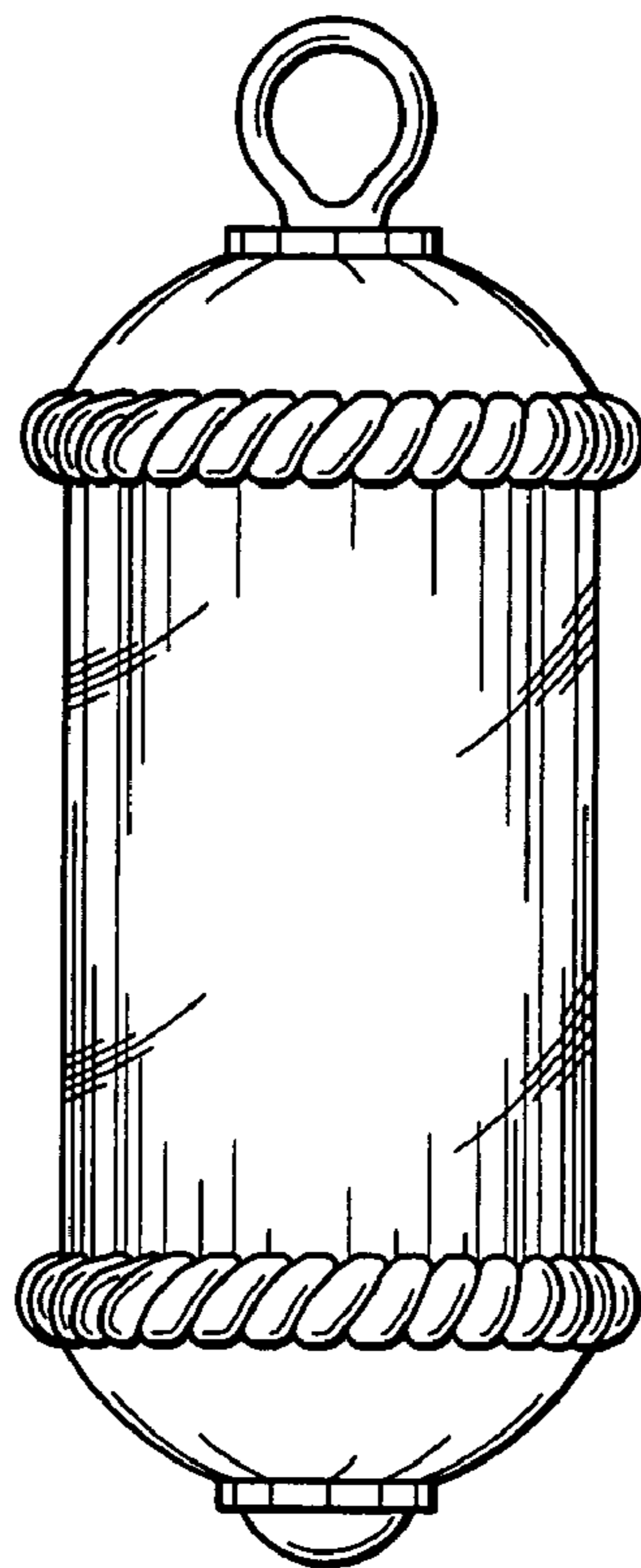

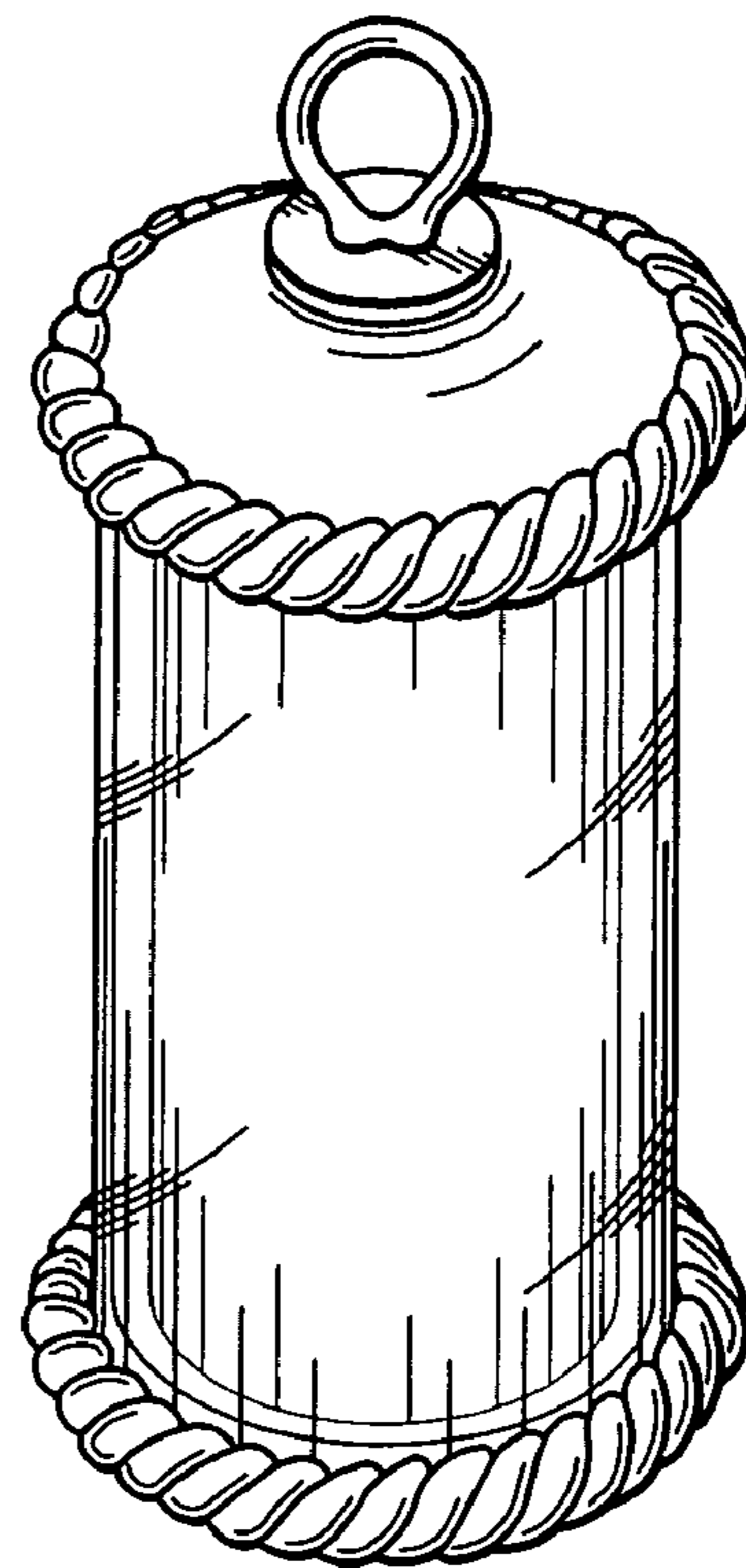

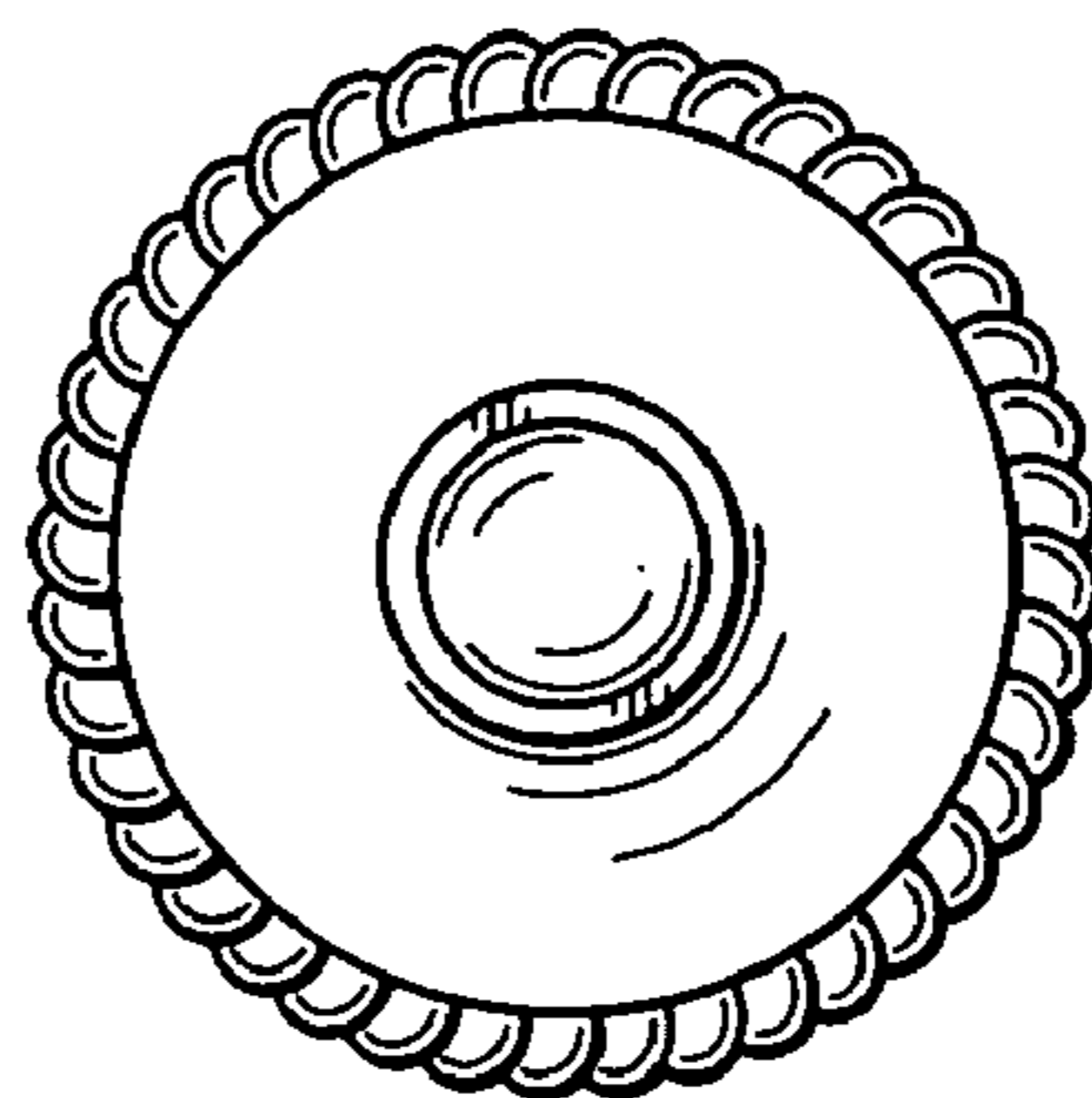

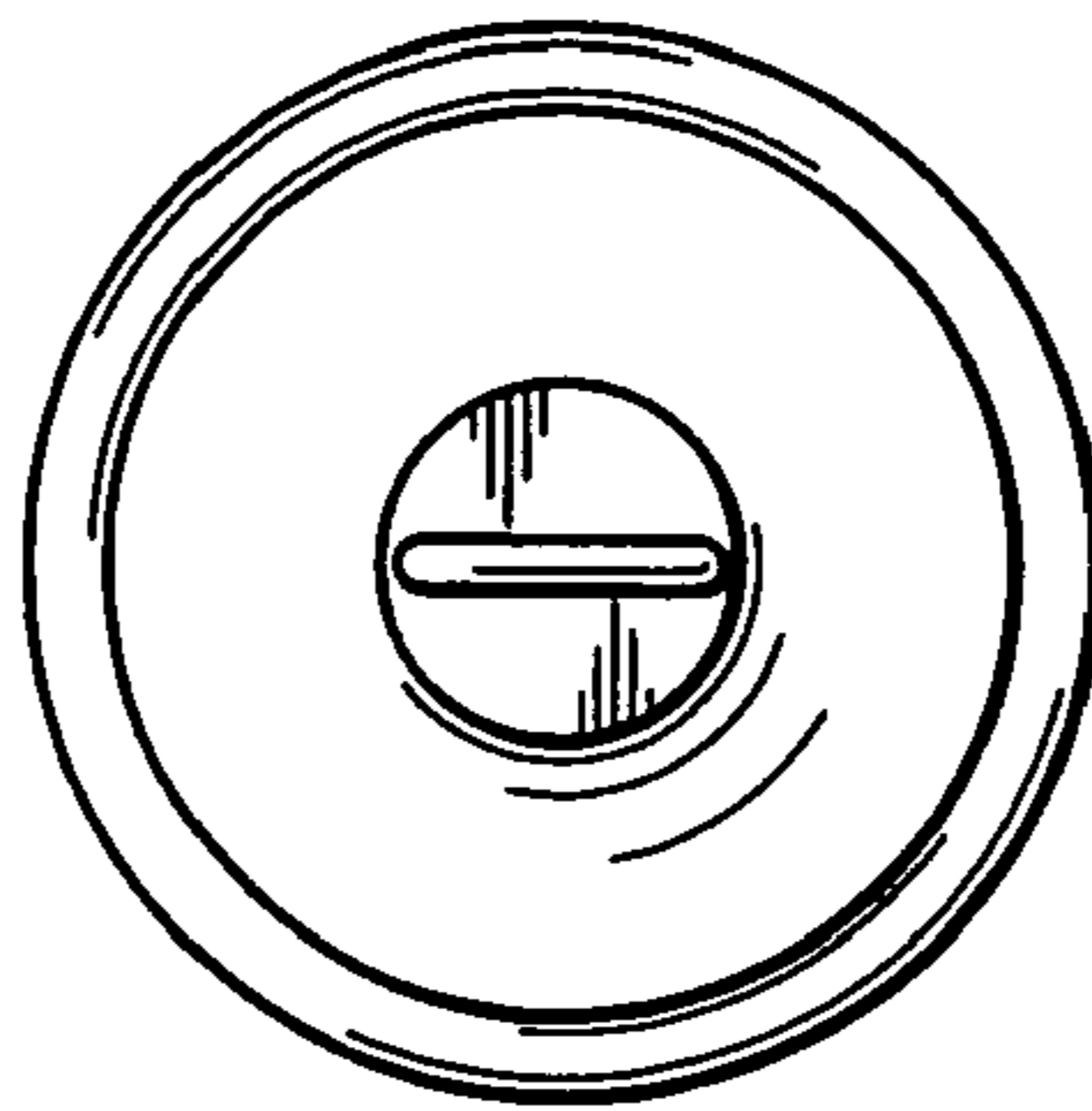

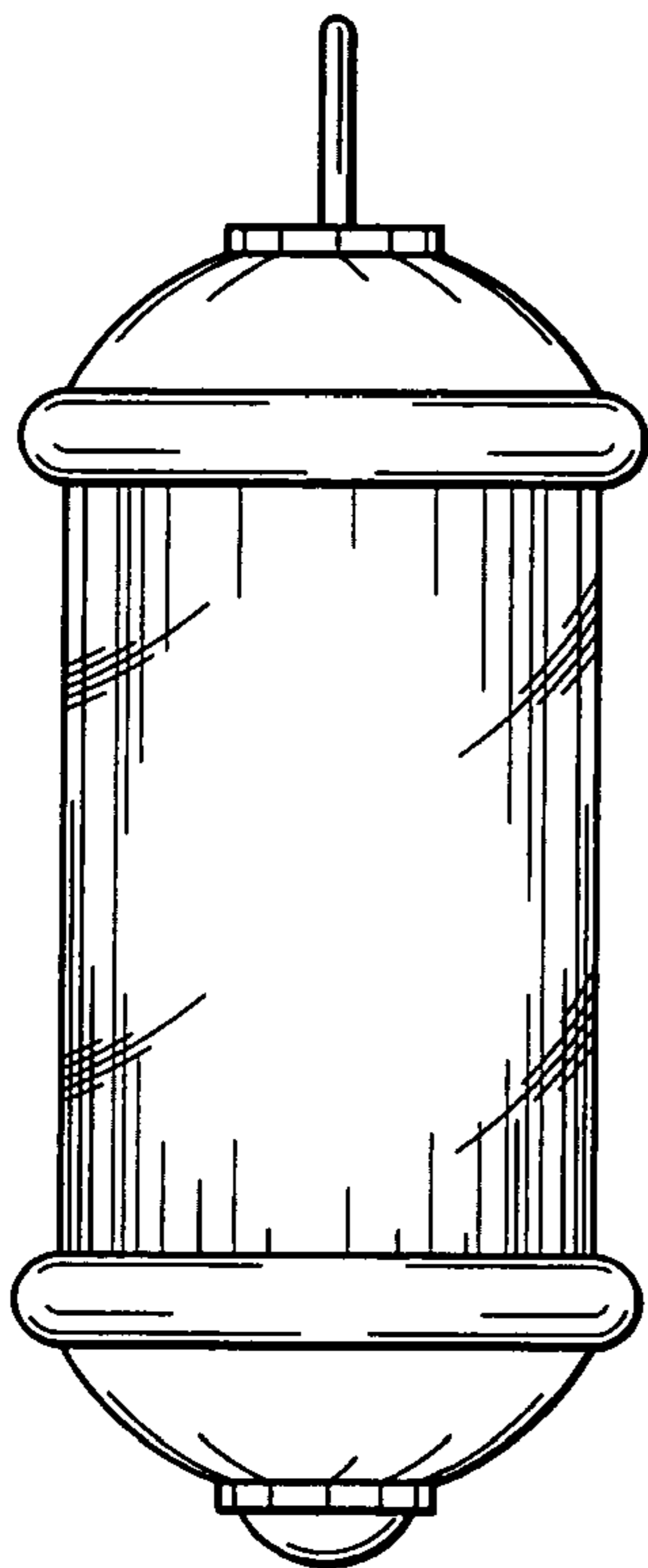

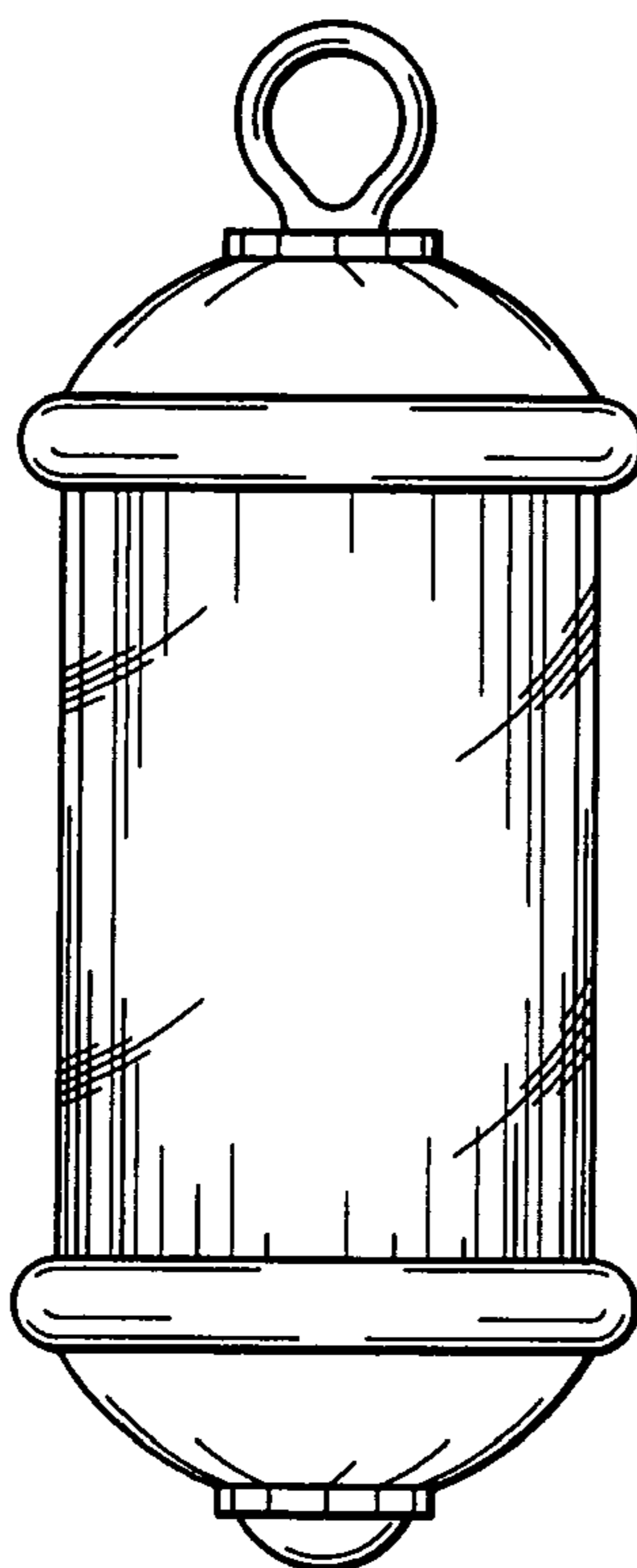

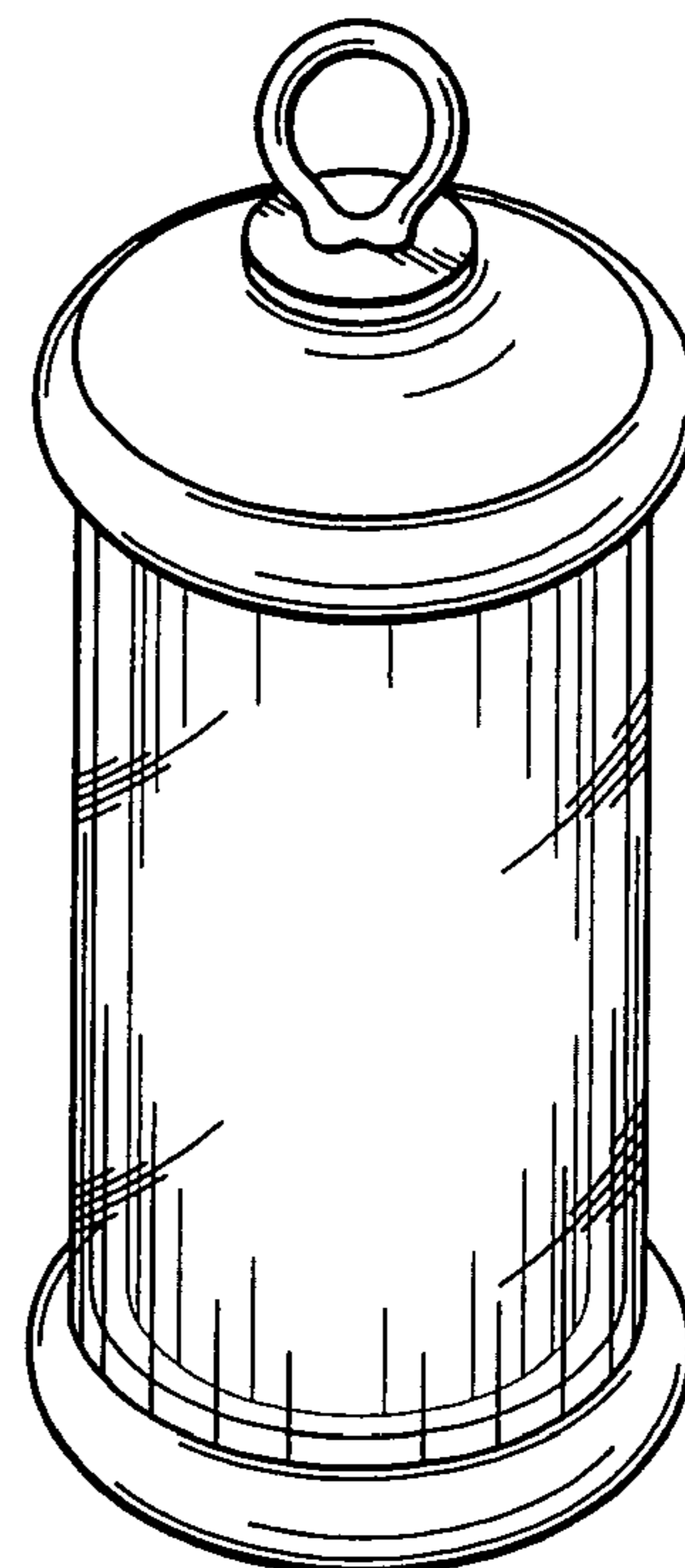

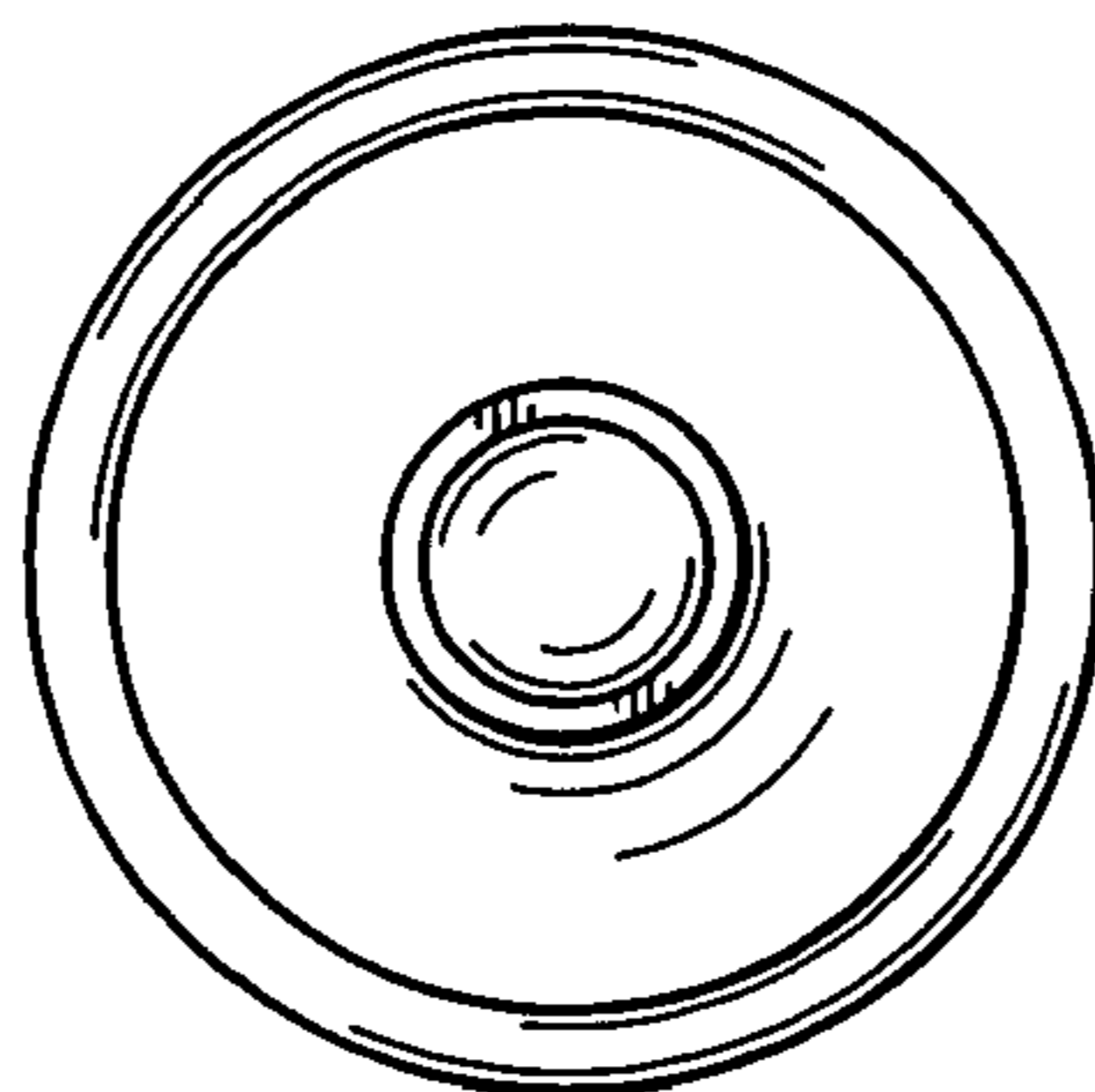

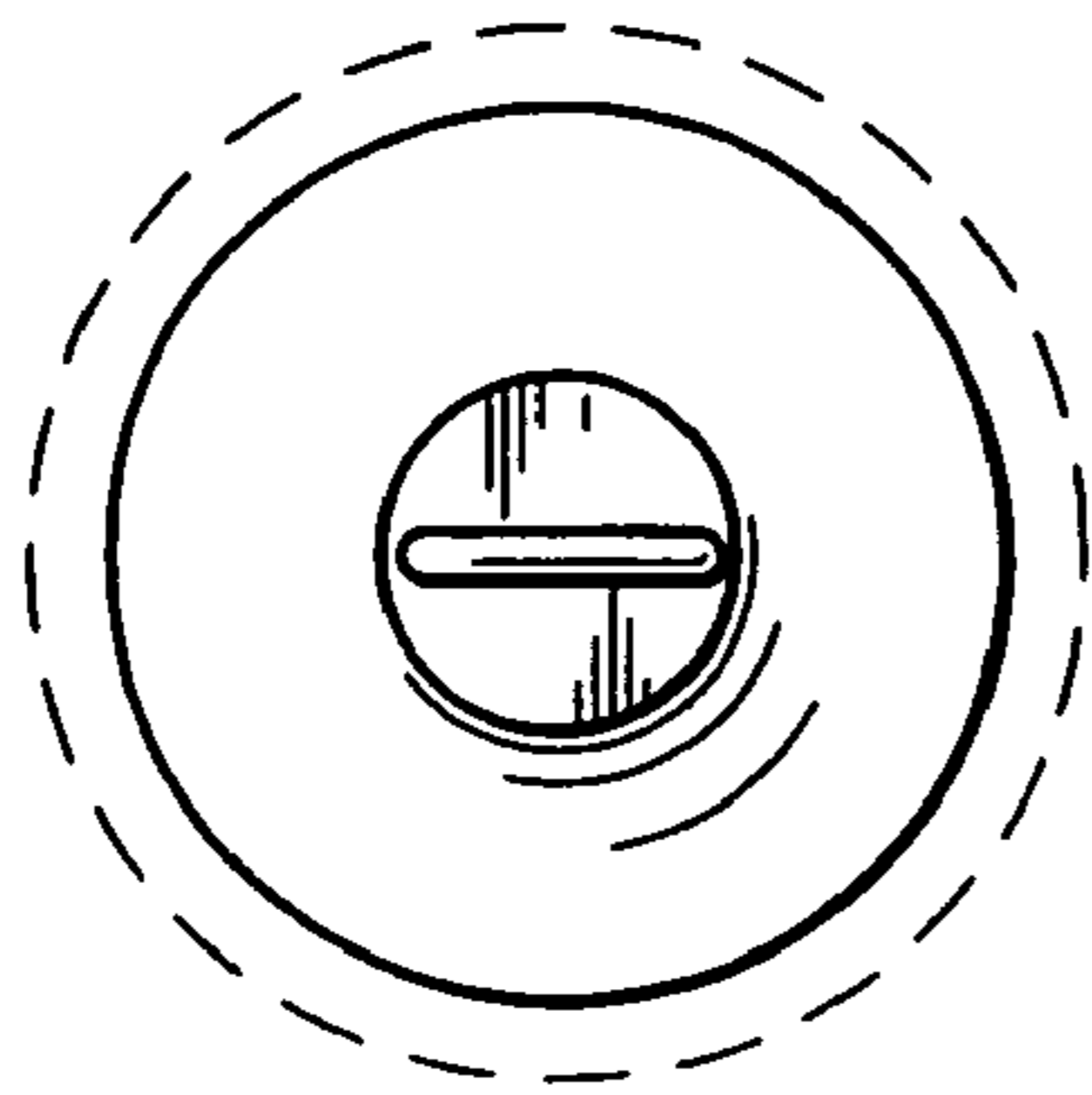

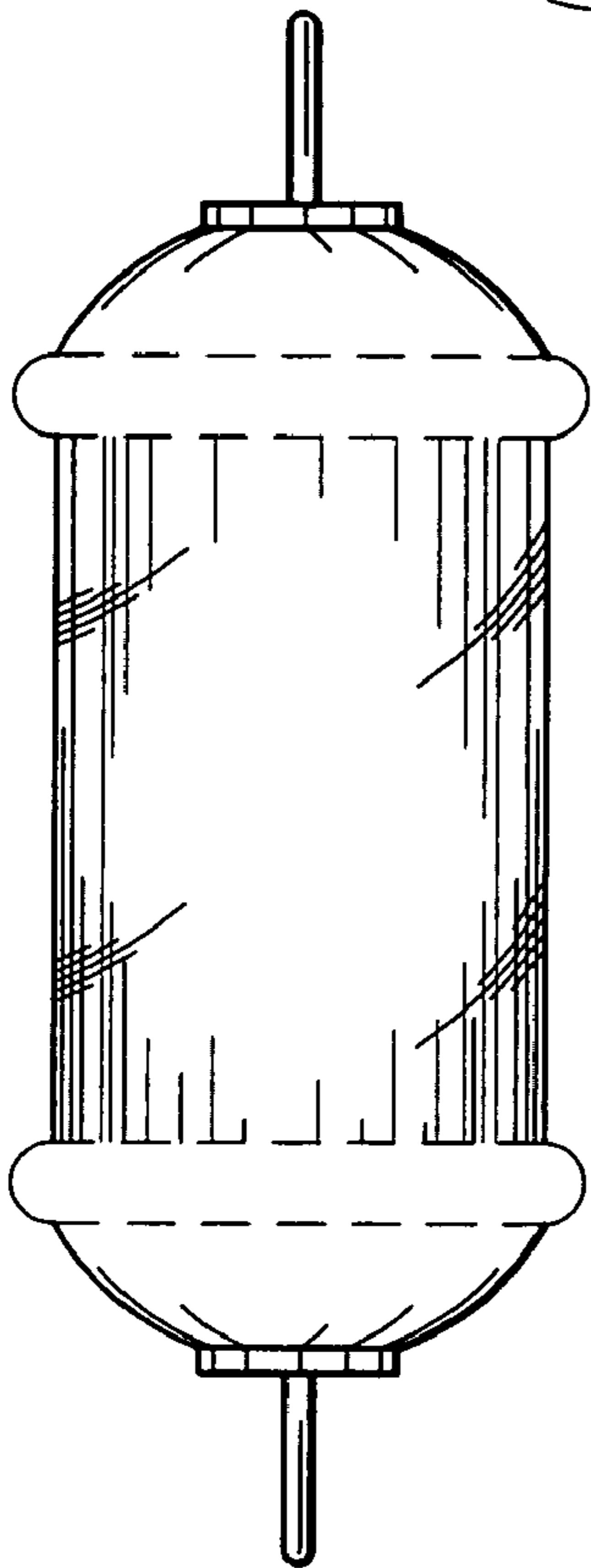

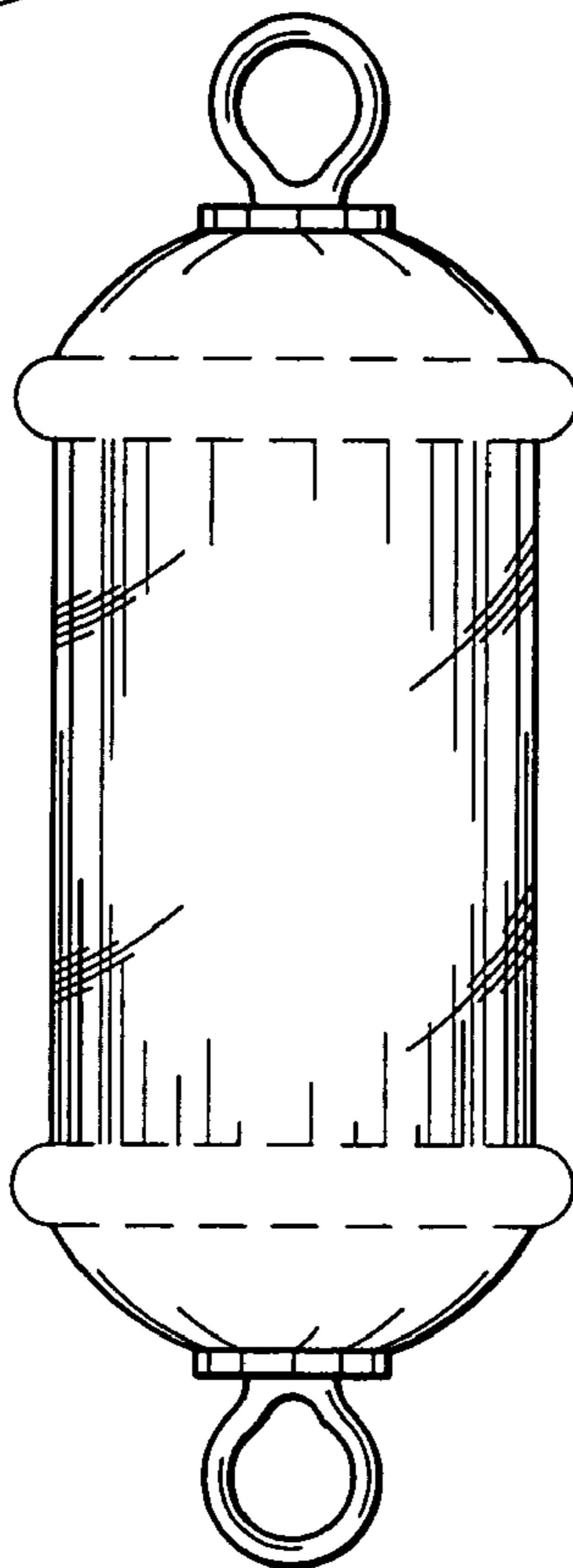

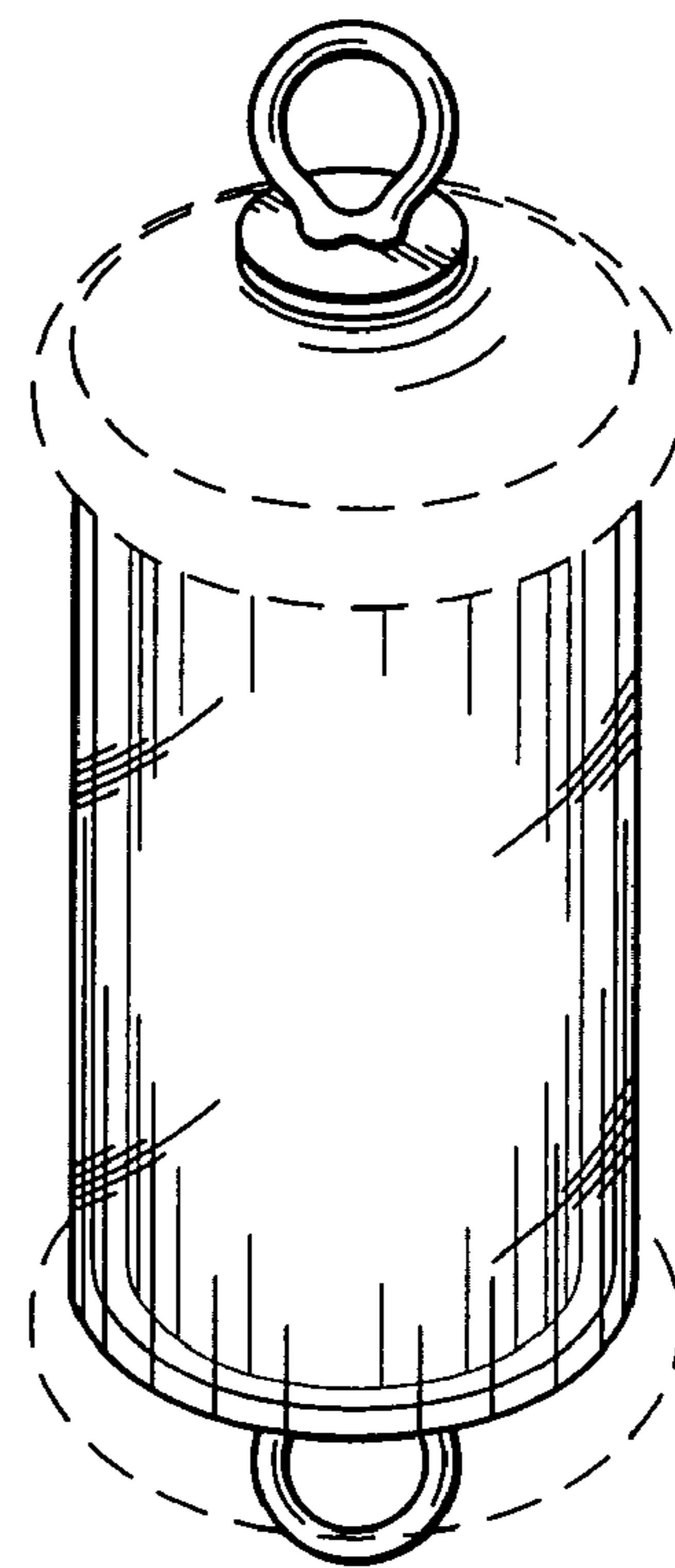
