FIG. 1 is a perspective view of a brassiere strap clip, as shown and described in an environmental view as installed on a brassiere;

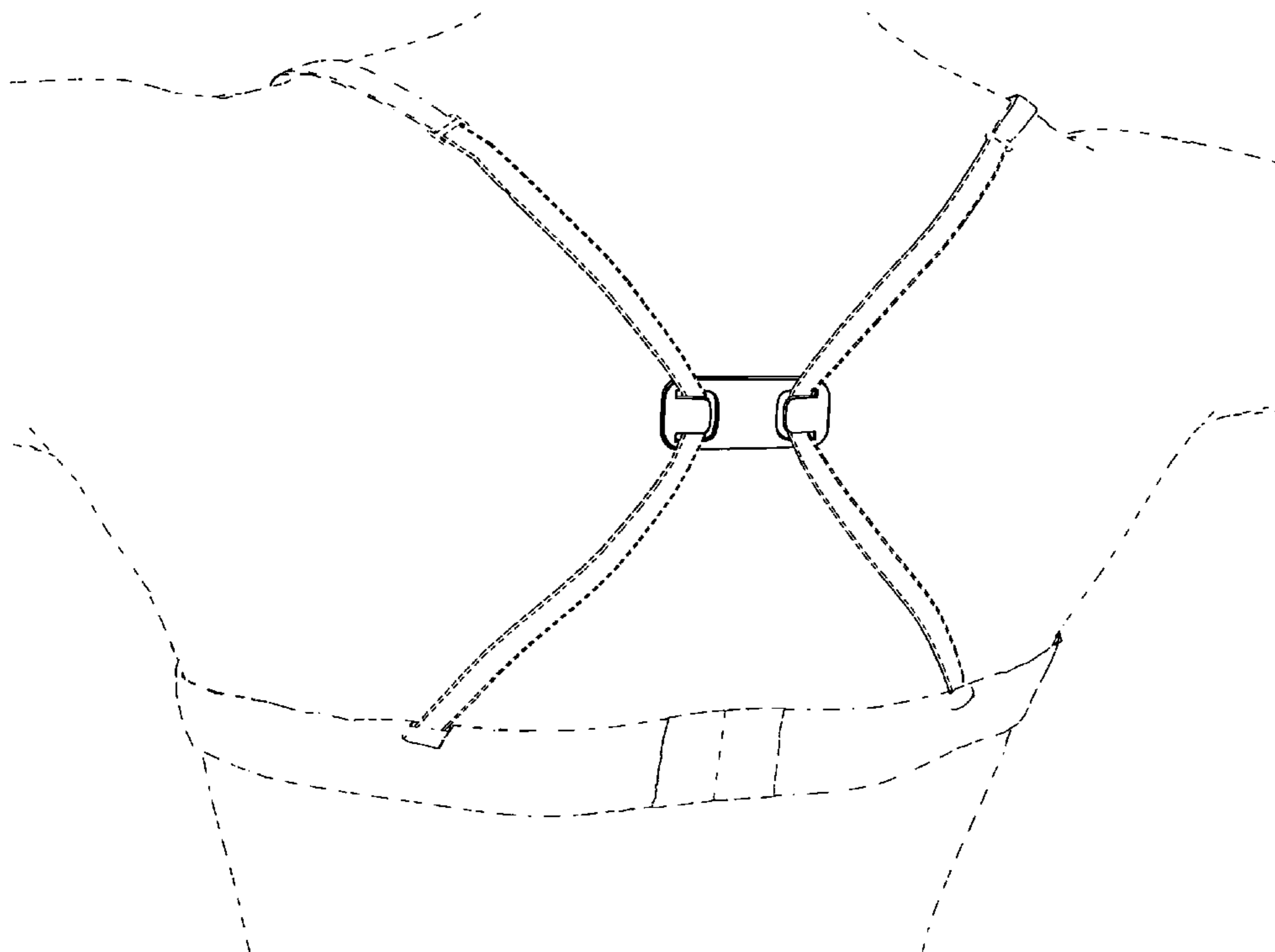
FIG. 2 is a front view thereof;

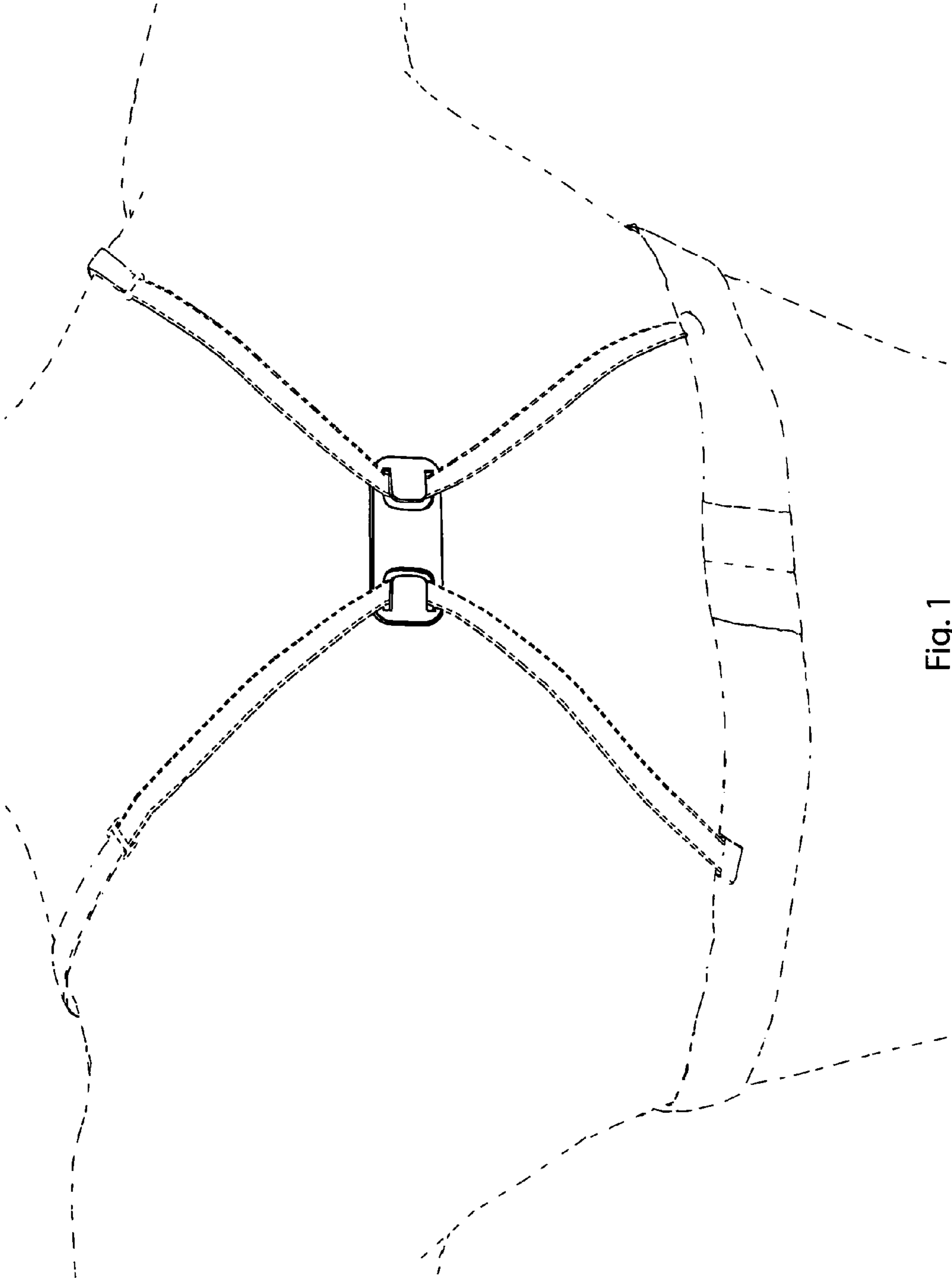

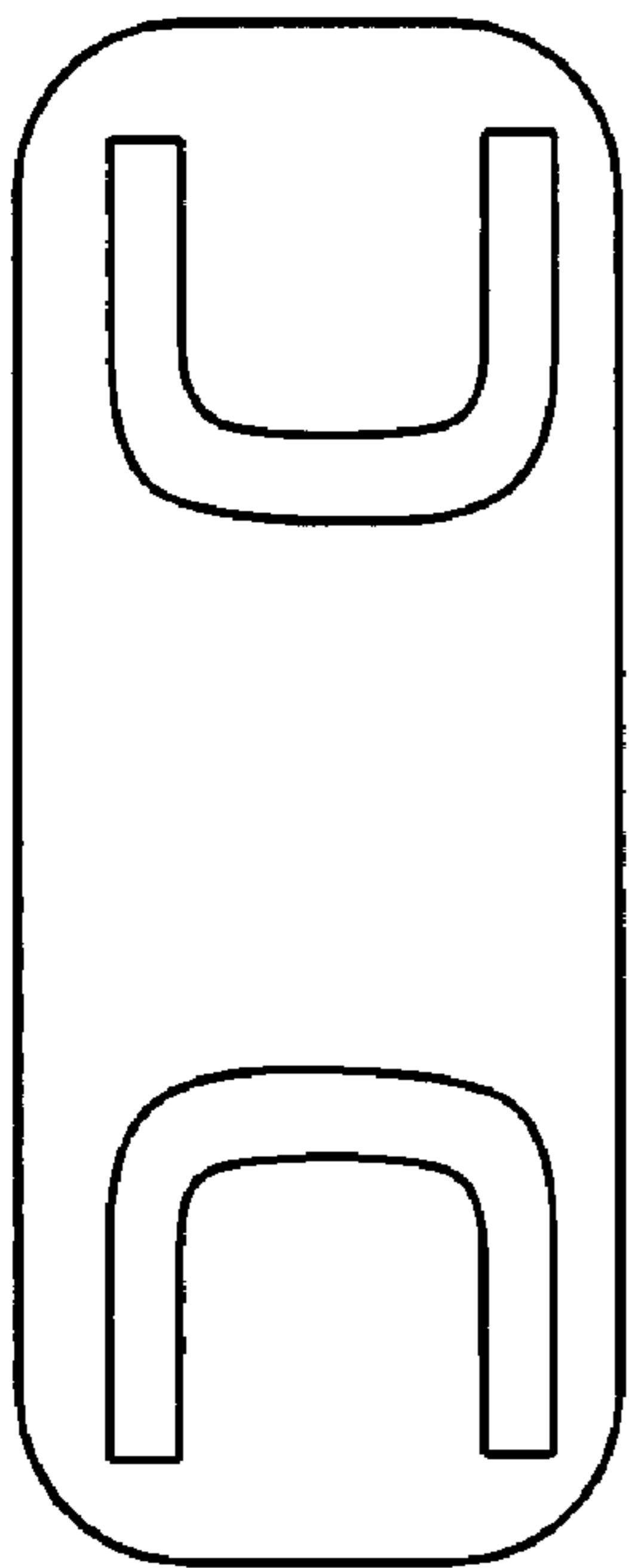

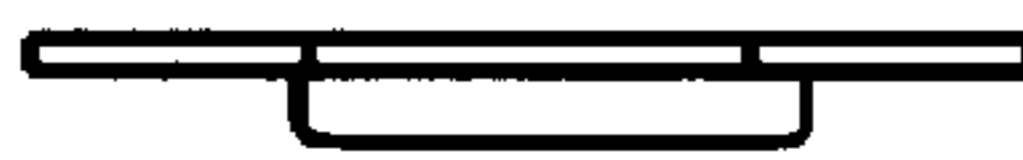
