FIG. 4 is a front view of the equipment stand of FIG. 1.

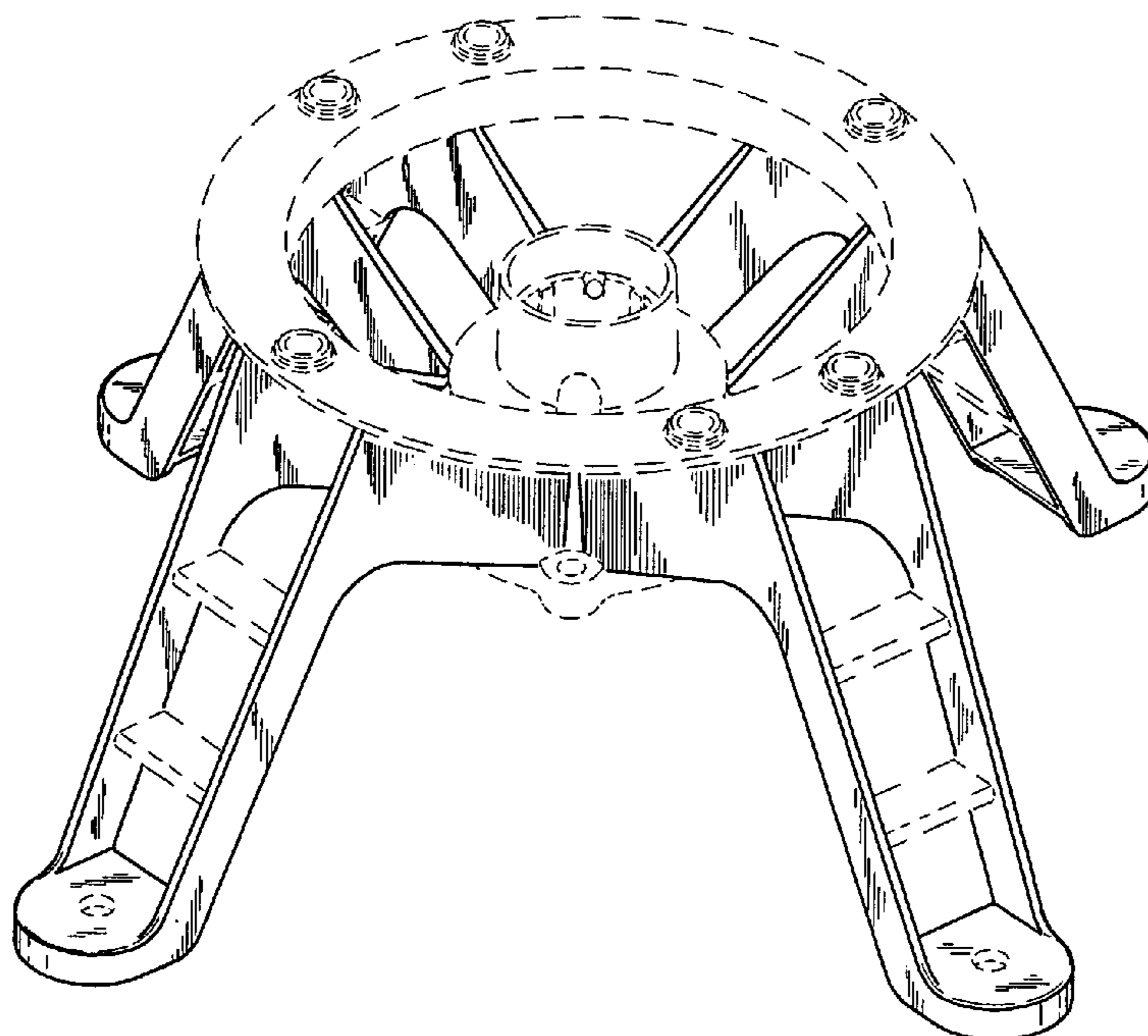

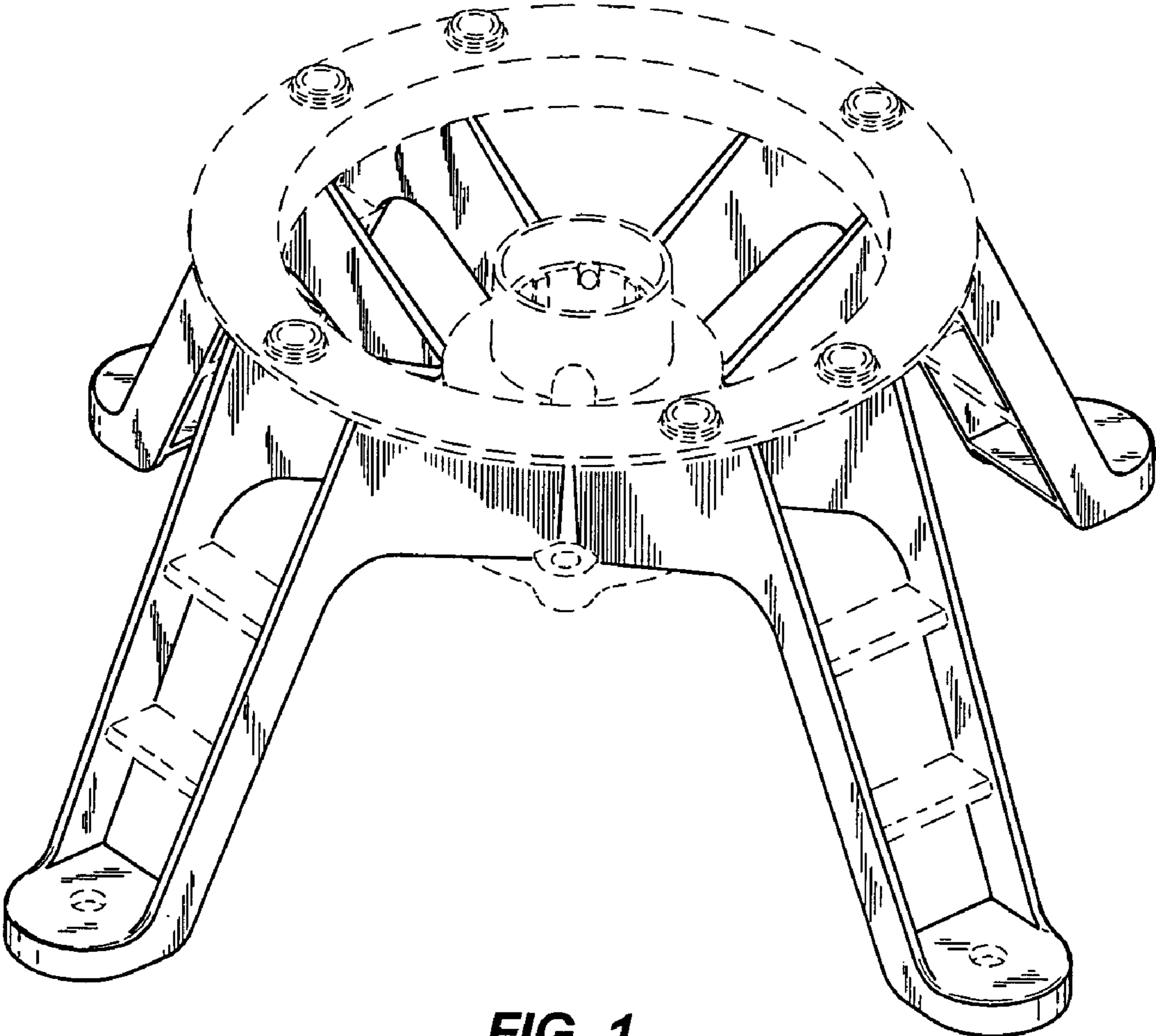

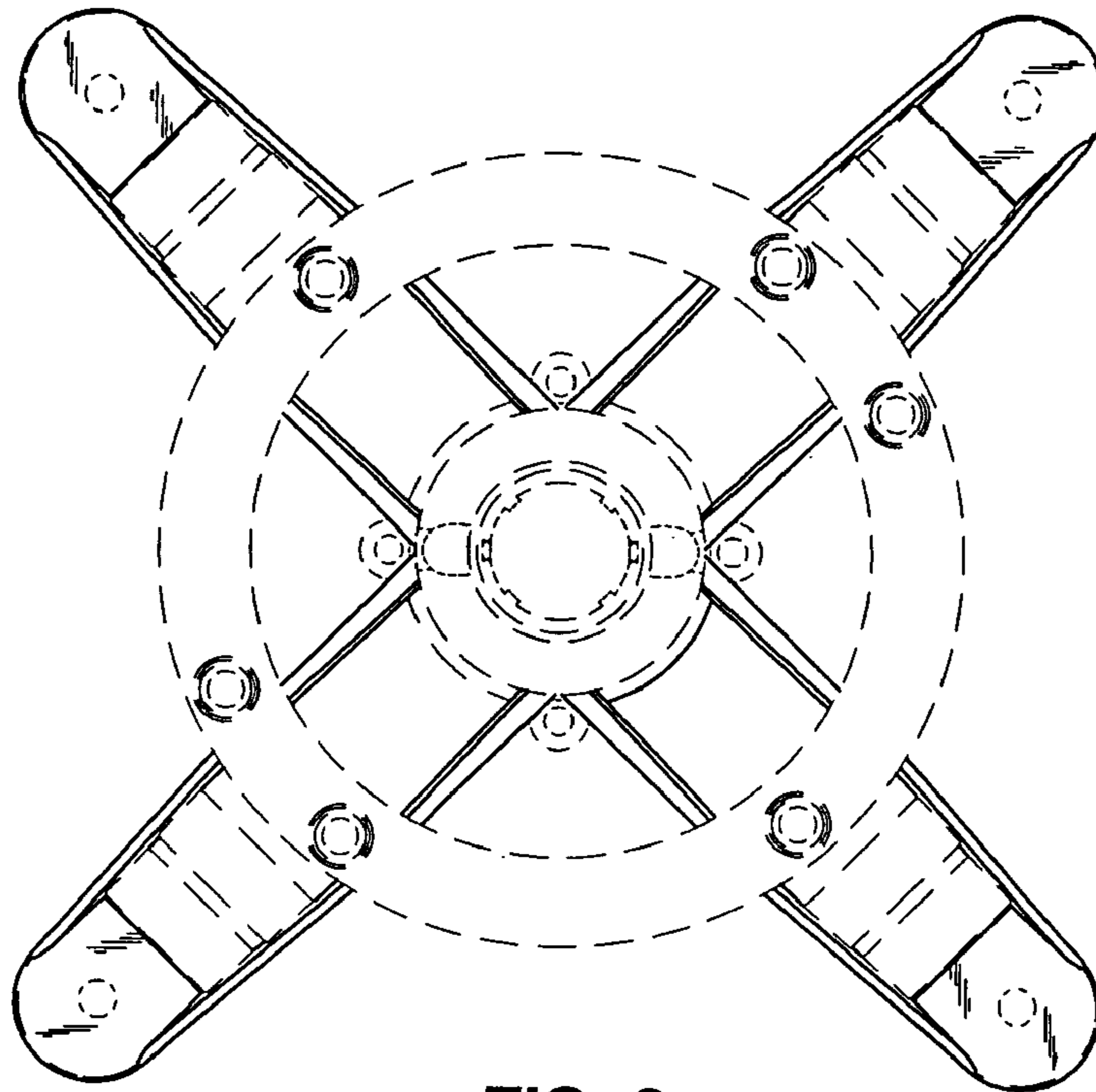

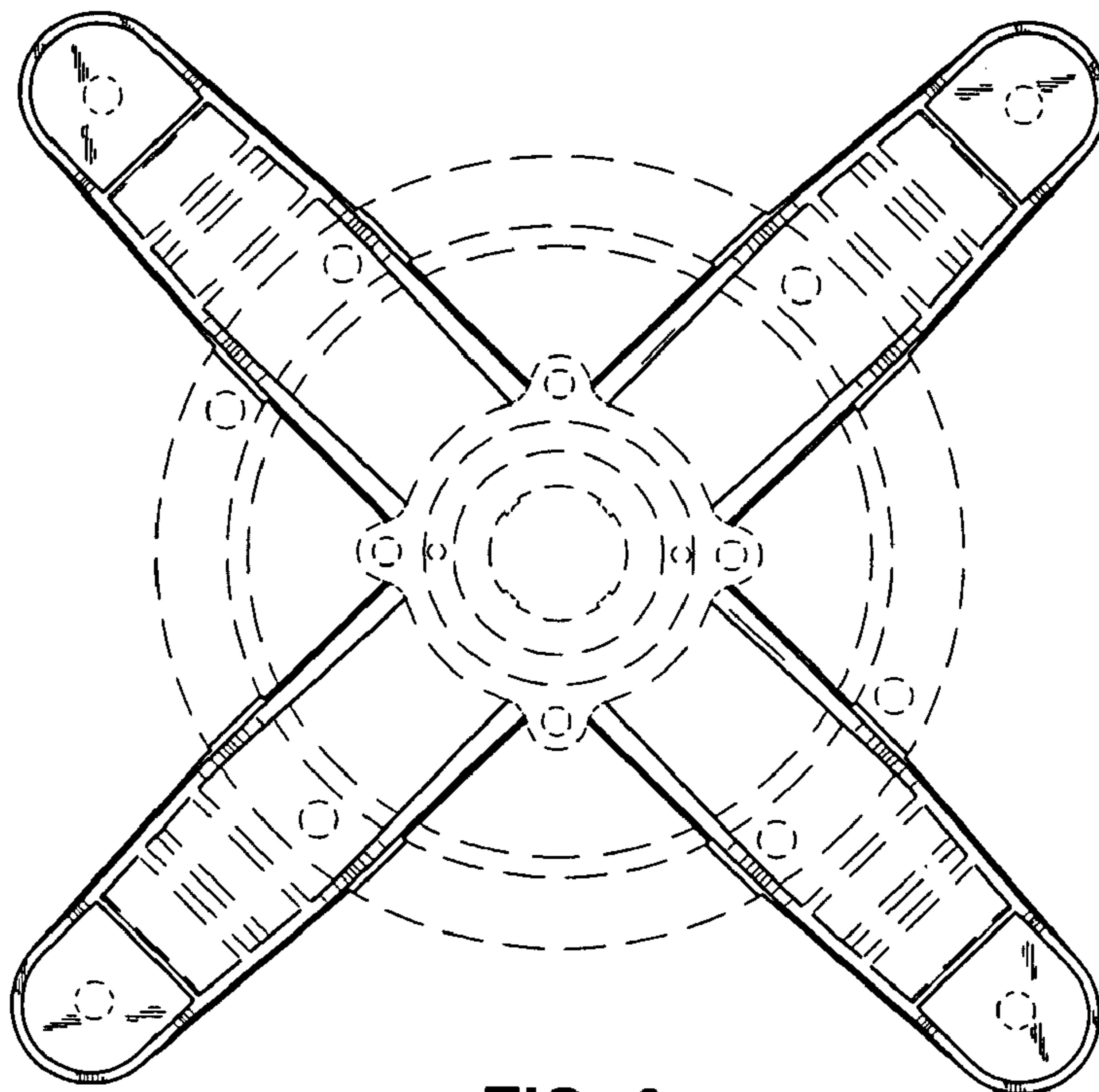

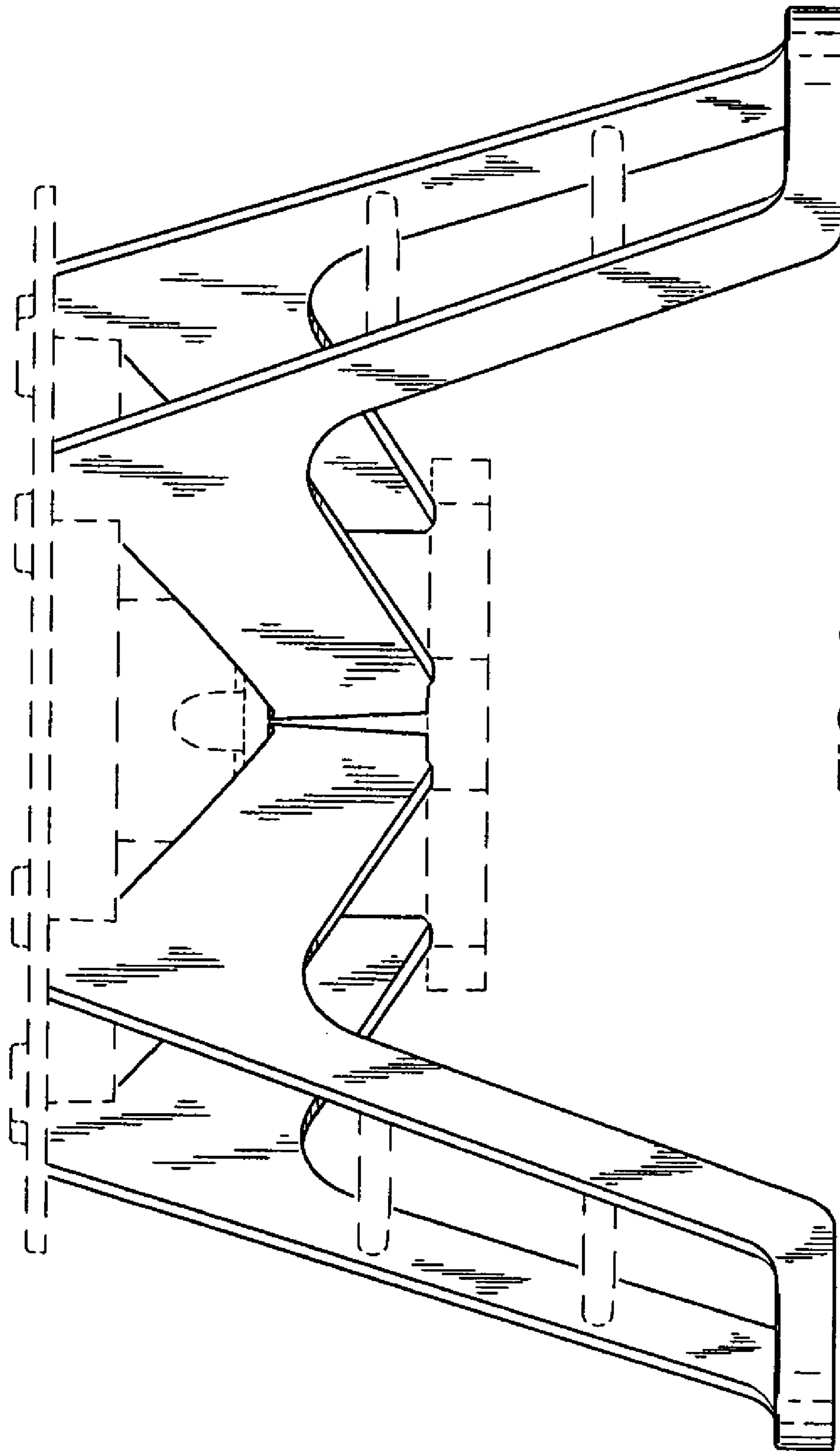
