**DESCRIPTION**

FIG. 1 is a perspective view of the front, right side and bottom of the remote control design;

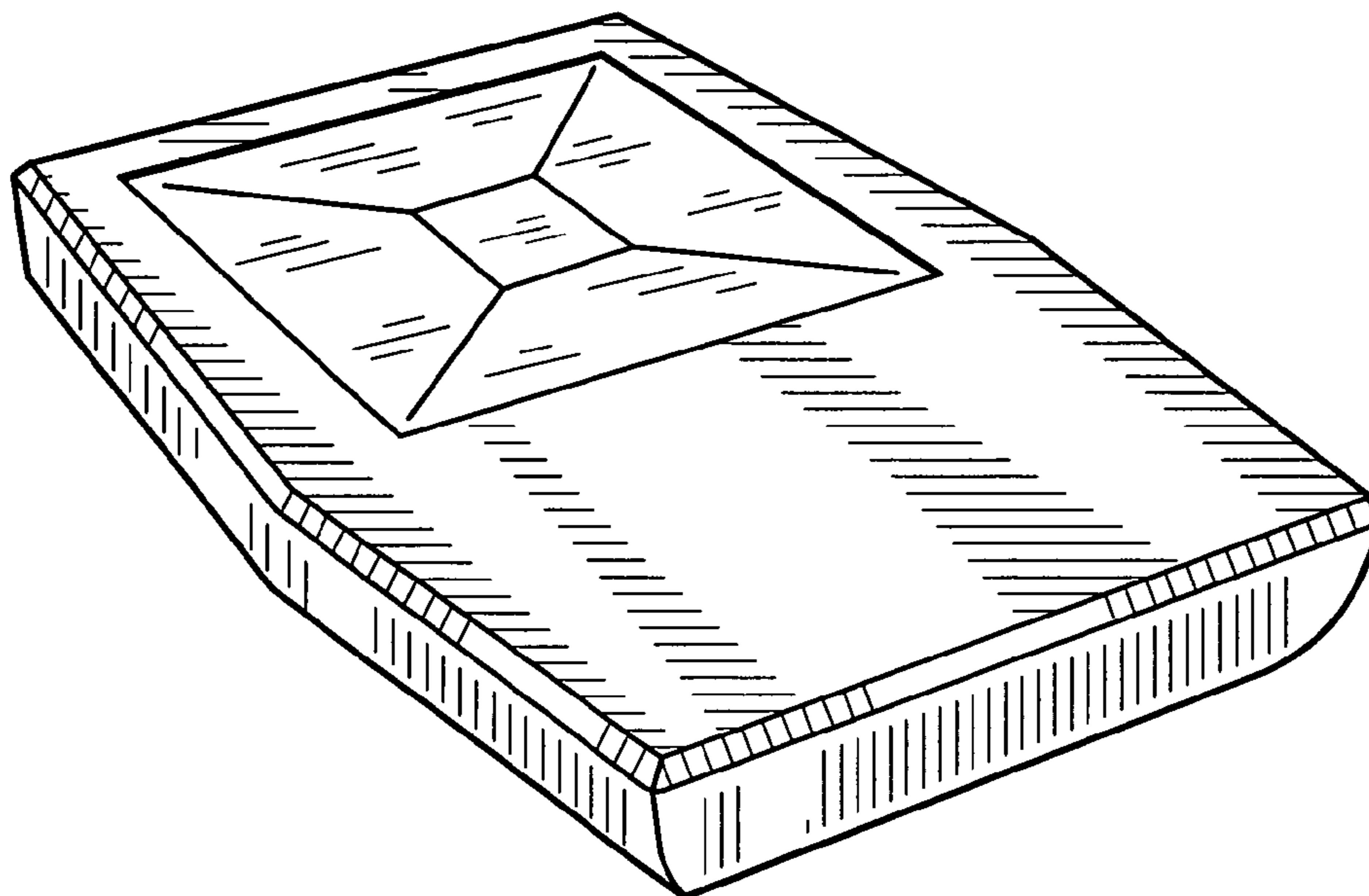
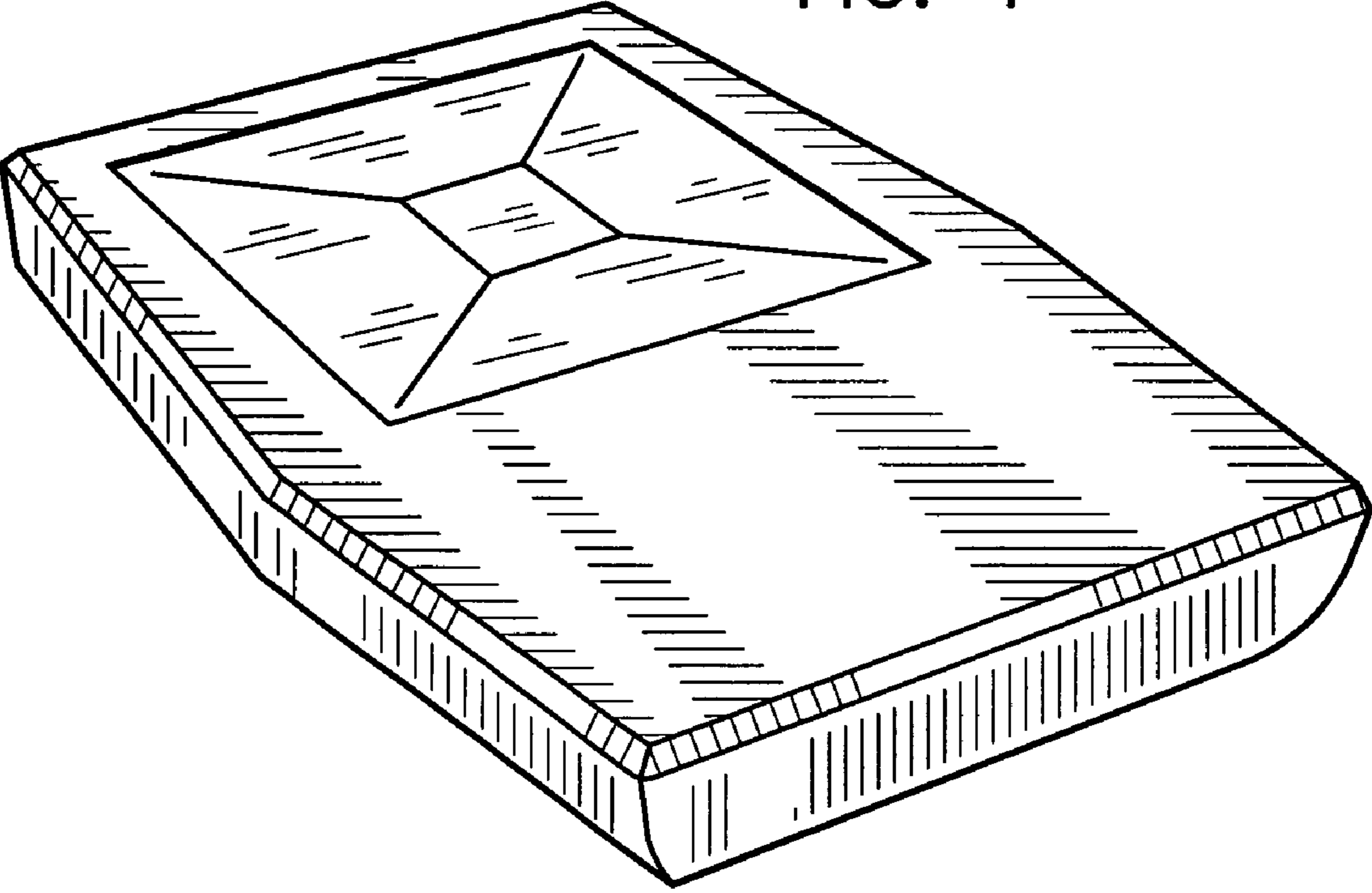

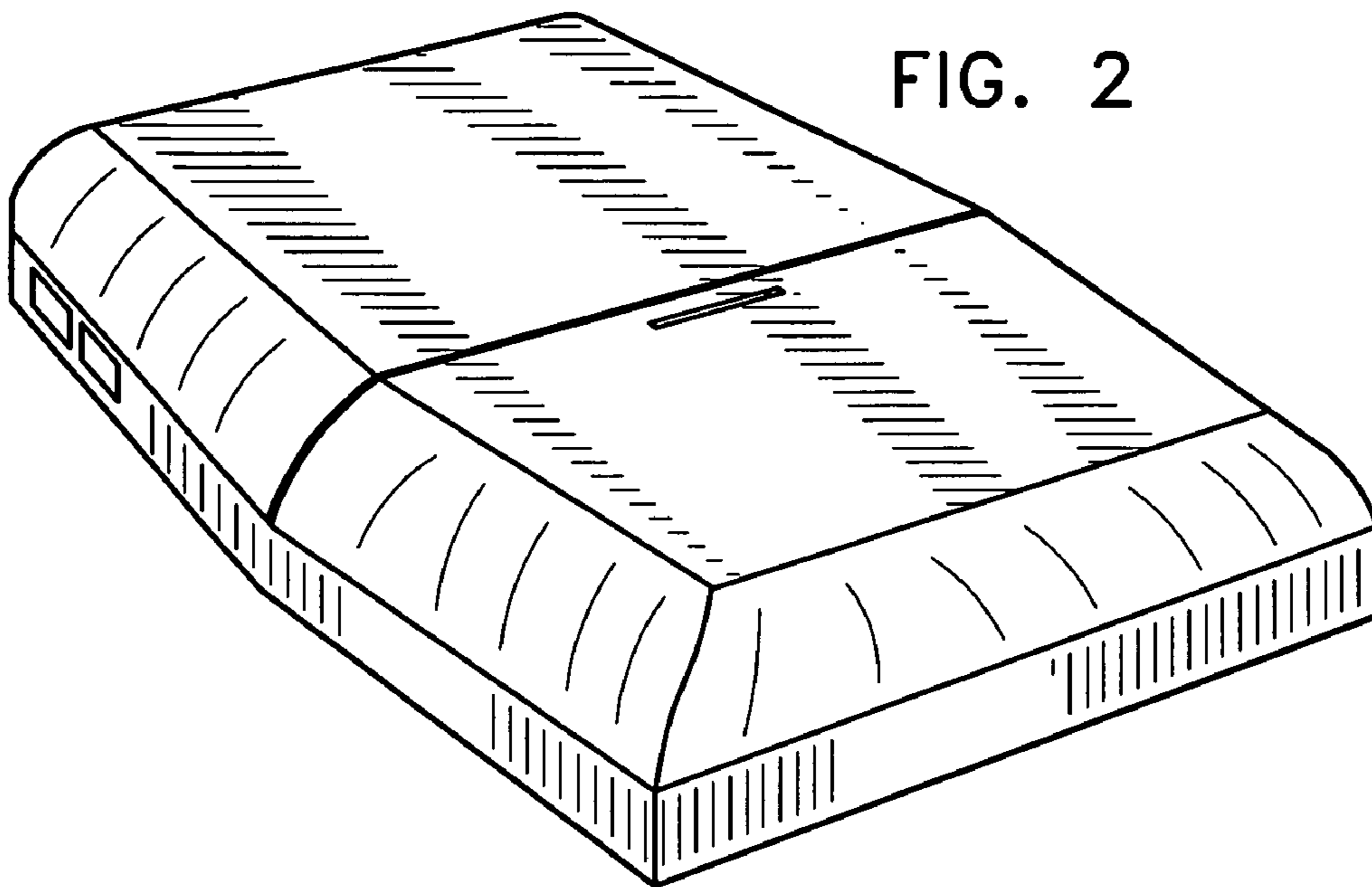

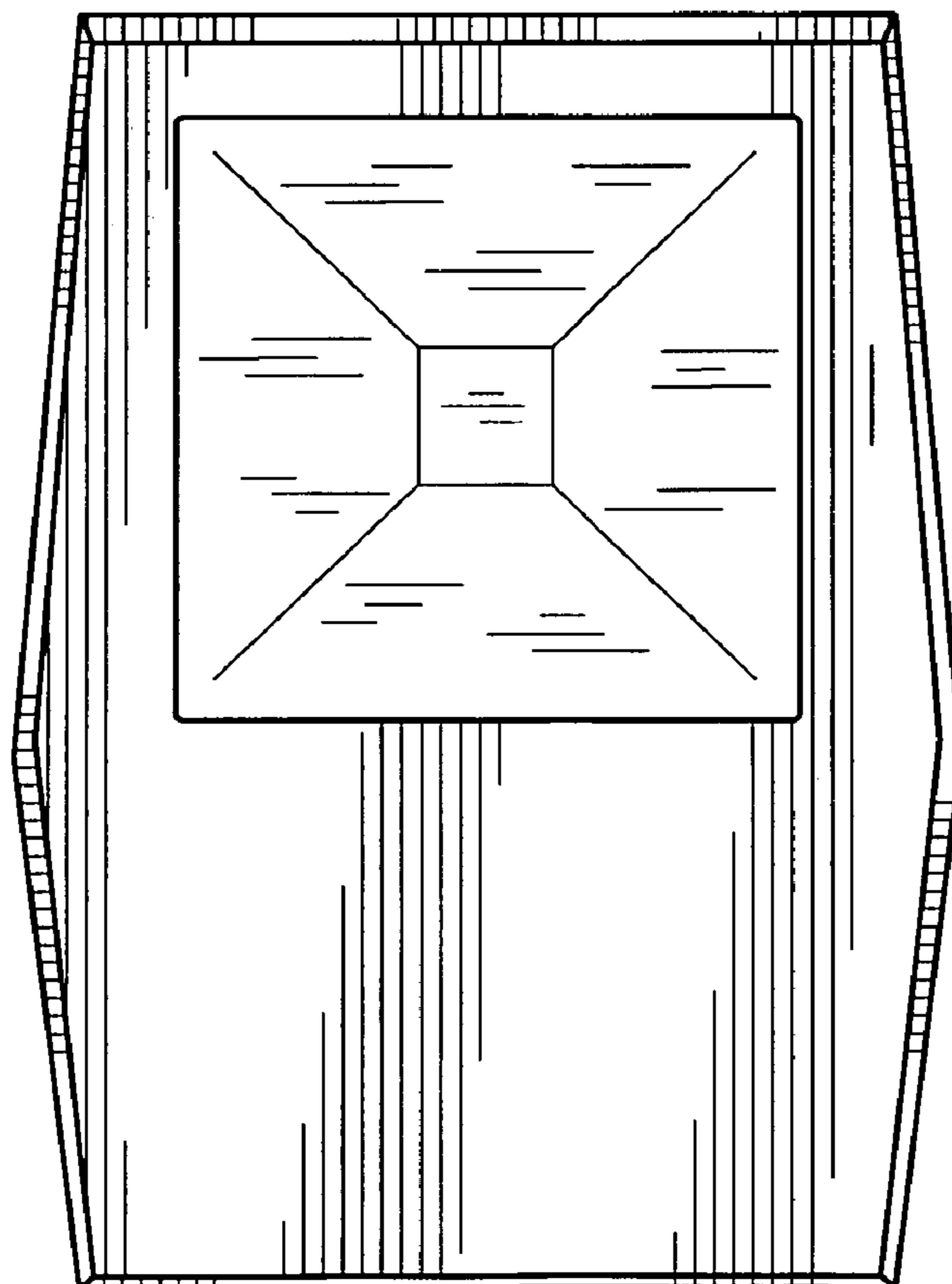

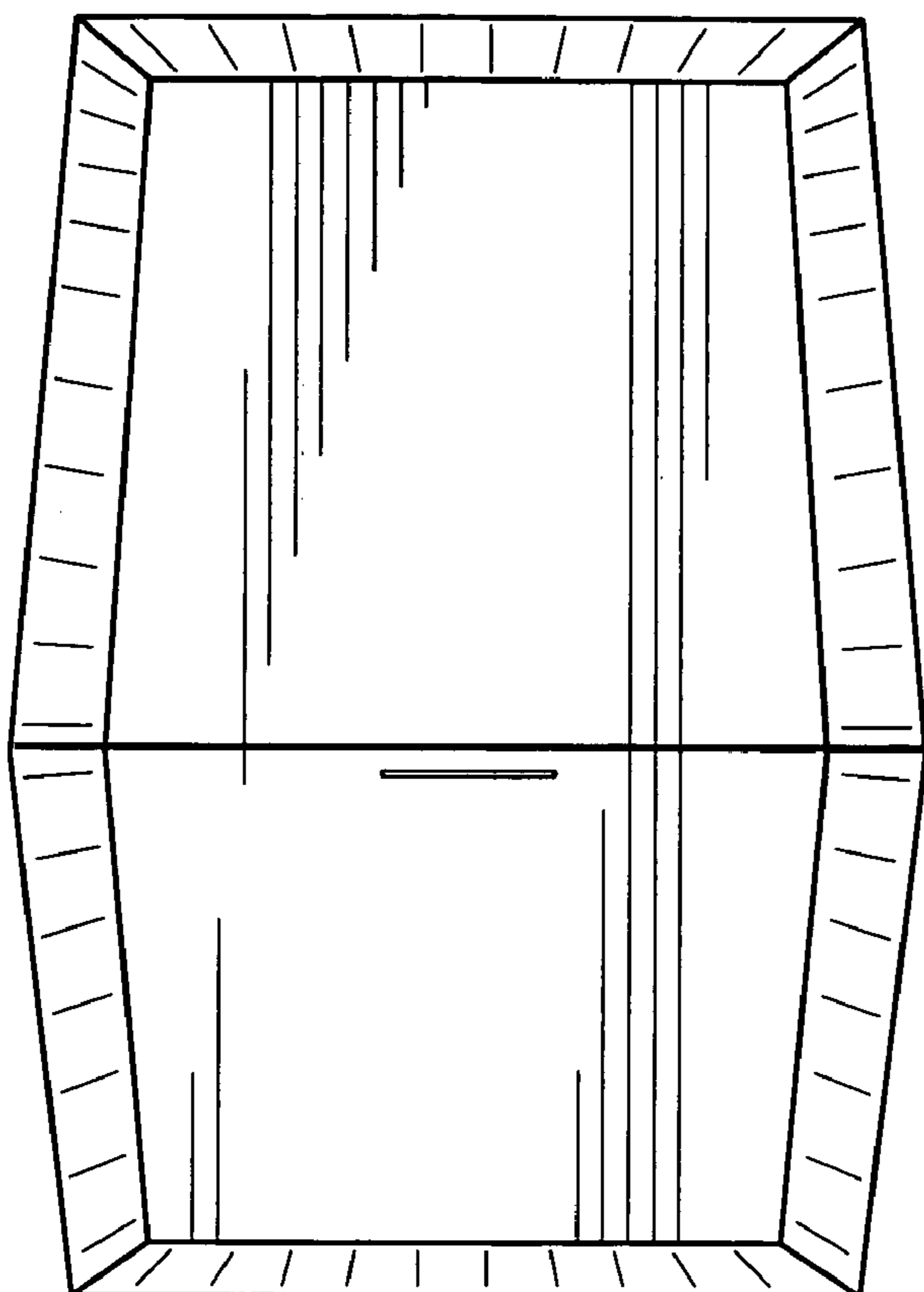

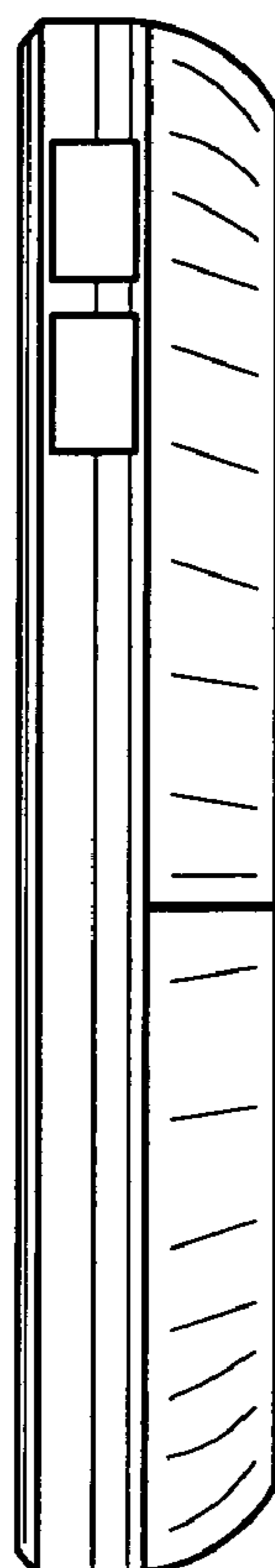

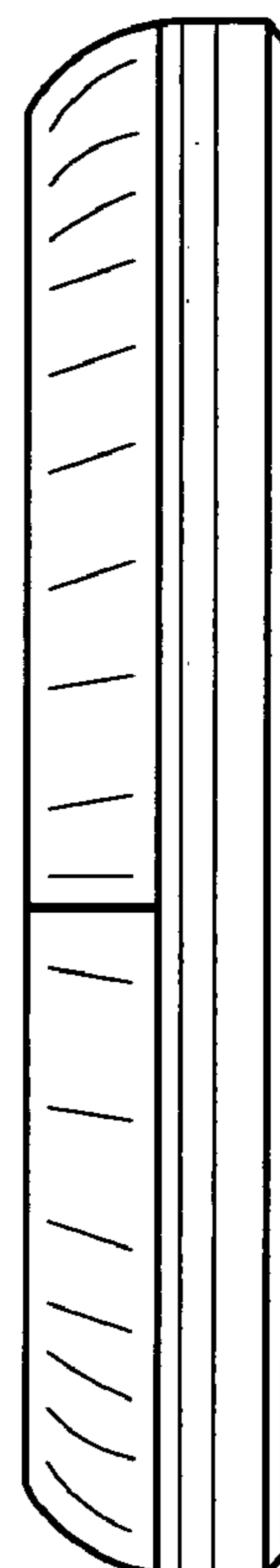
