FIG. 4 is a left-side elevational view thereof;

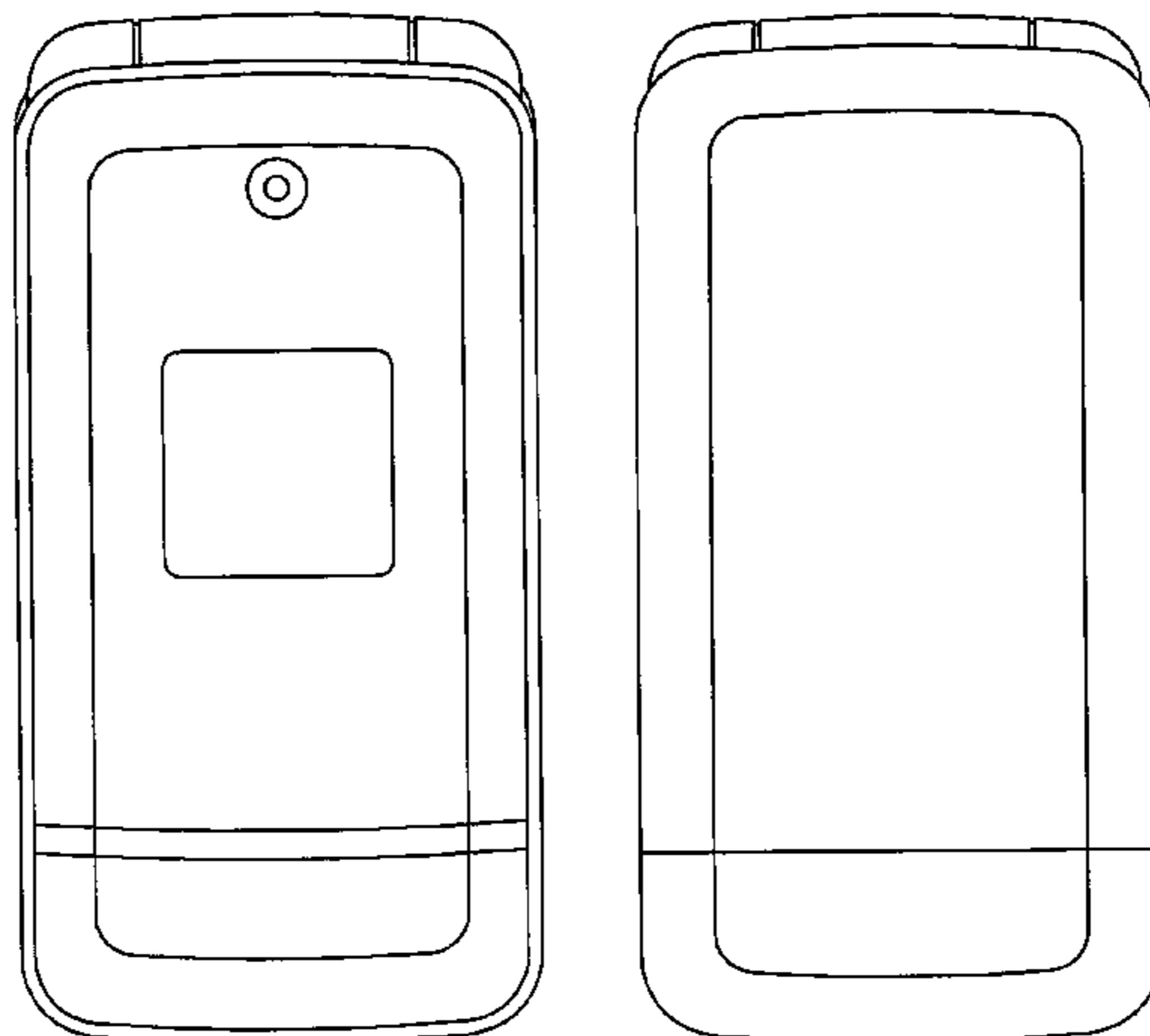
FIG. 5 is a right-side elevational view thereof;

FIG. 6 is a top-side elevational view thereof;

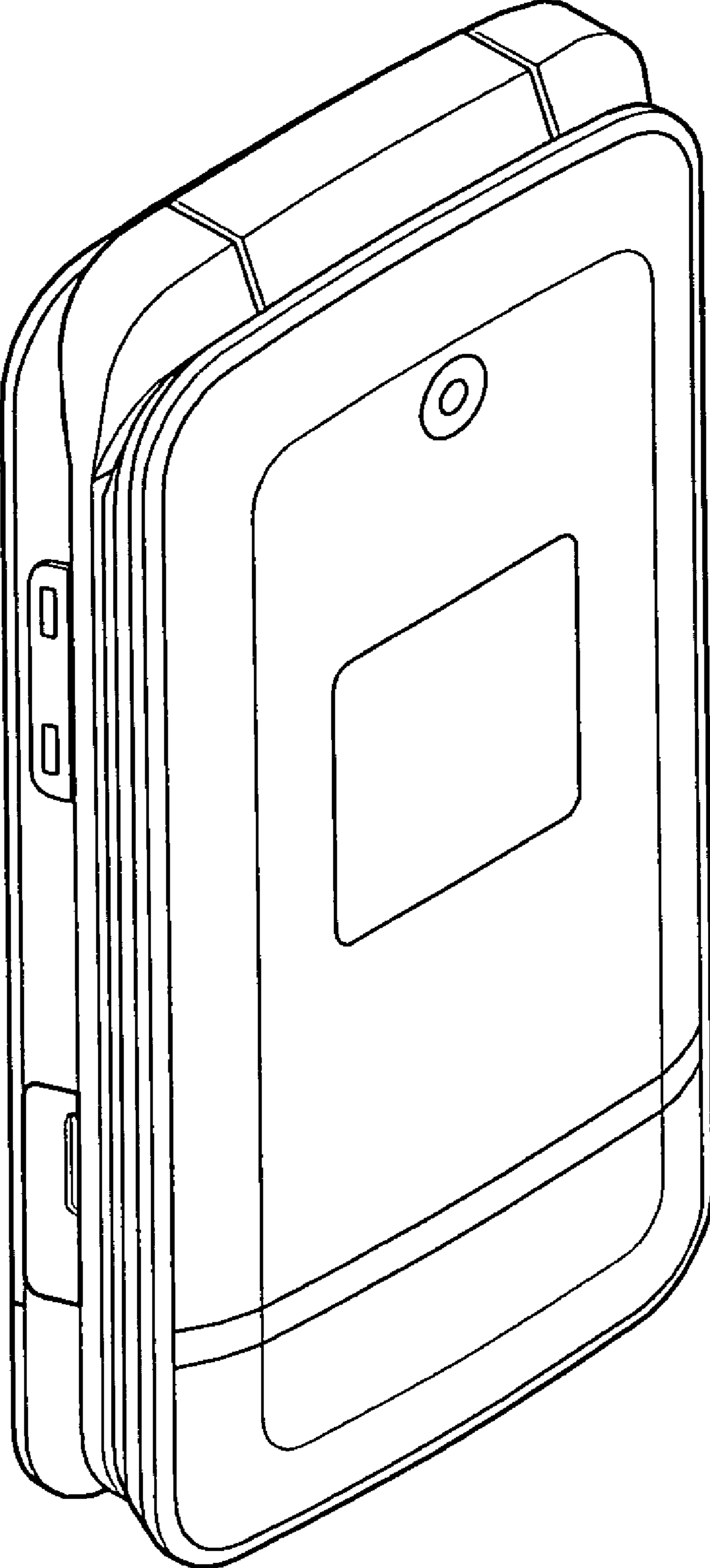
FIG. 7 is a bottom-side elevational view thereof; and,

FIG. 8 is a front/right-side/top perspective view thereof showing that it is opened.

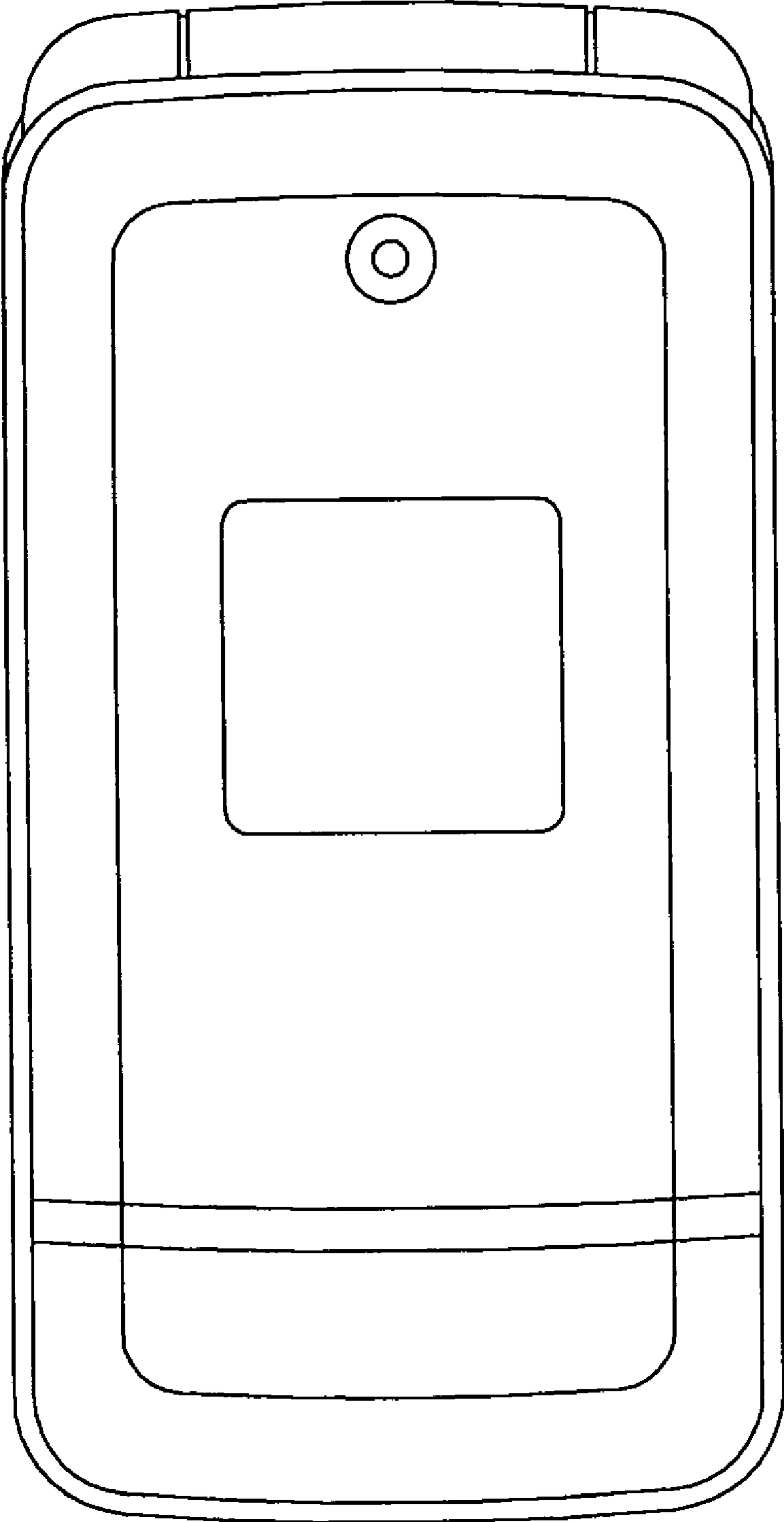

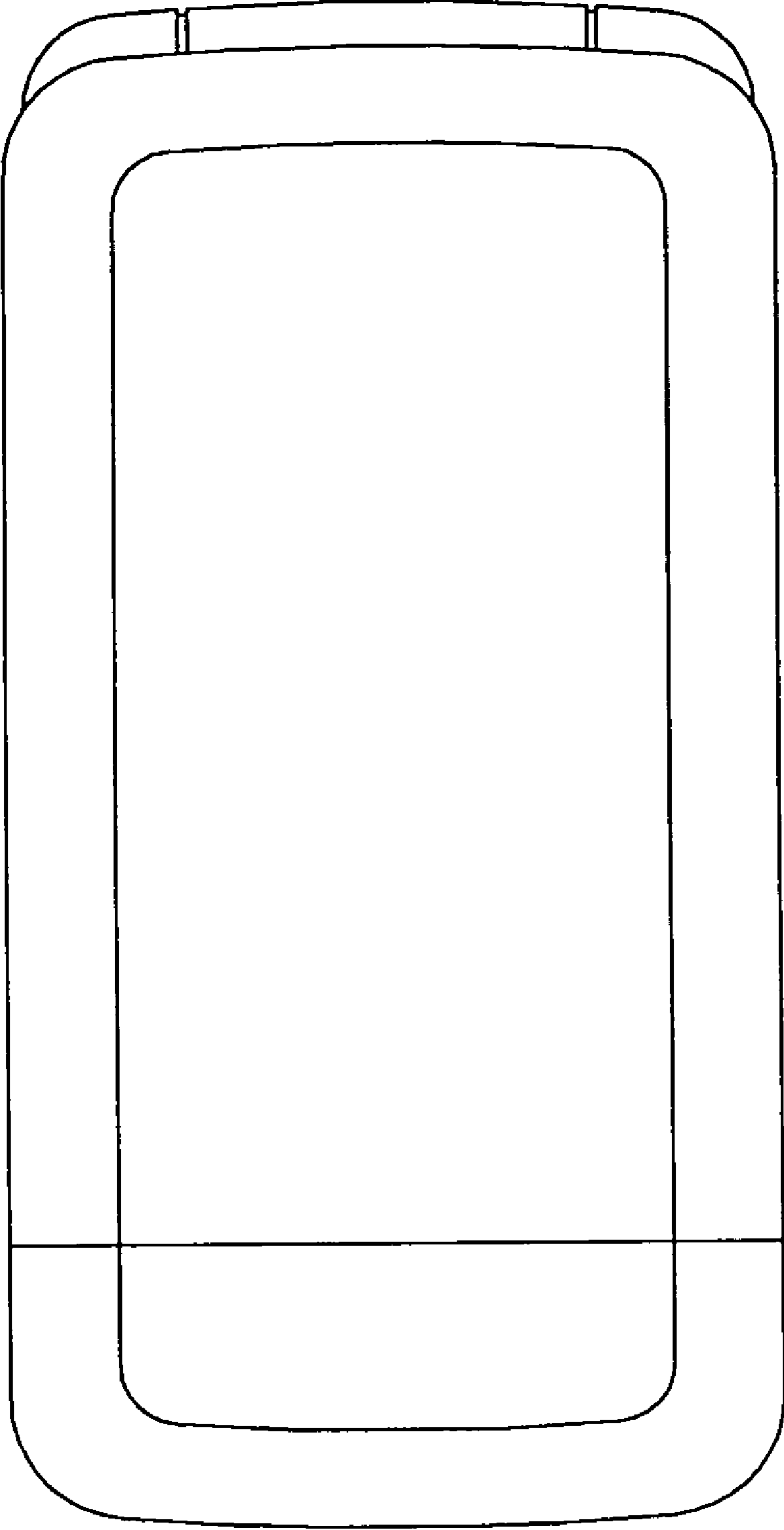

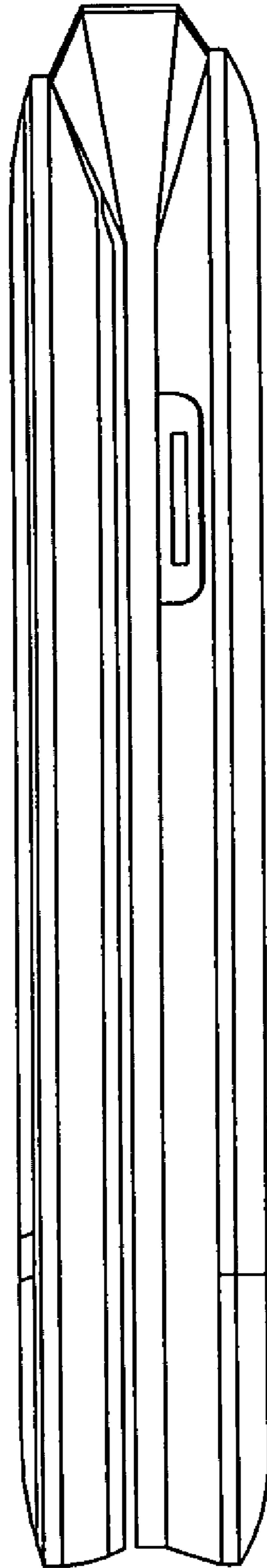

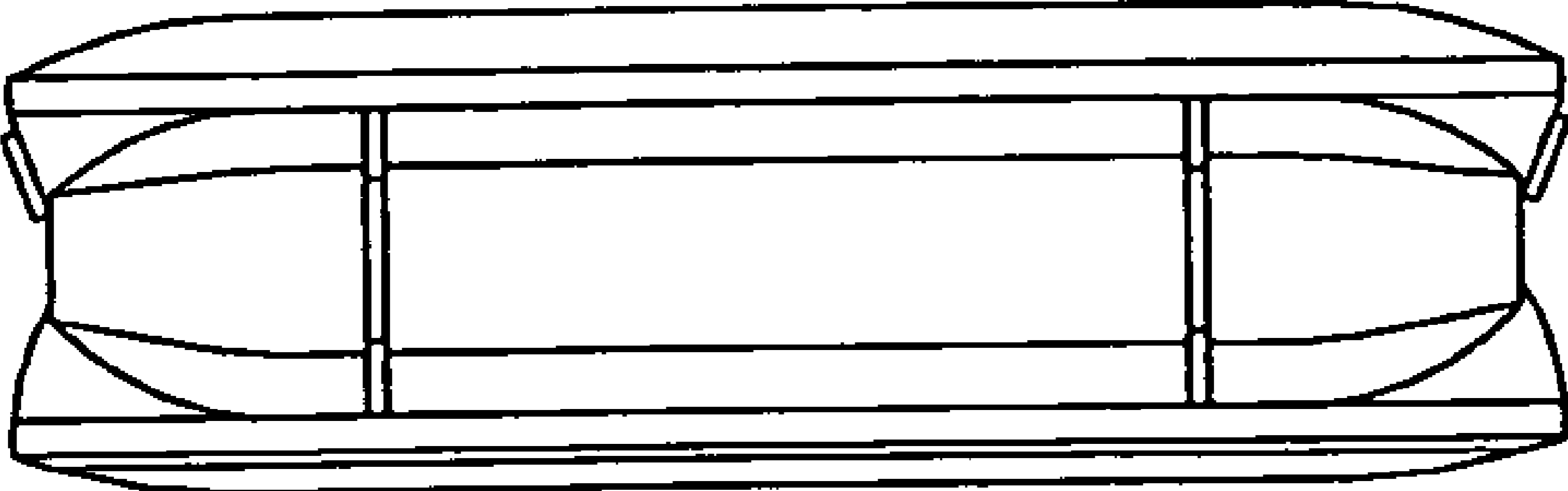

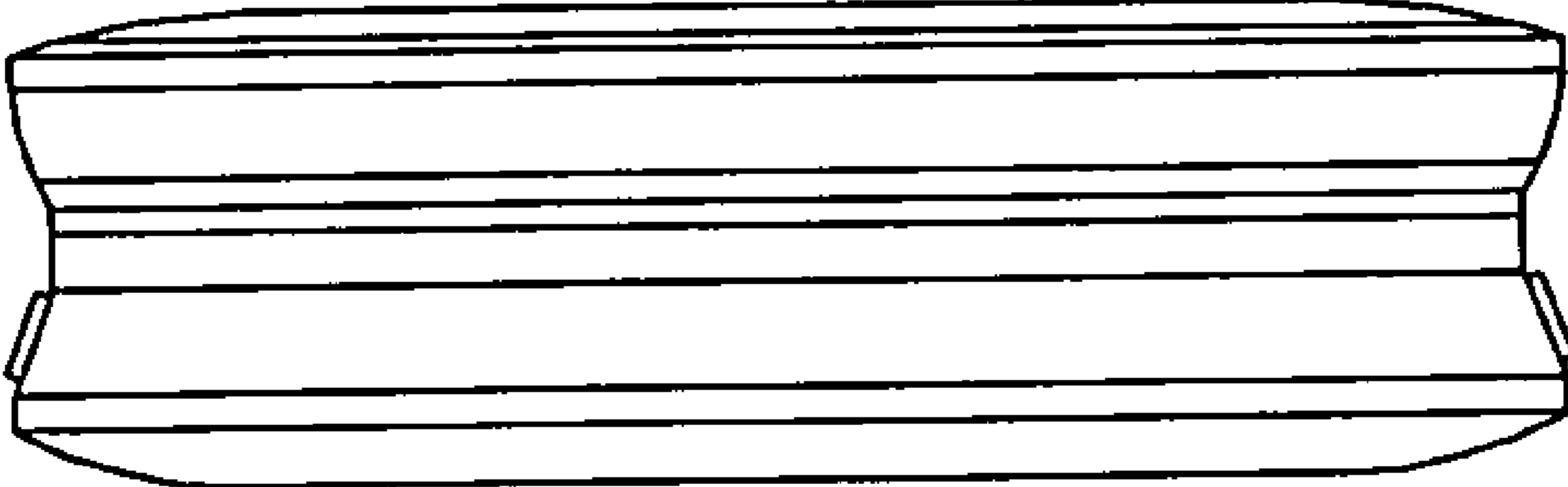
