(57) **CLAIM**

The ornamental design for a support box for supporting a lap top computer holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an support box for supporting a lap top computer holder;

FIG. 2 is a top view of the support box for supporting a lap top computer holder shown in FIG. 1;

FIG. 3 is a front view of the support box for supporting a lap top computer holder shown in FIG. 2; a right side view is mirror-reversed,

FIG. 4 is a rear view of the support box for supporting a lap top computer holder shown in FIG. 2,

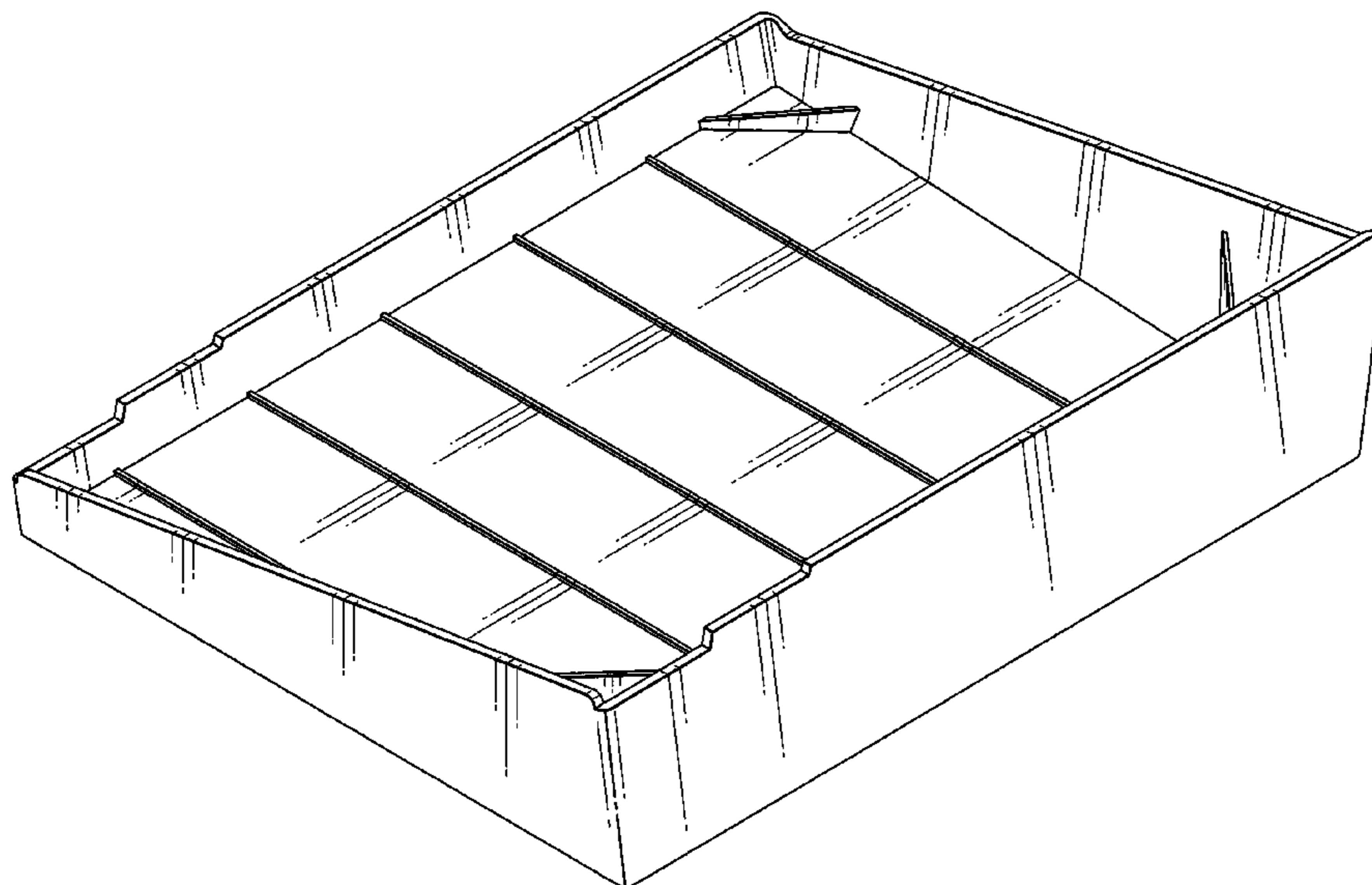
FIG. 5 is a left side view of the support box for supporting a lap top computer holder shown in FIG. 2,

FIG. 6 is a right side view of the support box for supporting a lap top computer holder shown in FIG. 2; and,

FIG. 7 is a bottom view of the support box for supporting a lap top computer holder shown in FIG. 2.

The support box for supporting a lap top computer holder is used for supporting a computer holder in a level position on an inclined seat surface for example a car seat.

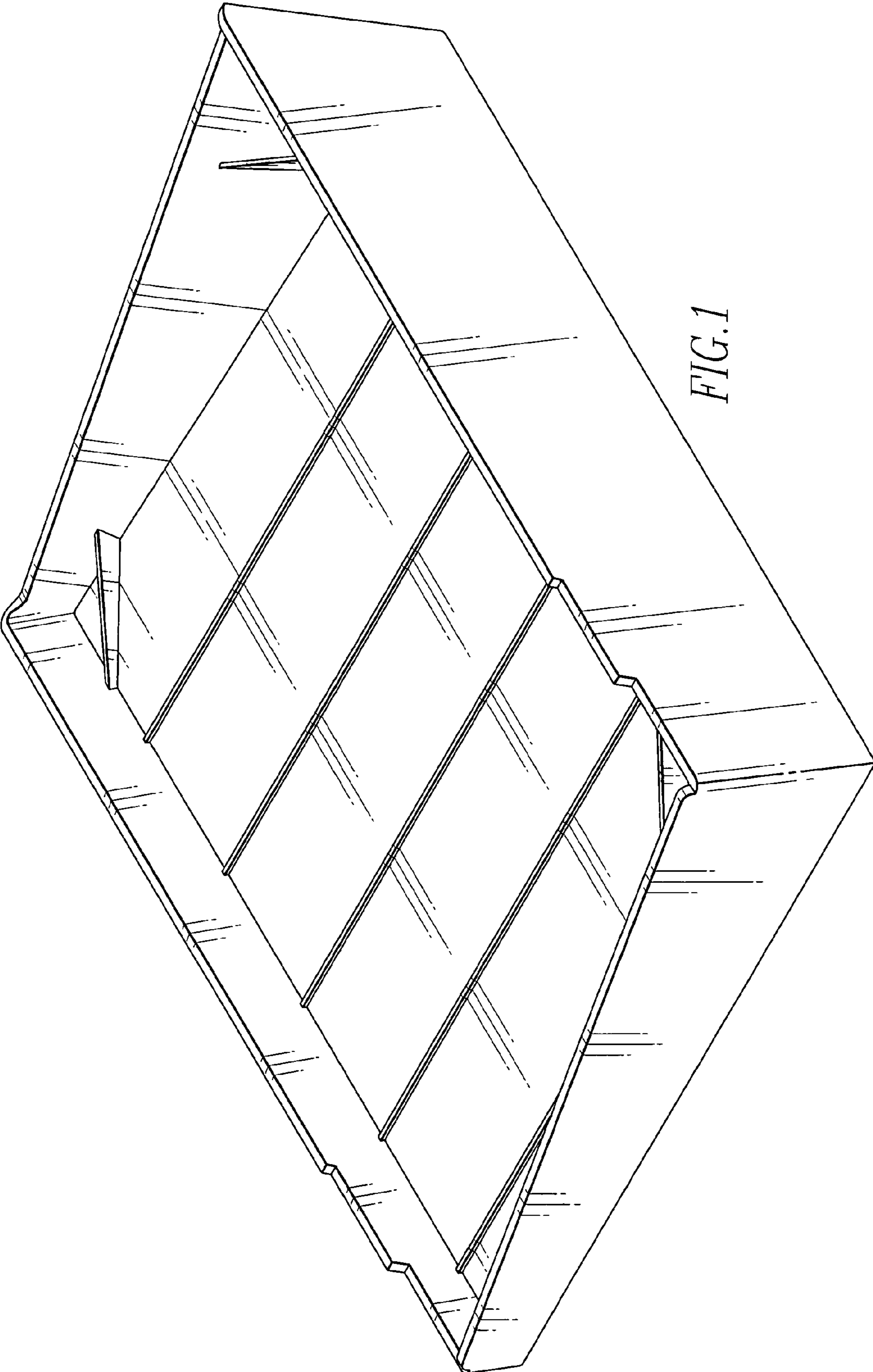

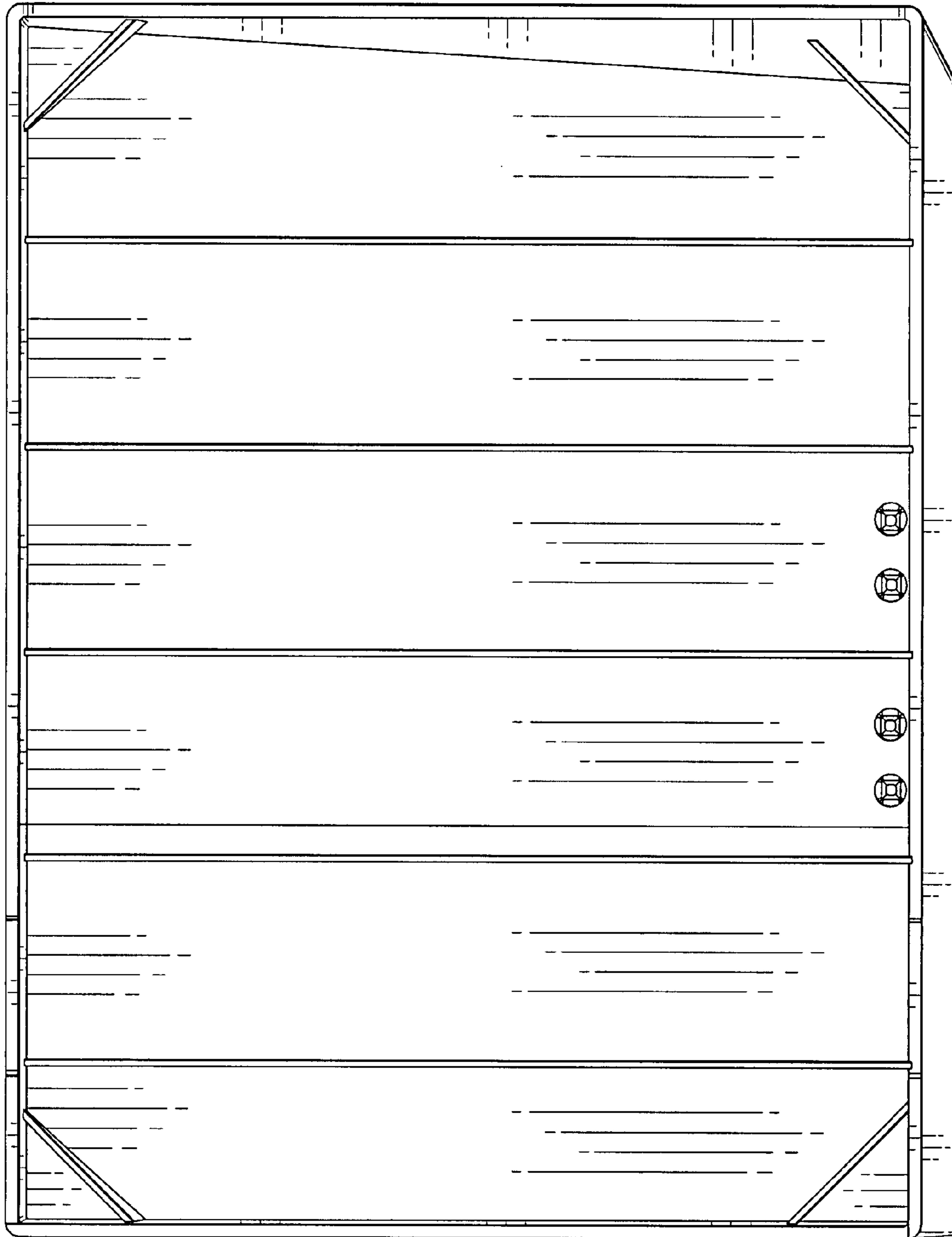

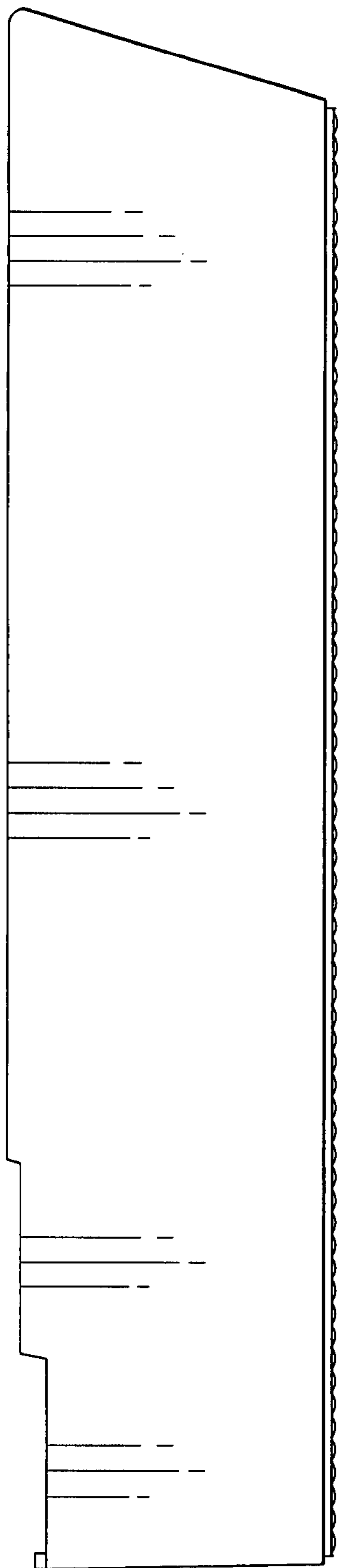

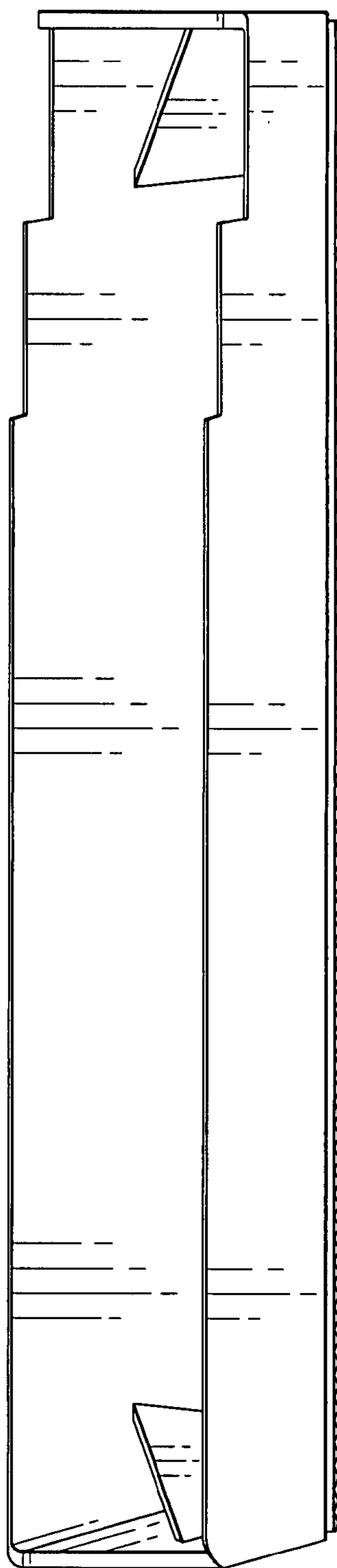

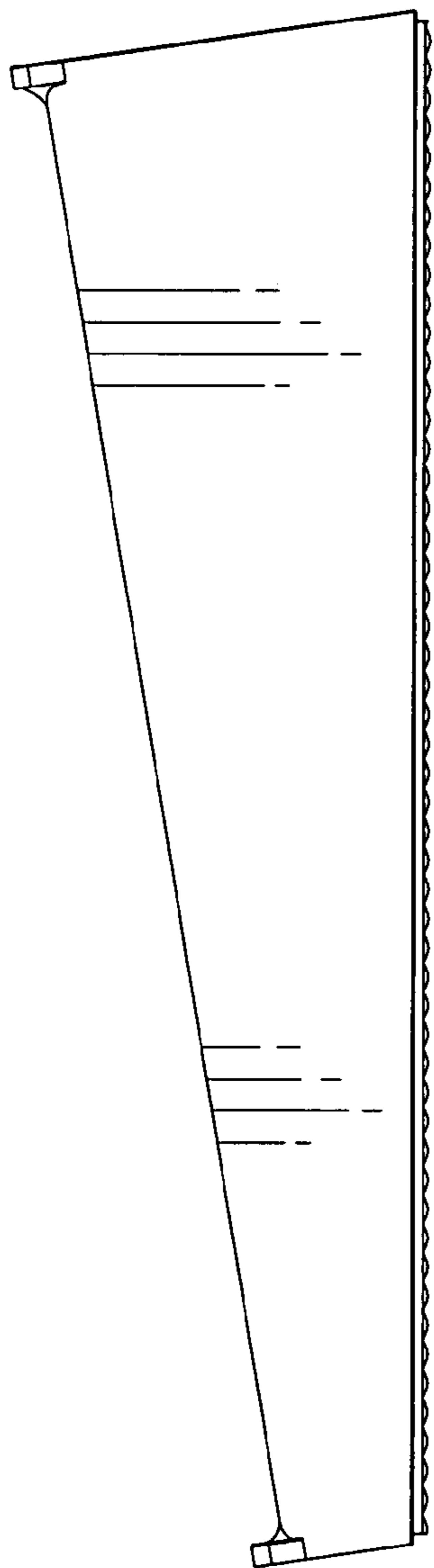

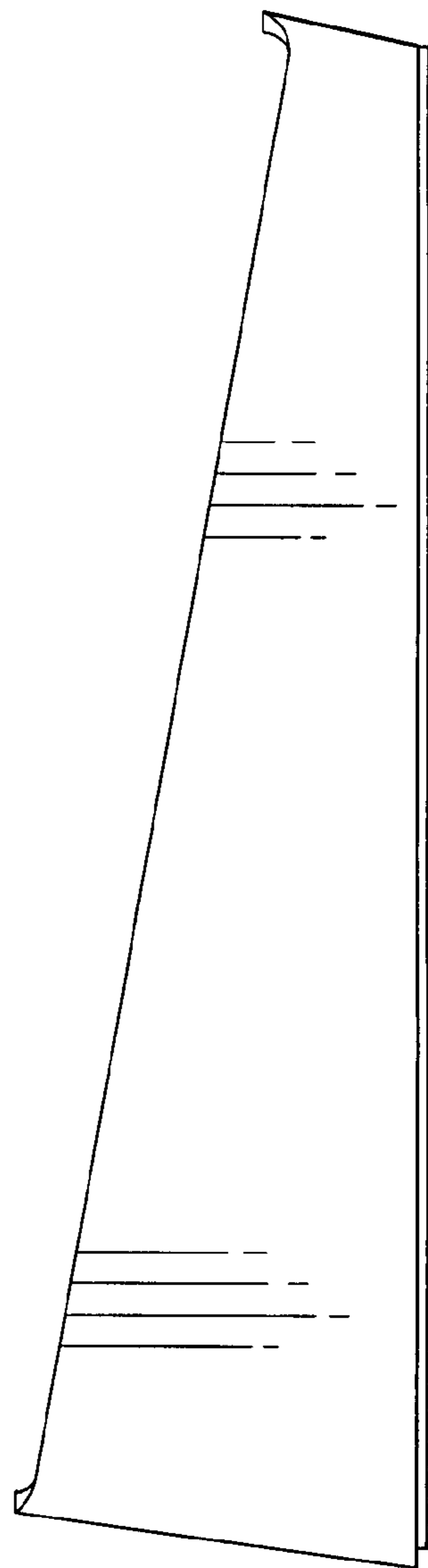

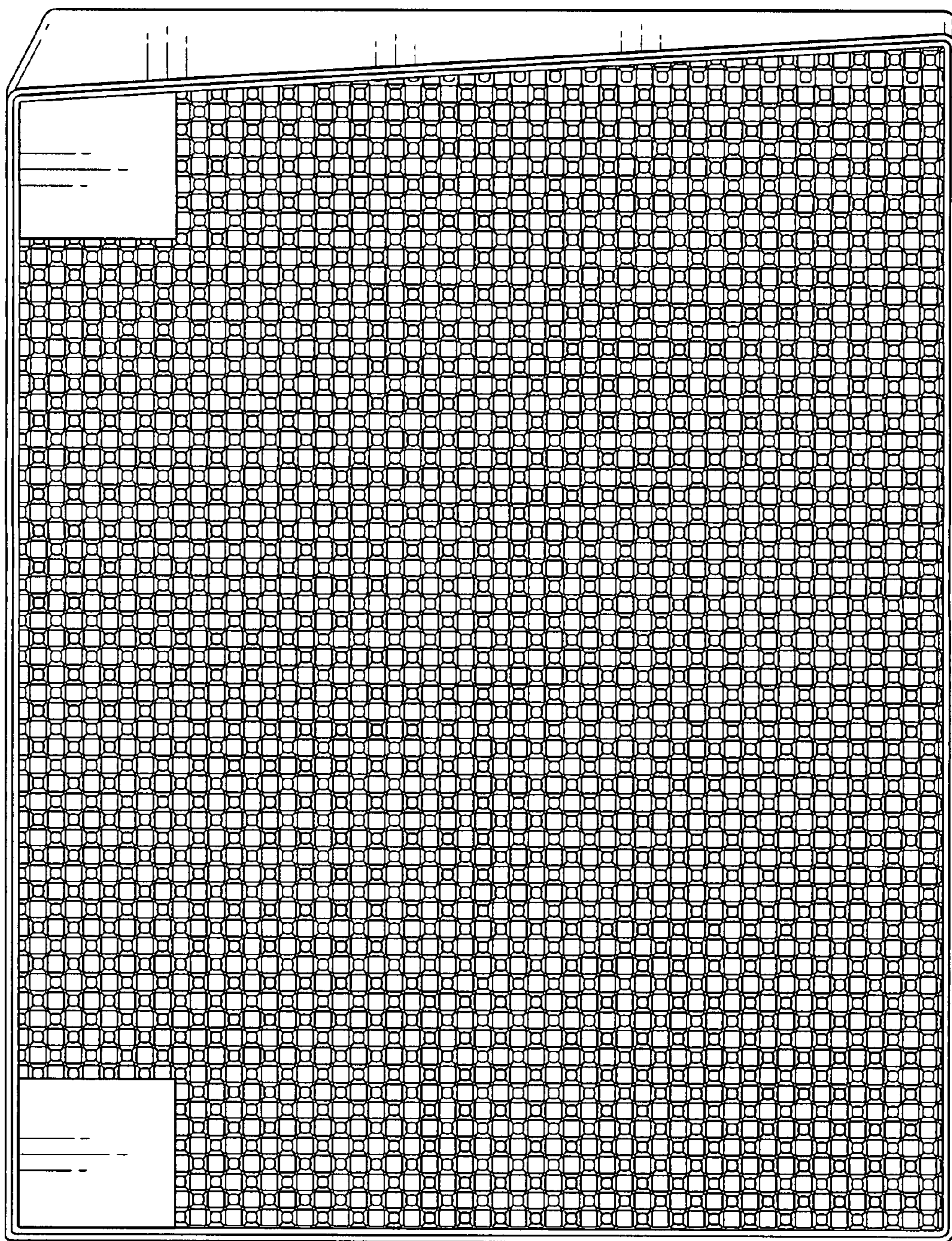
