(57) **CLAIM**

The ornamental design for a grinding chamber side liner, as shown and described.

DESCRIPTION

This patent application claims priority to U.S. patent application Ser. No. 11/070,525, filed Mar. 2, 2005, which is incorporated by reference herein in its entirety.

FIG. 1 is a perspective view of a grinding chamber side liner according to a first representative embodiment of the present invention.

FIG. 2 is a front view of the grinding chamber side liner shown in FIG. 1.

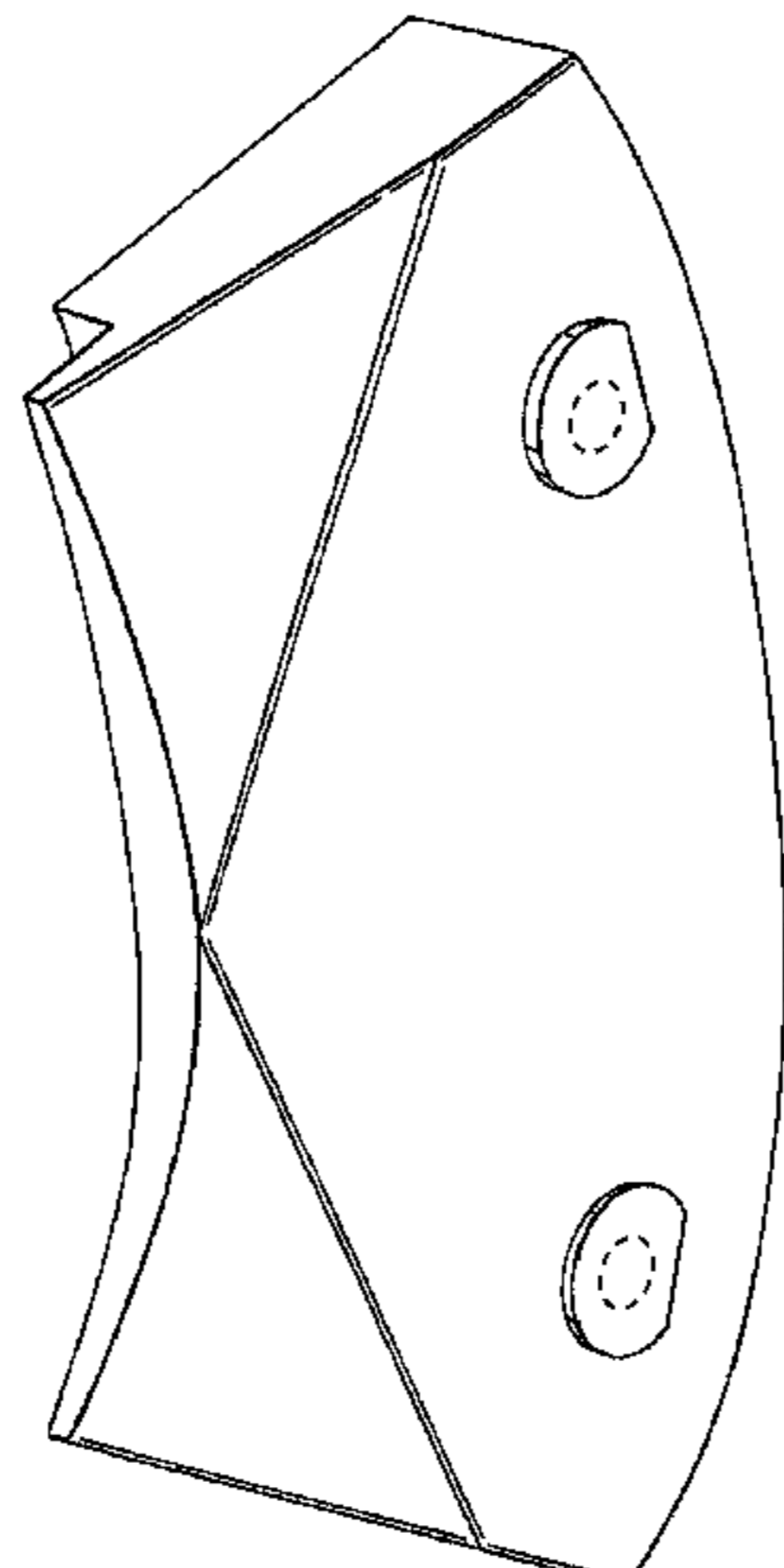
FIG. 3 is a front view of a grinding chamber side liner according to a second representative embodiment of the present invention.

FIG. 4 is a front view of a grinding chamber side liner according to a third representative embodiment of the present invention; and,

FIG. 5 is a front view of the grinding chamber side liner shown in FIG. 1, showing environment in broken lines, the environment being shown partially cut away and including an adjacent portion of a grinding chamber and a portion of an adjacent grinding chamber side liner.

The broken line showing is included for the purpose of illustrating environment and forms no part of the claimed design.

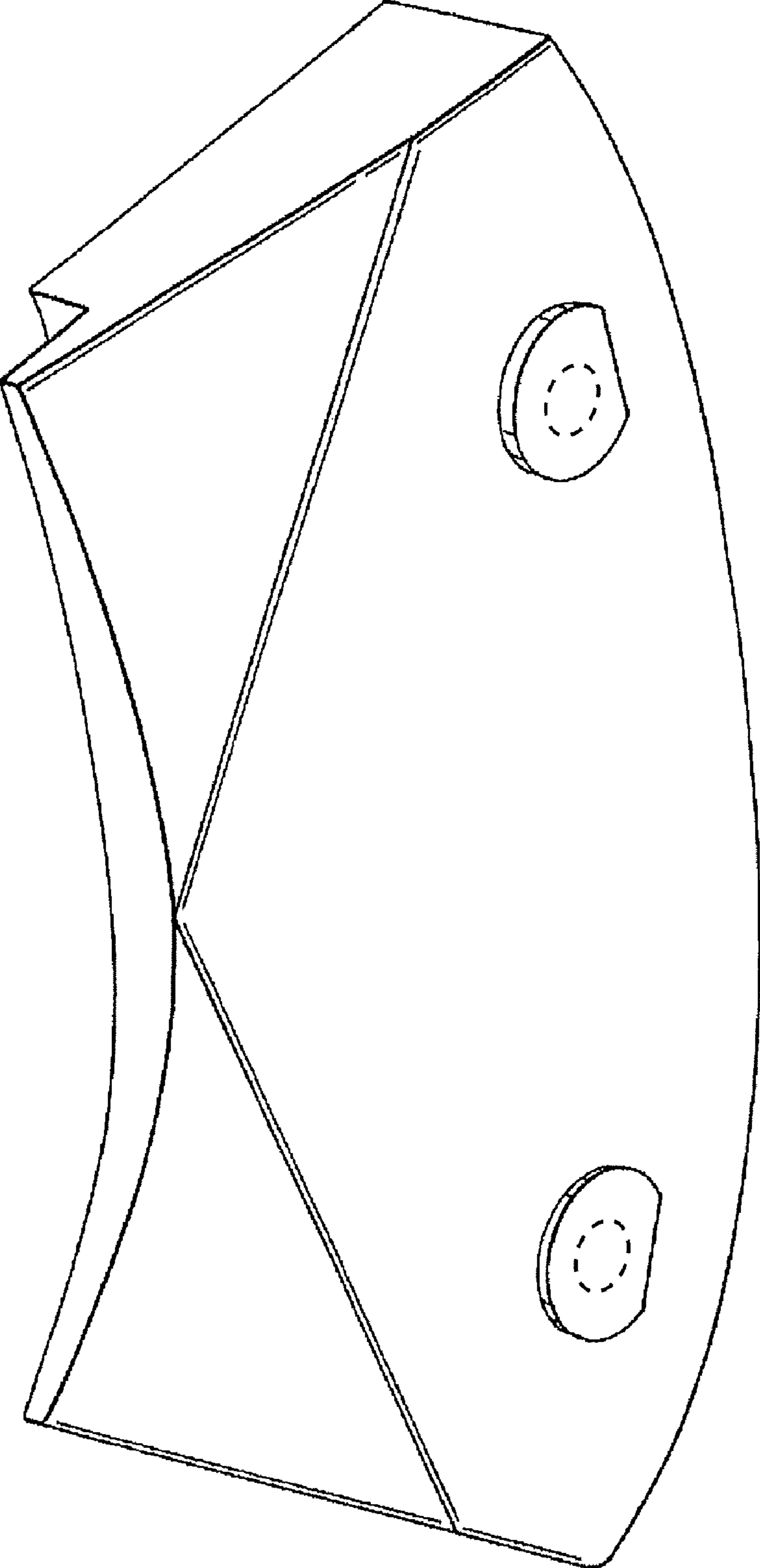

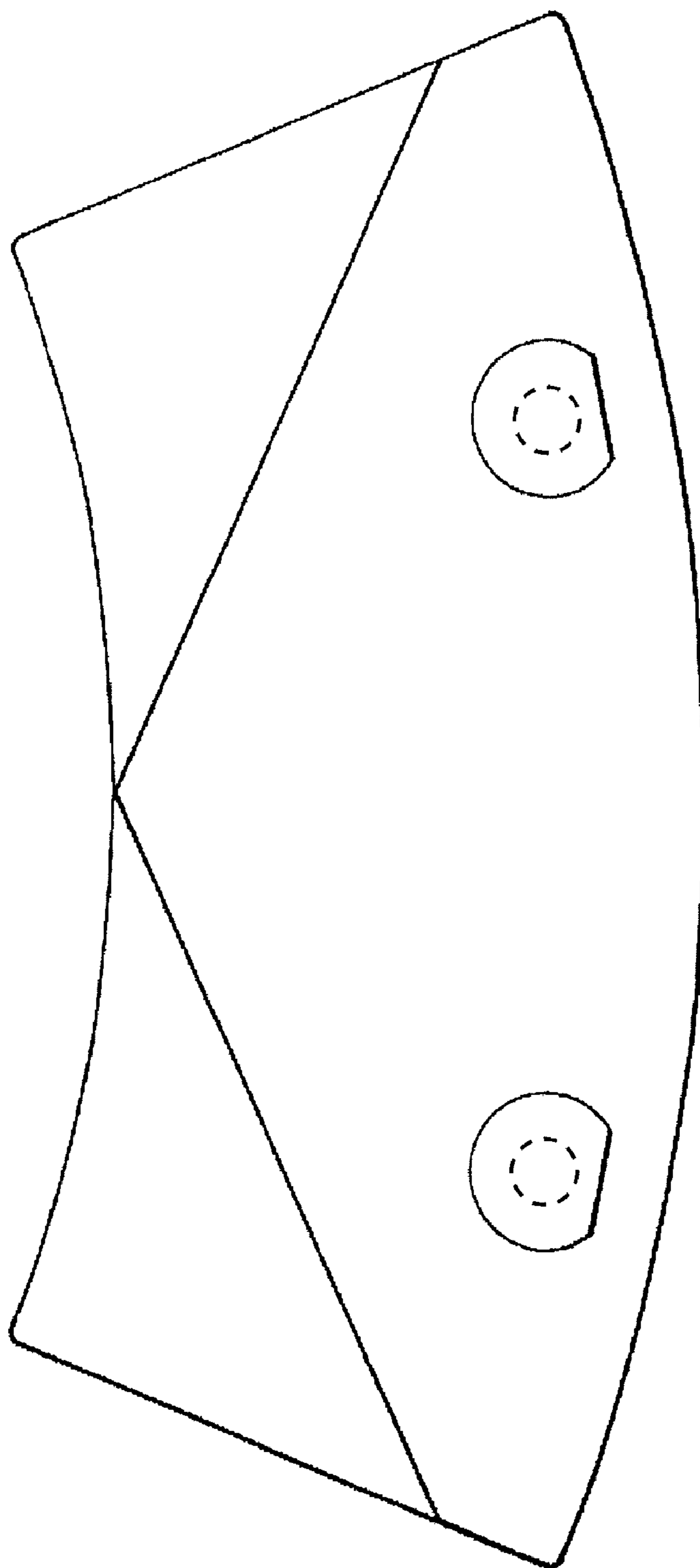

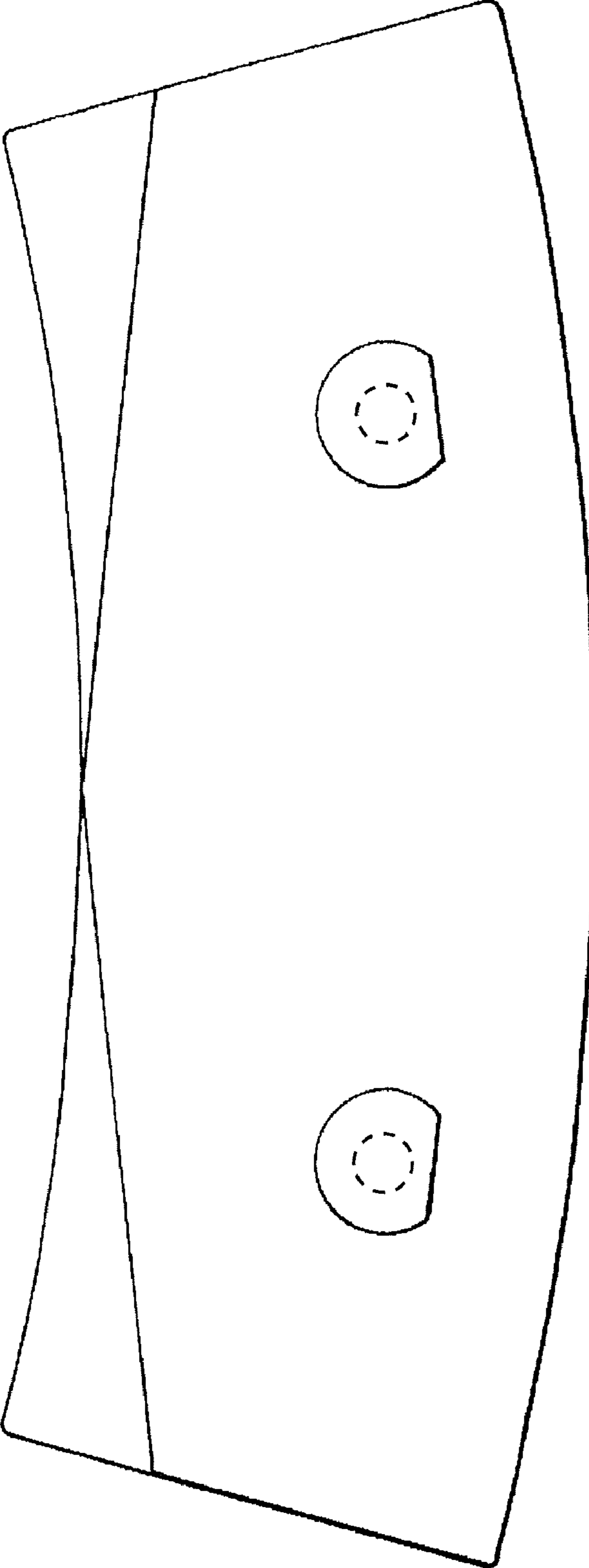
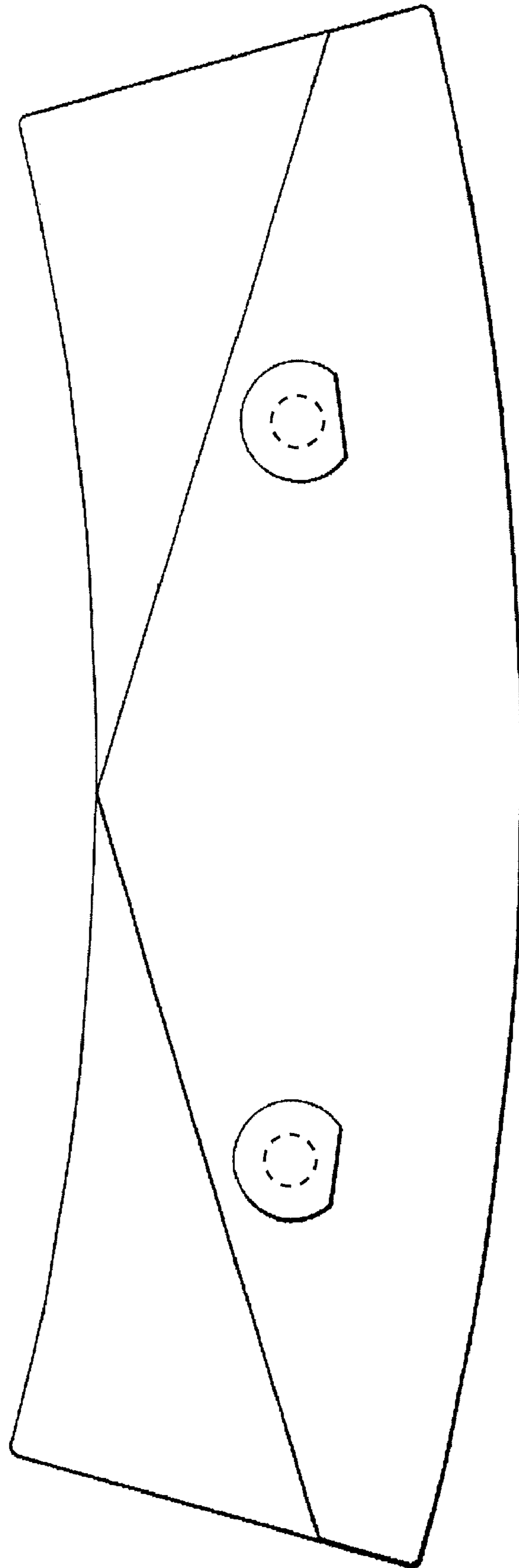

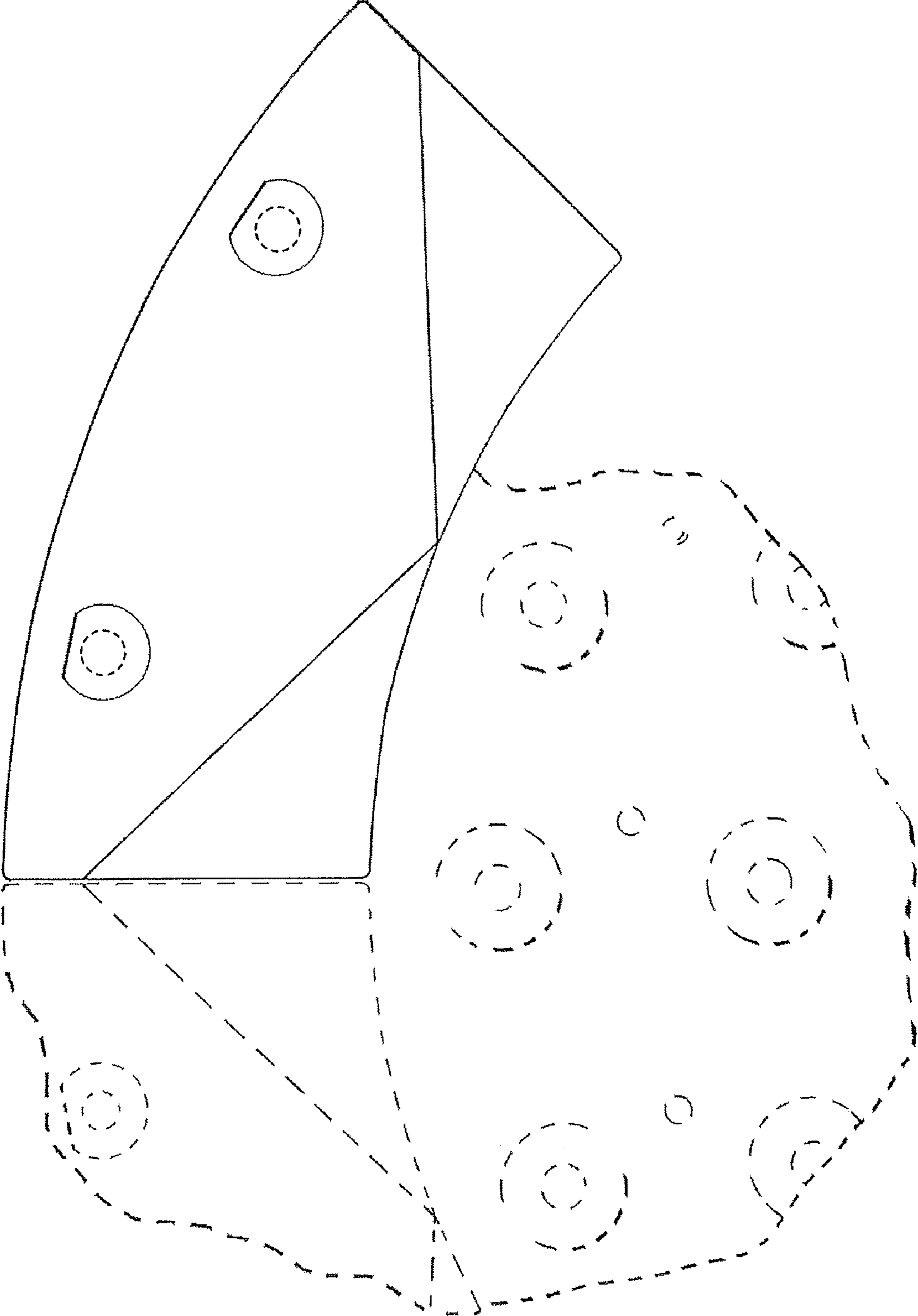
