The ornamental design for an orthotic device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an orthotic device showing our design.

FIG. 2 is a side elevational view of the device of FIG. 1.

FIG. 3 is a top plan view of the device of FIG. 1.

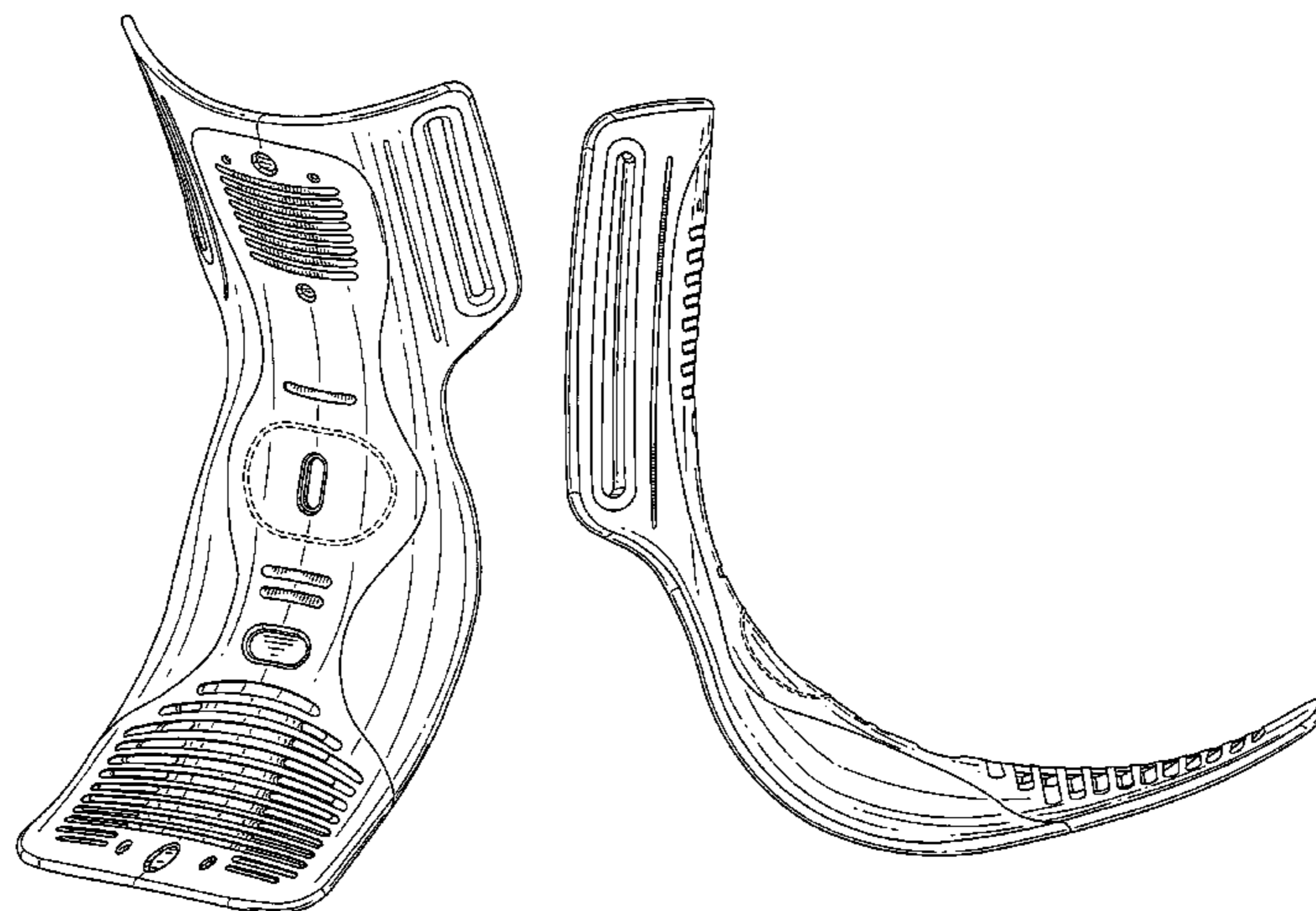
FIG. 4 is a bottom plan view of the device of FIG. 1.

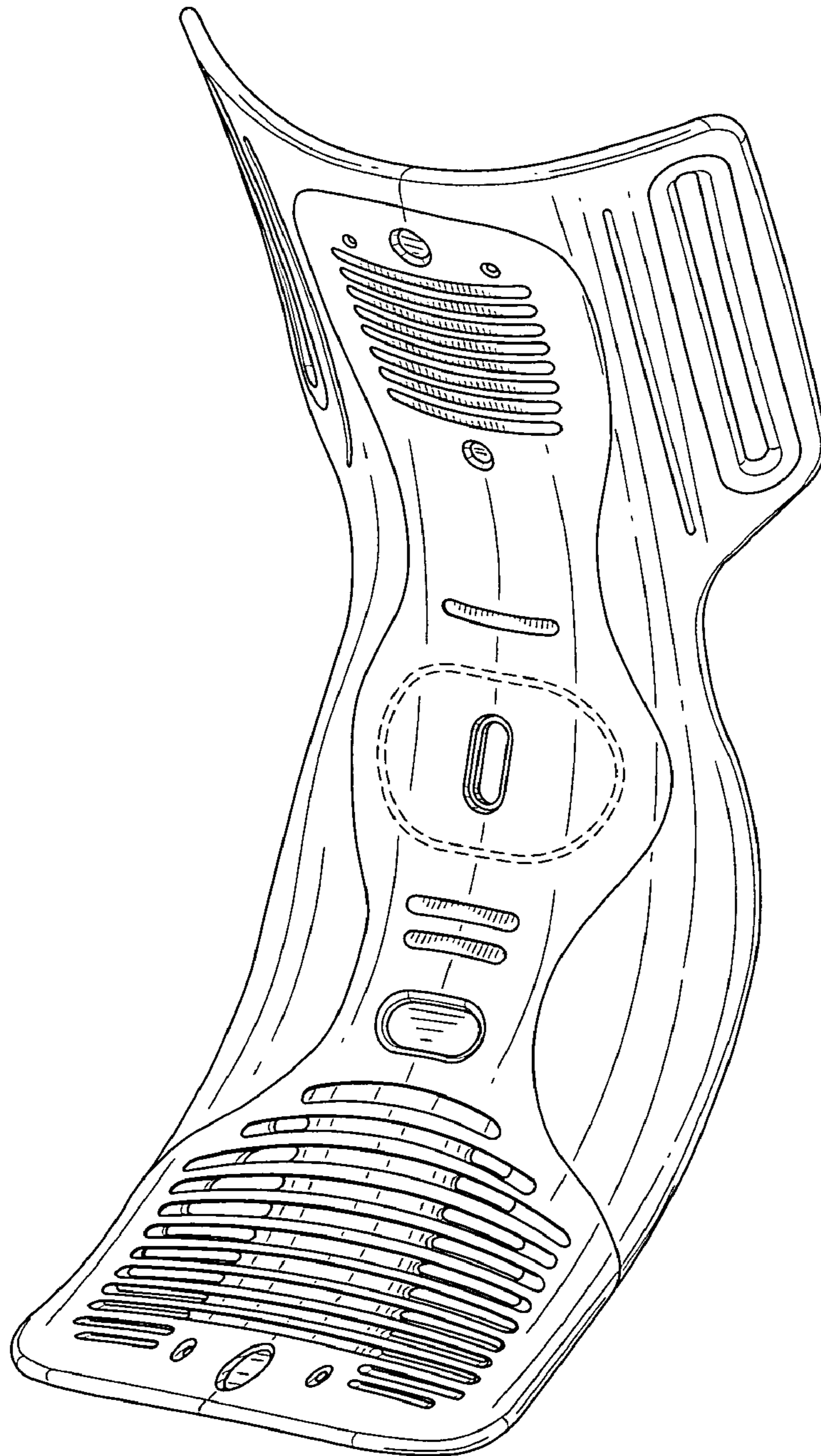

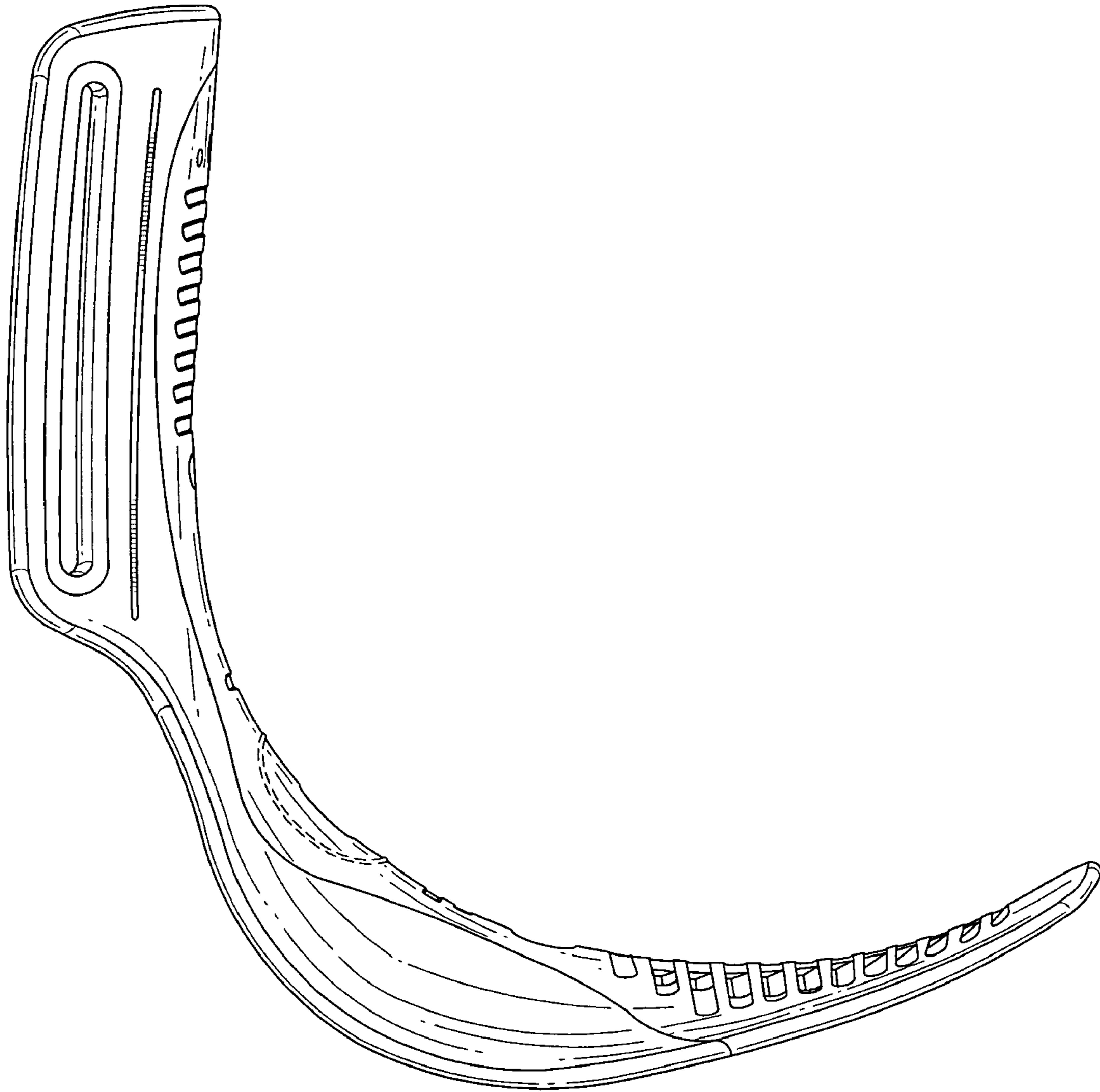

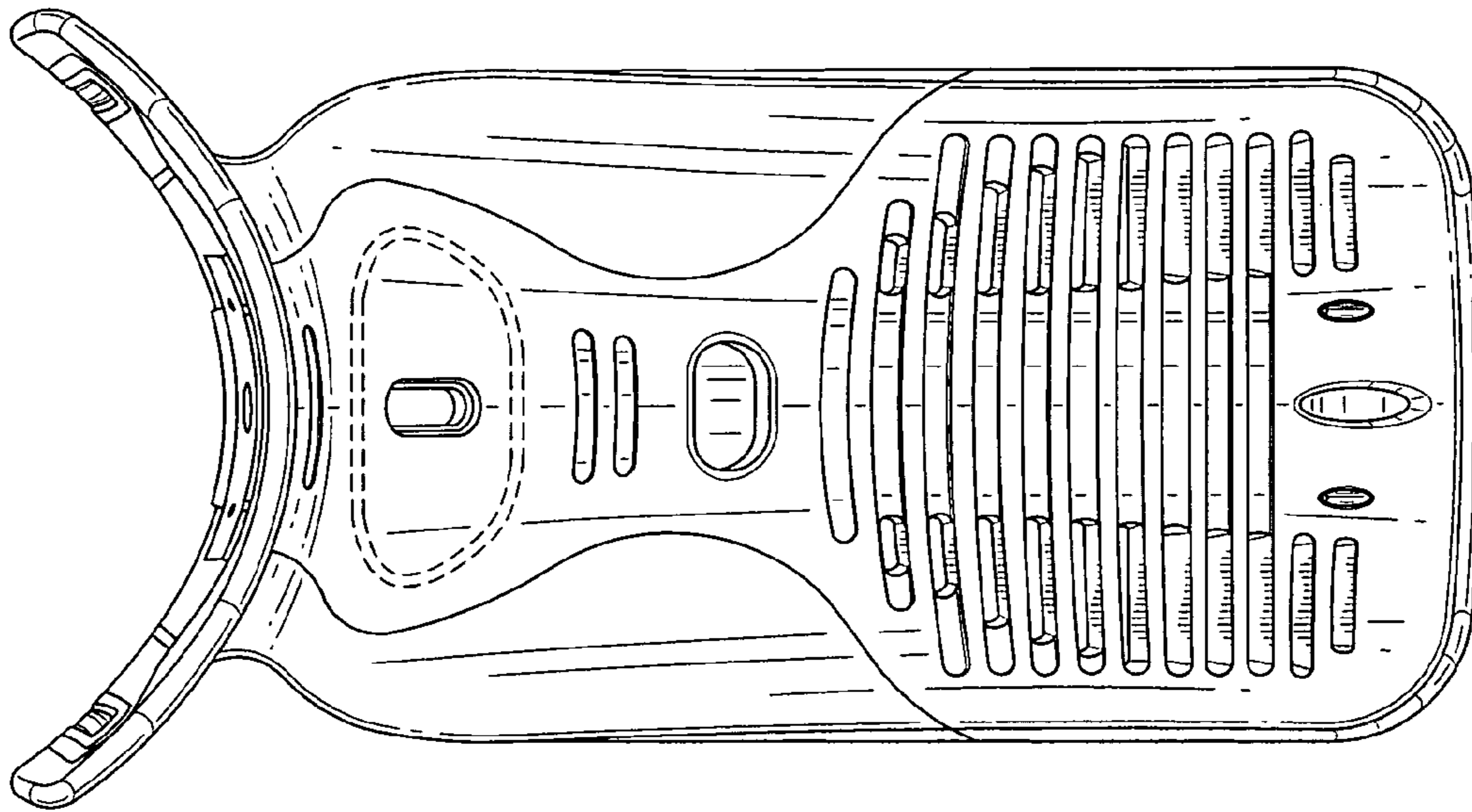

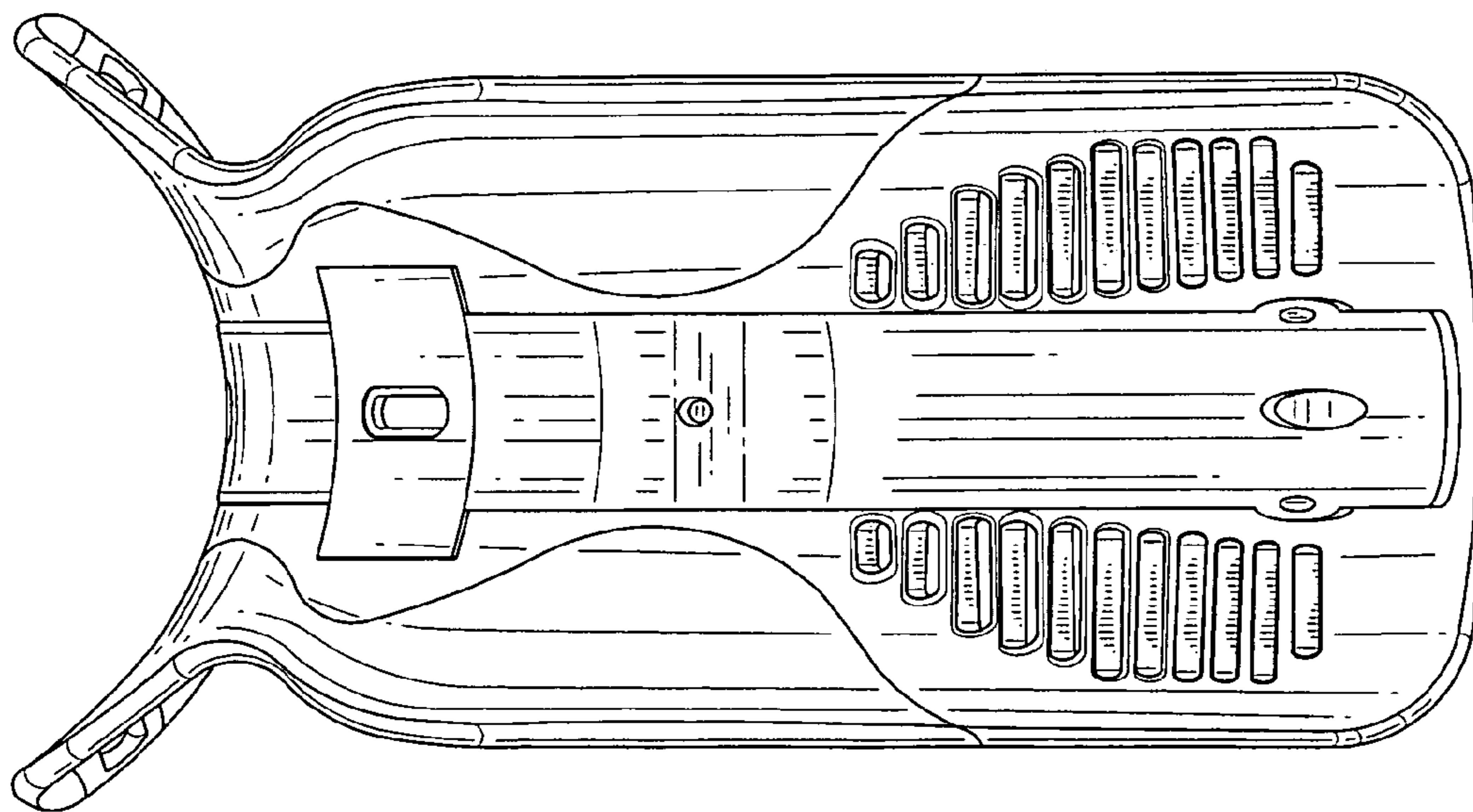

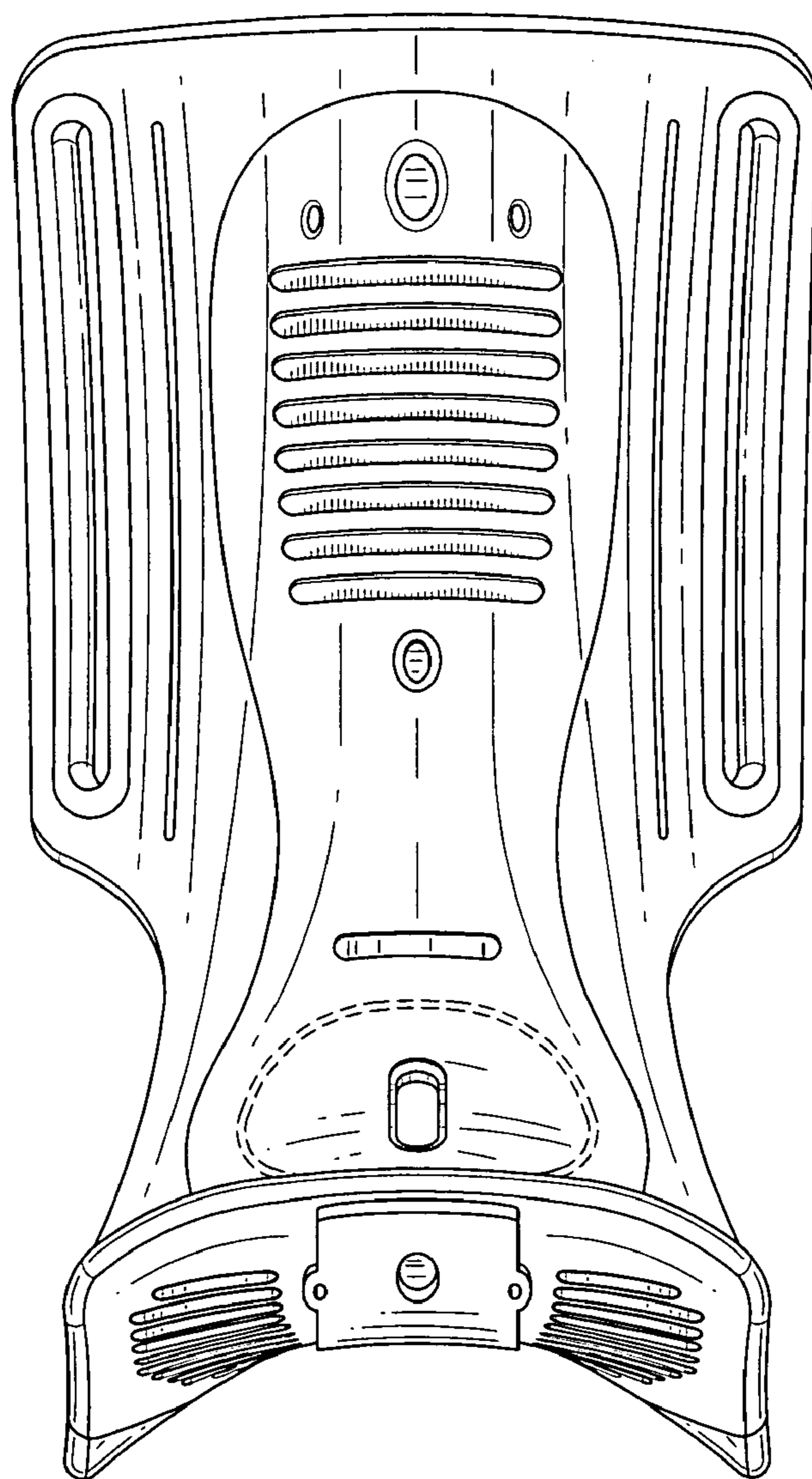

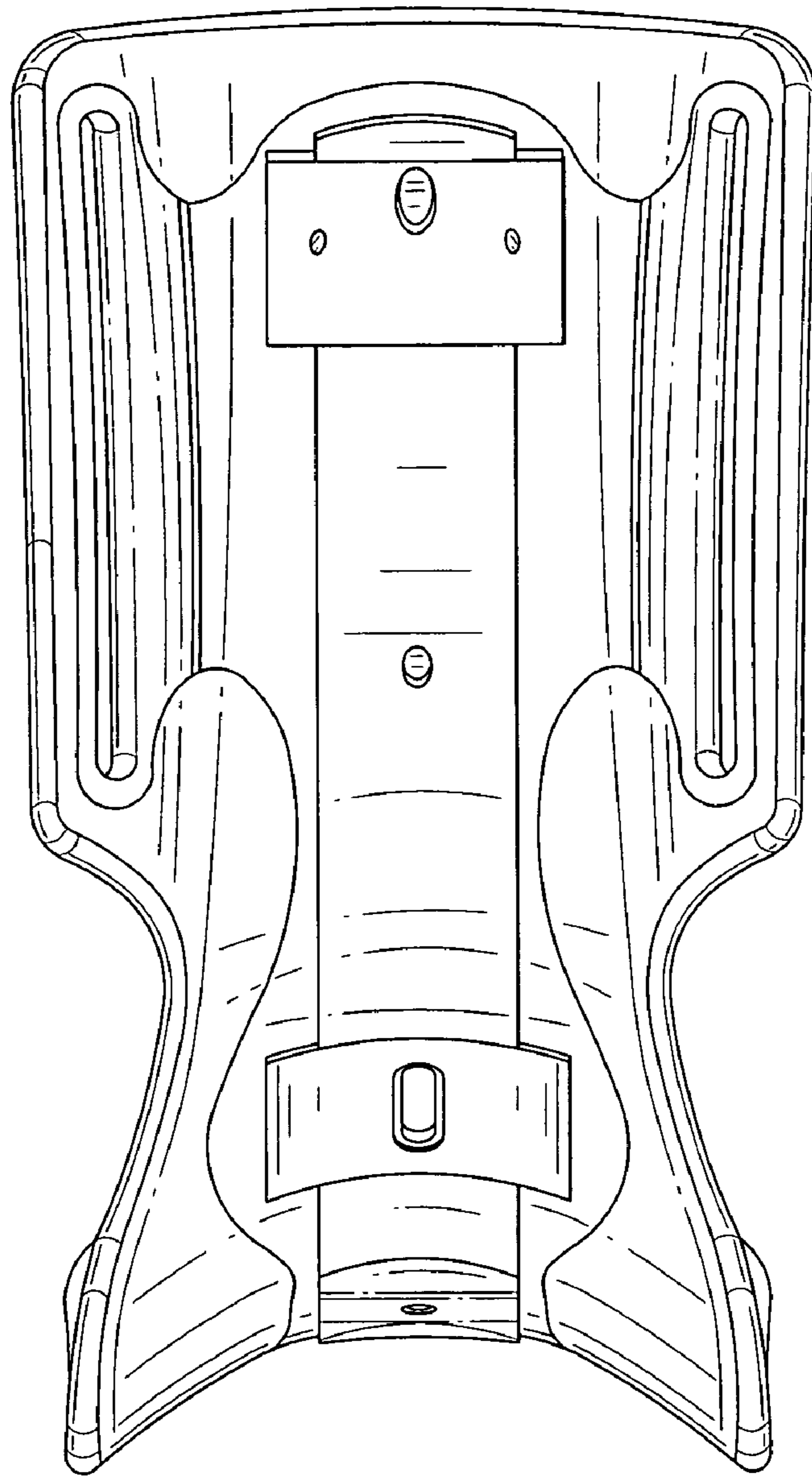
