FIG. 3 is a right side elevational view of the flashlight.

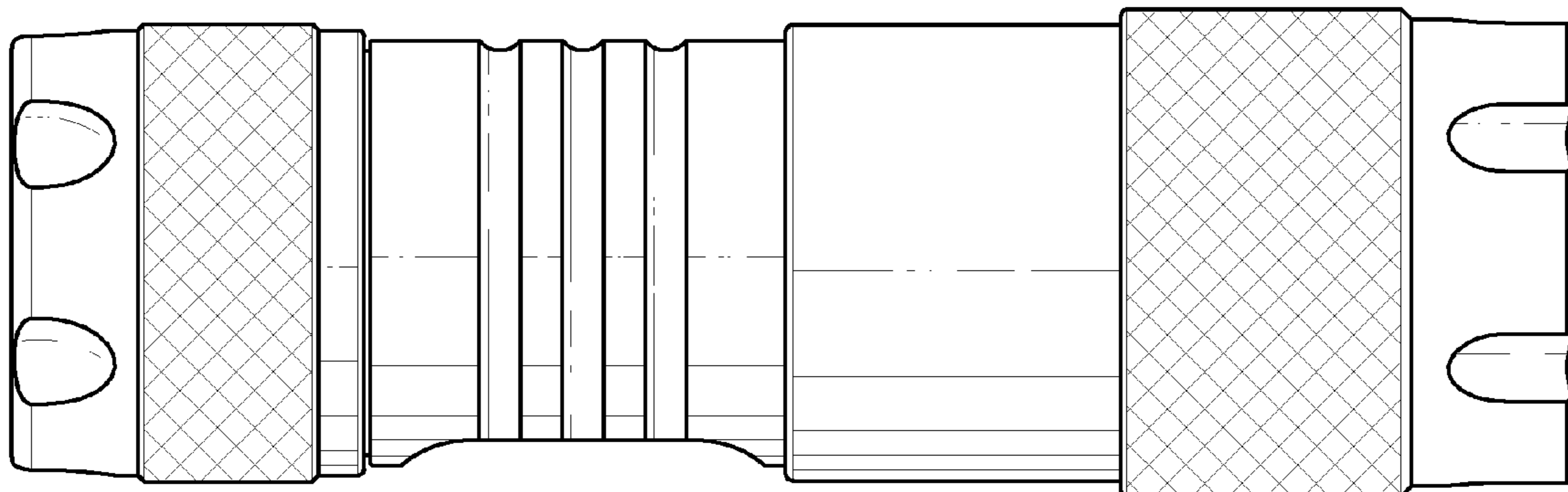
FIG. 4 is a bottom plan view of the flashlight.

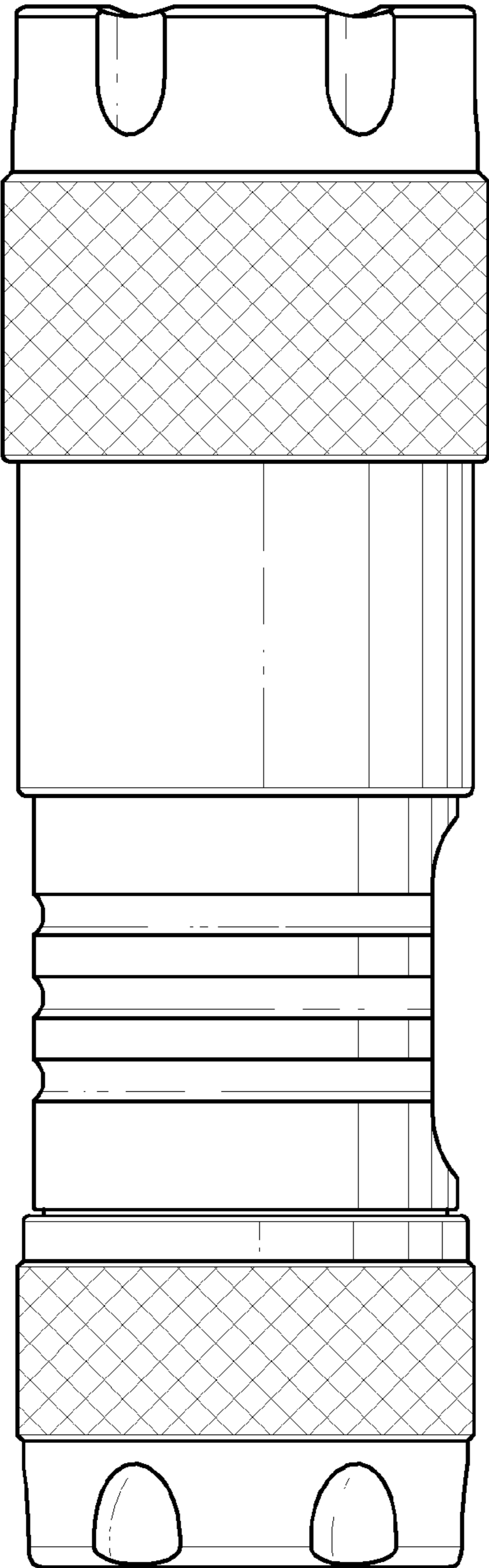

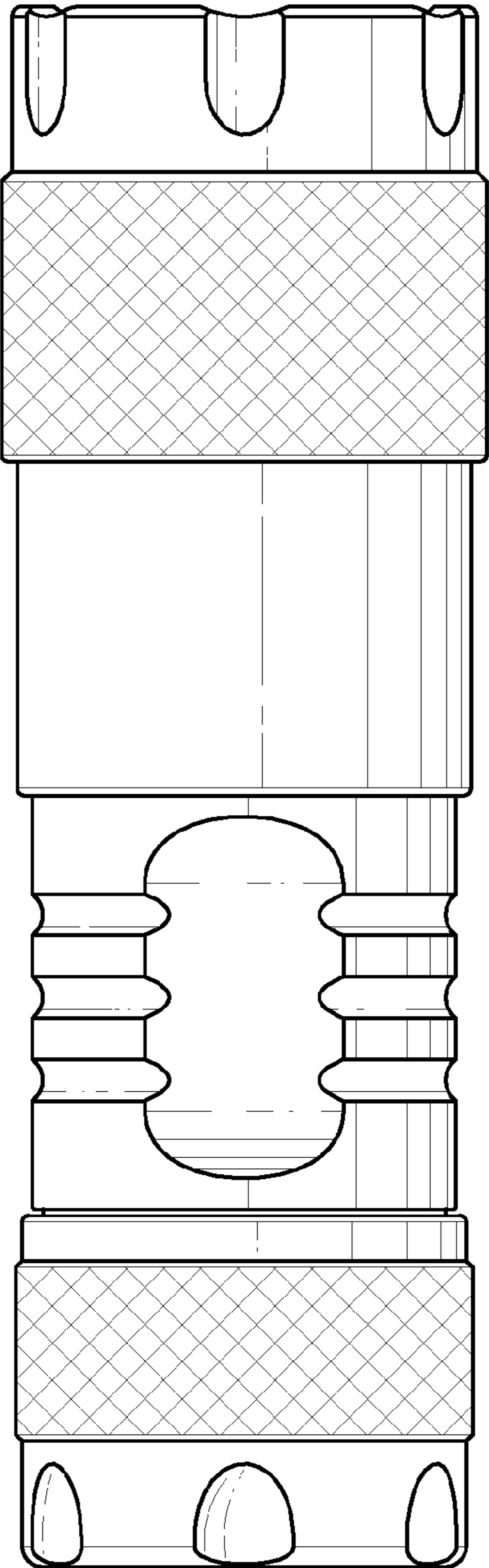

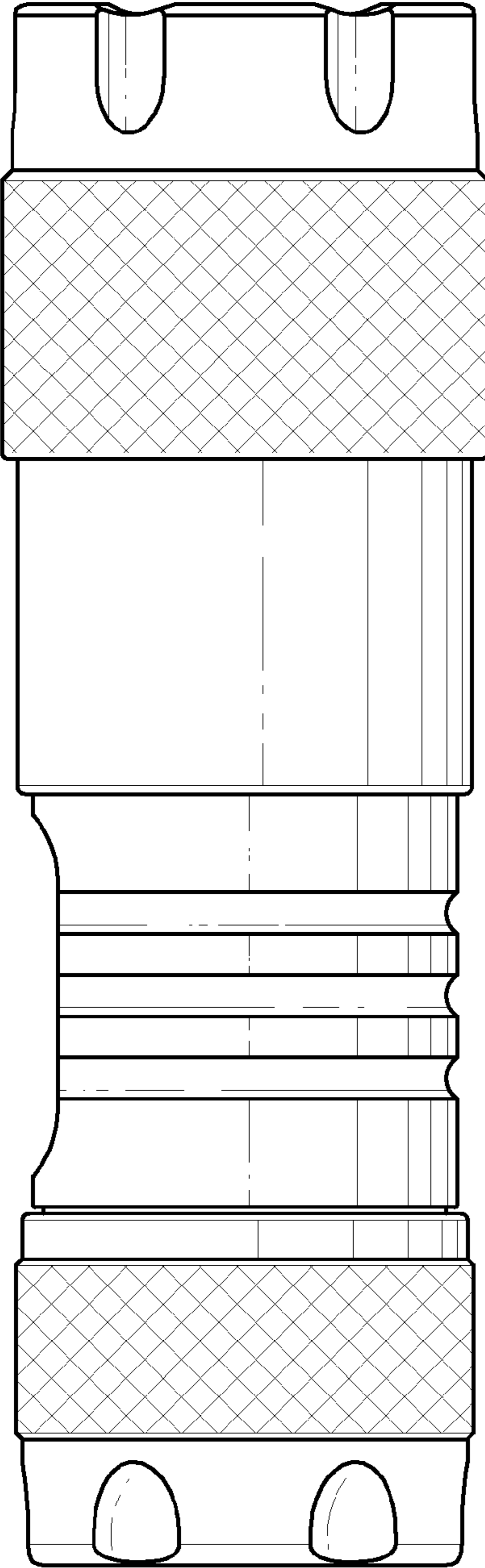

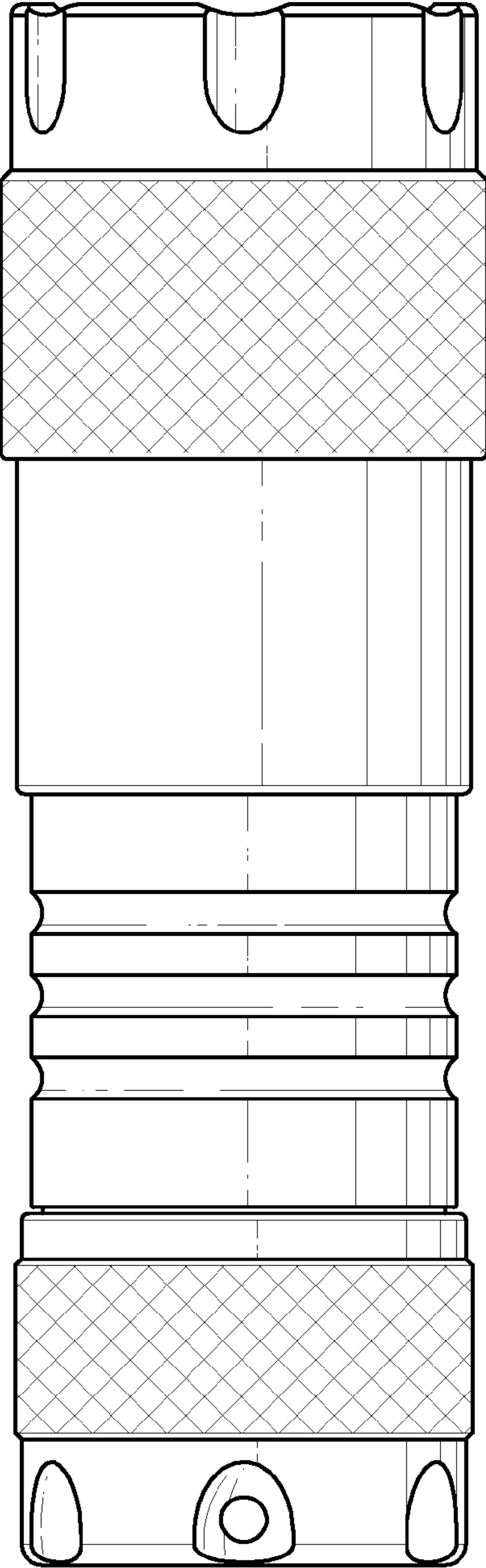
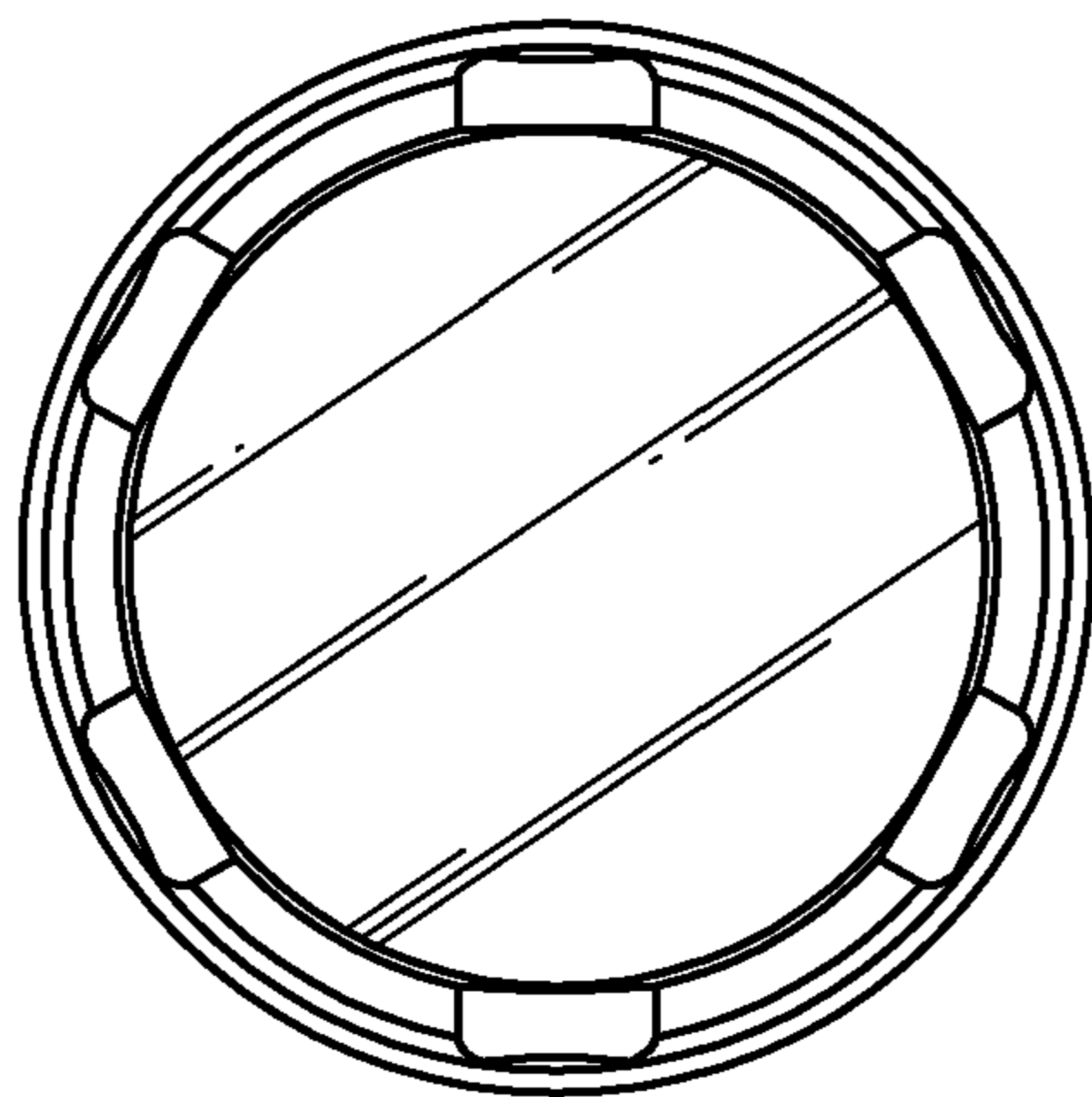
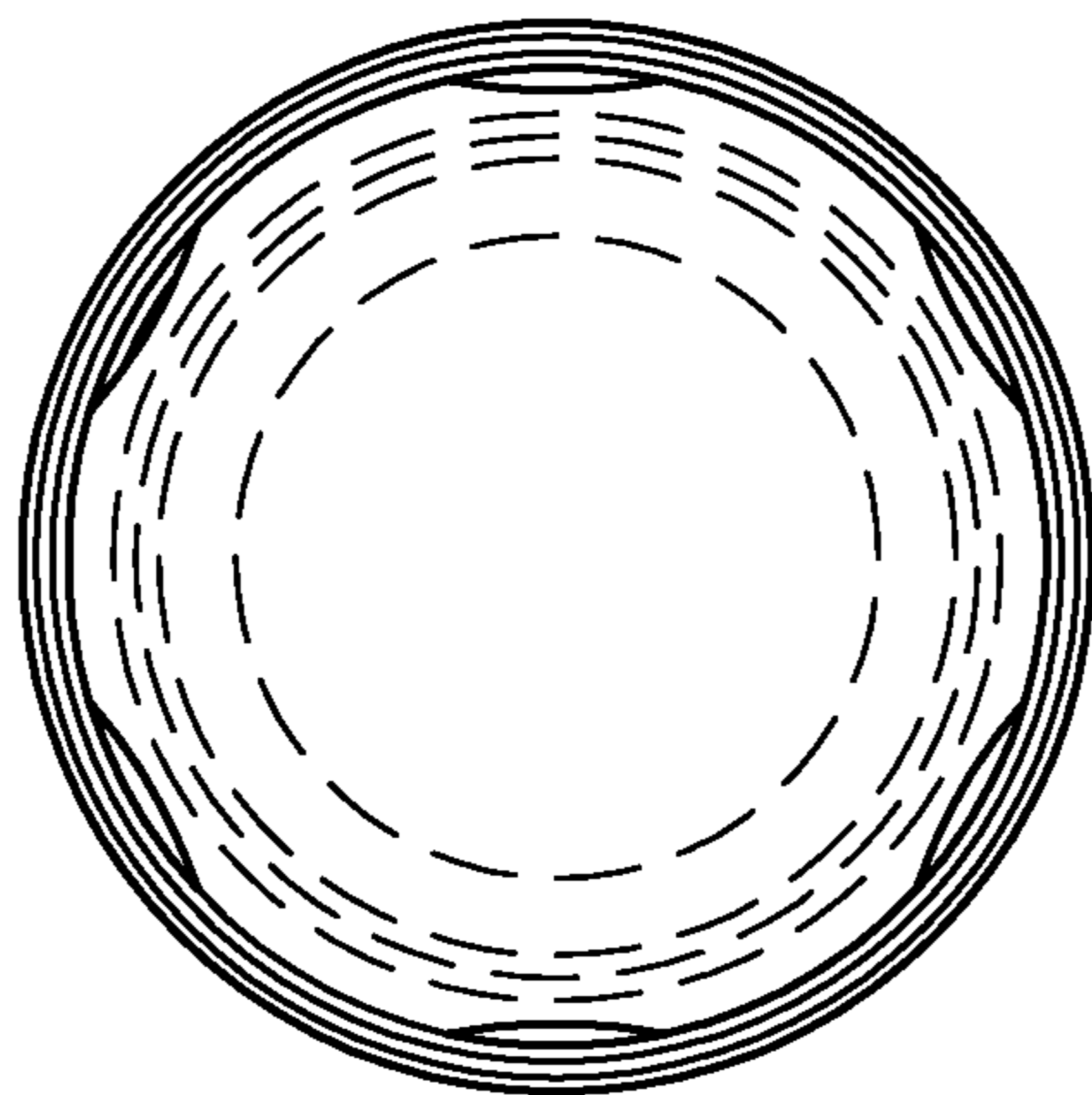
