(57) **CLAIM**

We claim the ornamental design for a helmet visor system, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a helmet visor system showing our new design;

FIG. 2 is a front perspective view thereof;

FIG. 3 is a left-side view thereof, the right-side view being a mirror image;

FIG. 4 is a rear view thereof;

FIG. 5 is a rear perspective view thereof;

FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view thereof.

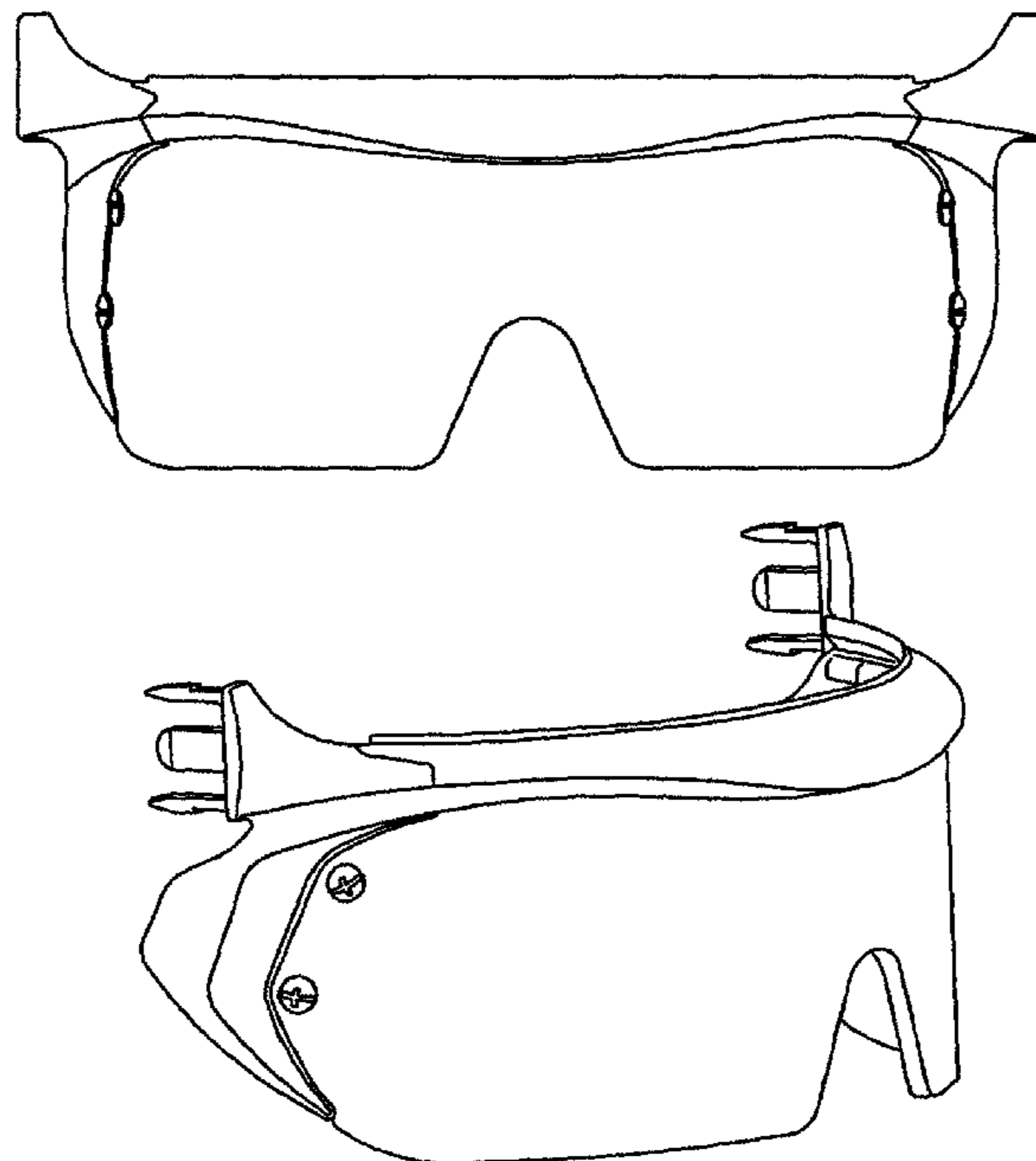

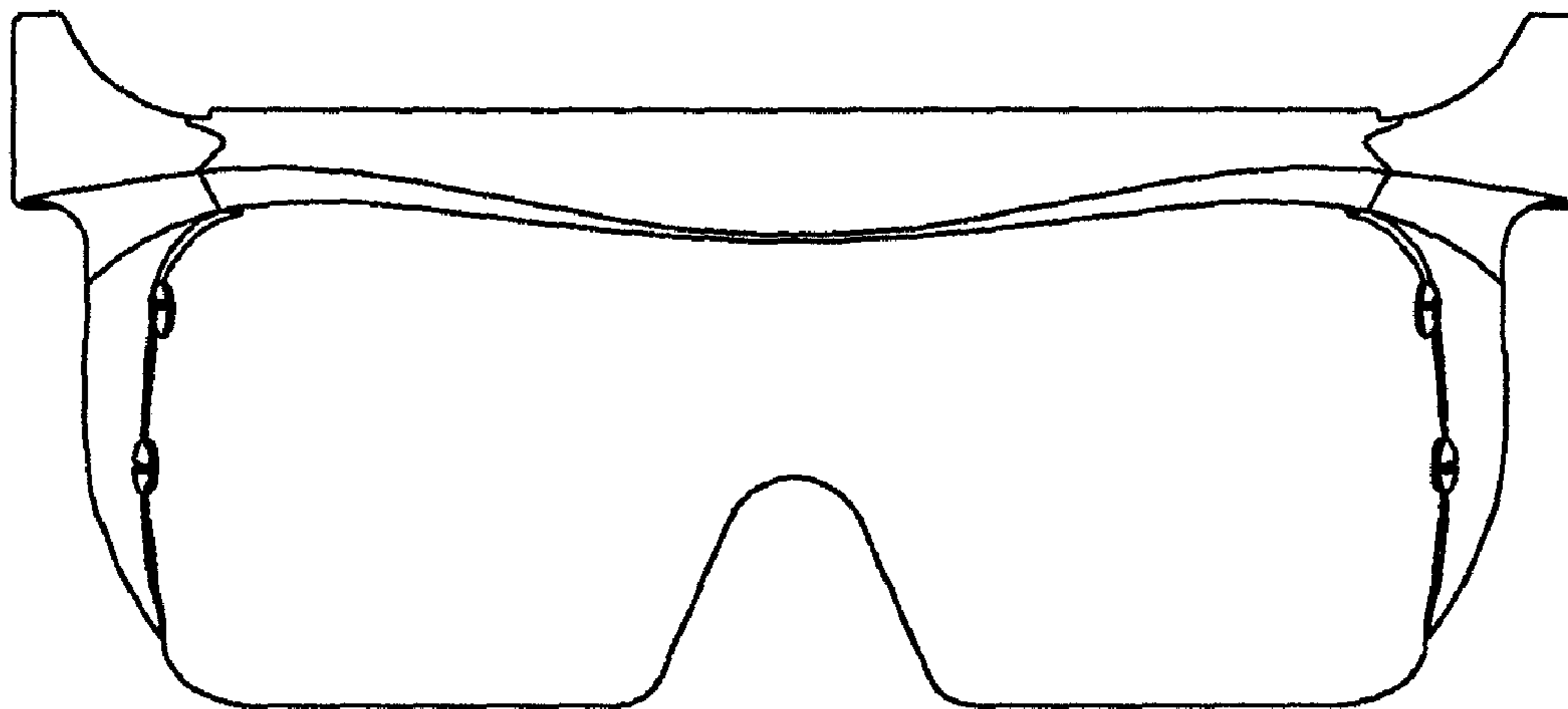

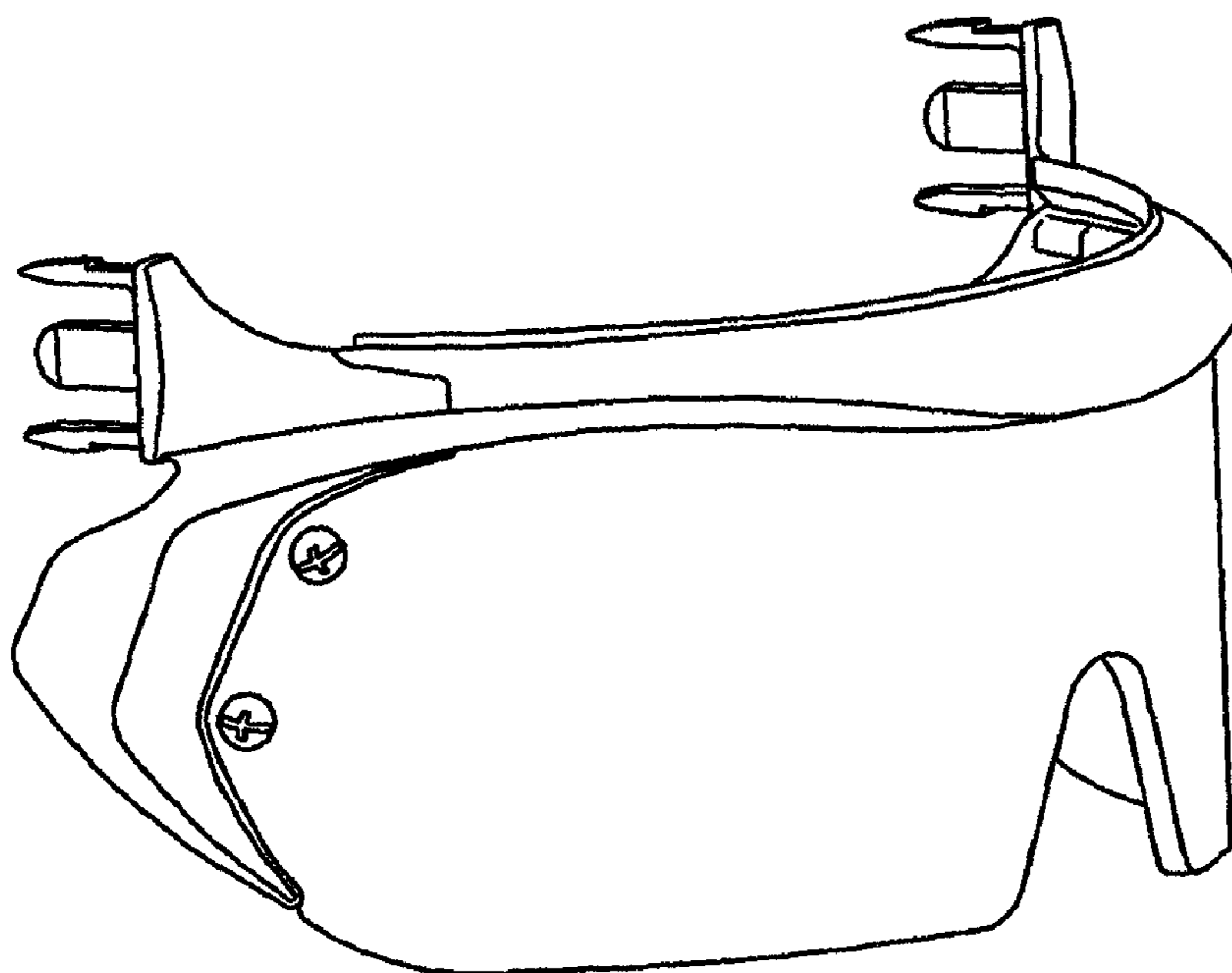

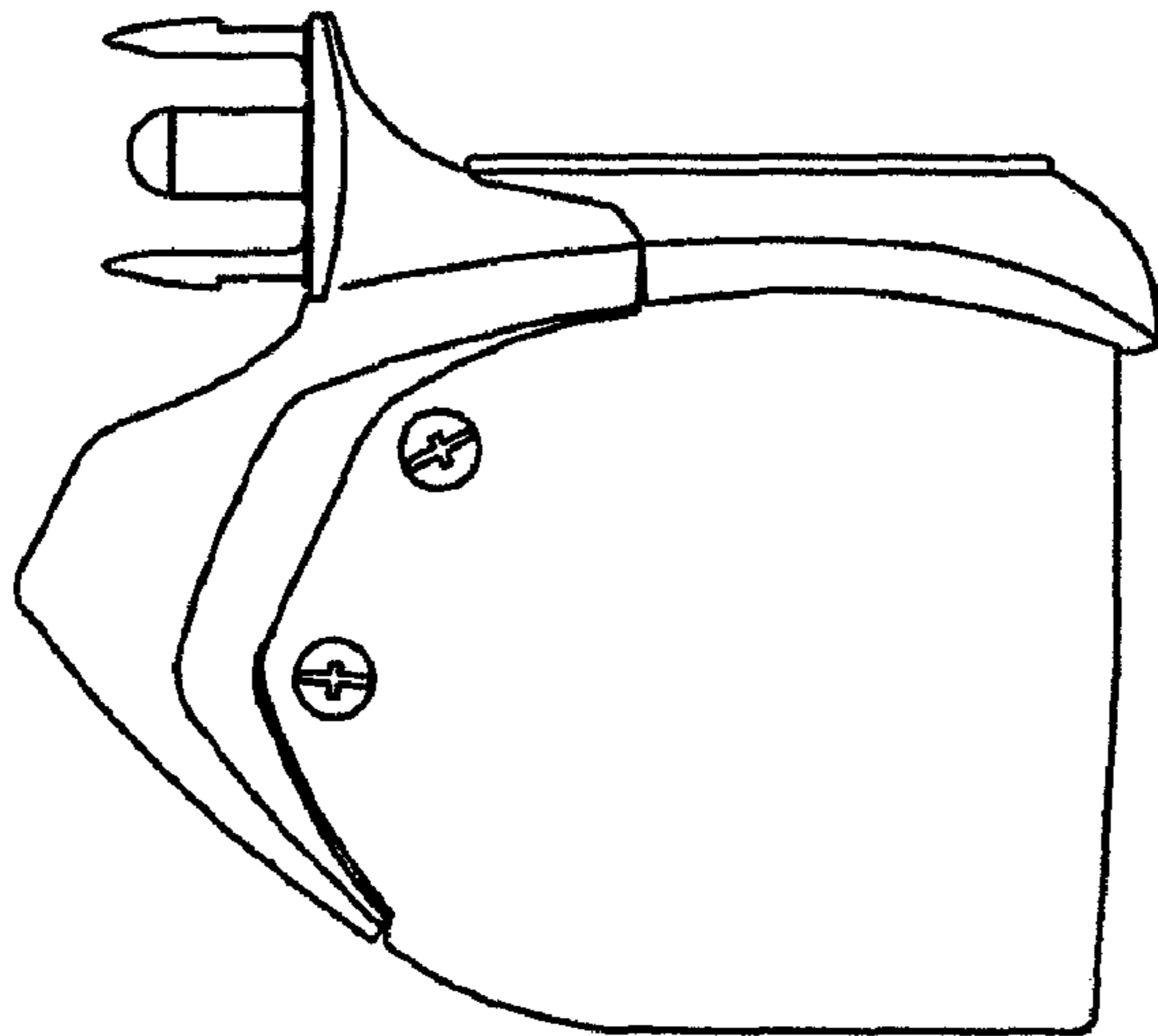

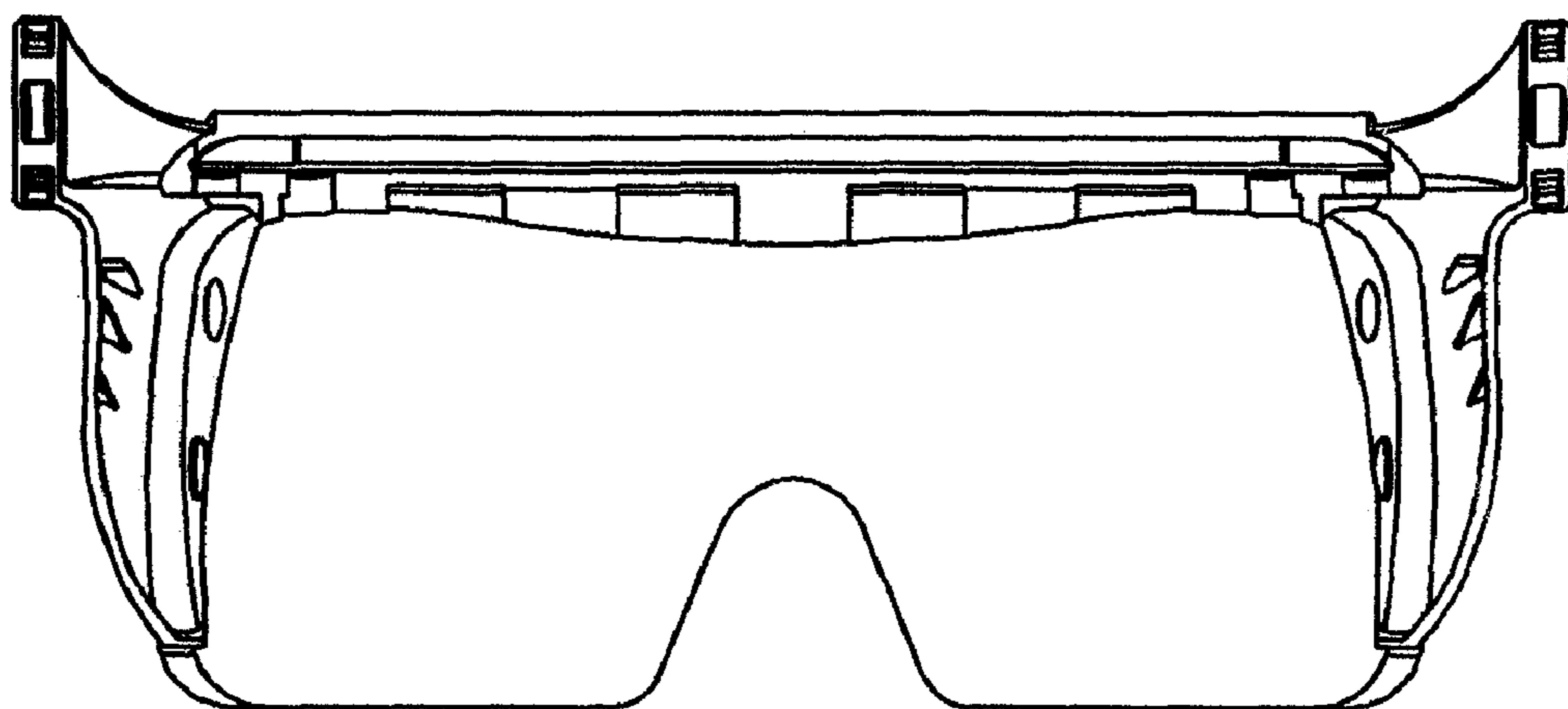

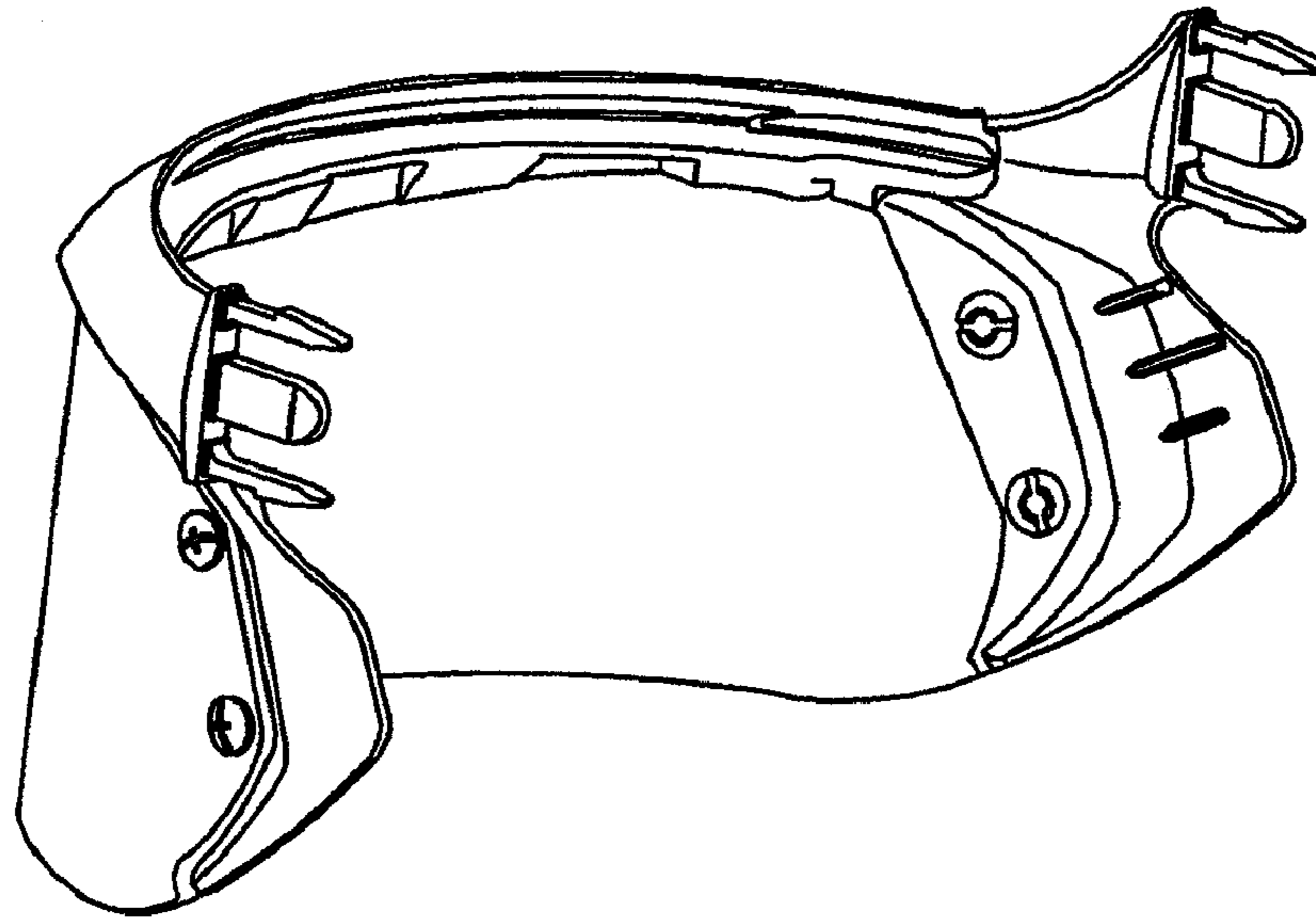

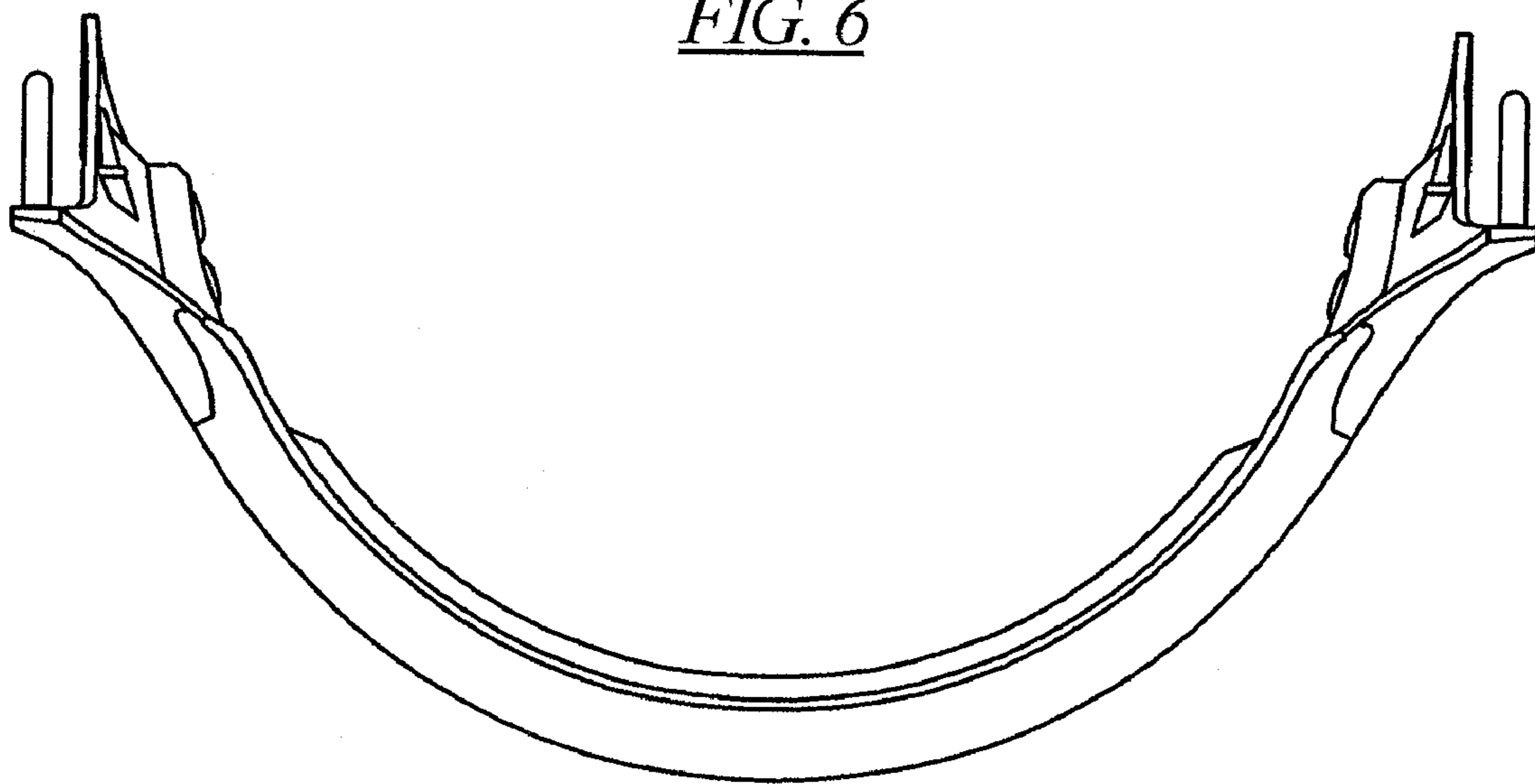
