(57) **CLAIM**

The ornamental design for a 3-seater sofa, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the 3-seater sofa according to the present invention.

FIG. 2 is a front elevational view of the 3-seater sofa shown in FIG. 1.

FIG. 3 is a rear elevational view of the 3-seater sofa shown in FIG. 1.

FIG. 4 is a top plan view of the 3-seater sofa shown in FIG. 1.

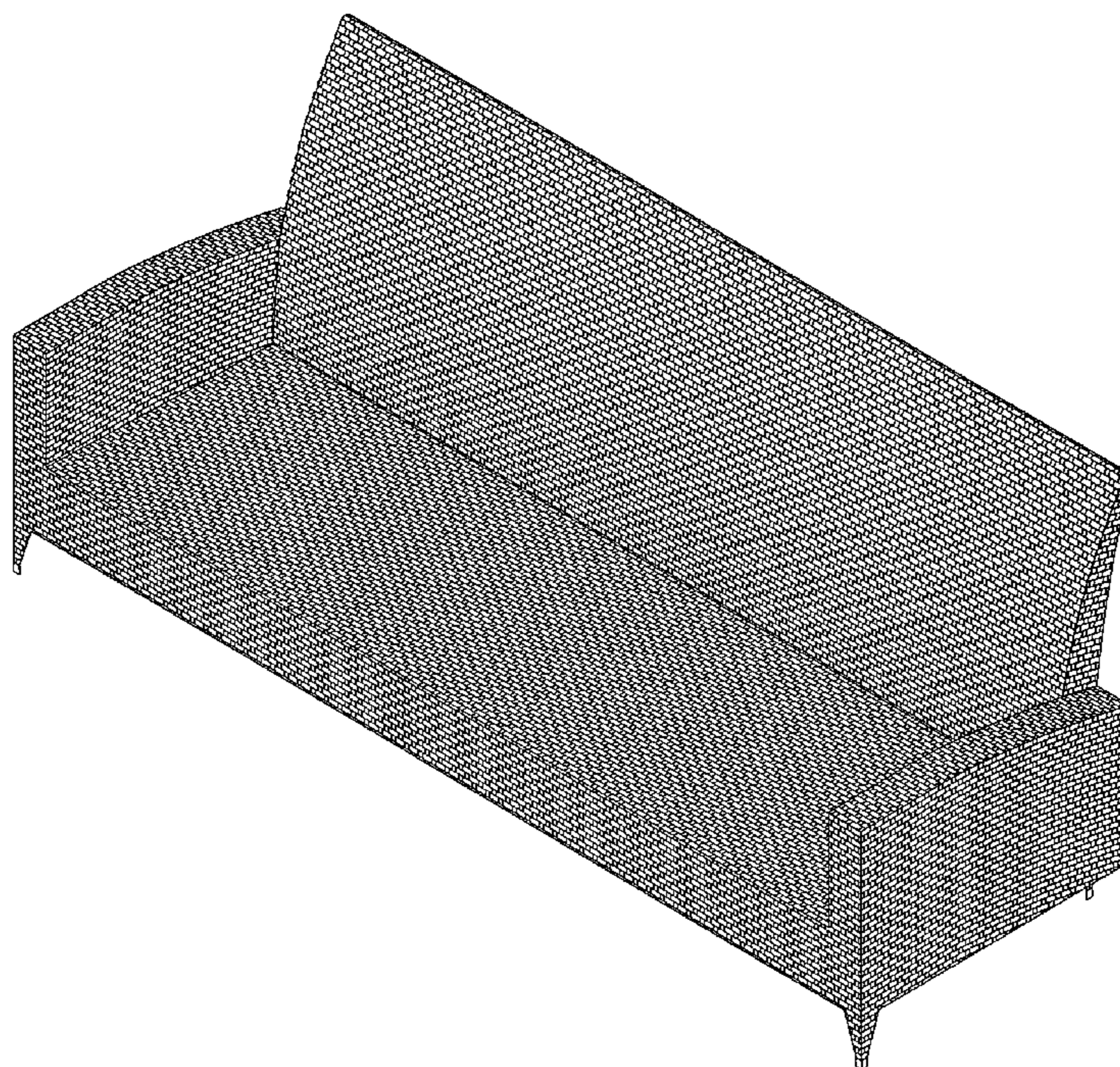
FIG. 5 is a bottom plan view of the 3-seater sofa shown in FIG. 1.

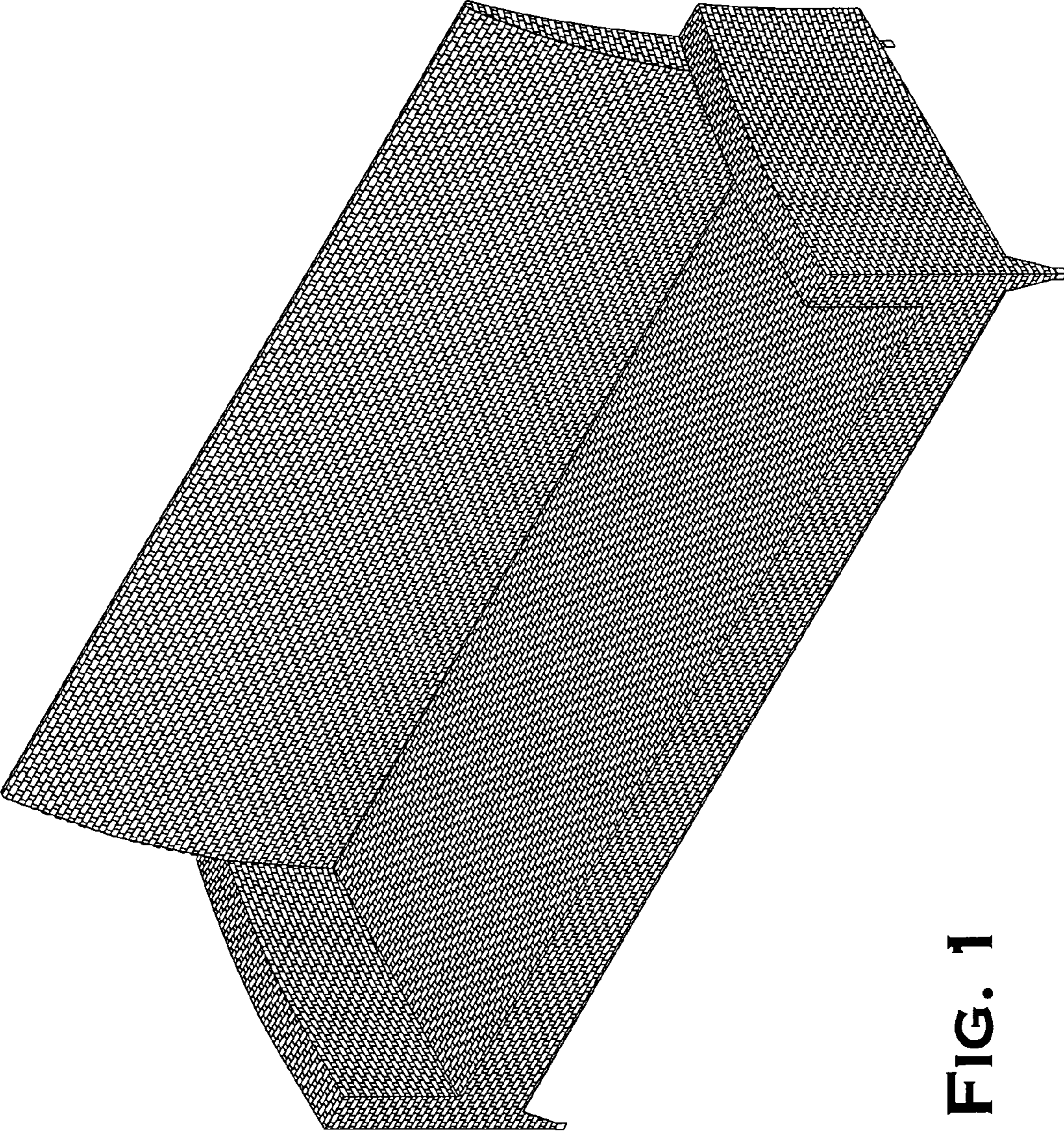

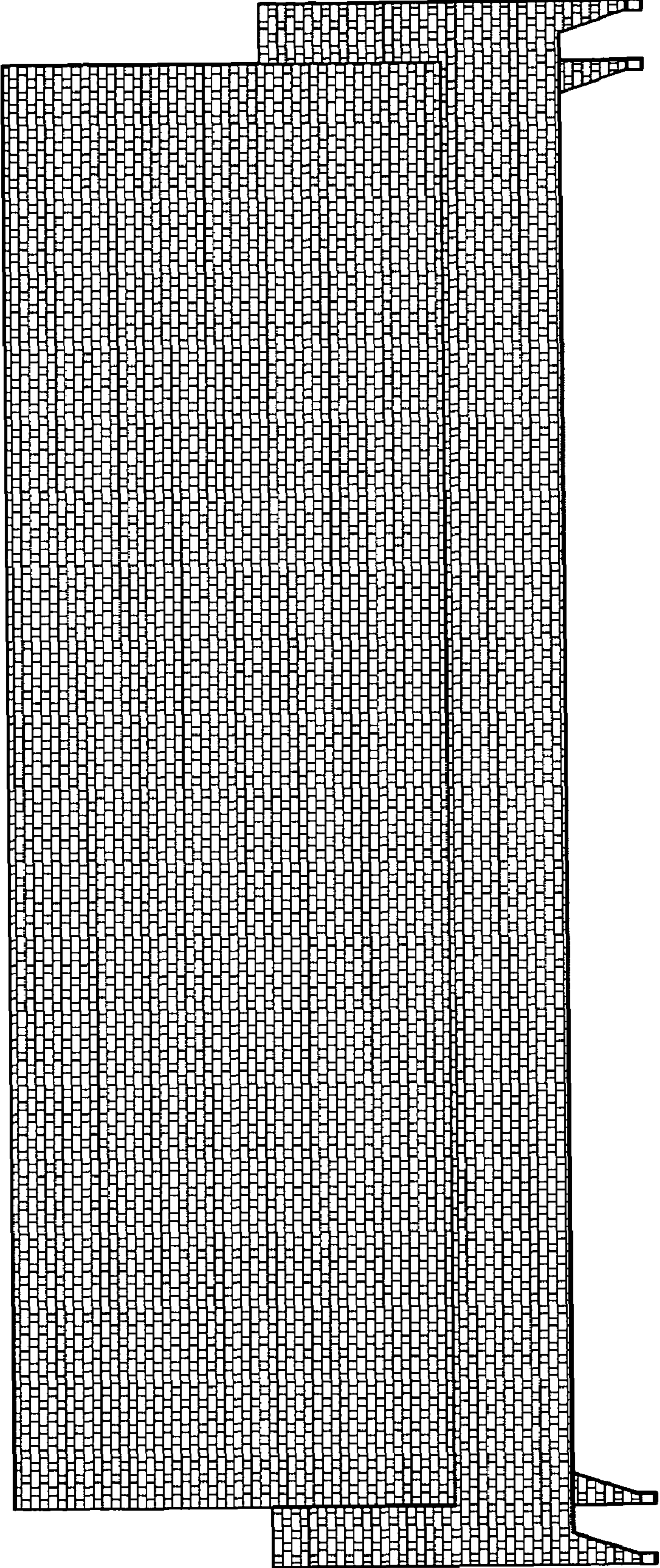

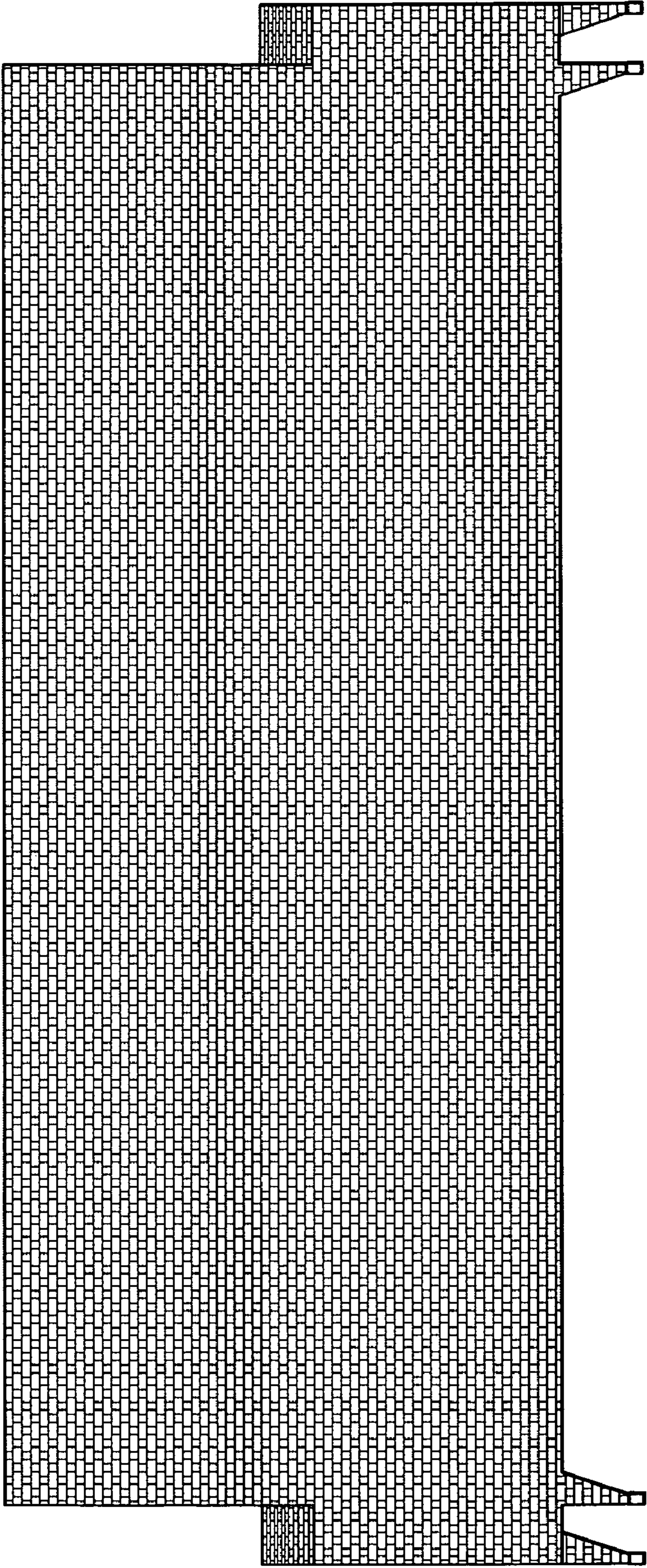

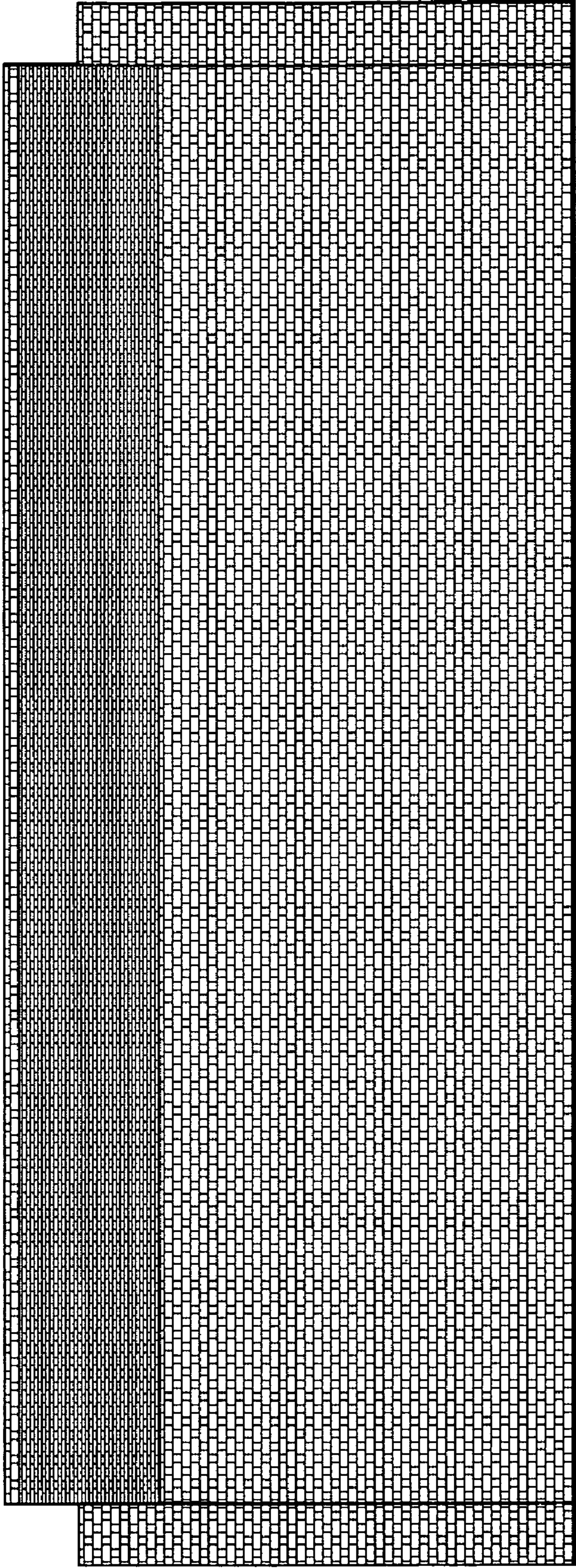

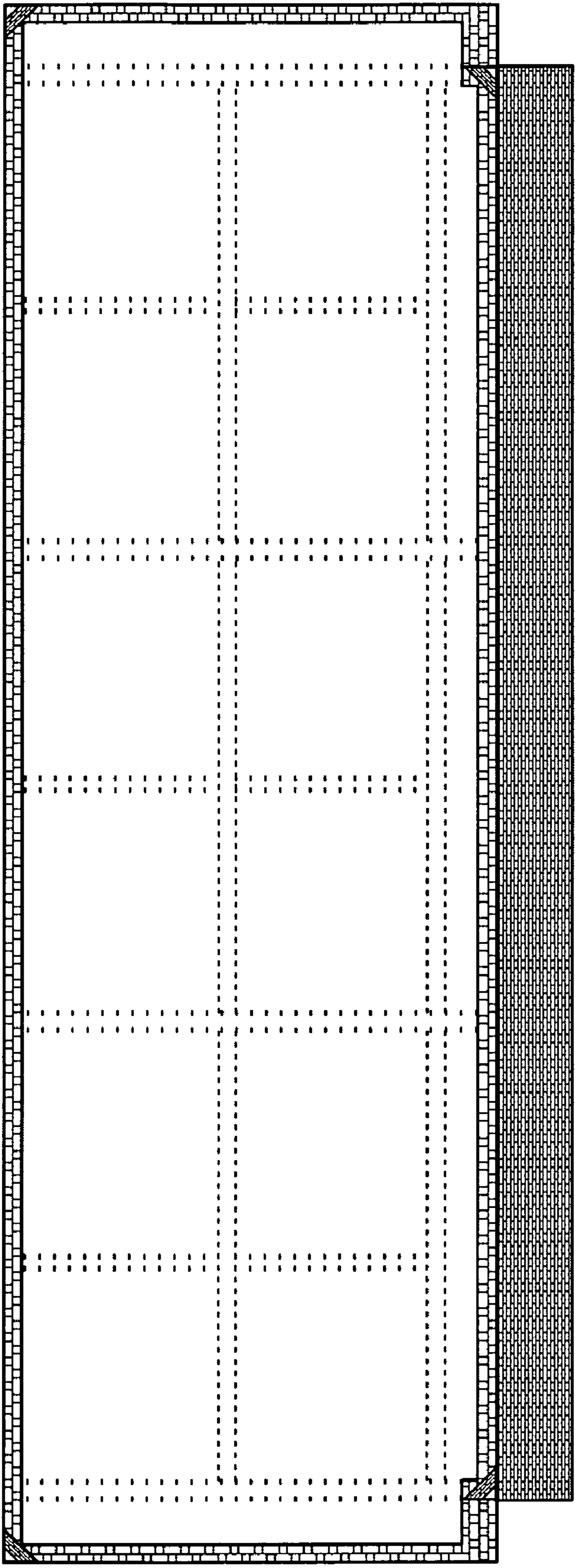

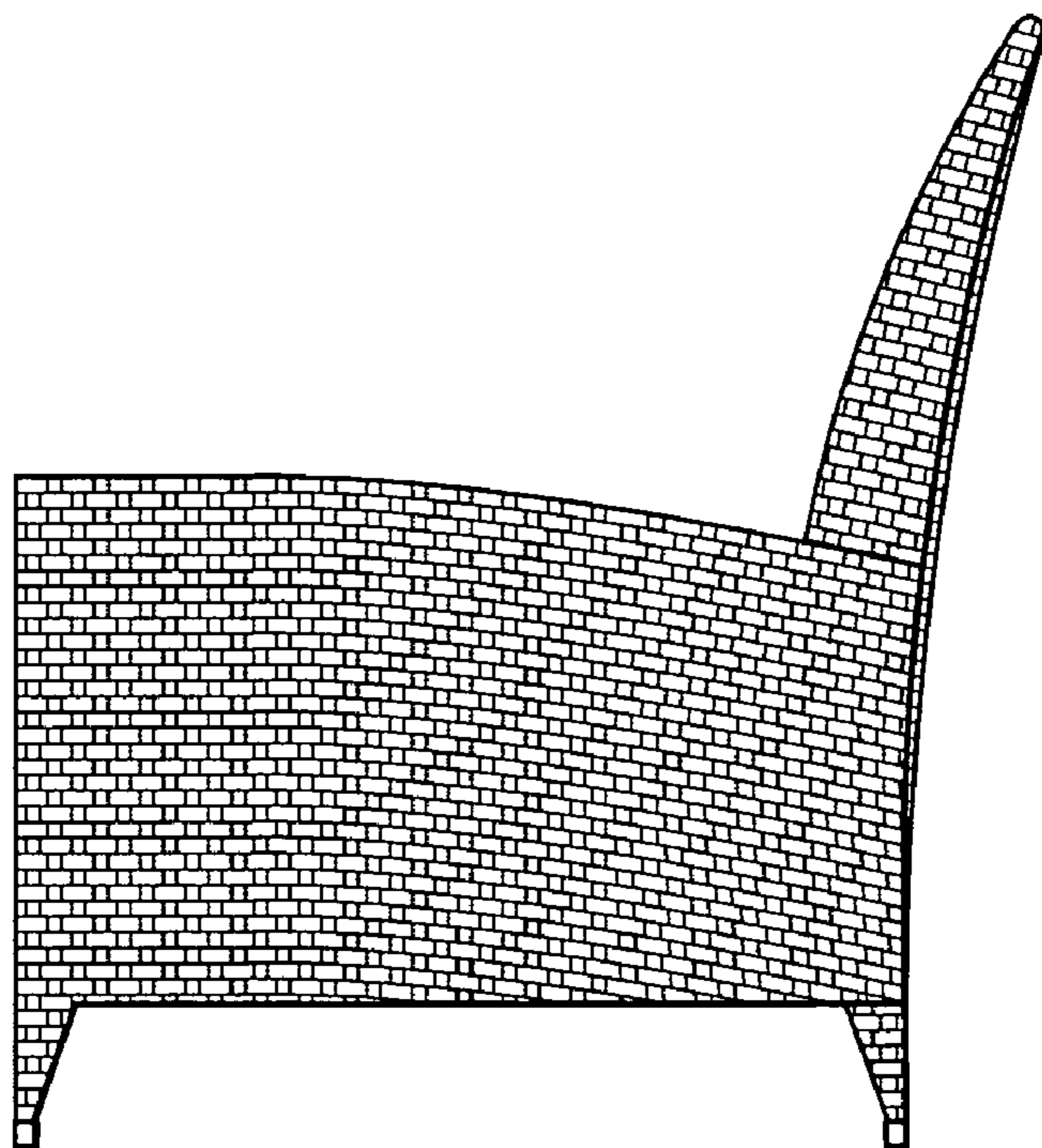
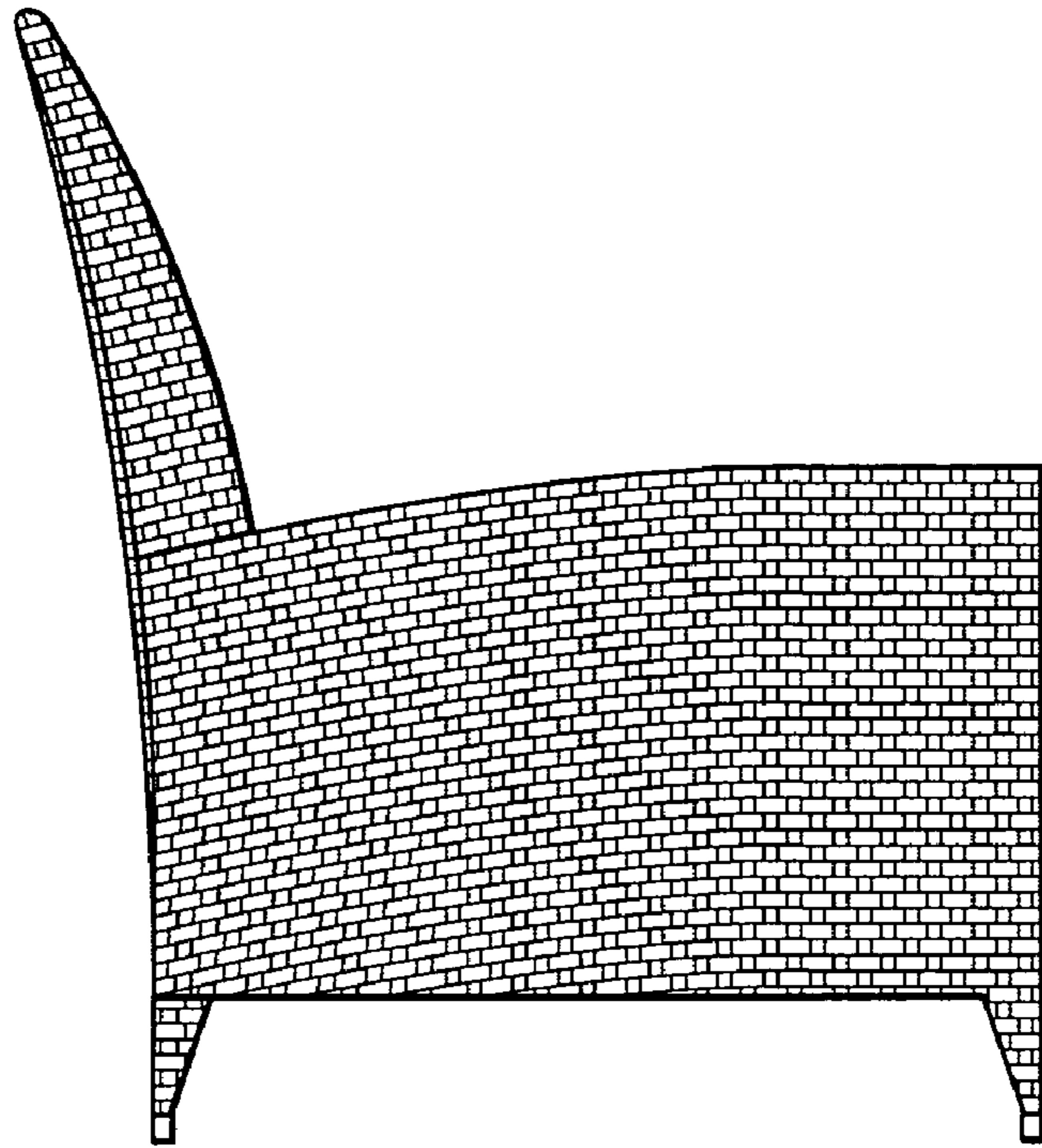
