**DESCRIPTION**

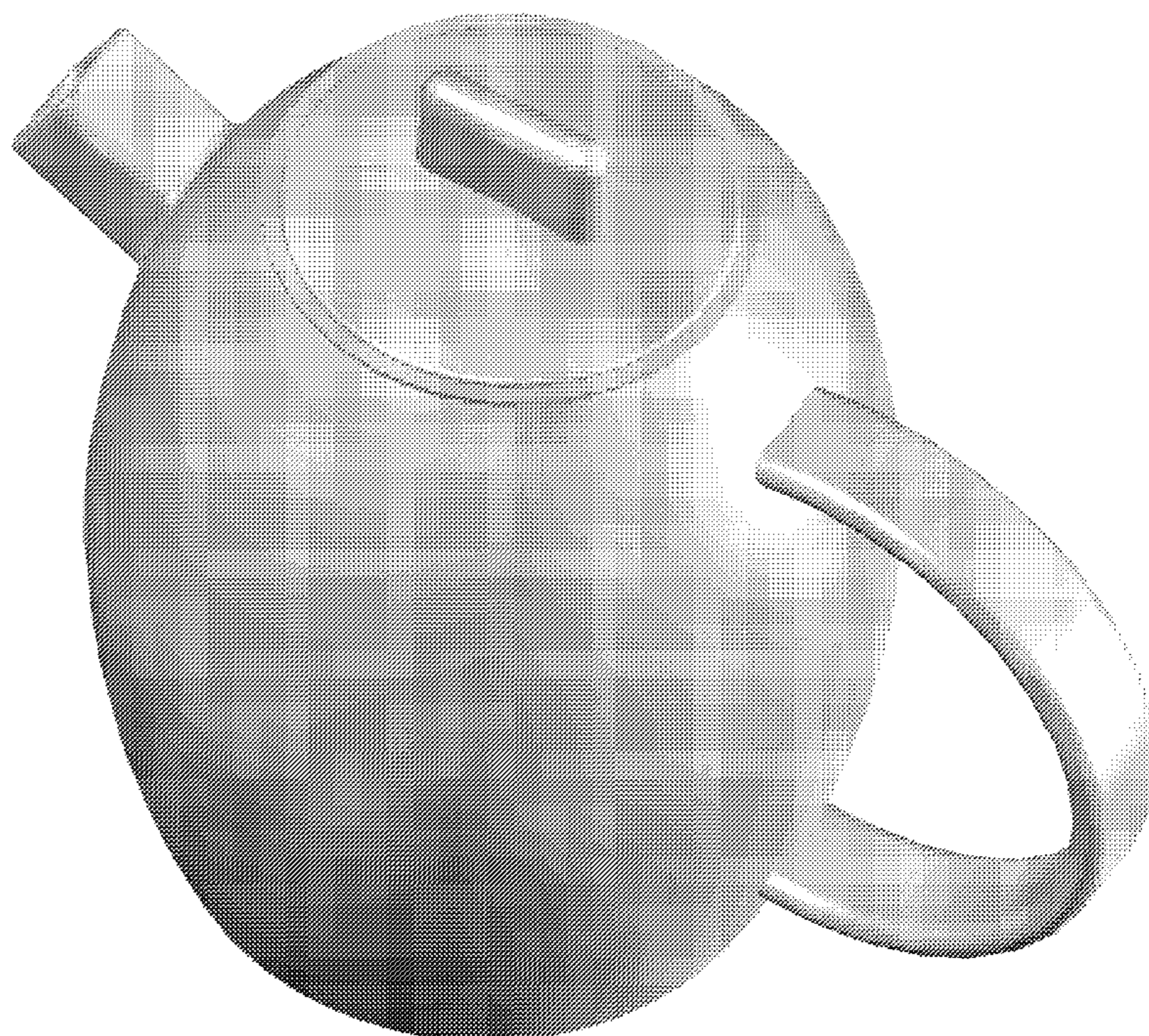

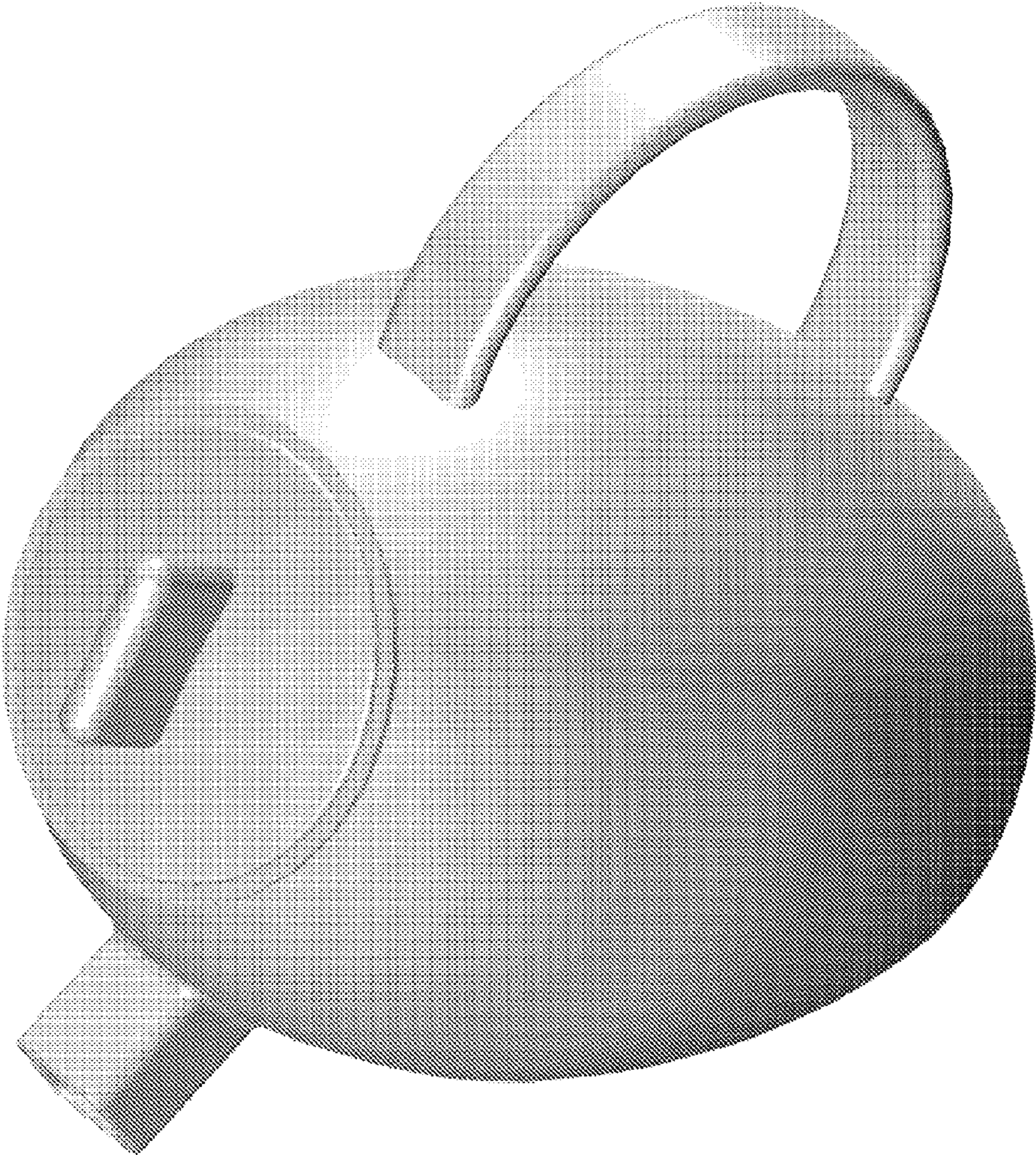

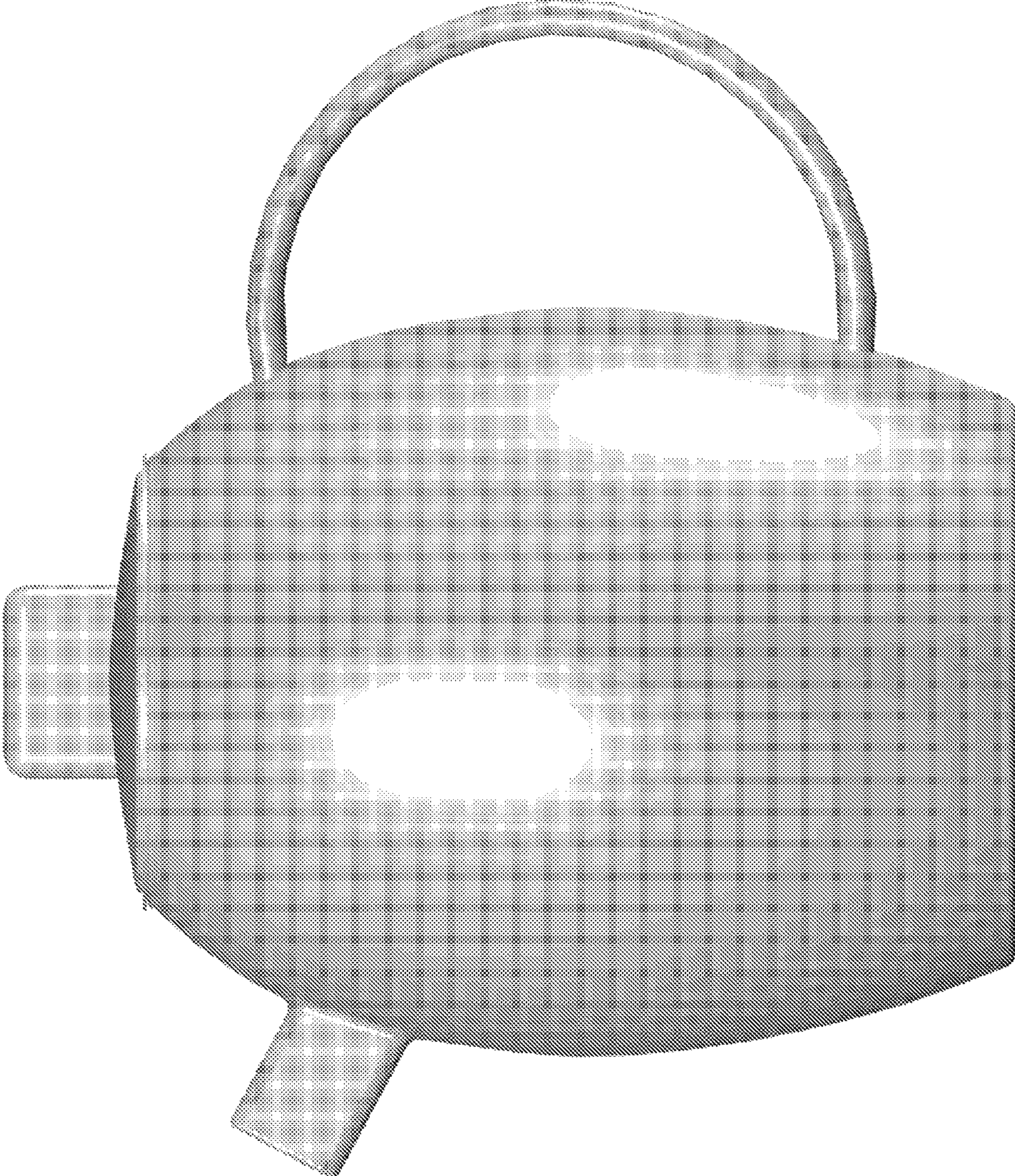

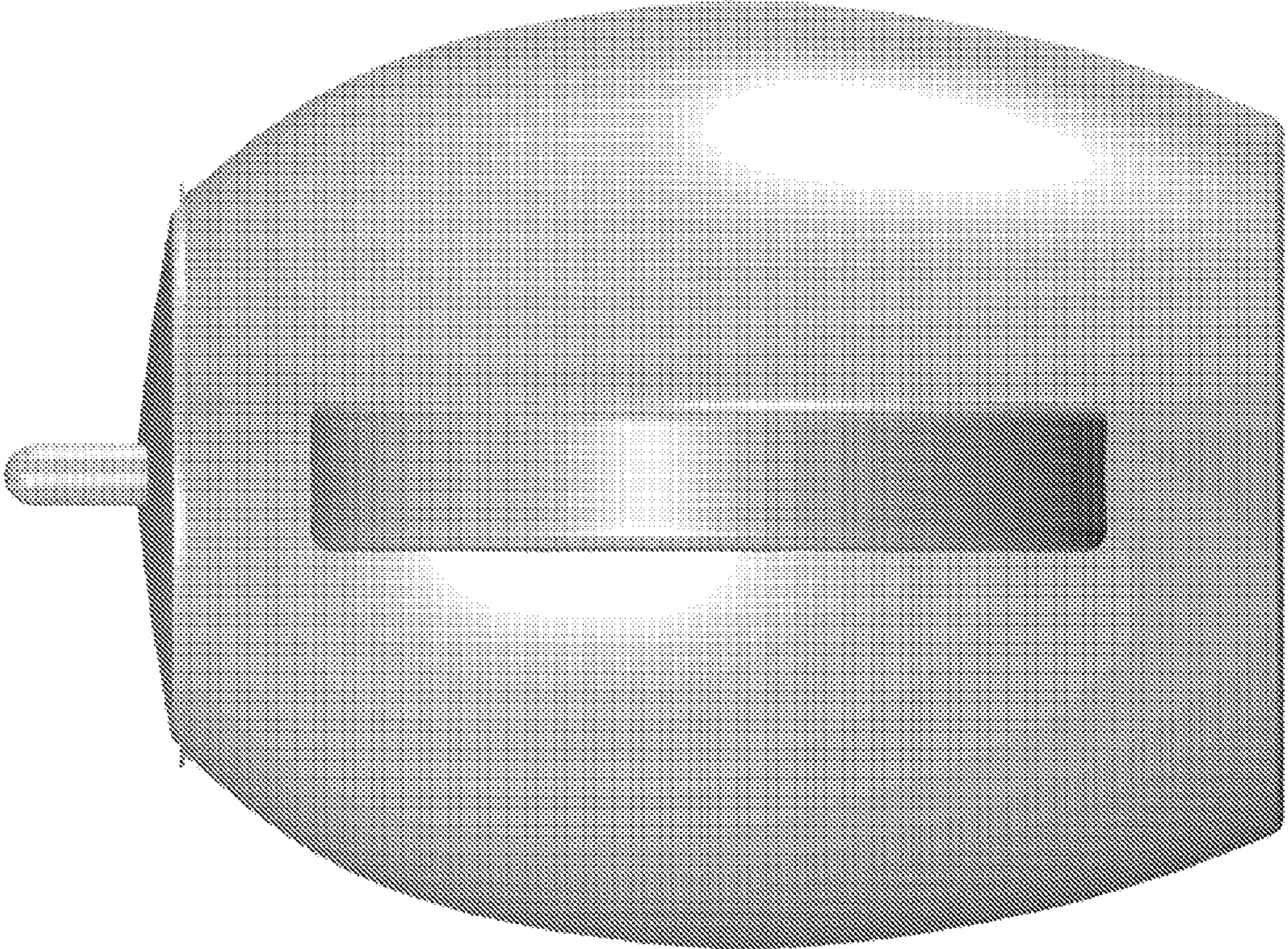

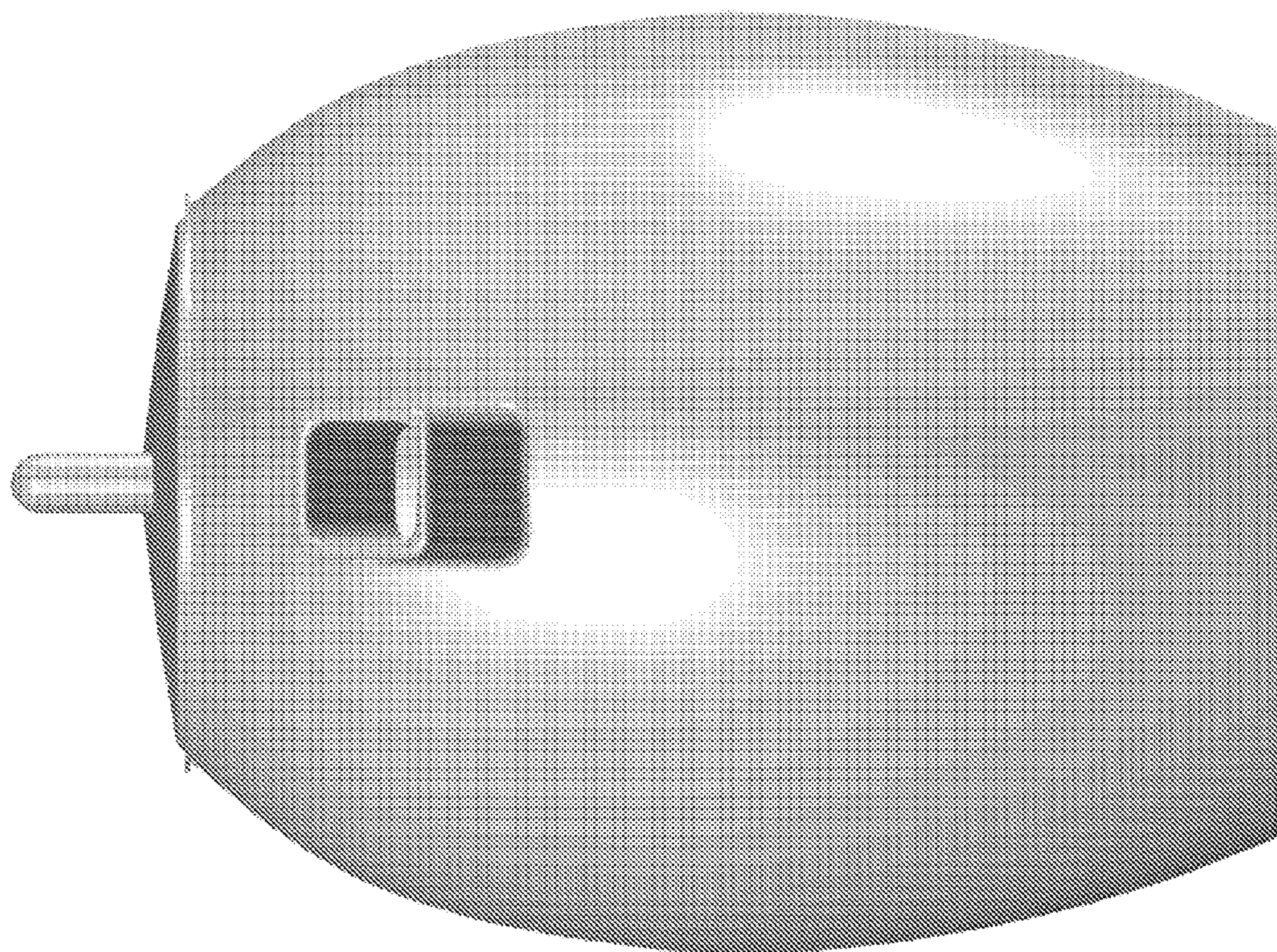

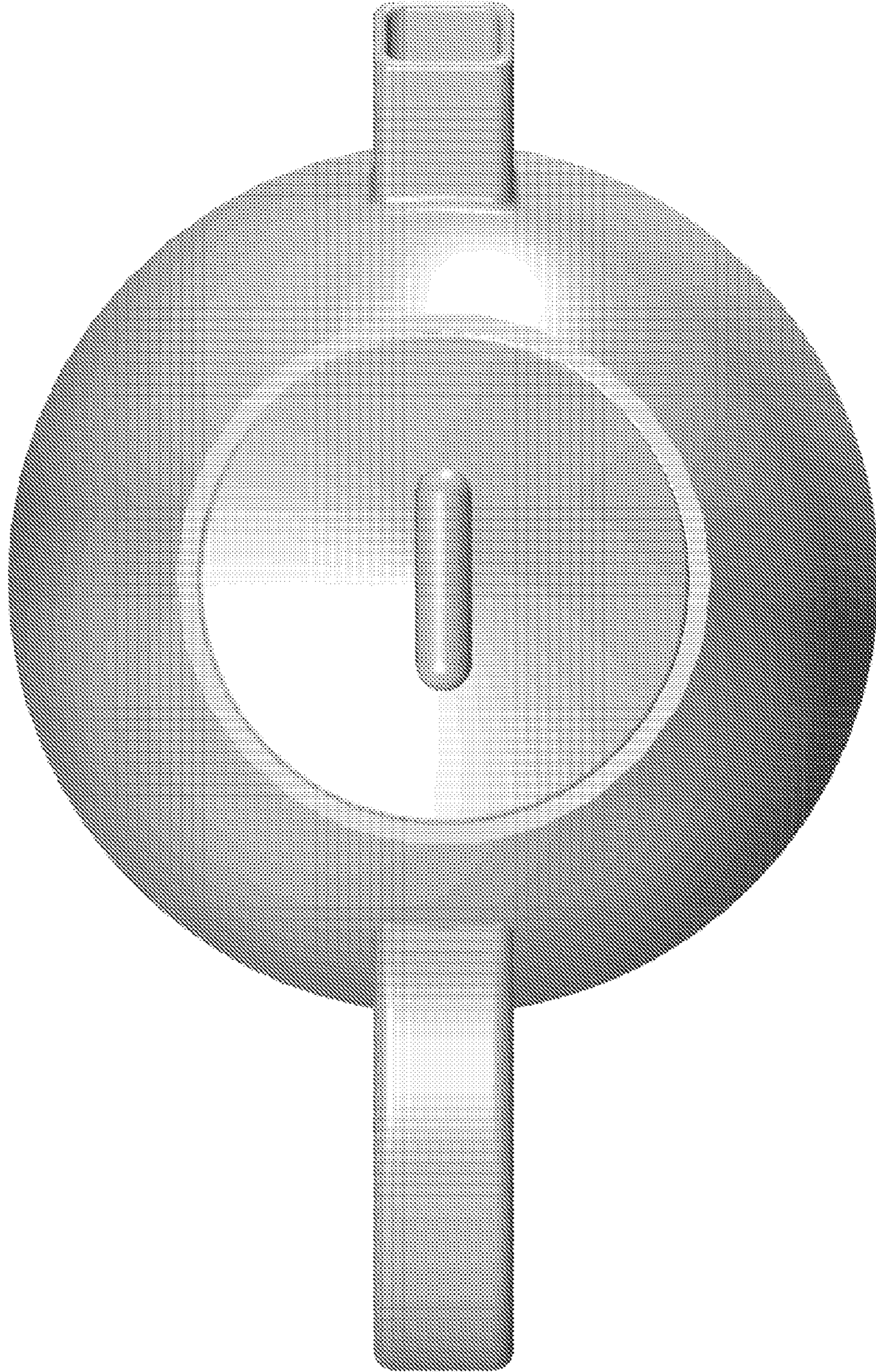
