The ornamental design for a tapered sheetrock mud knife, as shown and described.

DESCRIPTION

FIG. 1 is a bottom isometric view of a tapered sheetrock mud knife showing my new design.

FIG. 2 is a top view of a preferred embodiment

FIG. 3 is a front view thereof.

FIG. 4 is a bottom view thereof.

FIG. 5 is a right side view thereof.

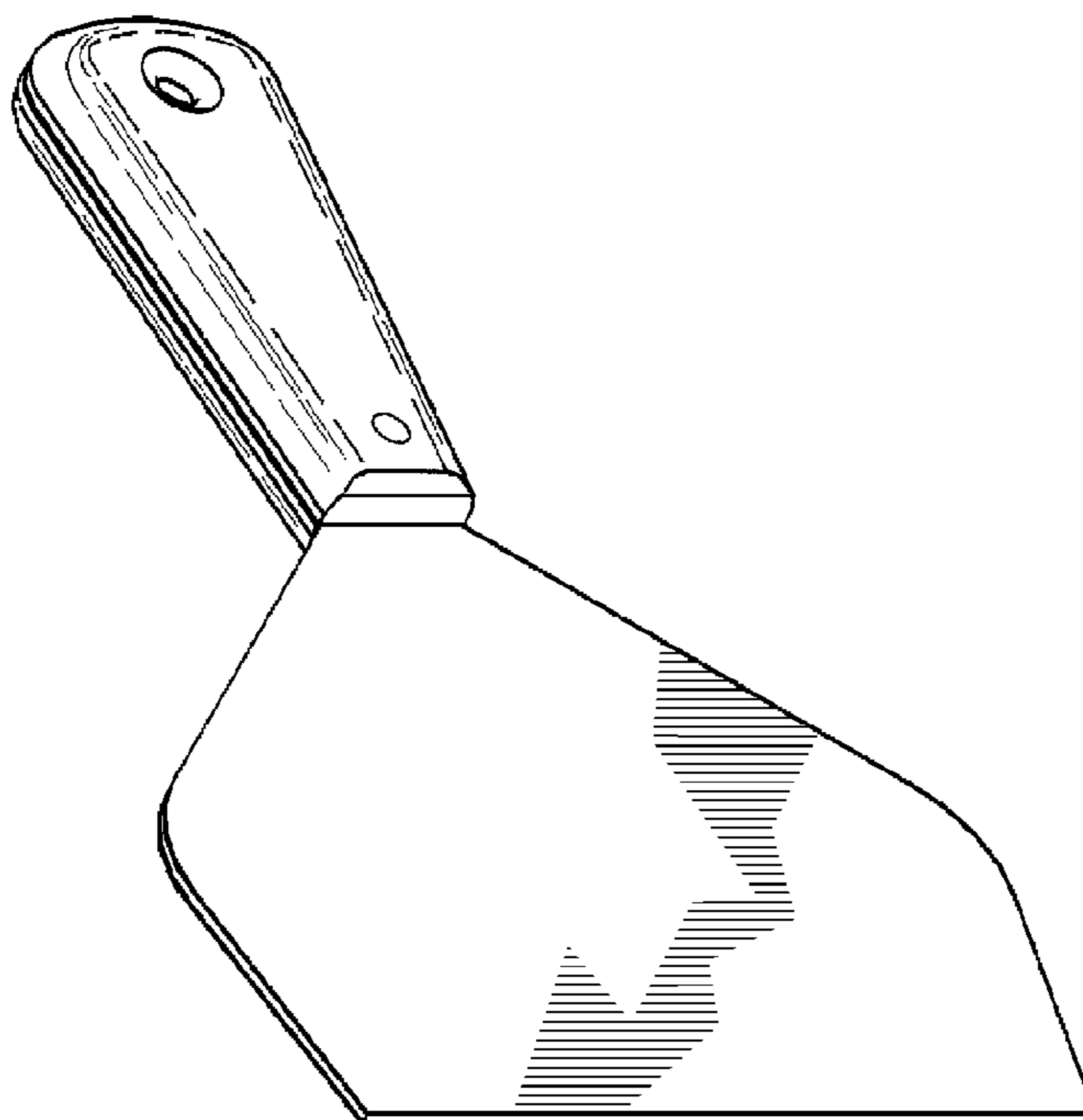
FIG. 6 is a back view thereof.

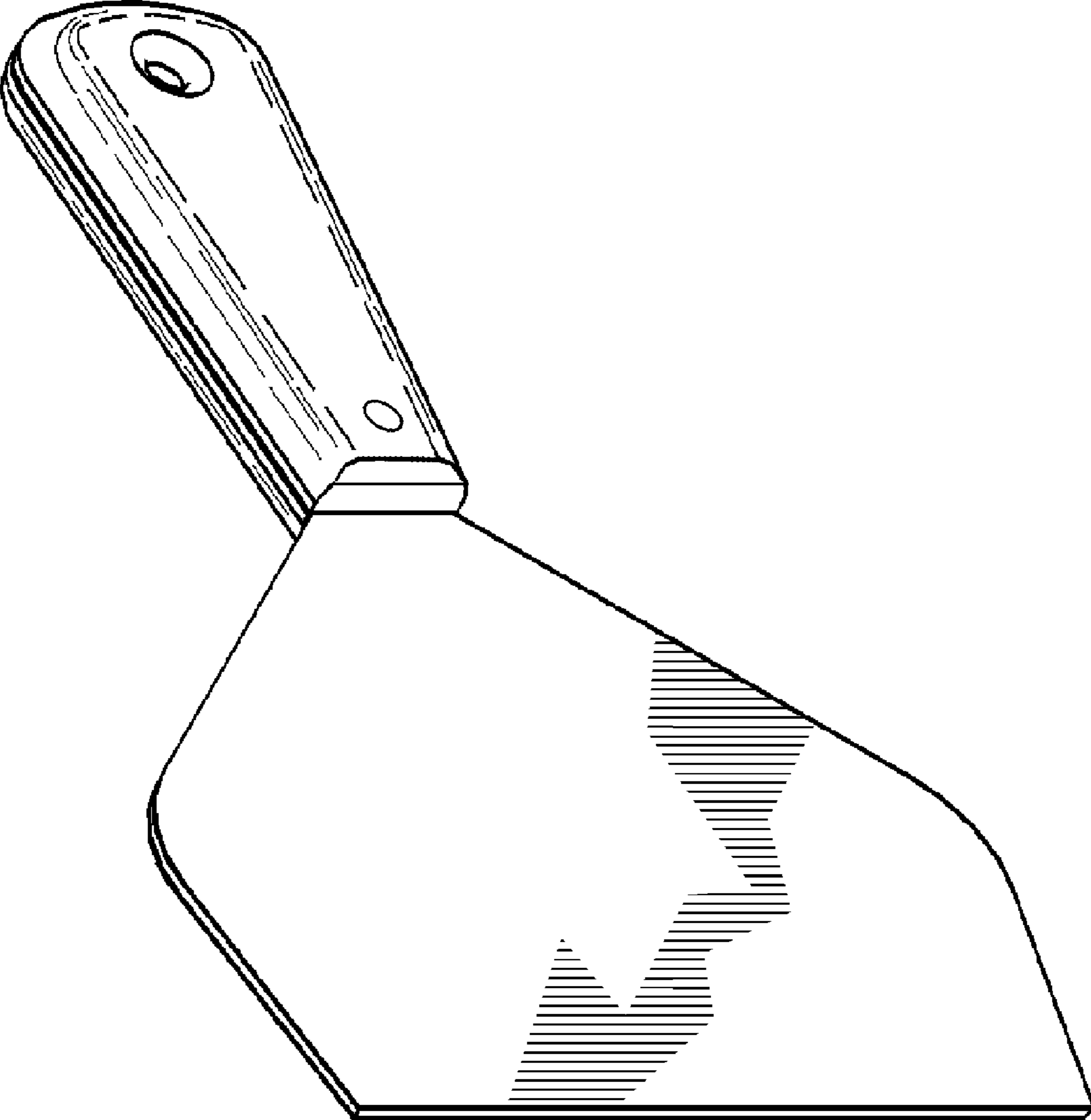

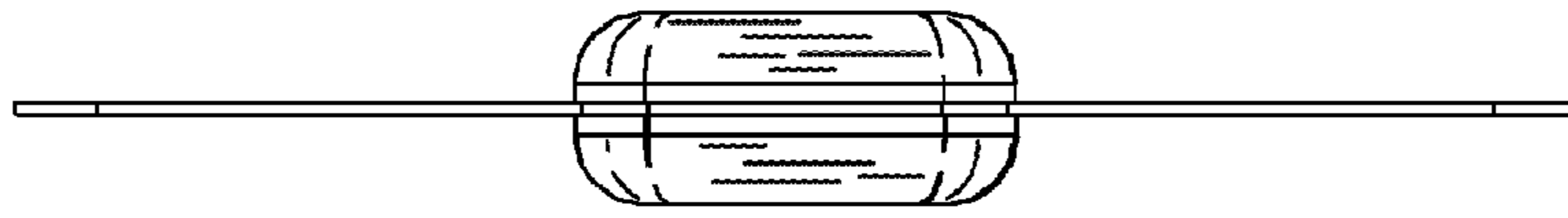

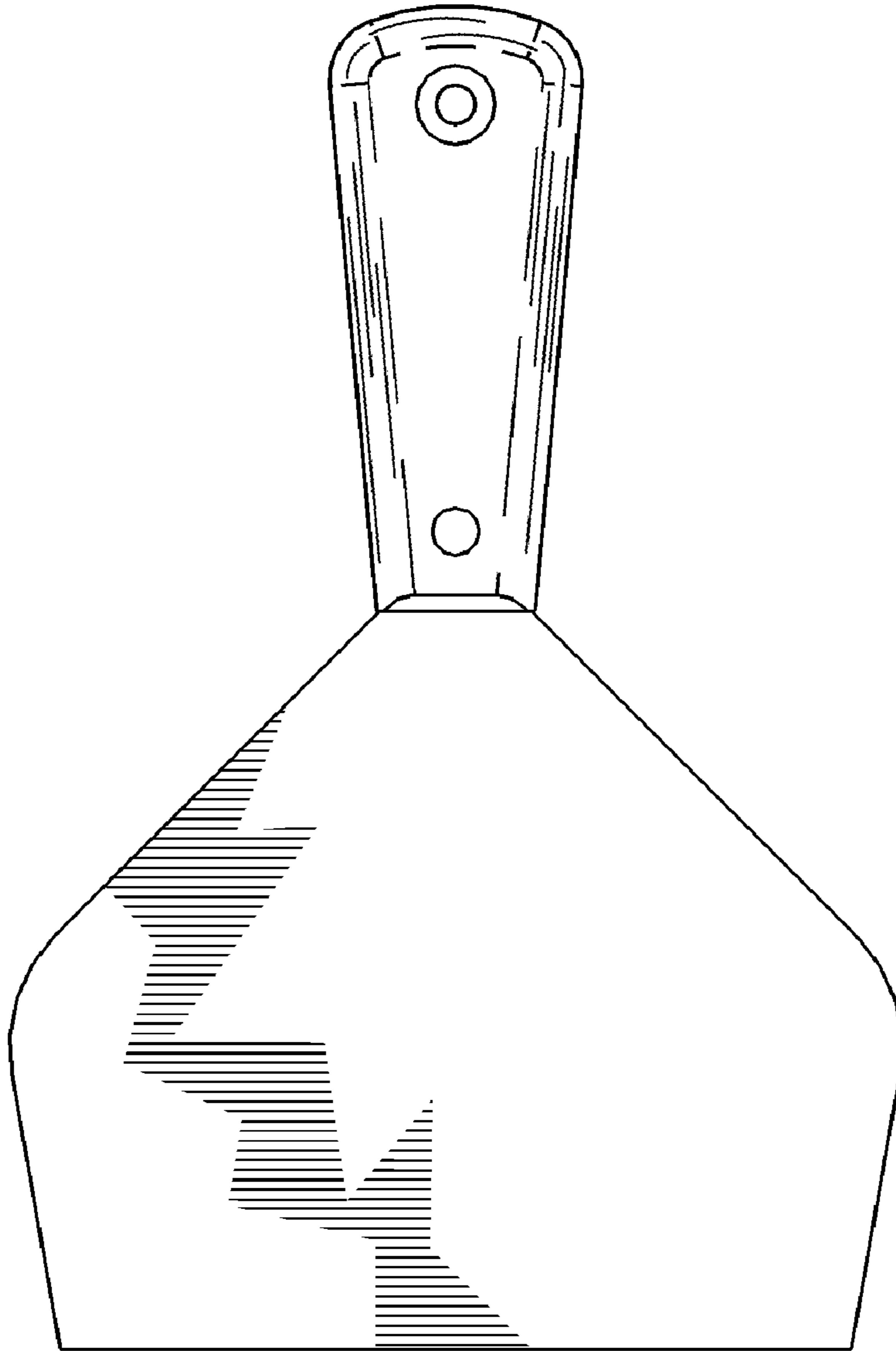

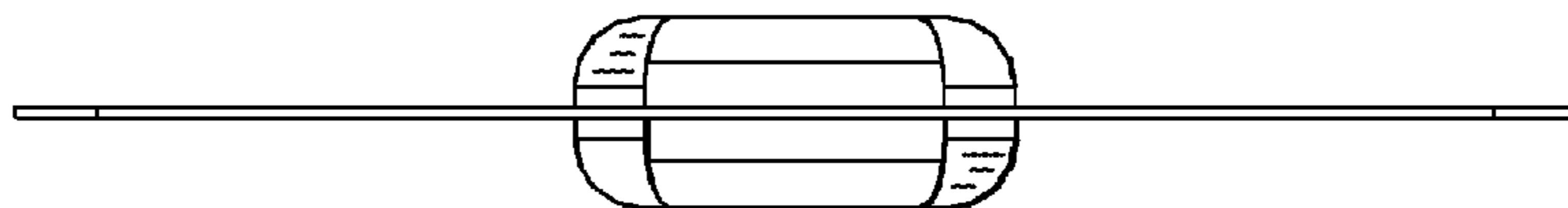

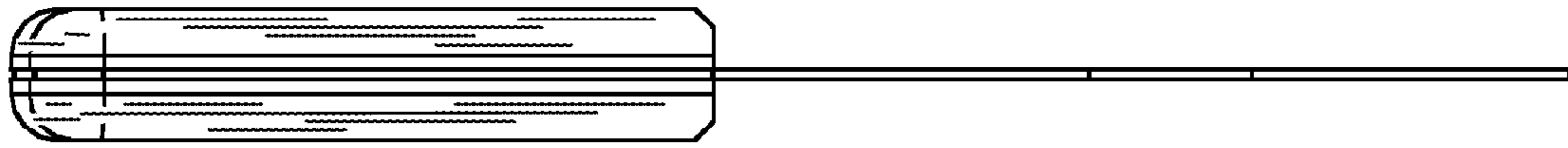

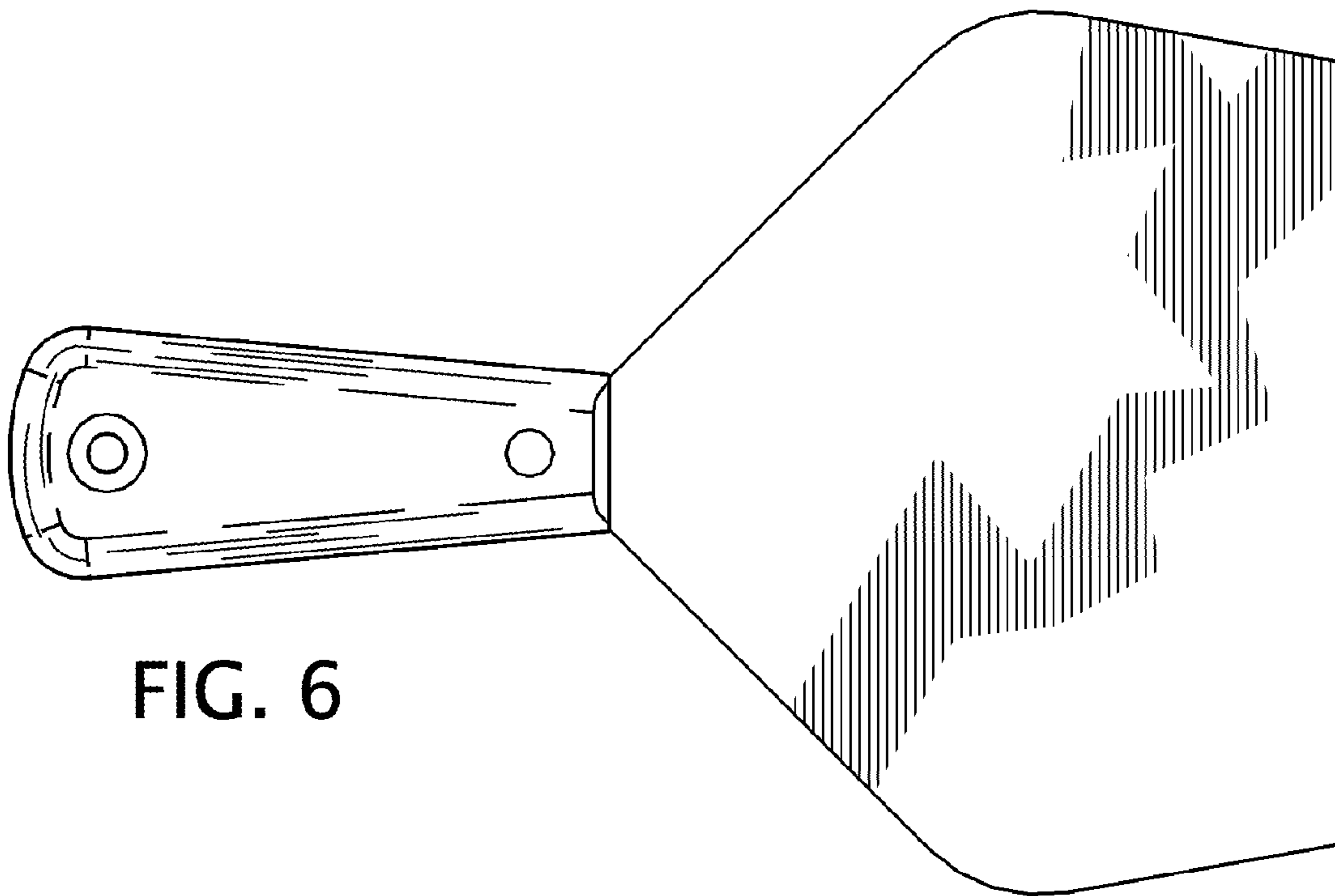

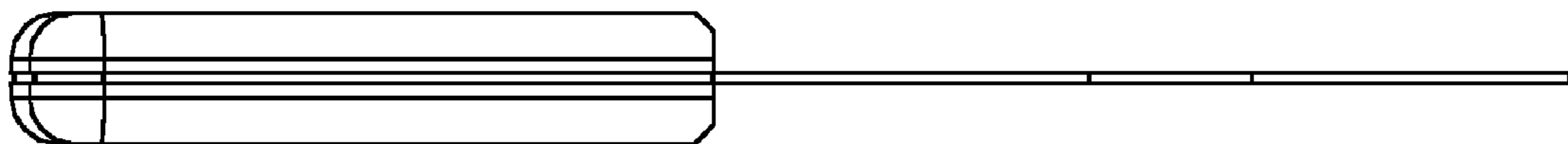

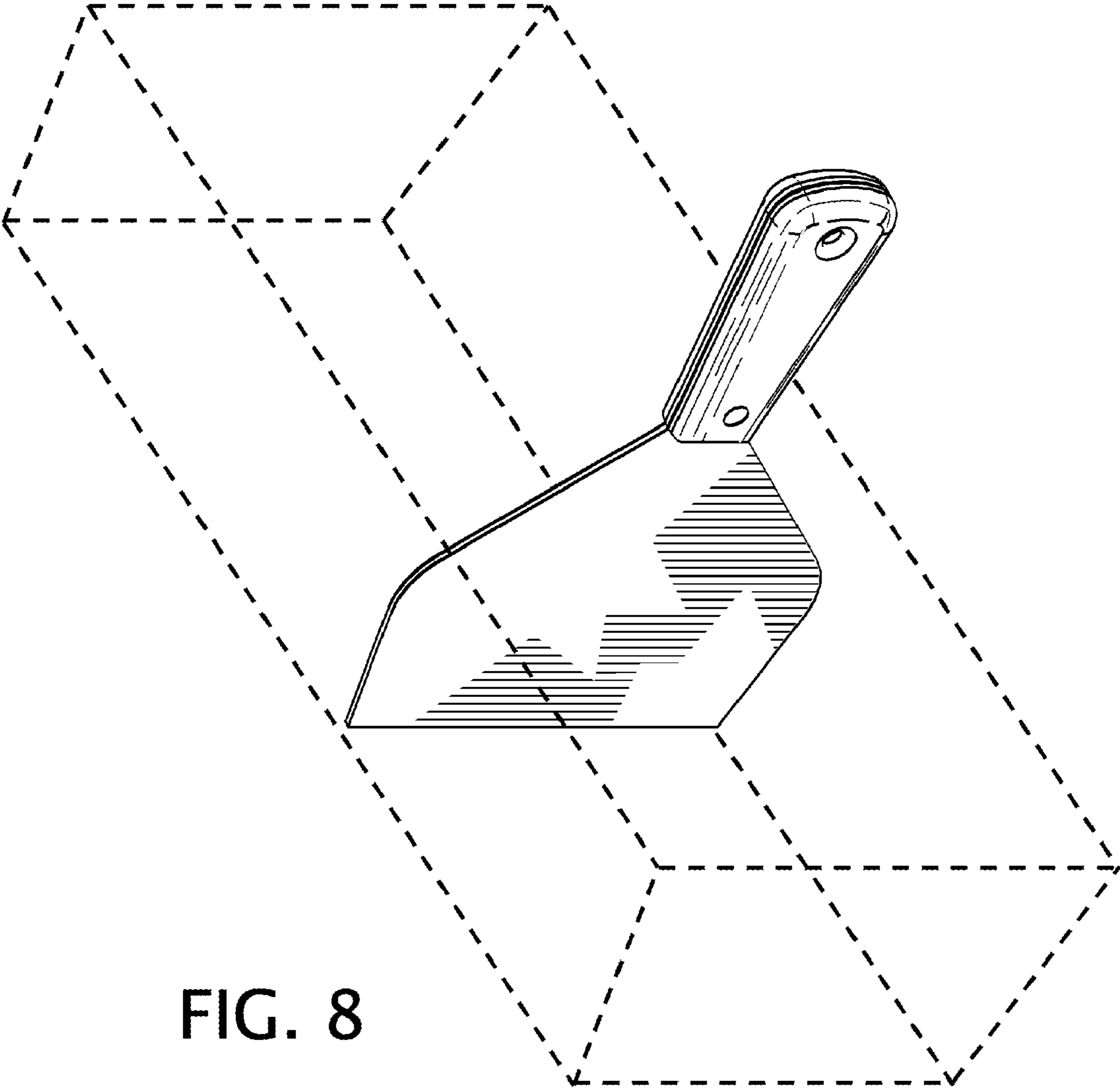
