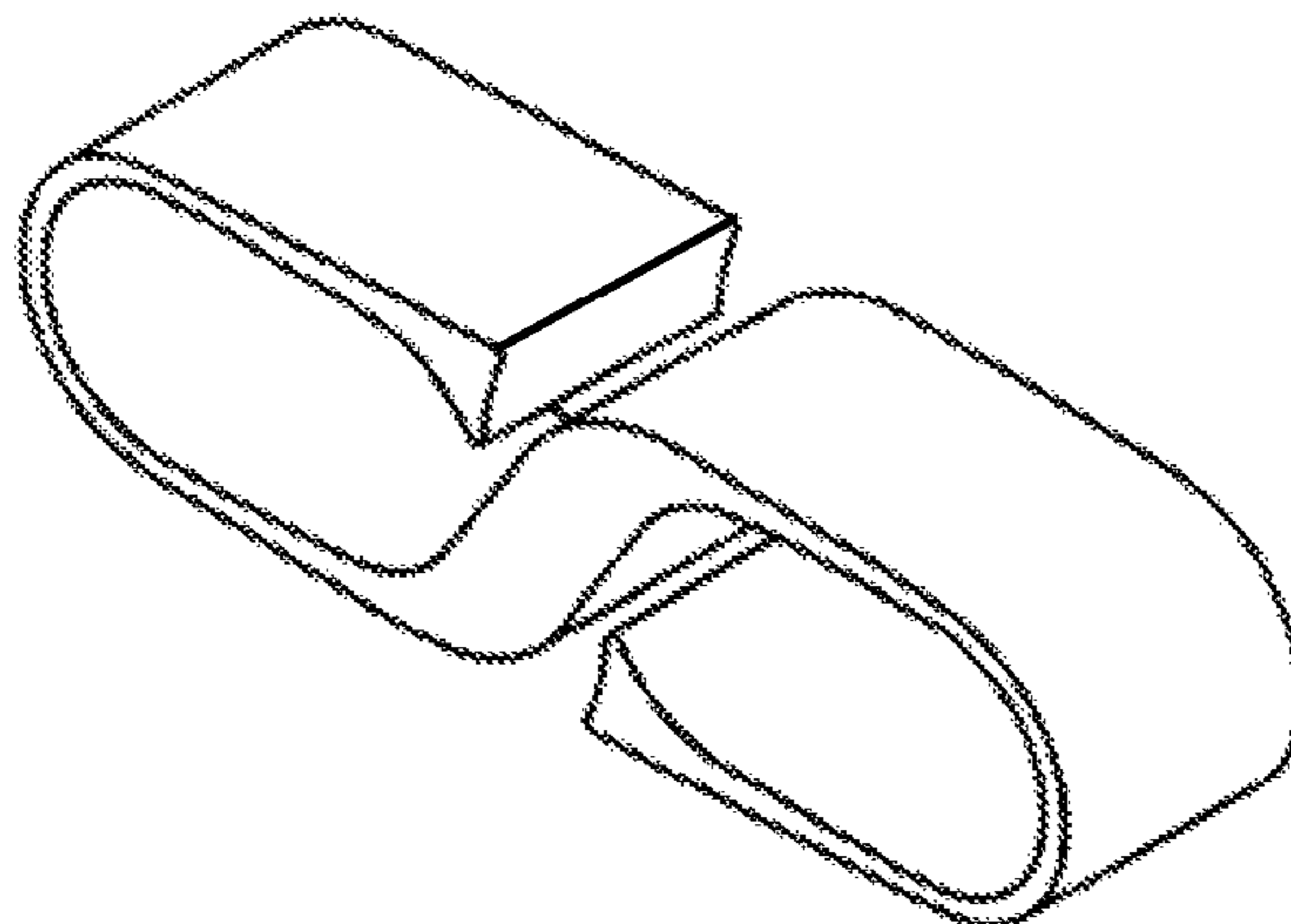
The ornamental design for a cable organizer, as shown and described.

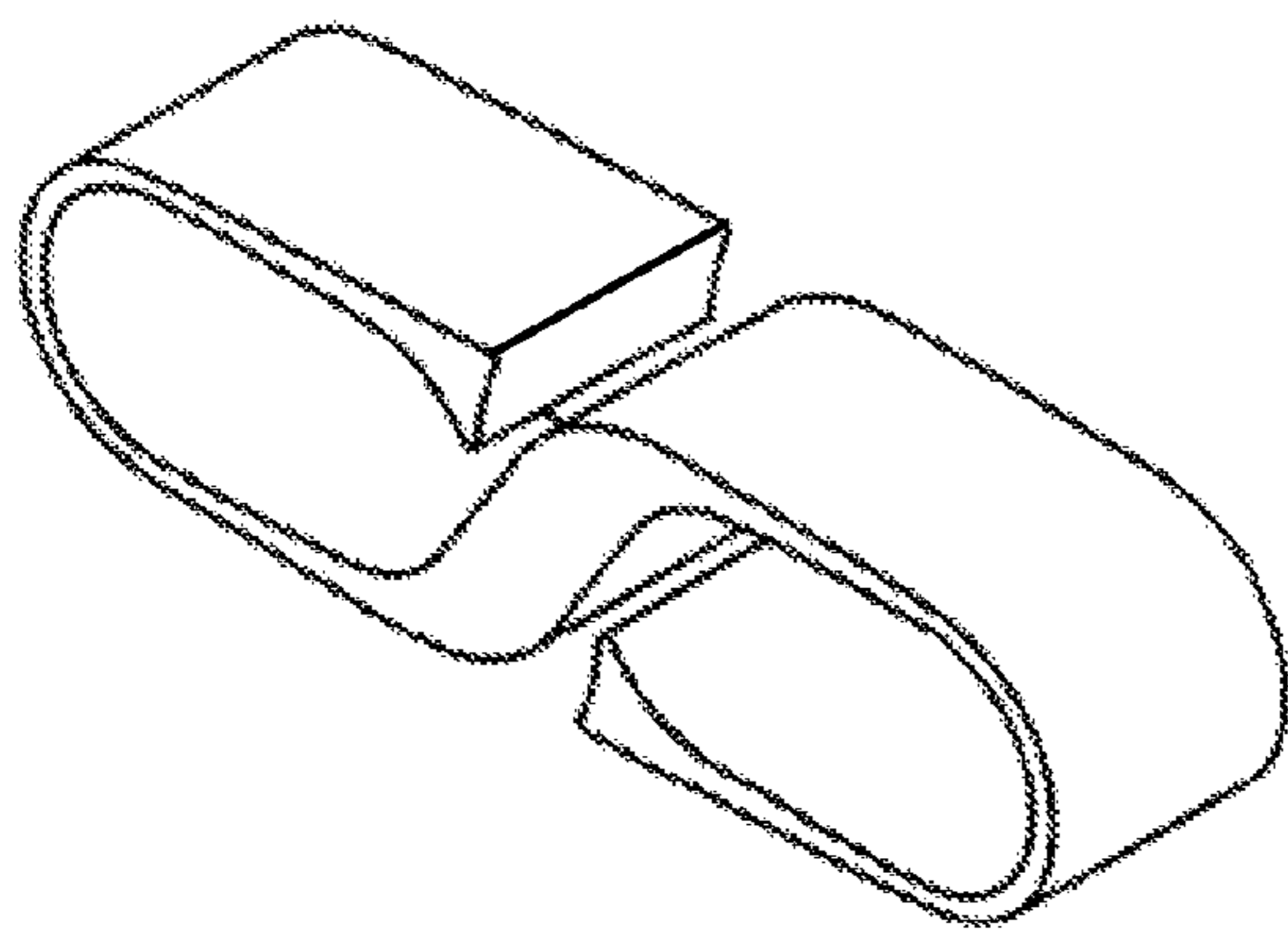

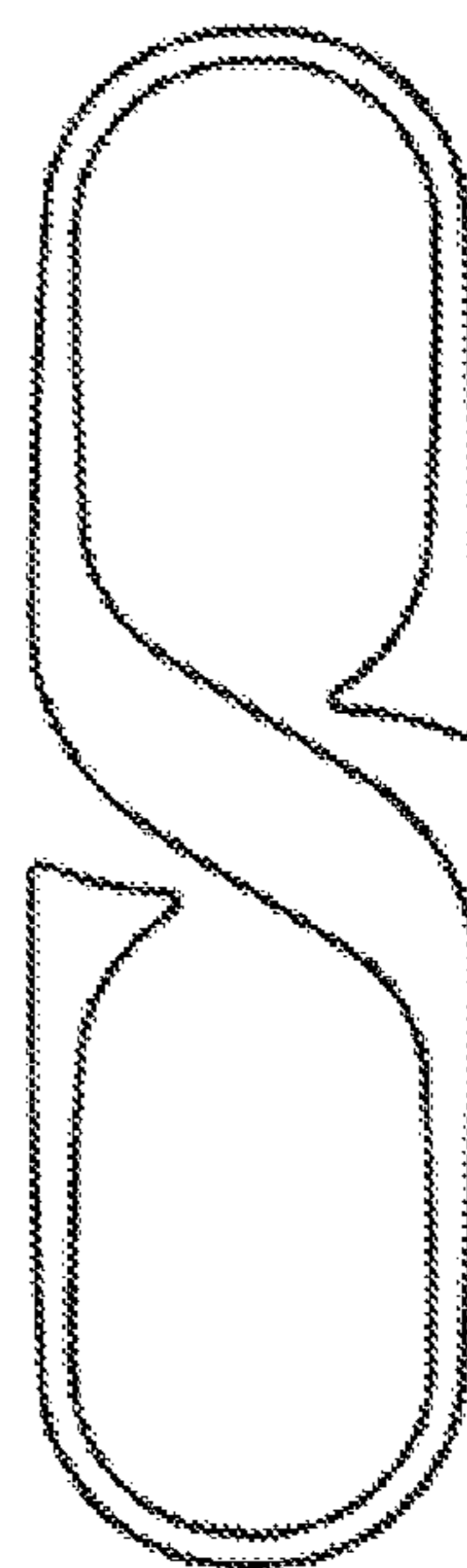
