DESCRIPTION

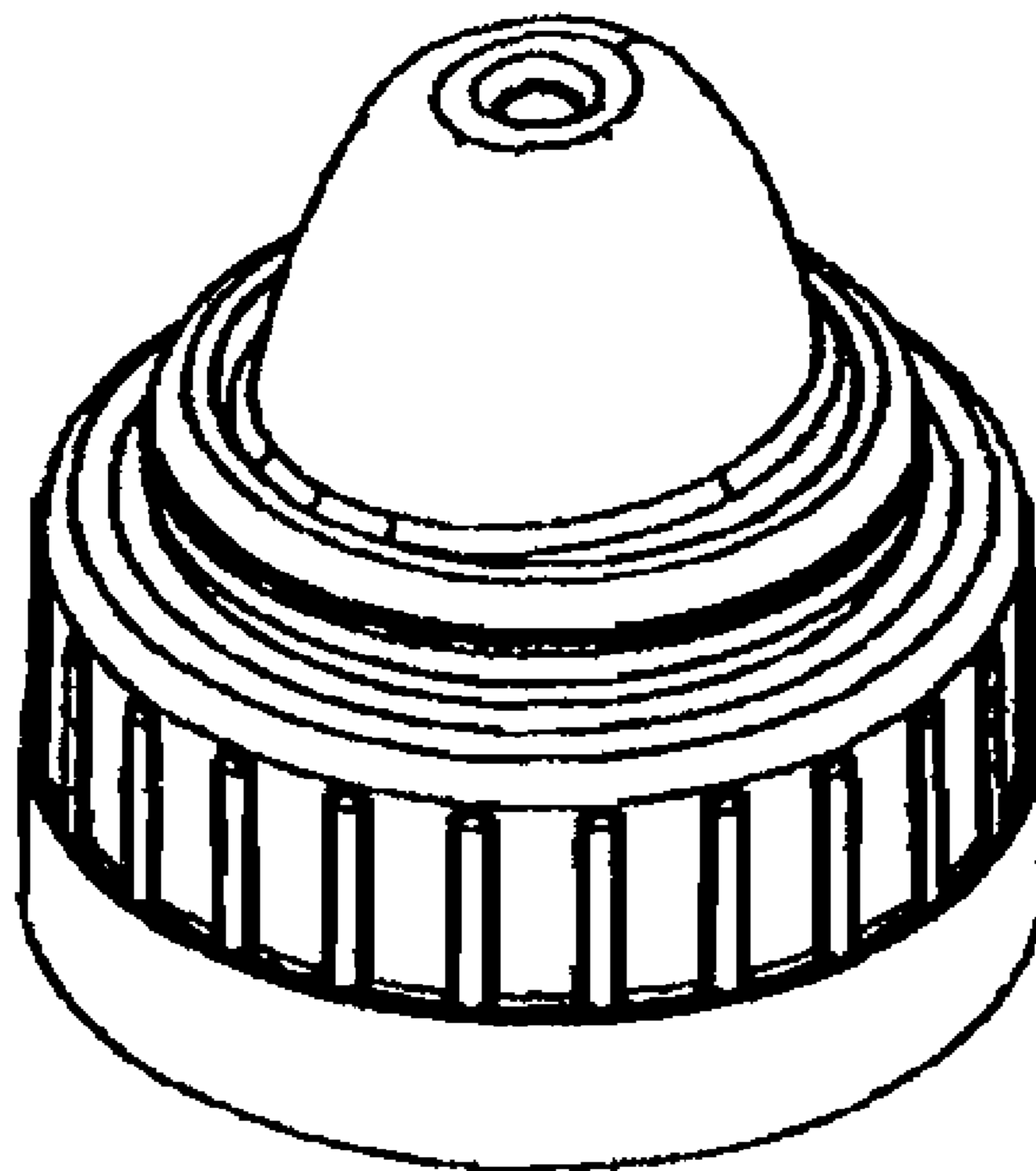
FIG. 1 is a perspective view of a bottle cap showing my new

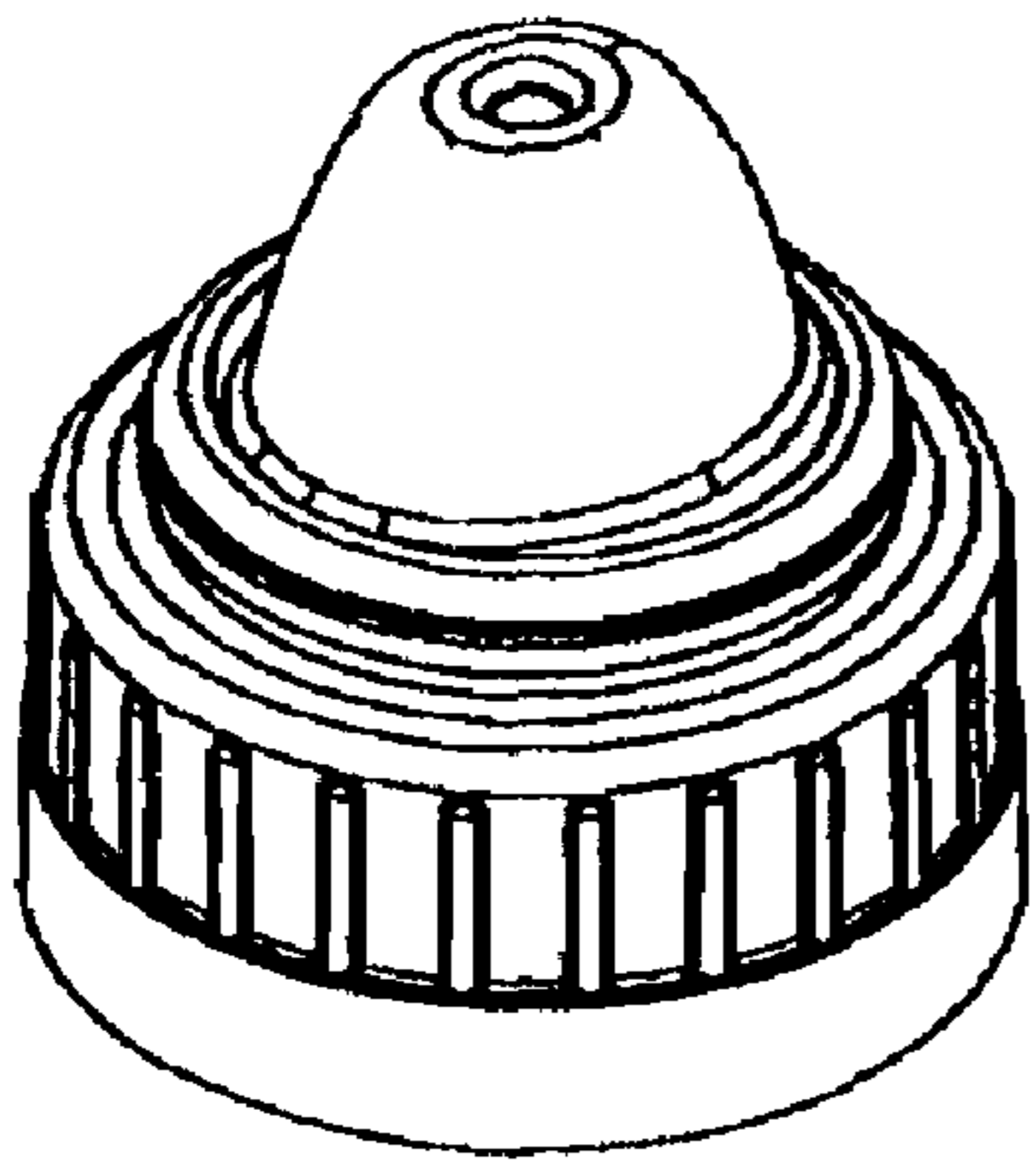

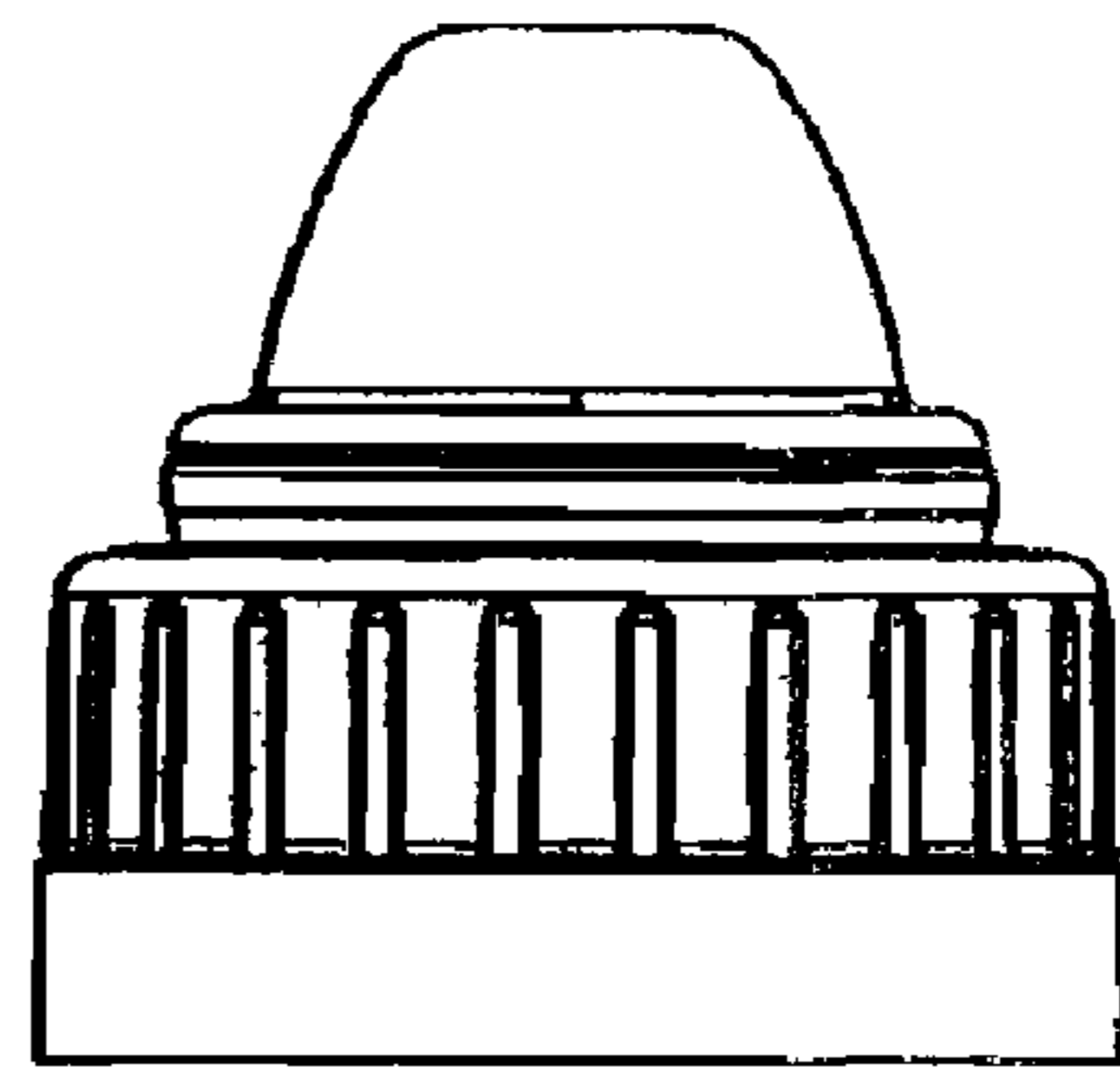

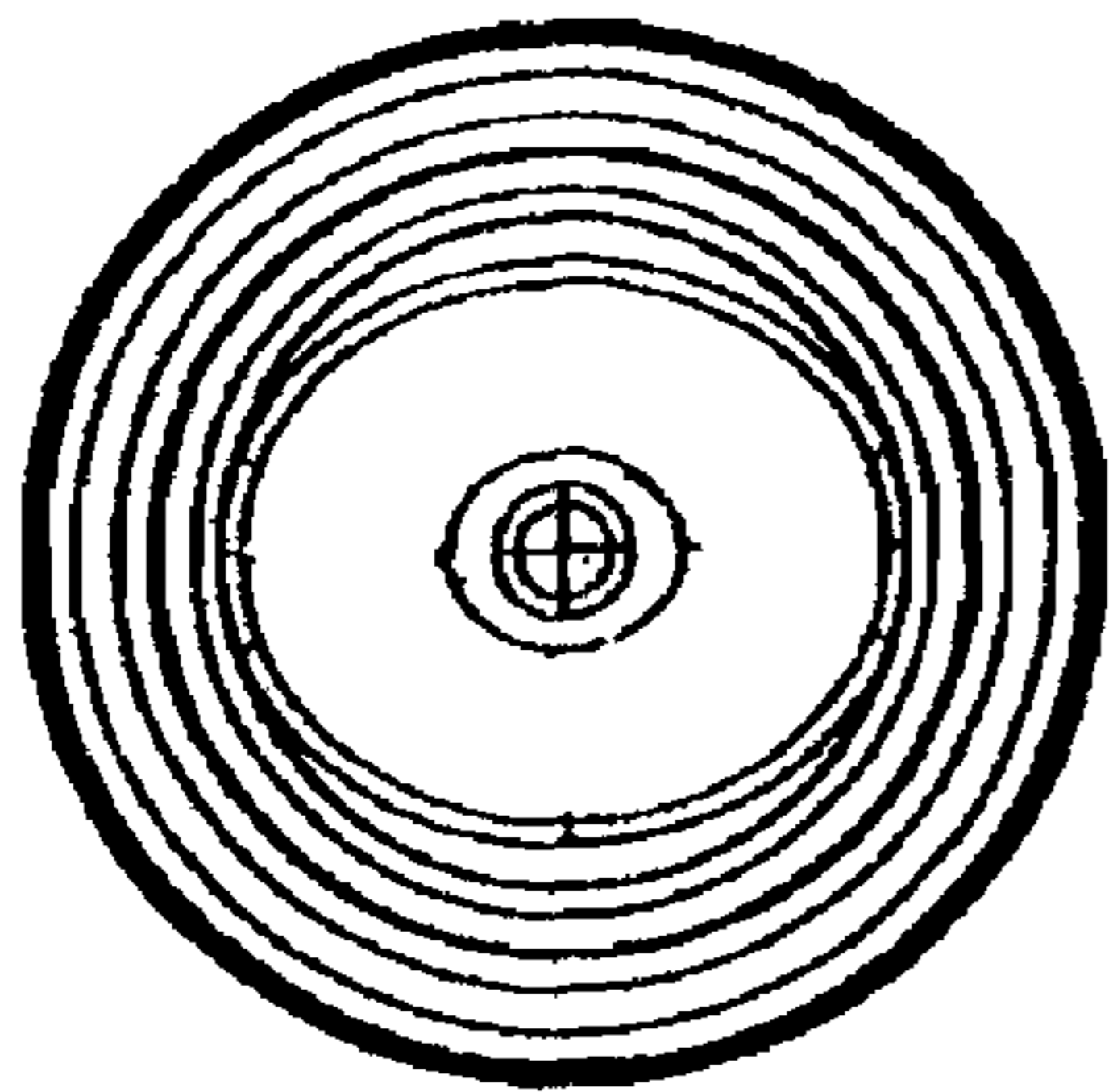

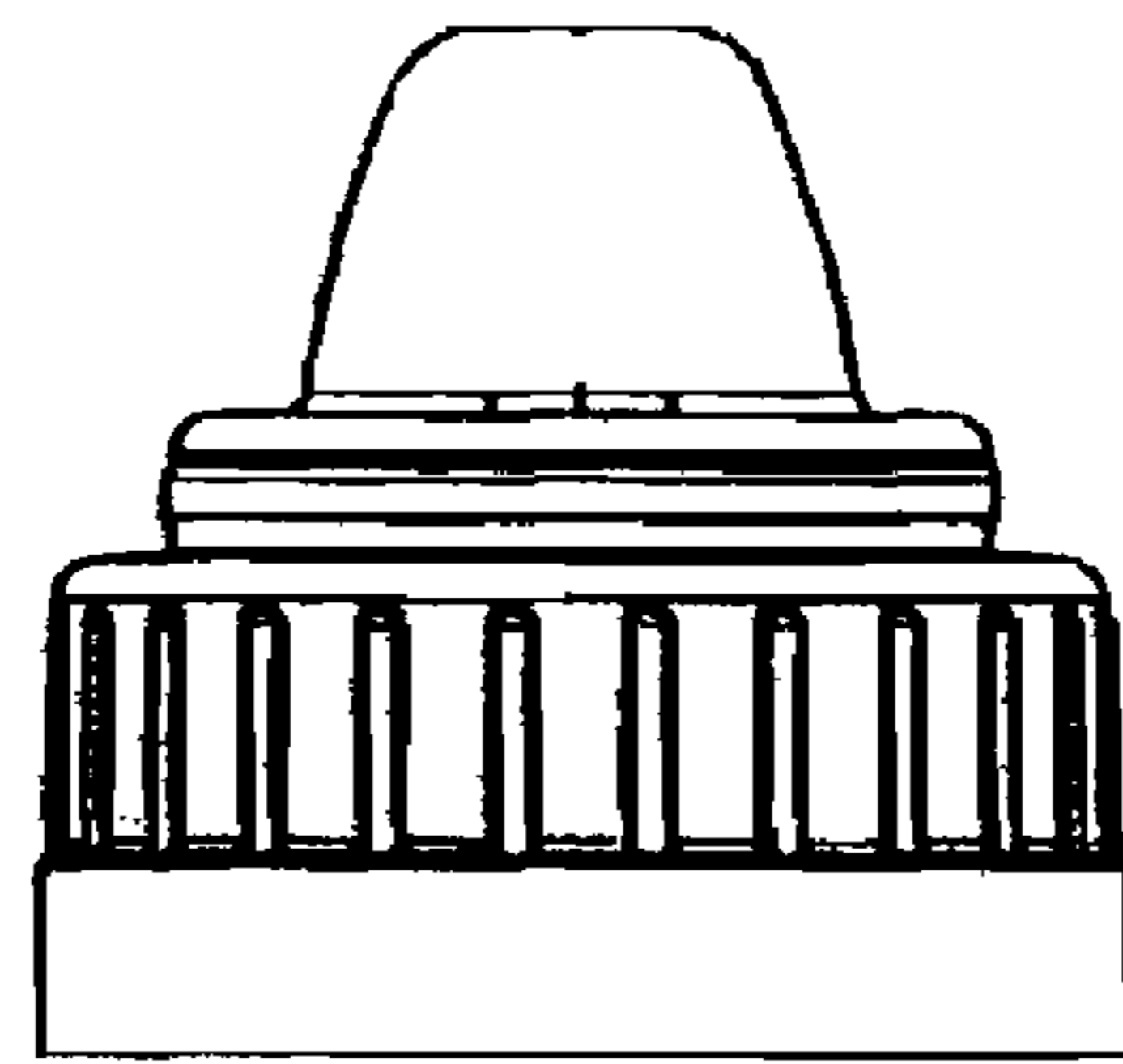
