The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a container showing our new design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a top plan view thereof; and

FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is a perspective view of the container shown in an alternate position.

The broken lines shown on the bottom surface are included for the purpose of showing environmental structure that forms no part of the claimed design.

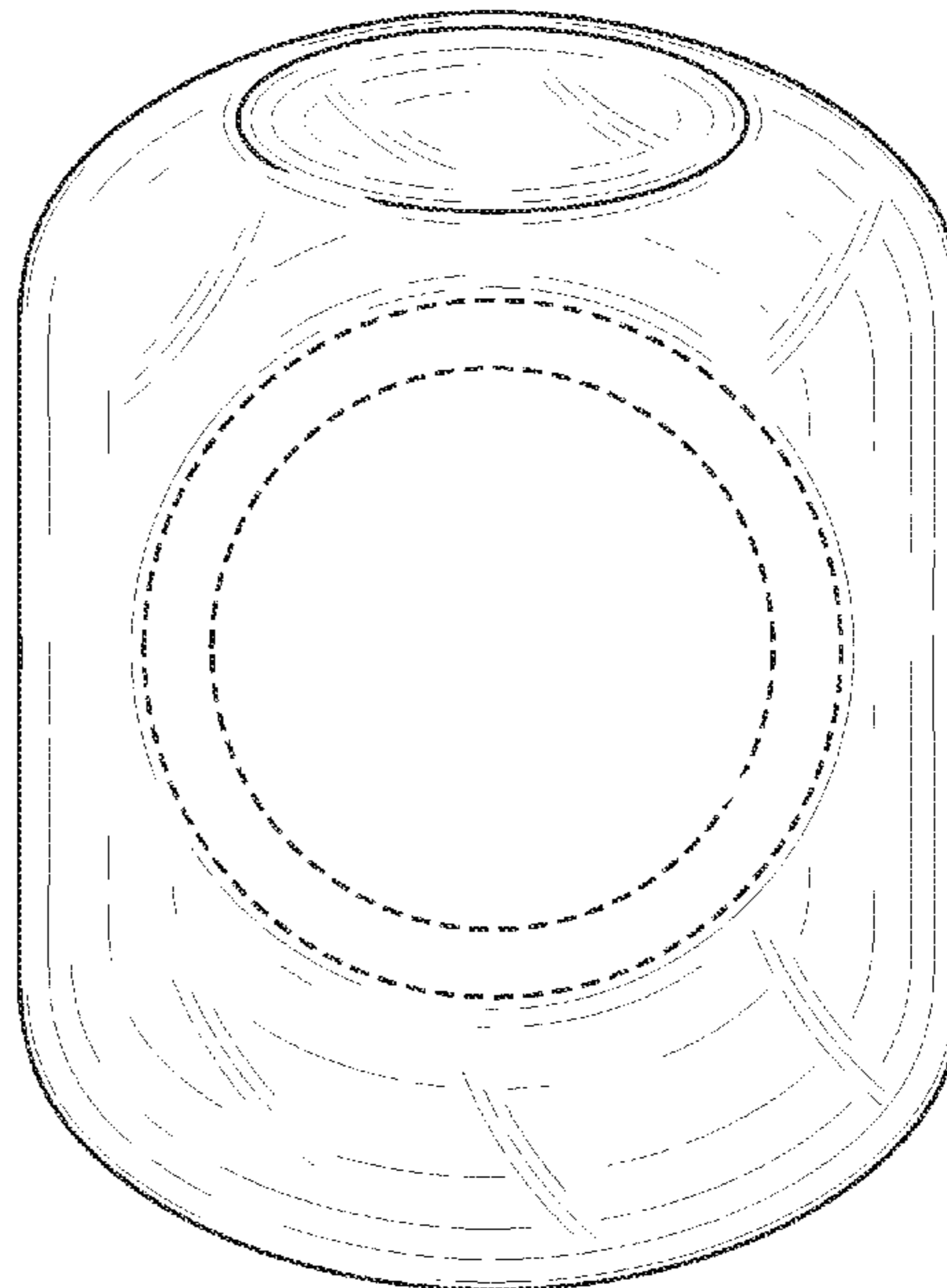
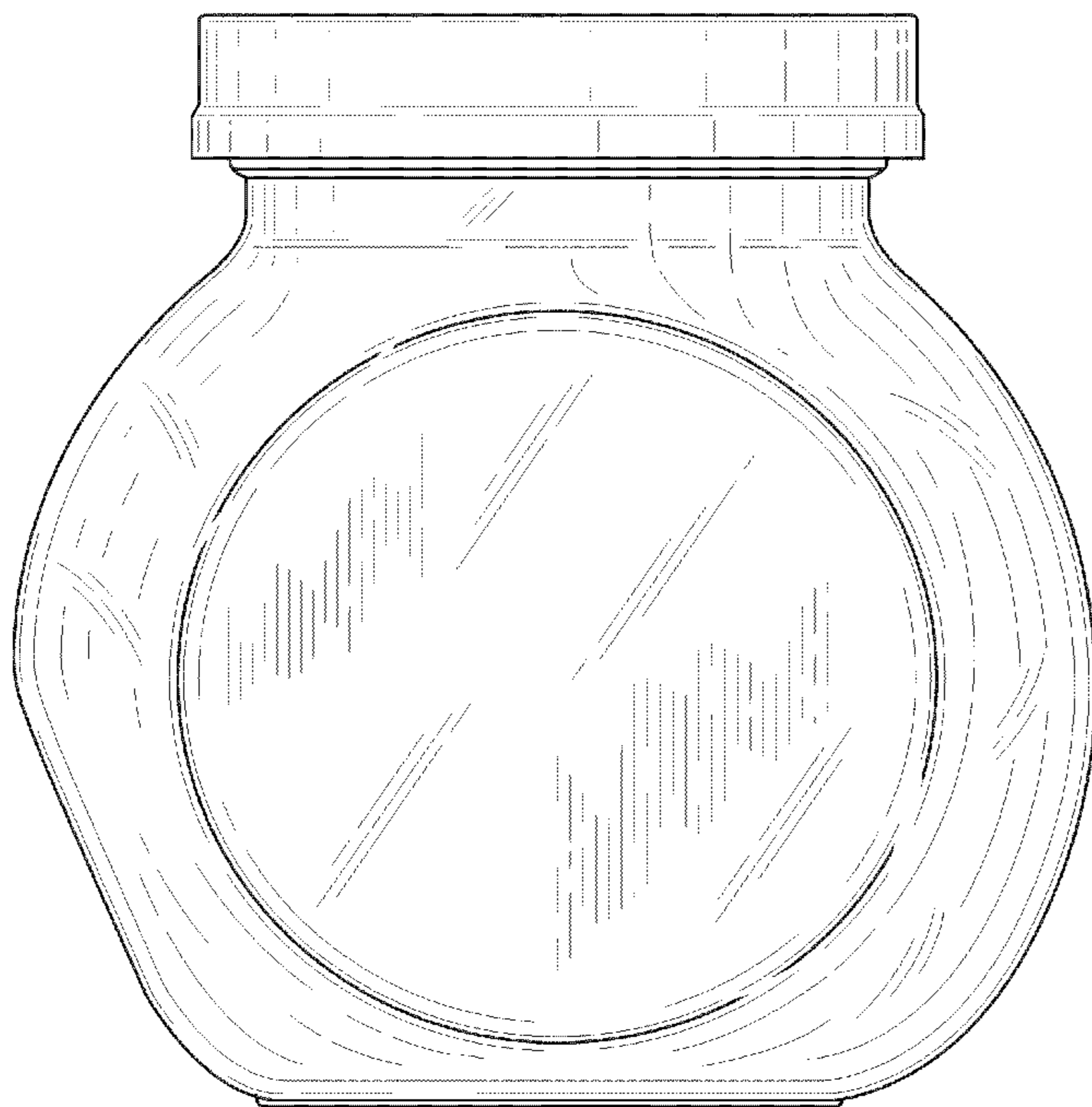

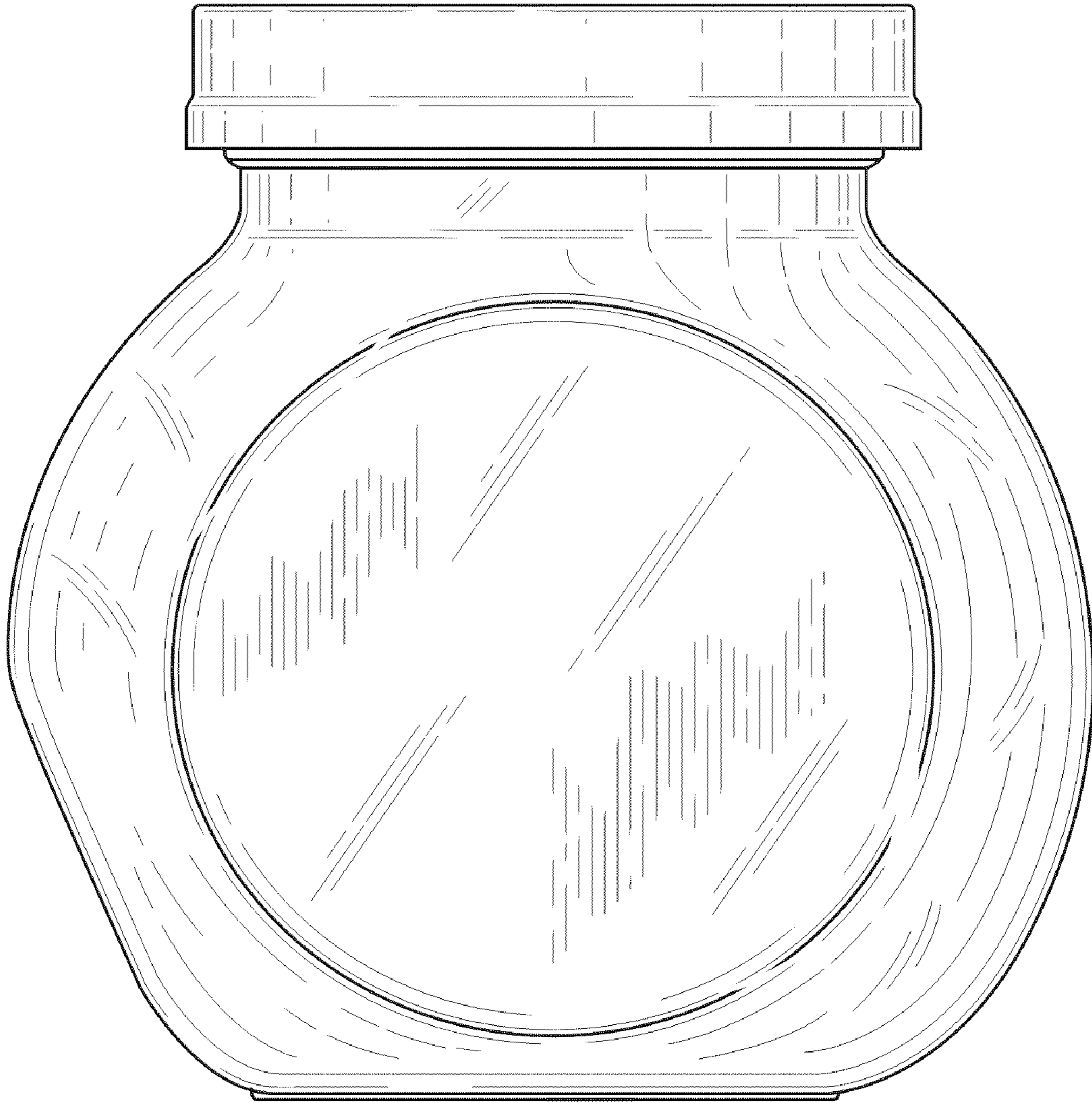

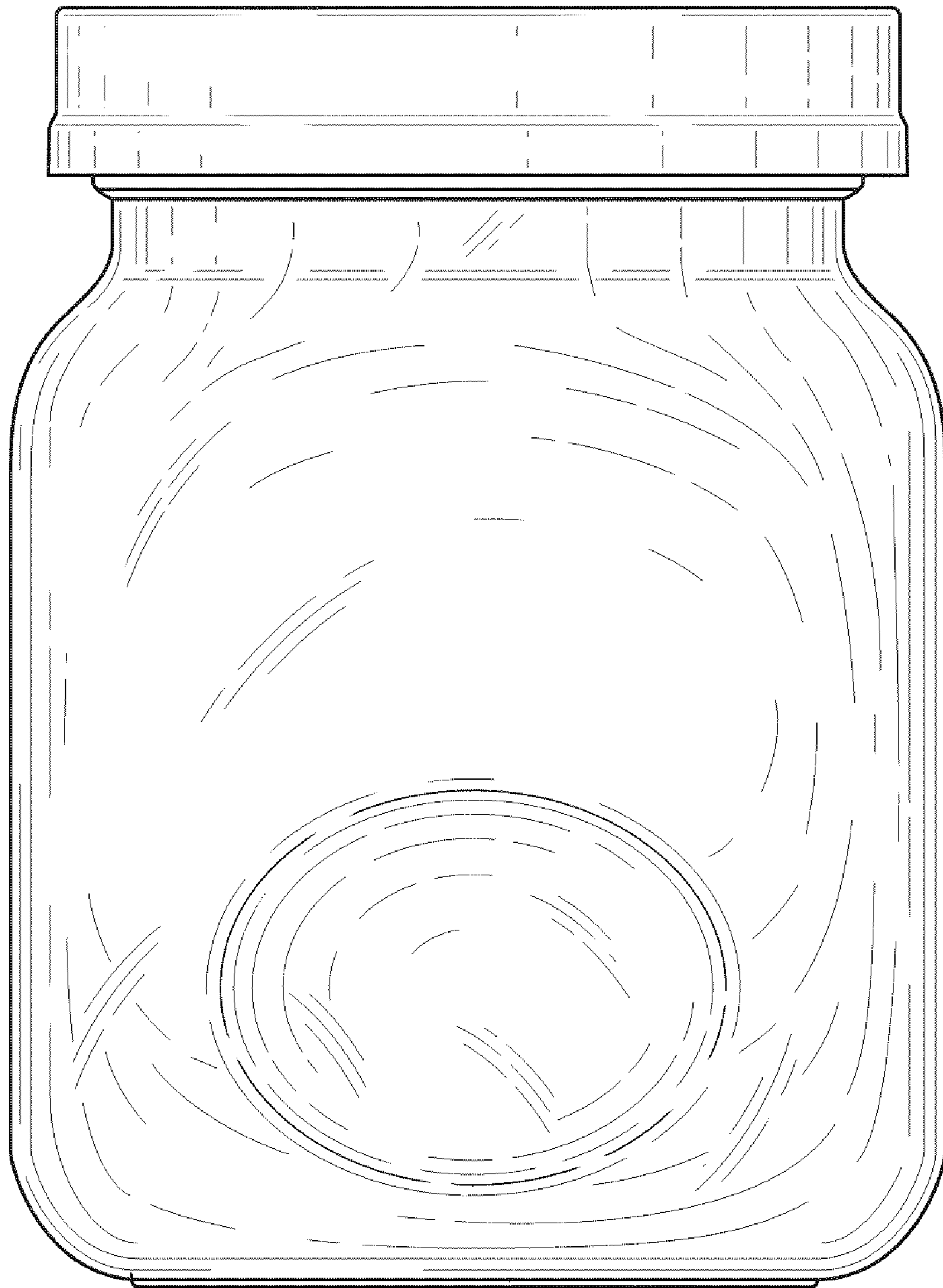

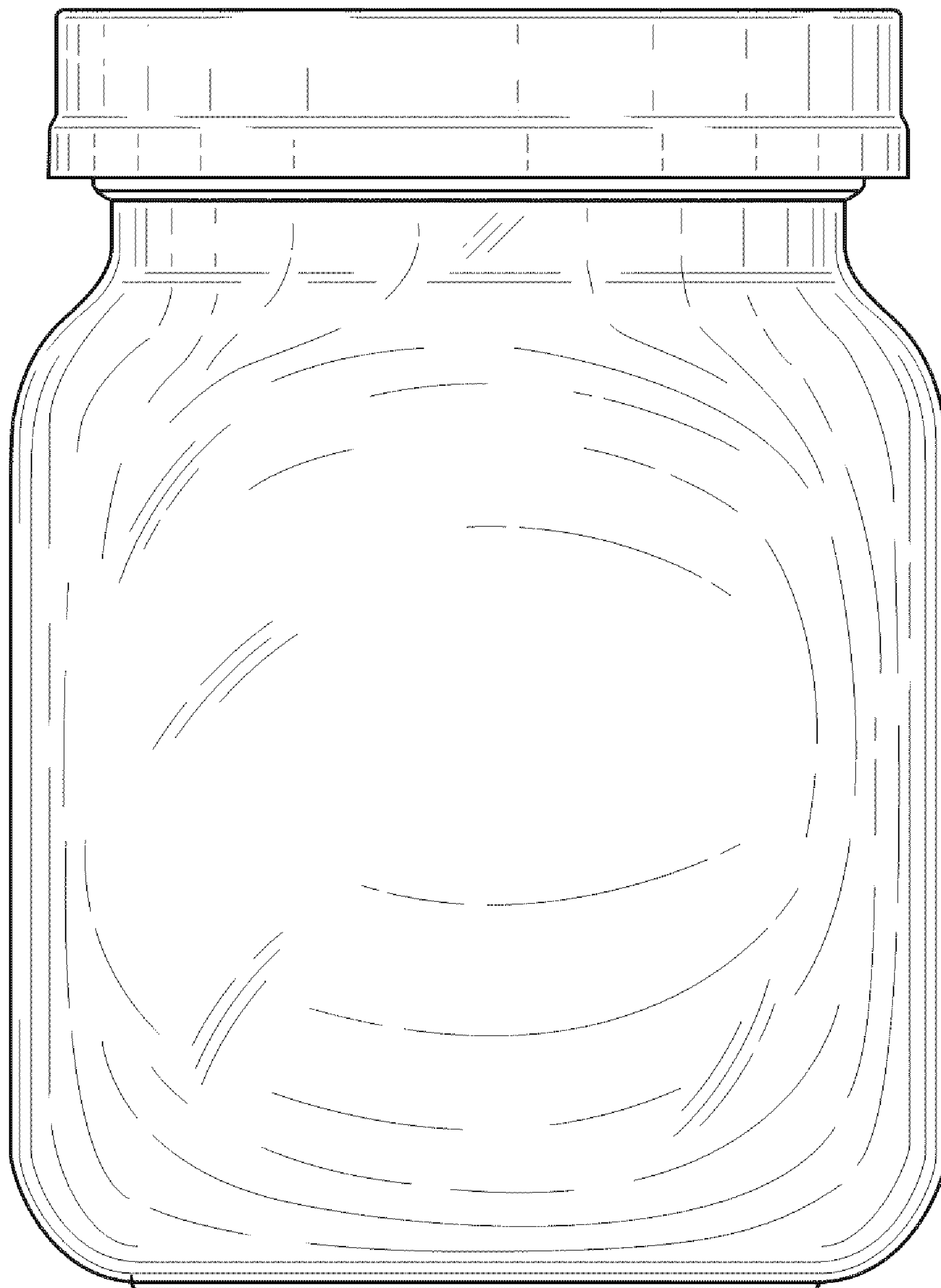

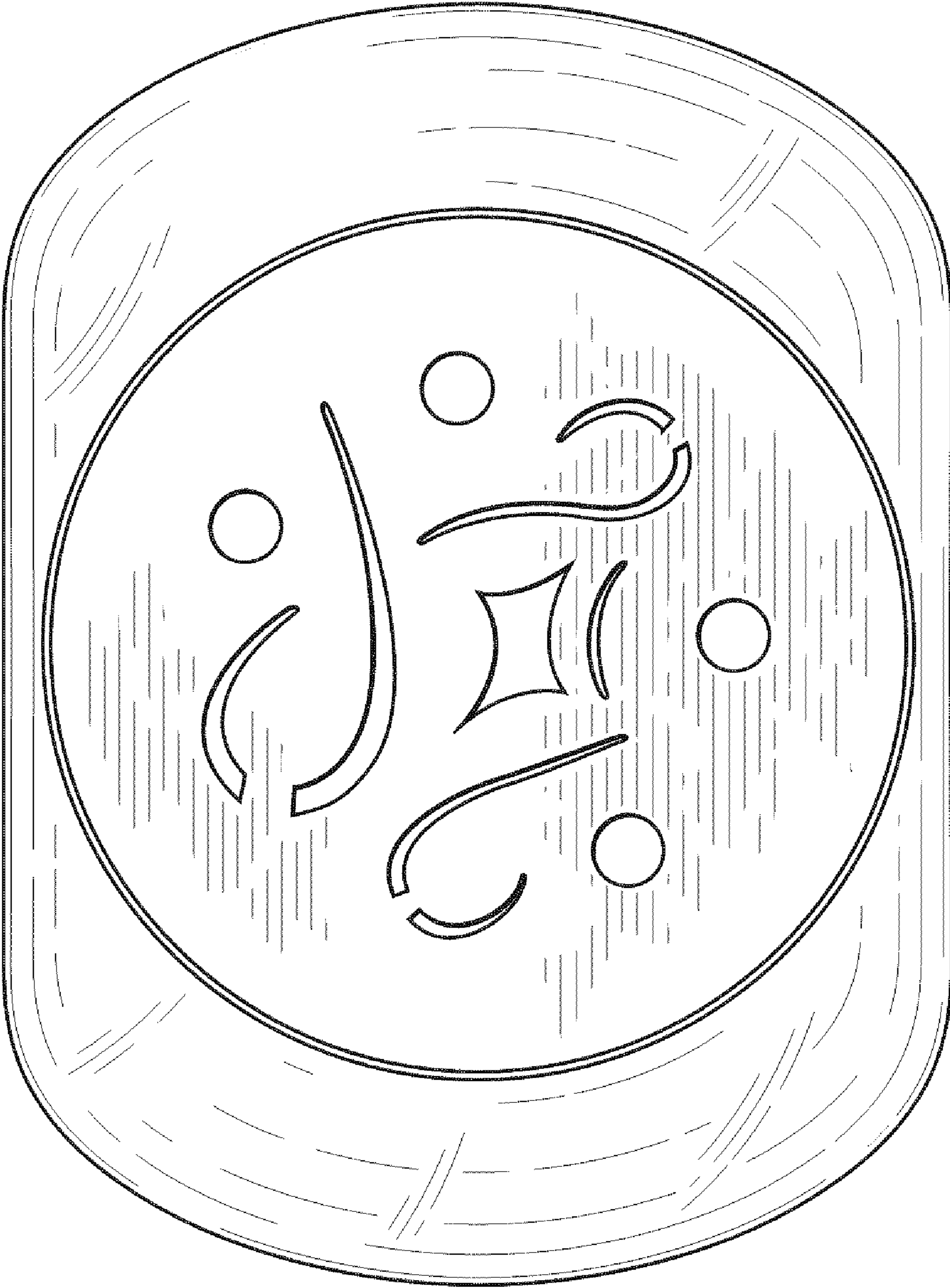

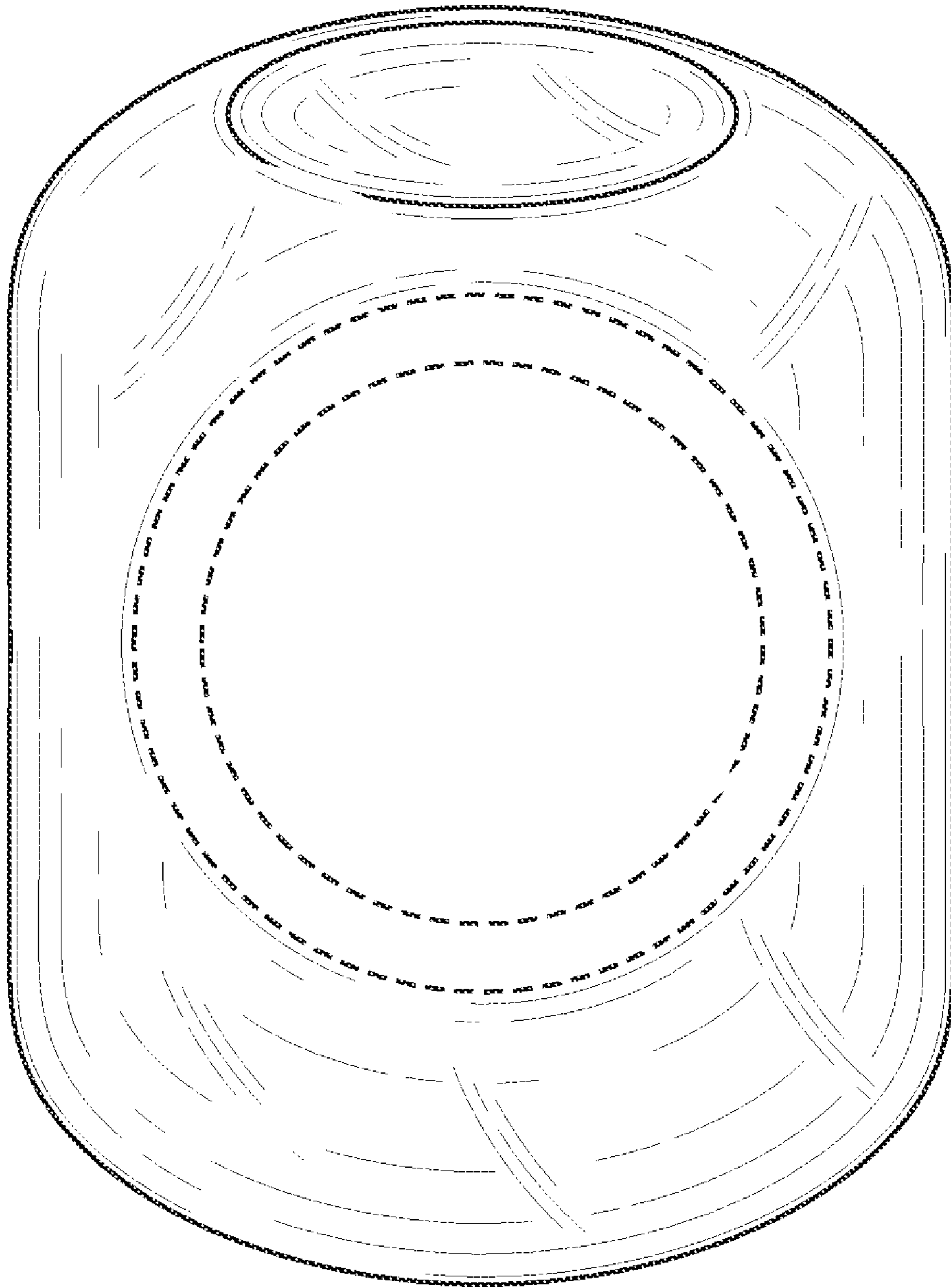

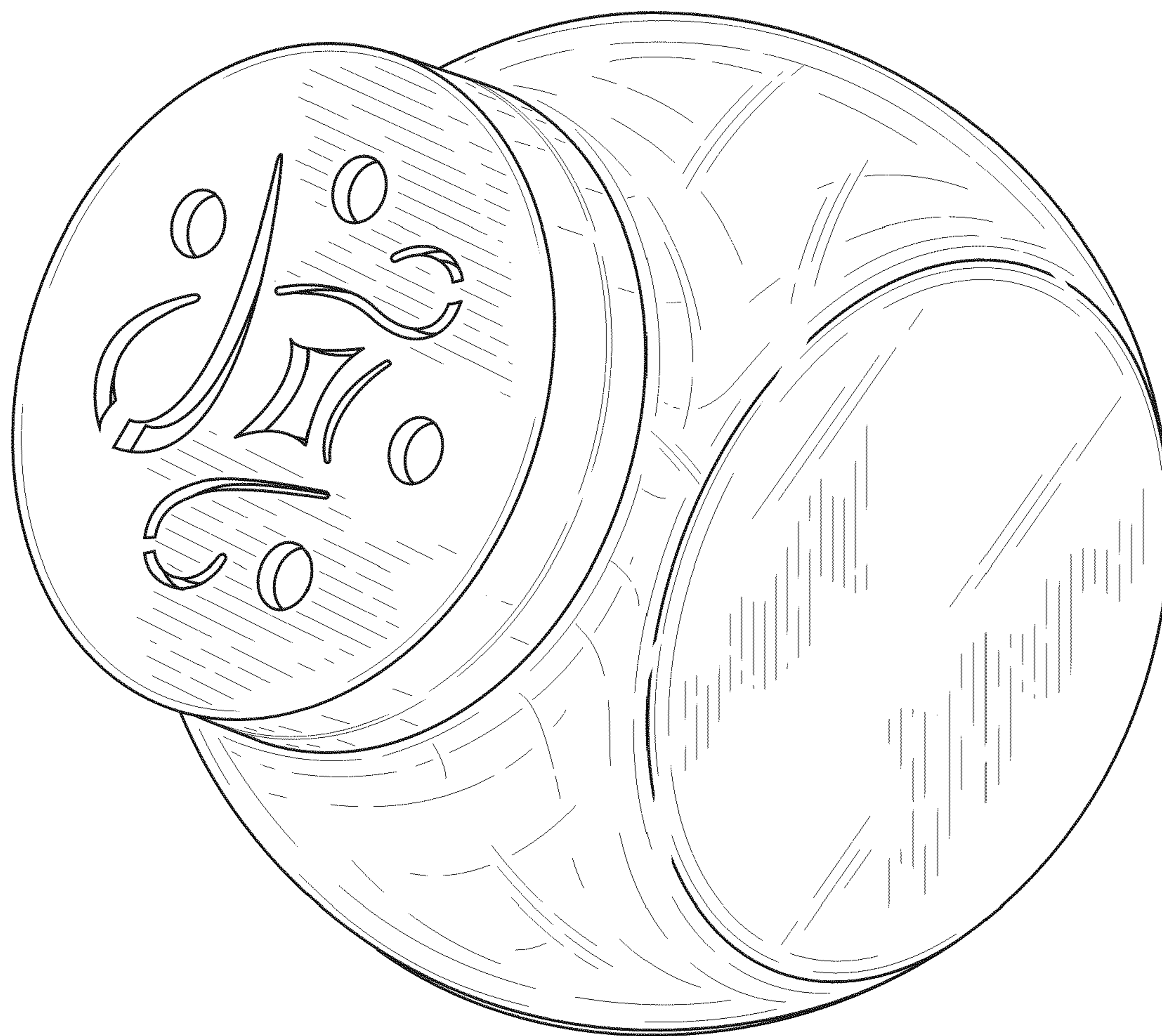
