DESCRIPTION

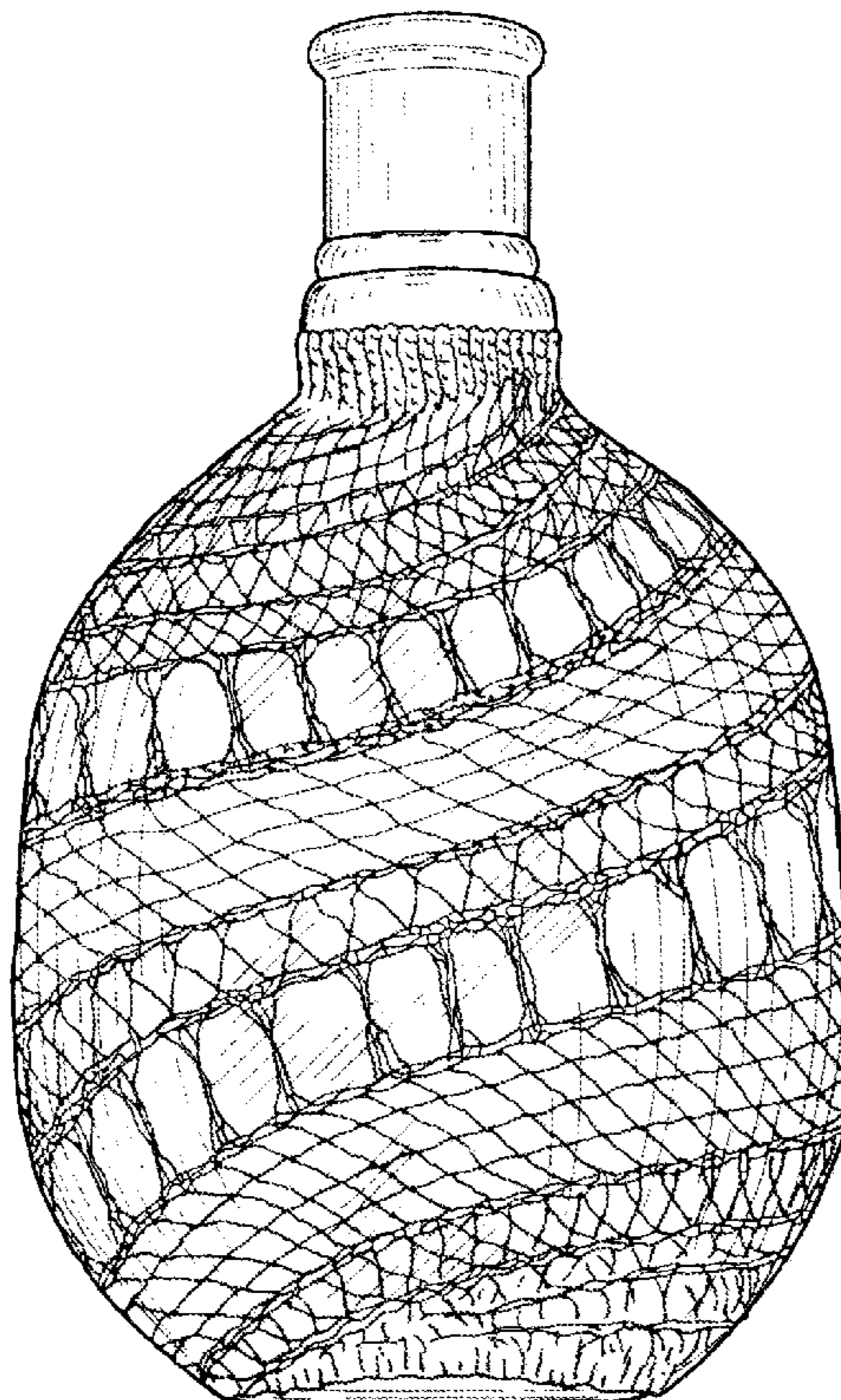
FIG. 1 is a front view of a bottle showing my new design;

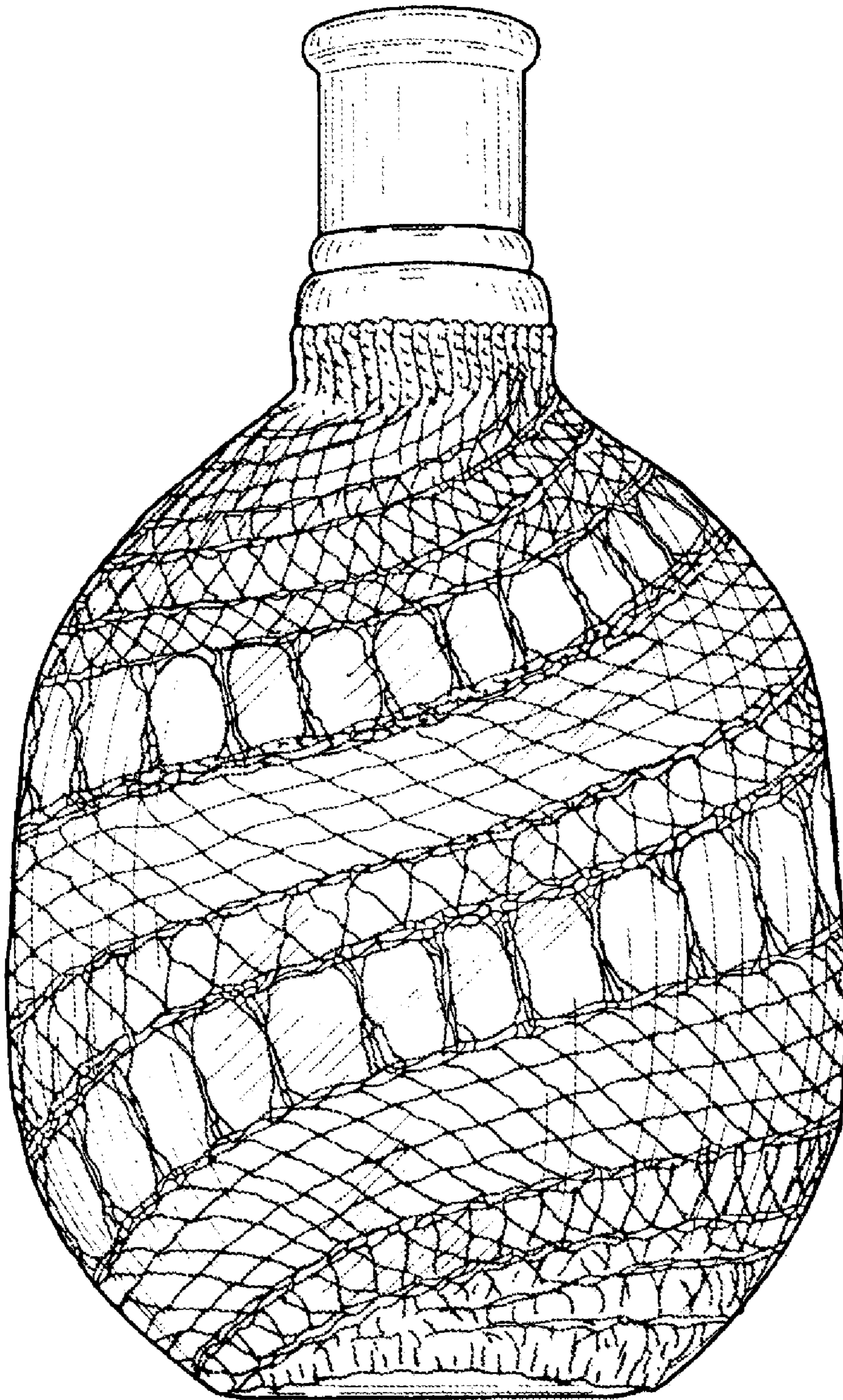

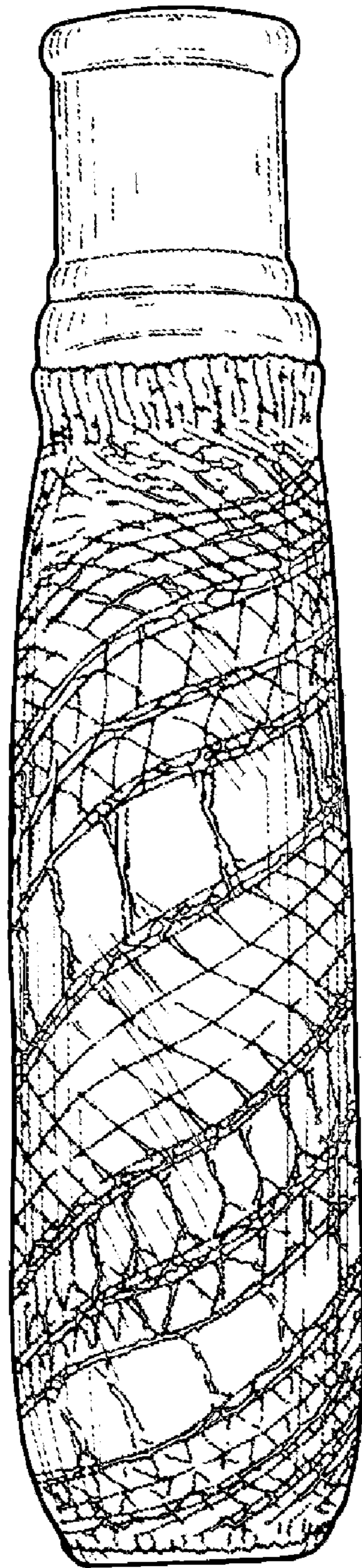

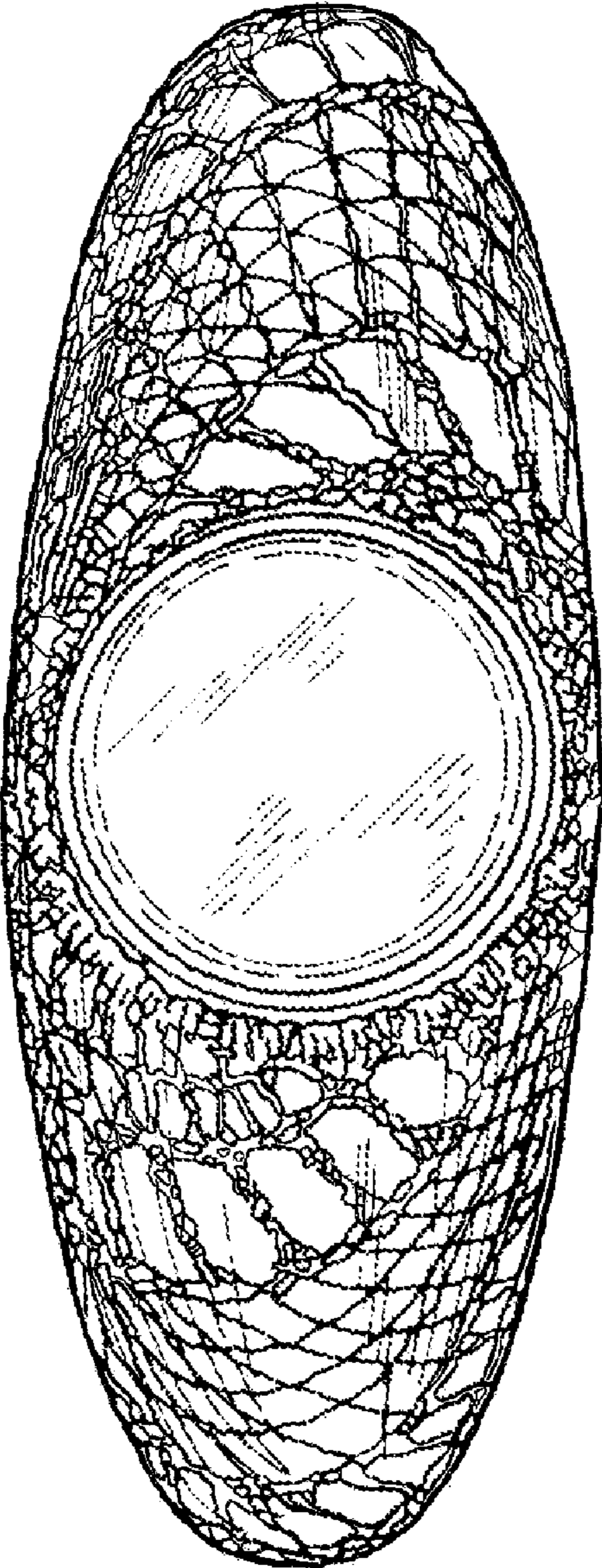

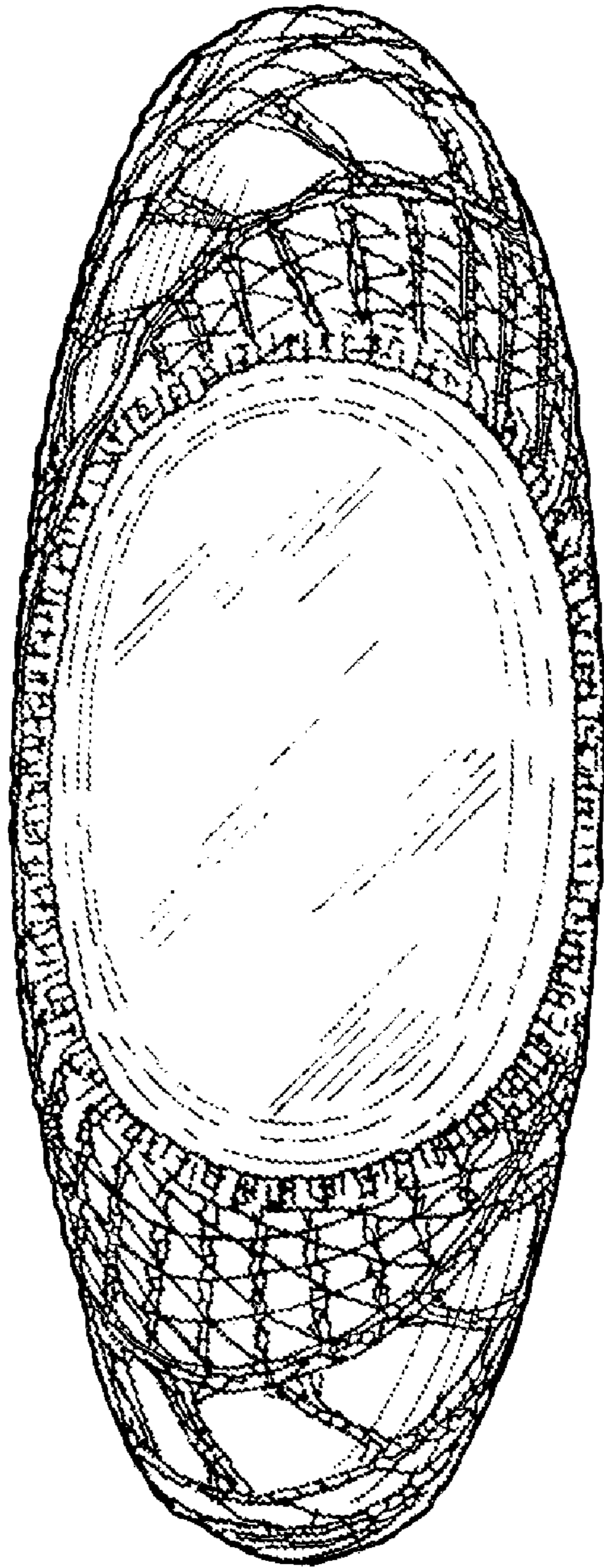
