**DESCRIPTION**

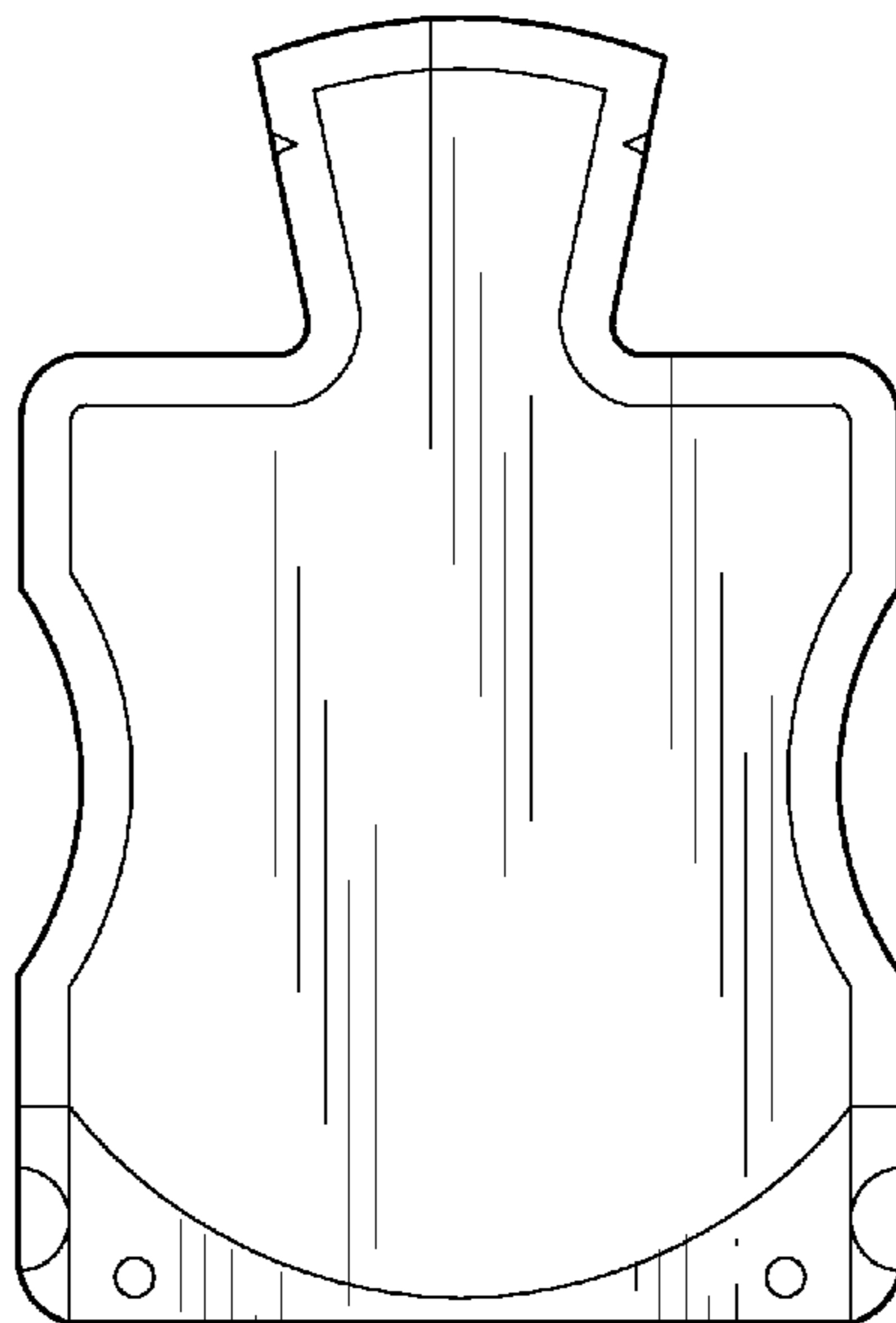
FIG. 1 is a front elevational view of a flexible pouch showing  
my new invention;

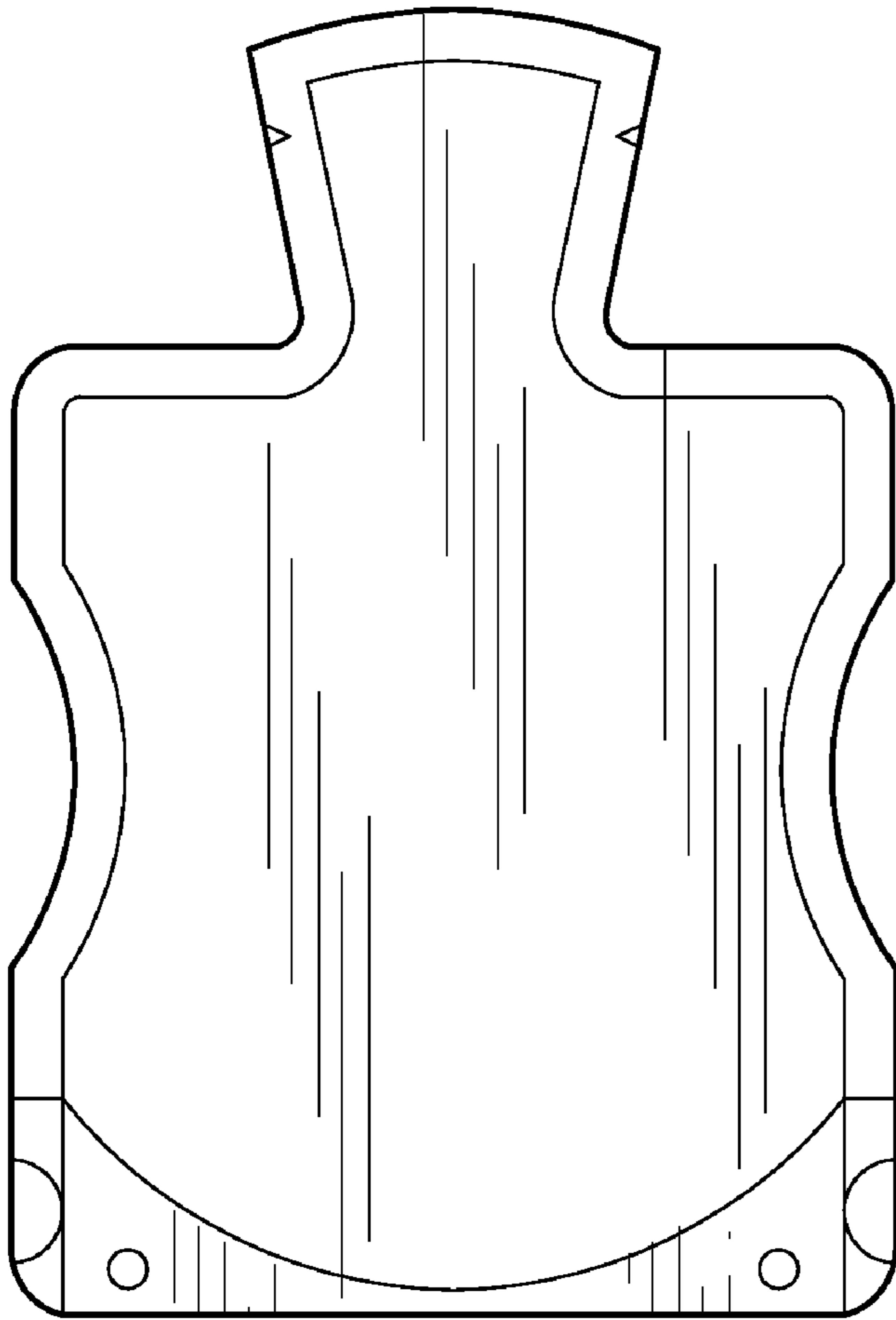
FIG. 2 is an a side elevational view thereof;

FIG. 3 is a back elevational view thereof; and,

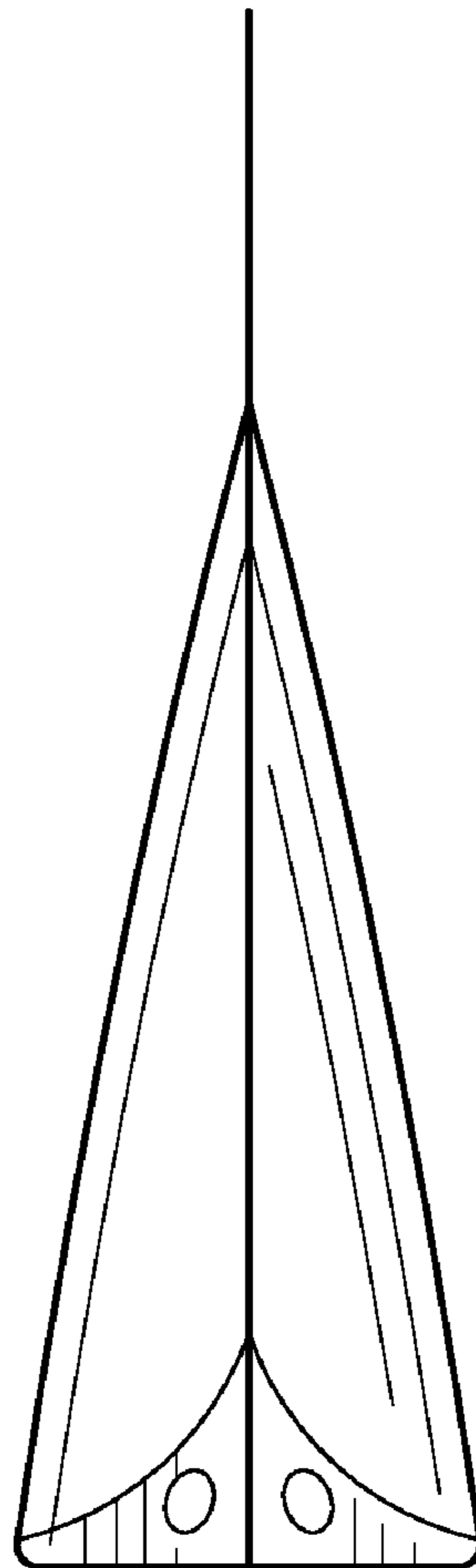
FIG. 4 is a bottom plan view thereof.

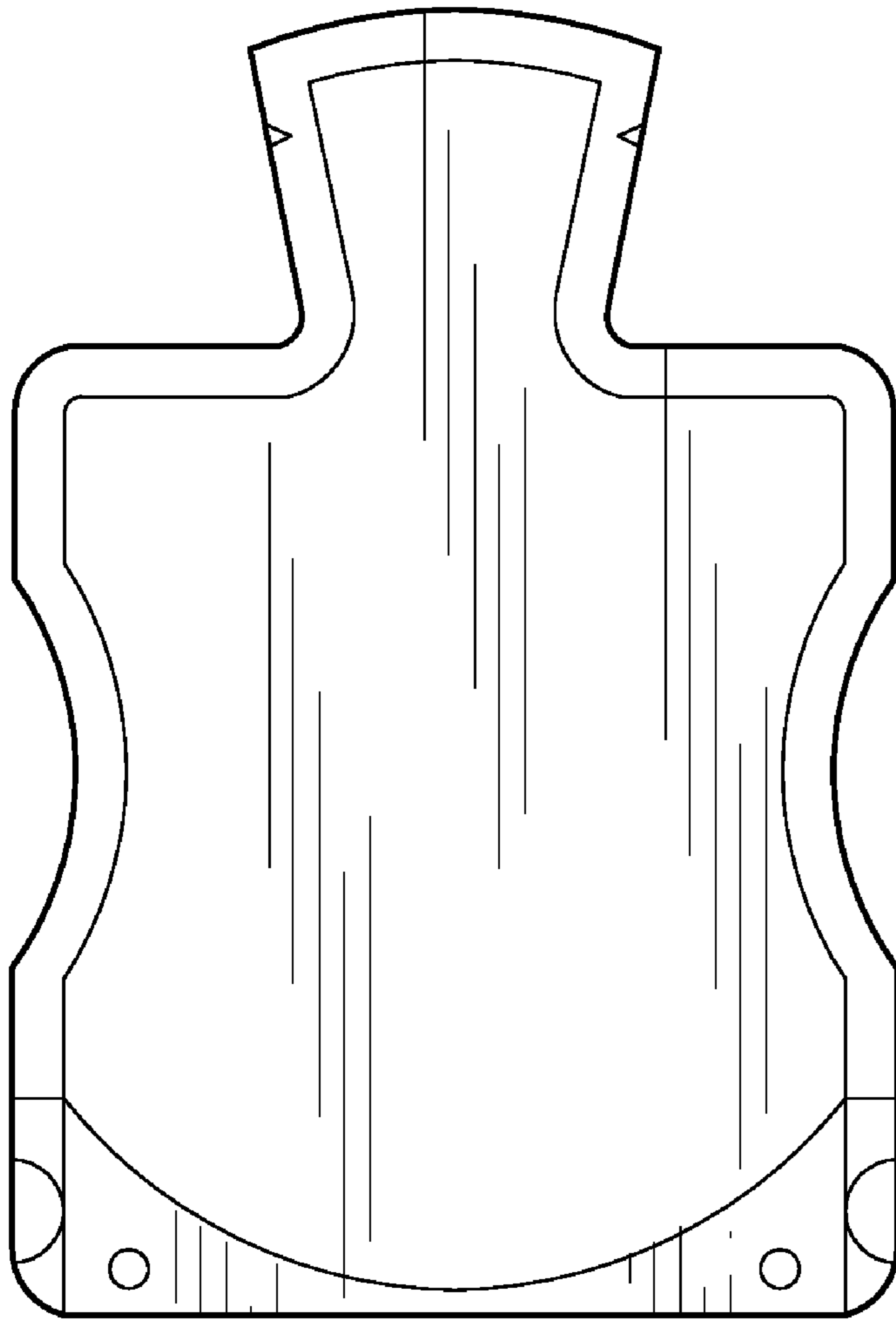
