(57) **CLAIM**

The ornamental design for an automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the automobile tire;

FIG. 2 is a rear view of the automobile tire;

FIG. 3 is a left-side view of the automobile tire;

FIG. 4 is a top view of the automobile tire;

FIG. 5 is a perspective view of the automobile tire;

FIG. 6 is an enlarged view of part between two lines X1-X2 in FIG. 1; and,

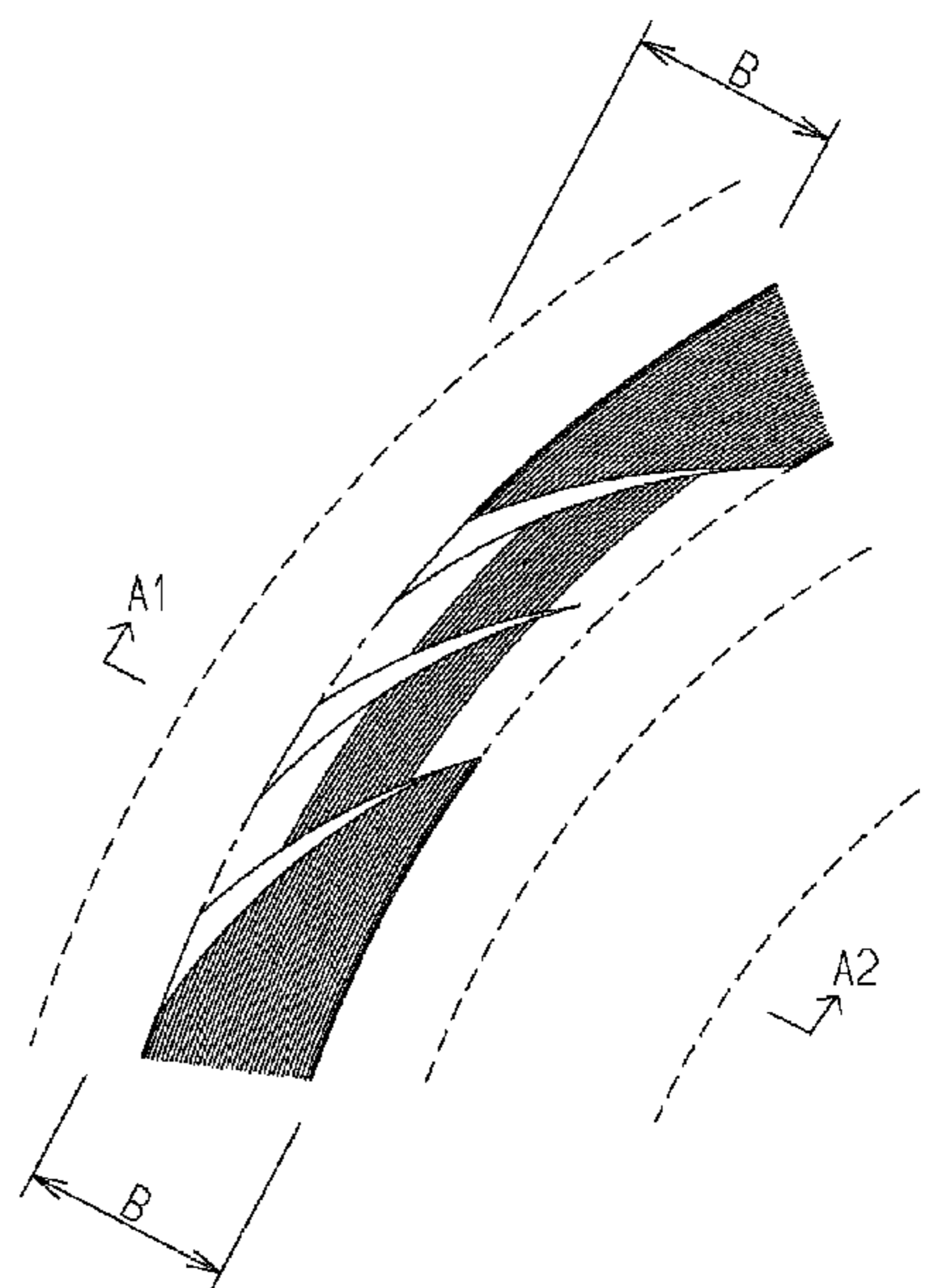
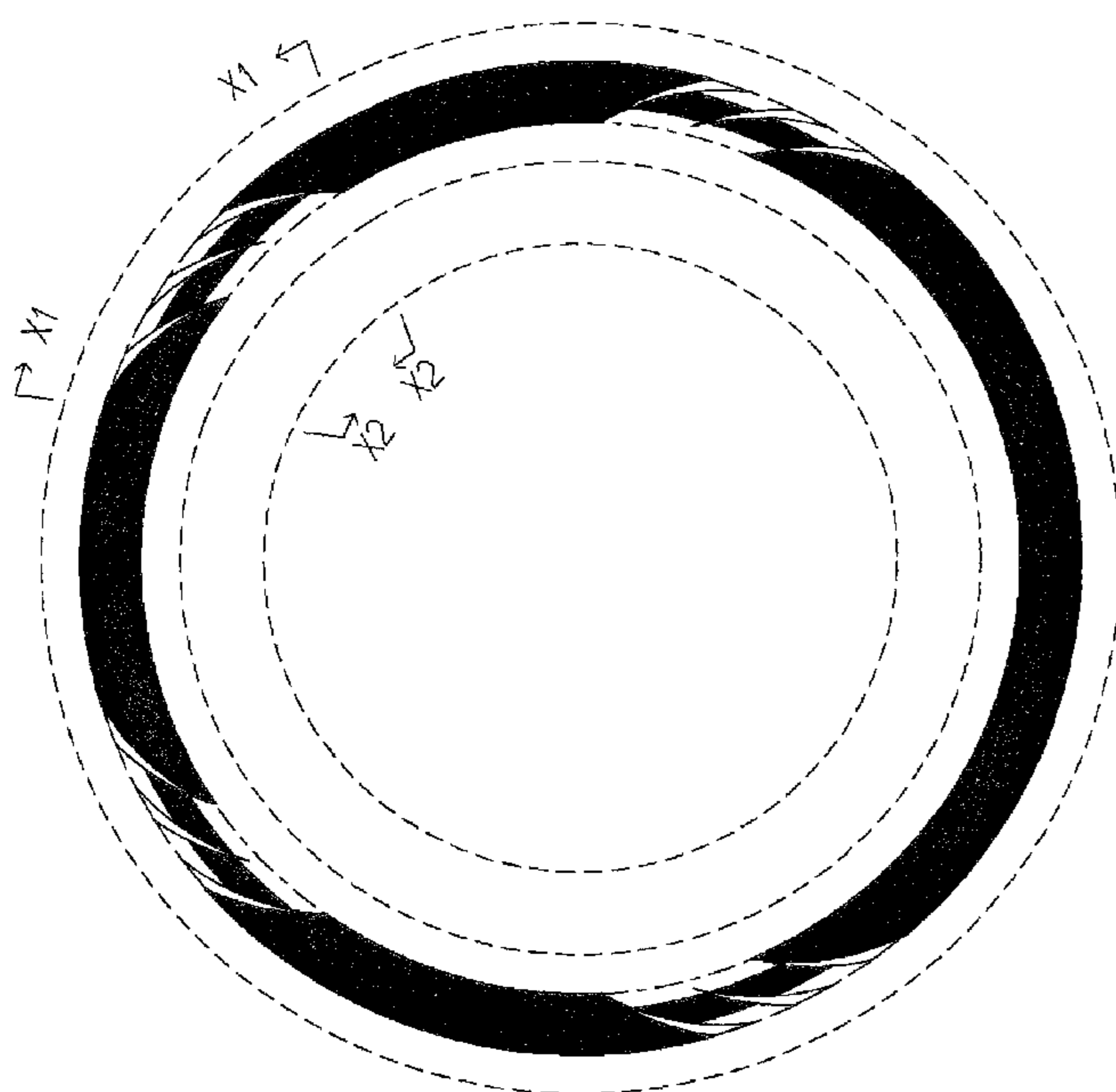
FIG. 7 is an enlarged cross-section view taken along the line A1-A2 of part B in FIG. 6.

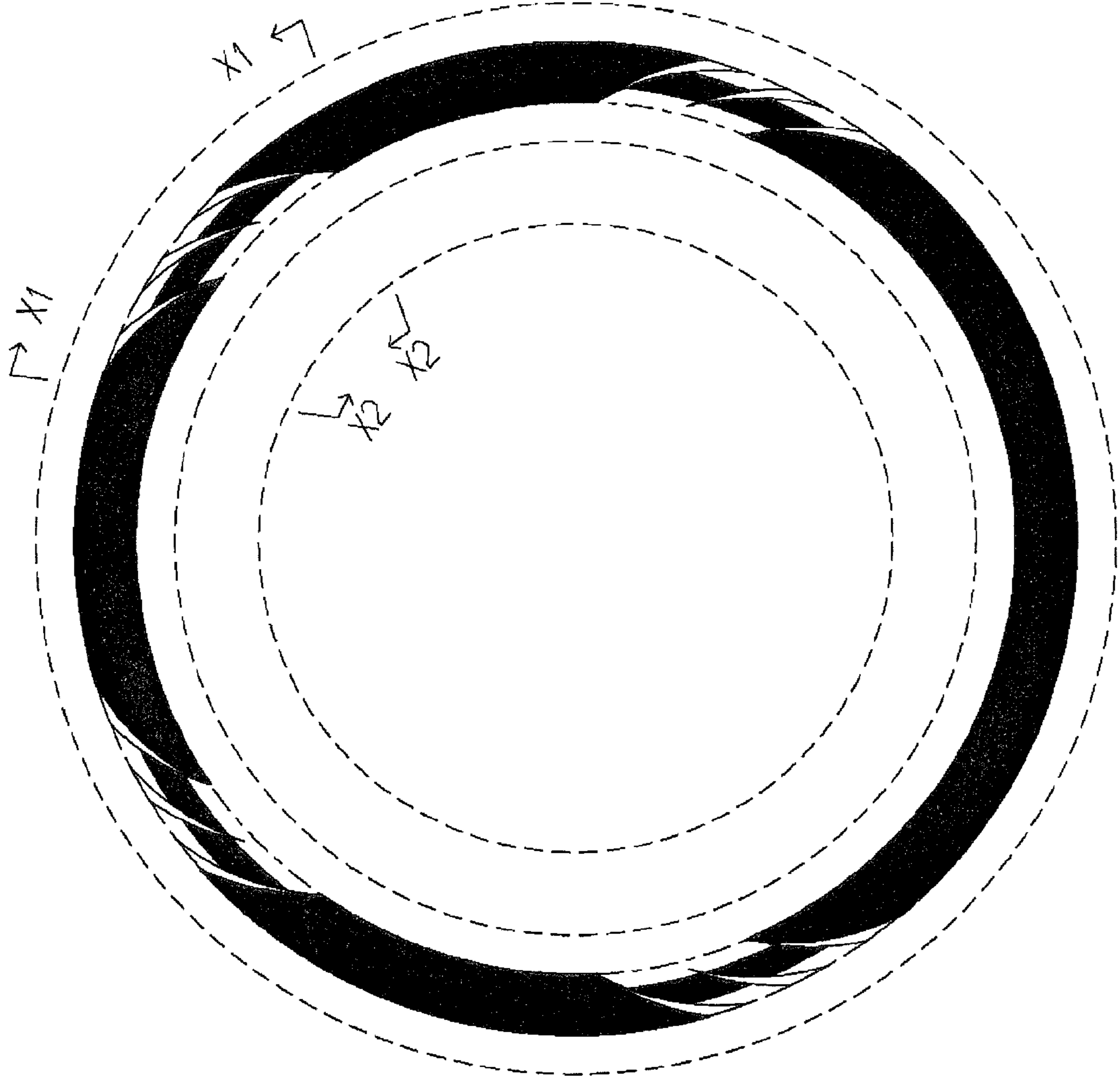

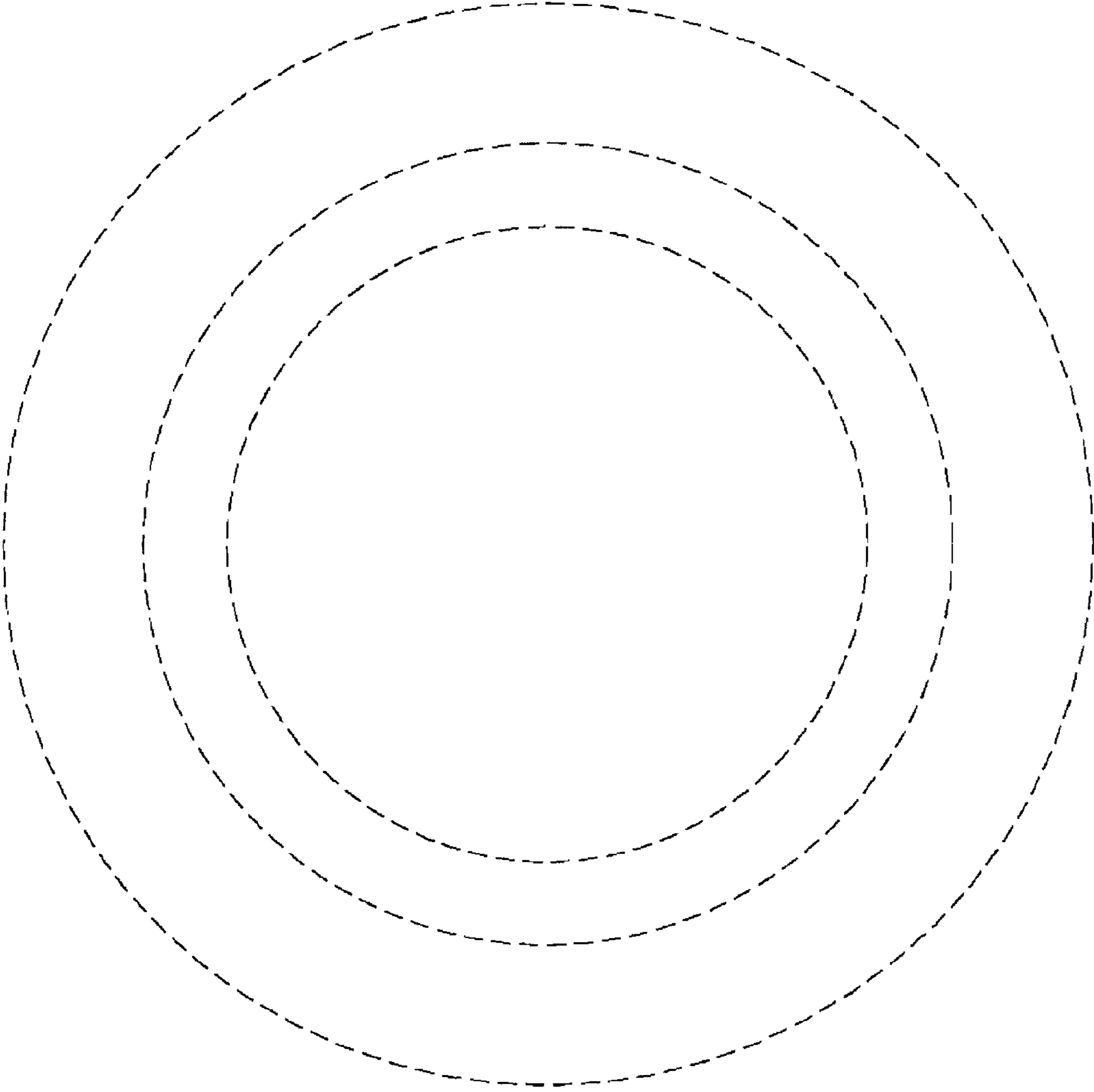

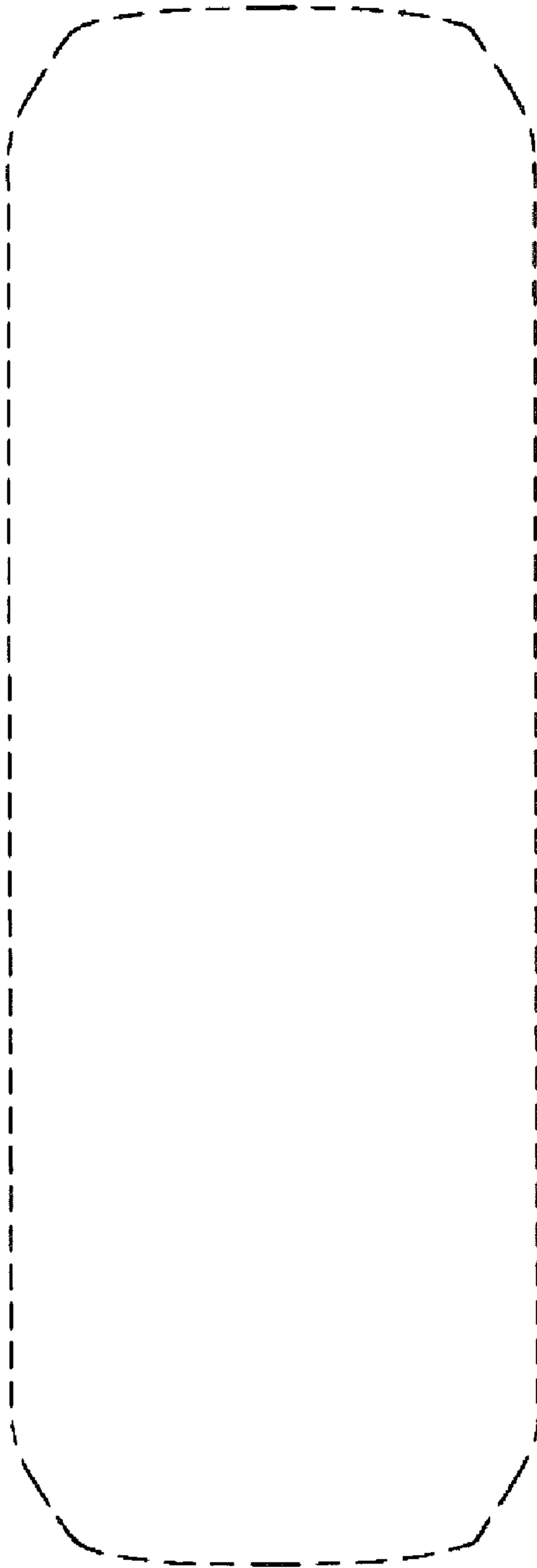

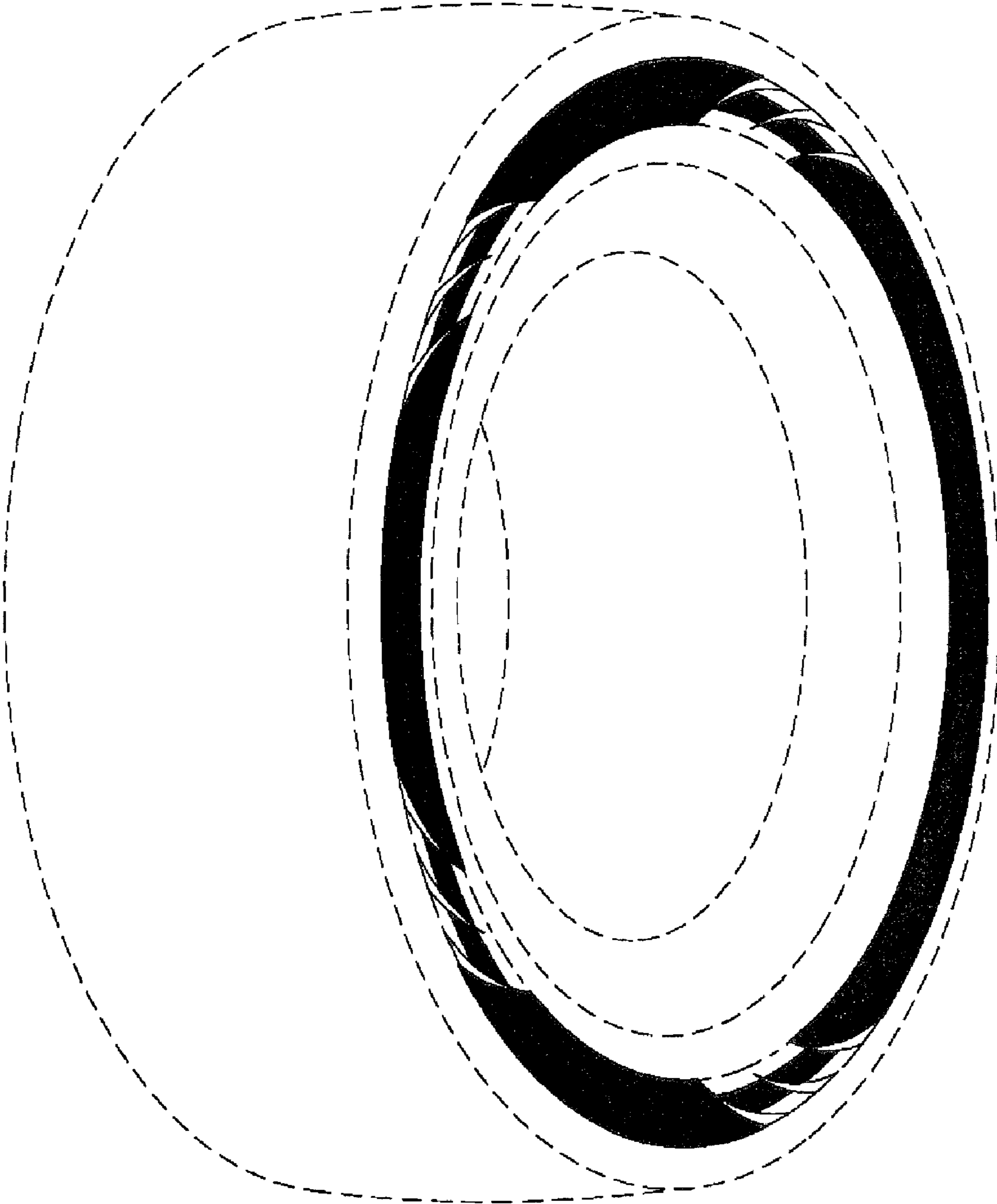

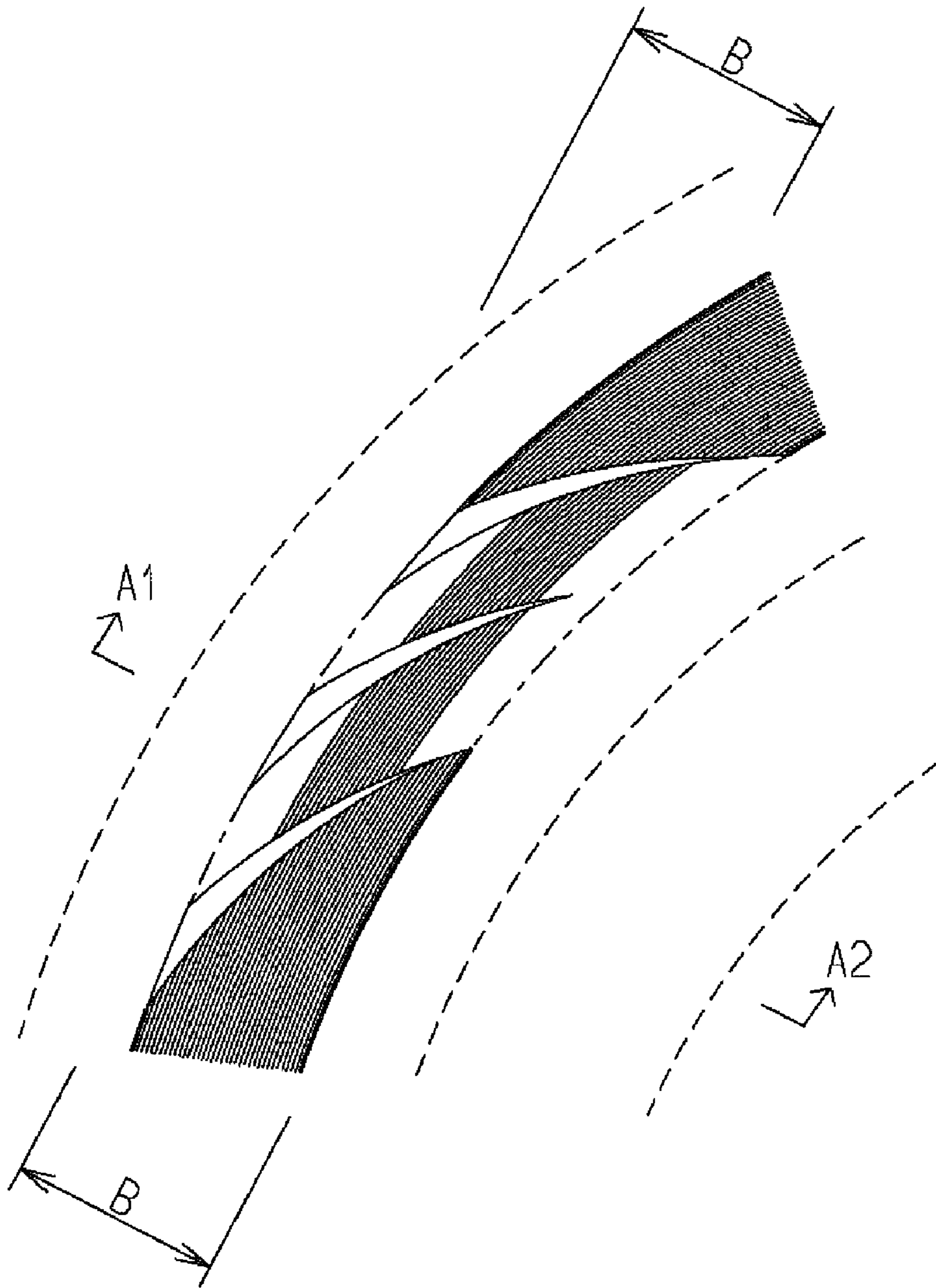

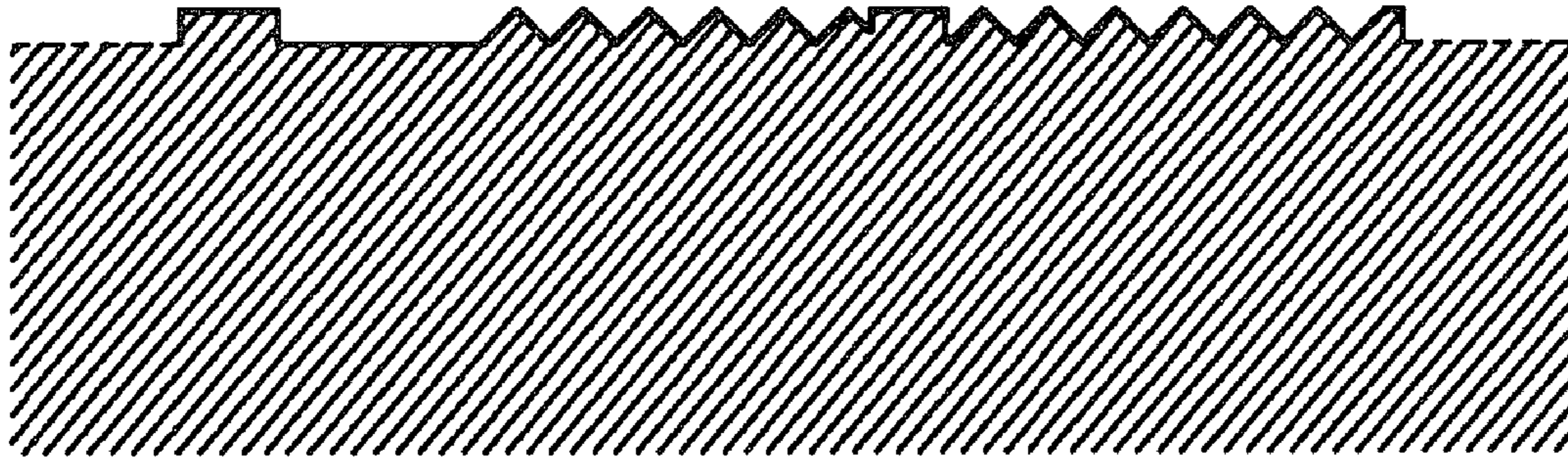
