DESCRIPTION

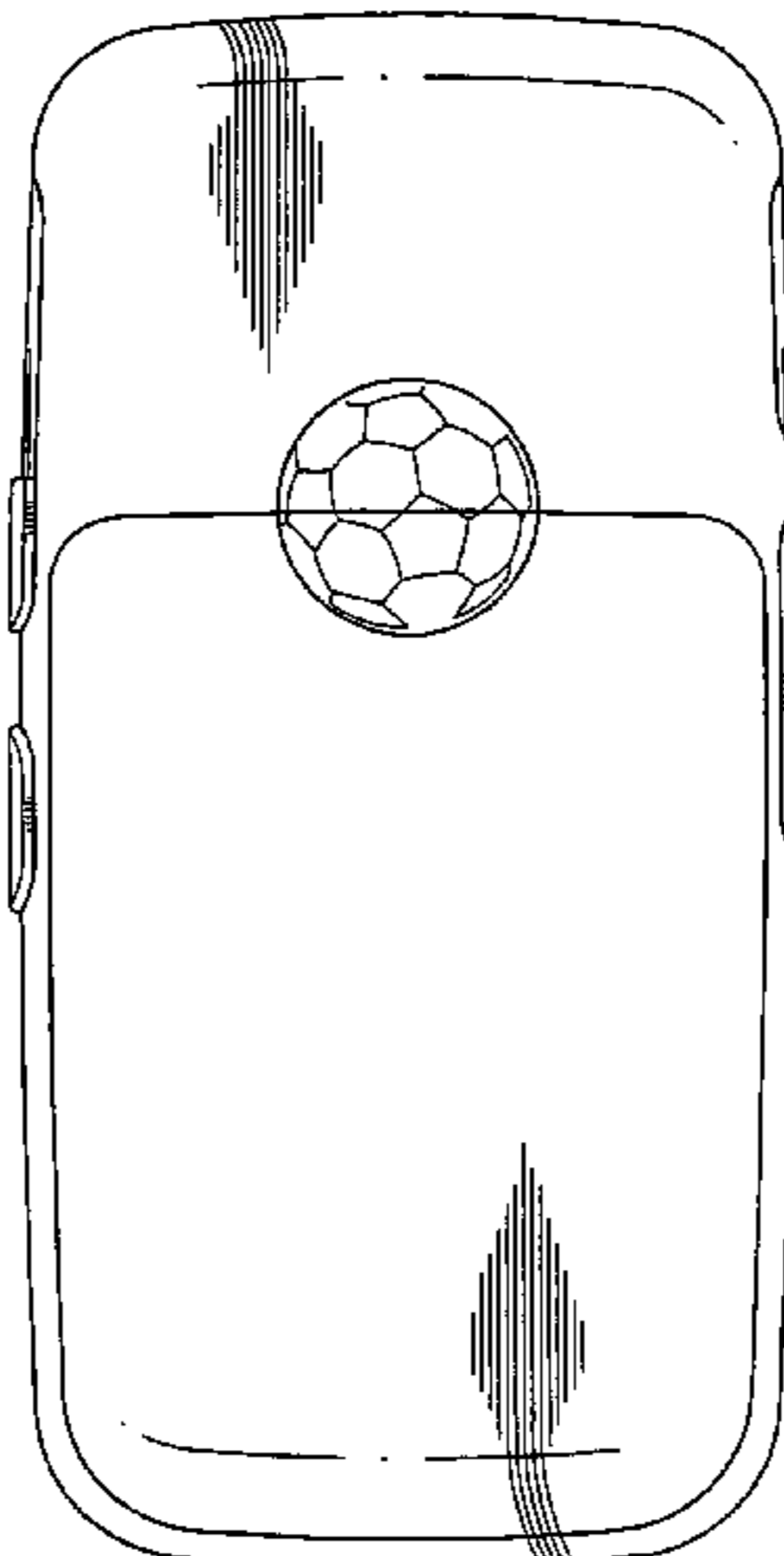
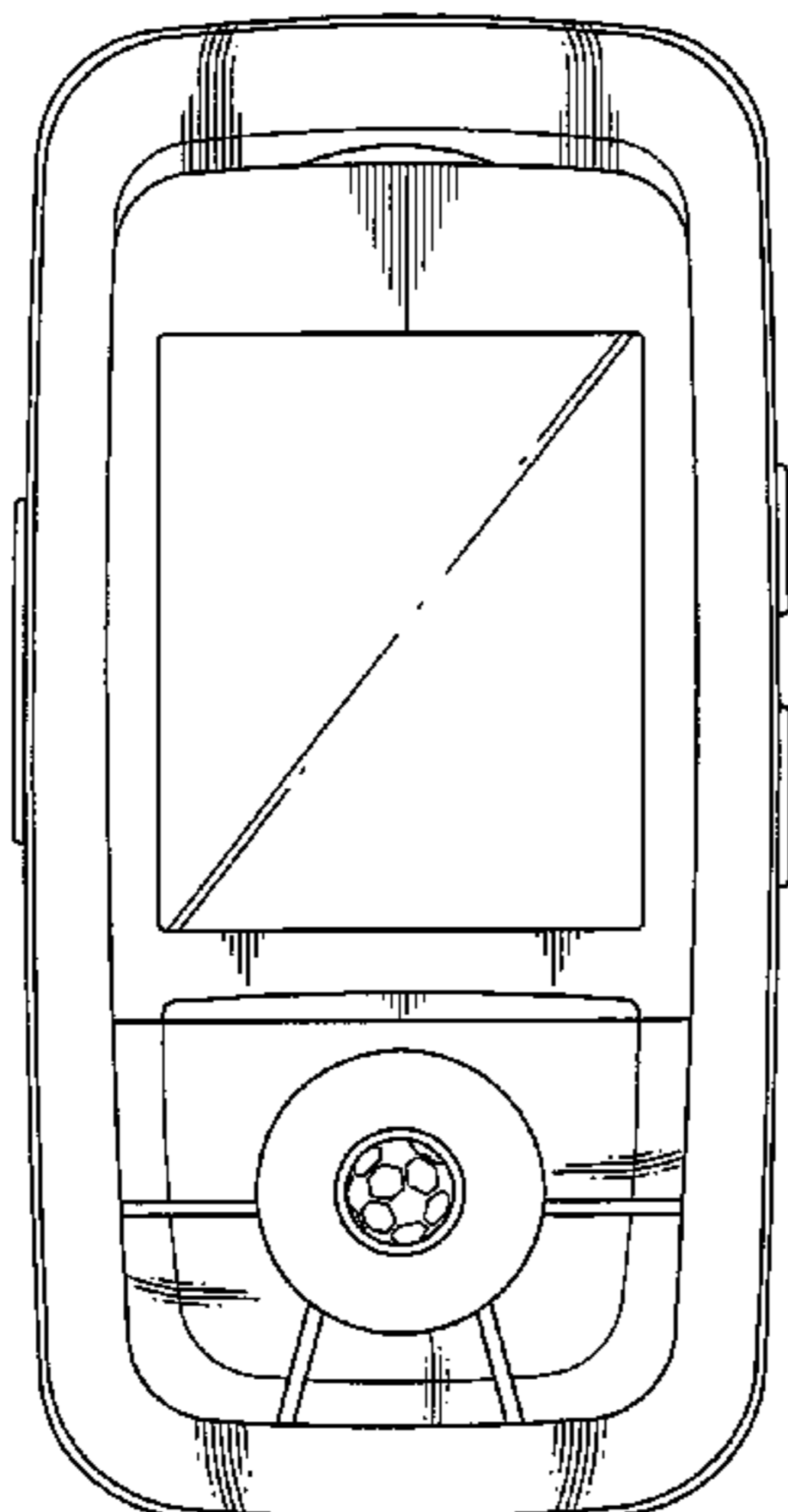

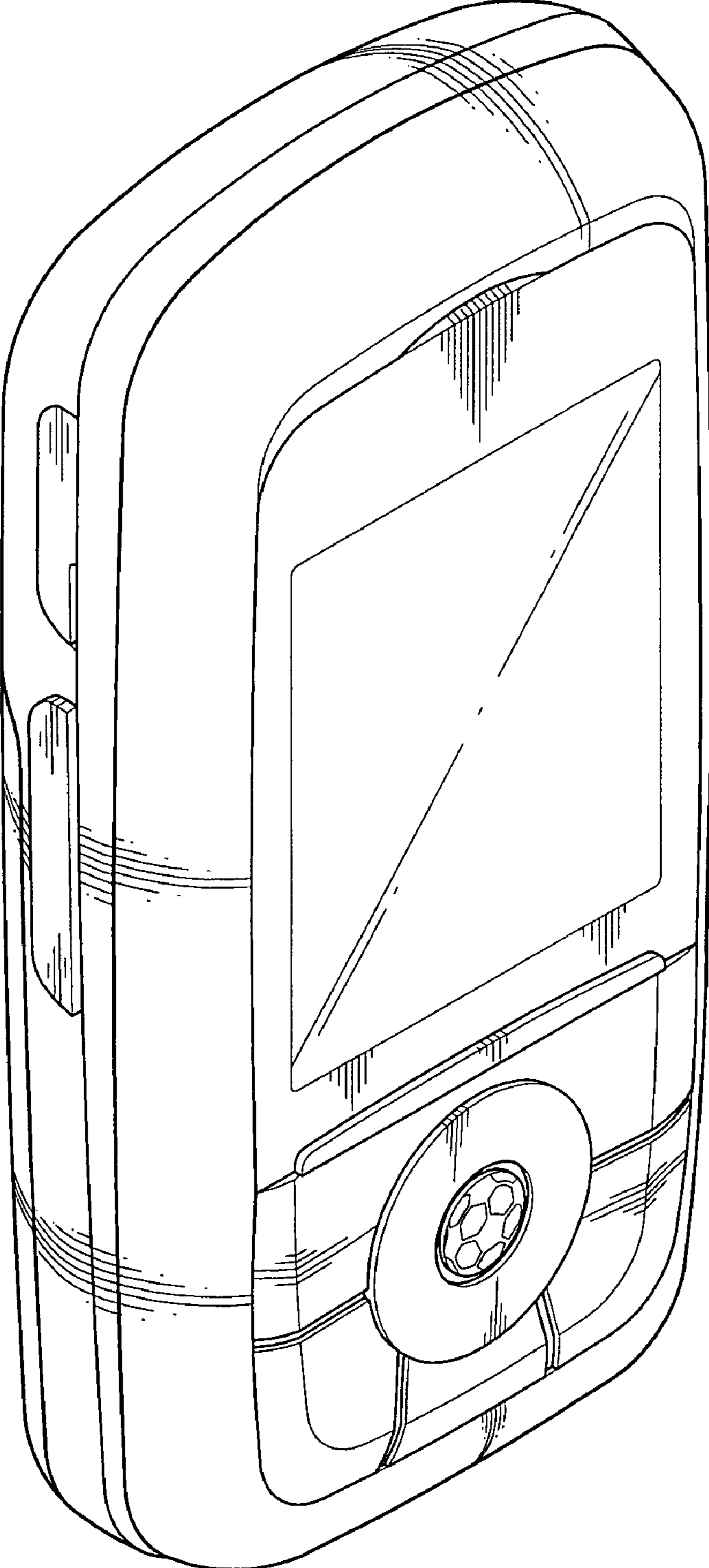

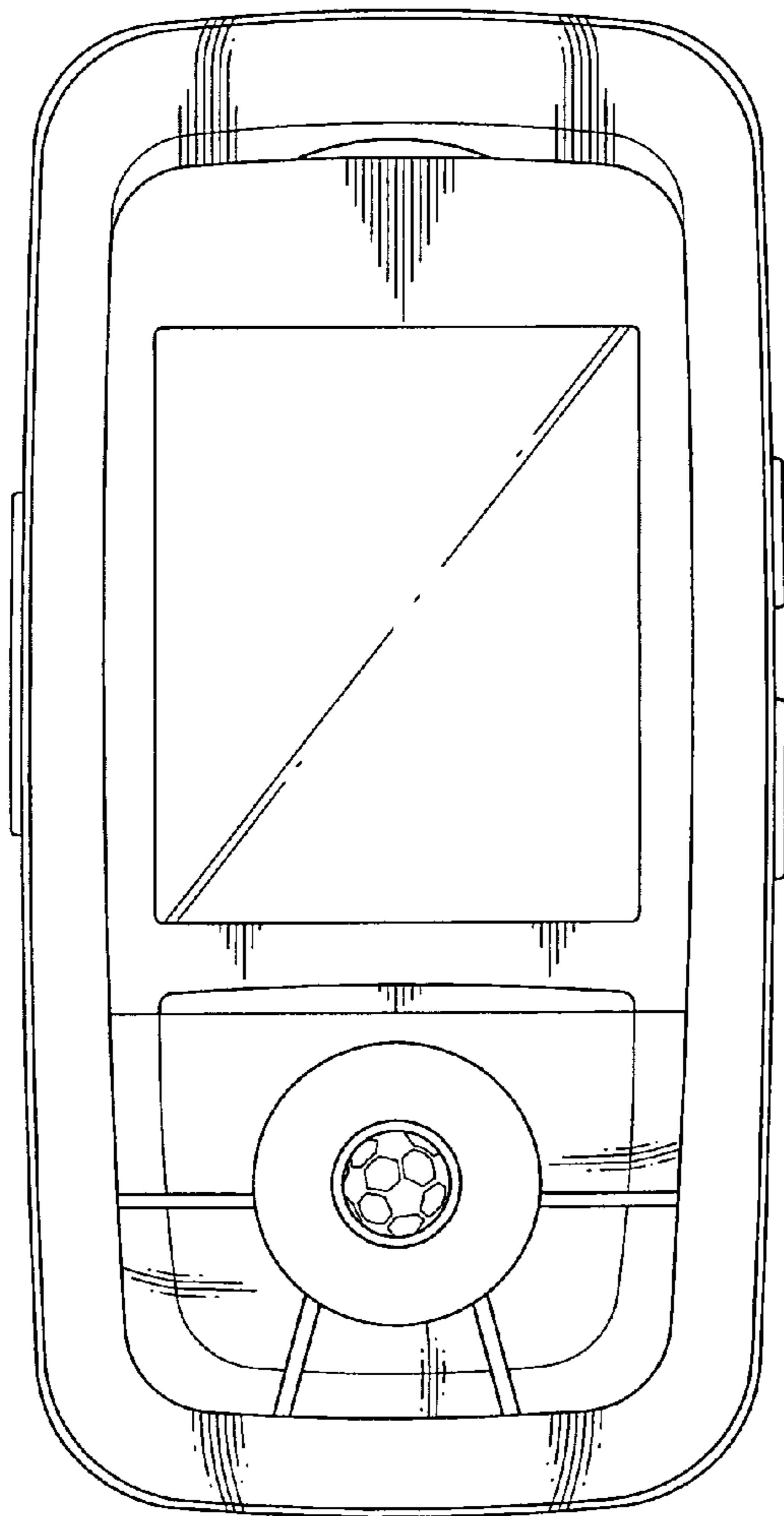

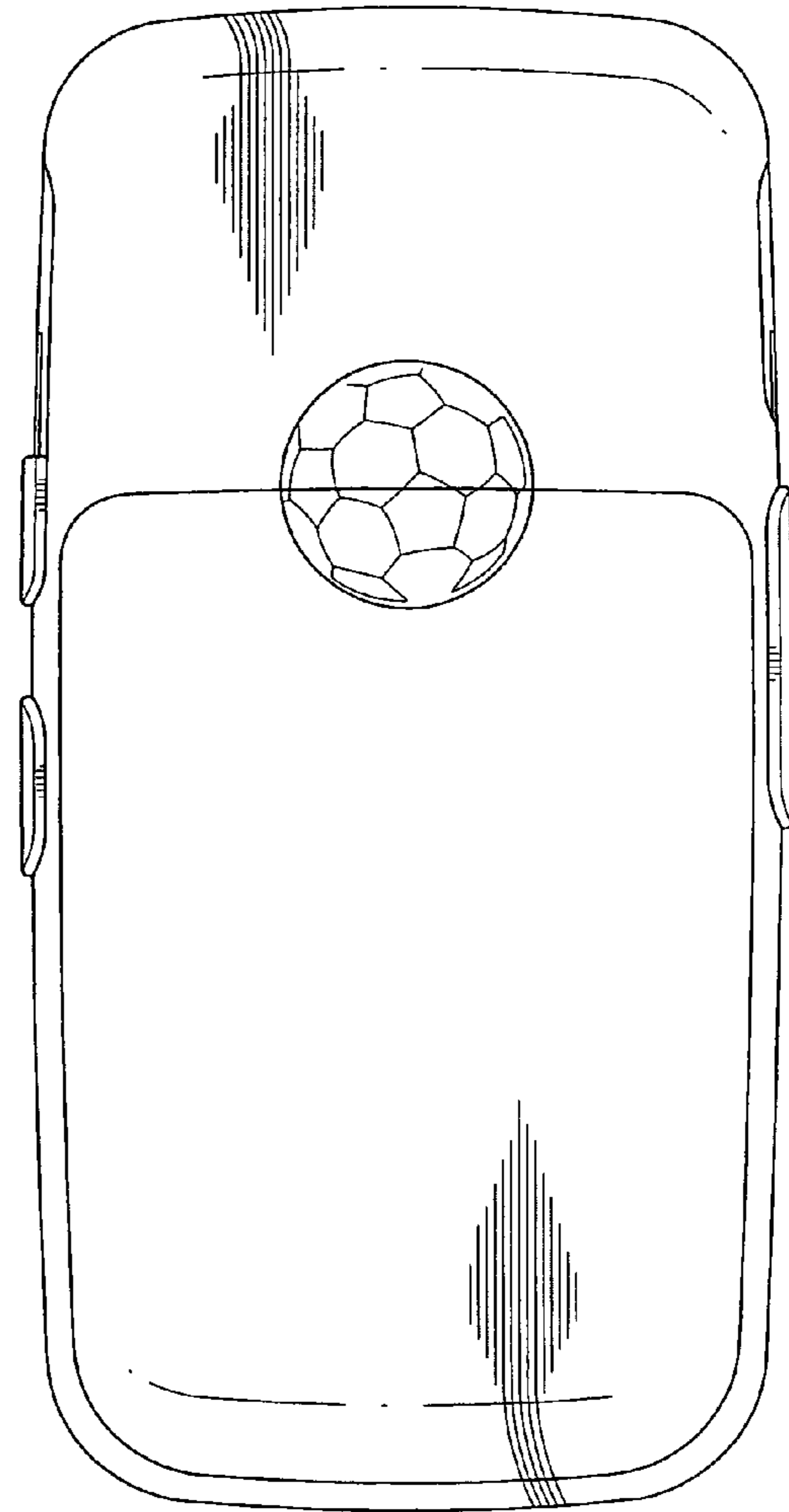

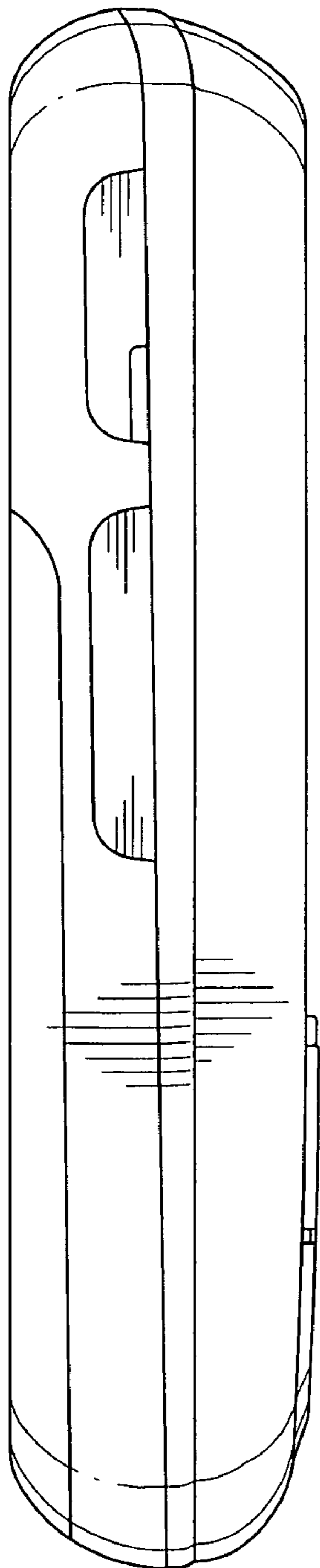

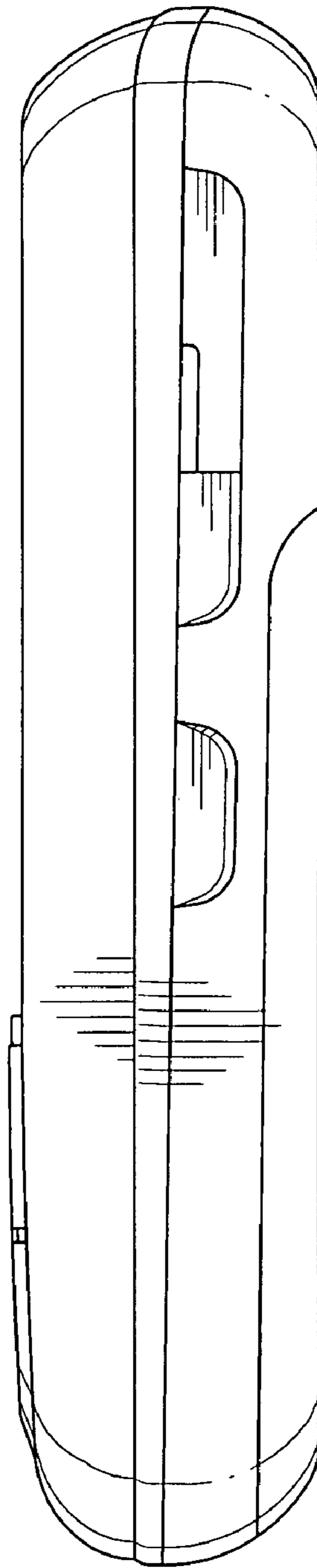

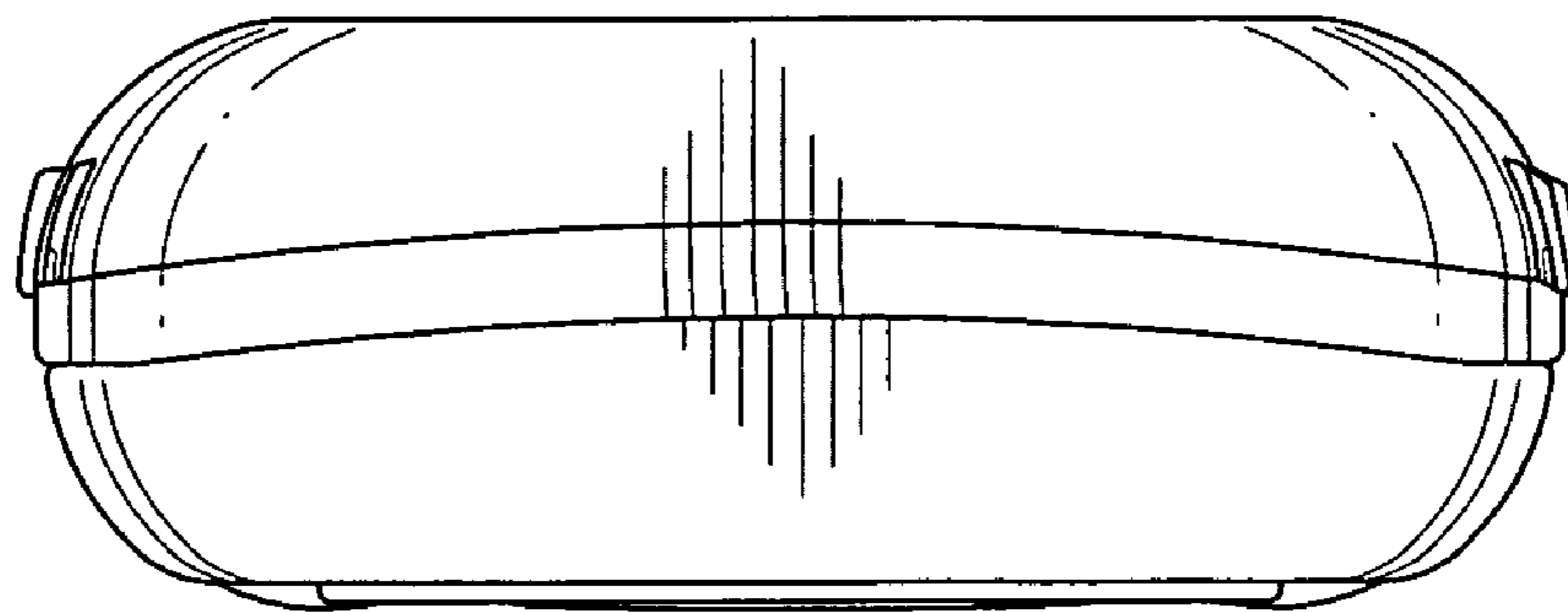

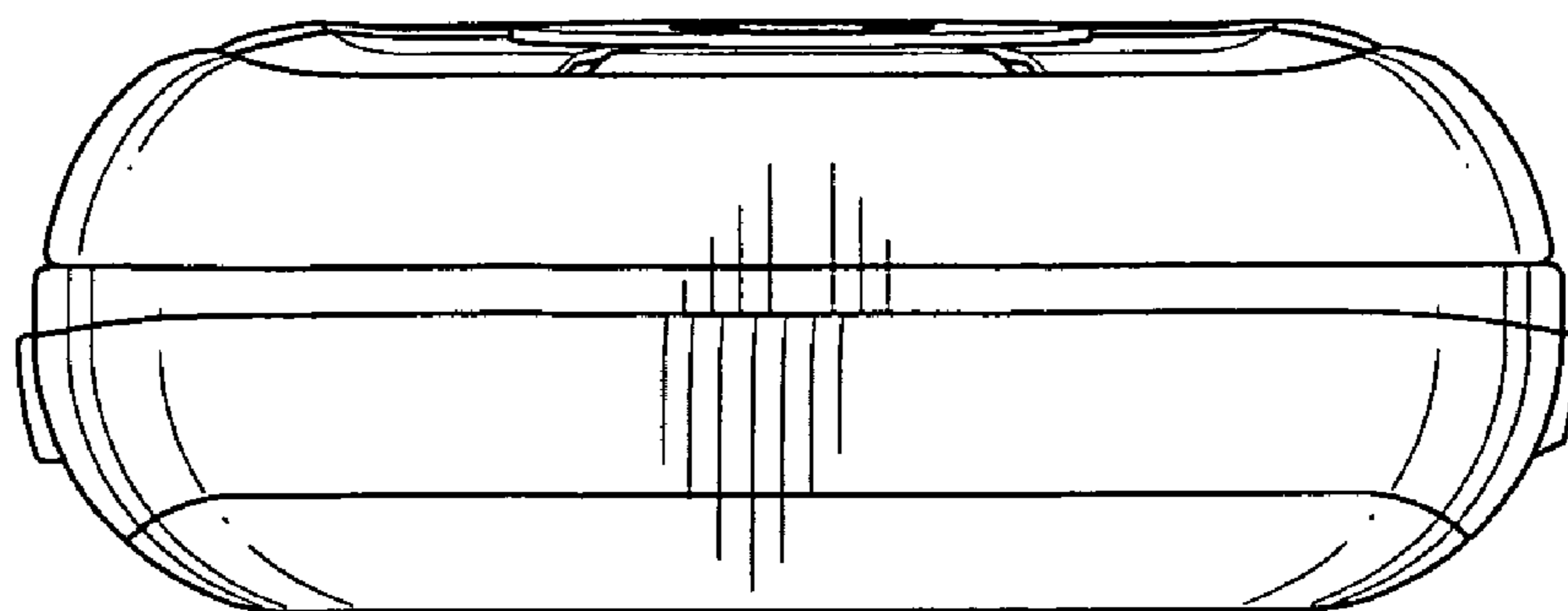
