**DESCRIPTION**

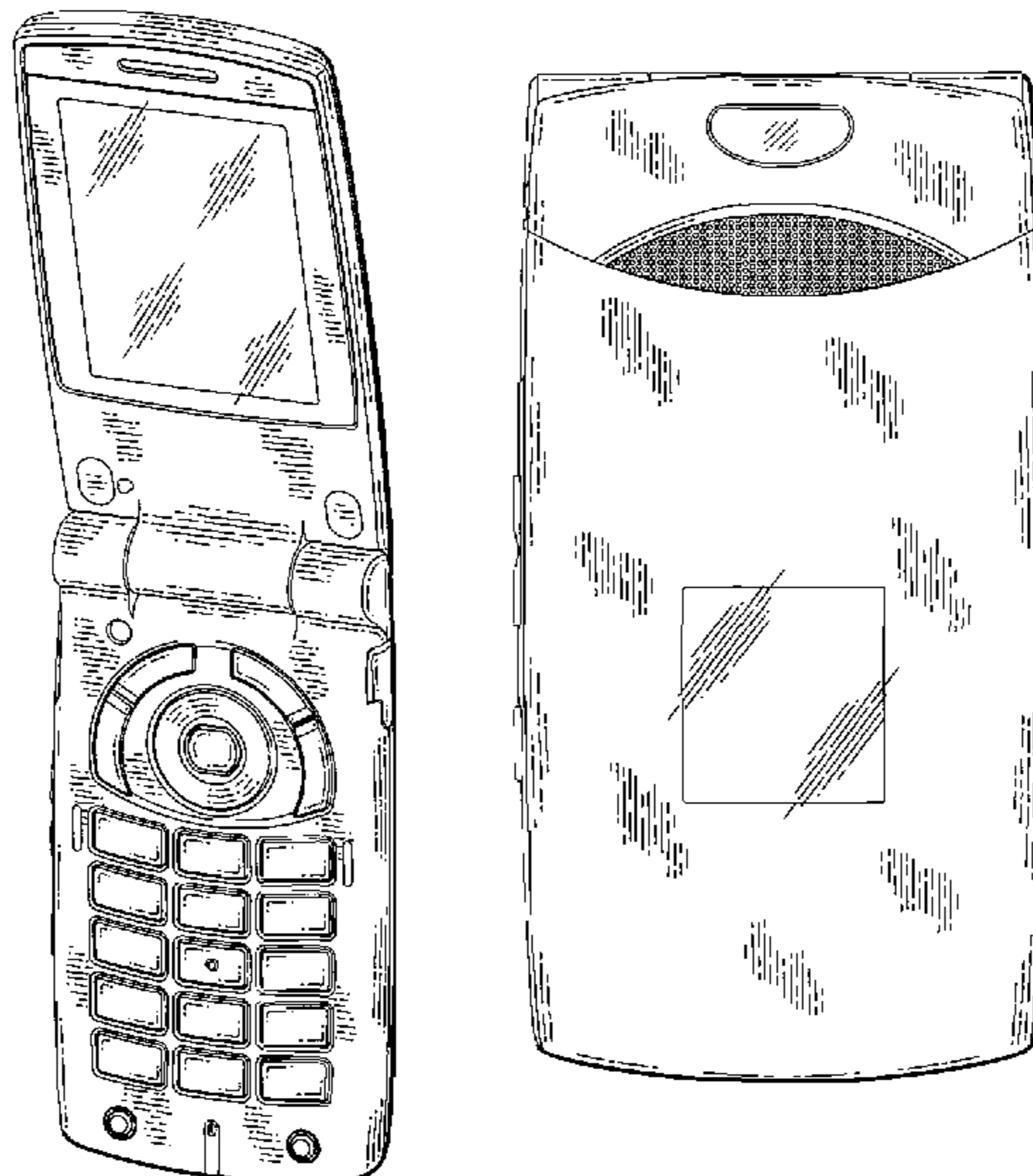

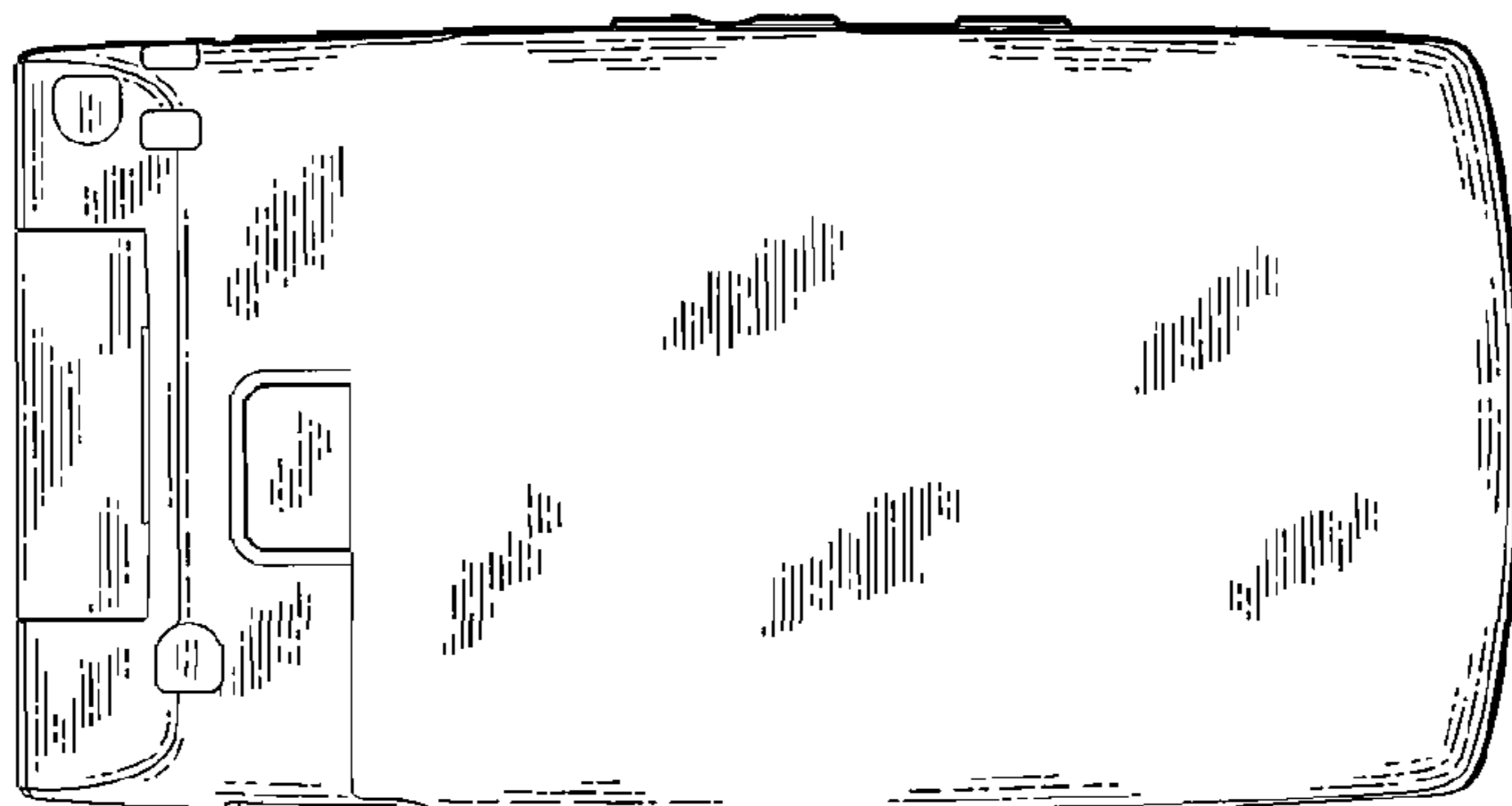

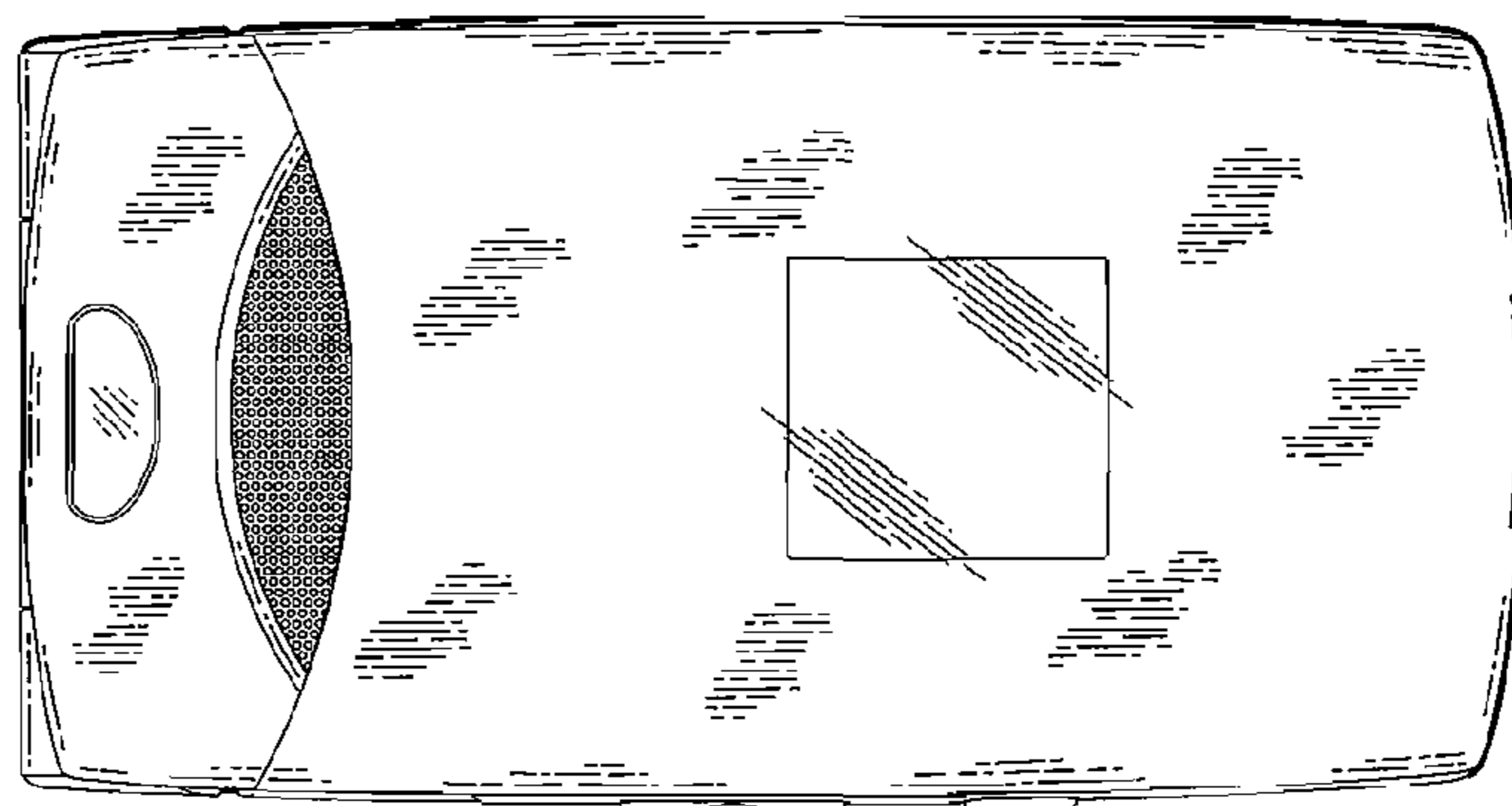

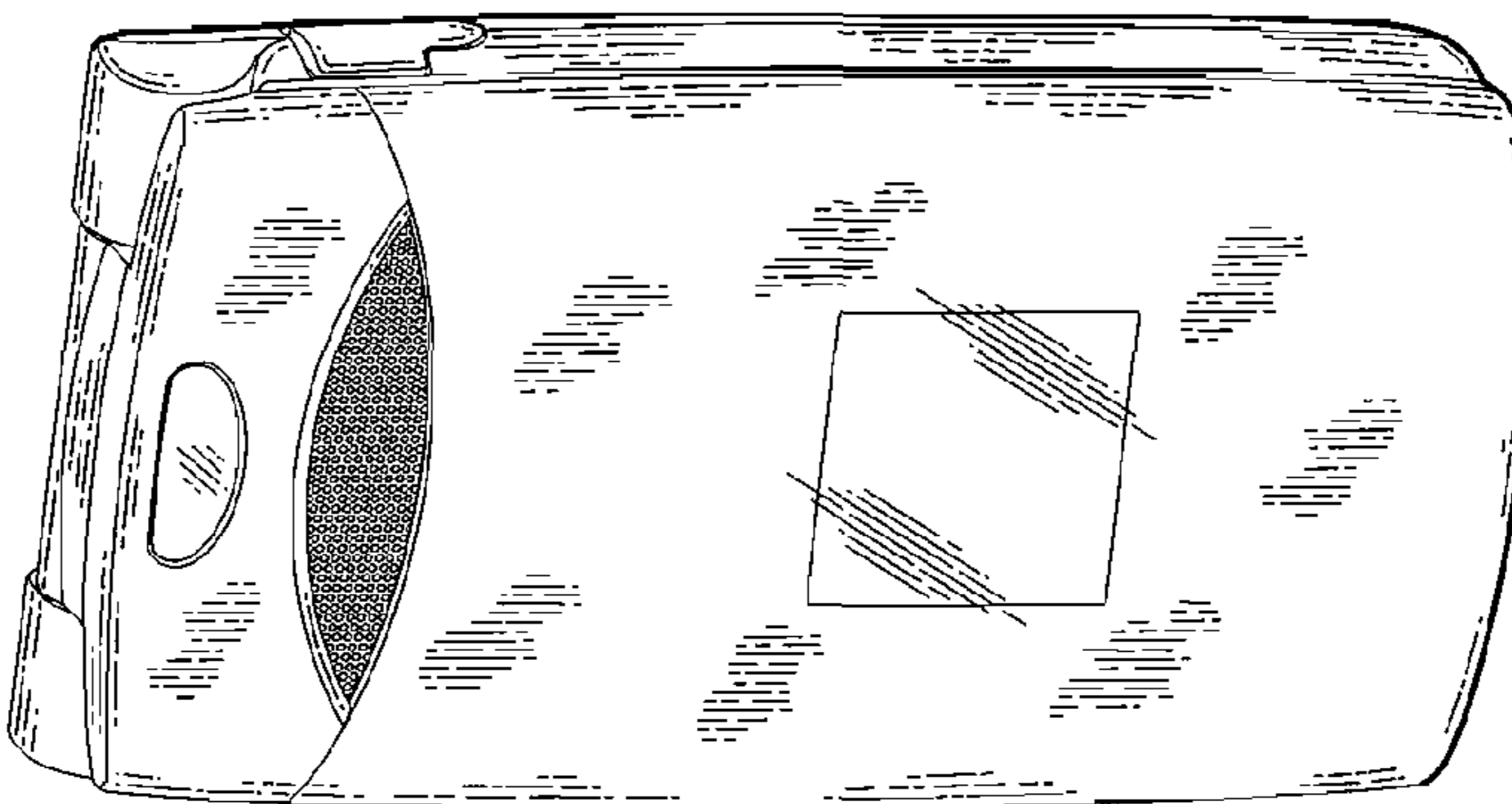

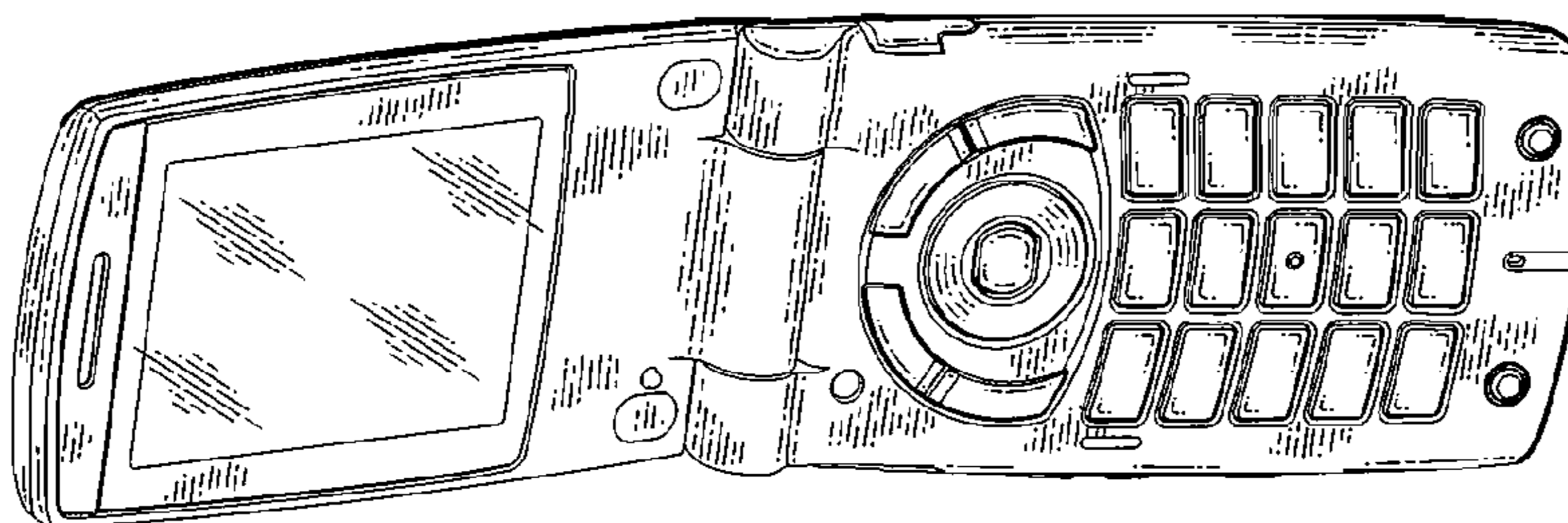

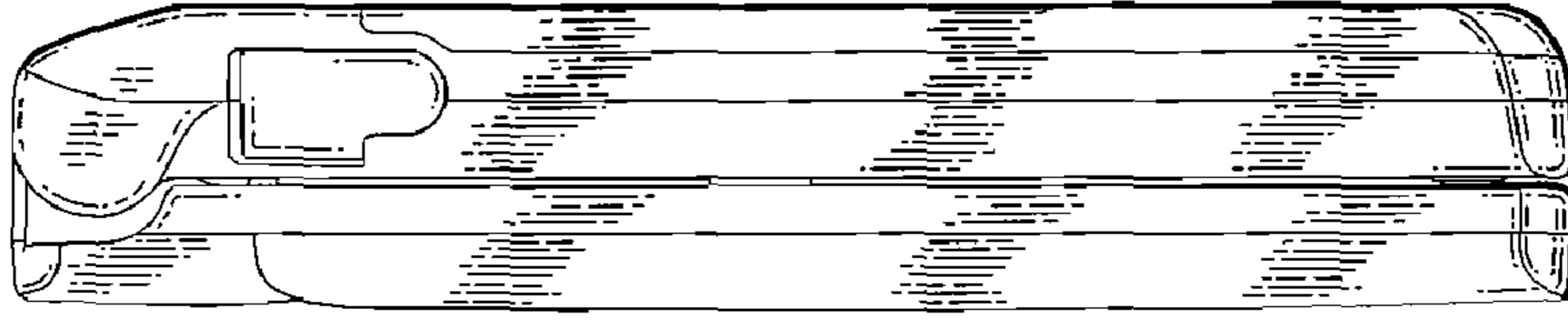

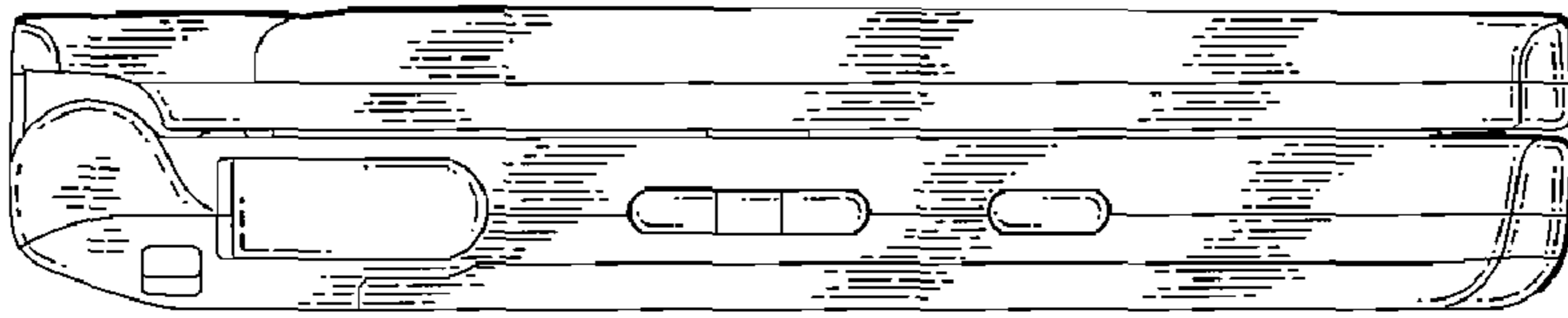

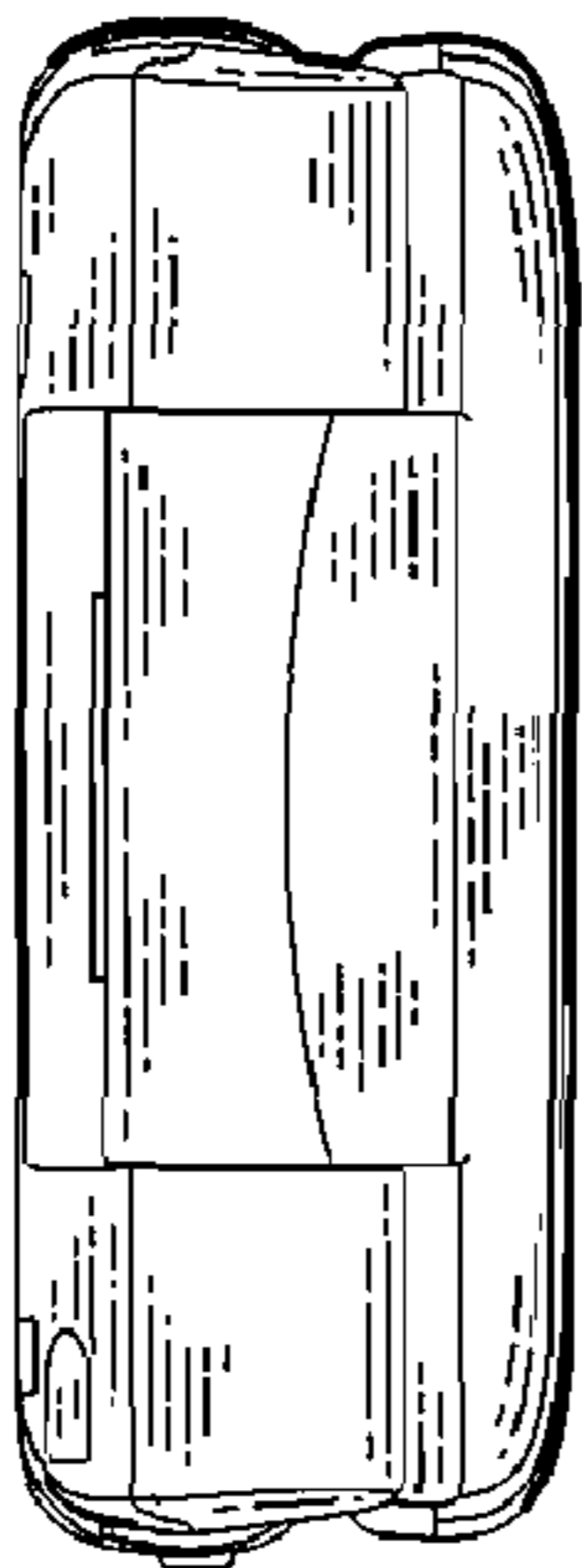
