(57) **CLAIM**

The ornamental design for a game controller unit for an exercise system, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a game controller unit for an exercise system, embodying my new design, with the right-hand controller shown separately for ease of illustration.

FIG. 2 is a front view thereof;

FIG. 3 is a side view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 an enlarged view of the top front portion thereof;

FIG. 6 is a perspective view of a game controller unit for an exercise system, embodying my new design, with the left-hand controller shown separately for ease of illustration;

FIG. 7 is a front view thereof;

FIG. 8 is a side view thereof;

FIG. 9 a rear view thereof;

FIG. 10 an enlarged view of the top front portion thereof; and,

FIG. 11 is a perspective view of a game controller unit for an exercise system with both the left and right-hand controllers shown mounted on an exercise bar.

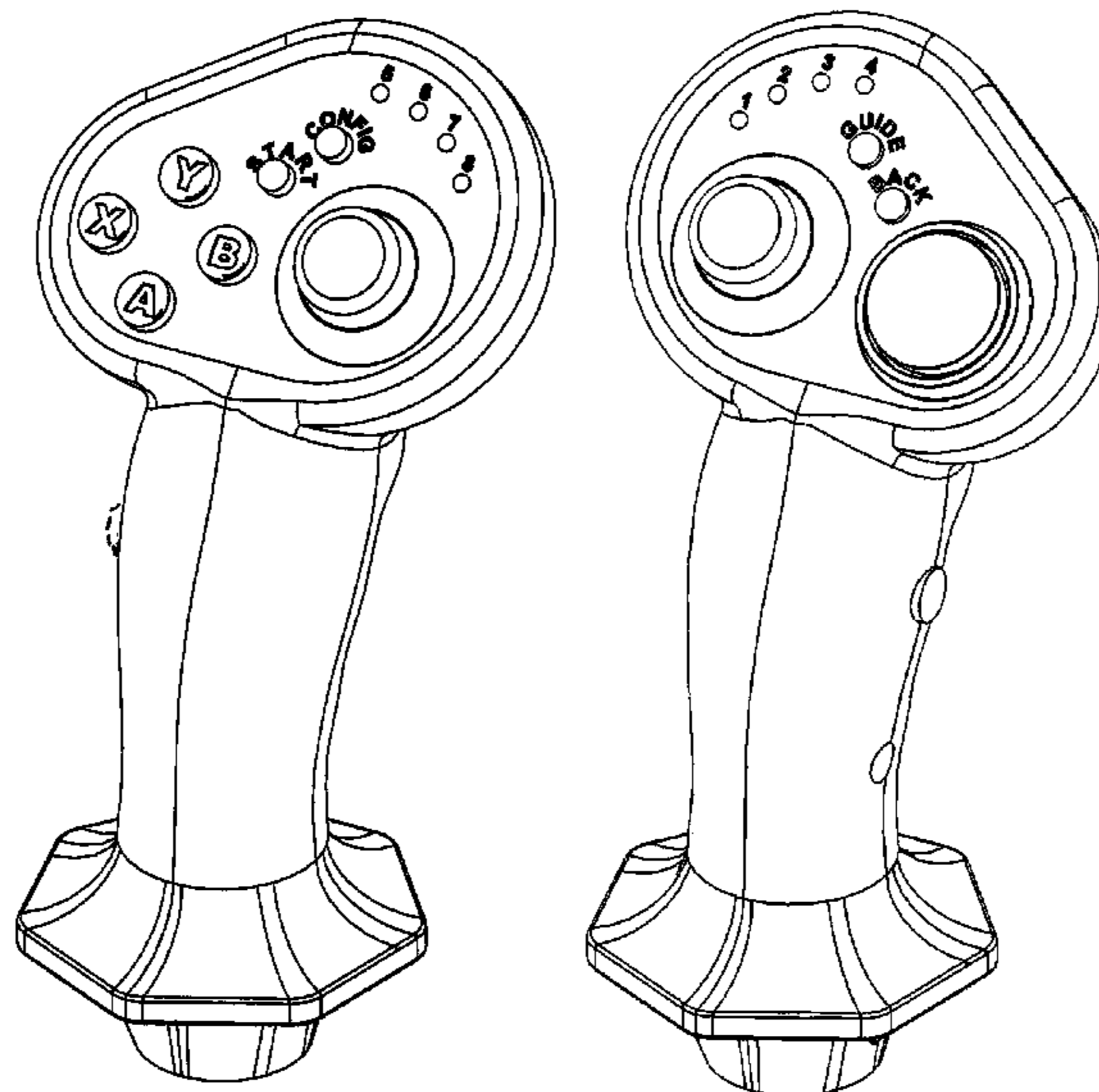

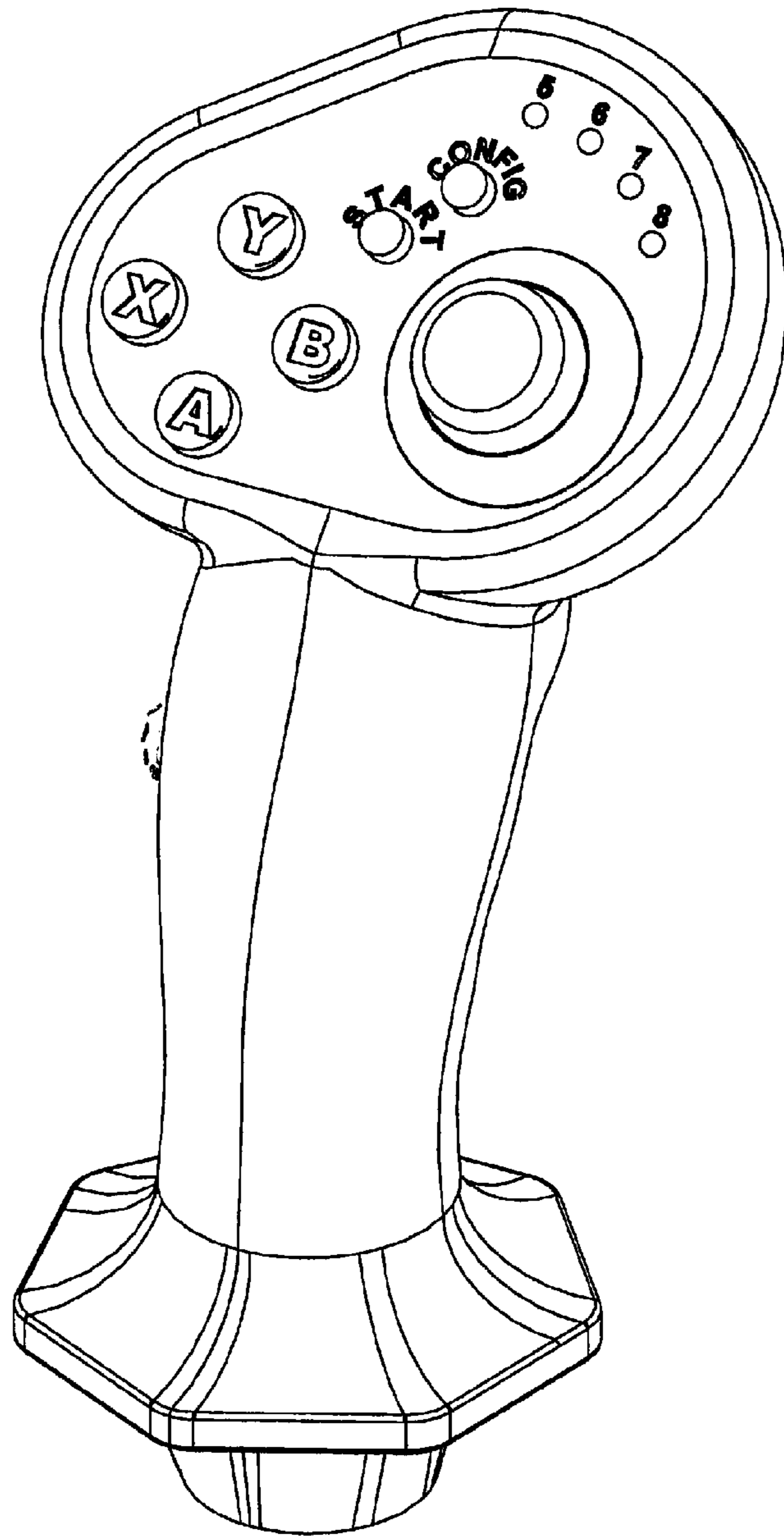

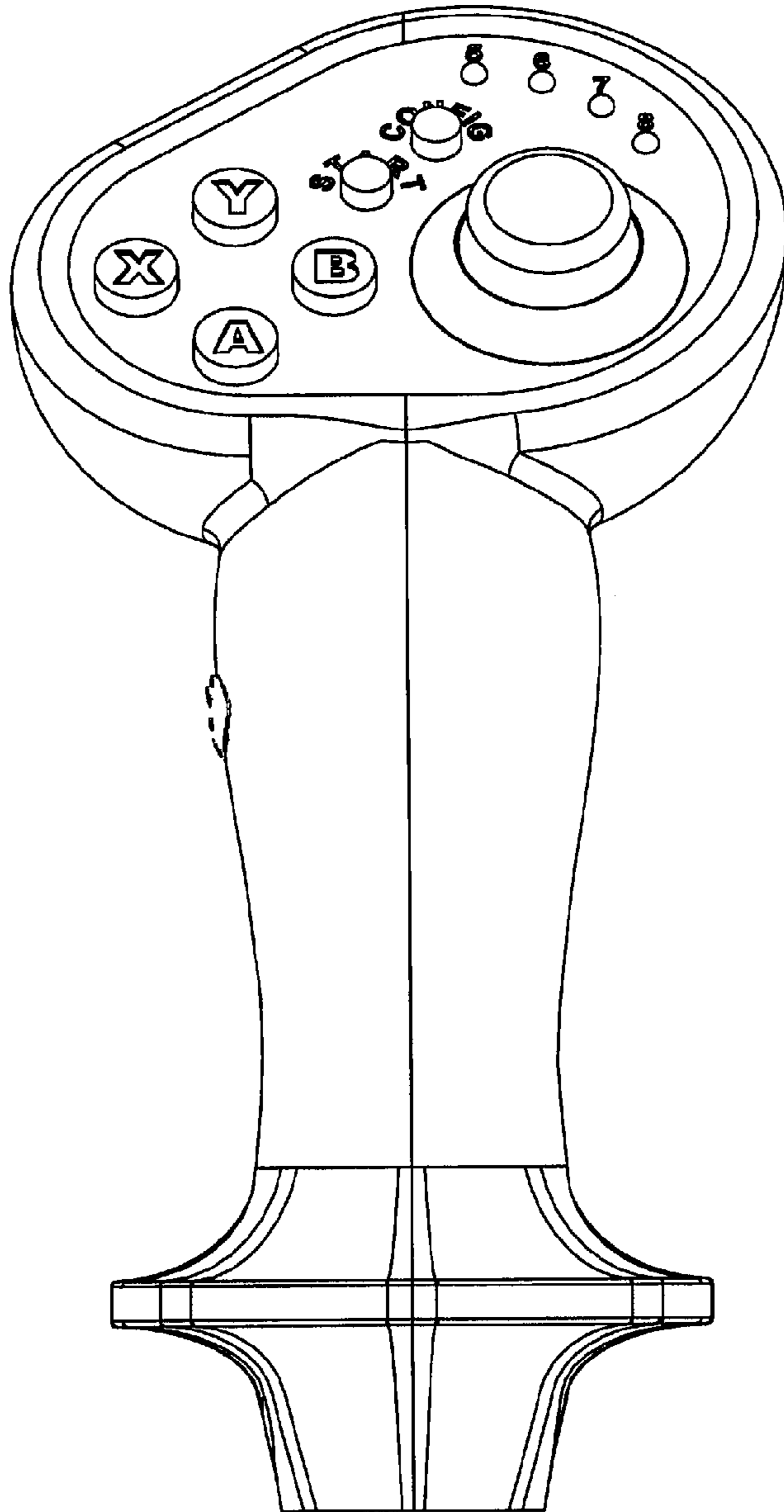

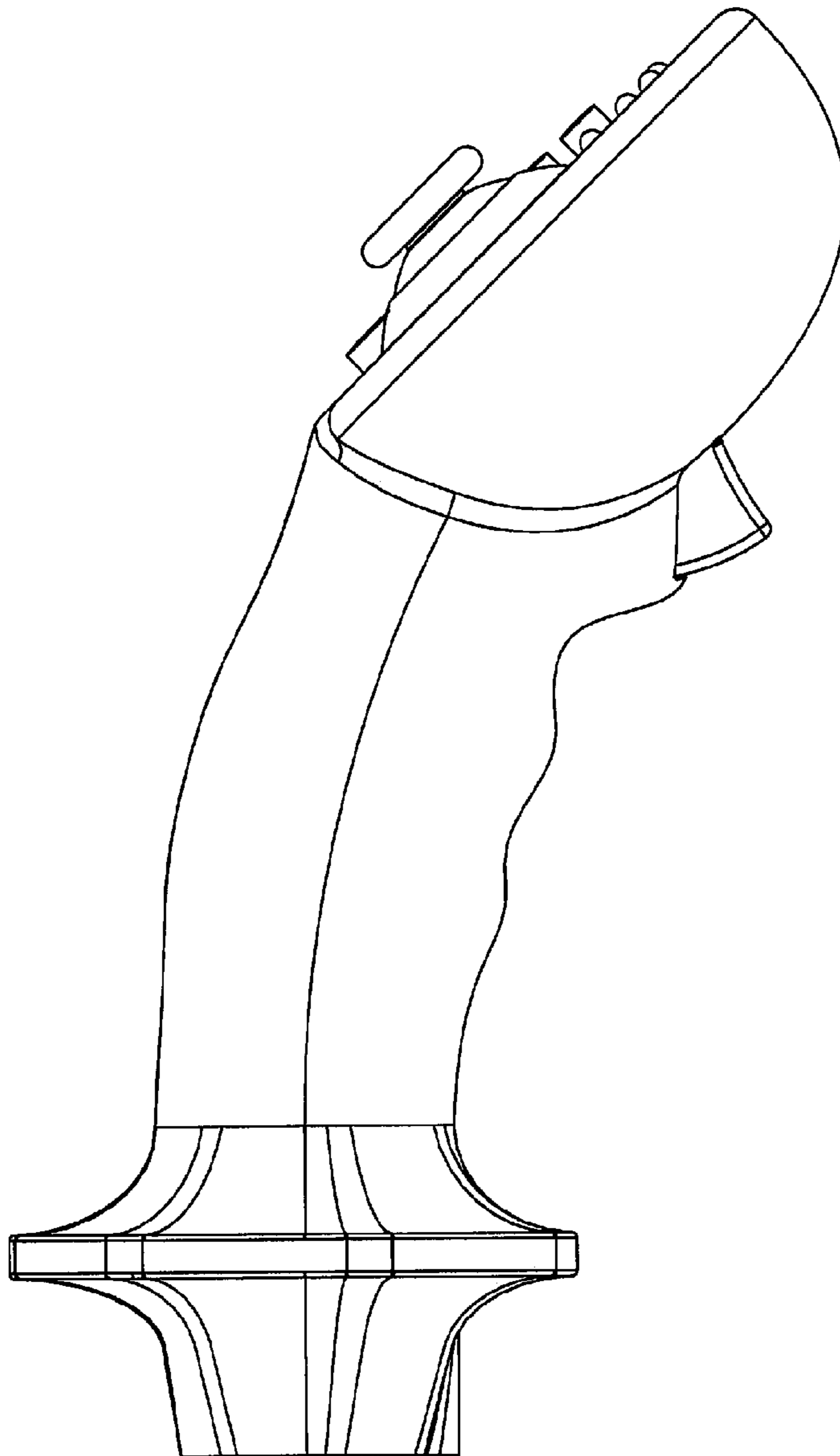

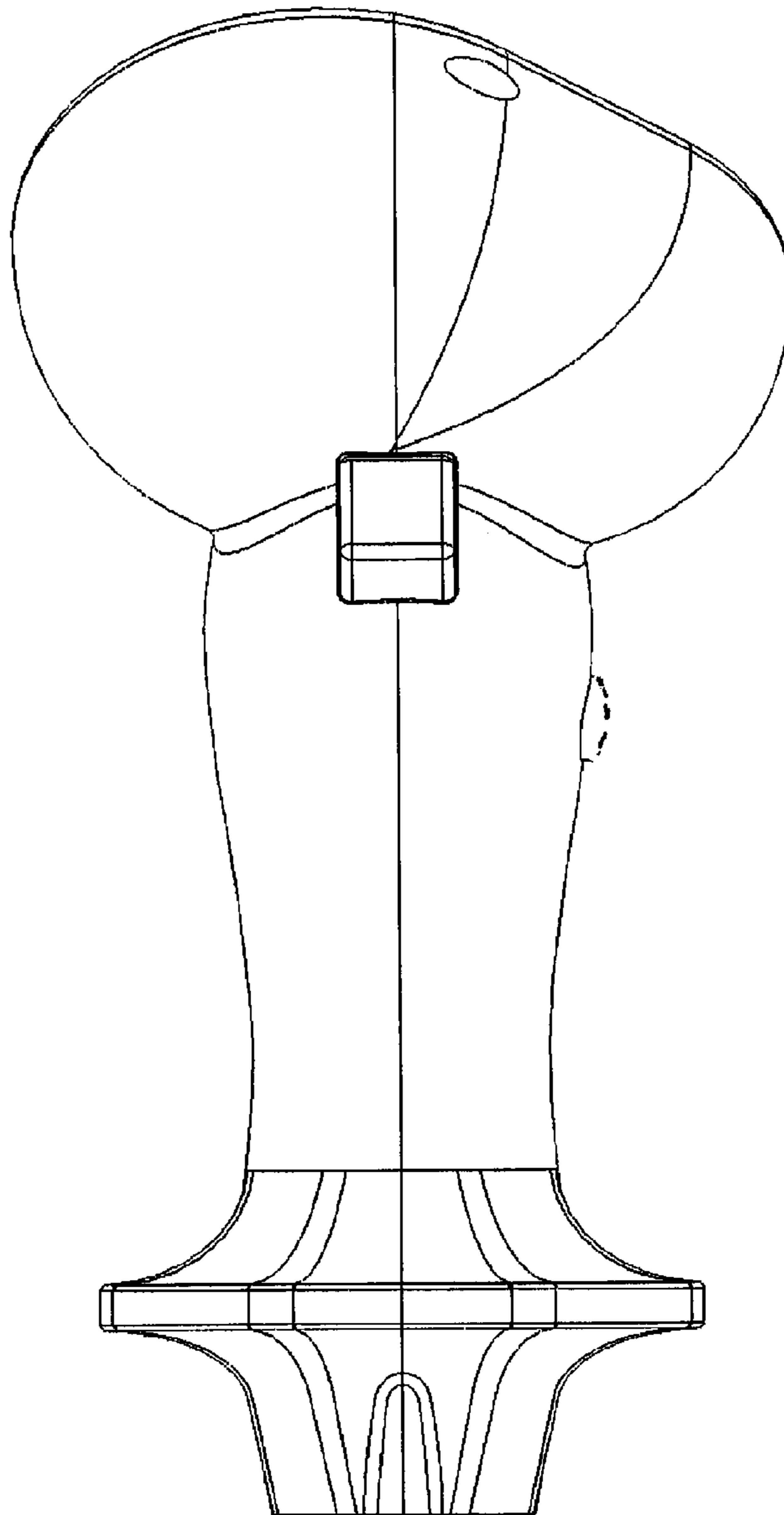

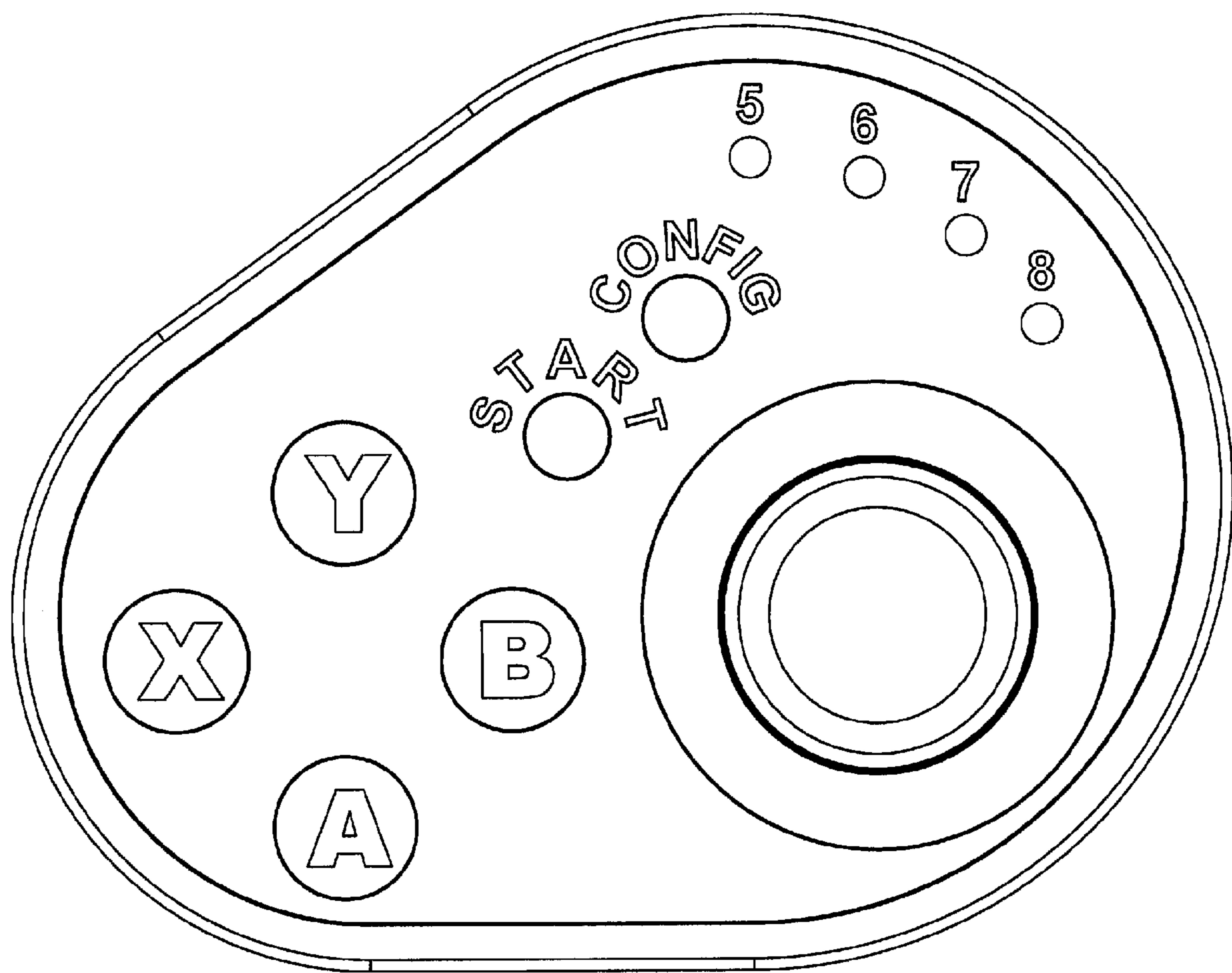

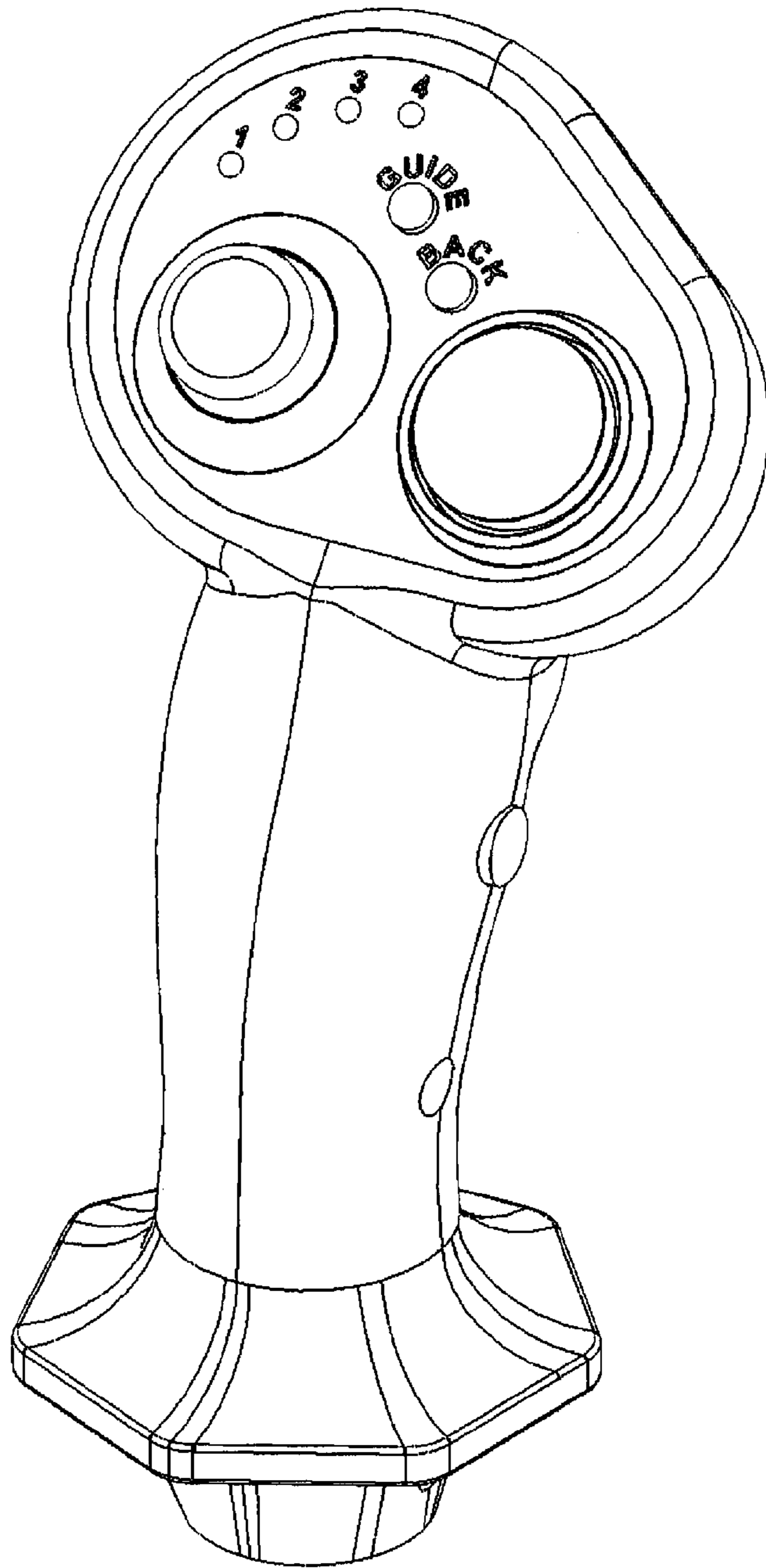

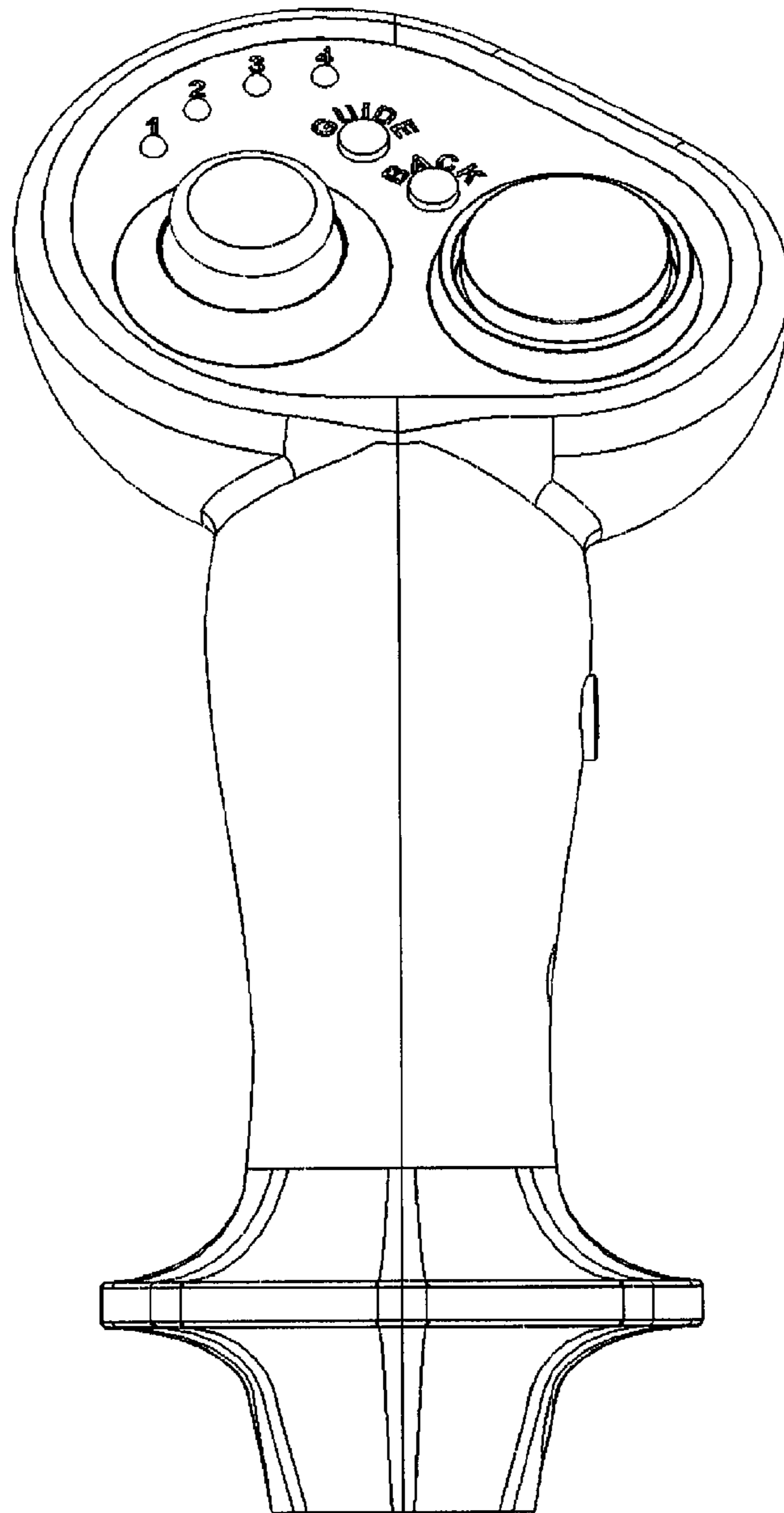

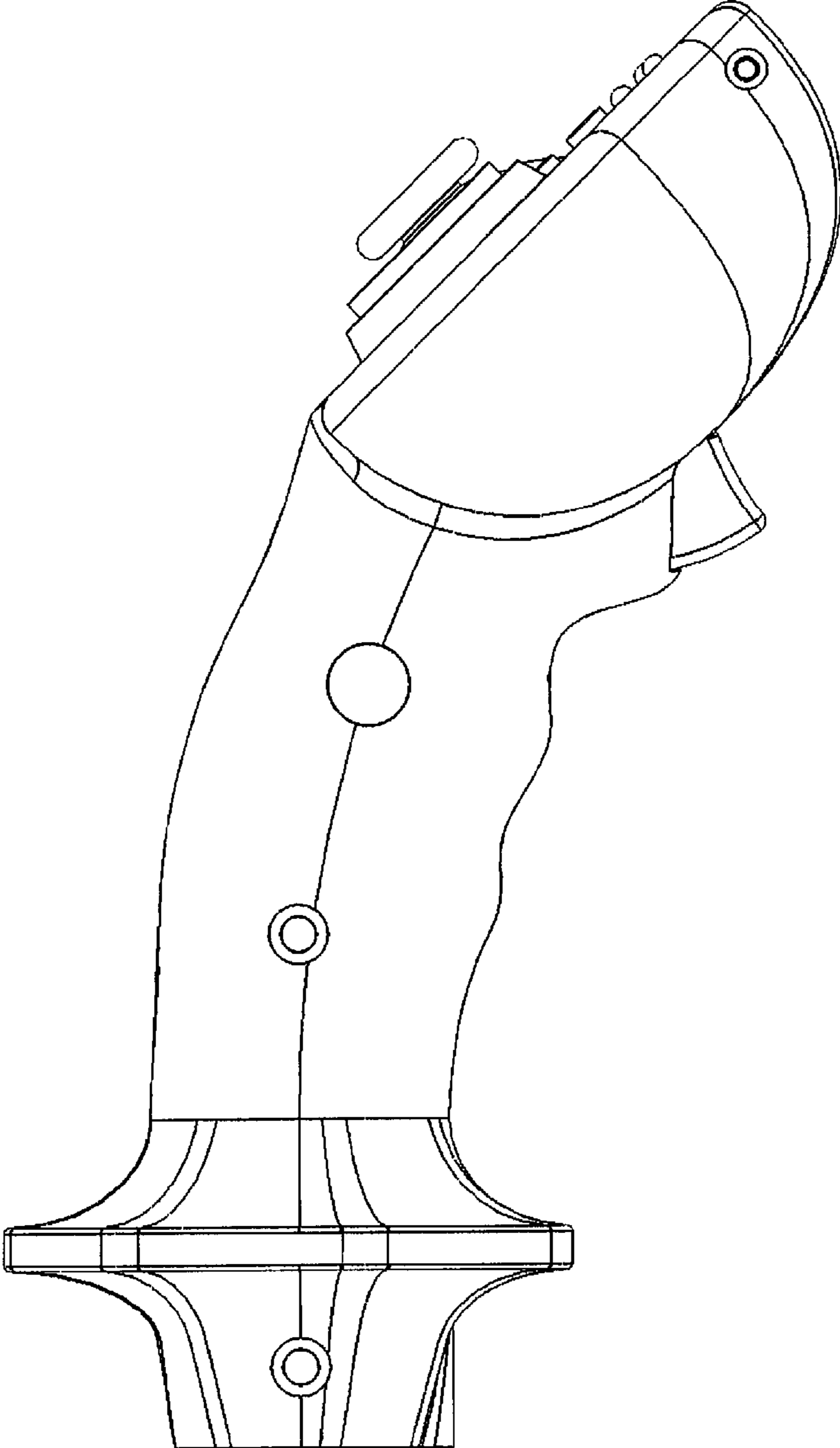

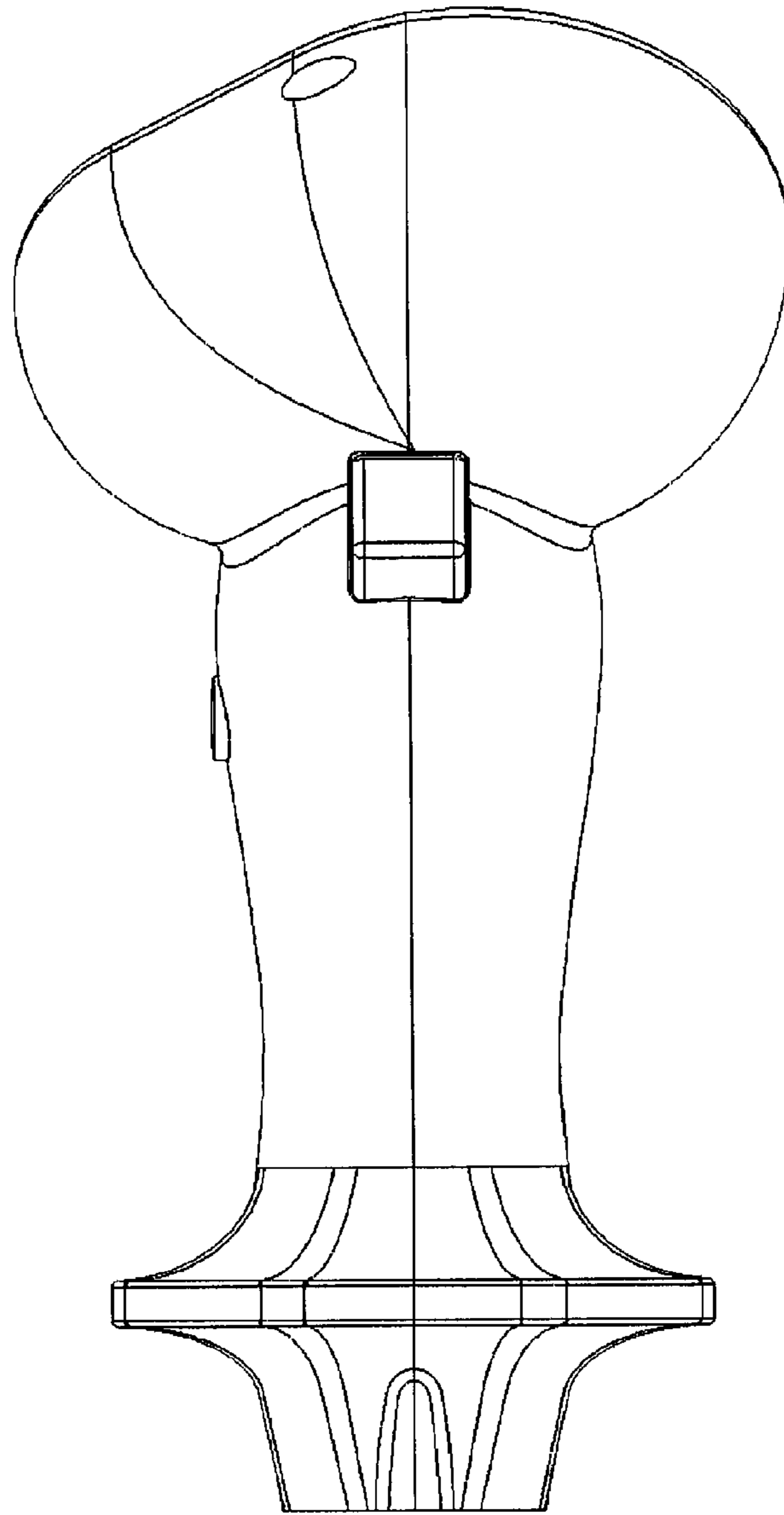

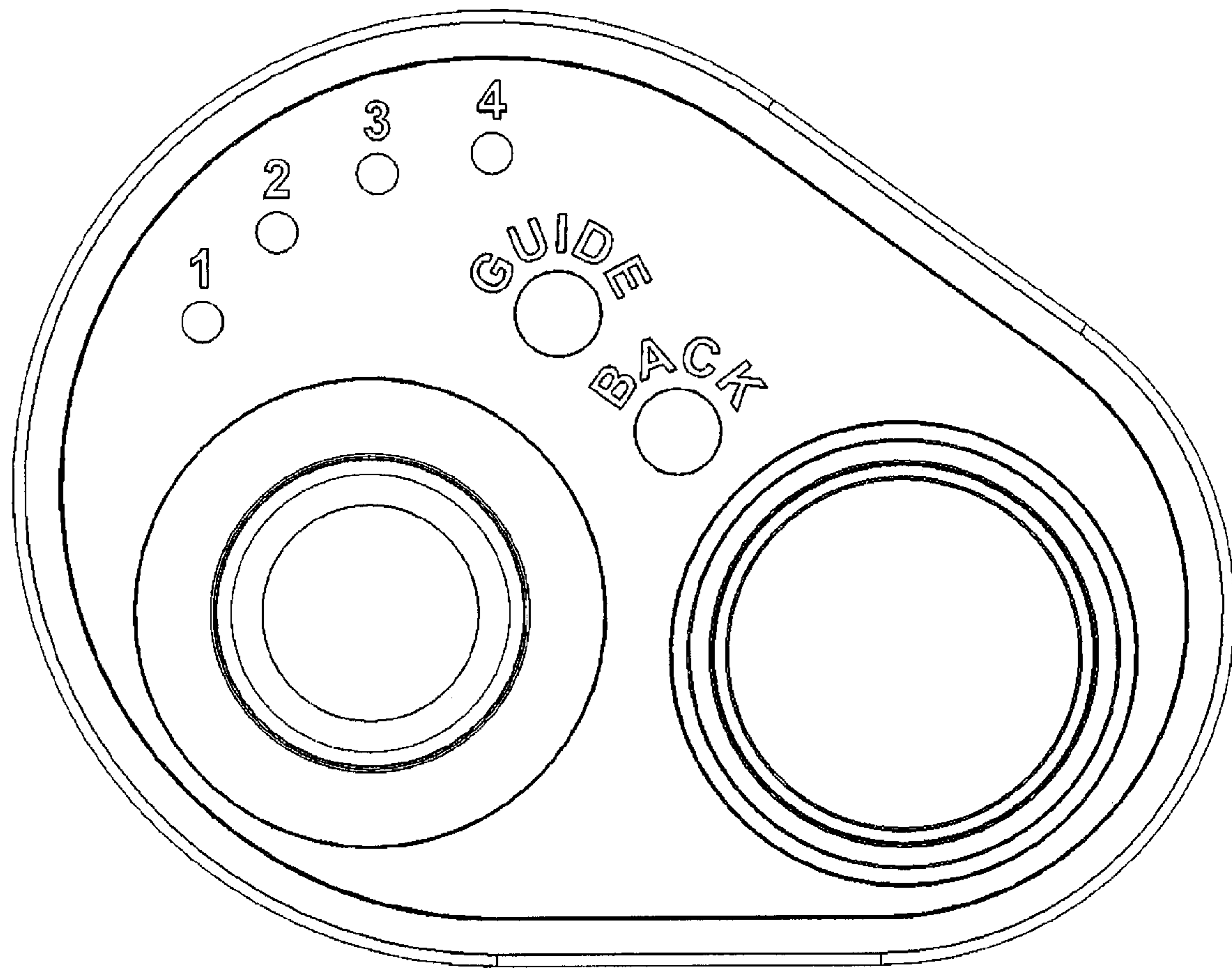
