The broken lines in the Figures are for illustrative purposes only and form no part of the claimed design.

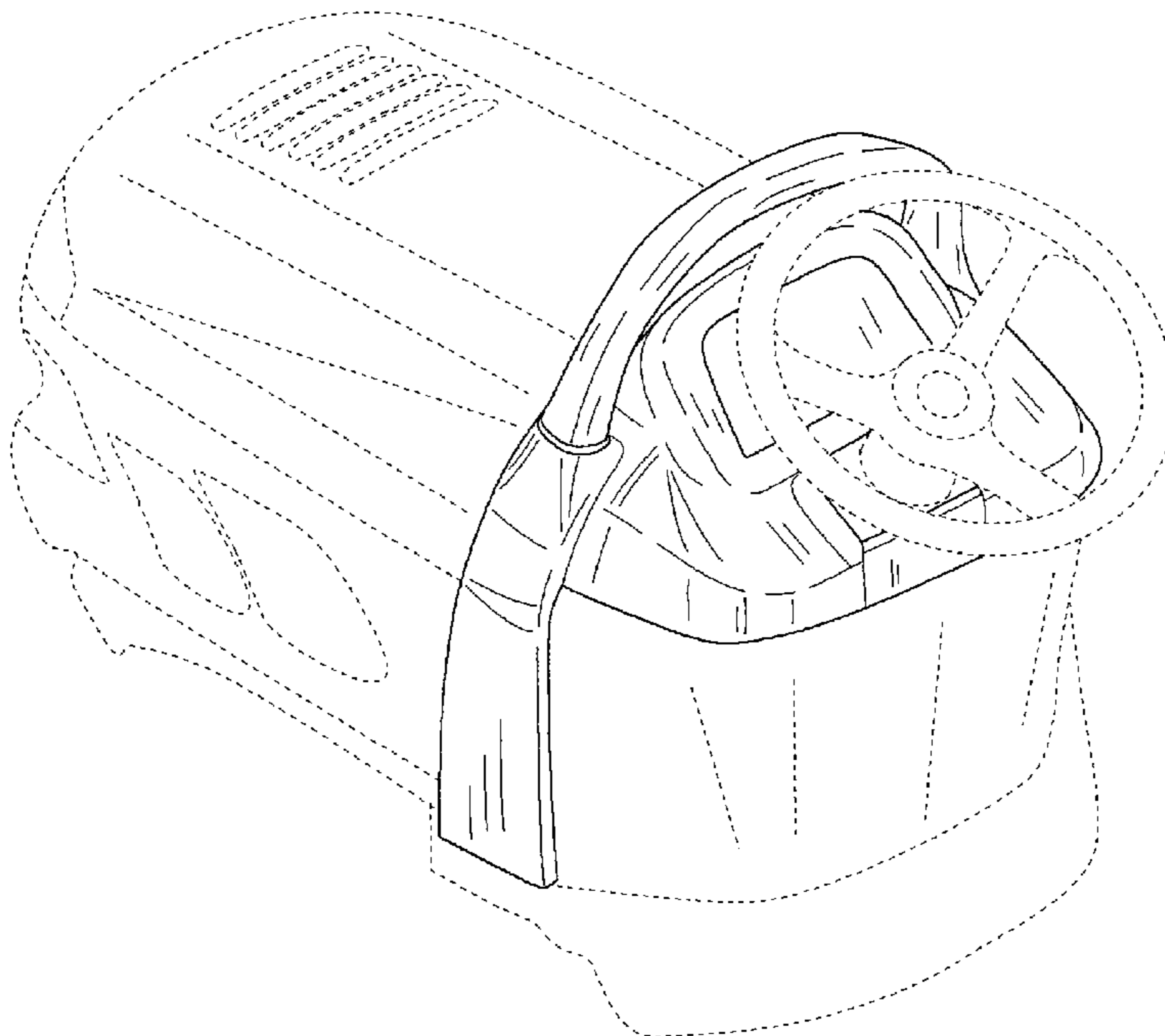

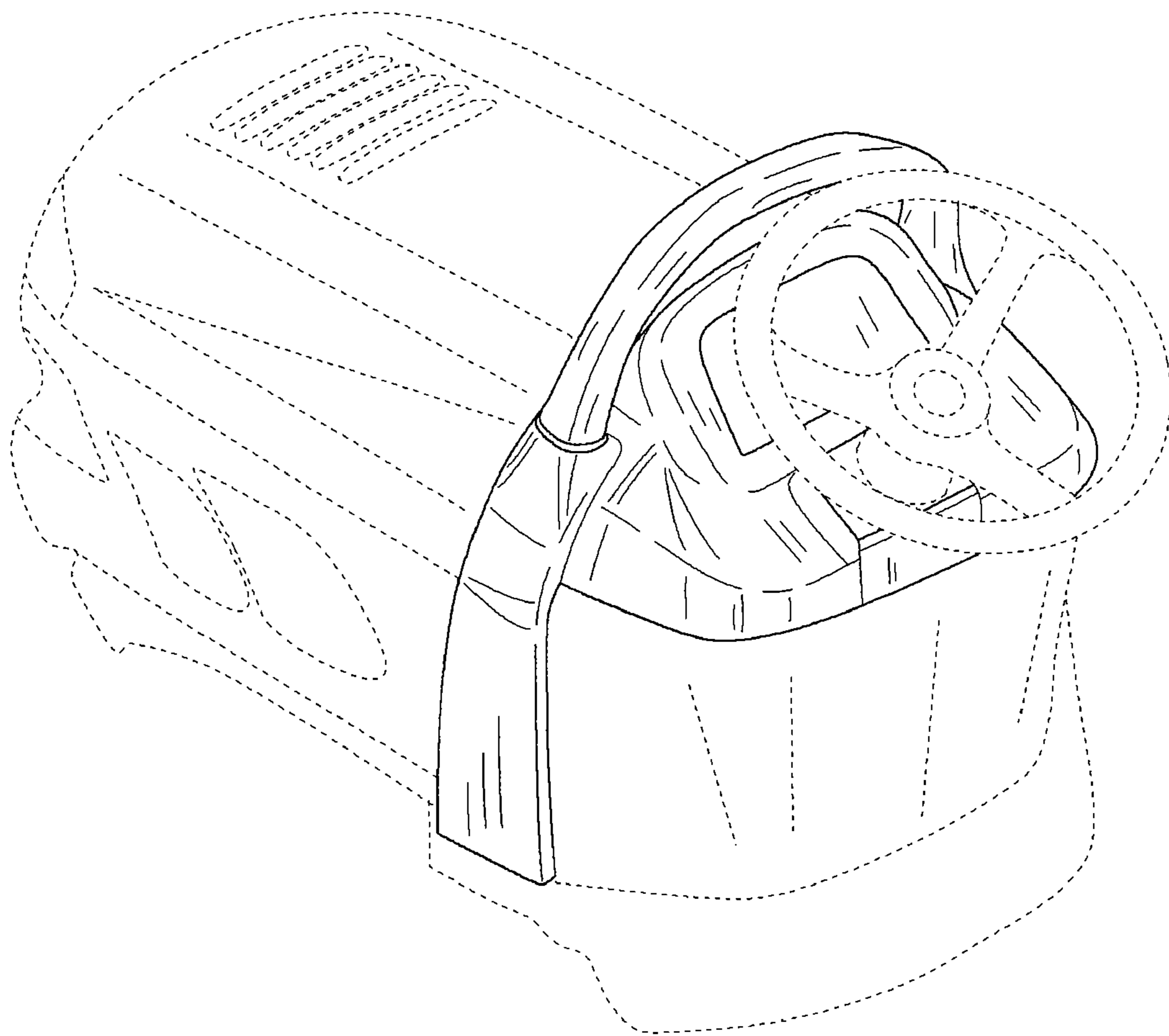

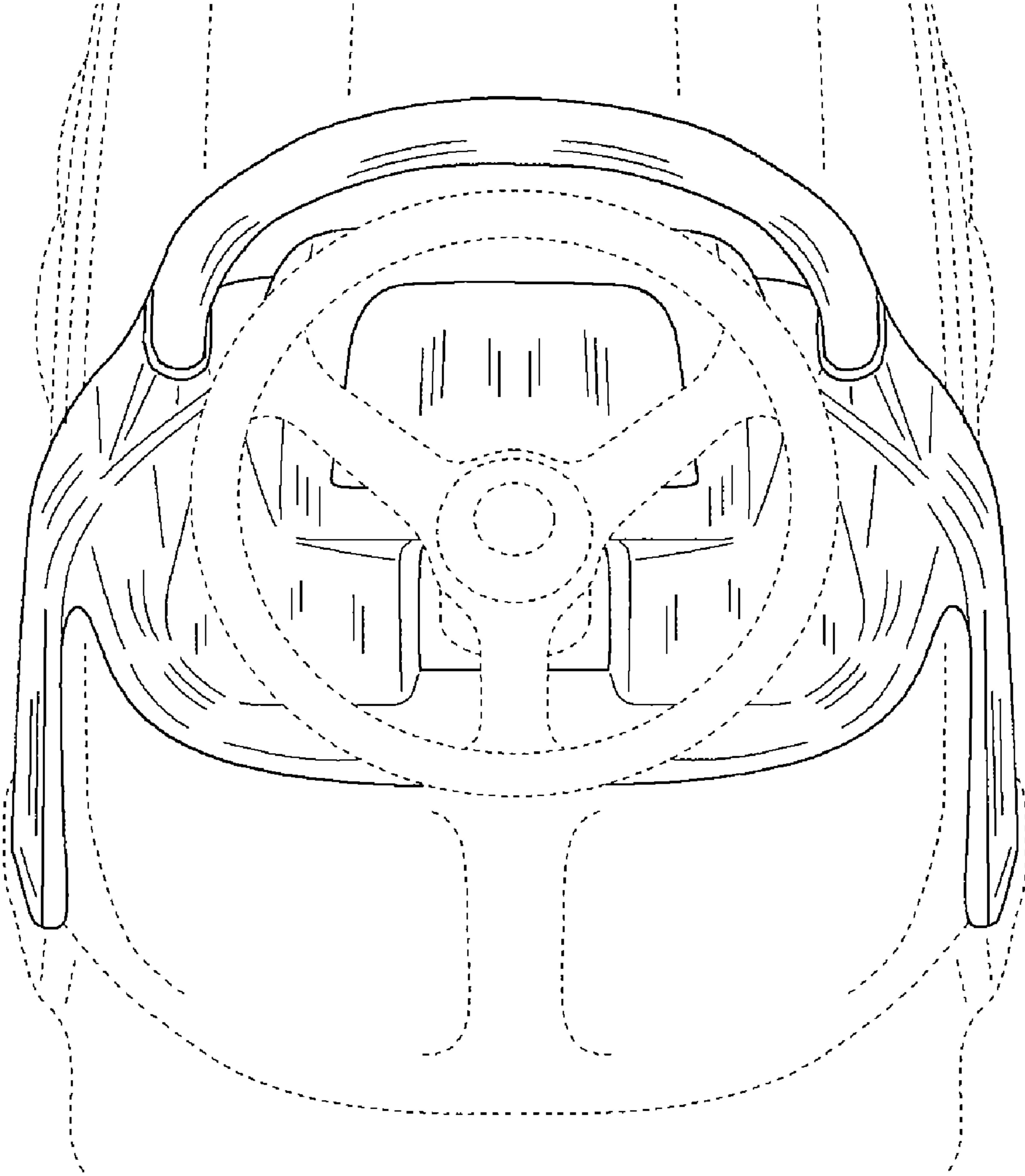

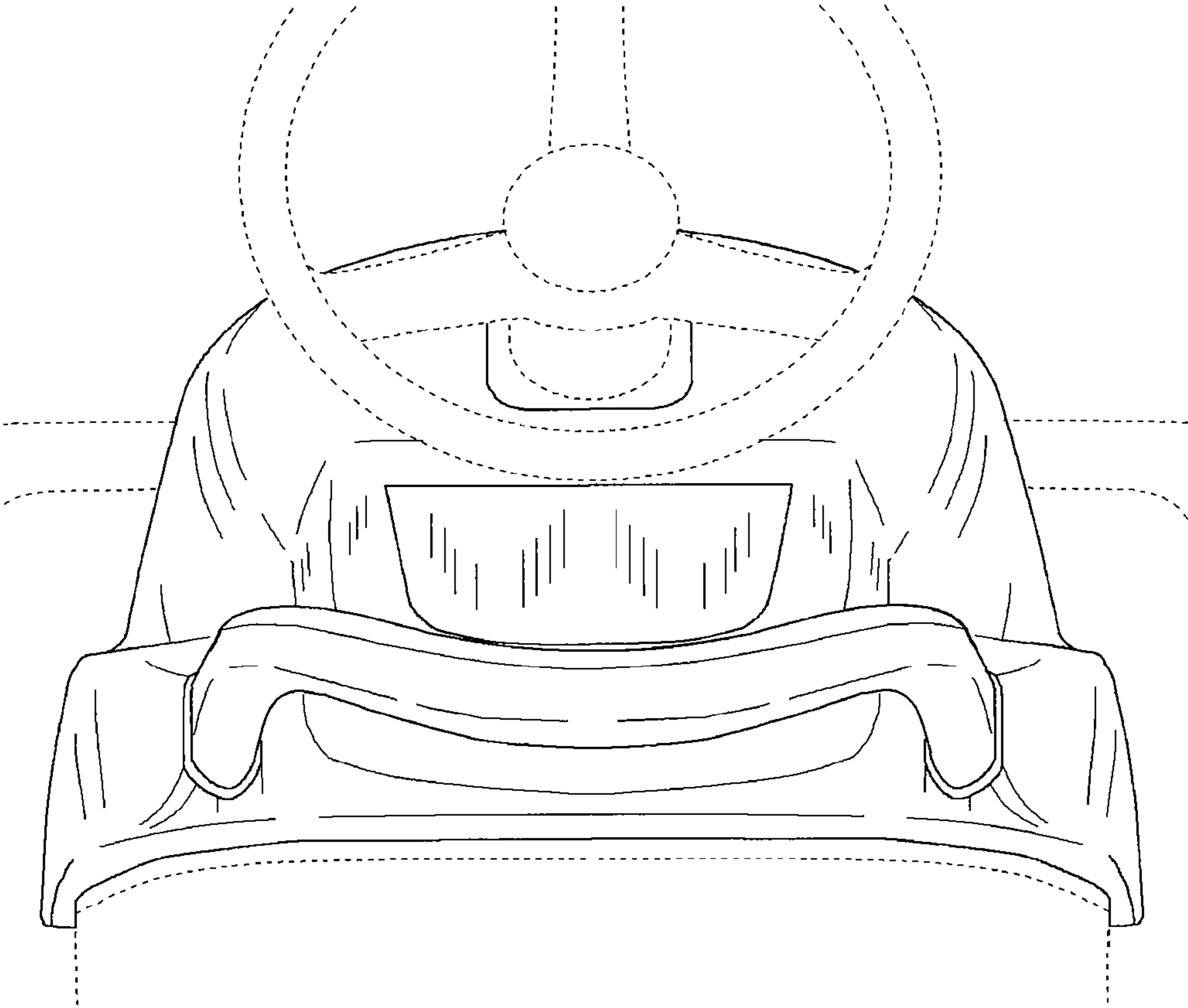

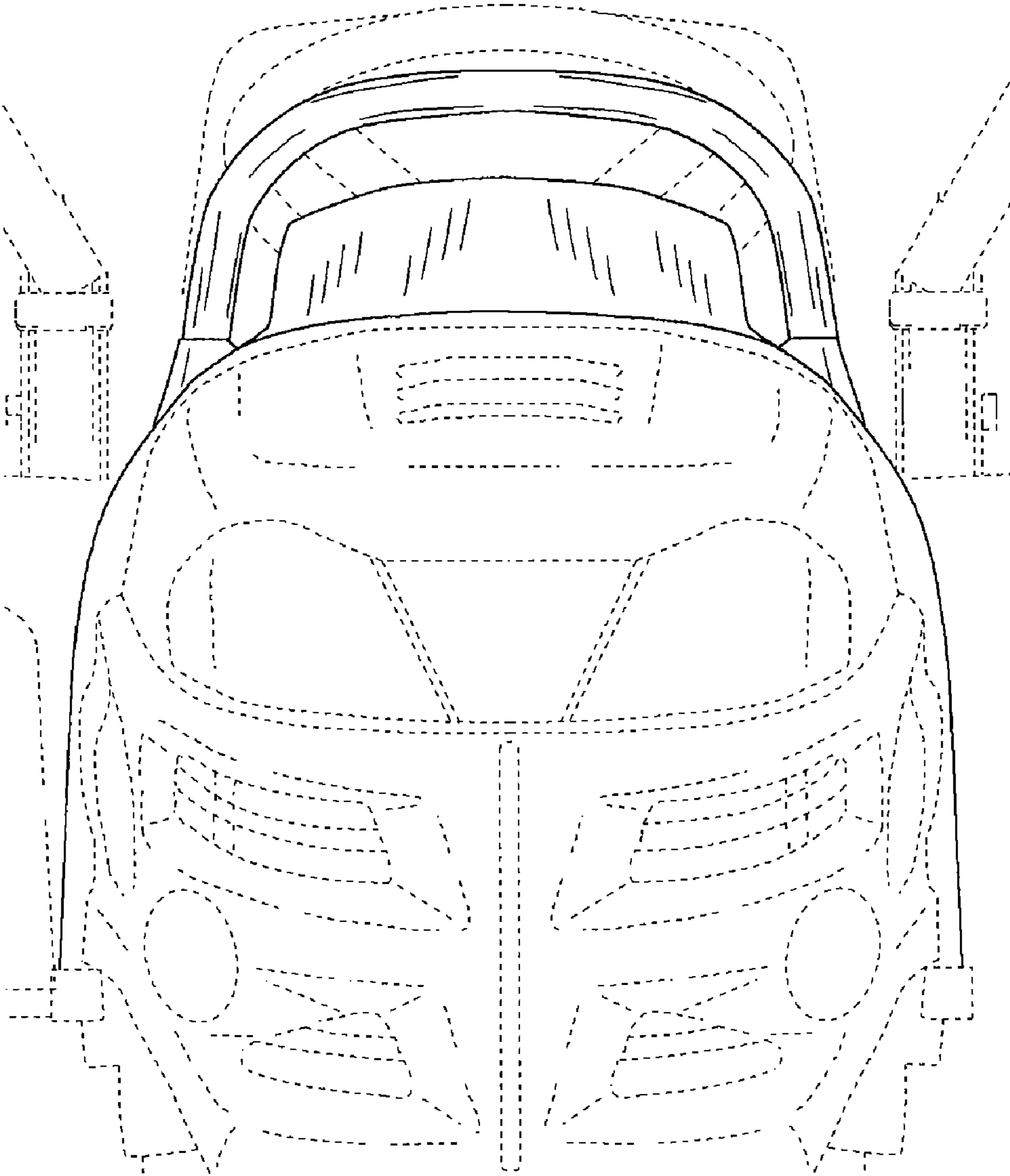

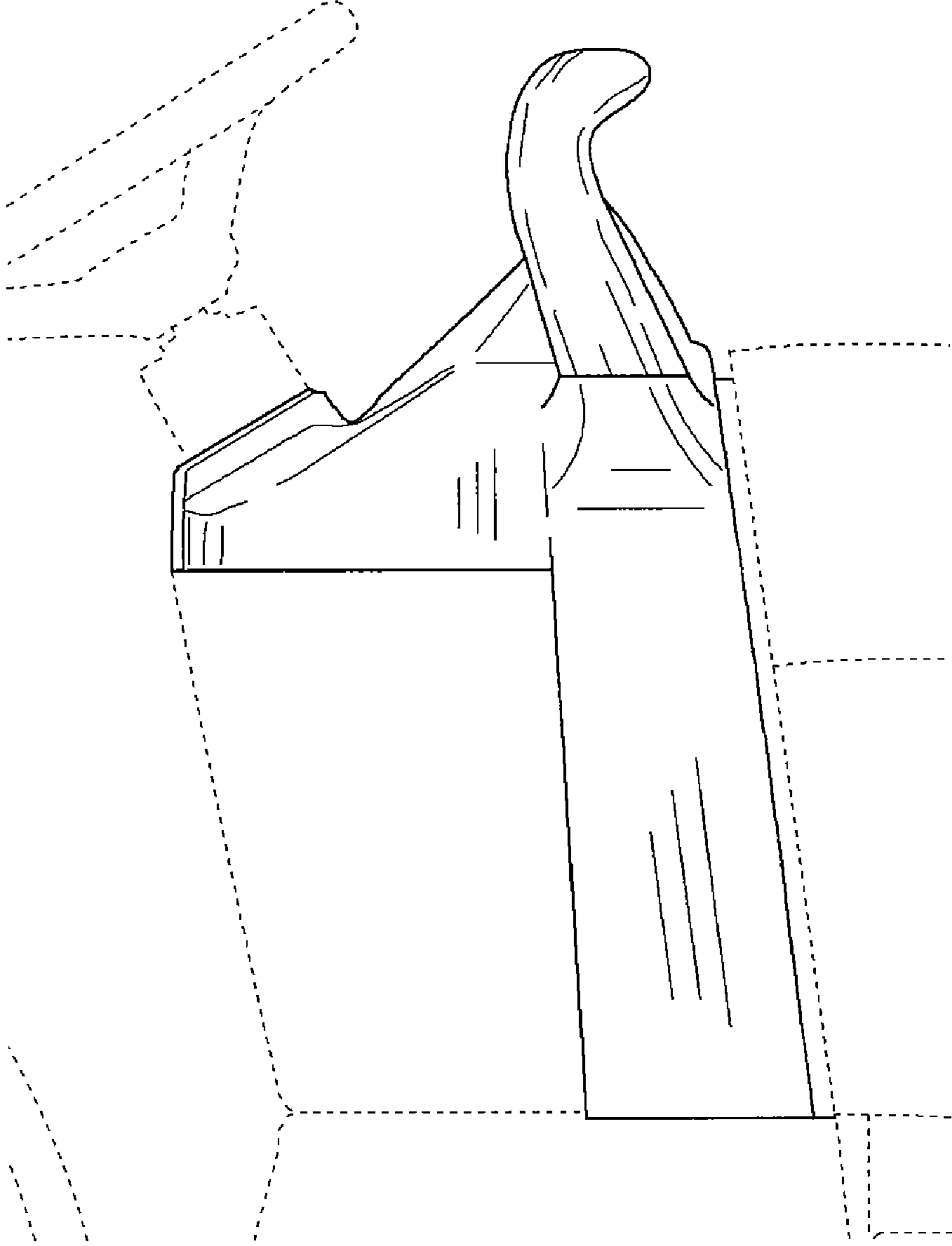

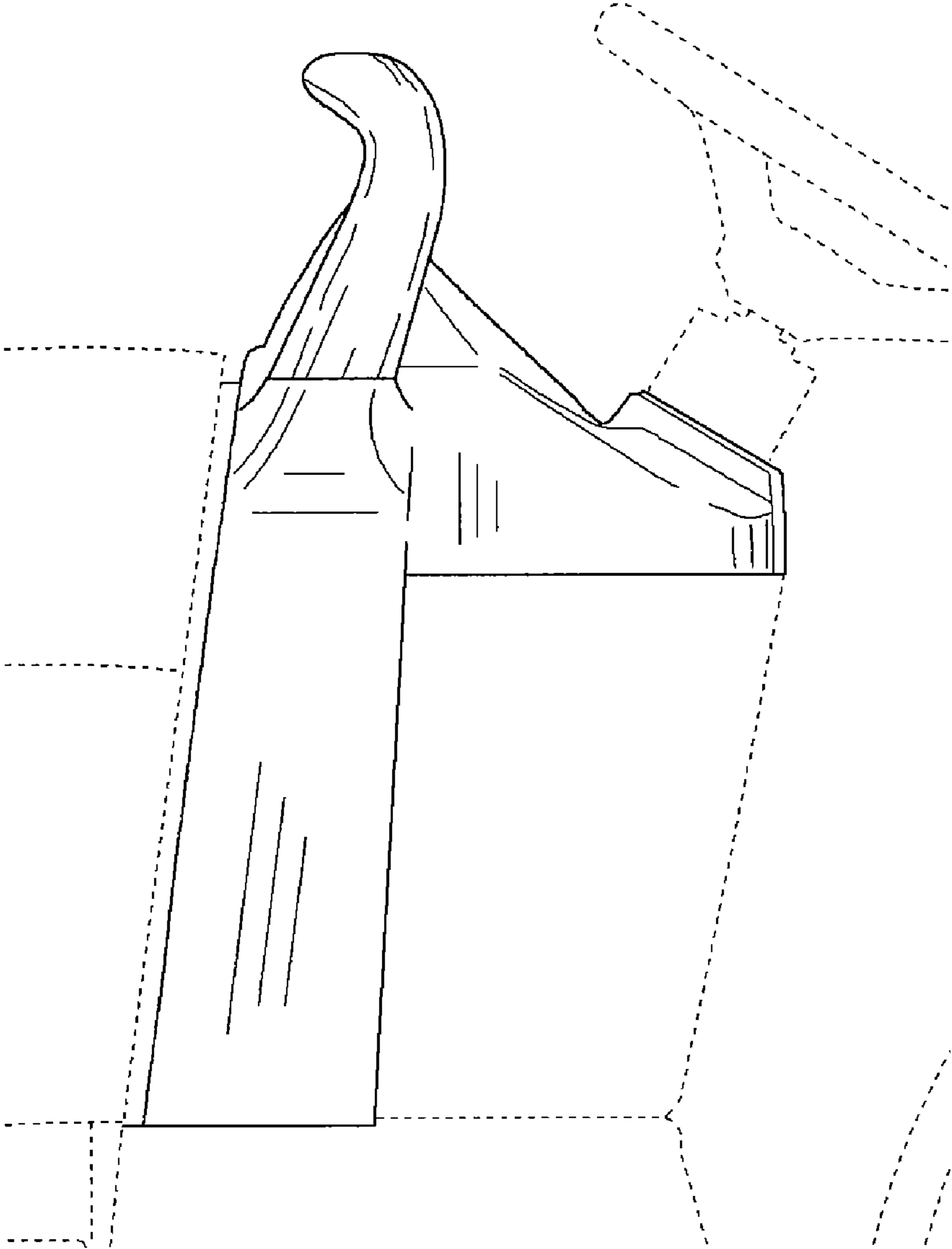

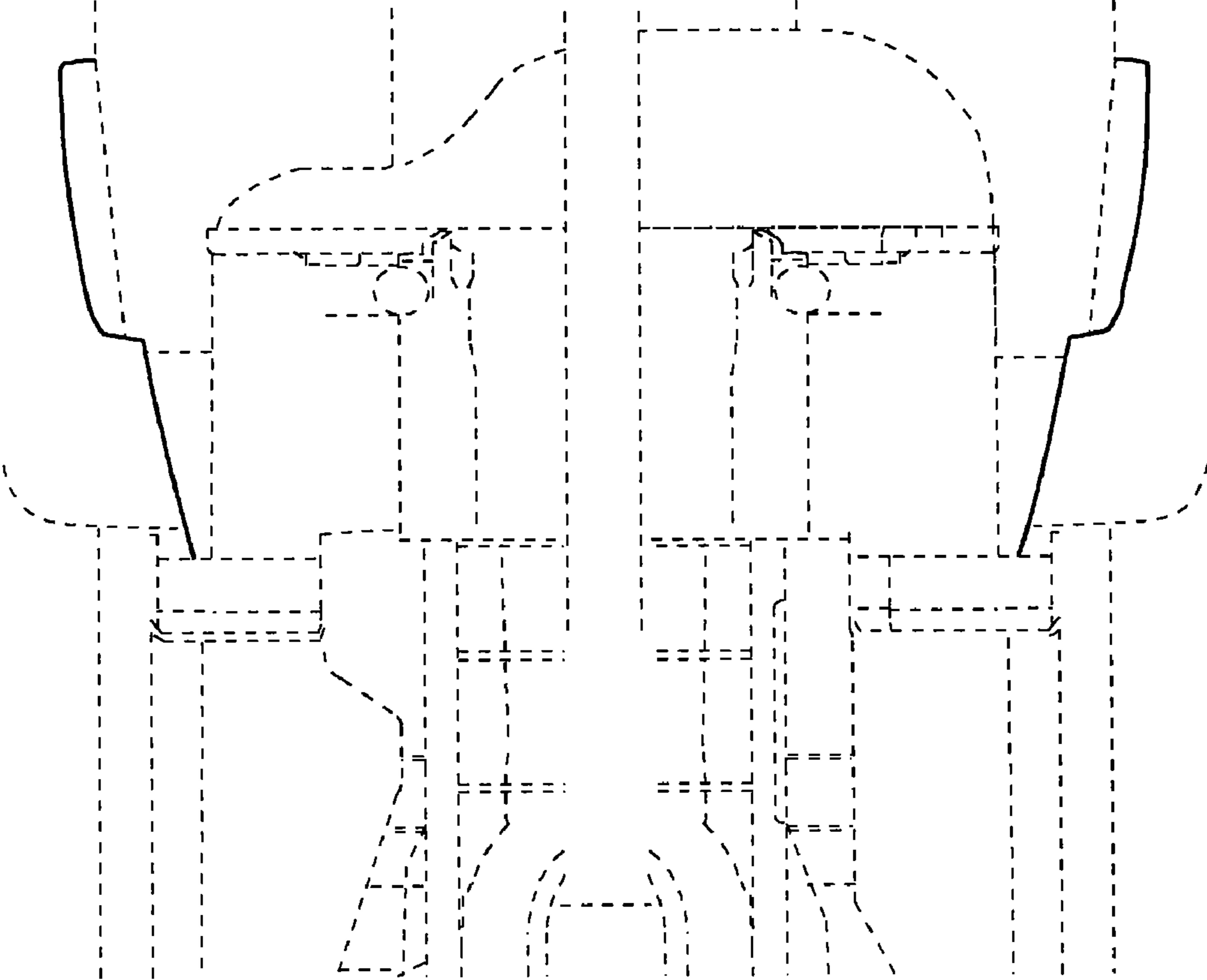
