FIG. 2 is a front view of the eyeglasses.

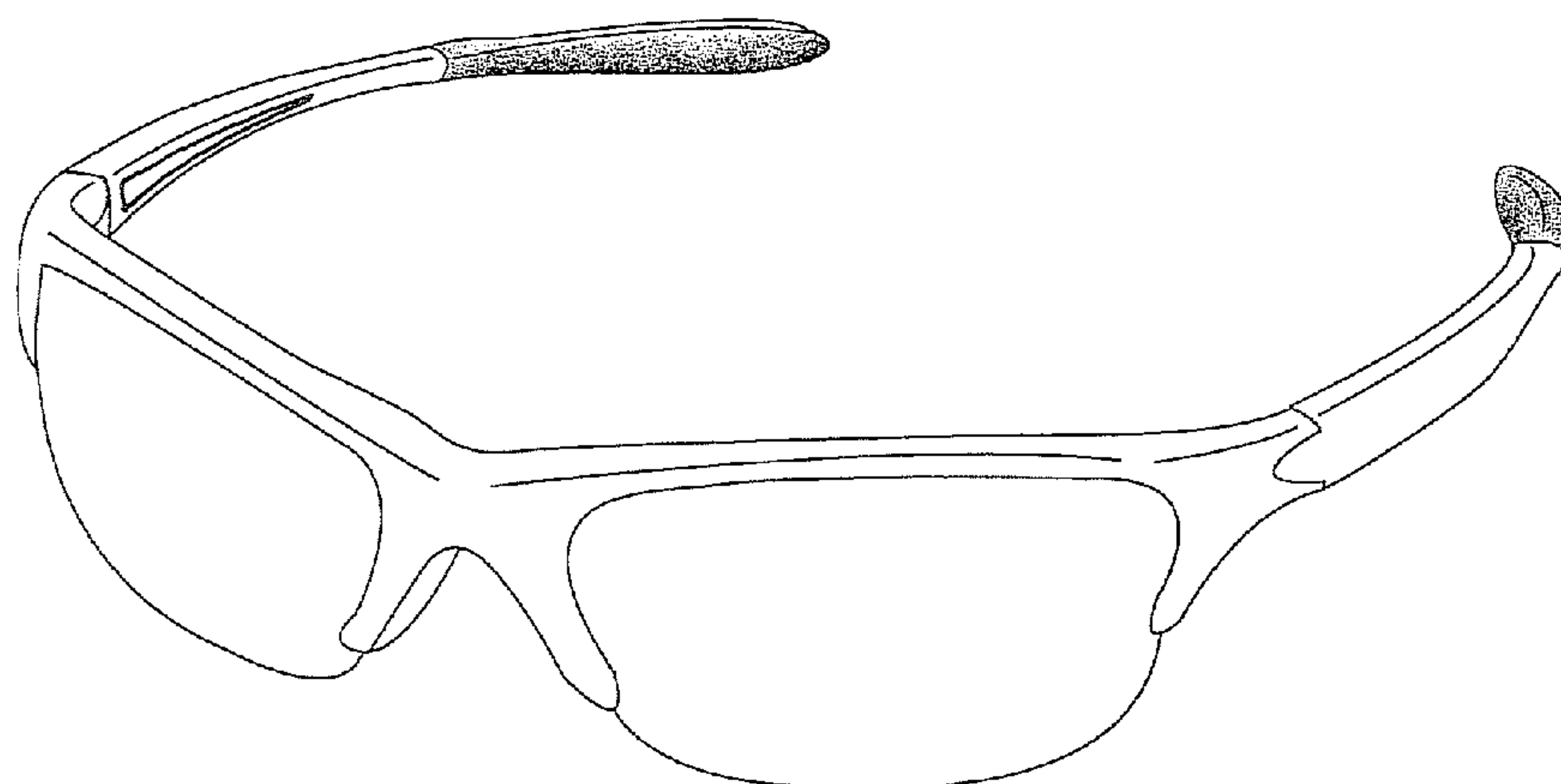
FIG. 3 is a top view of the eyeglasses.

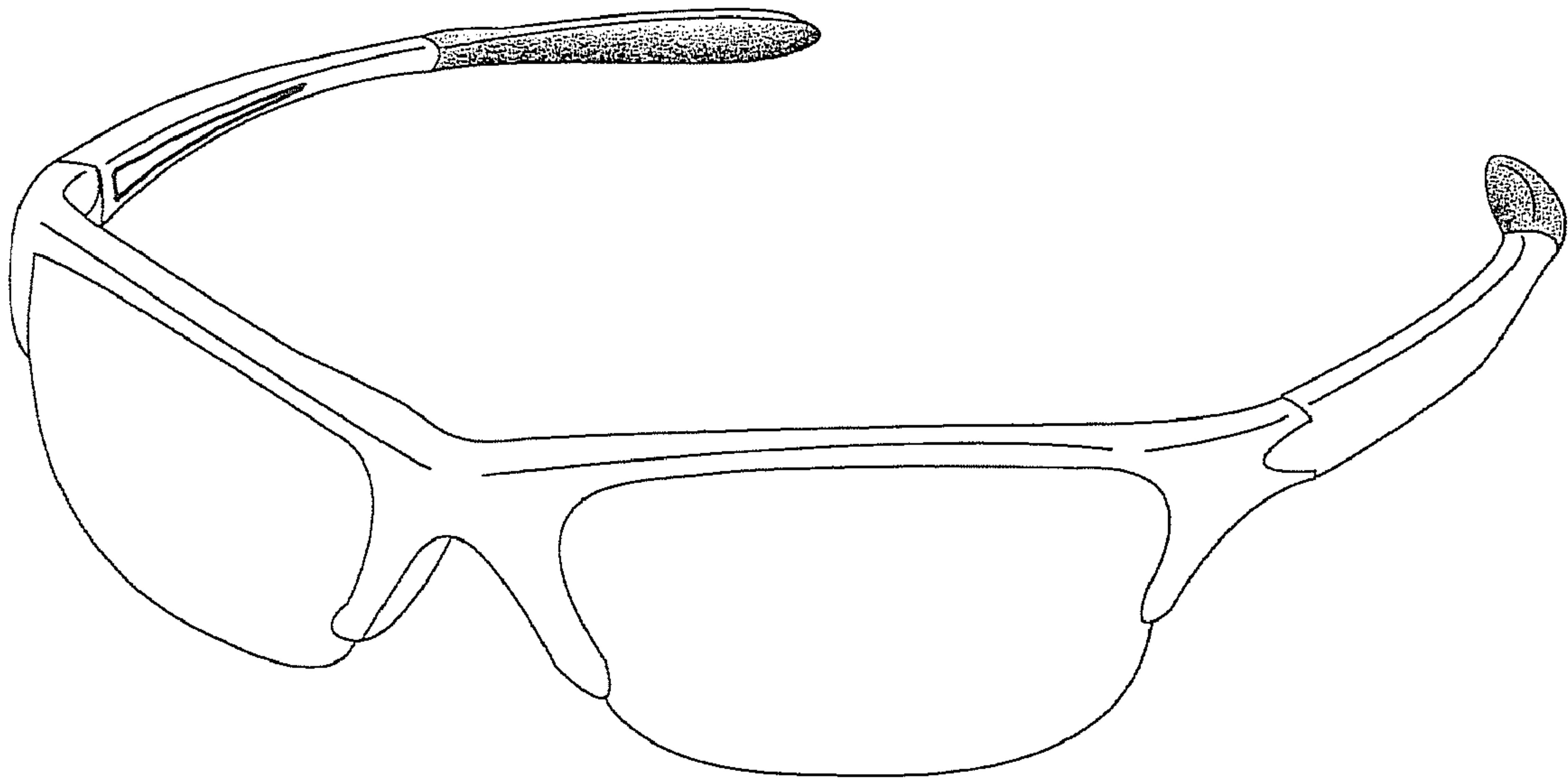

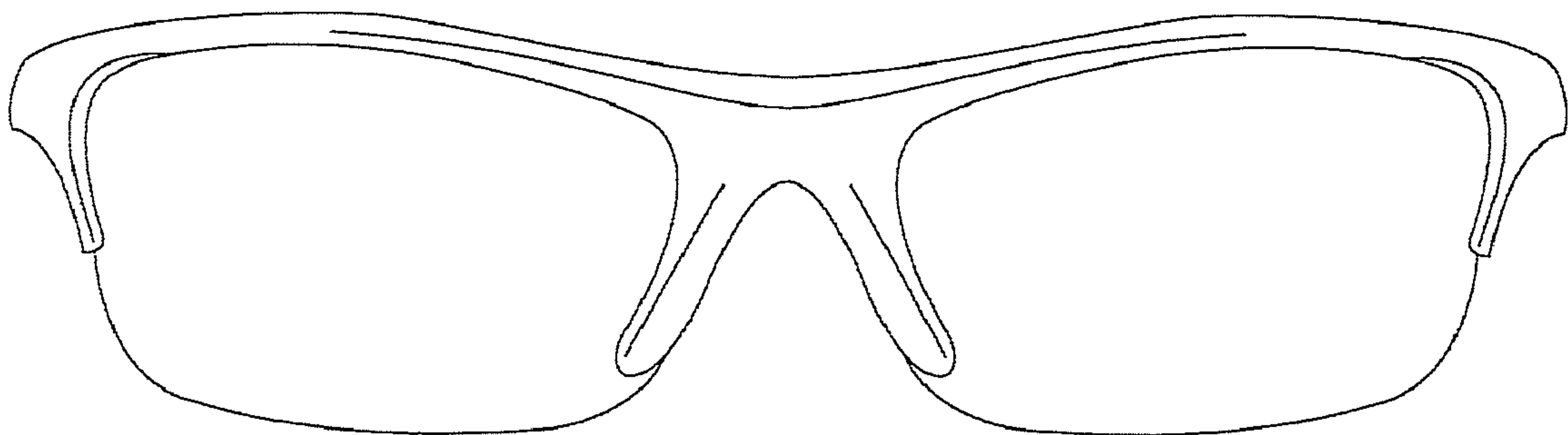

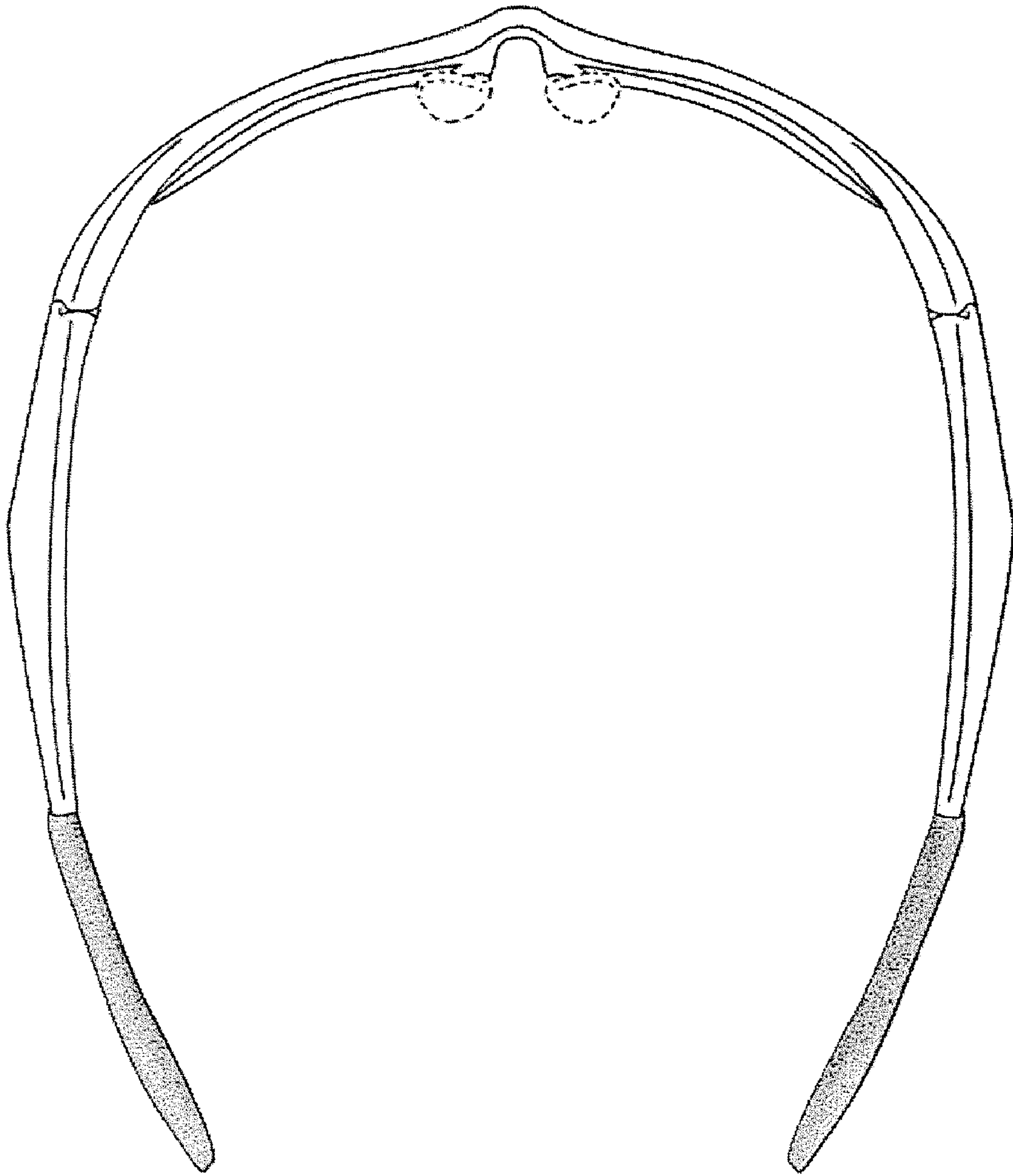

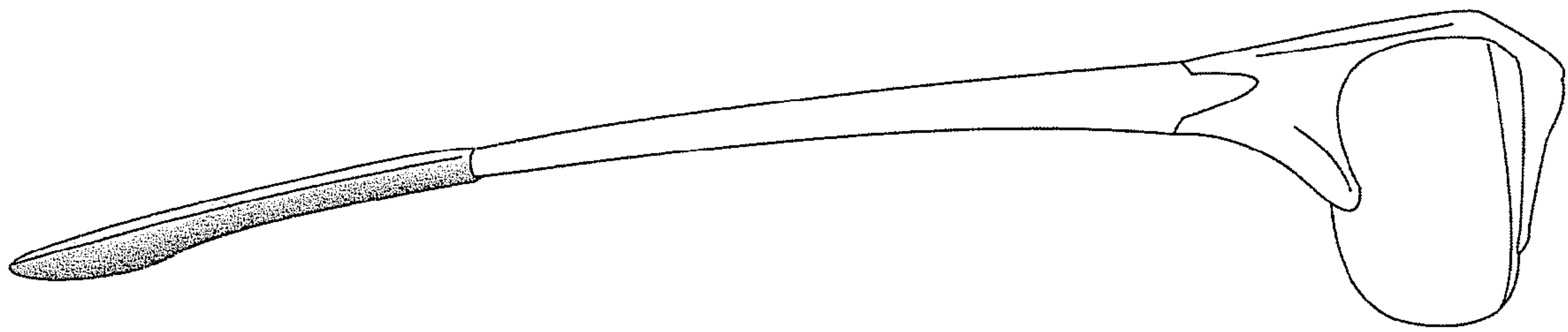

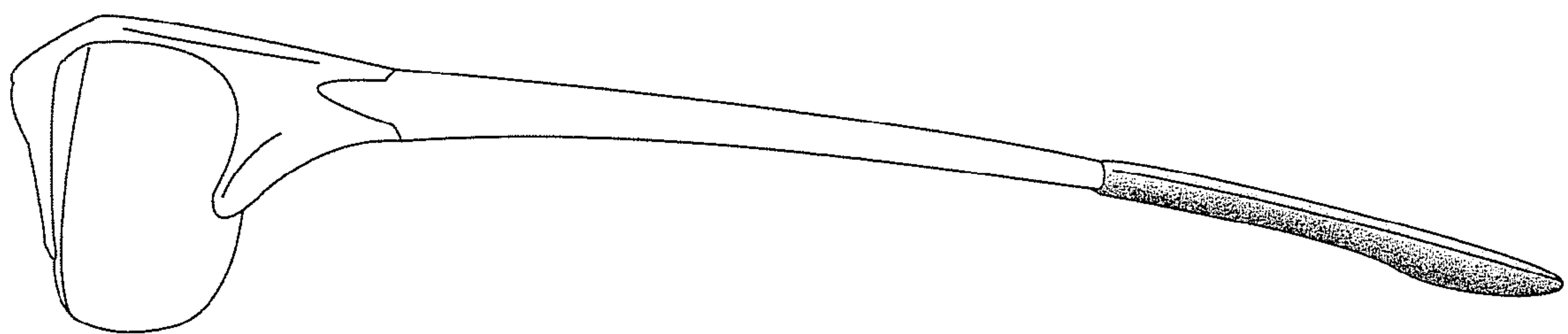
