(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is an orthographic back elevational view of a portion of a golf club head, embodying the inventive design.

FIG. 2 is a perspective view thereof.

FIG. 3 is an orthographic bottom plan view thereof.

FIG. 4 is an orthographic front elevational view thereof.

FIG. 5 is an orthographic heel side elevational view thereof.

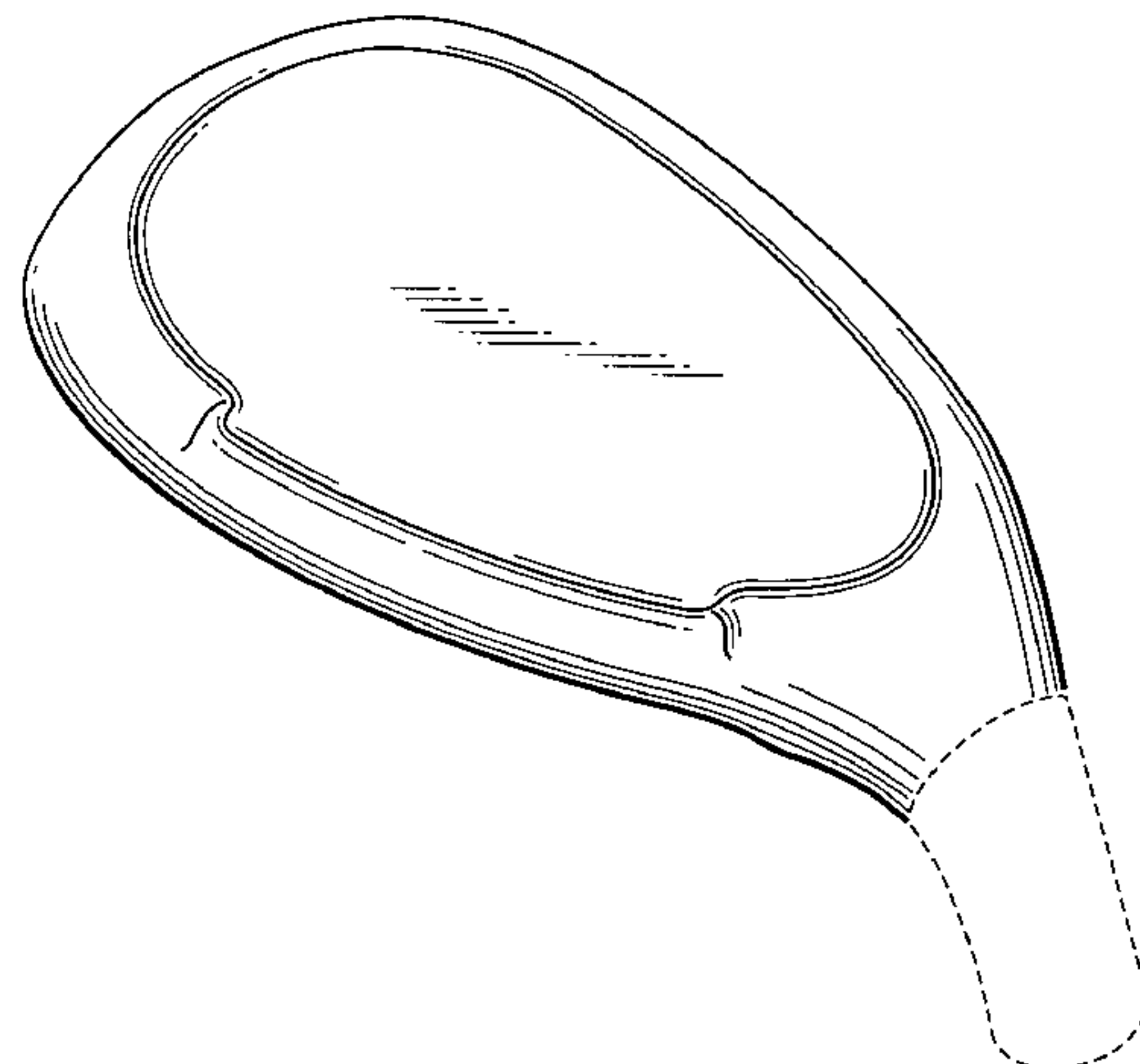
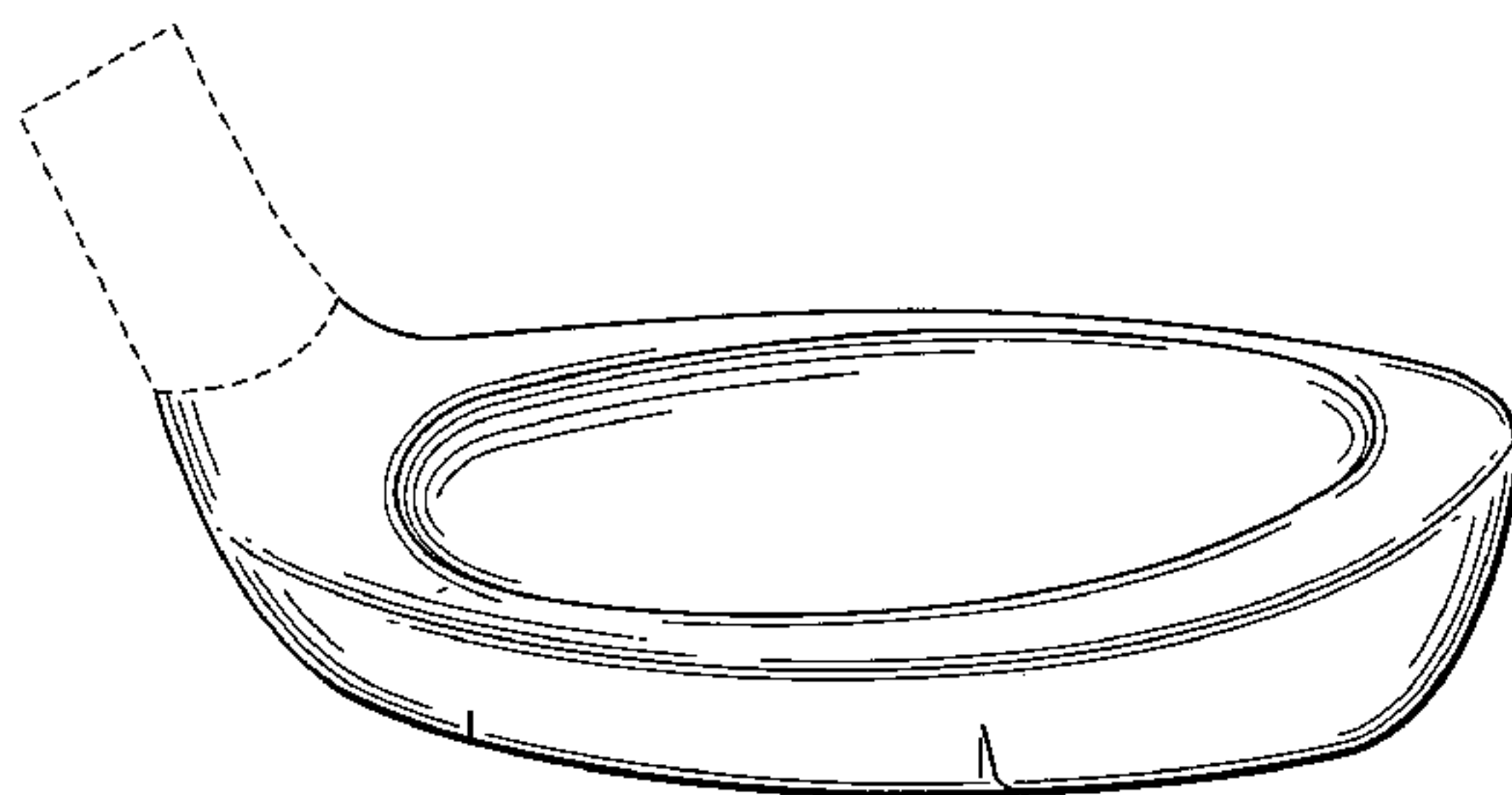
FIG. 6 is an orthographic toe side elevational view thereof.

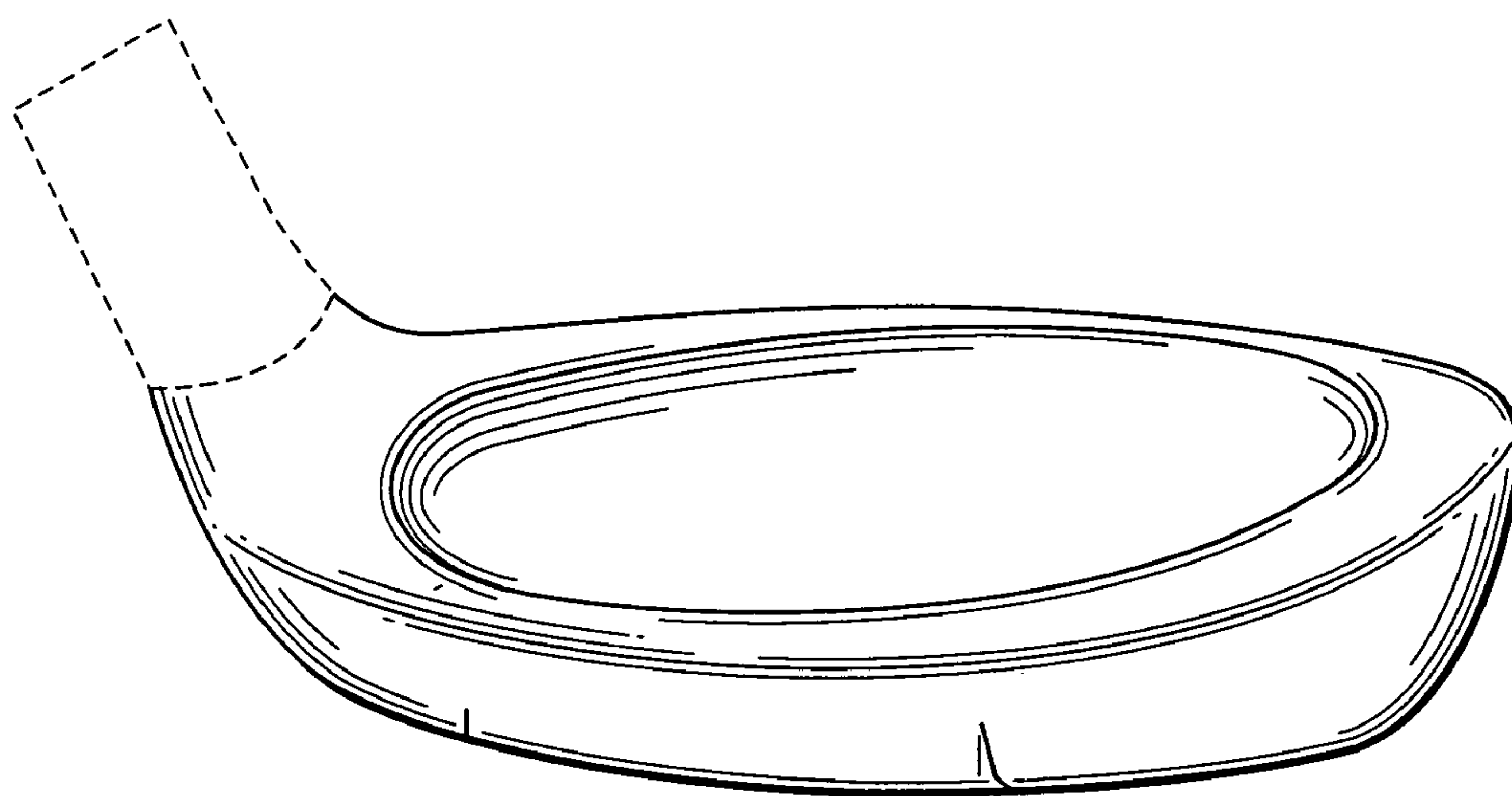

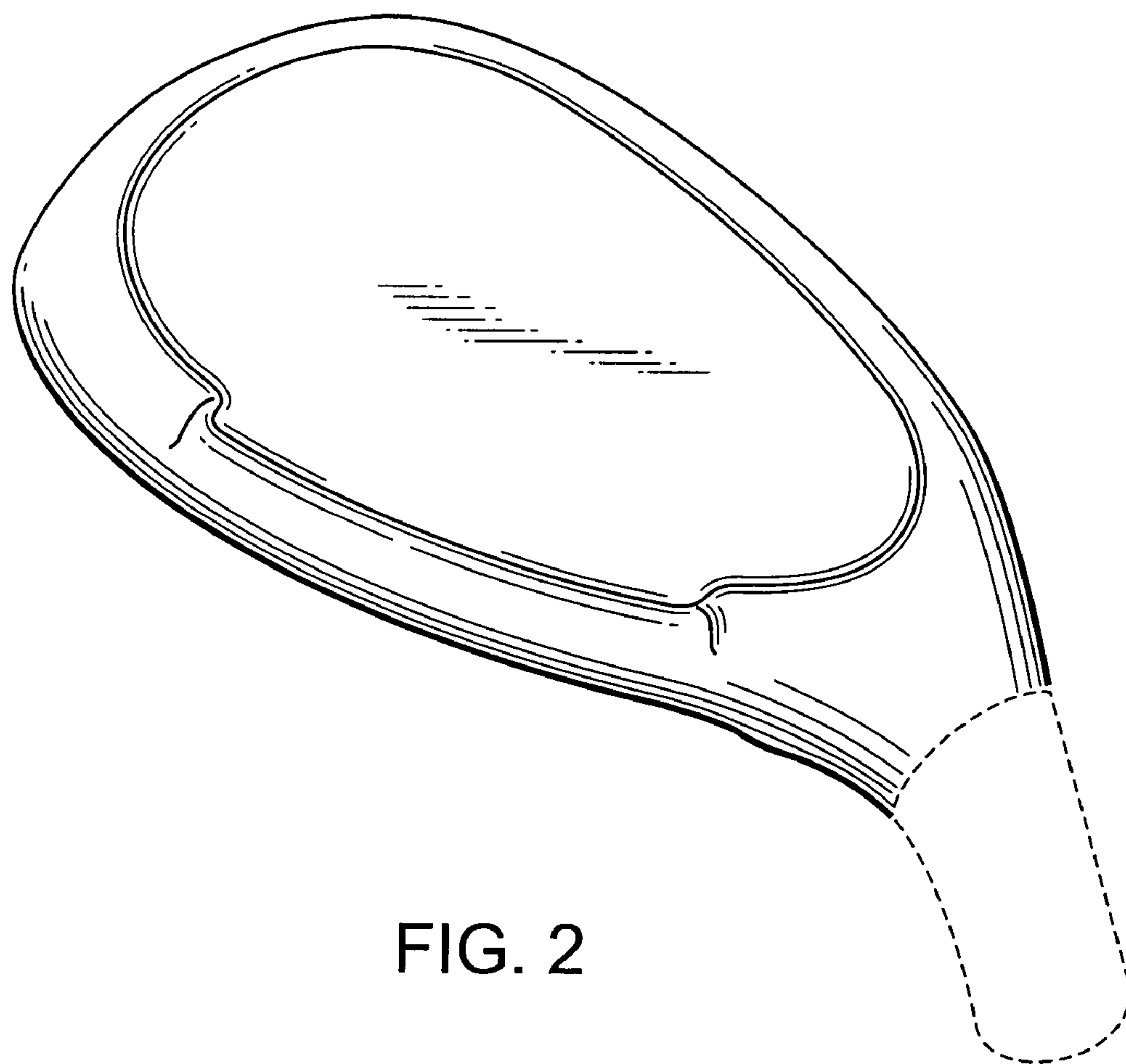

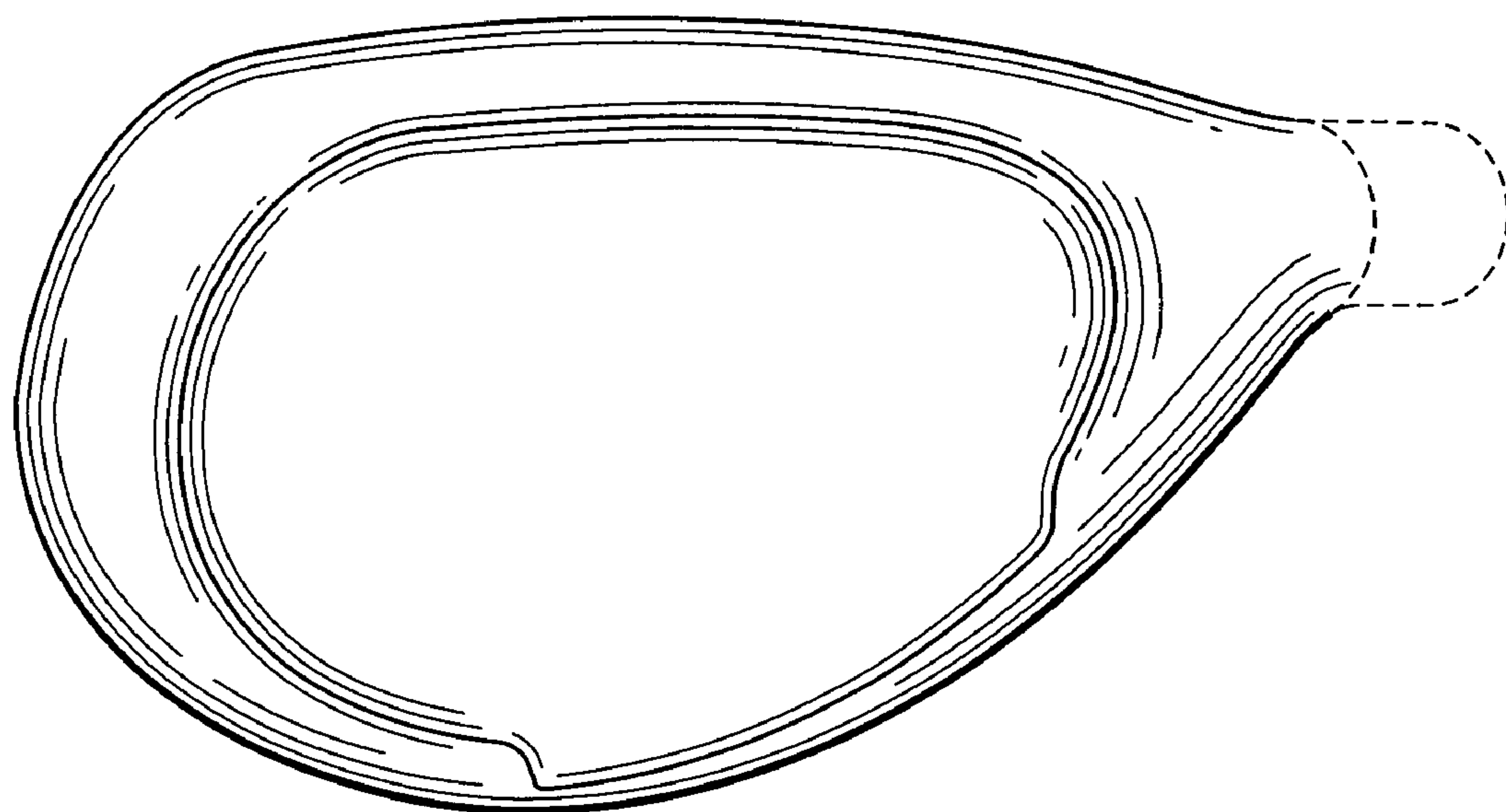

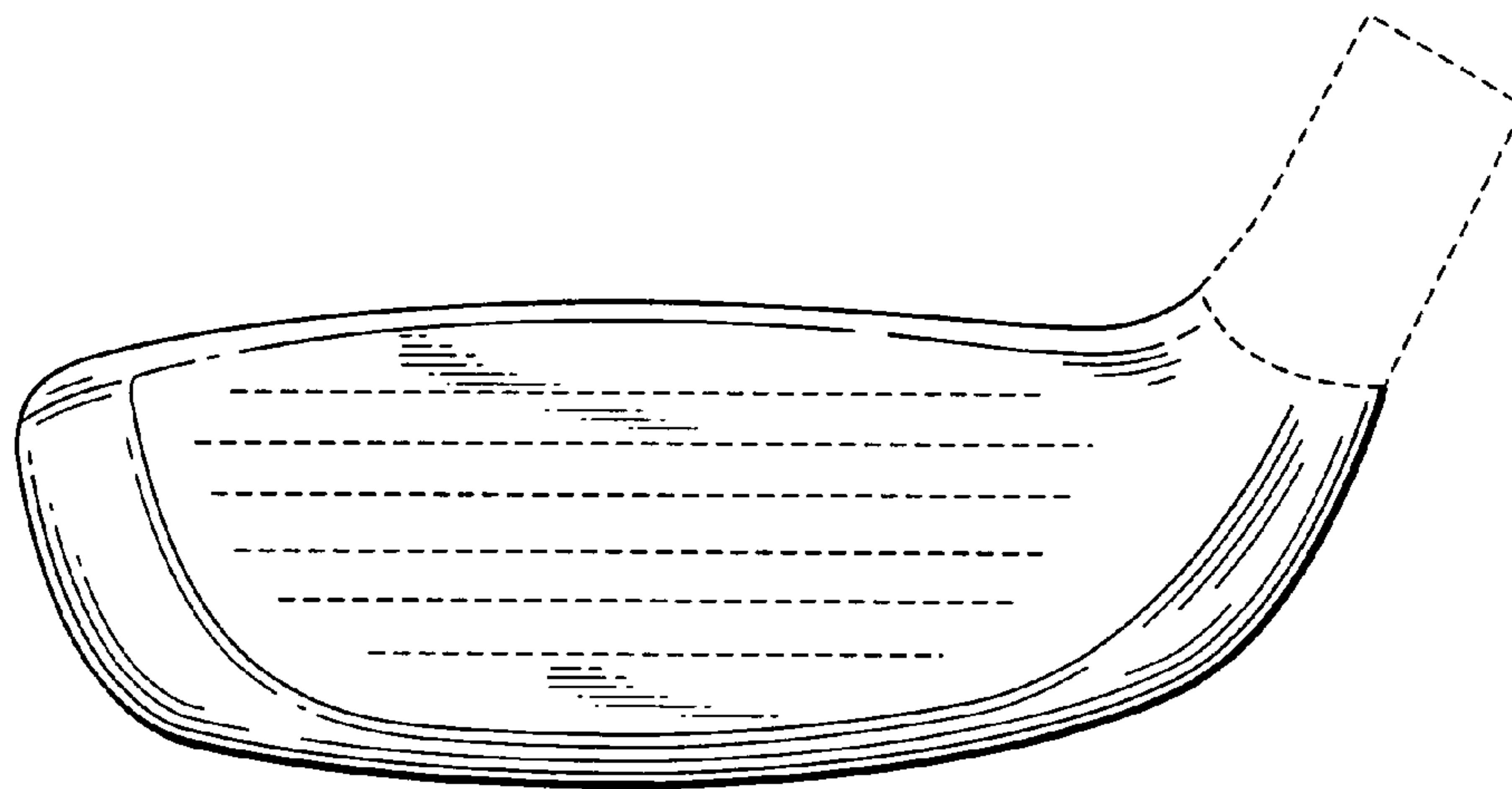

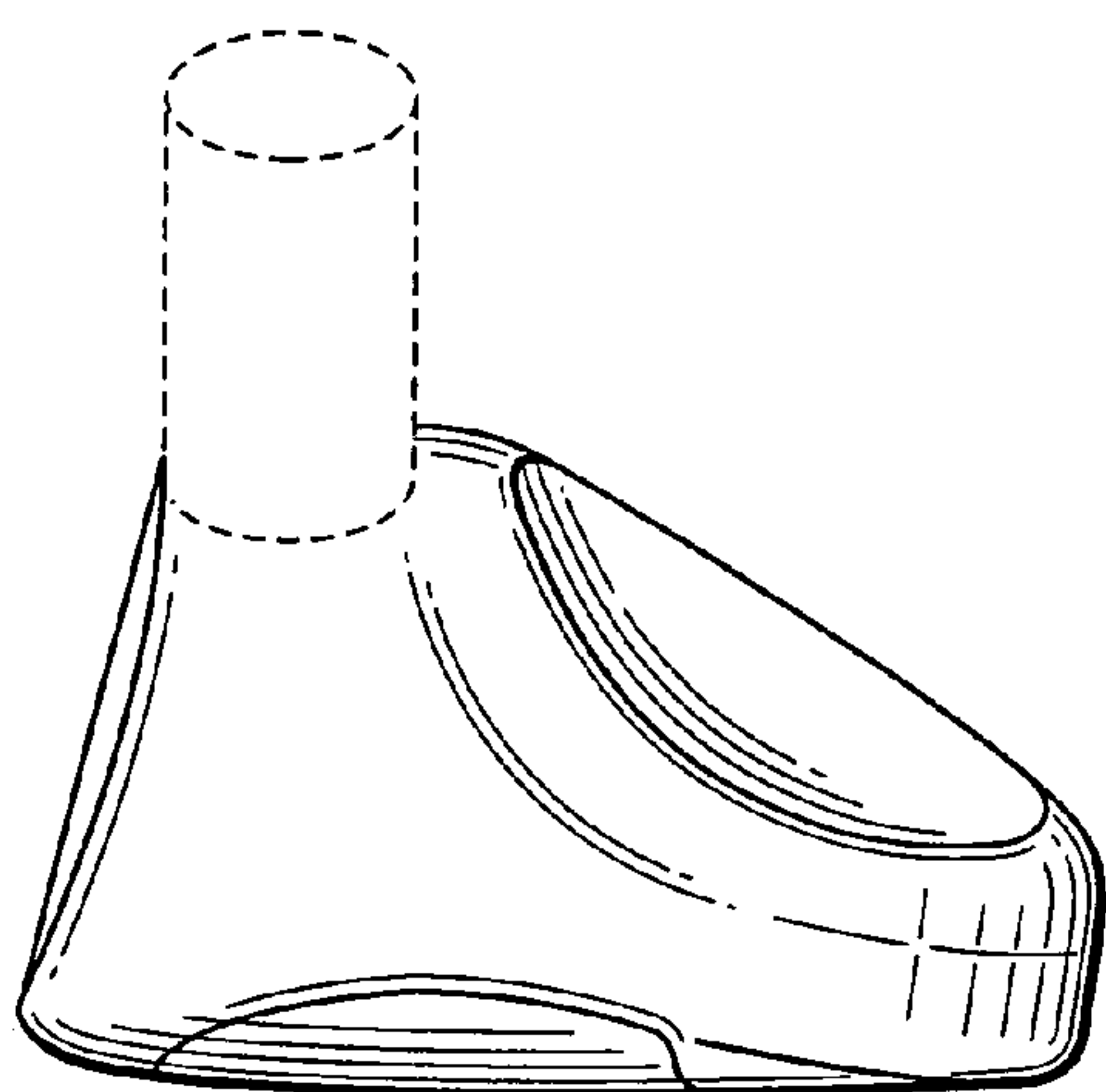

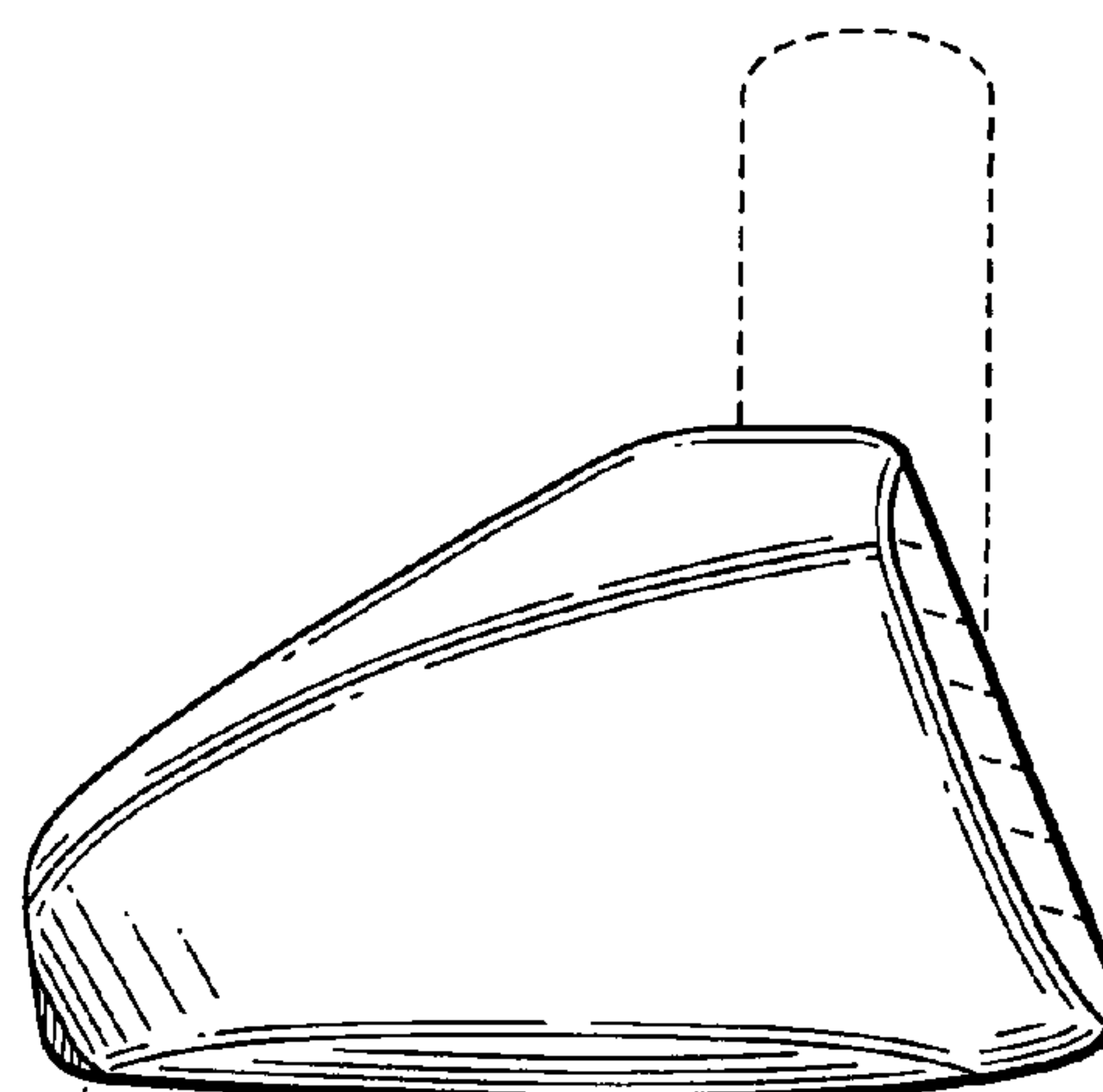

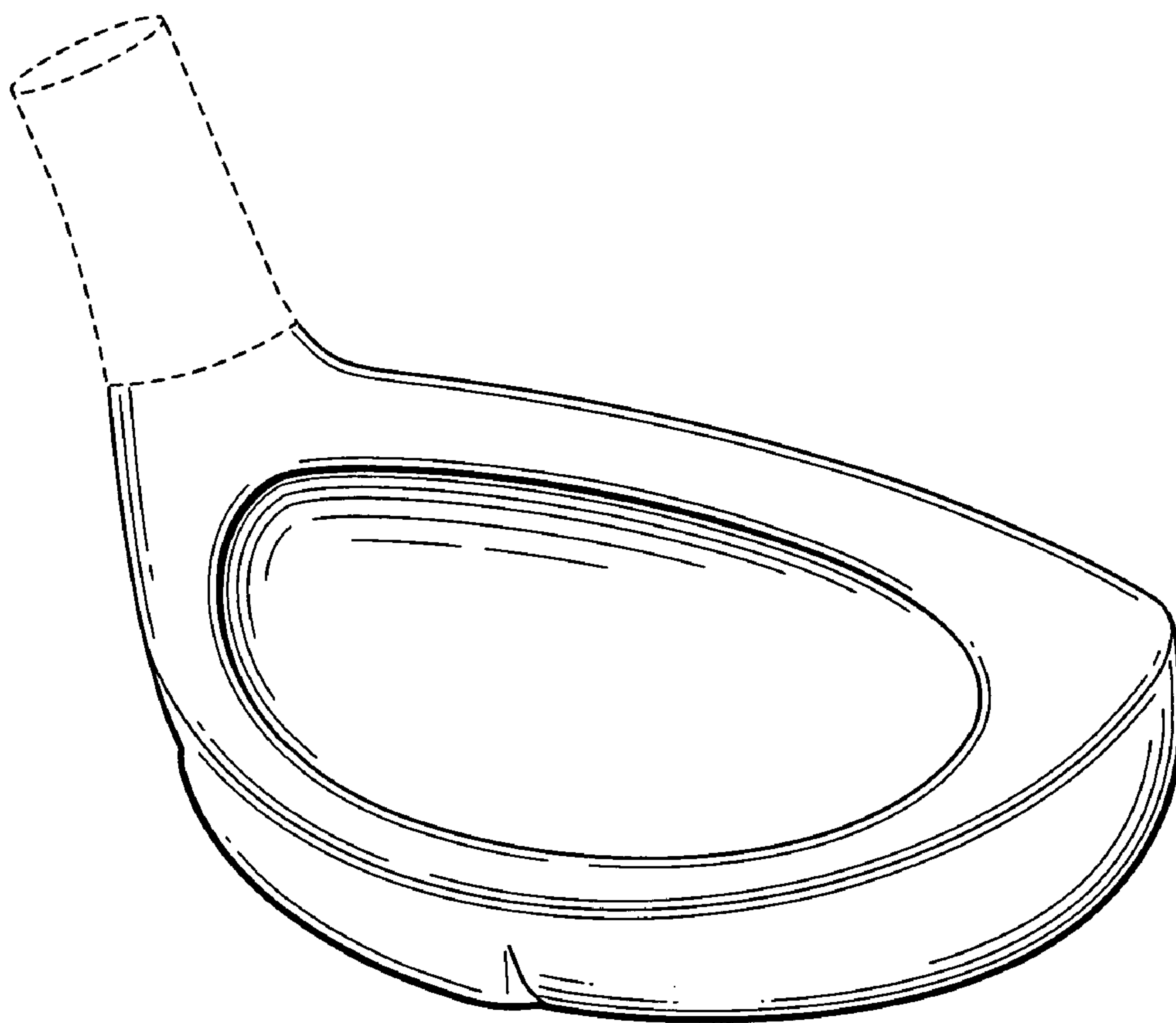

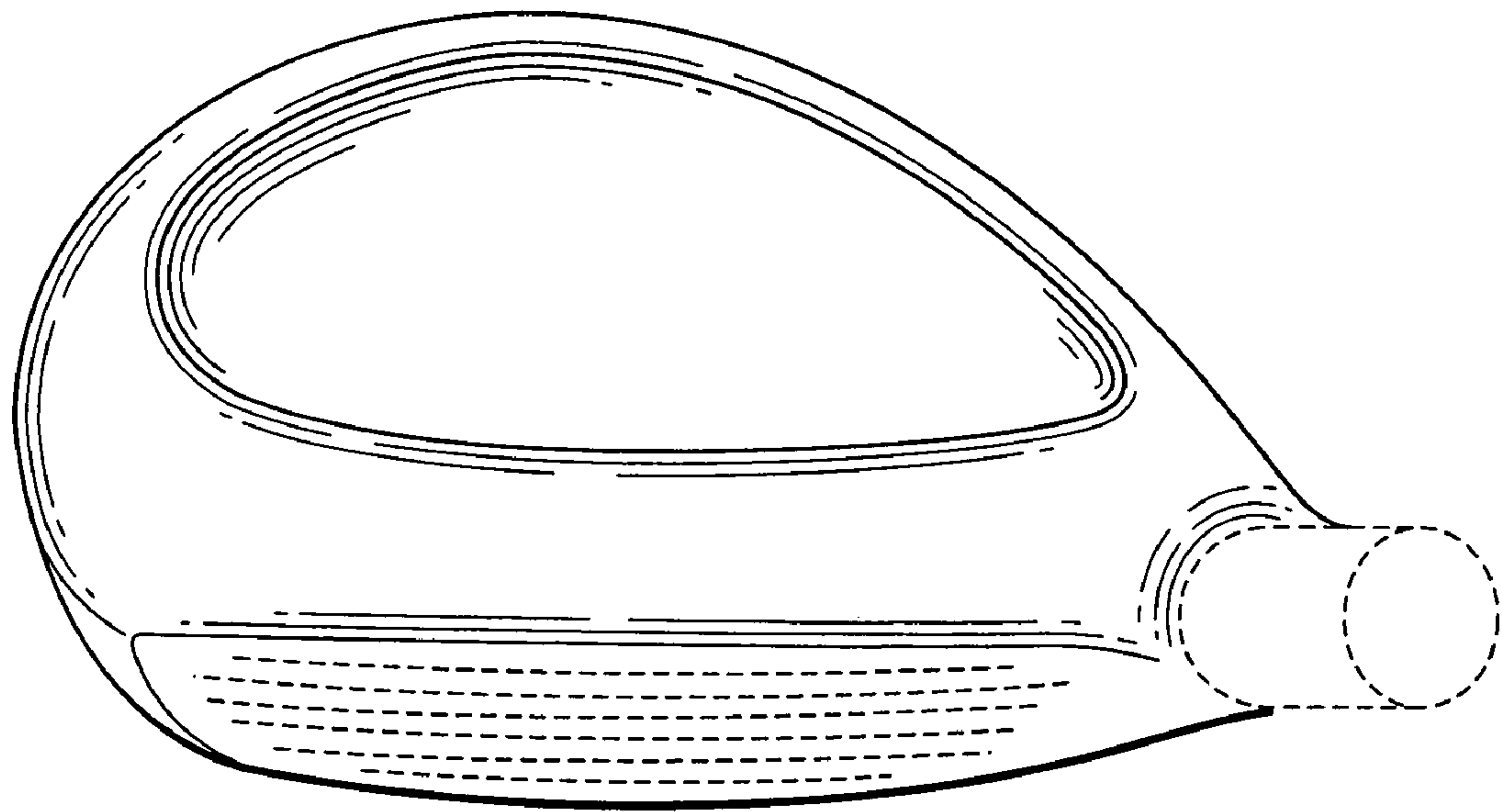
