FIG. 1 is a first perspective view of a golf club head, embodying the inventive design.

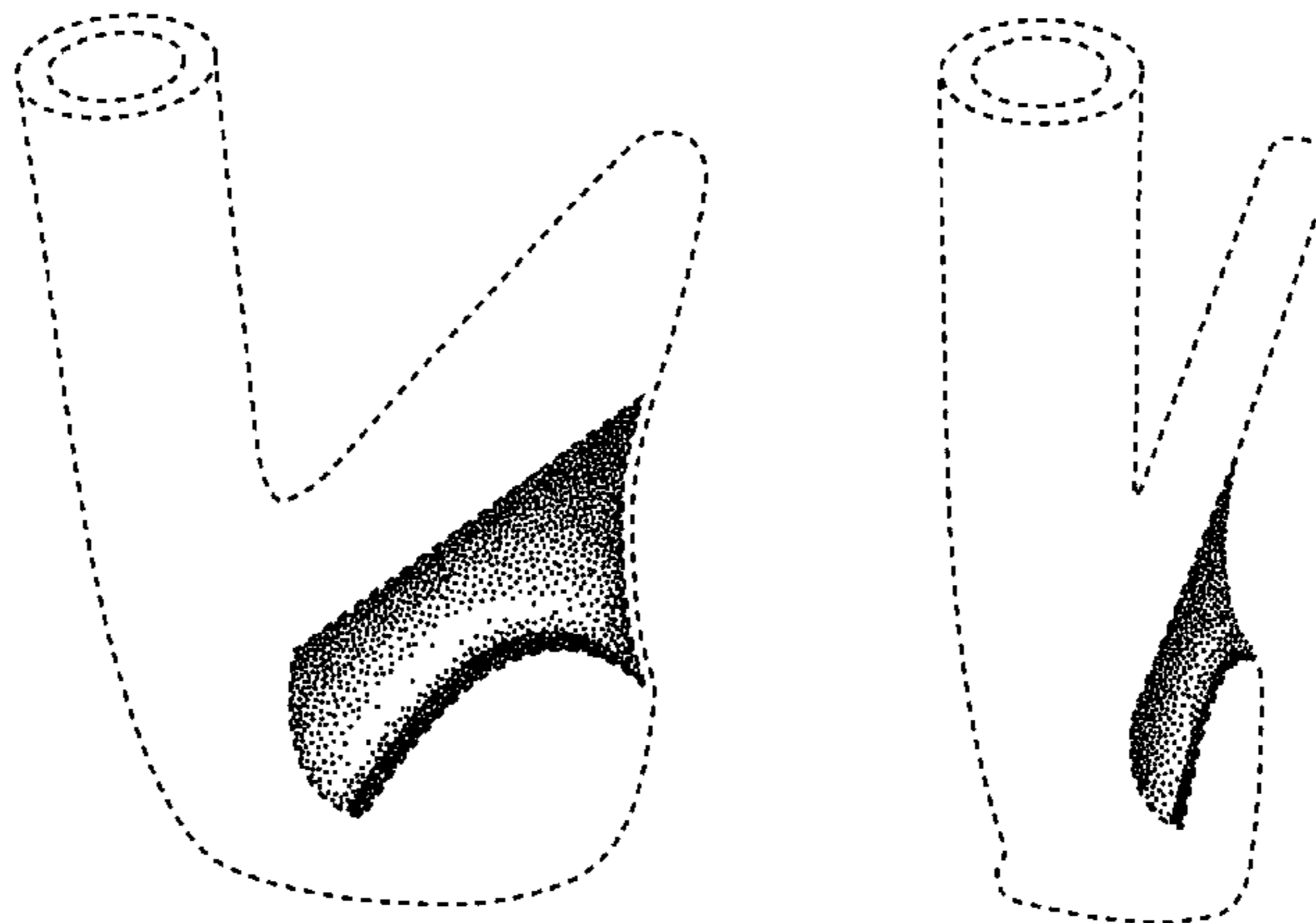
FIG. 2 is a rear elevational view thereof.

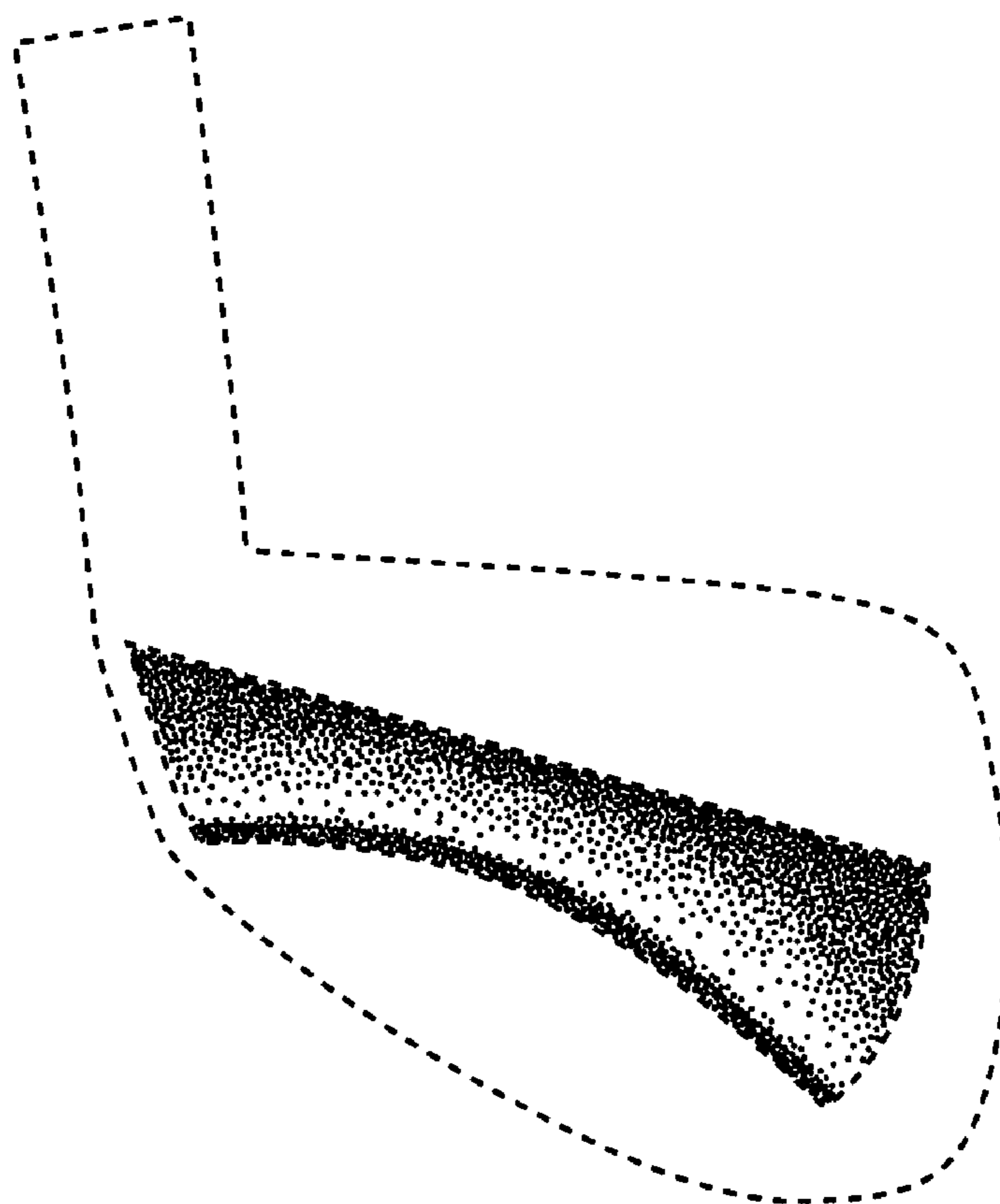

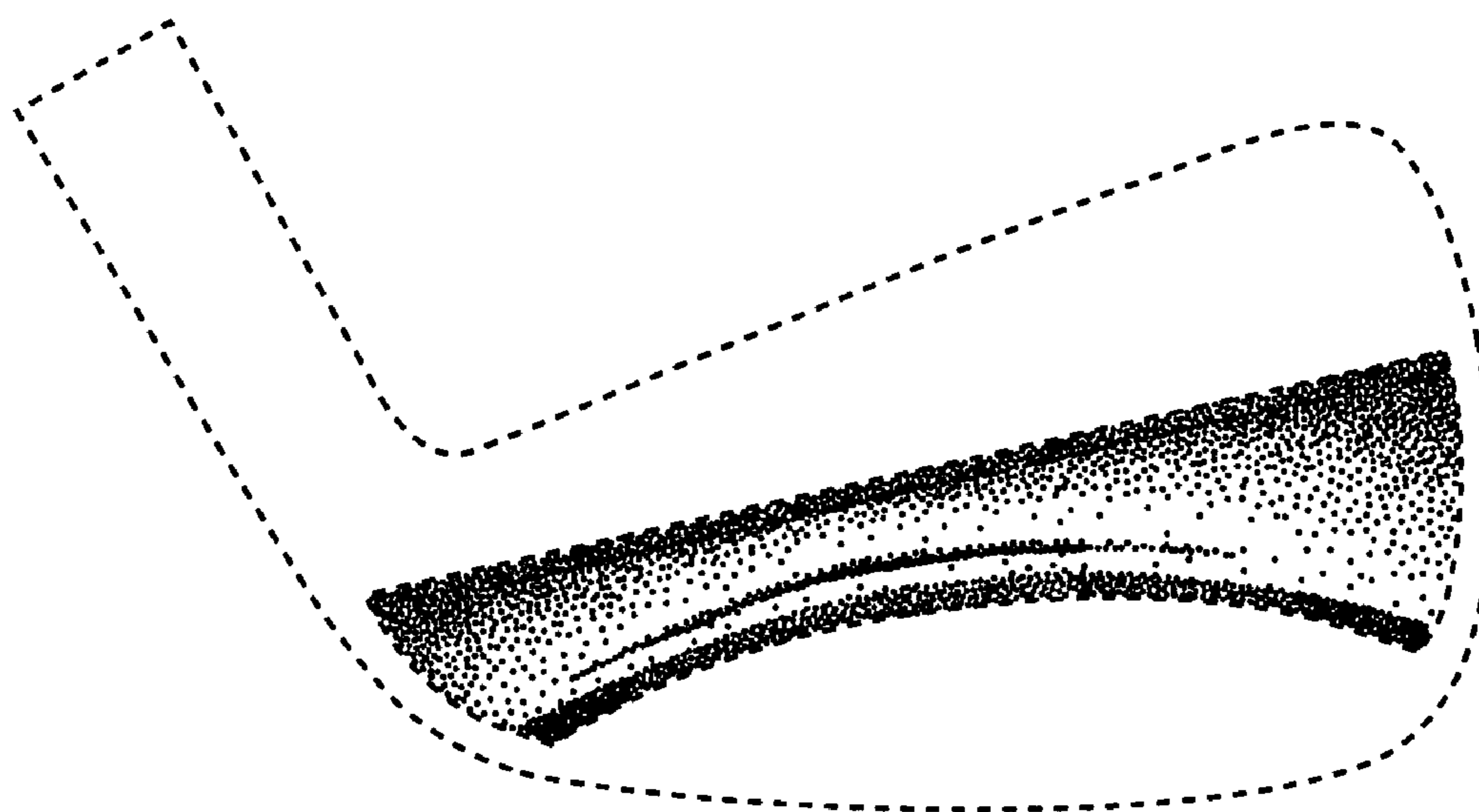

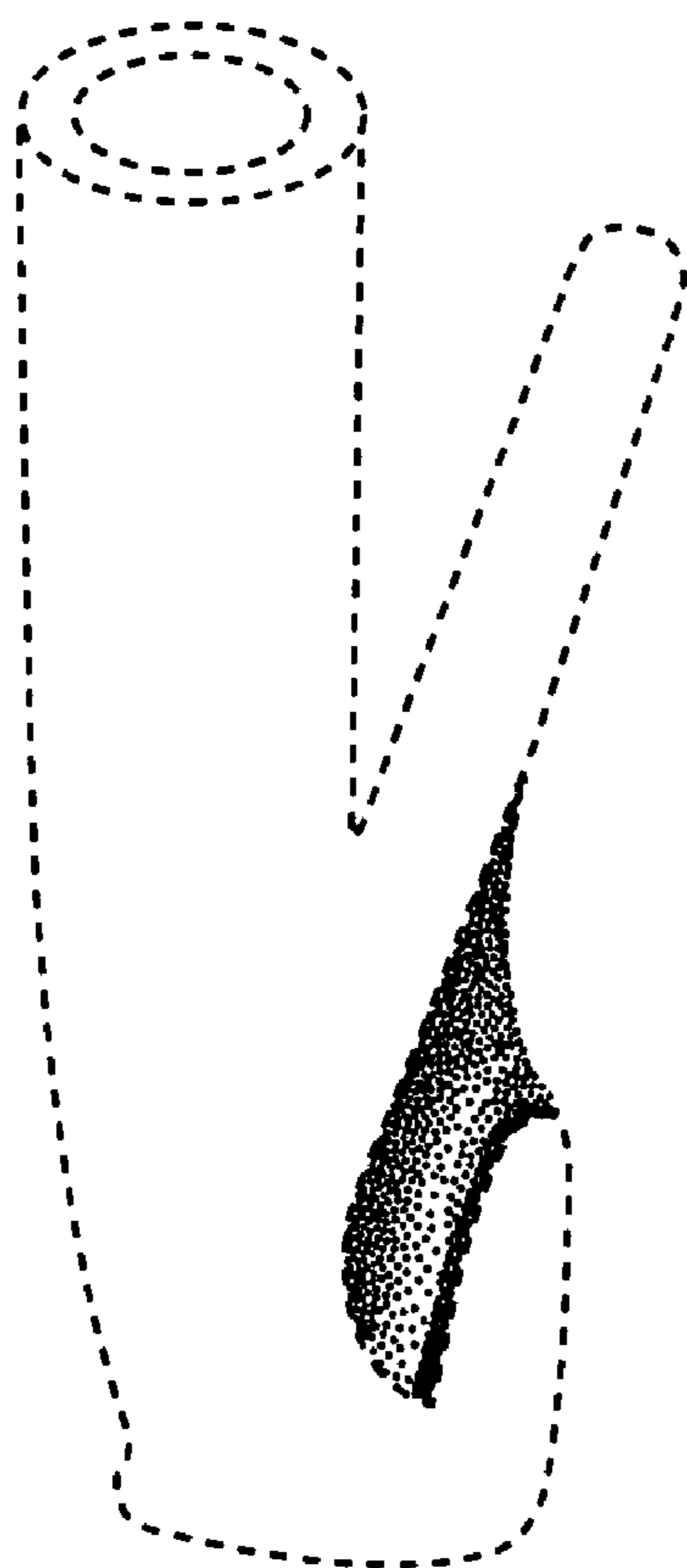
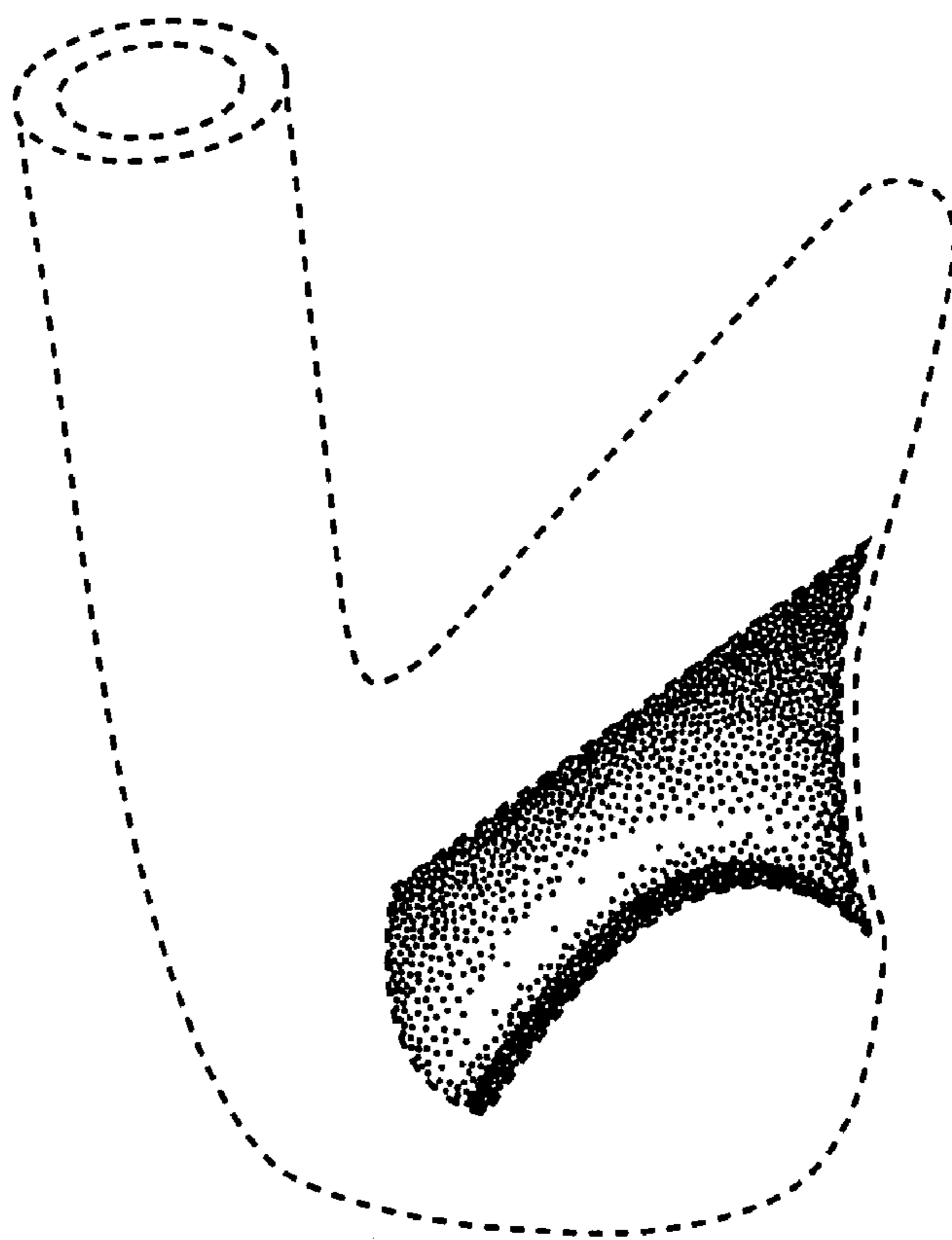
