(57) **CLAIM**

The ornamental design for a scrubbing glove, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a scrubbing glove showing our new design;

FIG. 2 is a left side elevational view thereof;

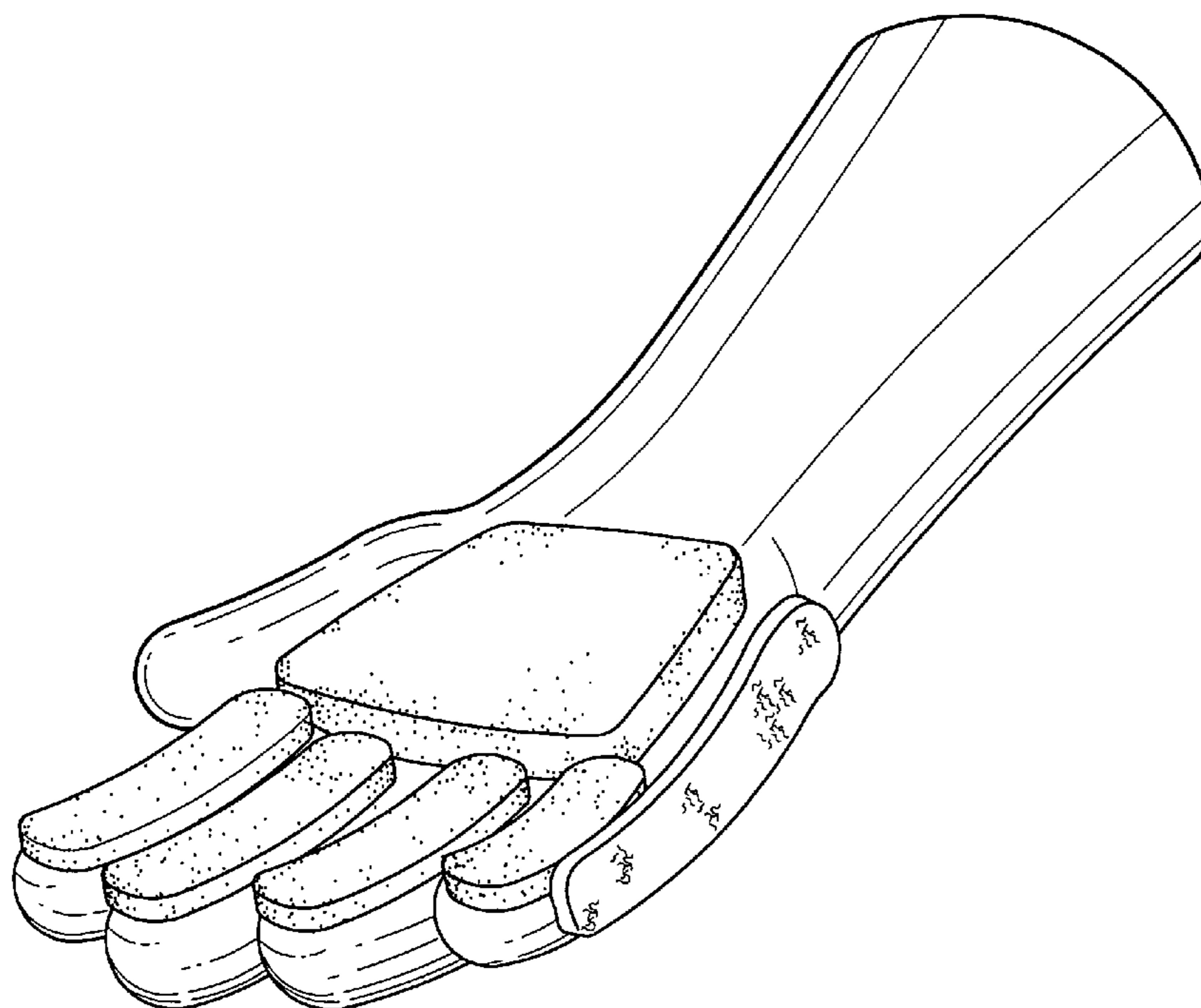

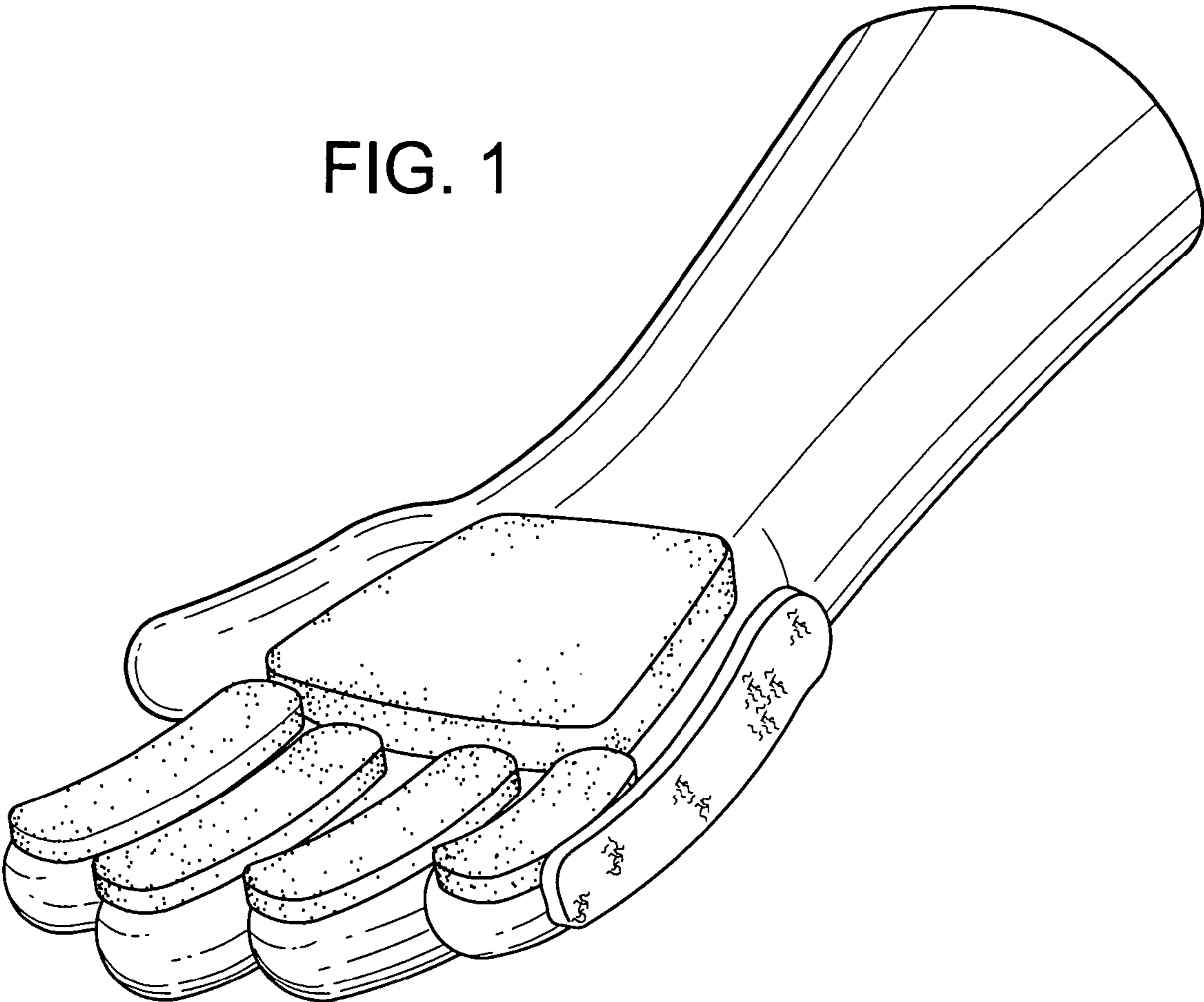

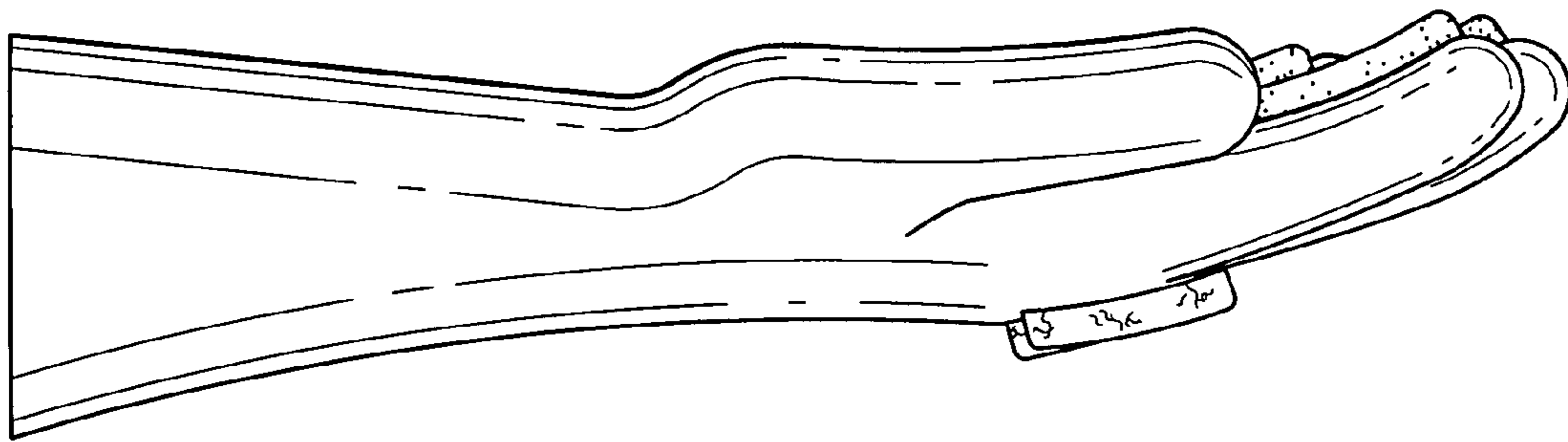

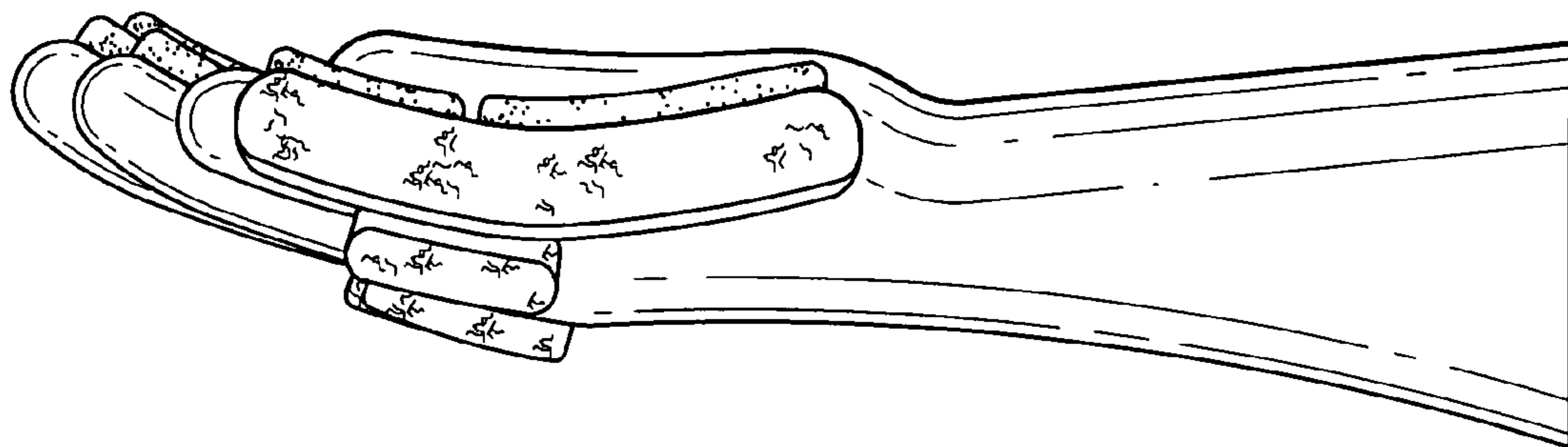

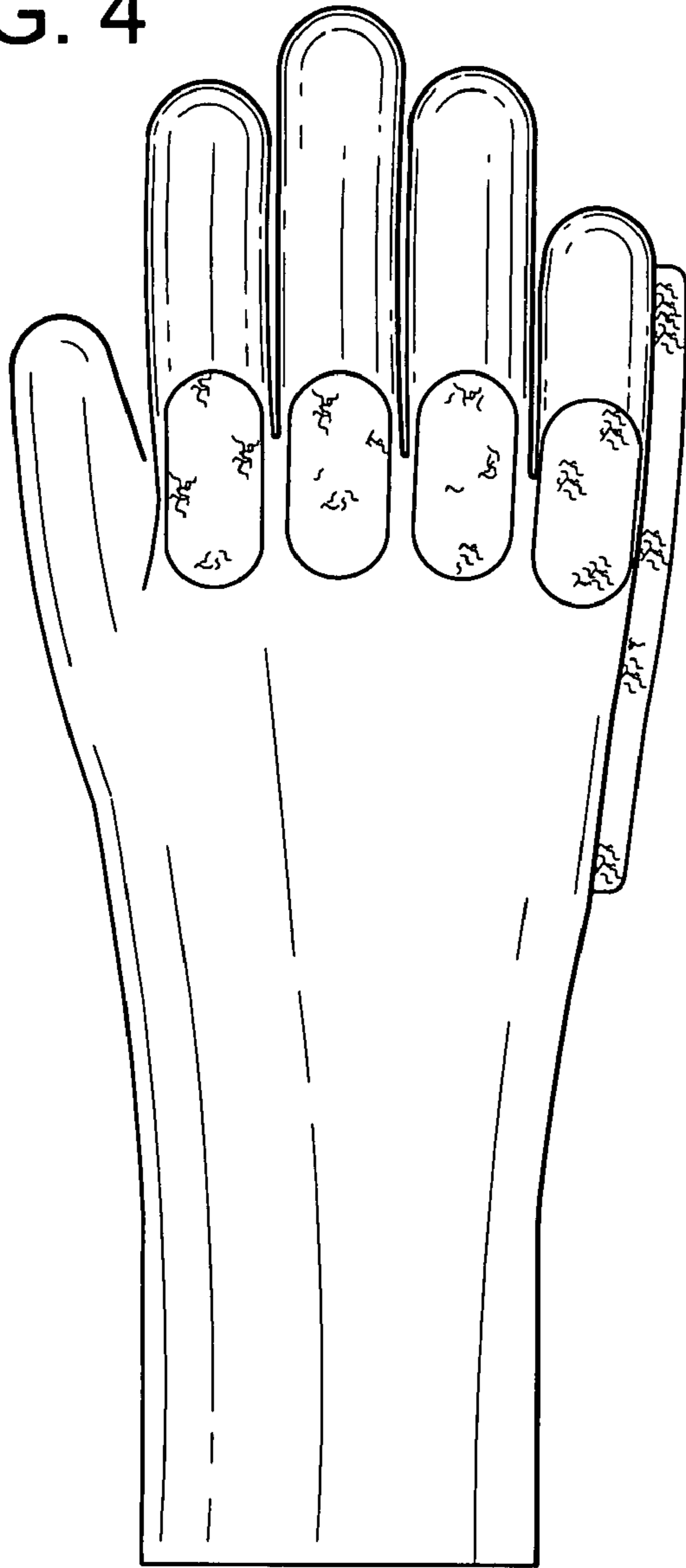

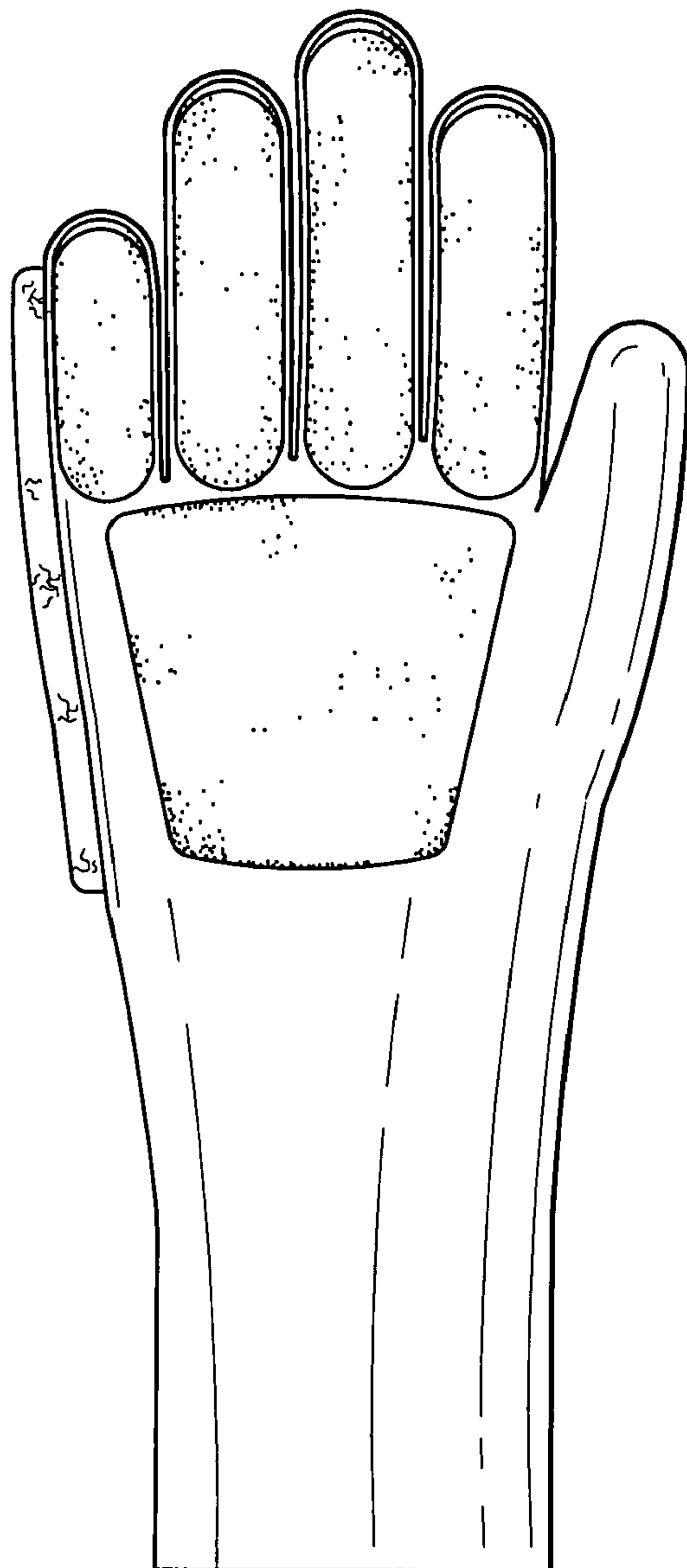

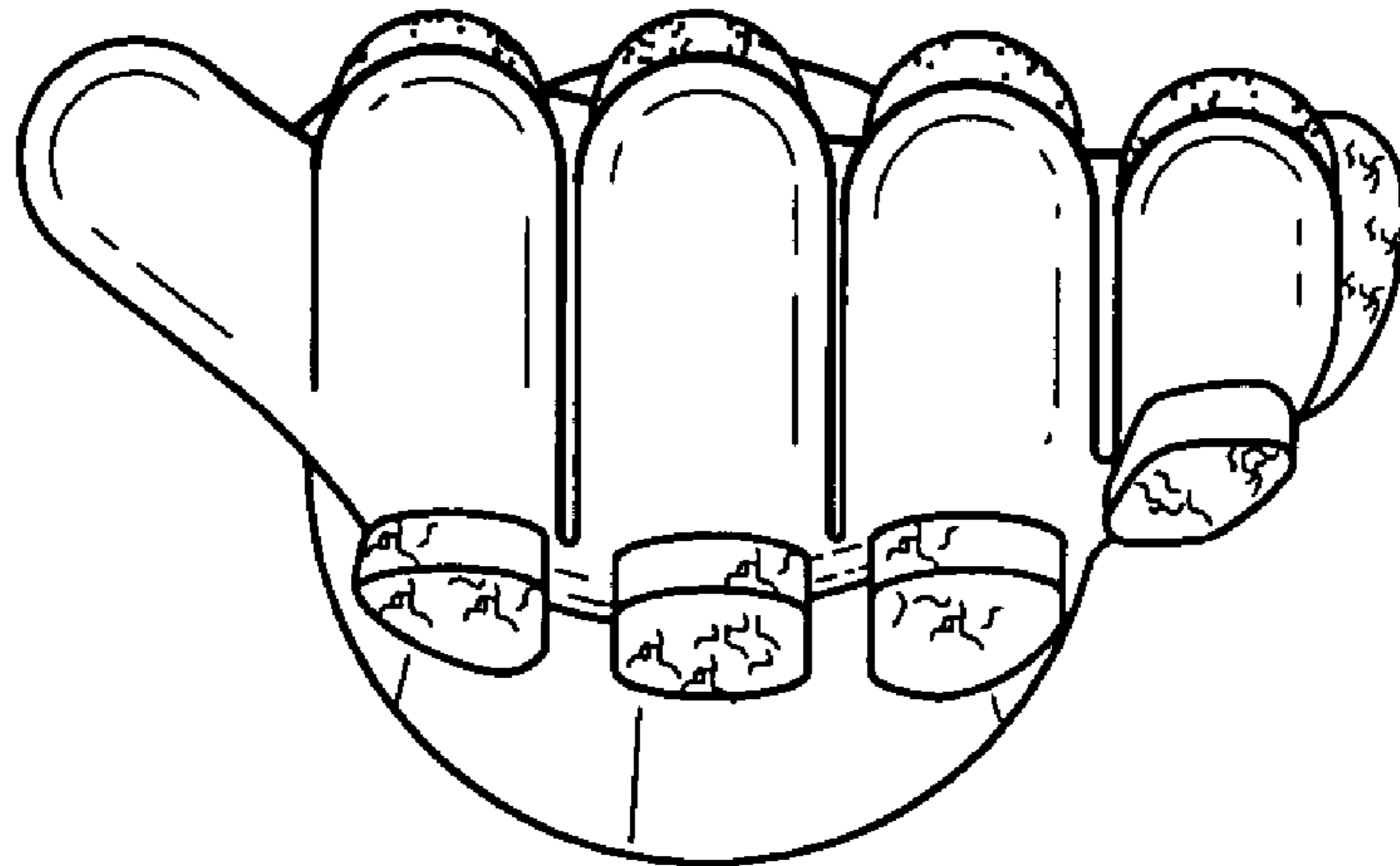
