(57) **CLAIM**

I claim the ornamental design for a pants pocket, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pants pocket showing my new design;

FIG. 16 is a bottom plan view thereof;

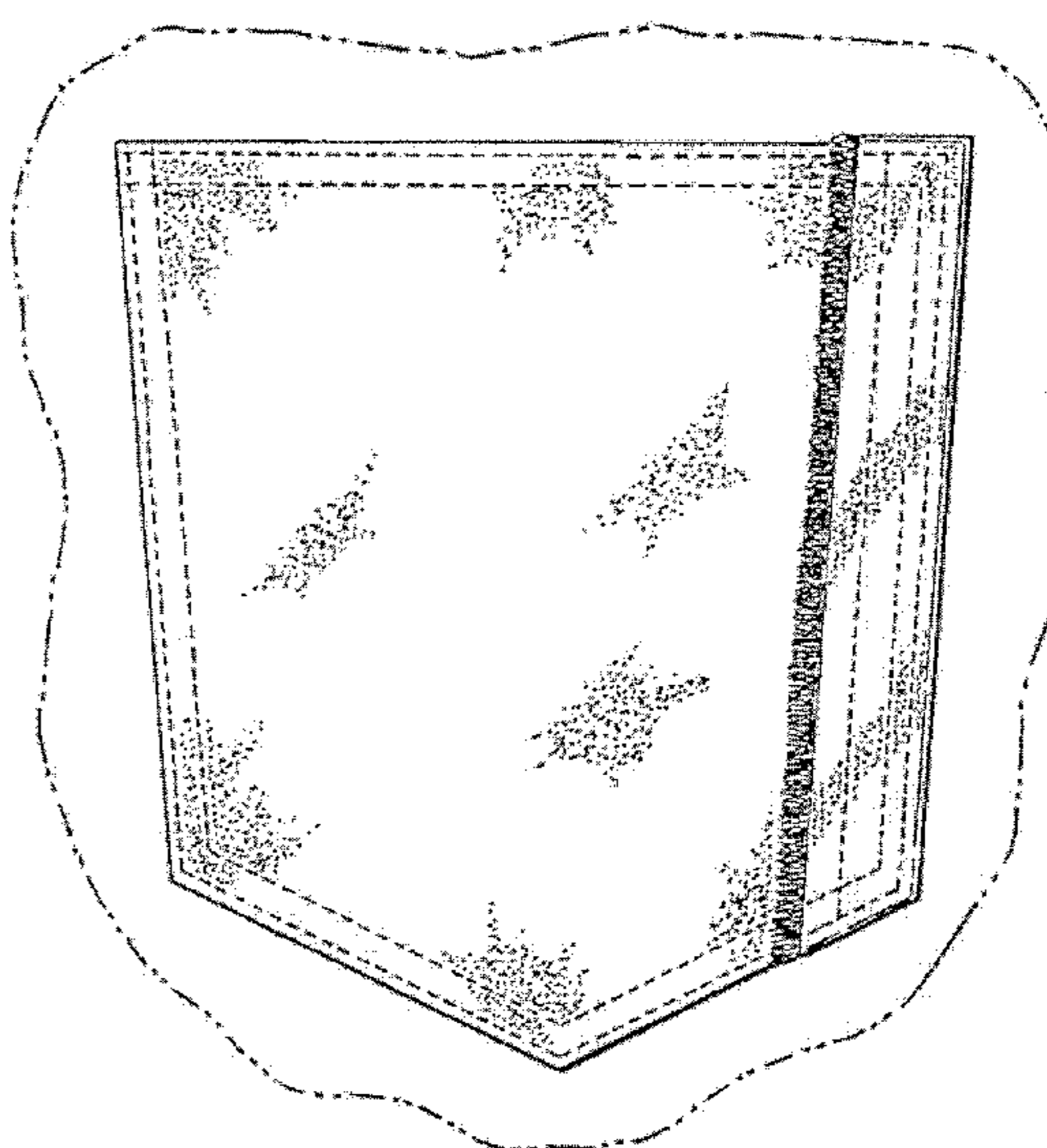
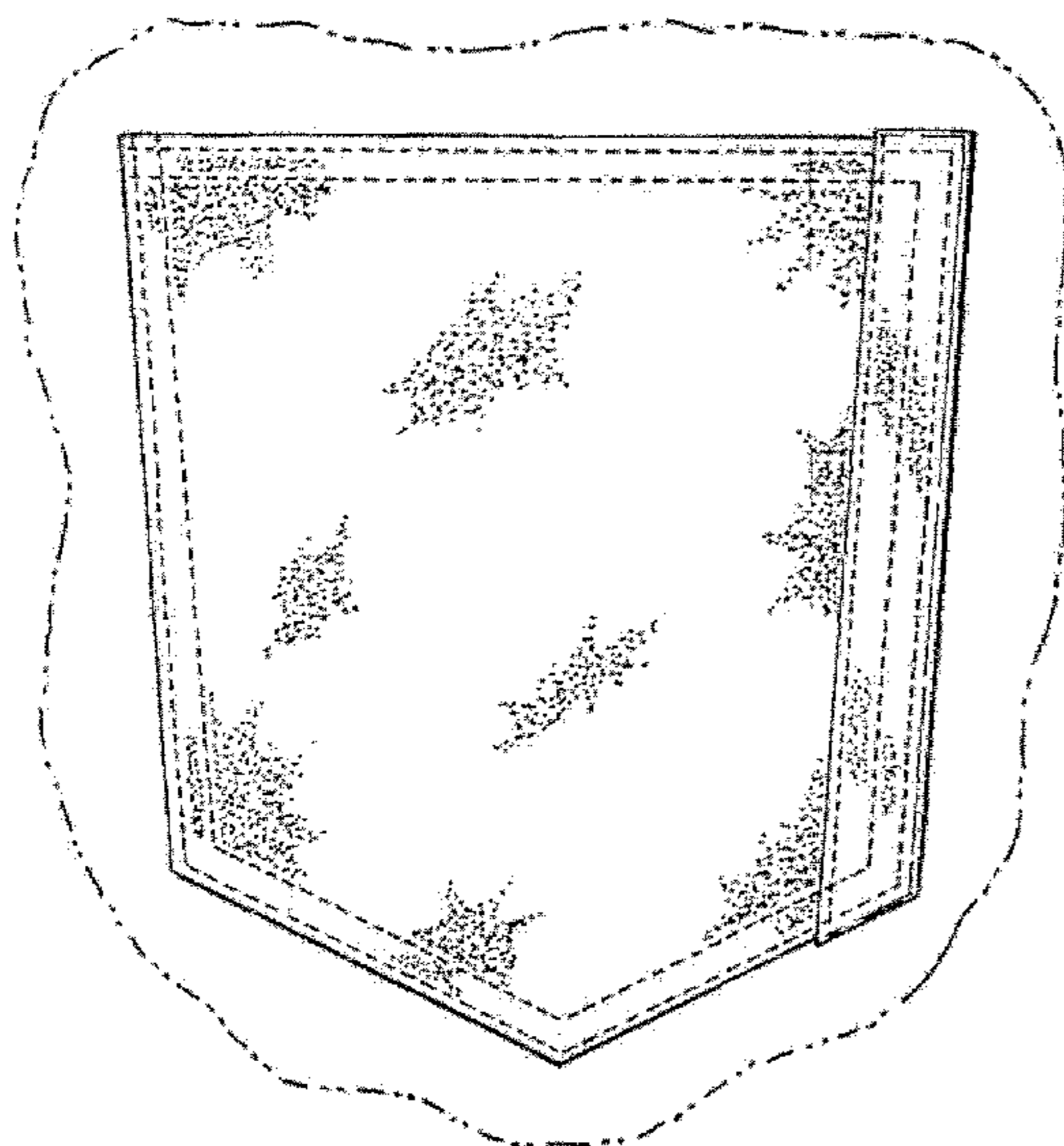
FIG. 17 is a left side elevational view thereof; and,

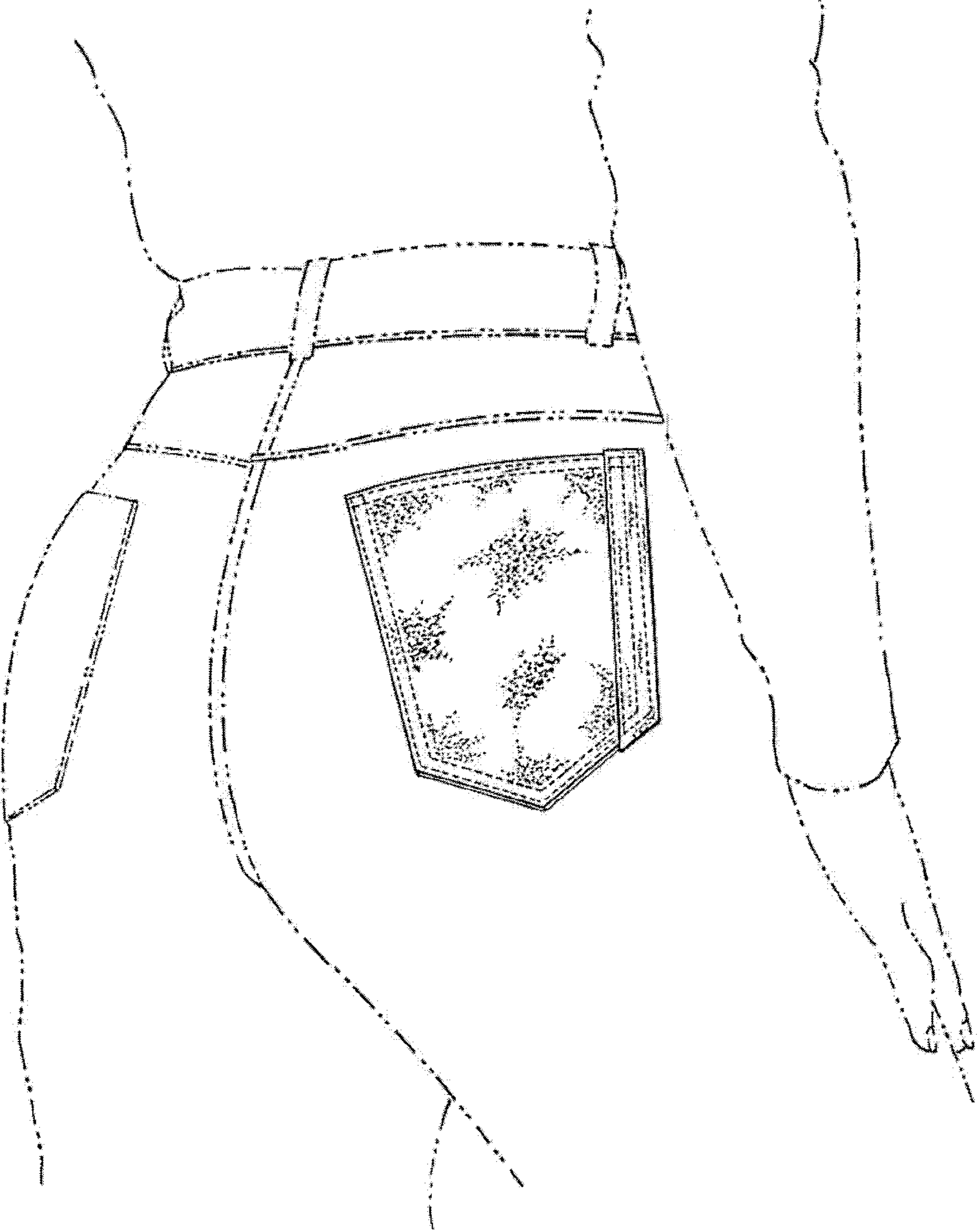

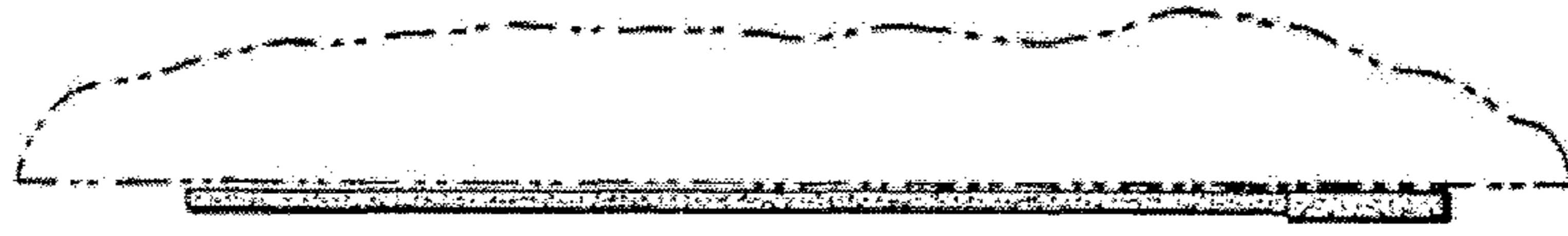

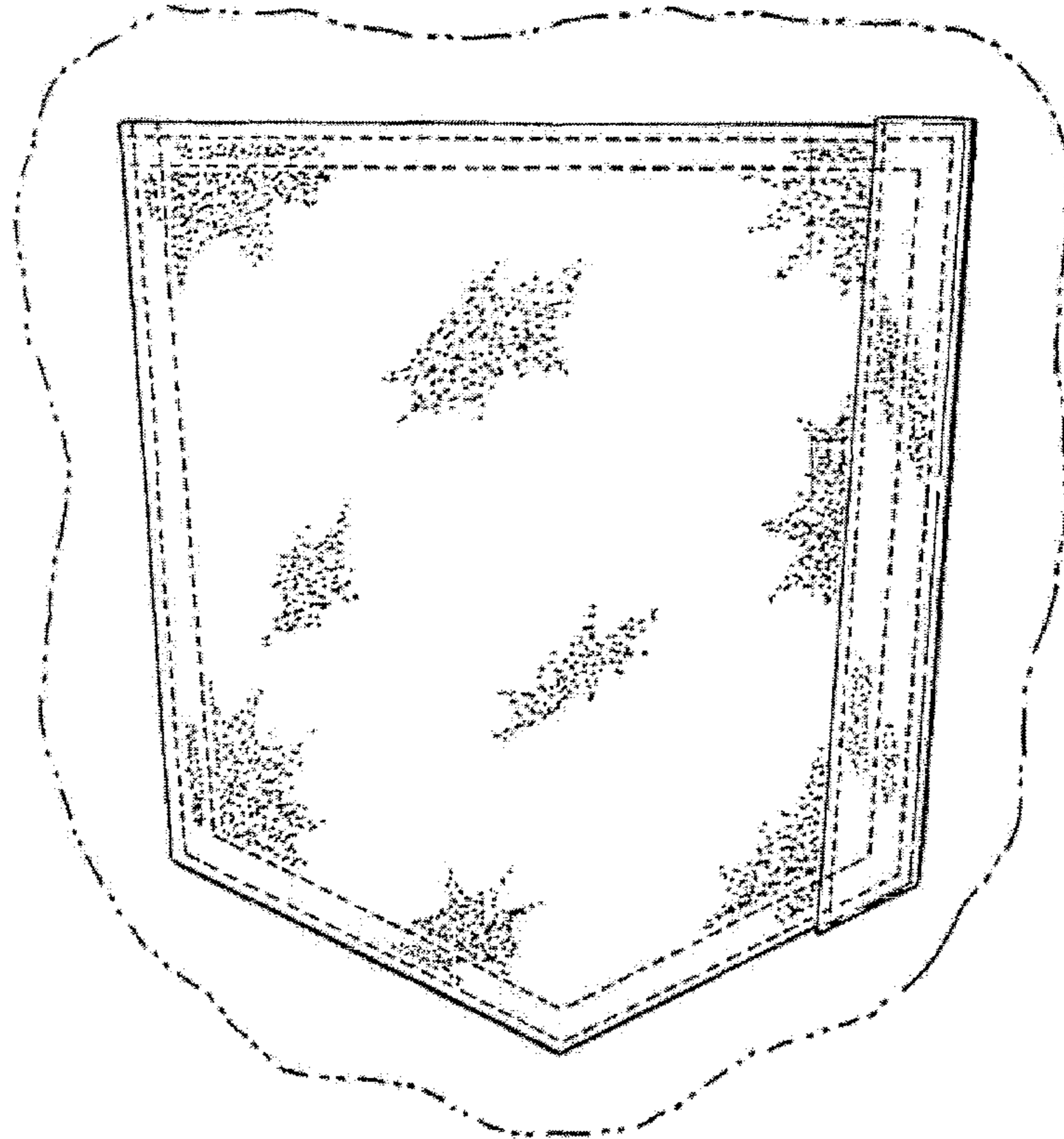

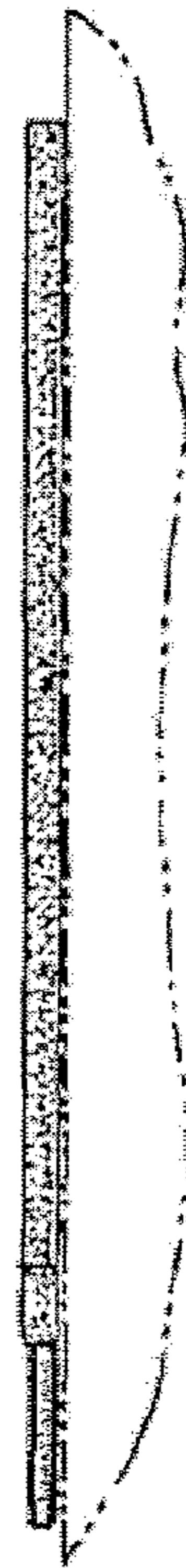

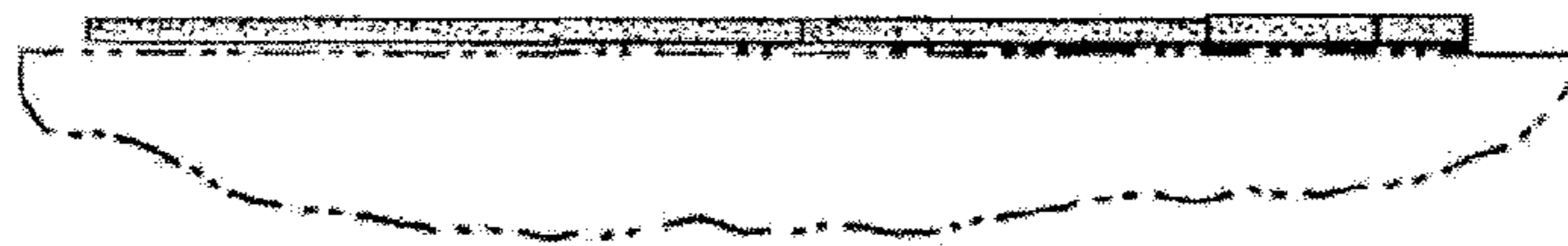

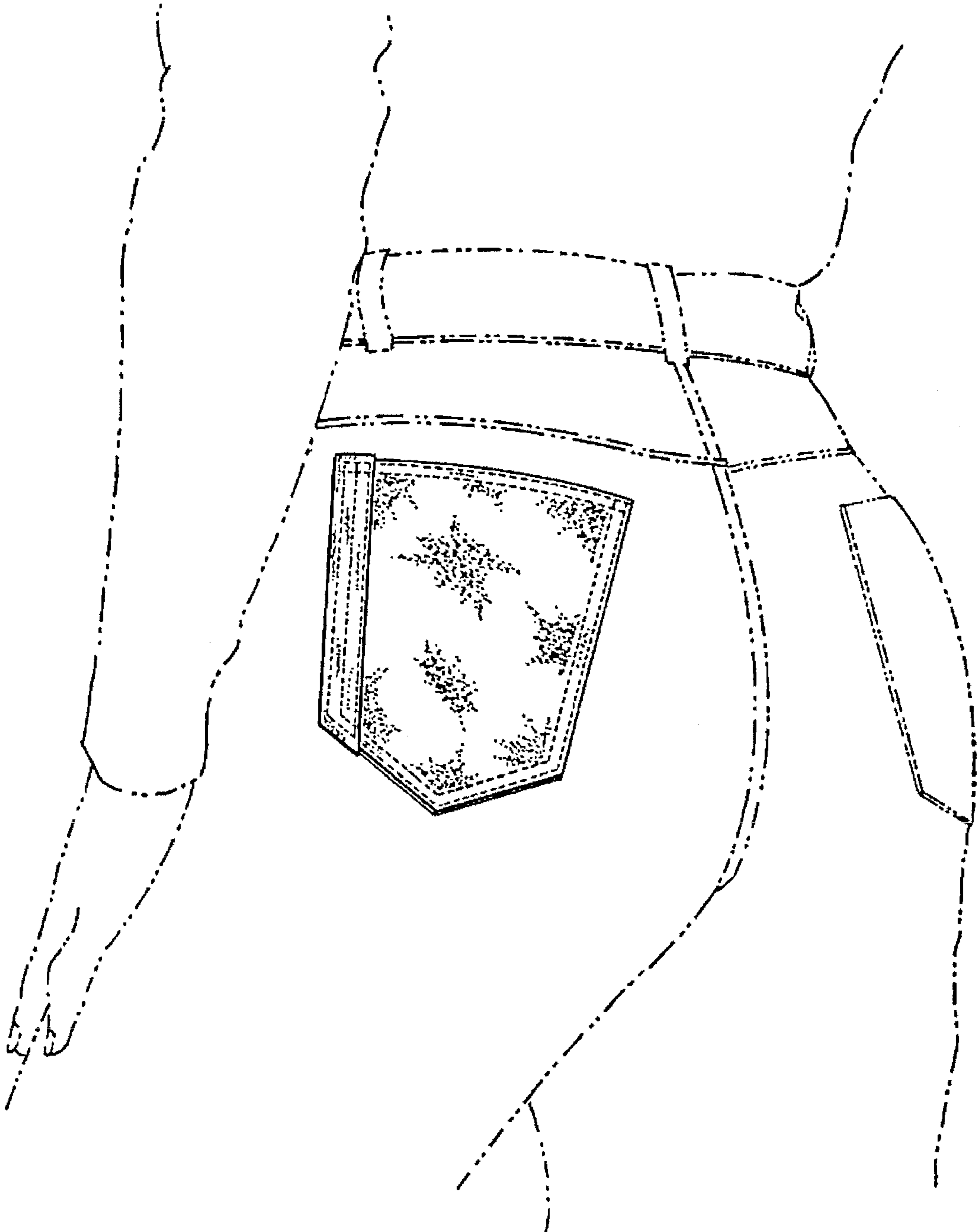

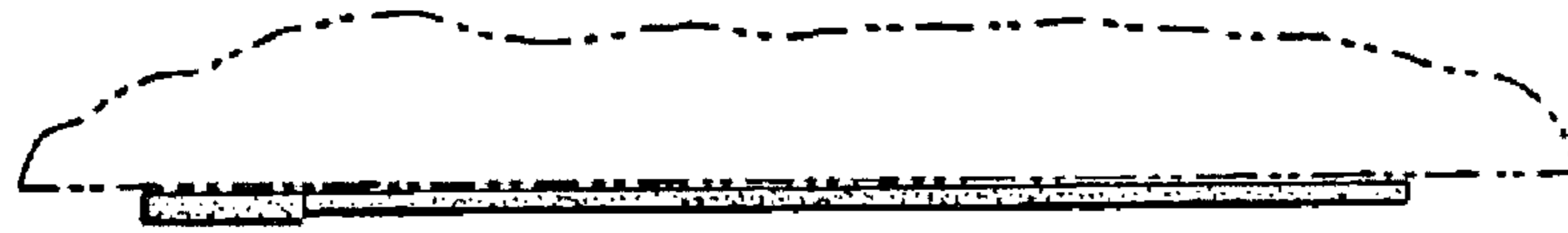

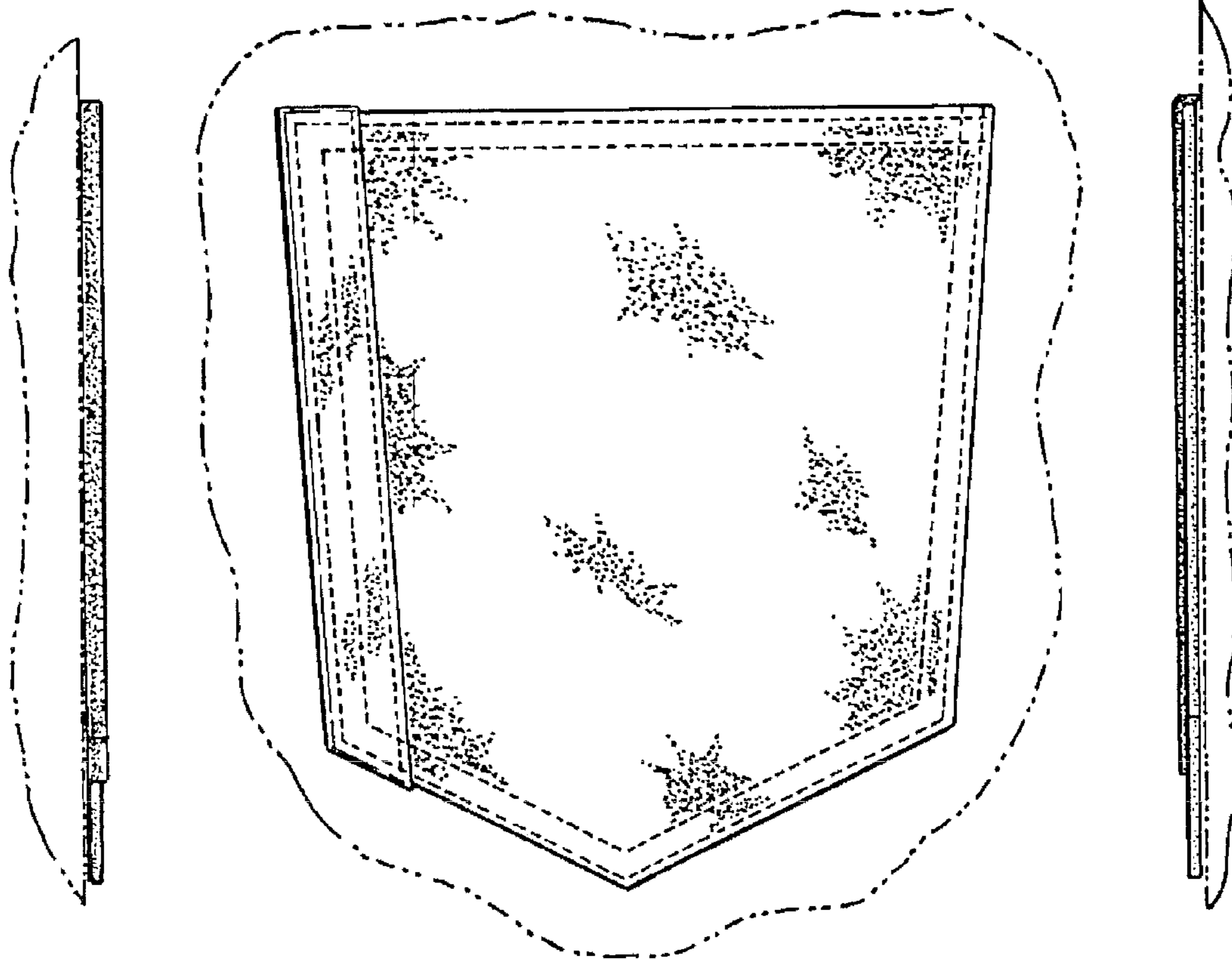

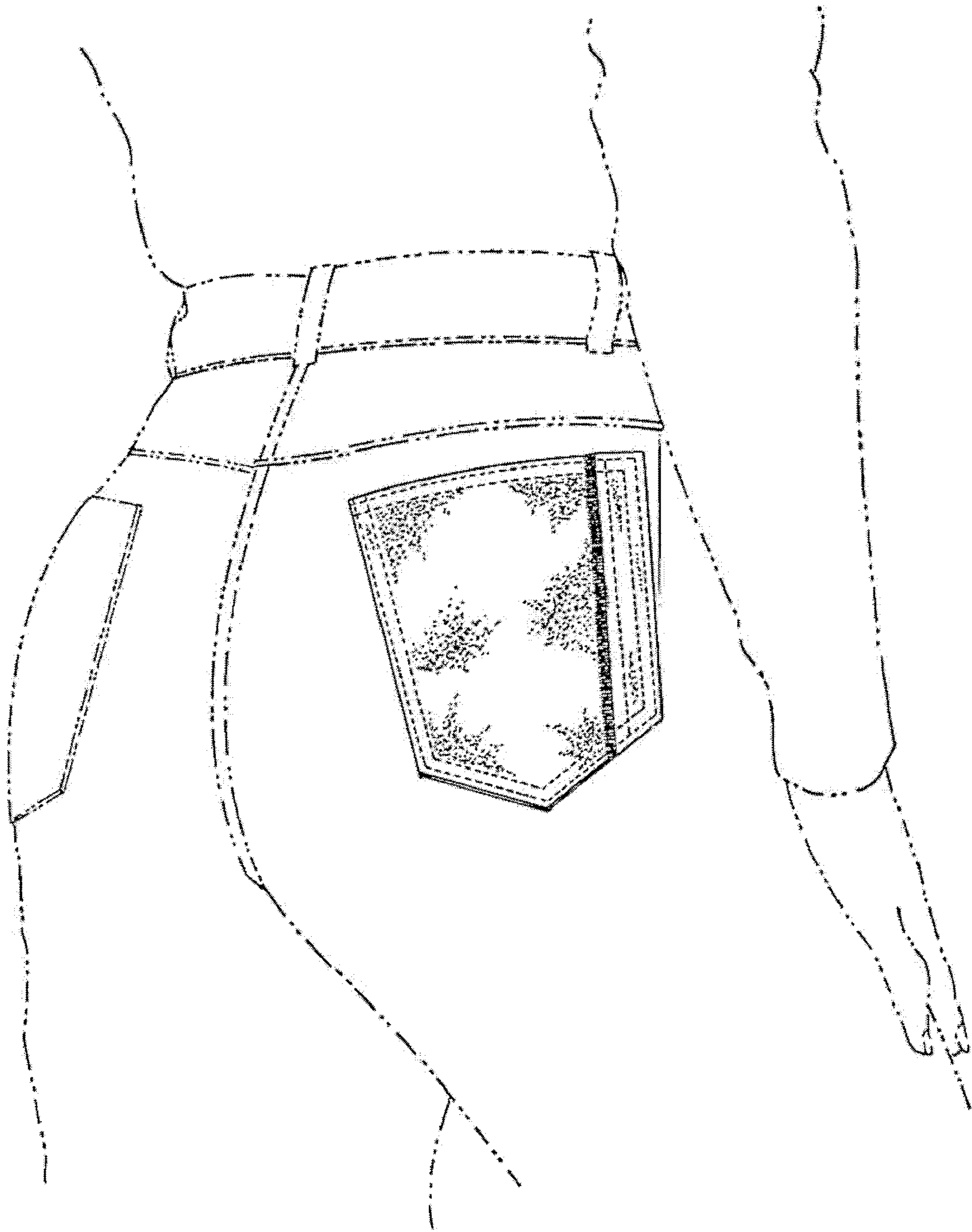

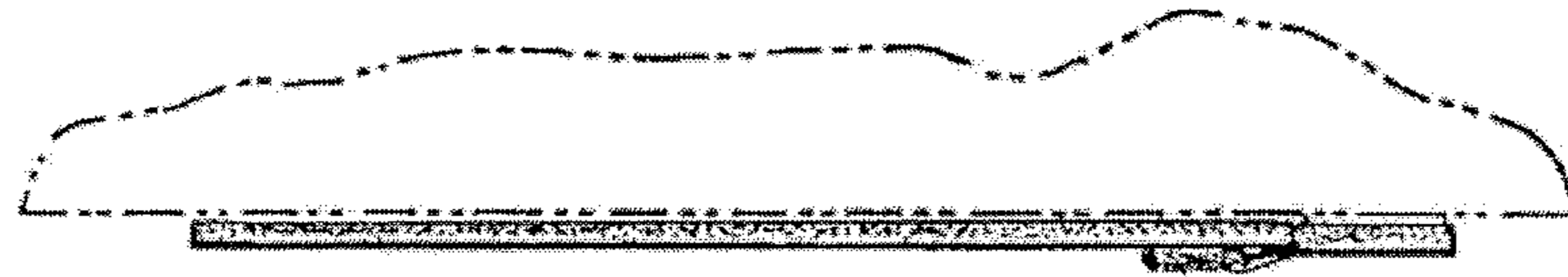

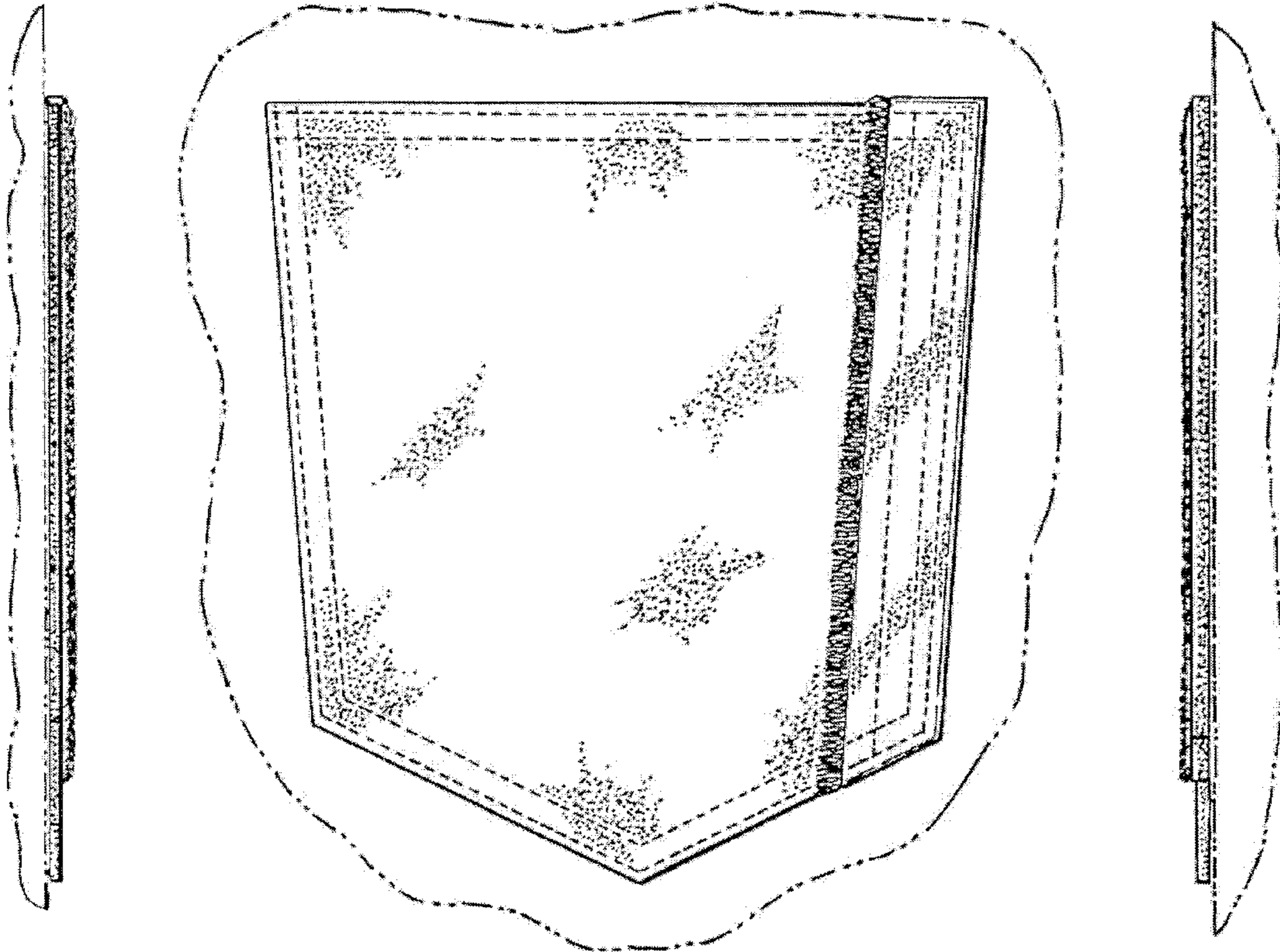

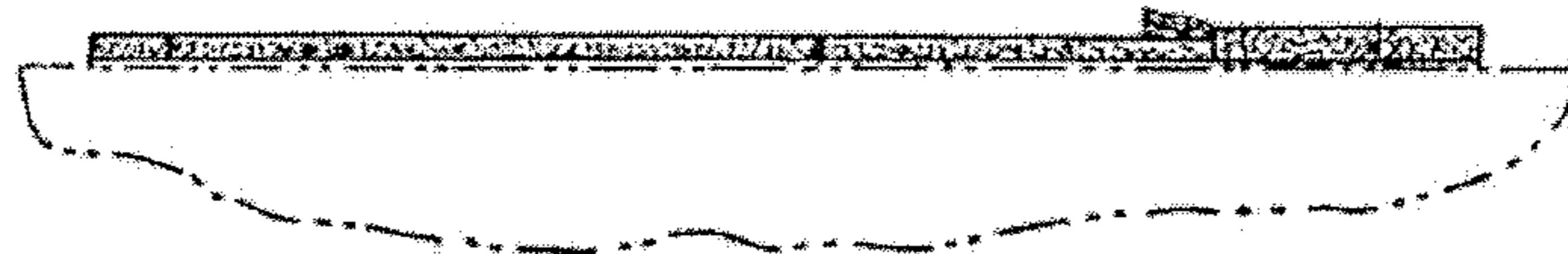
