I claim the ornamental design for a footwear insole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a footwear insole, showing my new design;

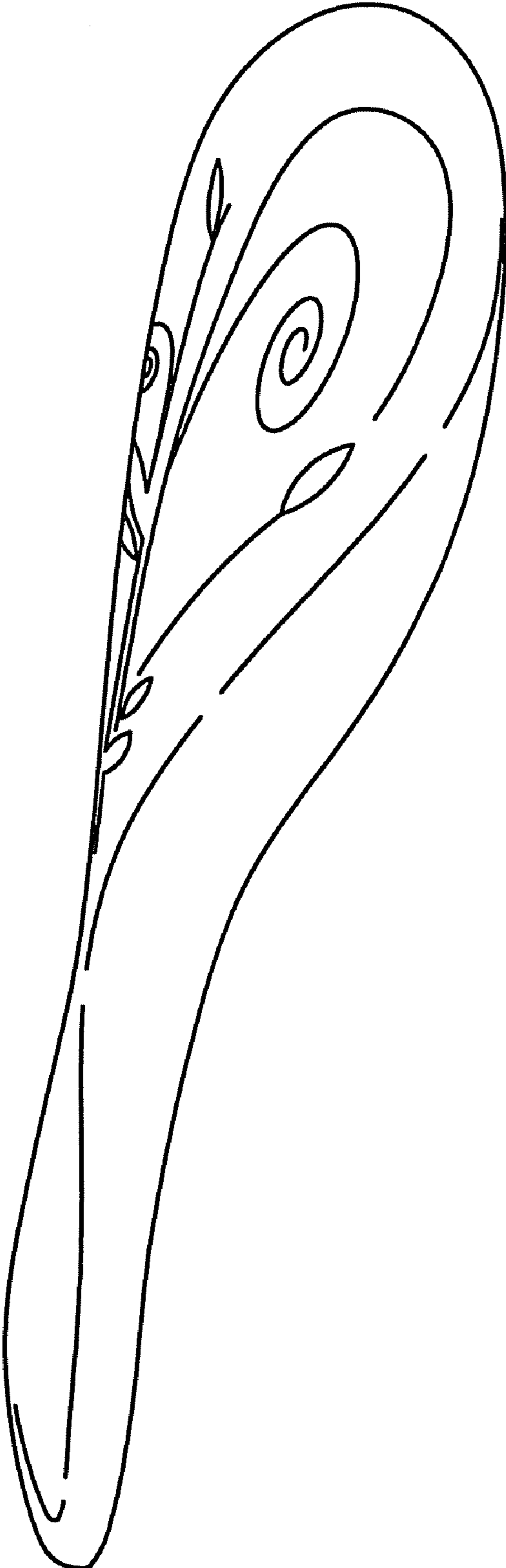

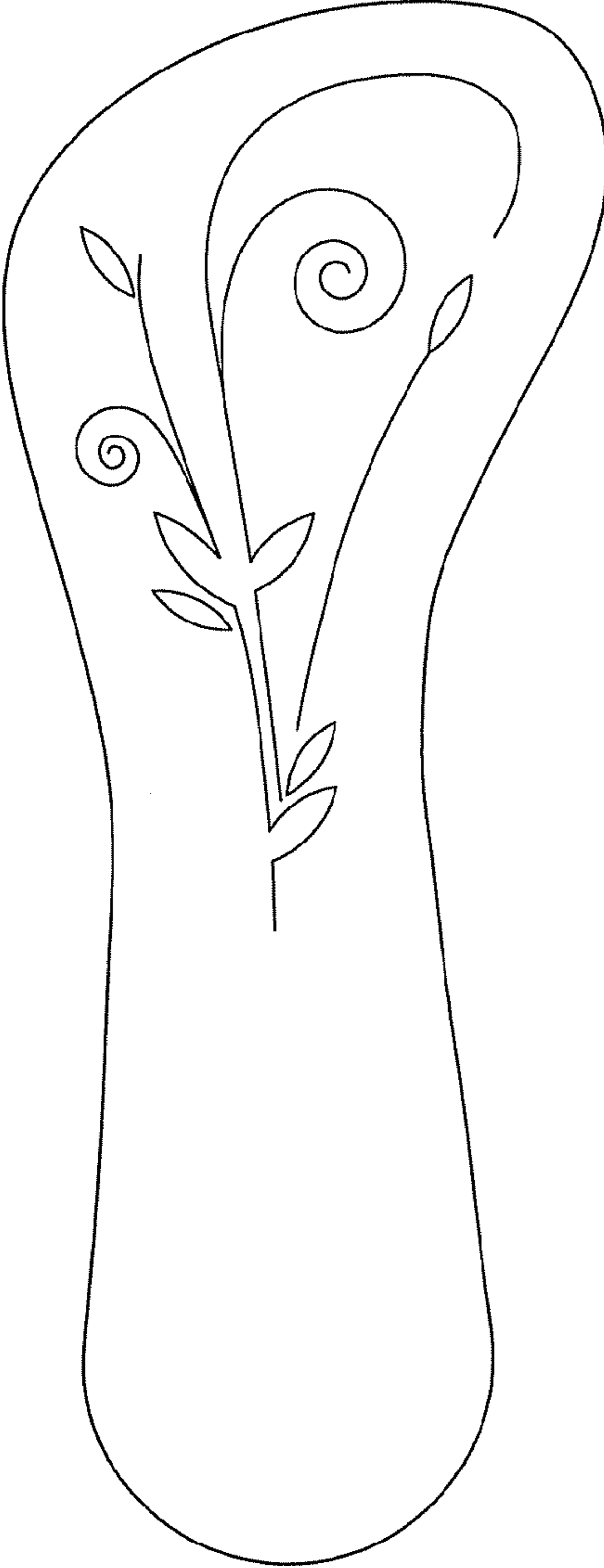

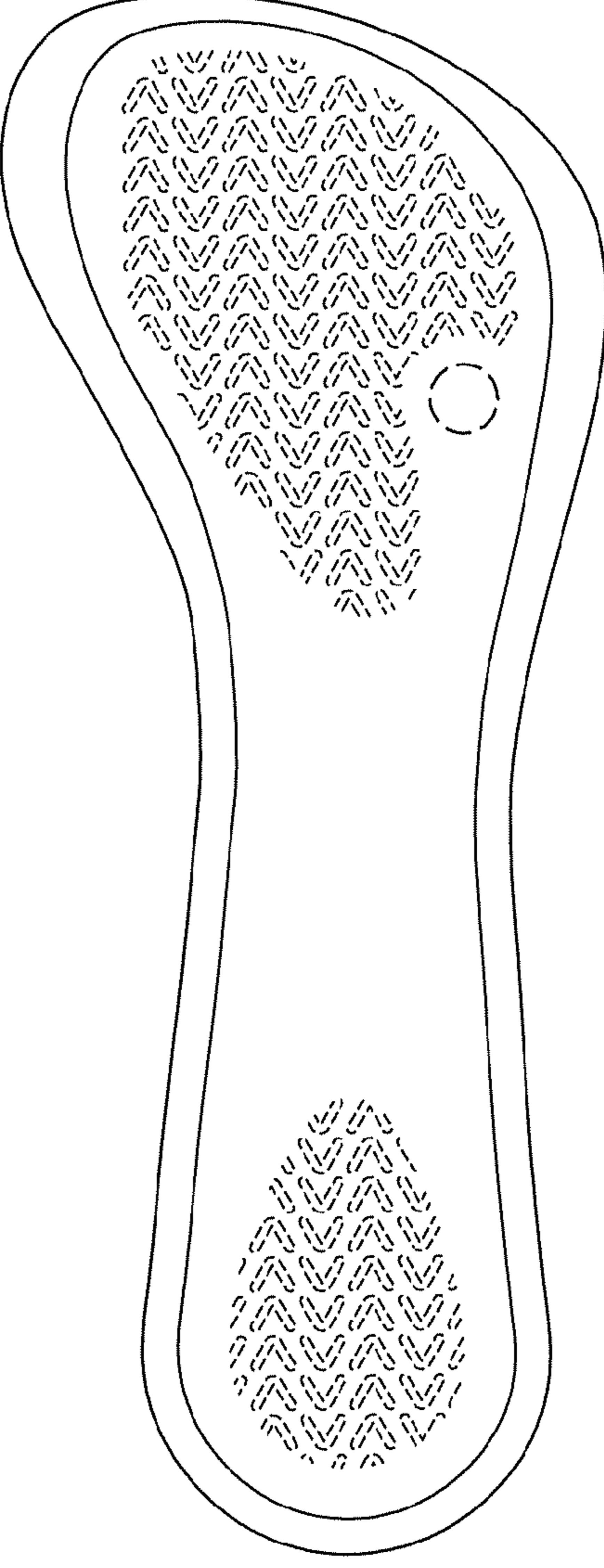

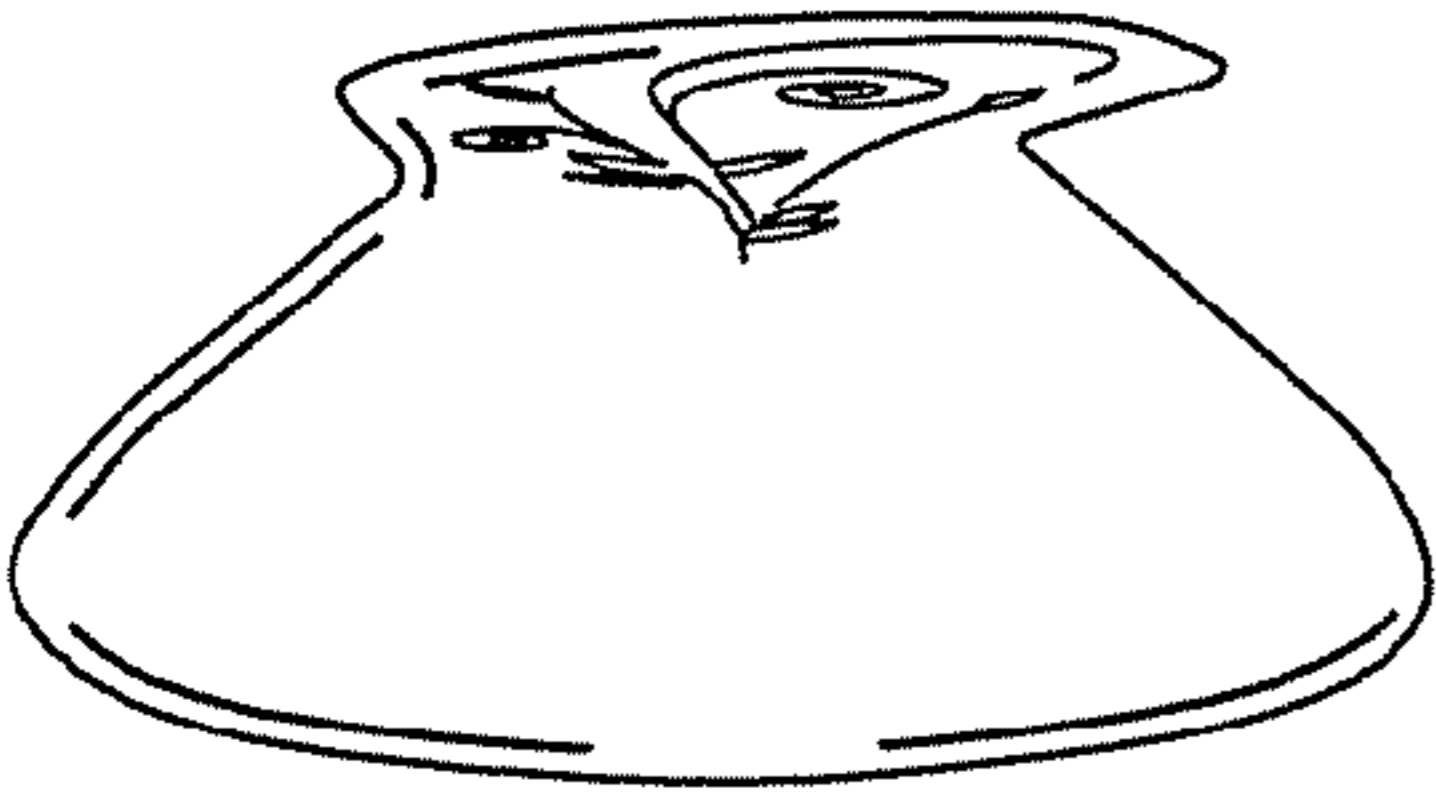

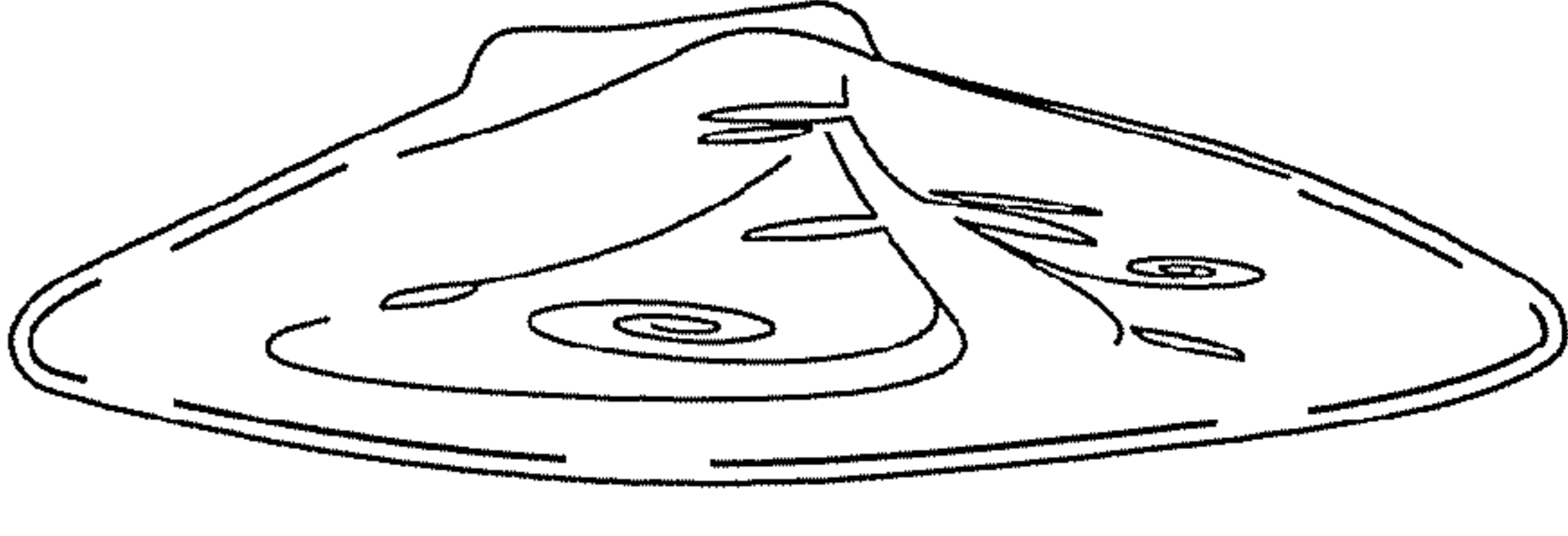
