FIG. 12 is a top plan view of the device for holding bait tubes of FIG. 8;

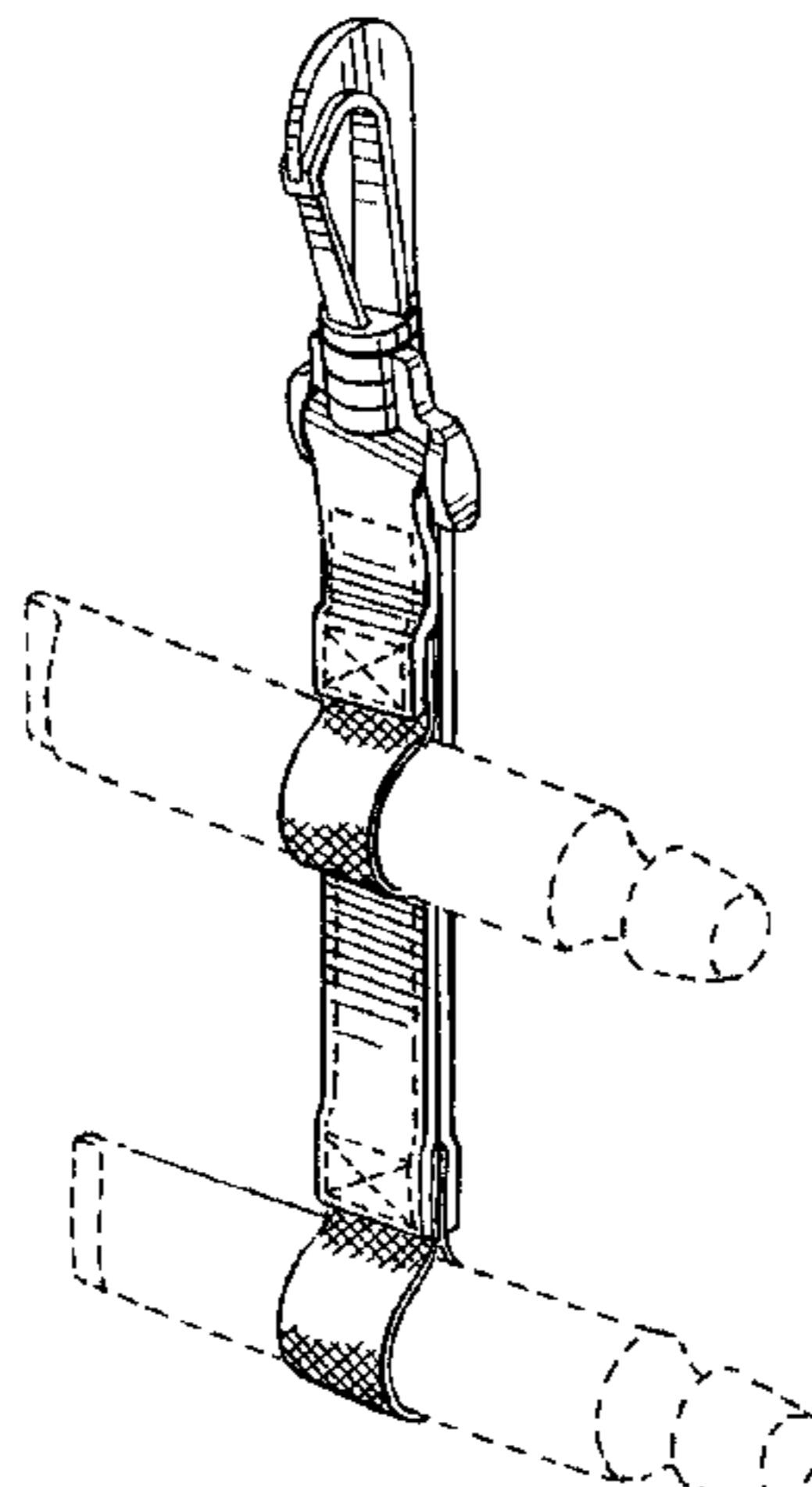
FIG. 13 is a bottom plan view of the device for holding bait tubes of FIG. 8; and,

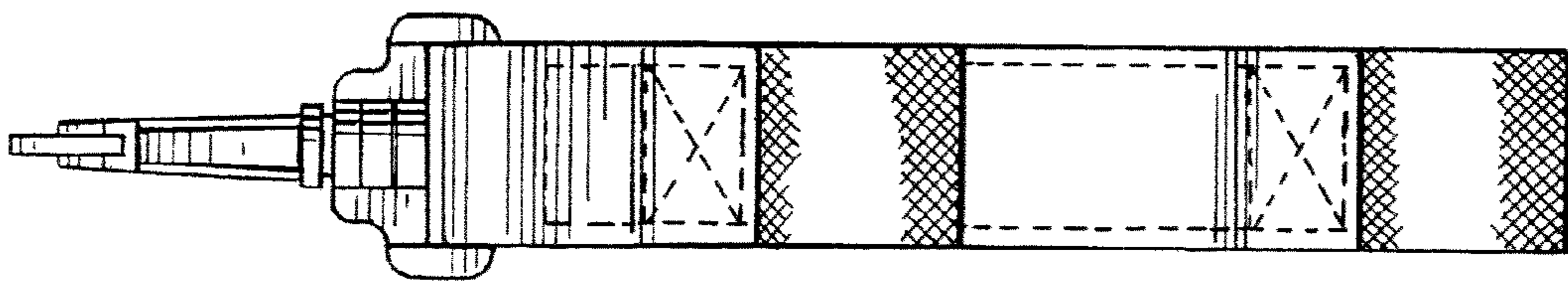

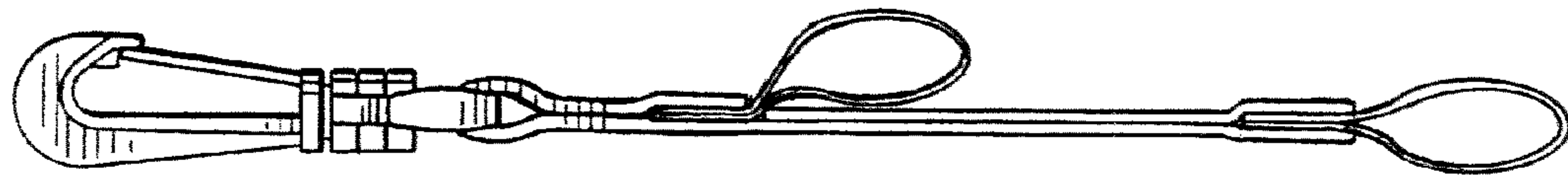

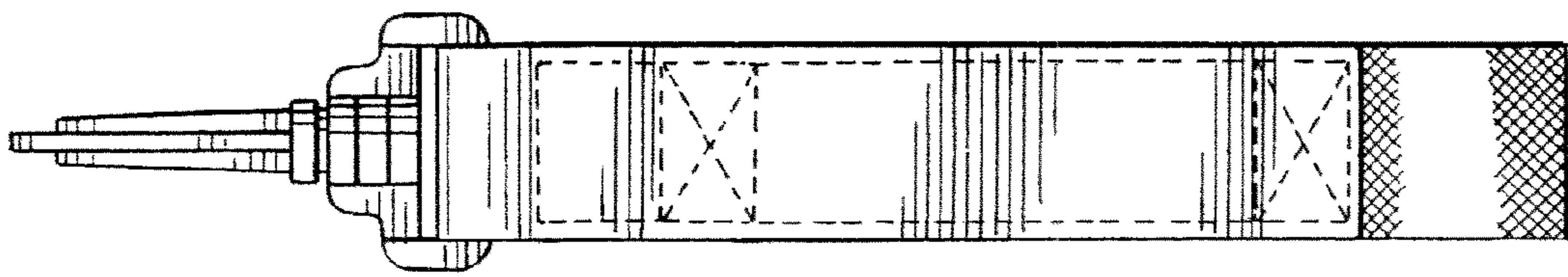

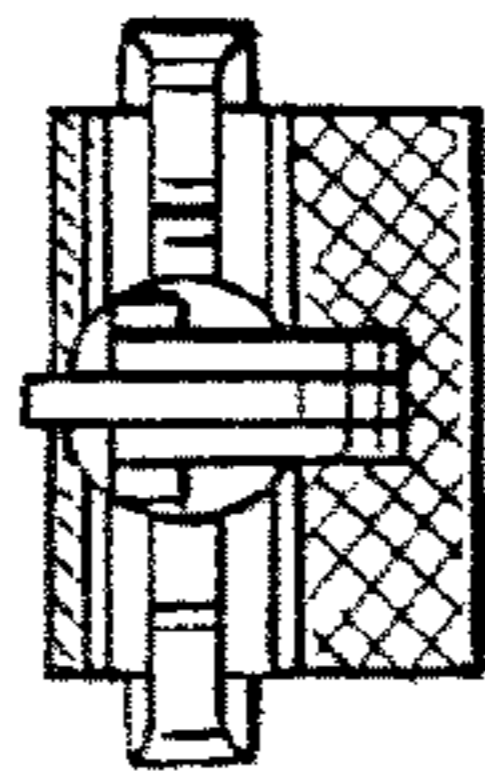

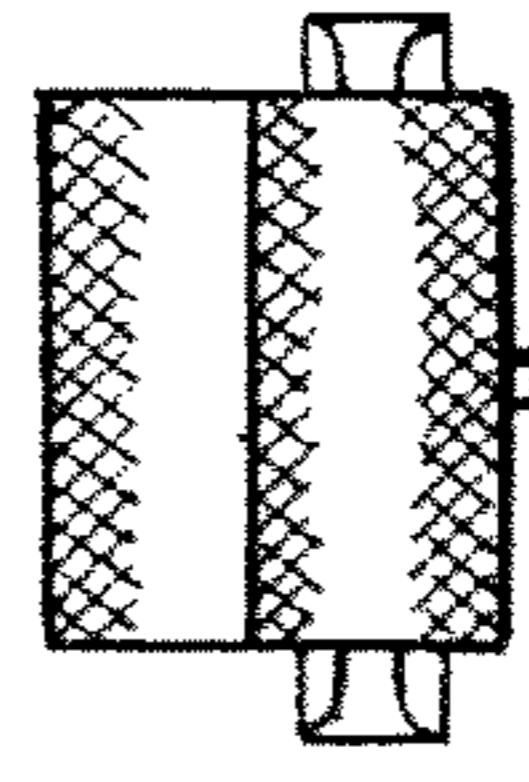

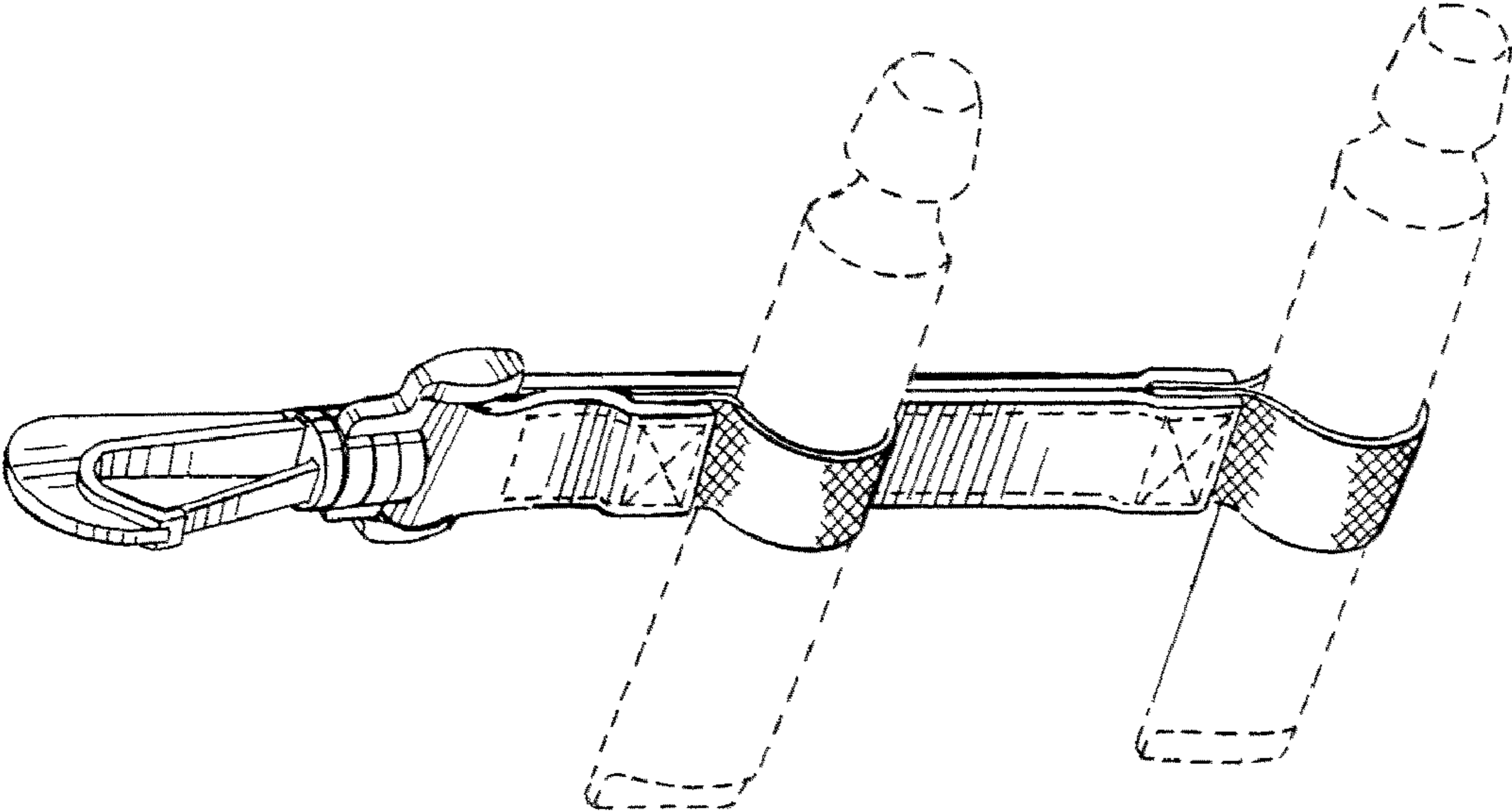

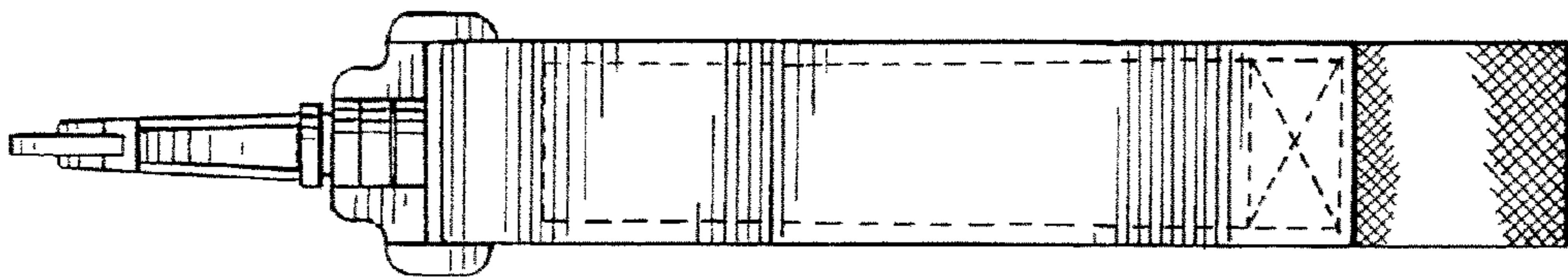

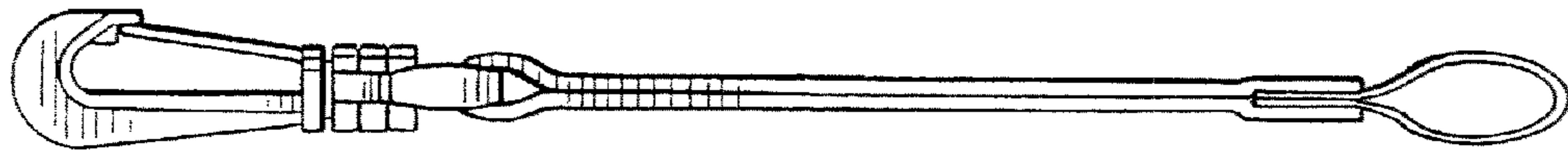

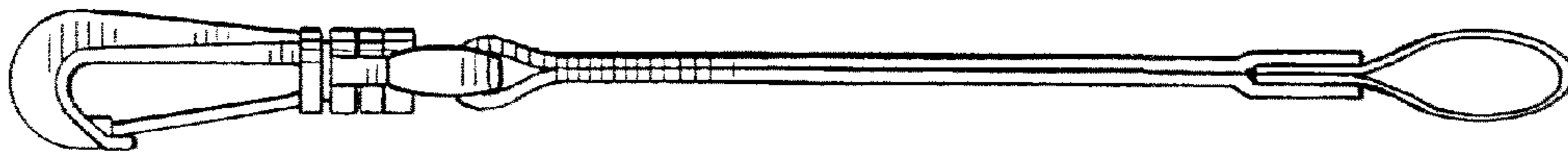

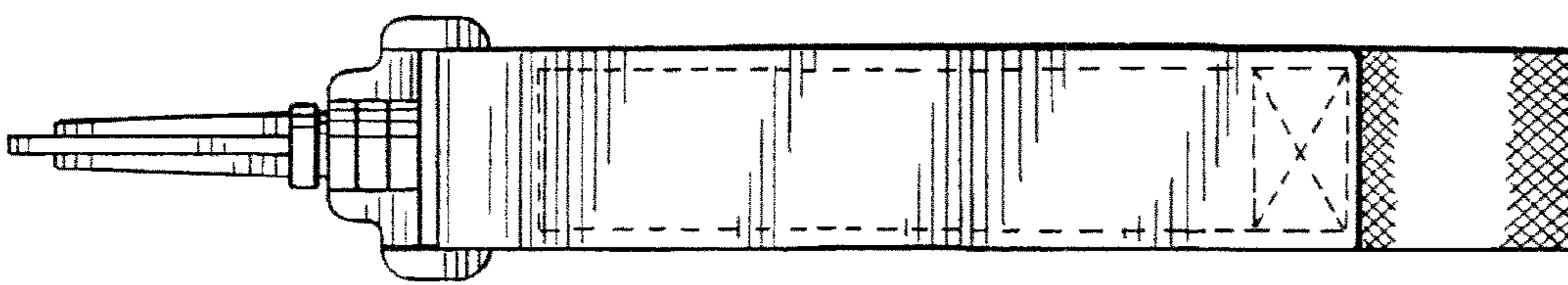

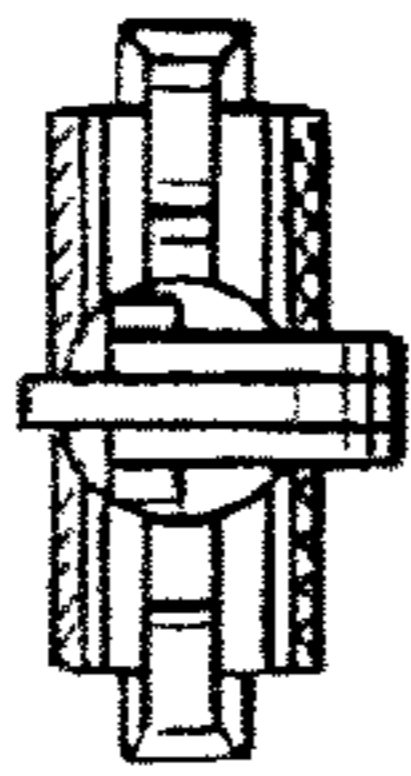

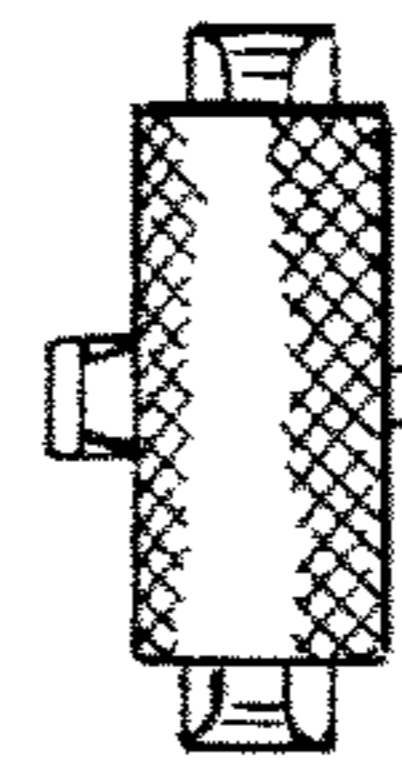

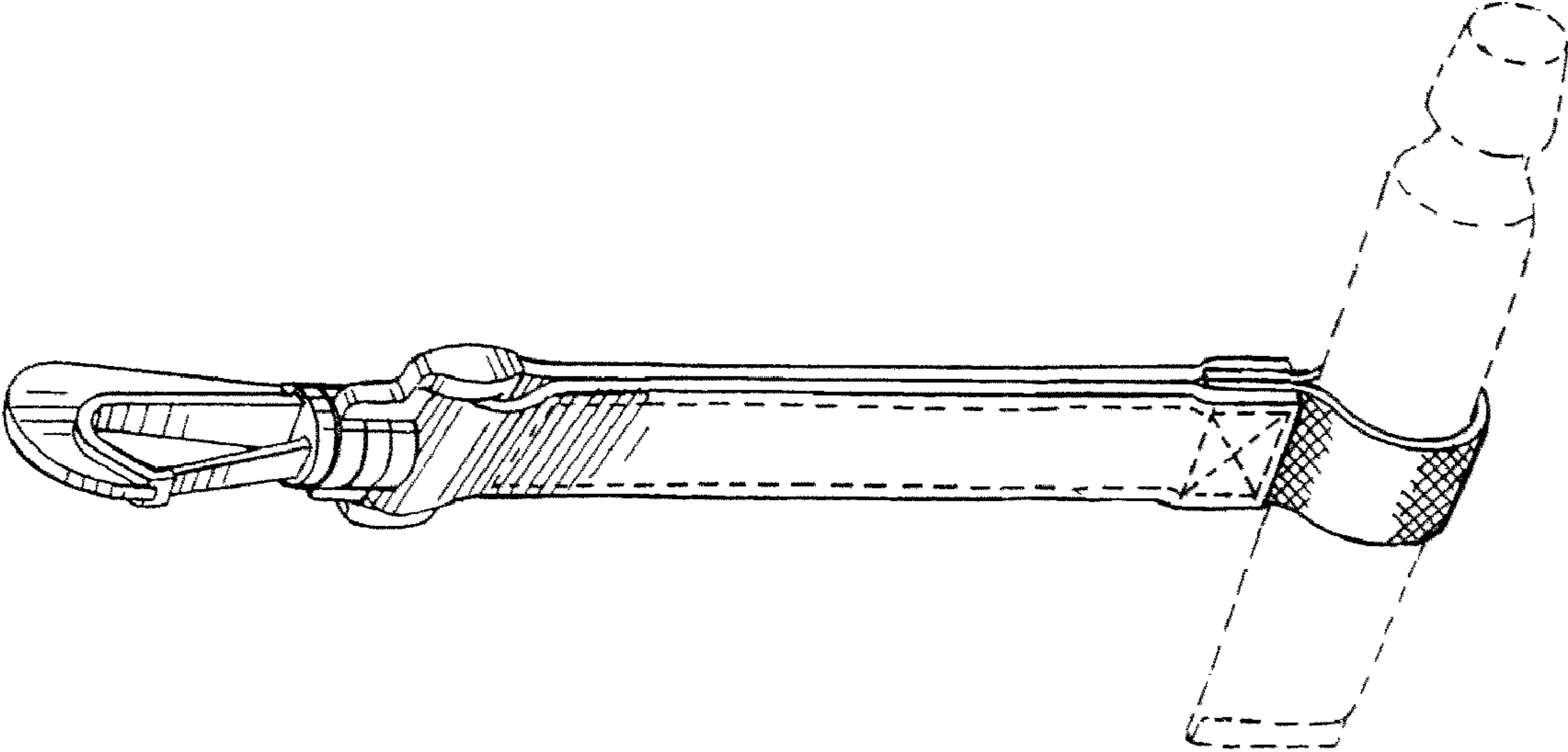
