(57) **CLAIM**

The ornamental design for a foldable deckchair, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the foldable deckchair, showing the present design in the position of use;

FIG. 2 is a right elevation view thereof in the position of use;

FIG. 3 is a left elevation view thereof in the position of use;

FIG. 4 is a rear elevation view thereof in the position of use;

FIG. 5 is a top plan view thereof in the position of use;

FIG. 6 is a bottom plan view thereof in the position of use; and

FIG. 7 is a front perspective view thereof in the position of use;

FIG. 8 is a front elevation view of the folded deckchair, showing the present design in the position of transport;

FIG. 9 is a rear elevation view thereof in the position of transport;

FIG. 10 is a bottom plan view thereof in the position of transport;

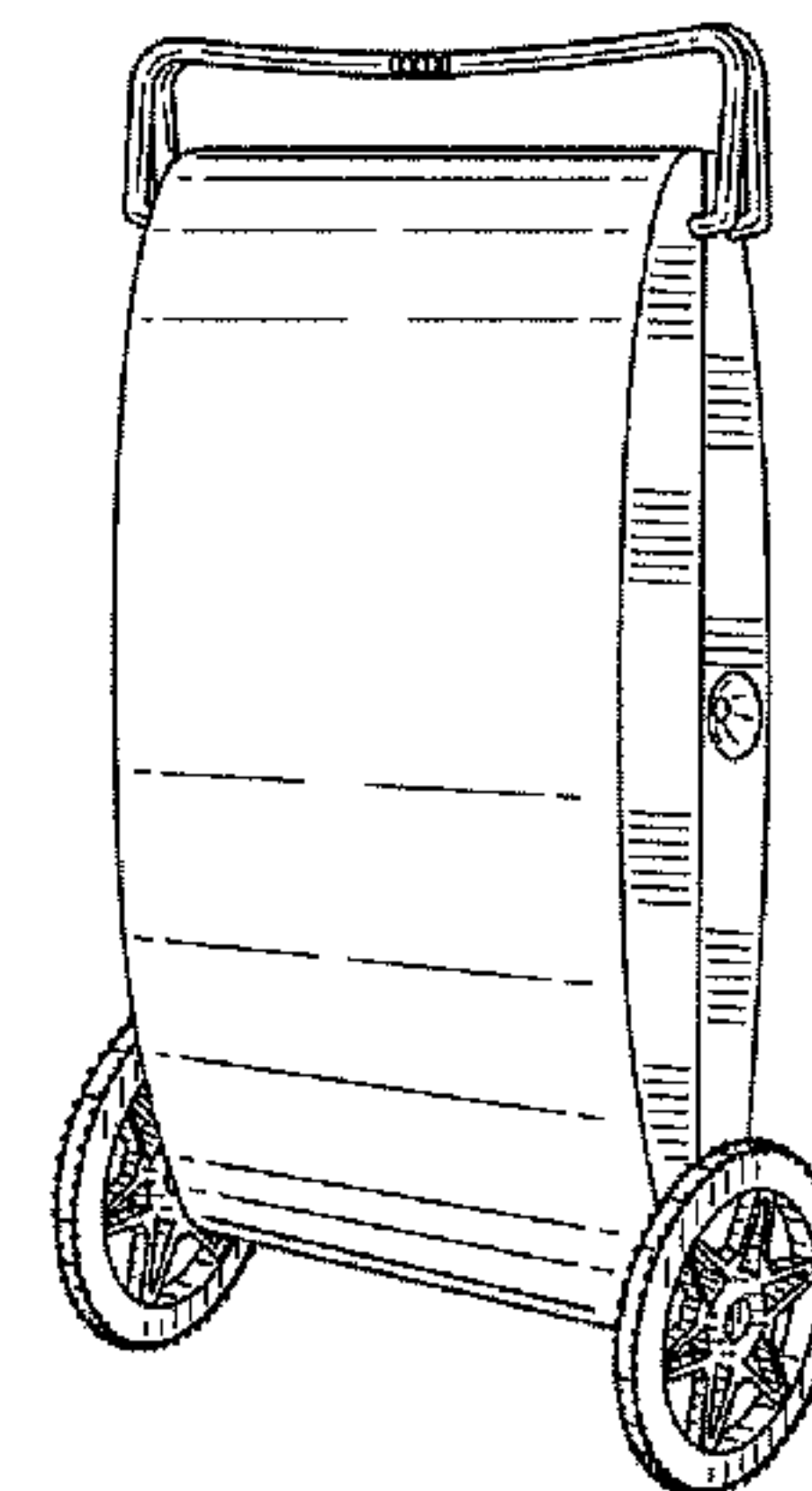
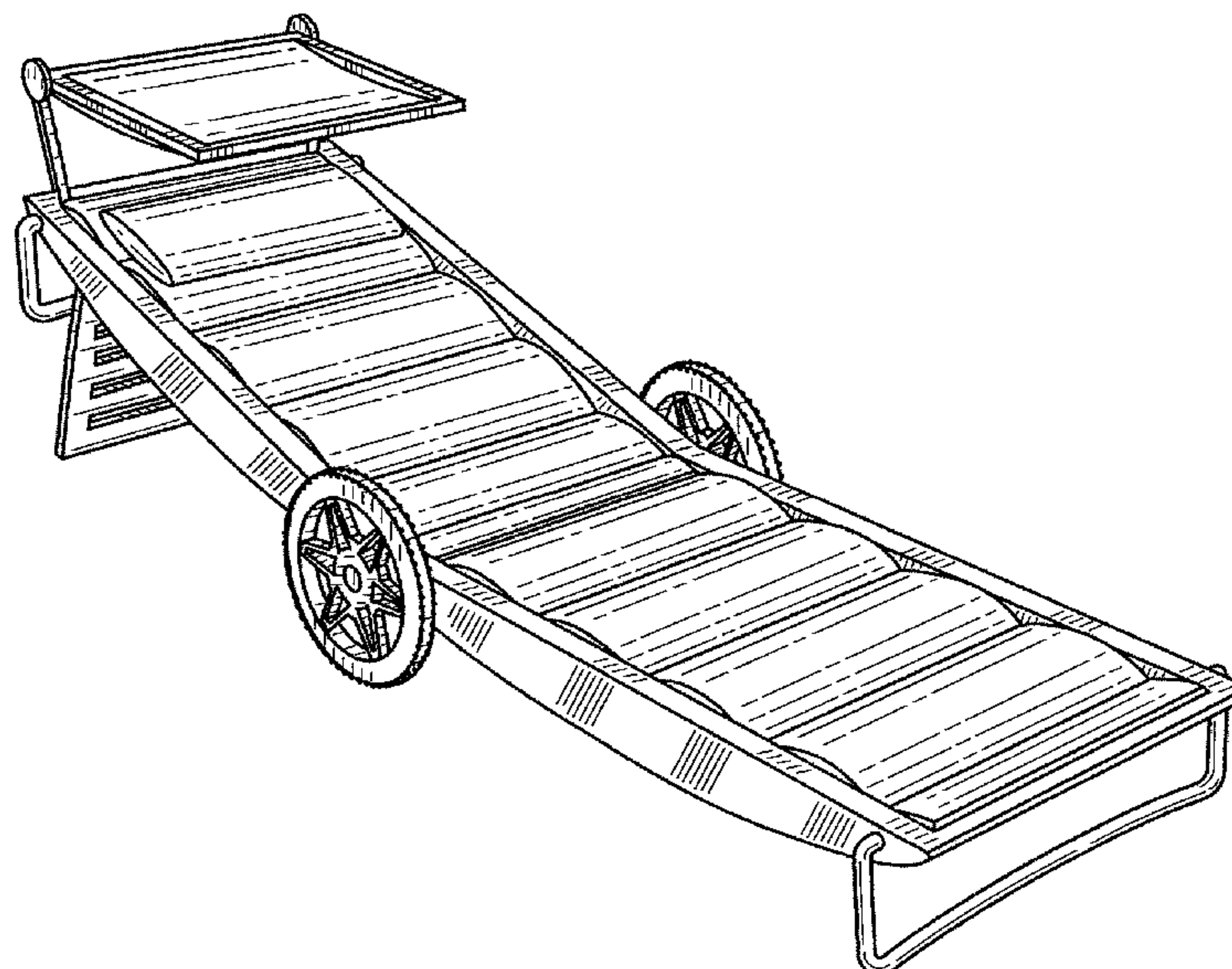
FIG. 11 is a top plan view thereof in the position of transport;

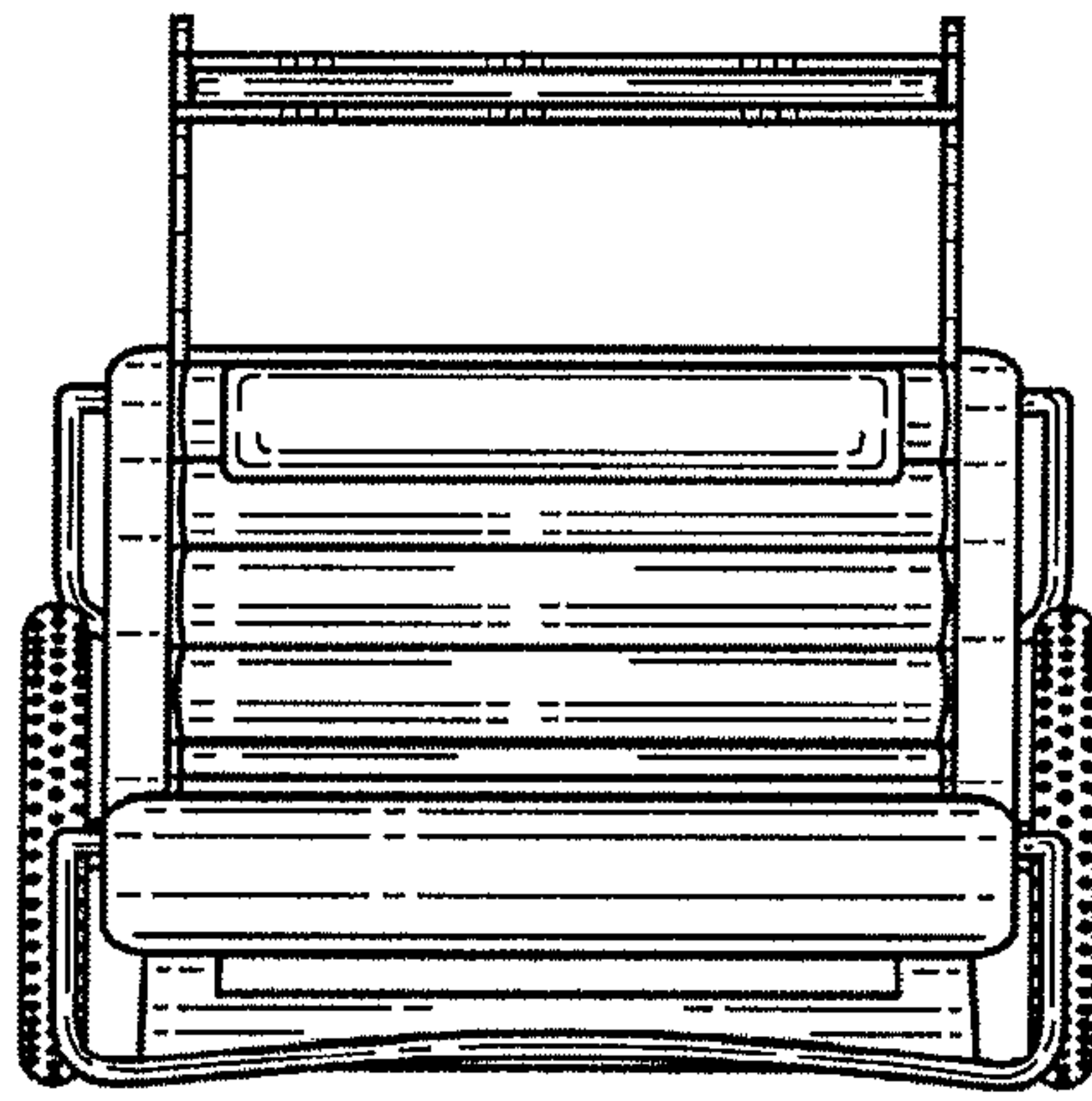

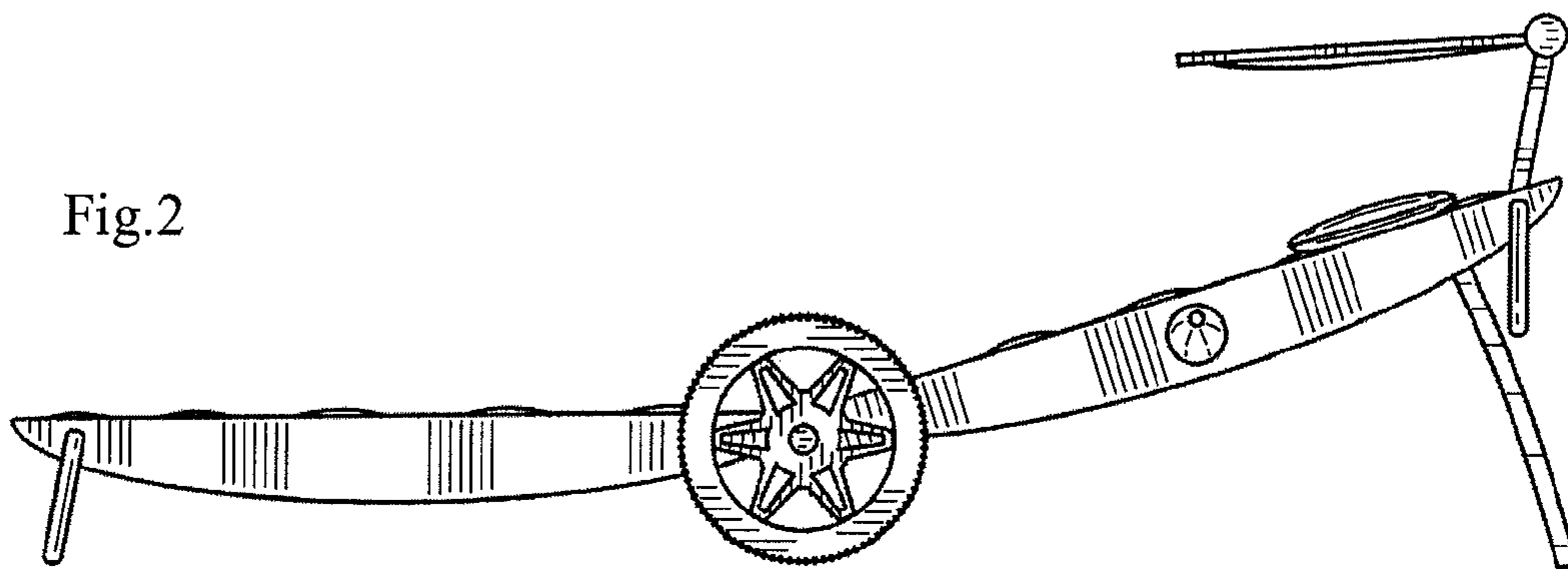

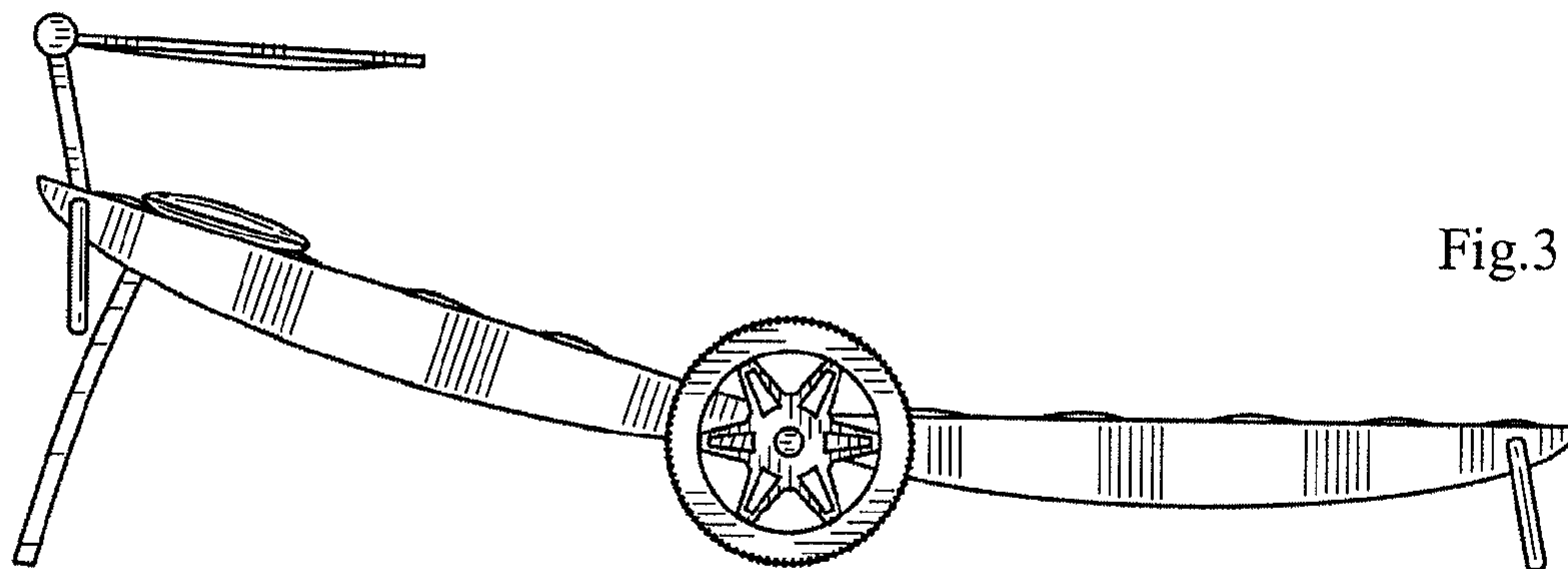

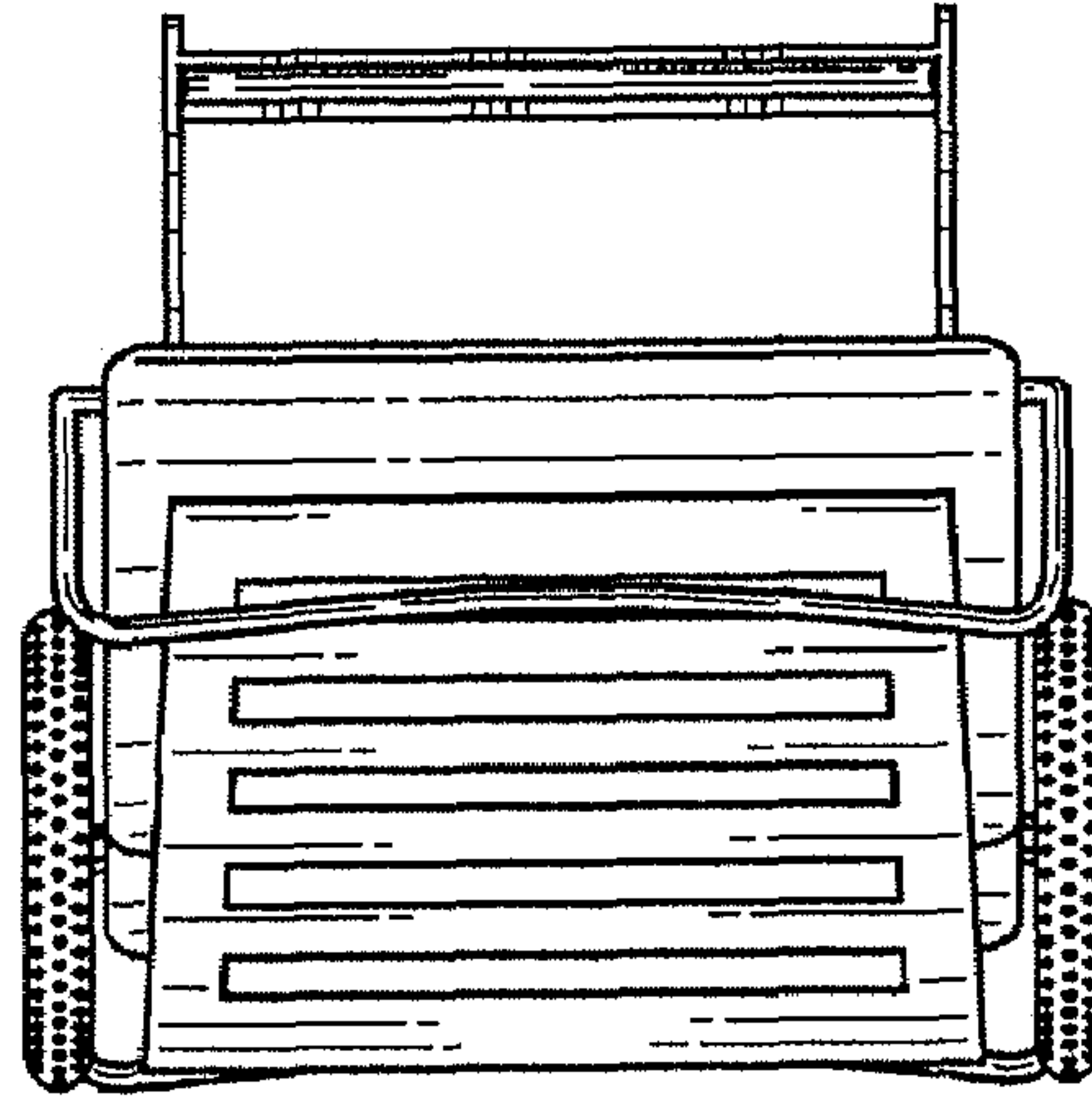

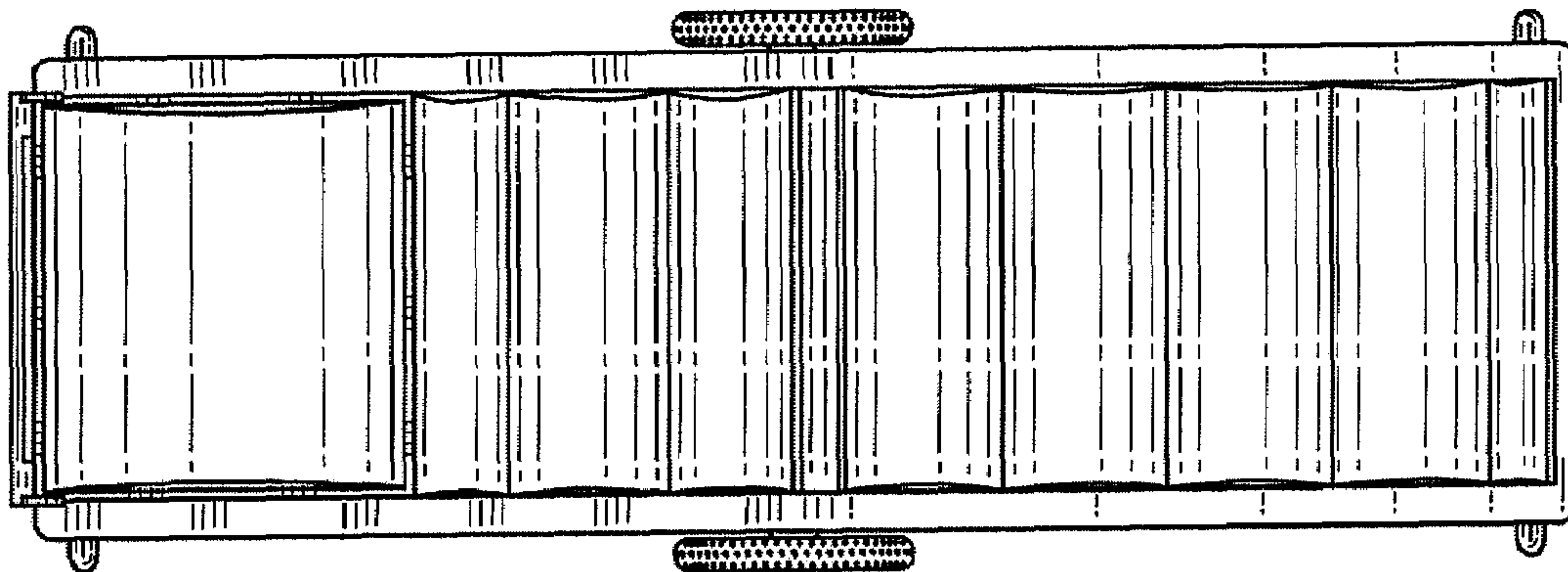

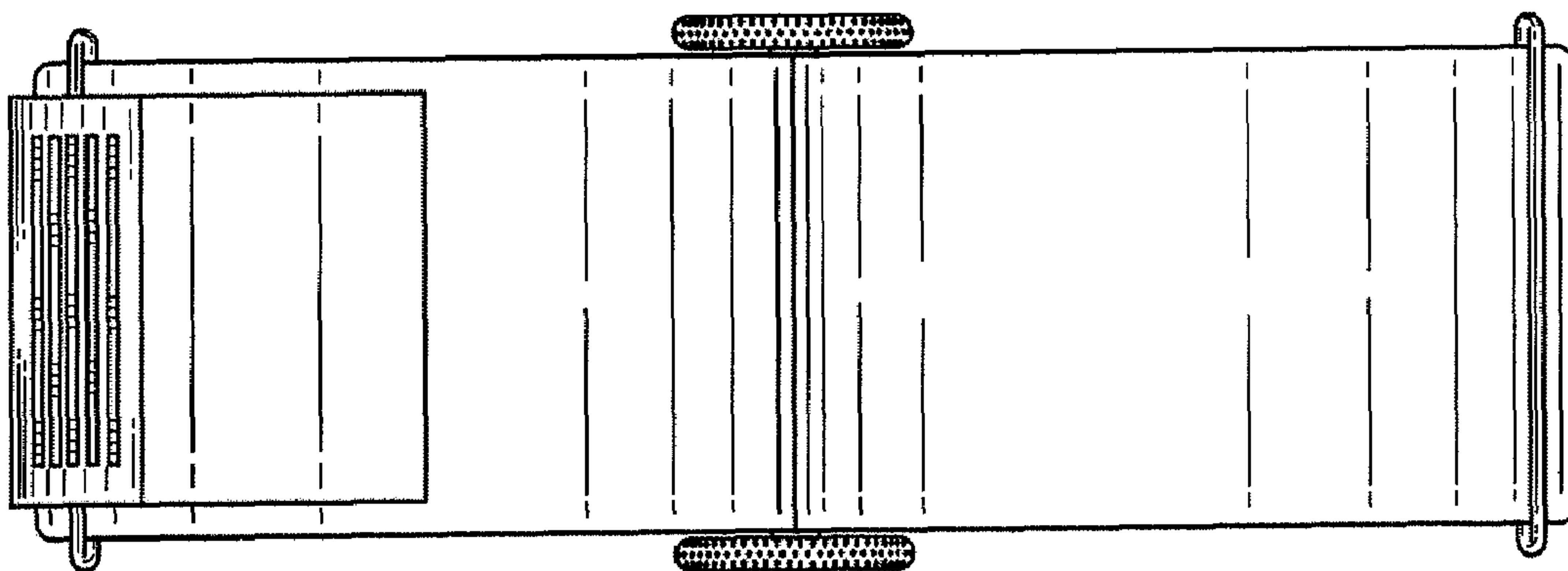

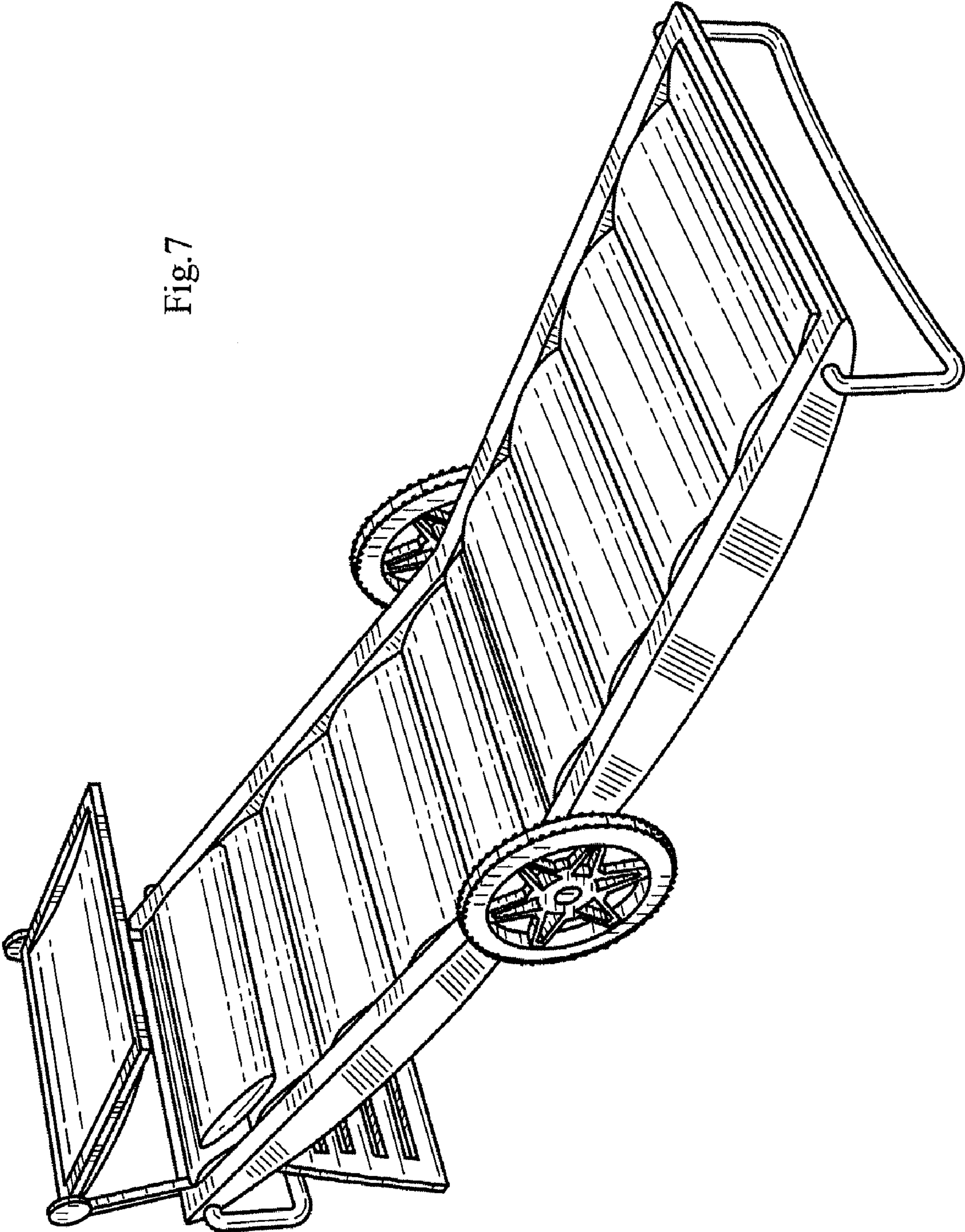

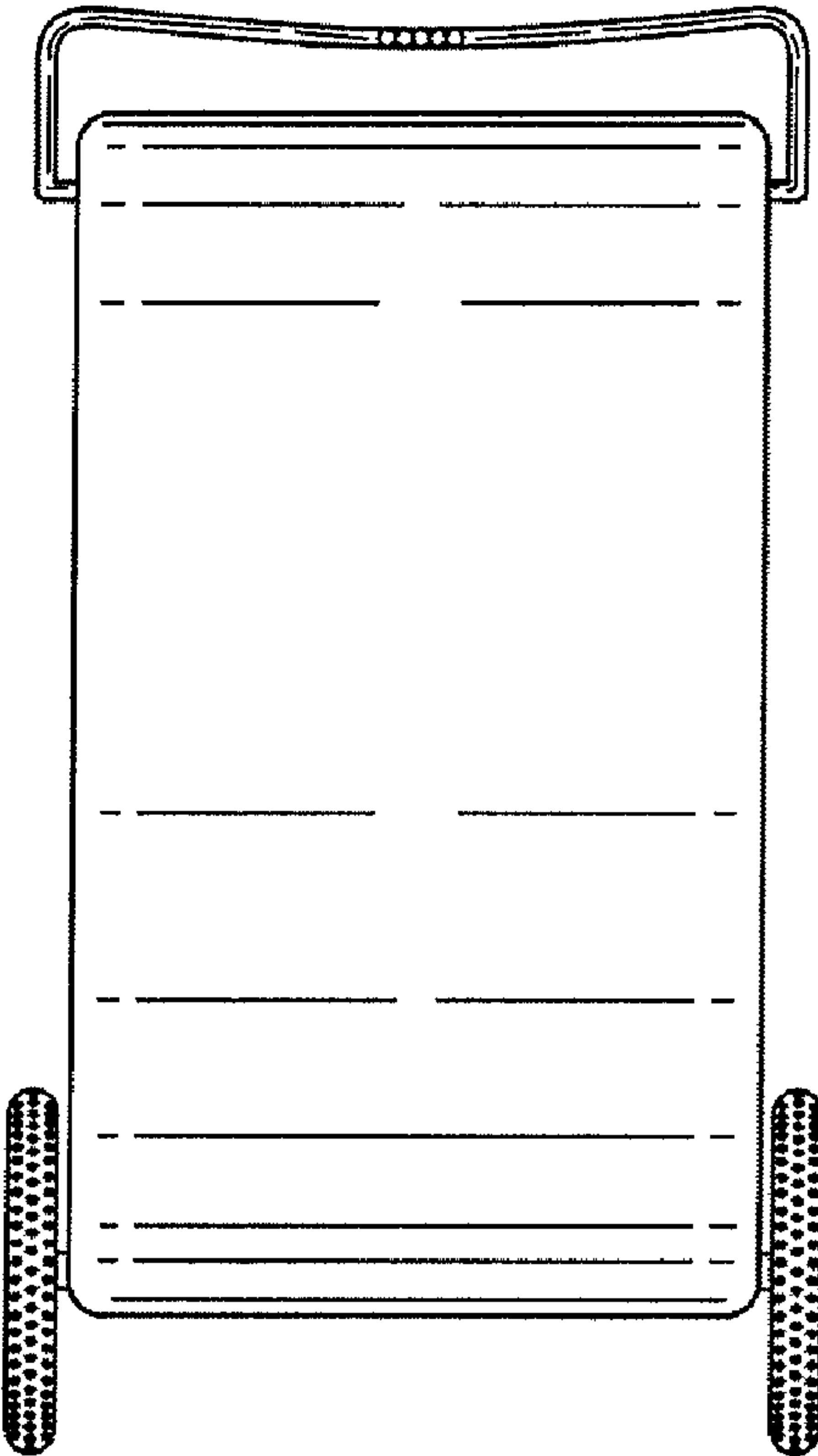

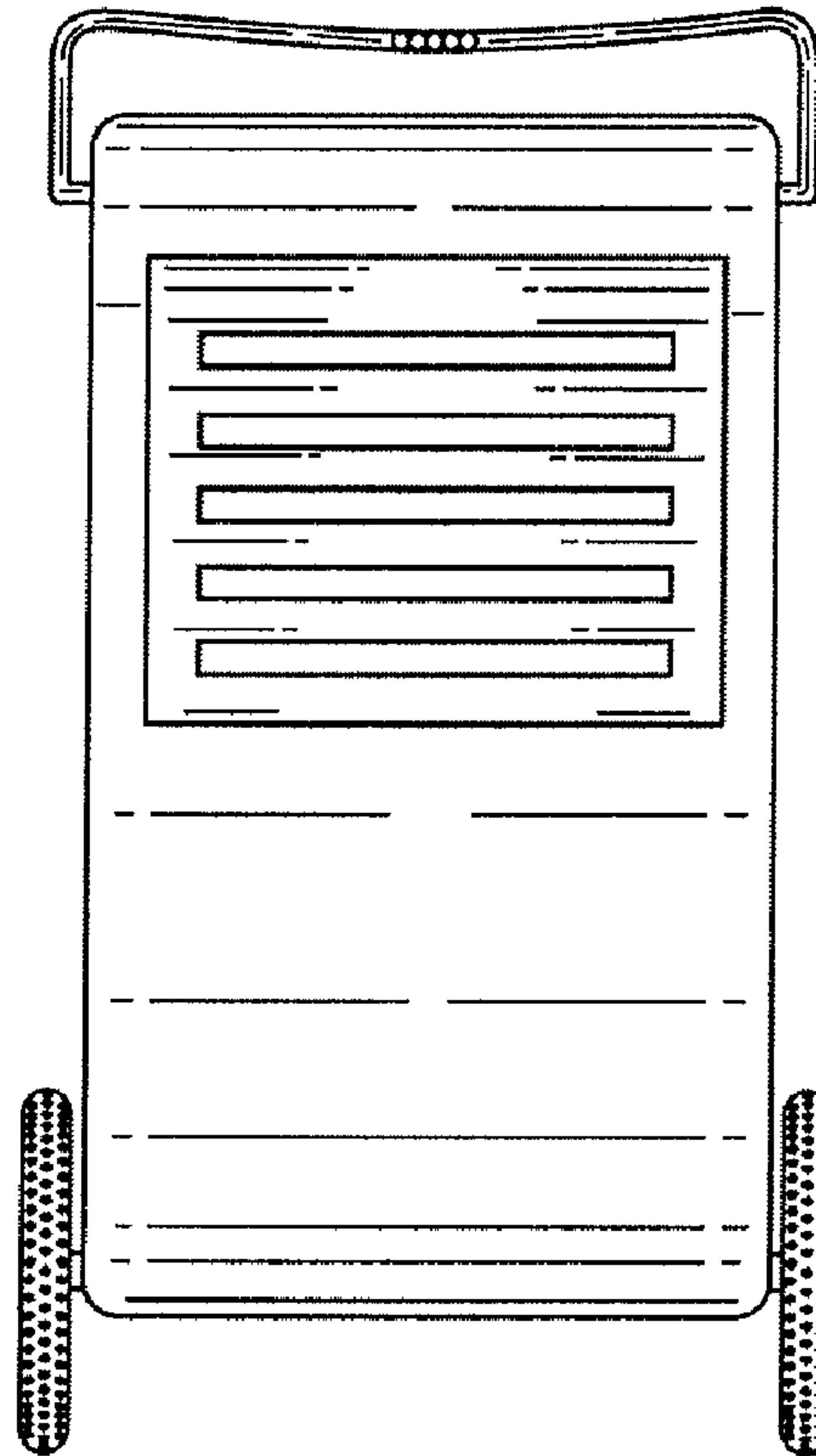

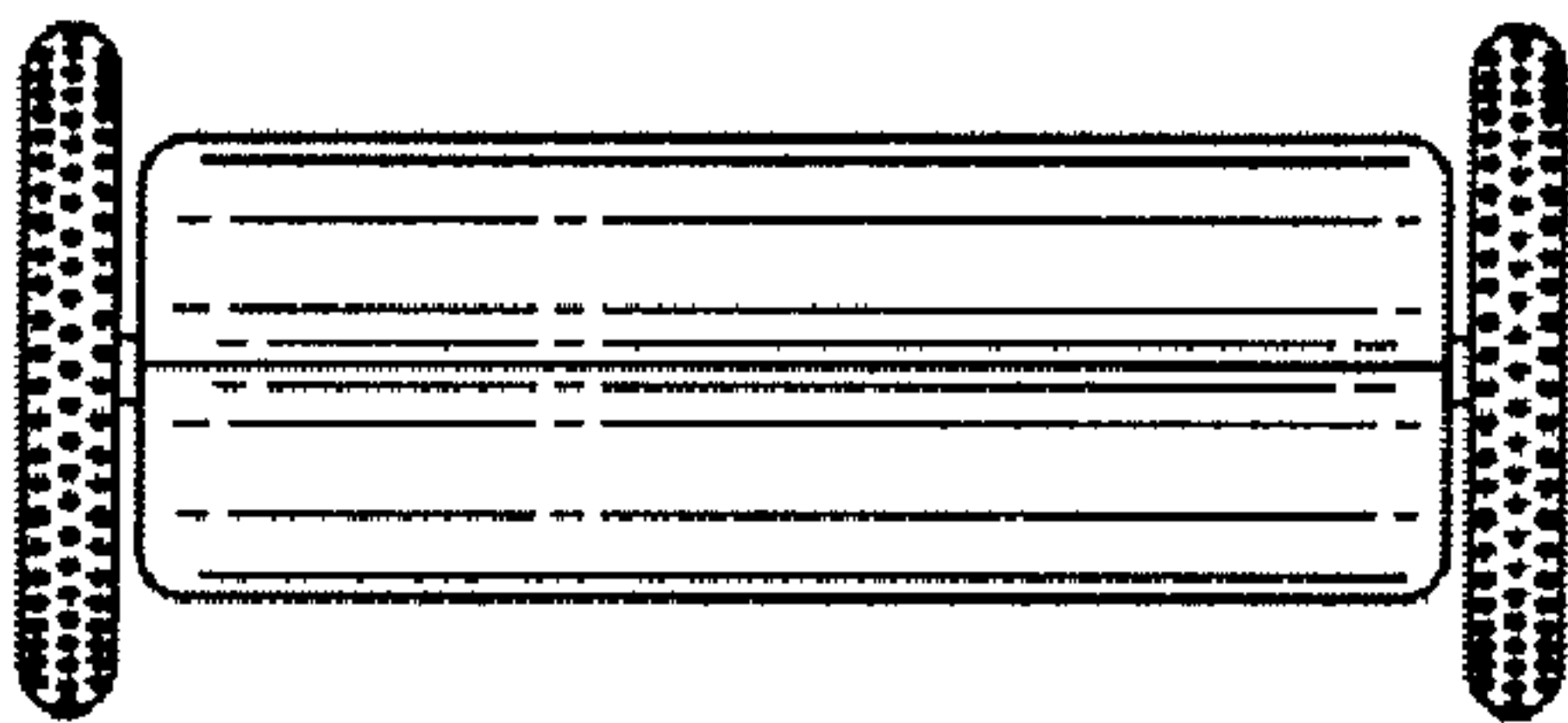

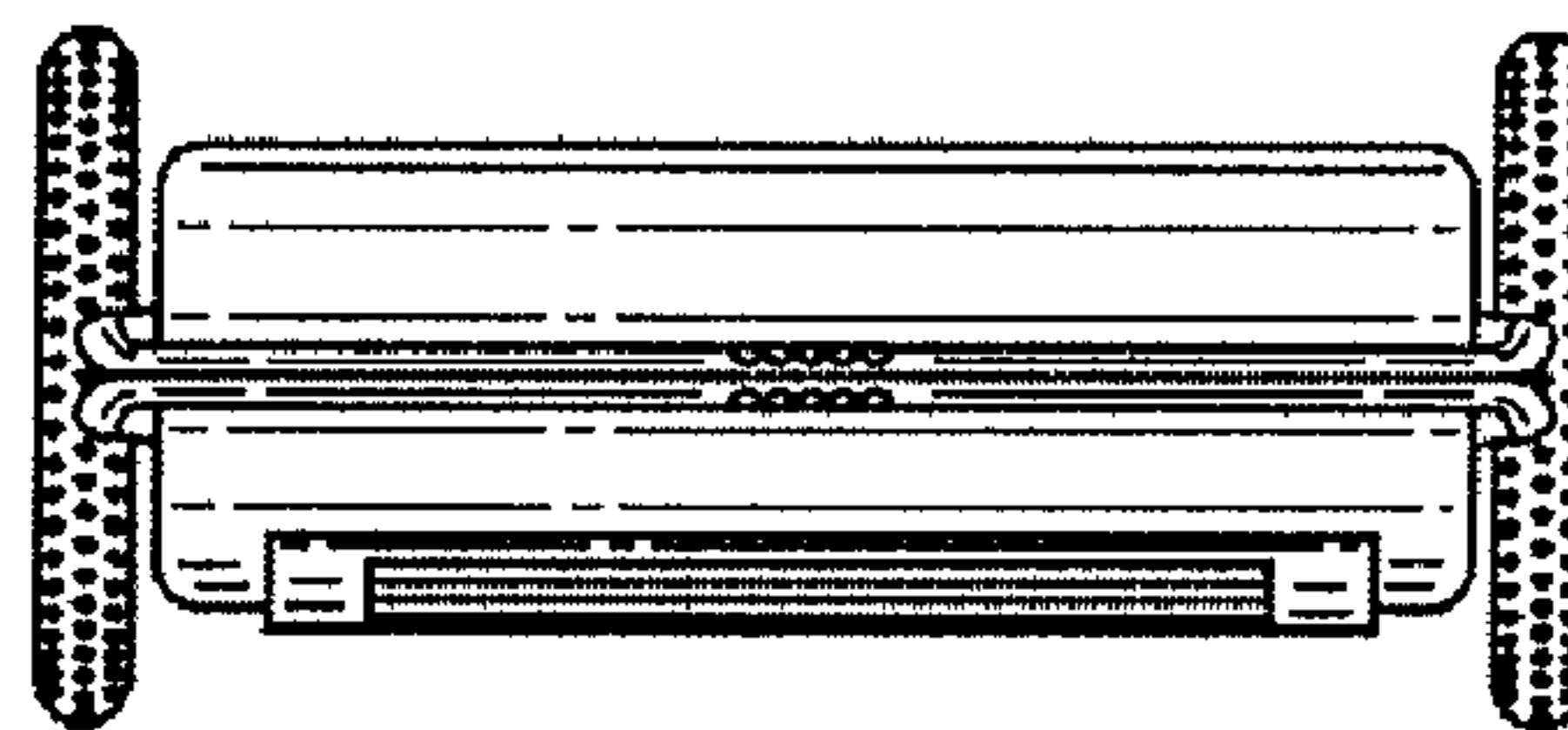

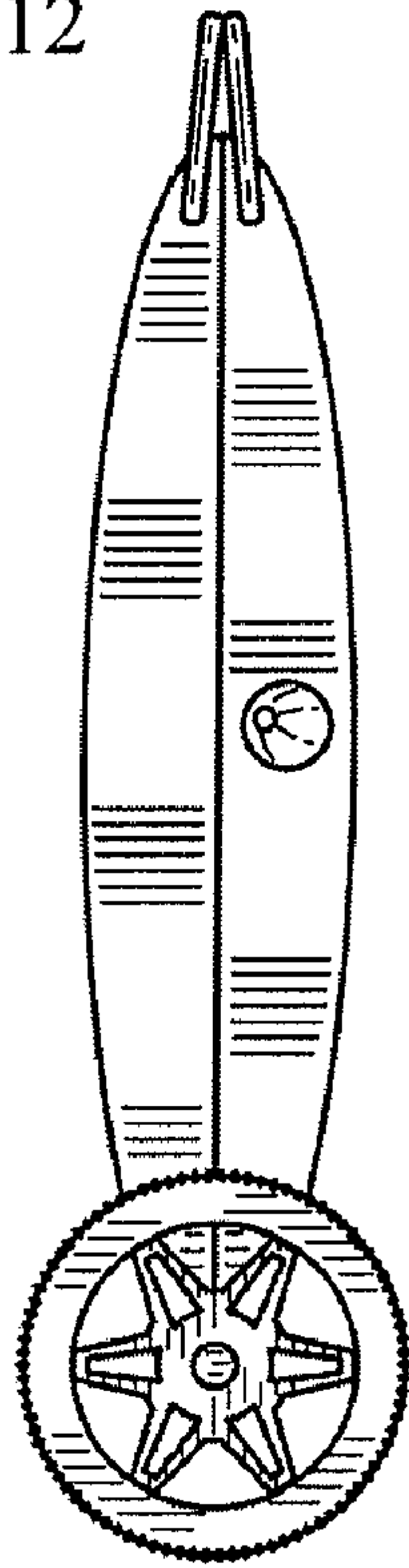

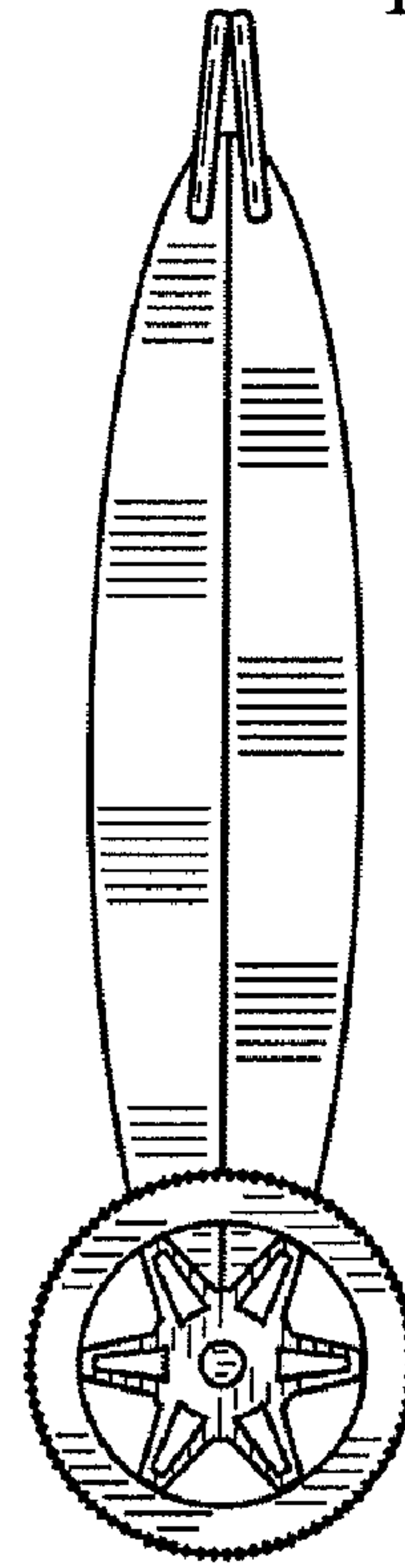
