FIG. 2 is a front view thereof;

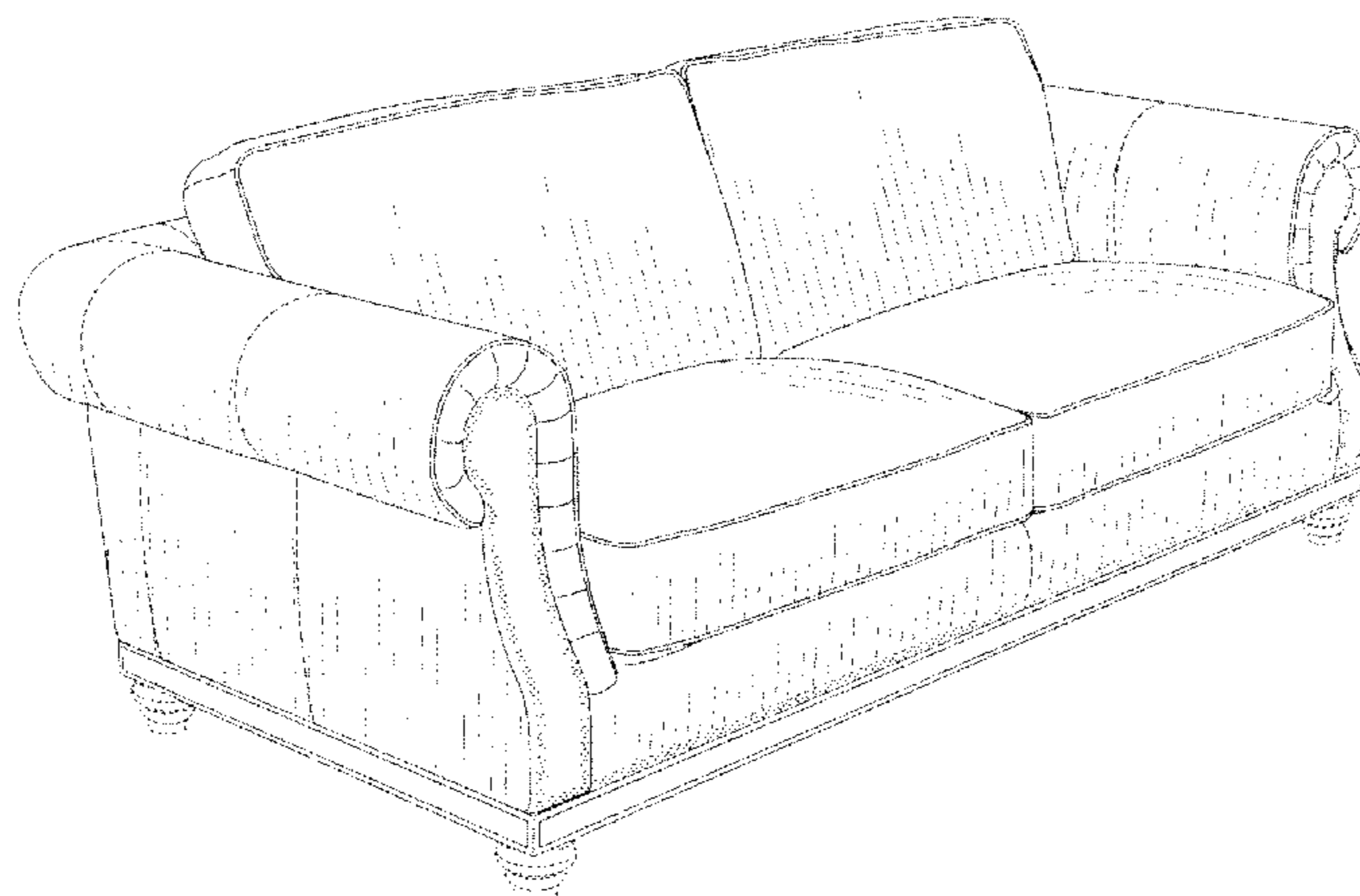
FIG. 3 is a top view thereof;

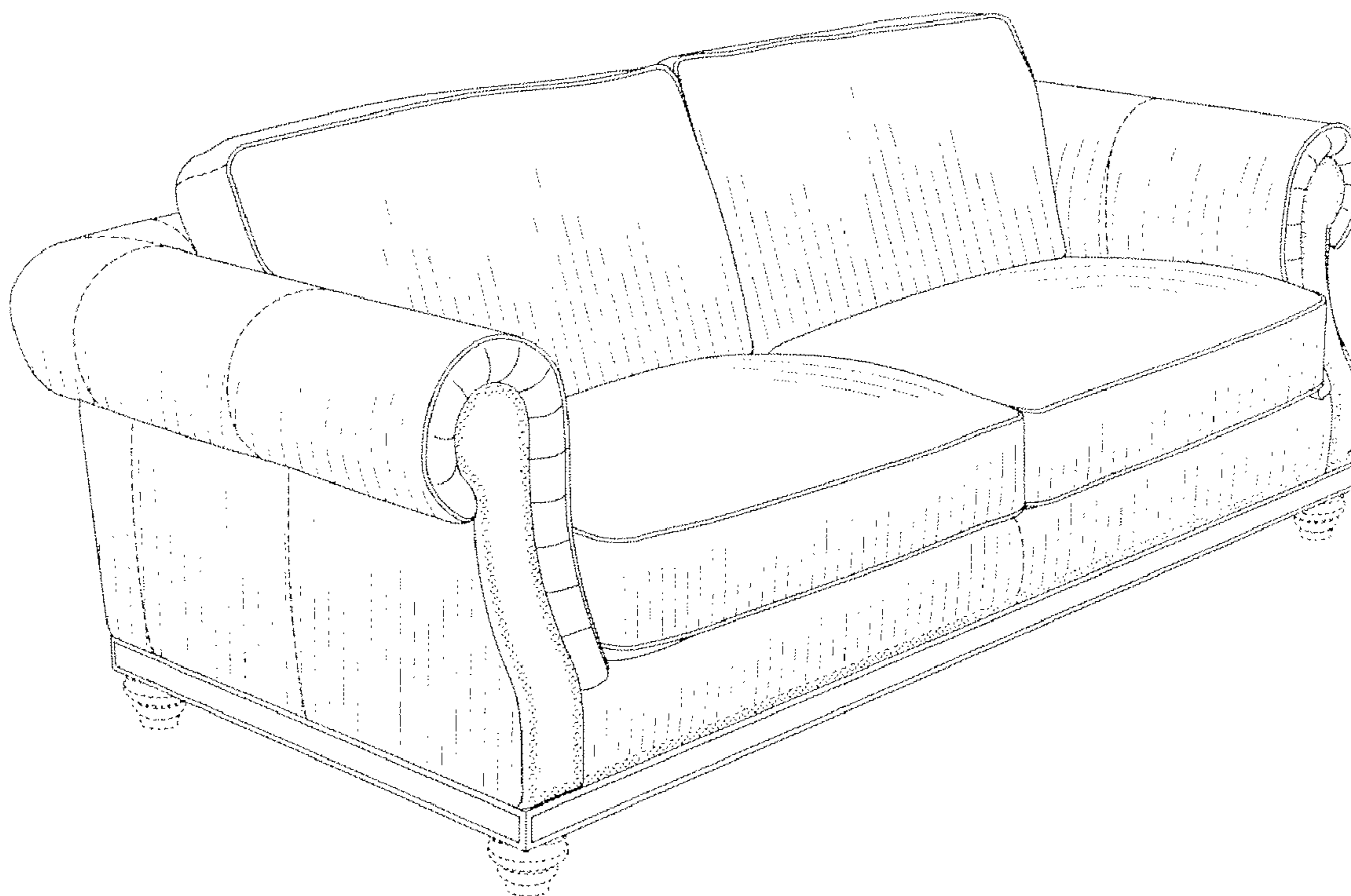
FIG. 4 is a right, side view thereof; and,

FIG. 5 is a back view thereof.

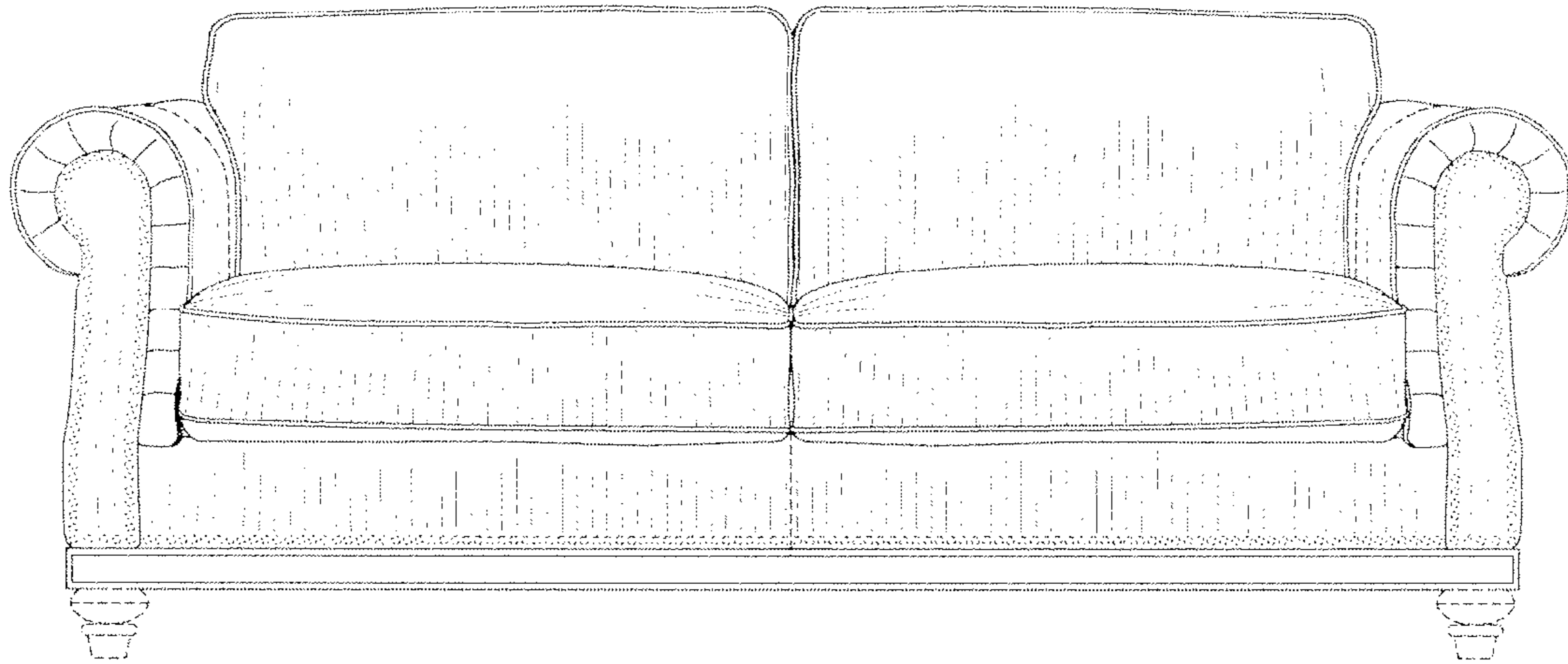

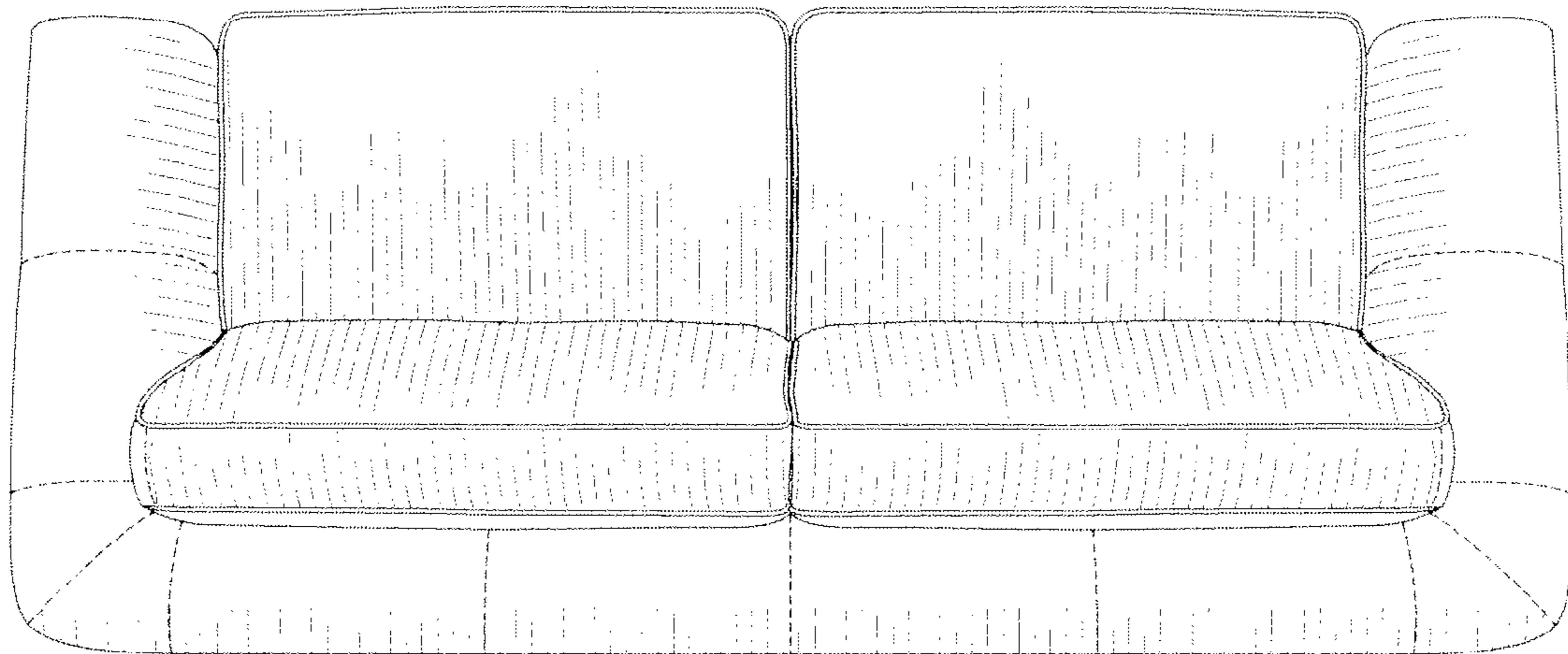




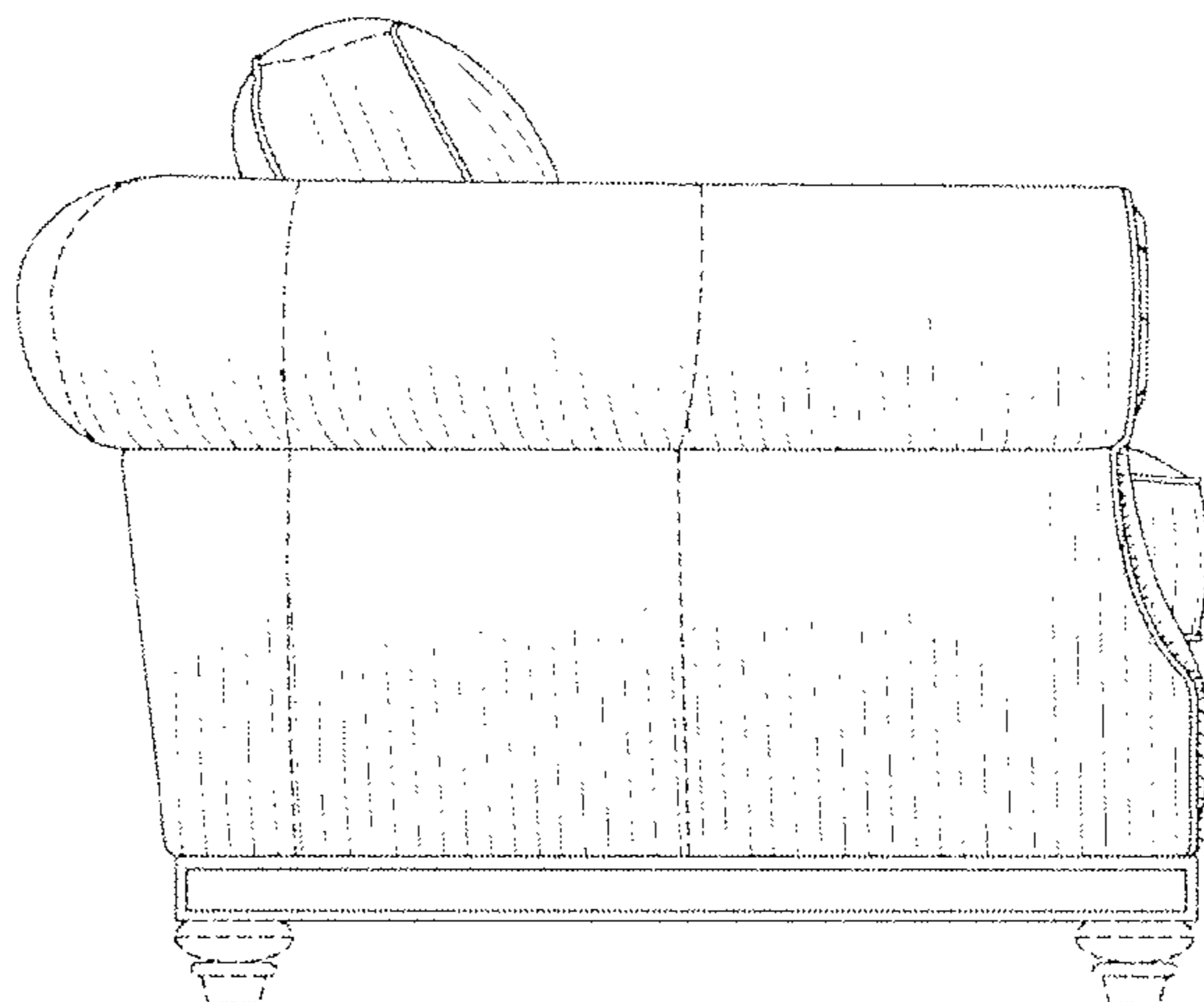

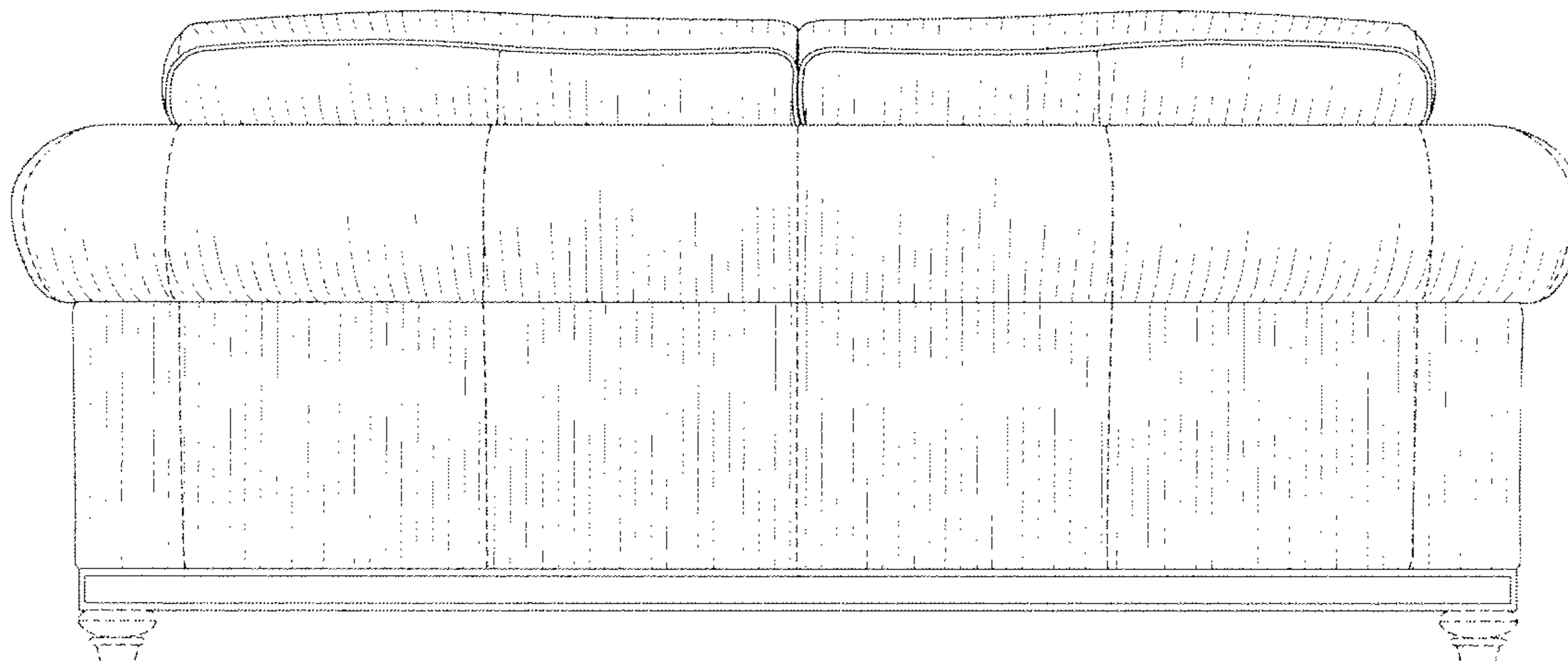
