The ornamental design for a bat and moon stackable cookie cutter set, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the bat and moon stackable cookie cutter set;

FIG. 4 is a front elevational view of the bat and moon stackable cookie cutter set;

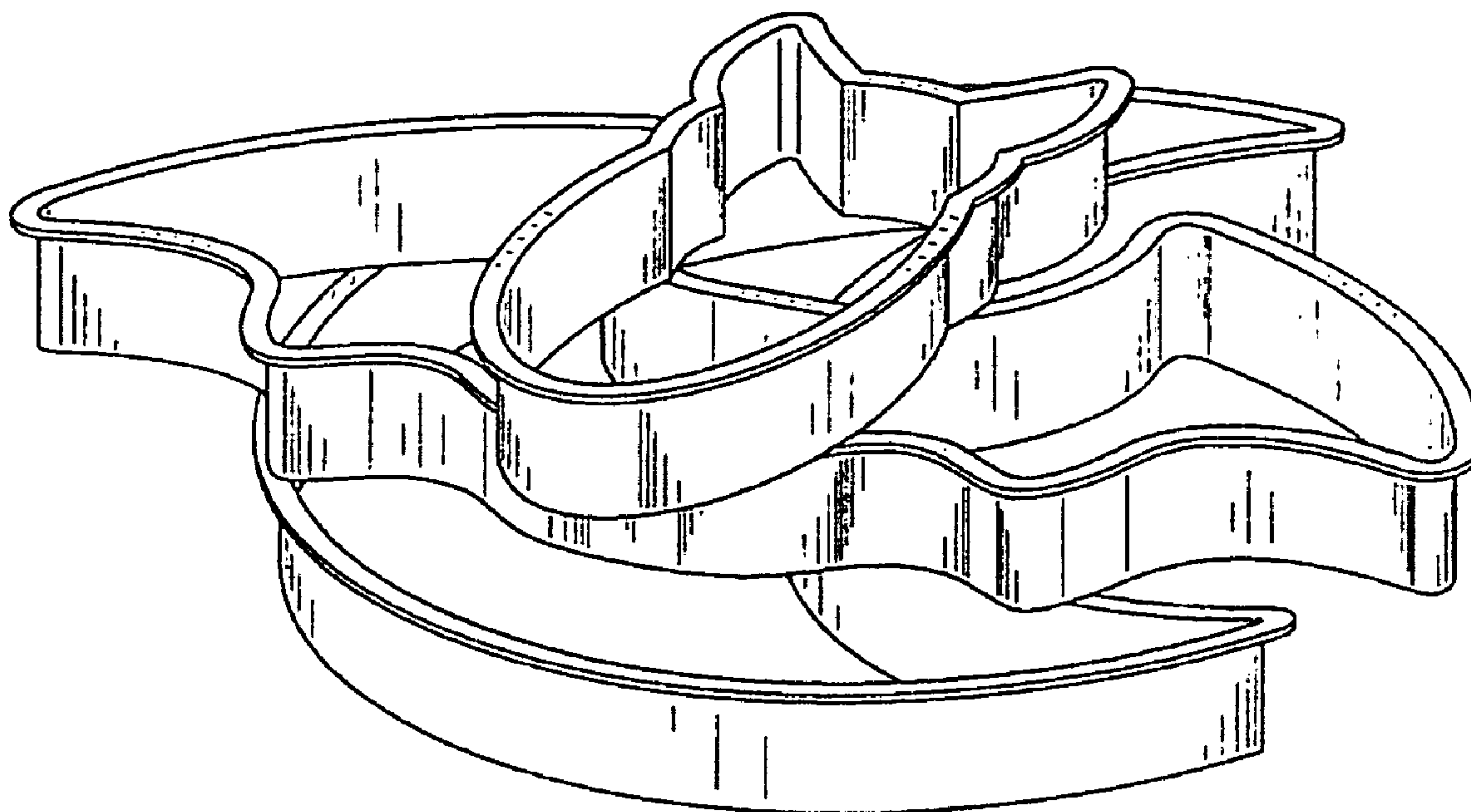
FIG. 5 is a rear elevational view of the bat and moon stackable cookie cutter set;

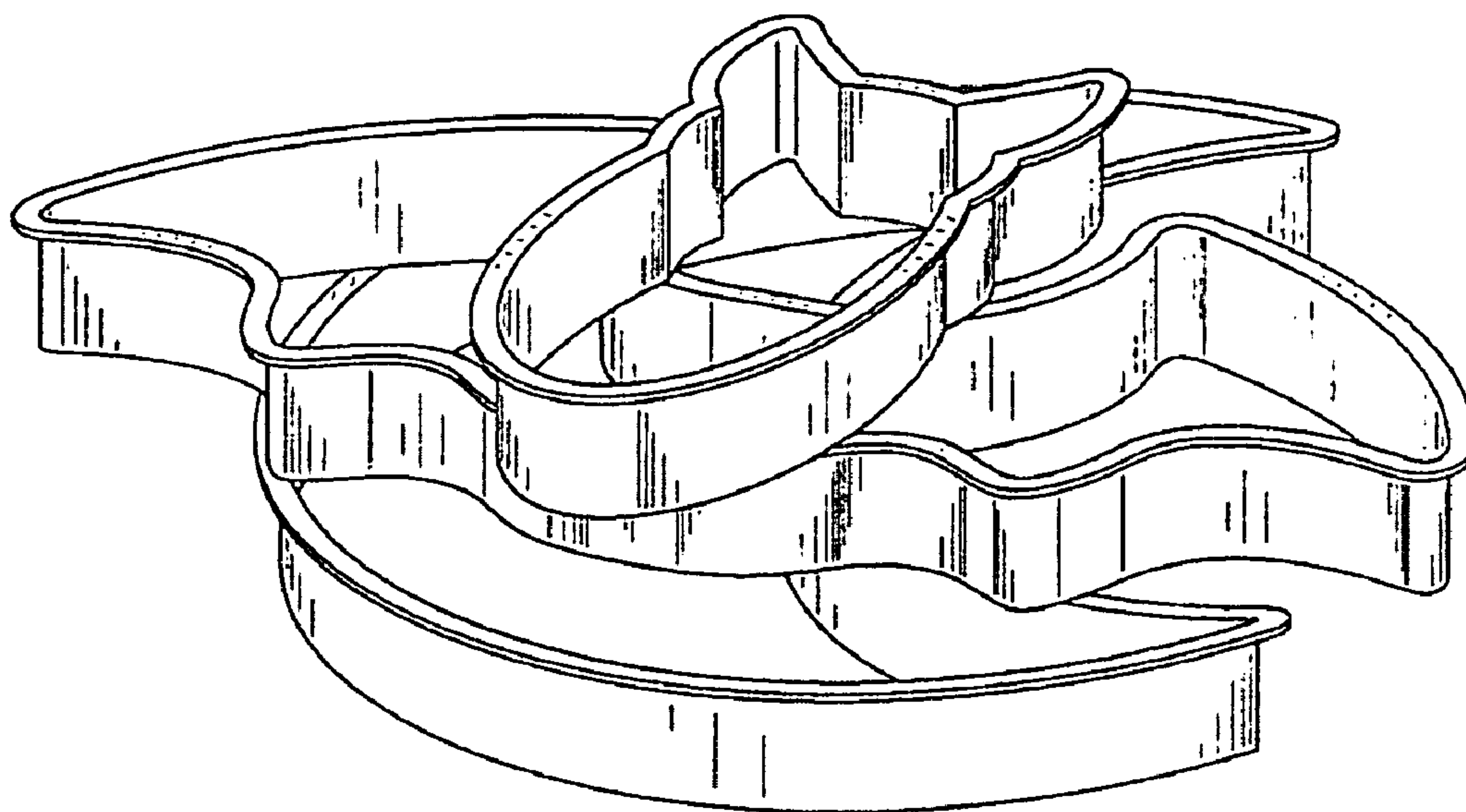

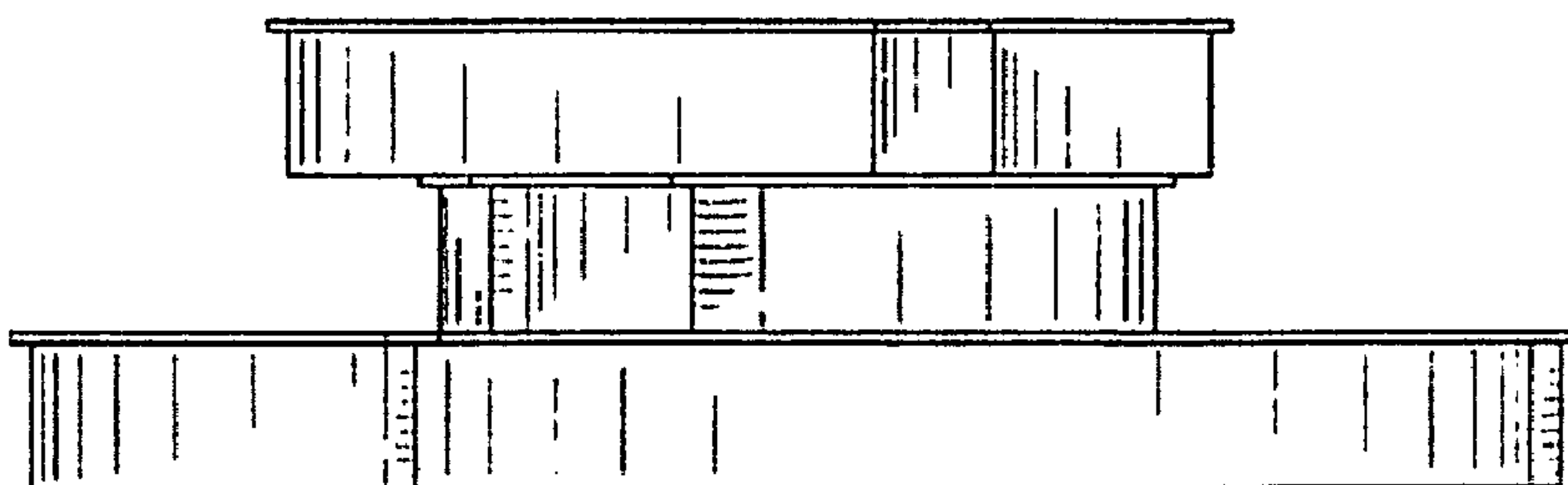

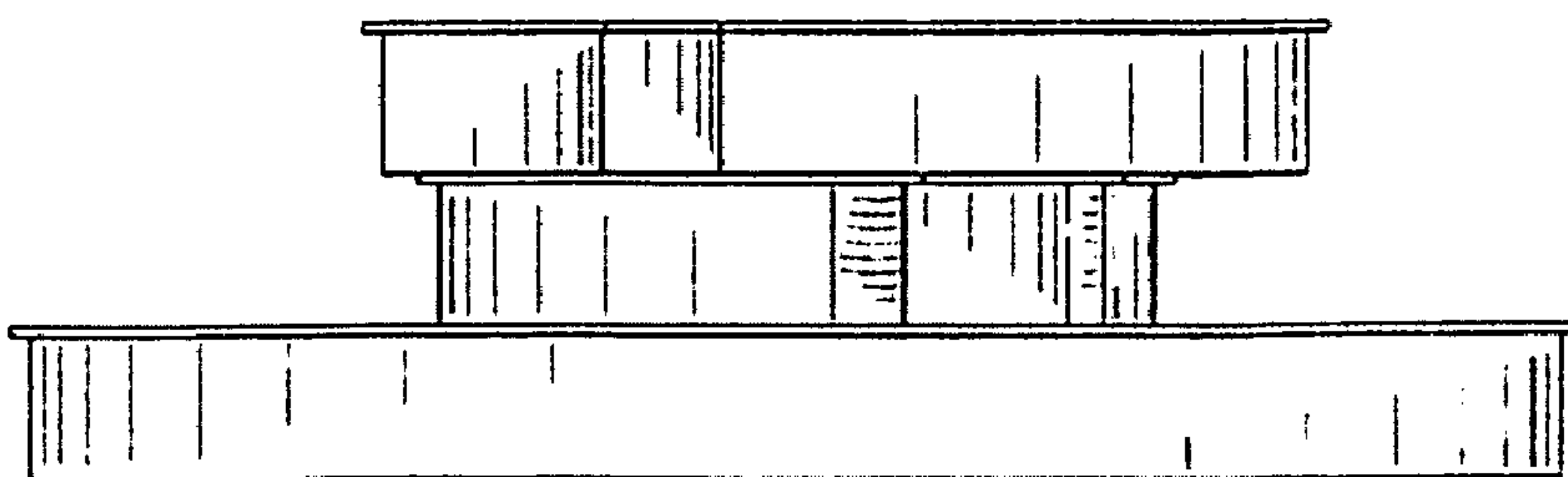

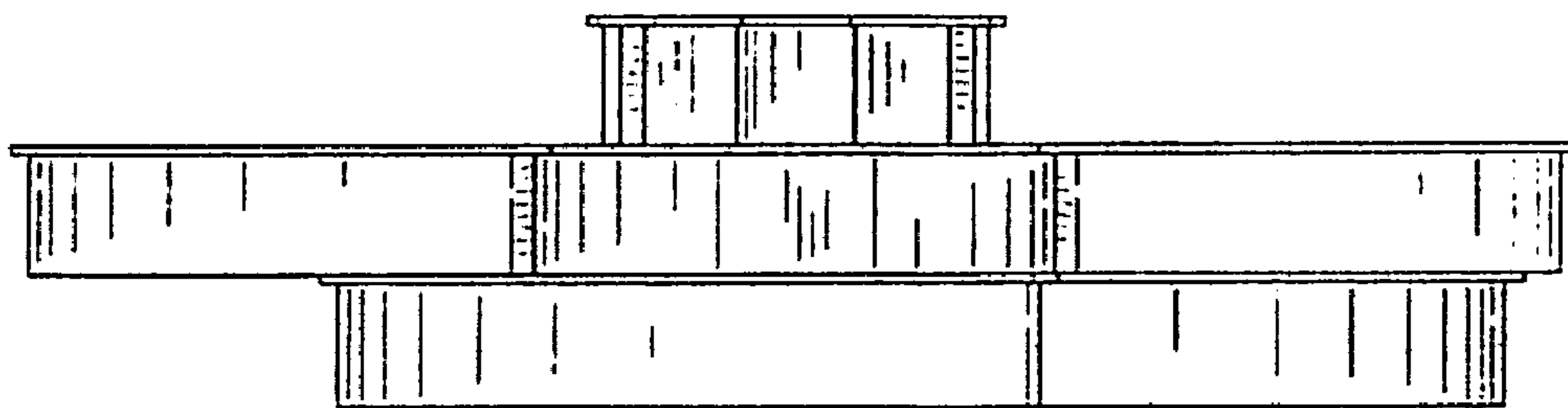

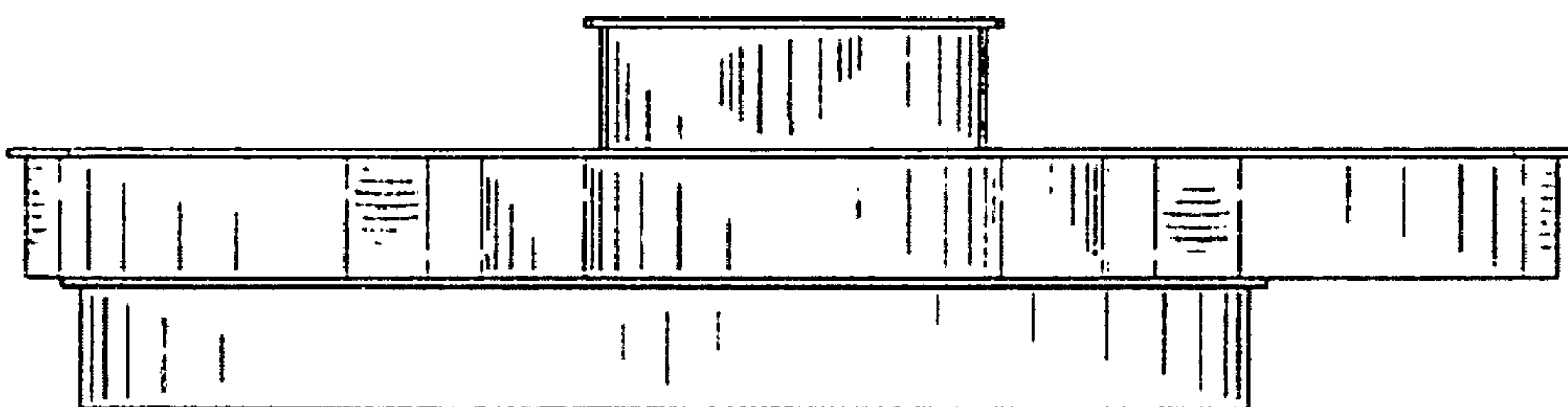

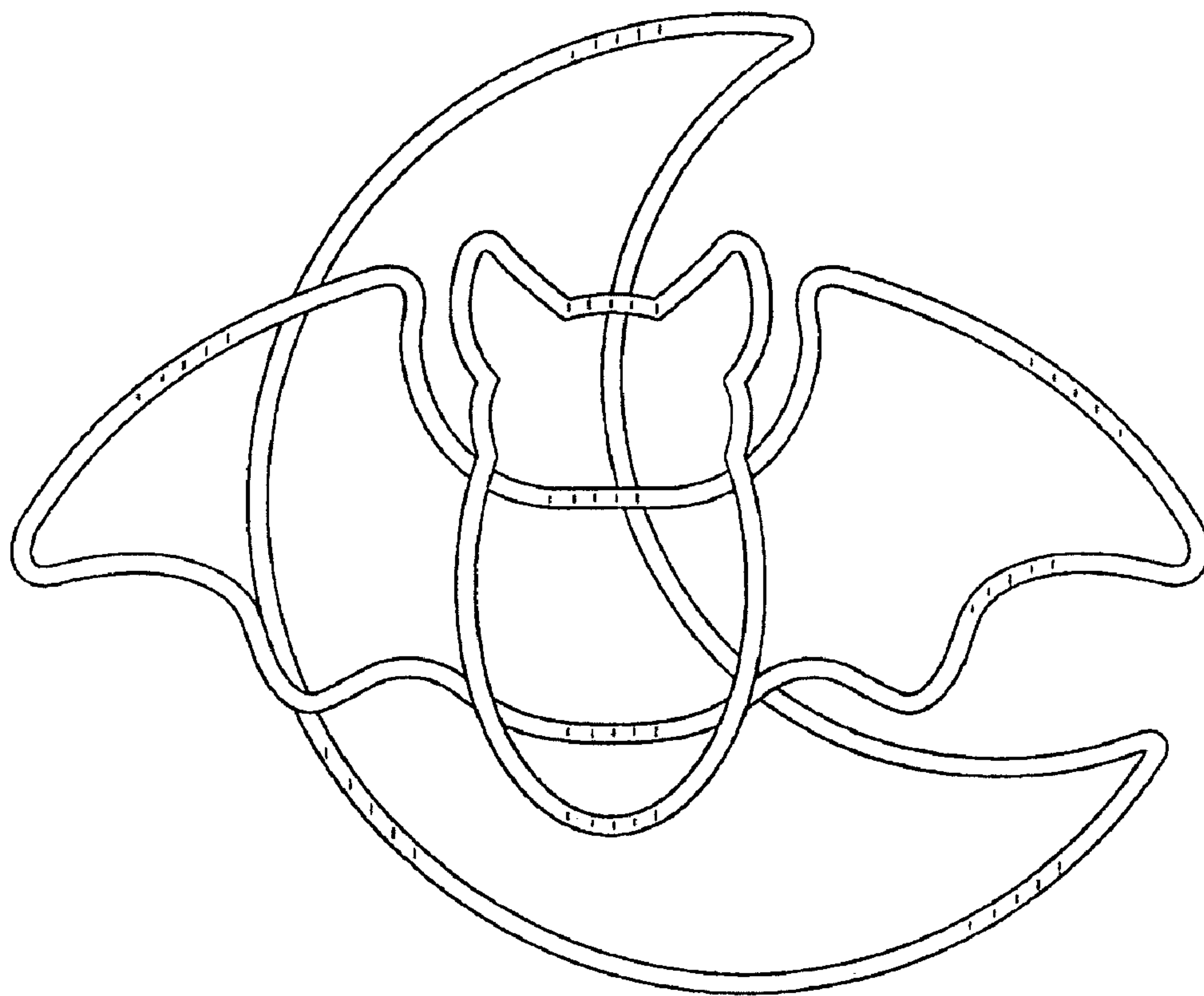

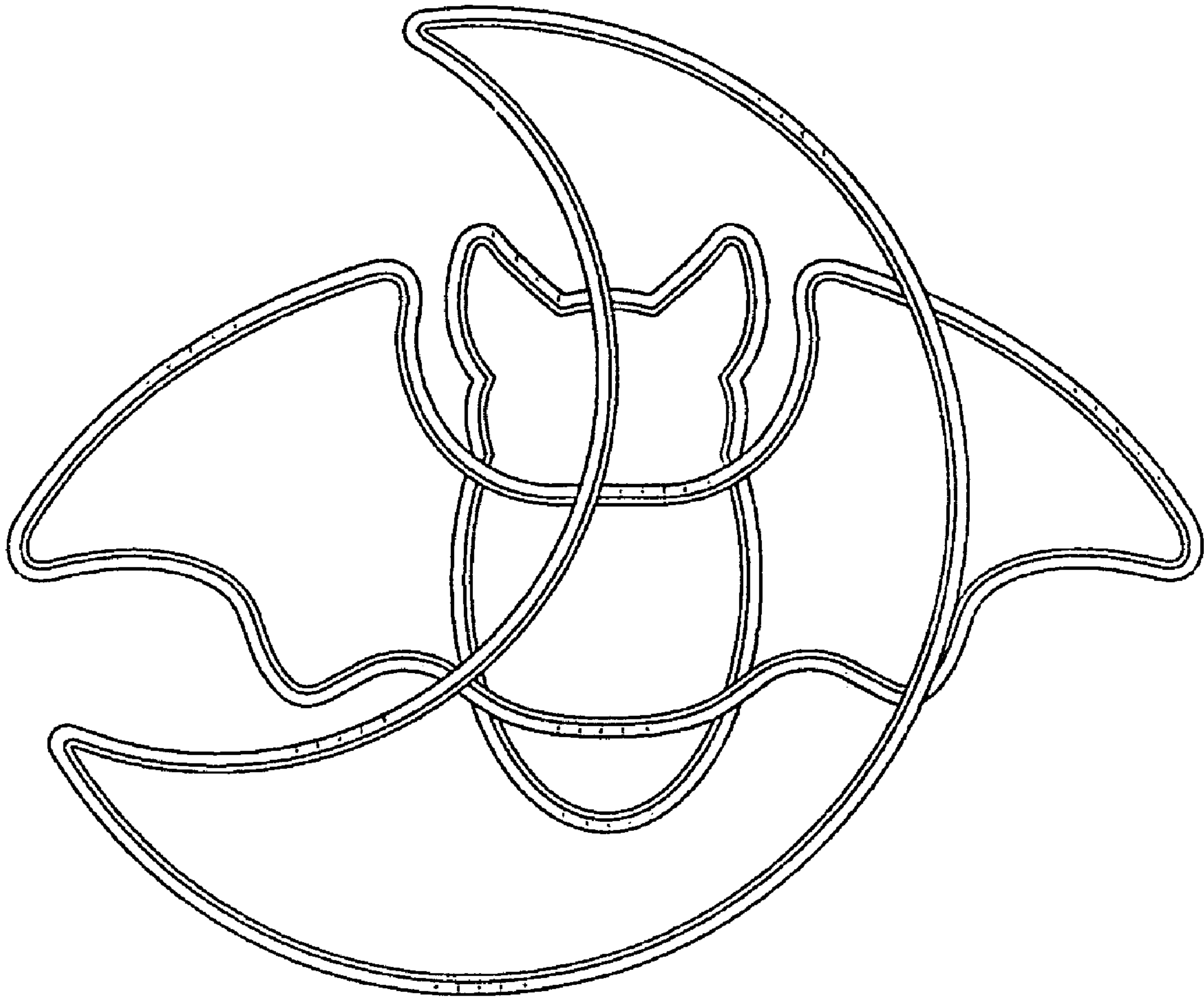

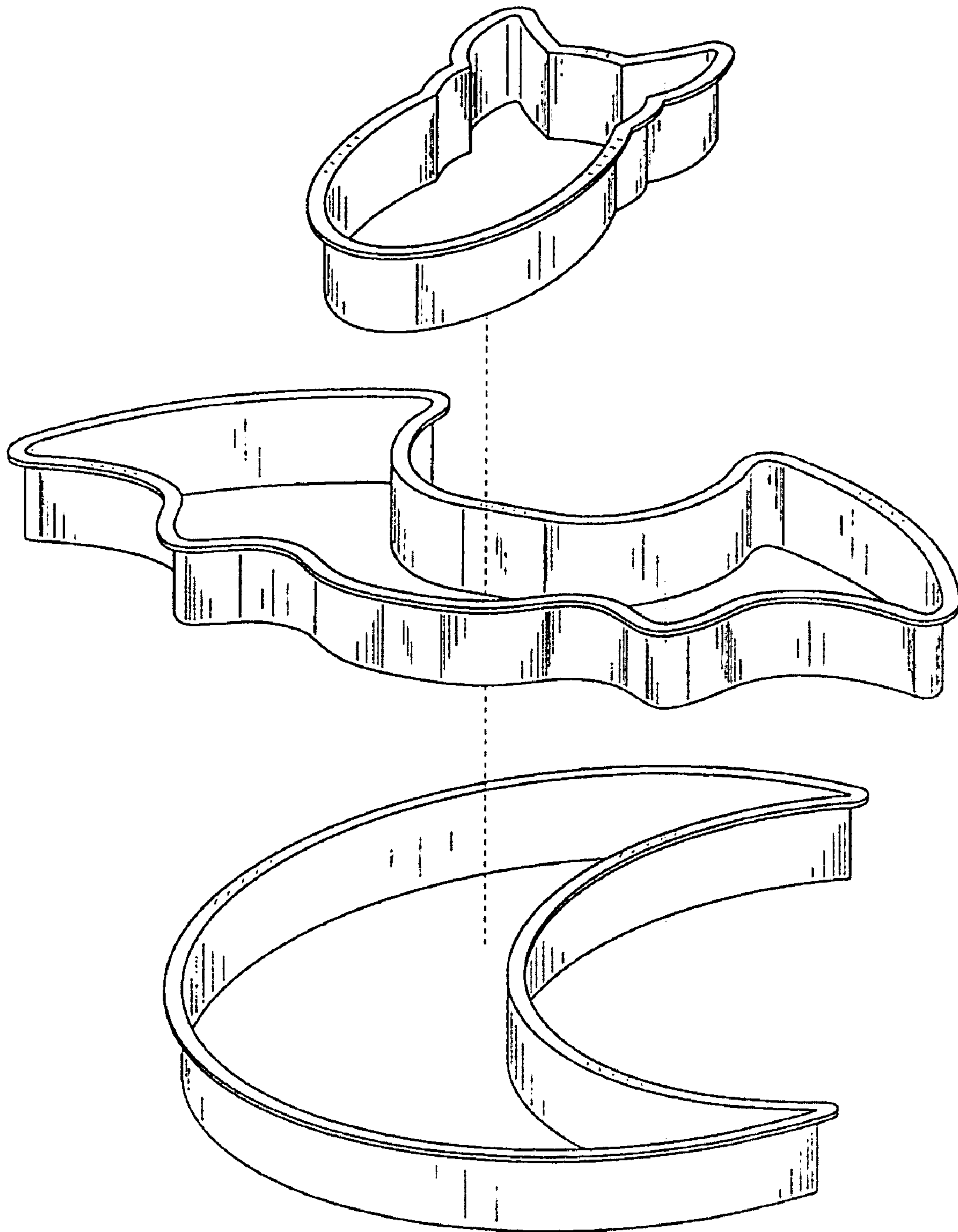
