FIG. 1 is a top plan view of a polishing pad showing our new design;

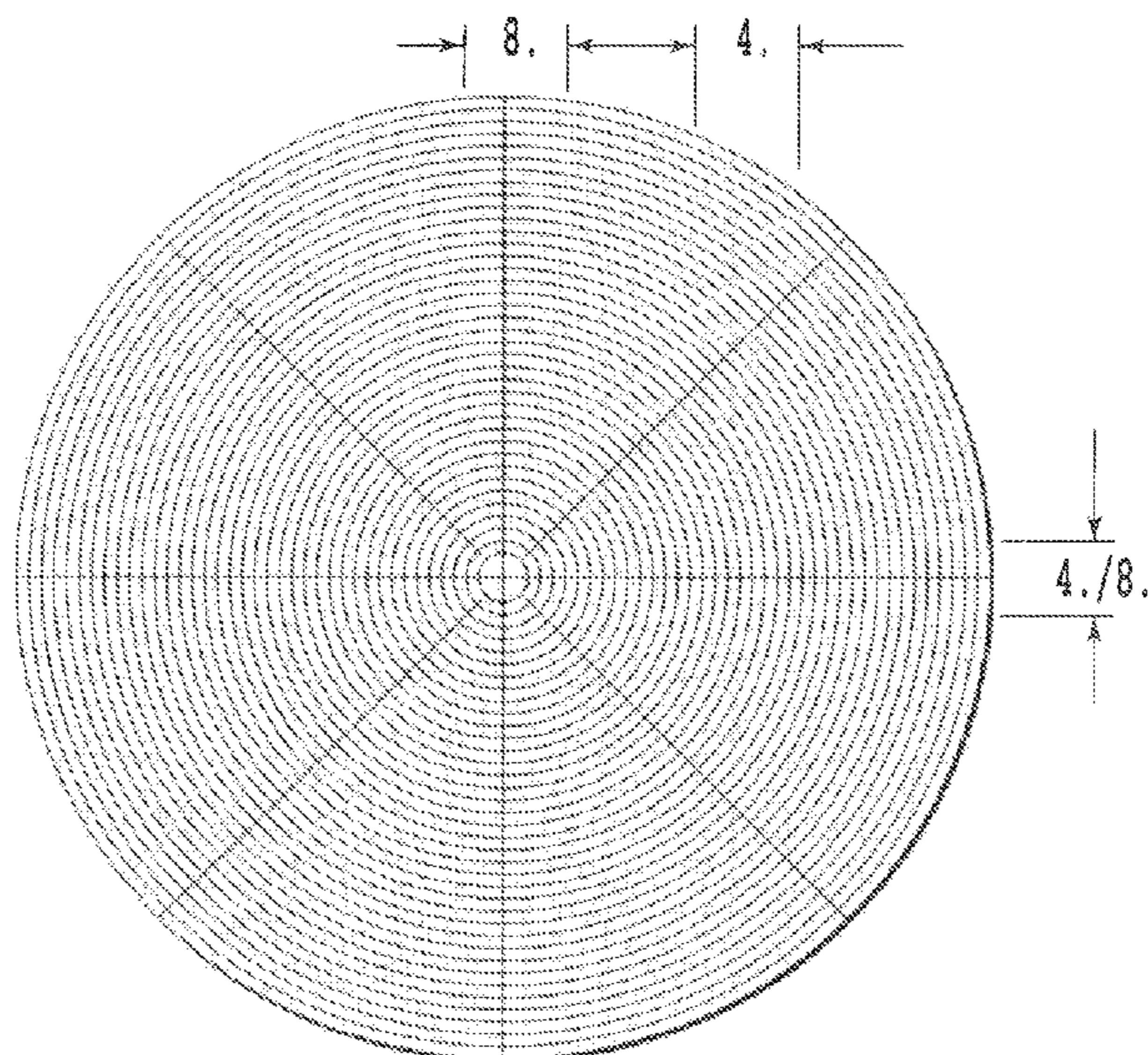

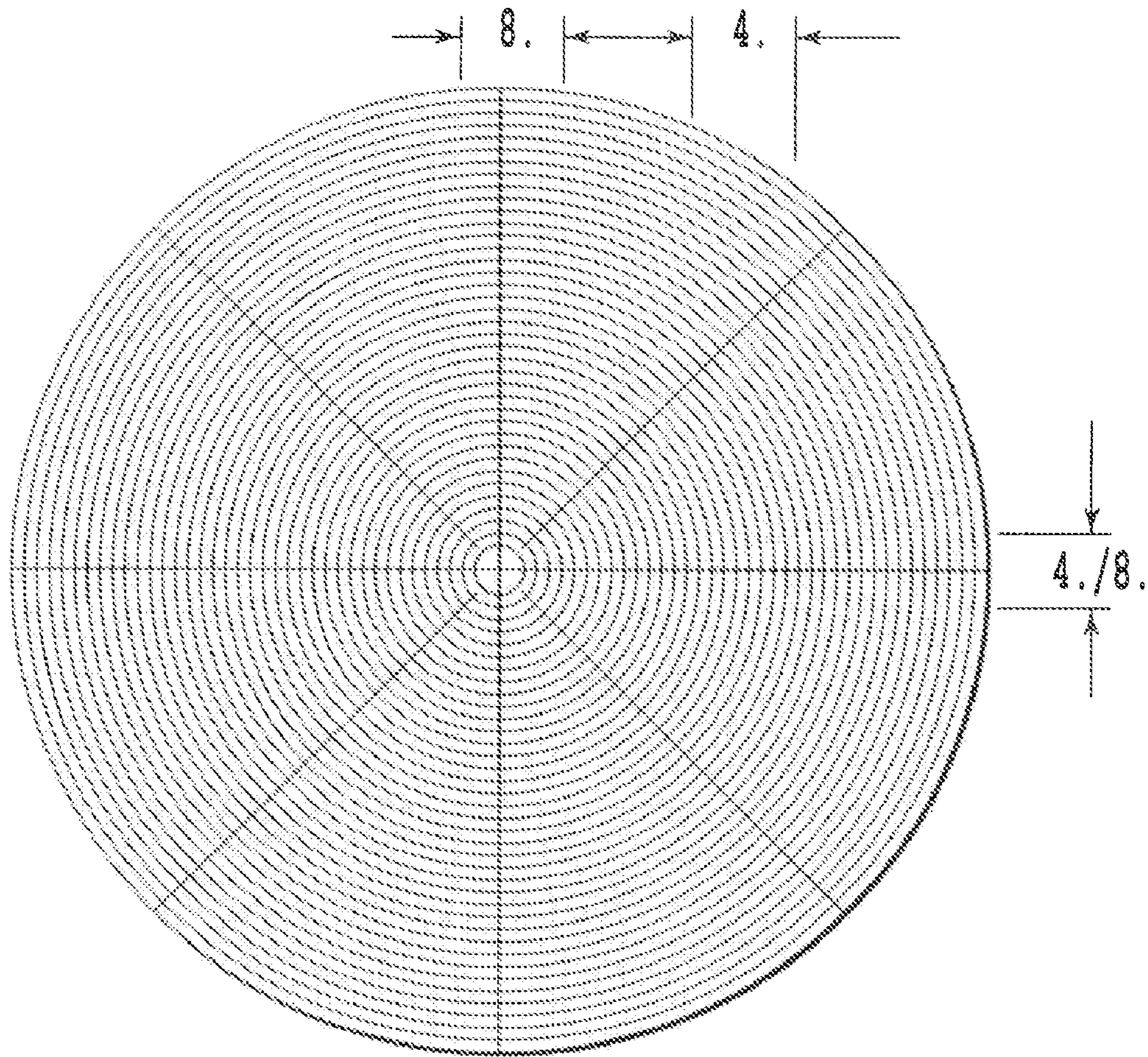

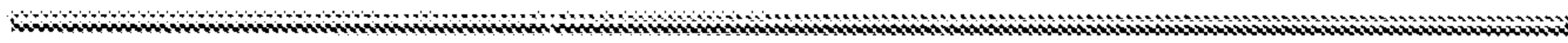

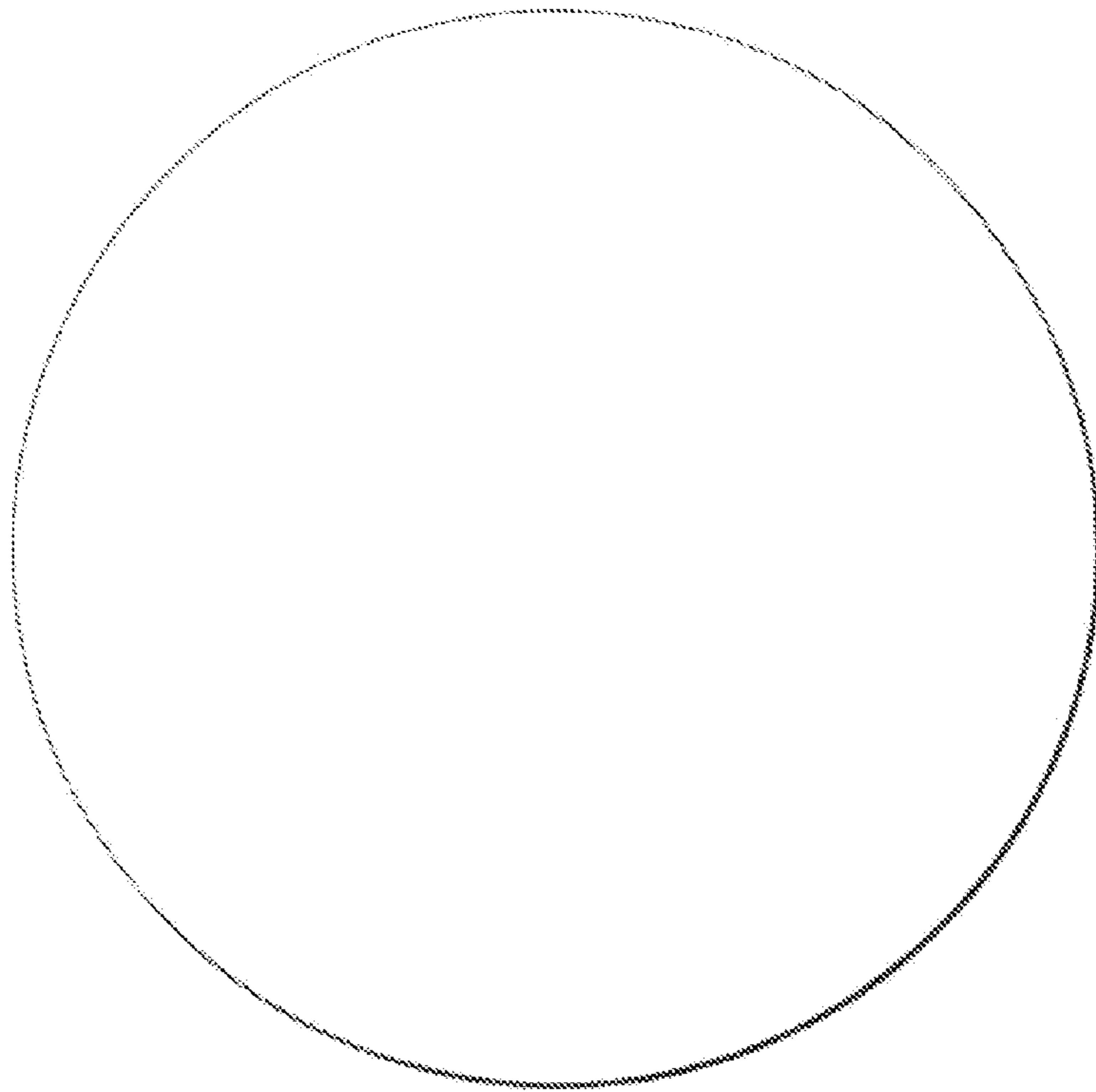

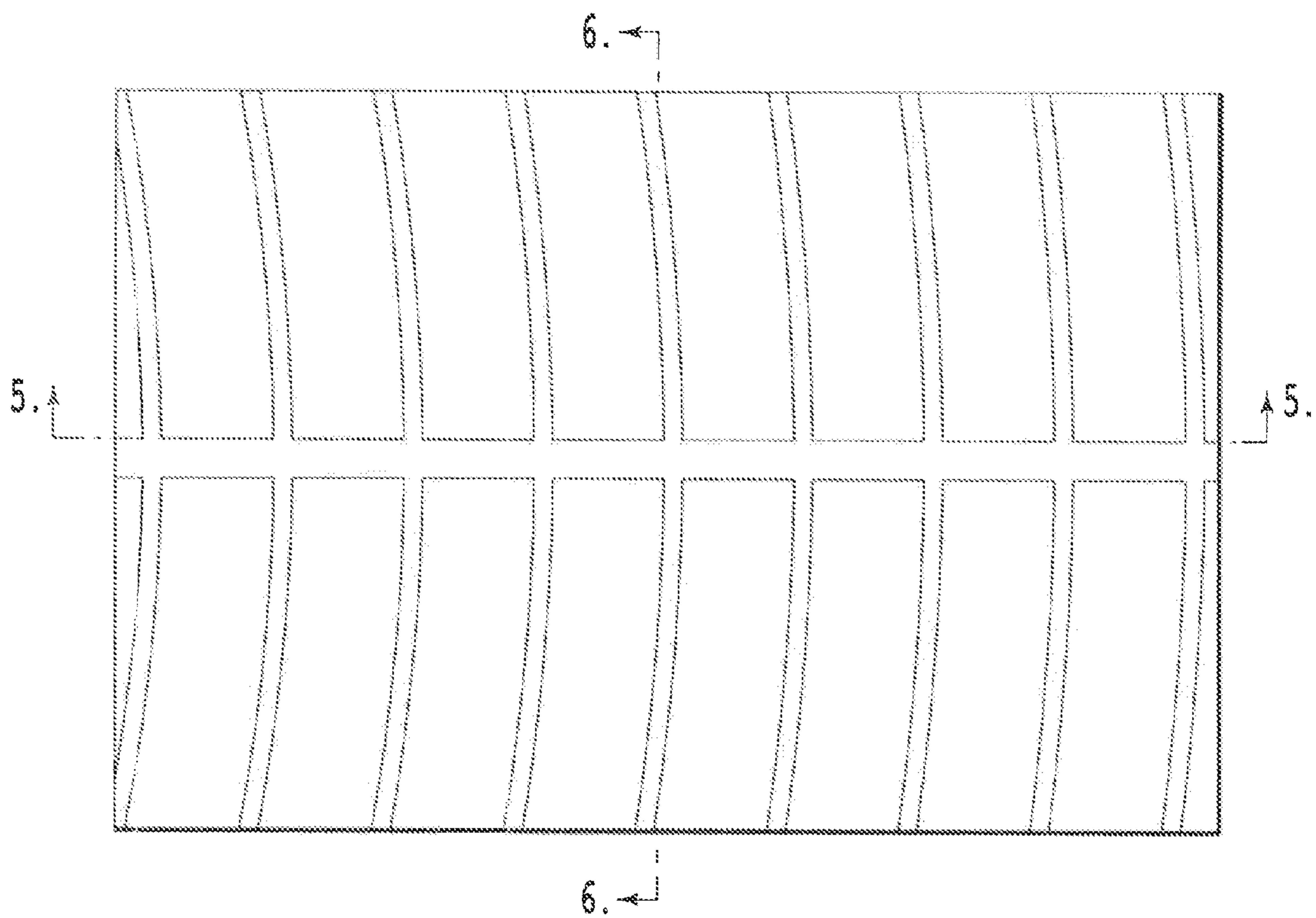

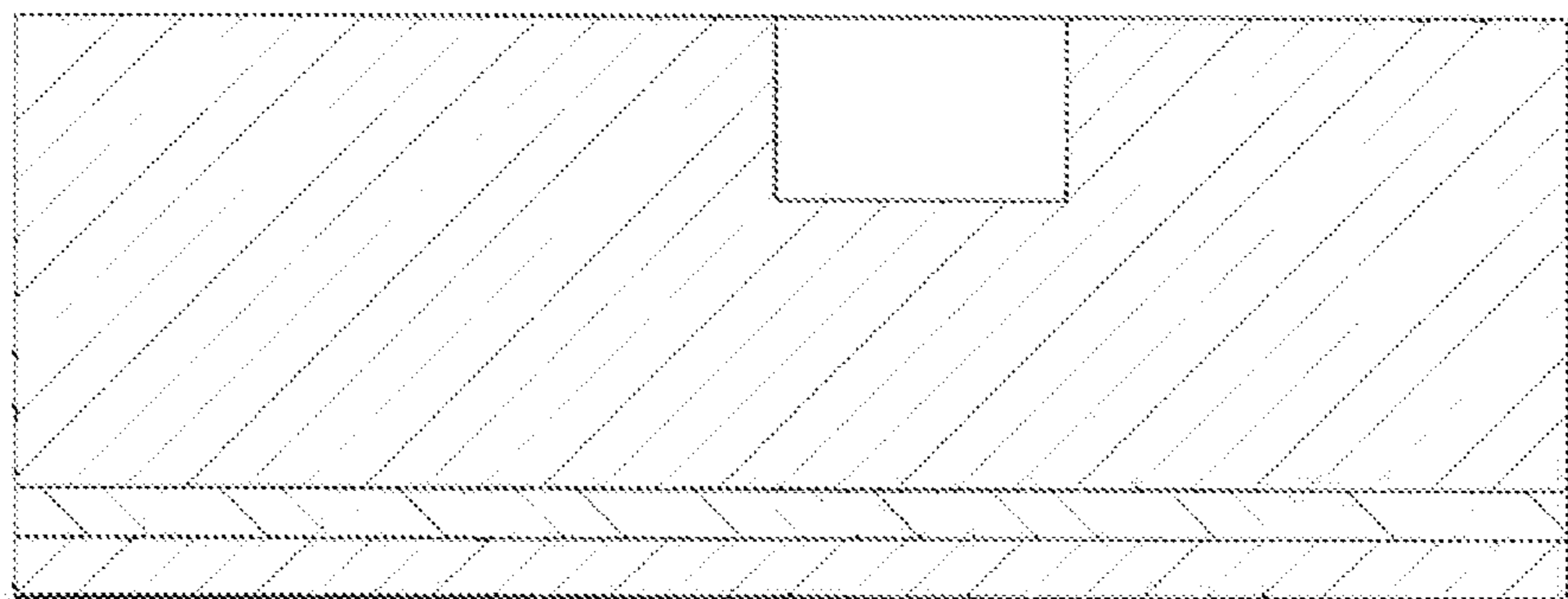

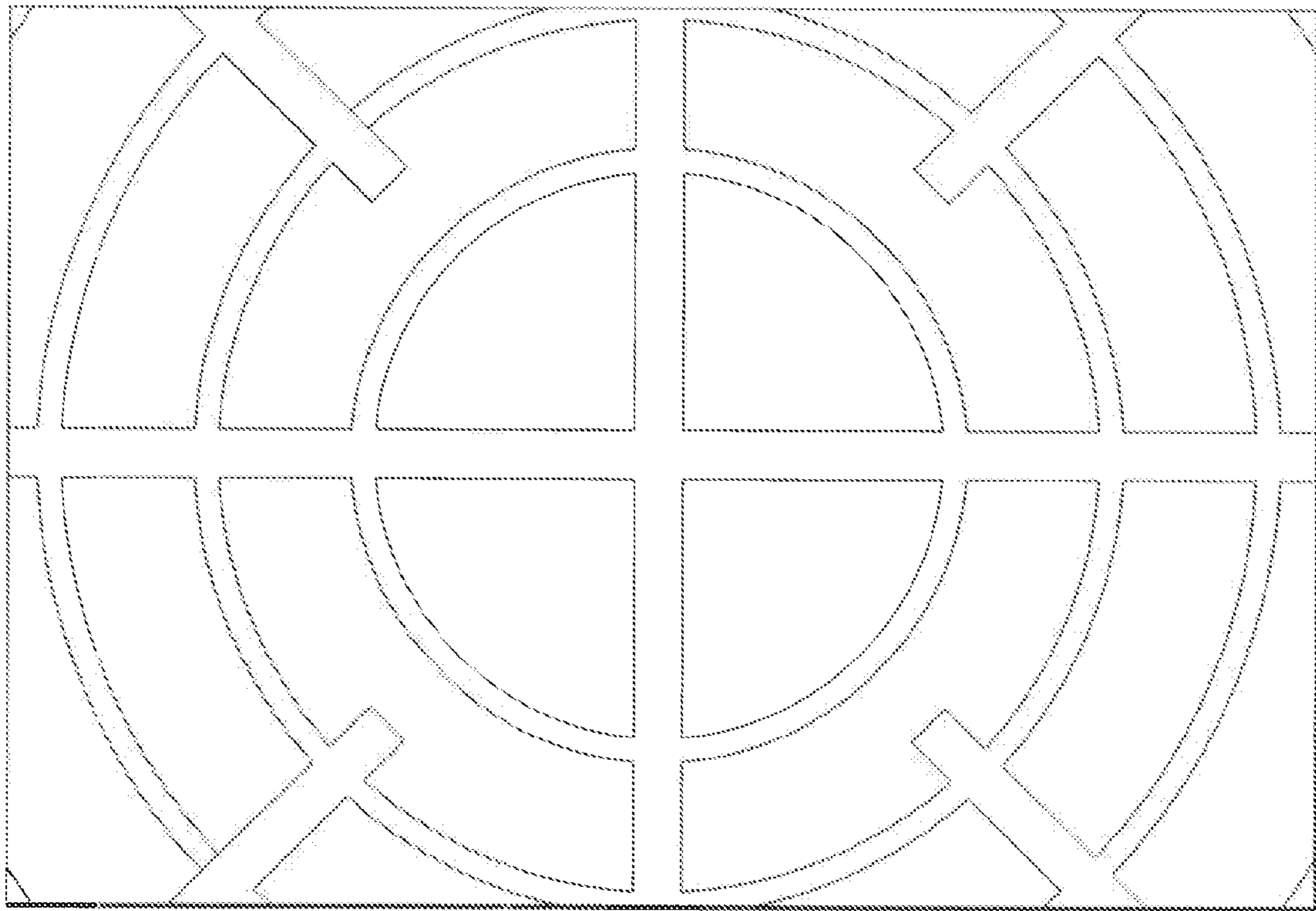
