FIG. 3 is a front elevational view thereof;

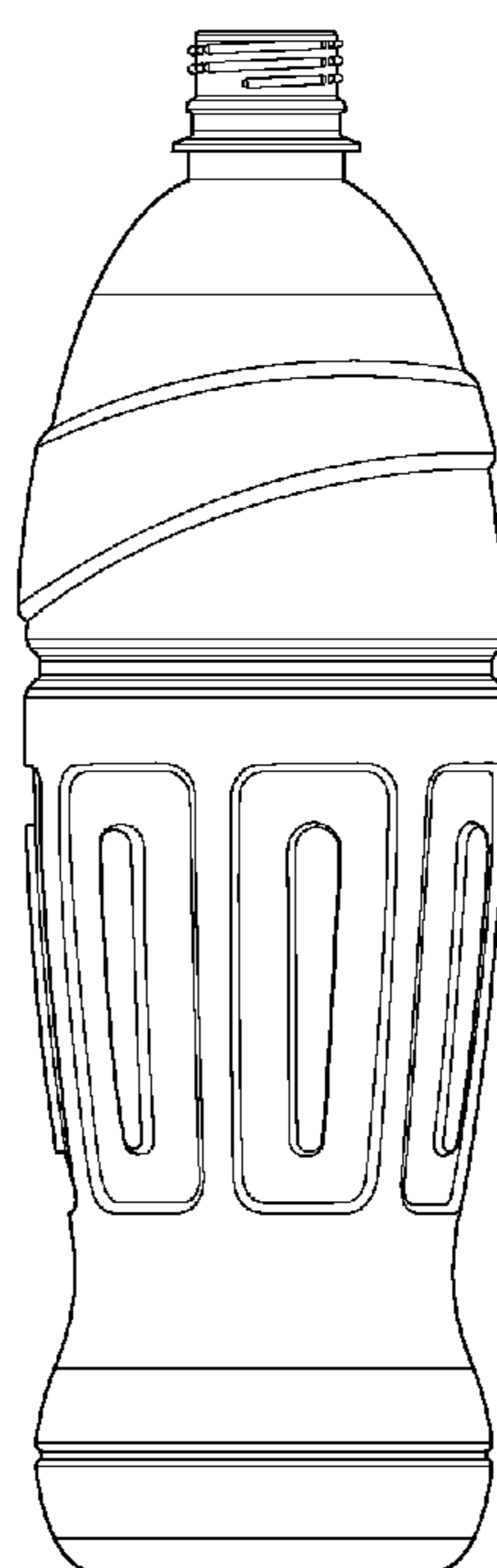
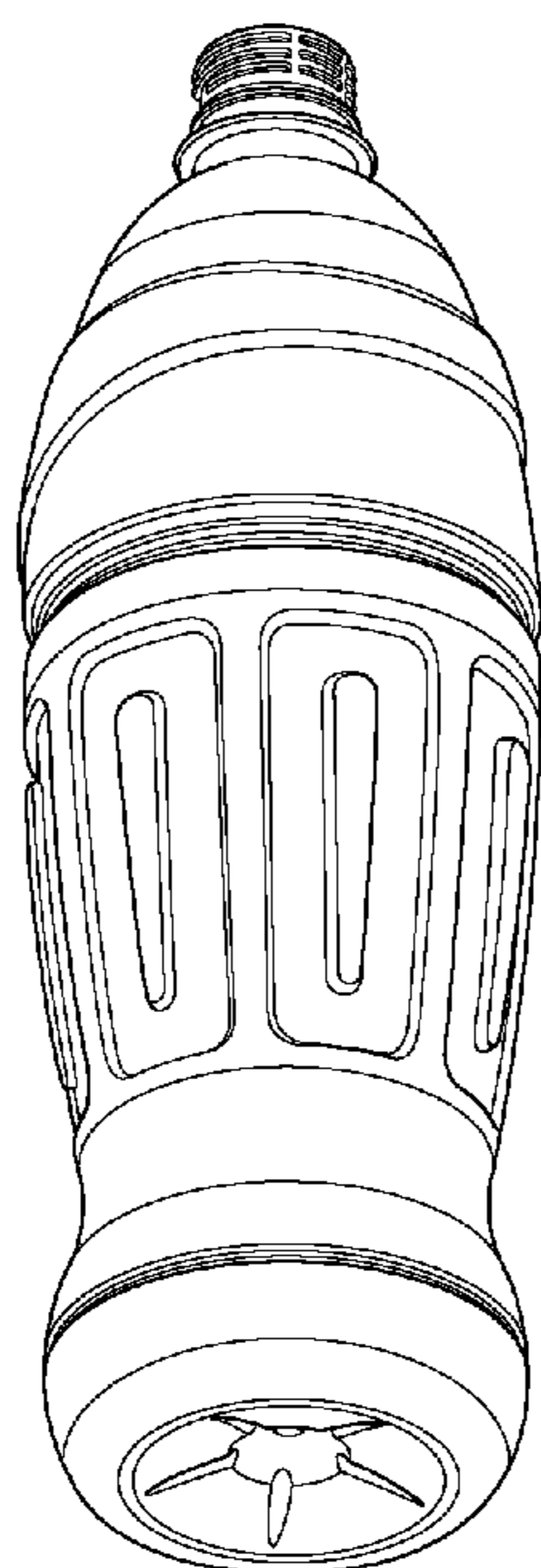
FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image except for the threads;

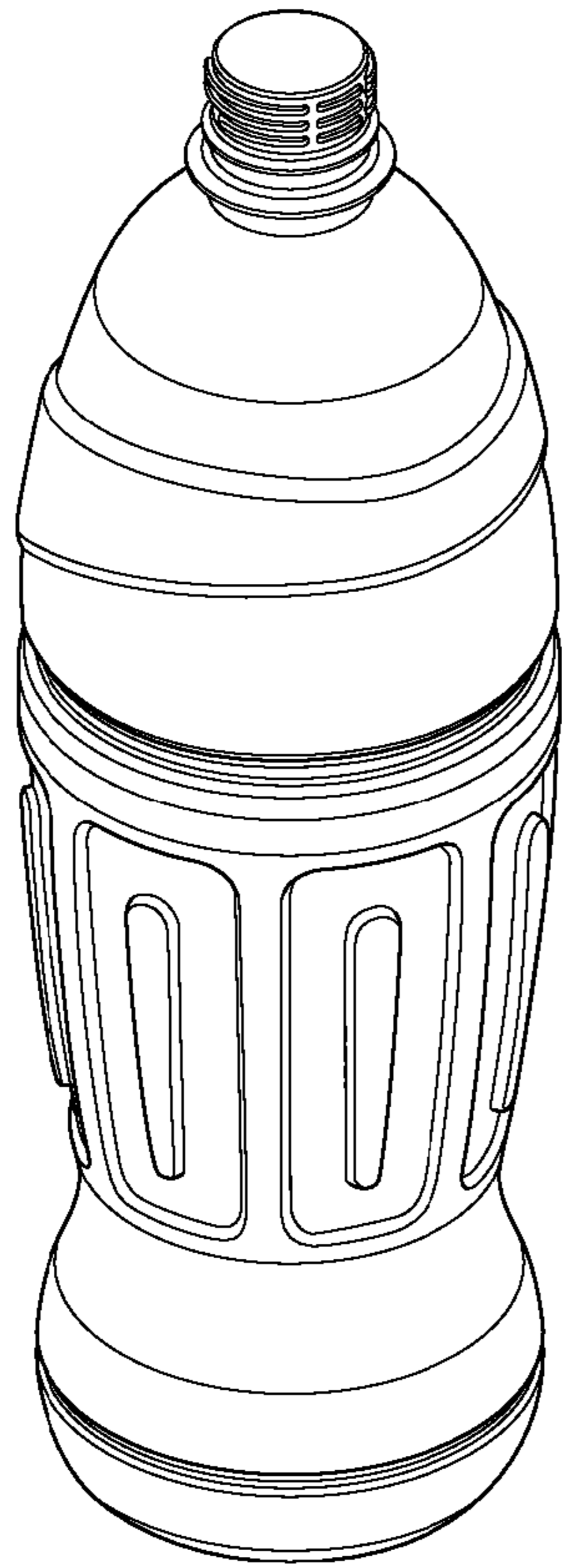
FIG. 5 is a rear elevational view thereof;

FIG. 6 is a top plan view thereof; and,

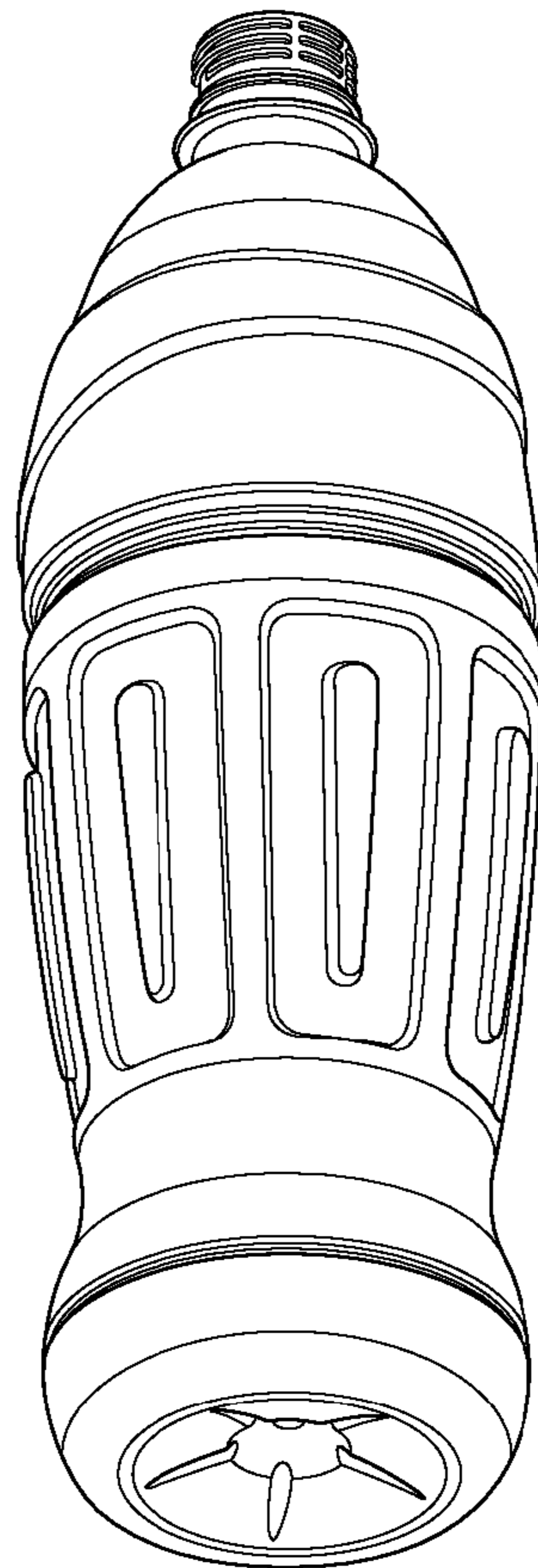
FIG. 7 is a bottom plan view thereof.

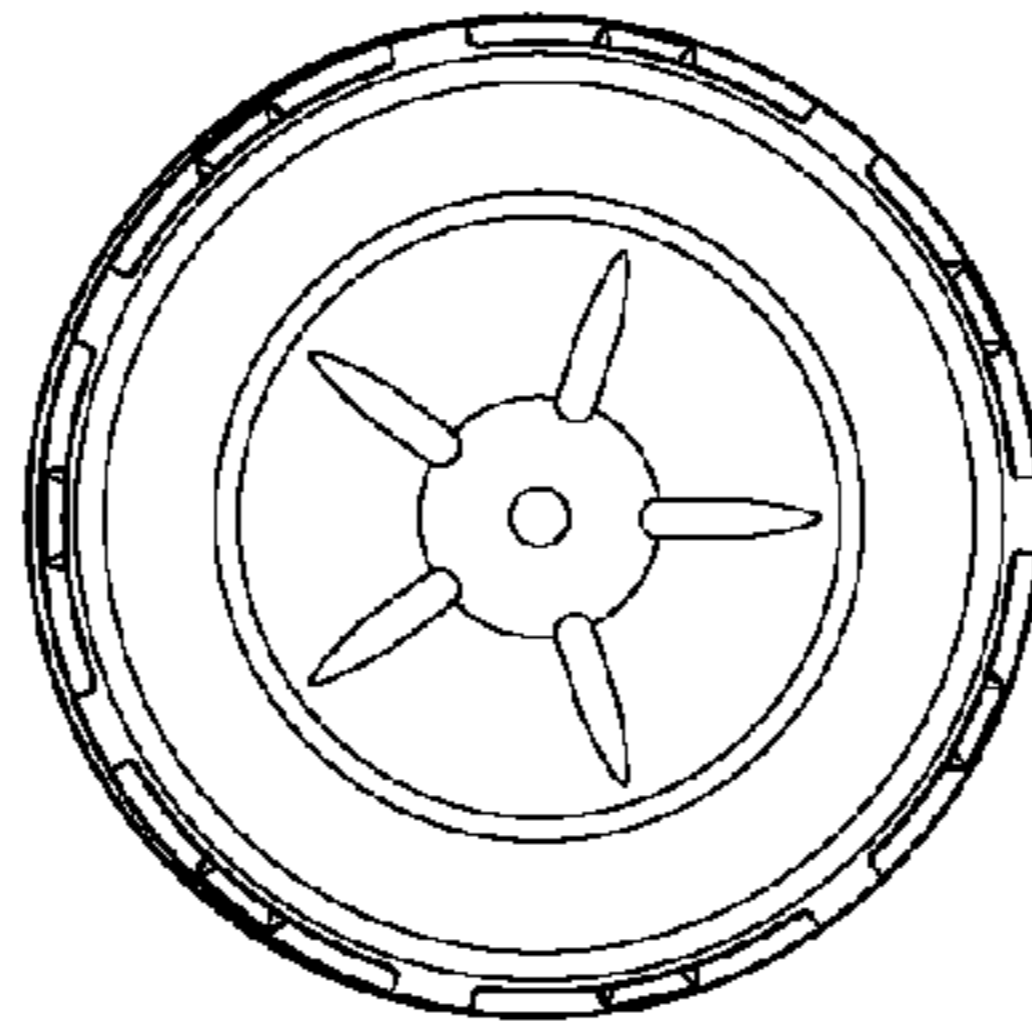




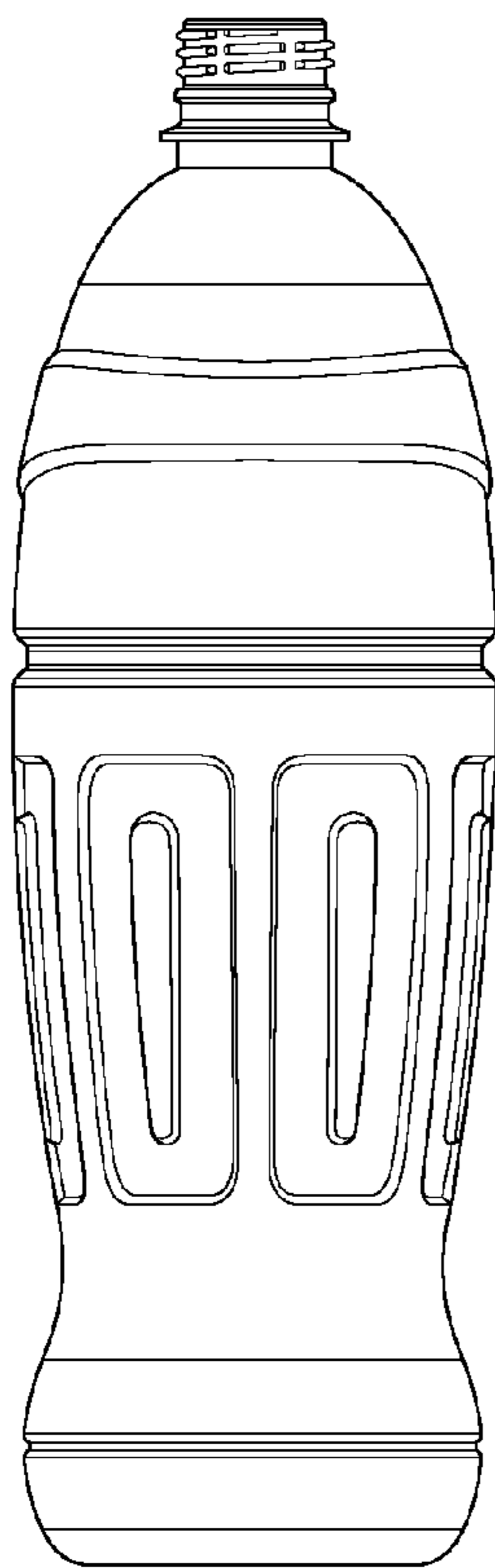

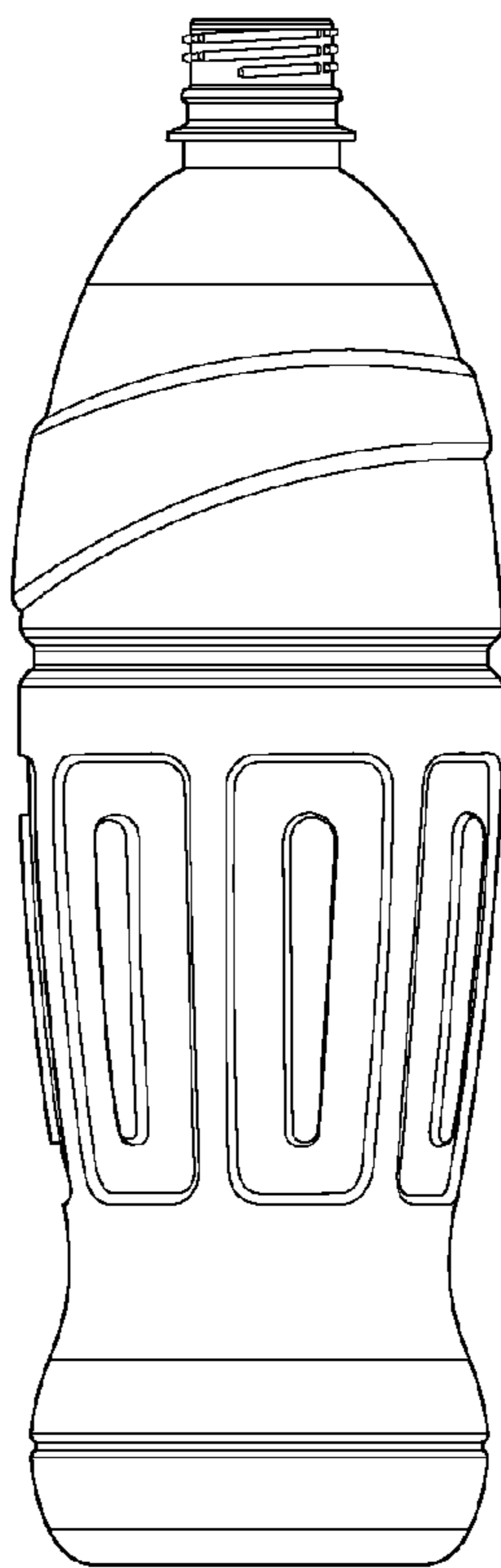

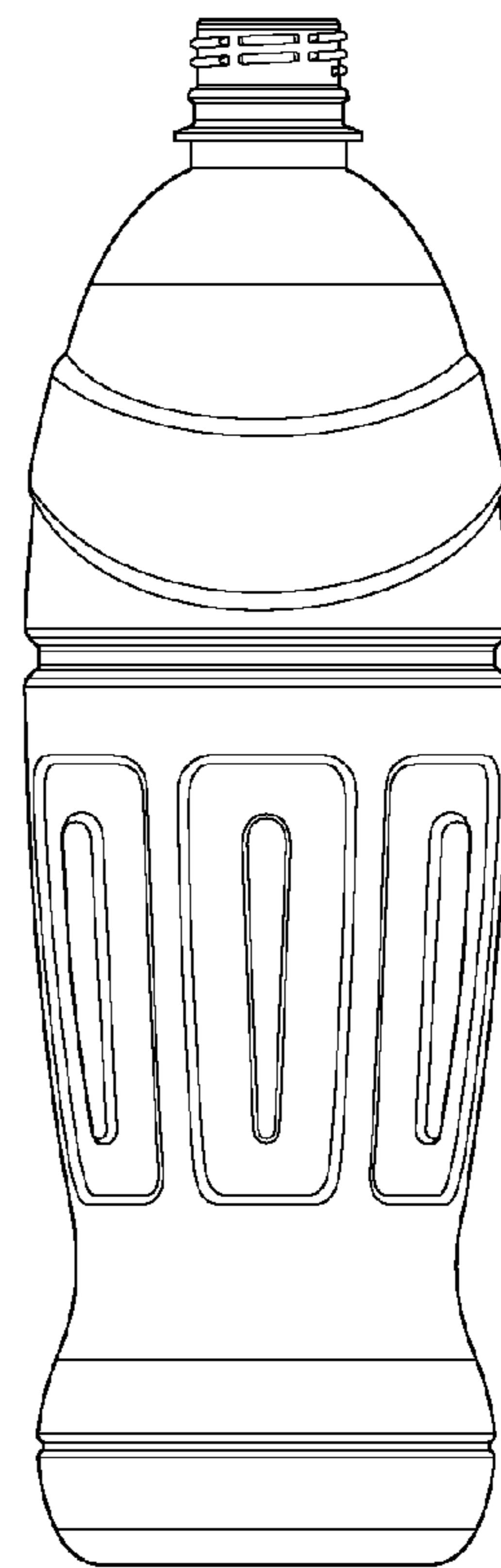

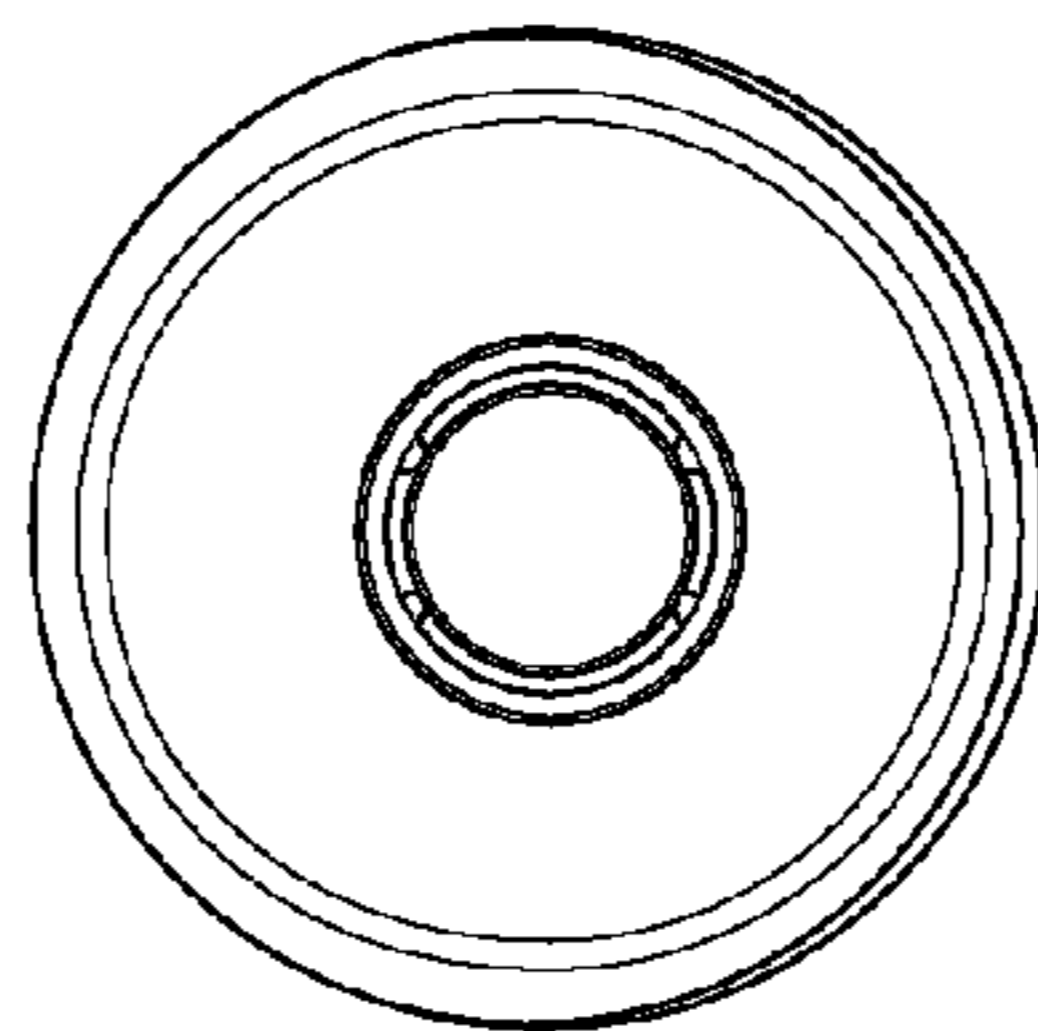
