FIG. 3 is a right side view of the tanning lotion bottle.

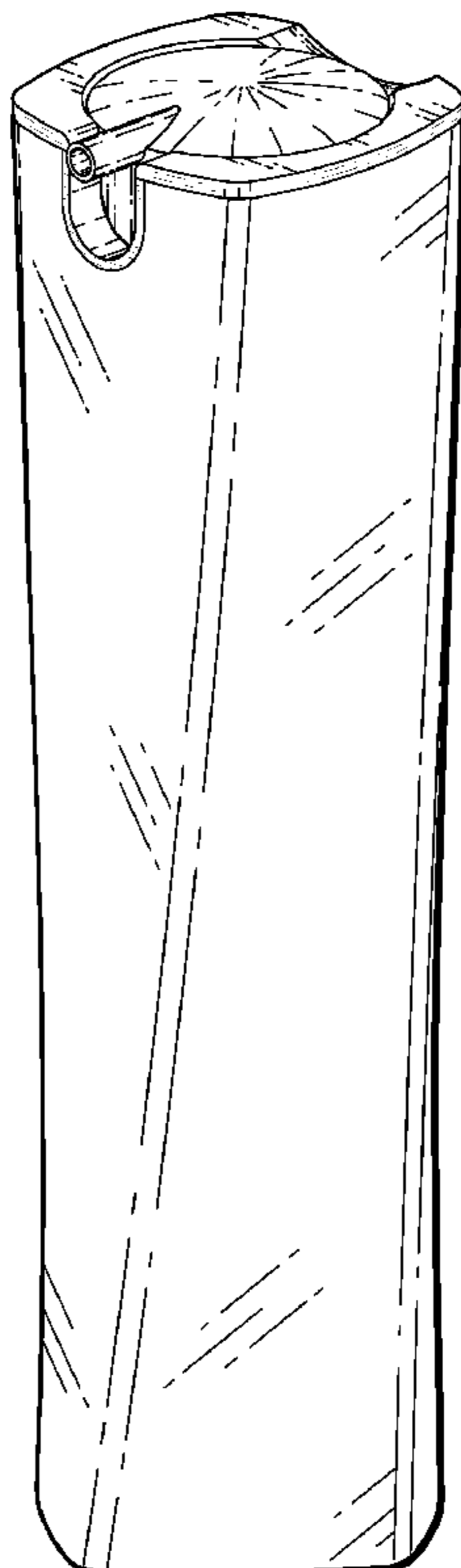
FIG. 4 is a left view of the tanning lotion bottle.

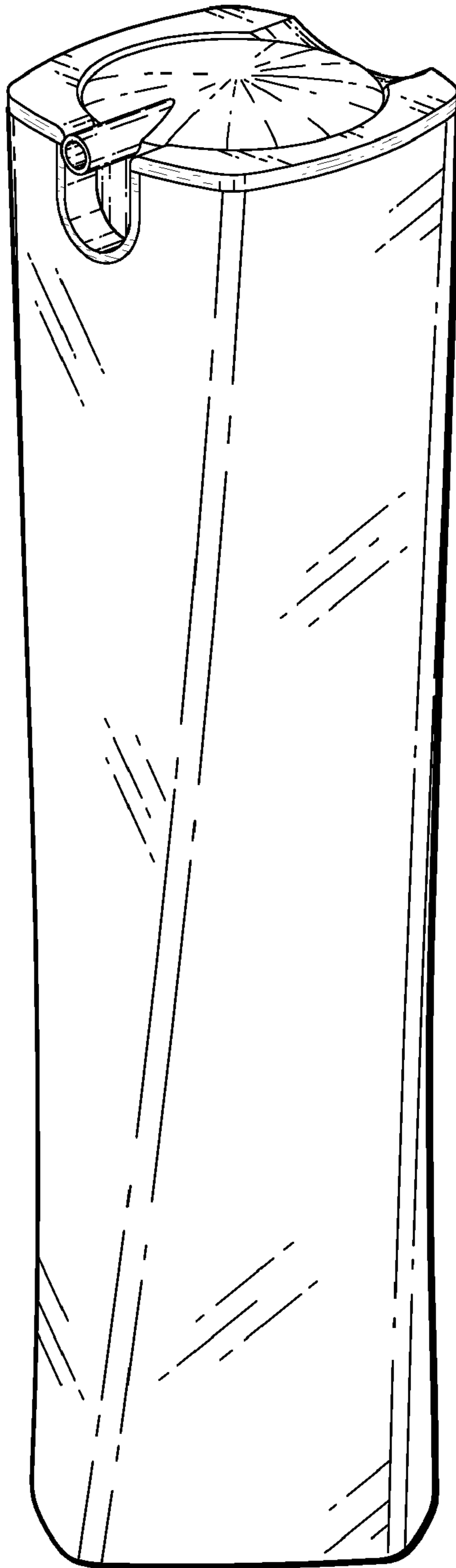

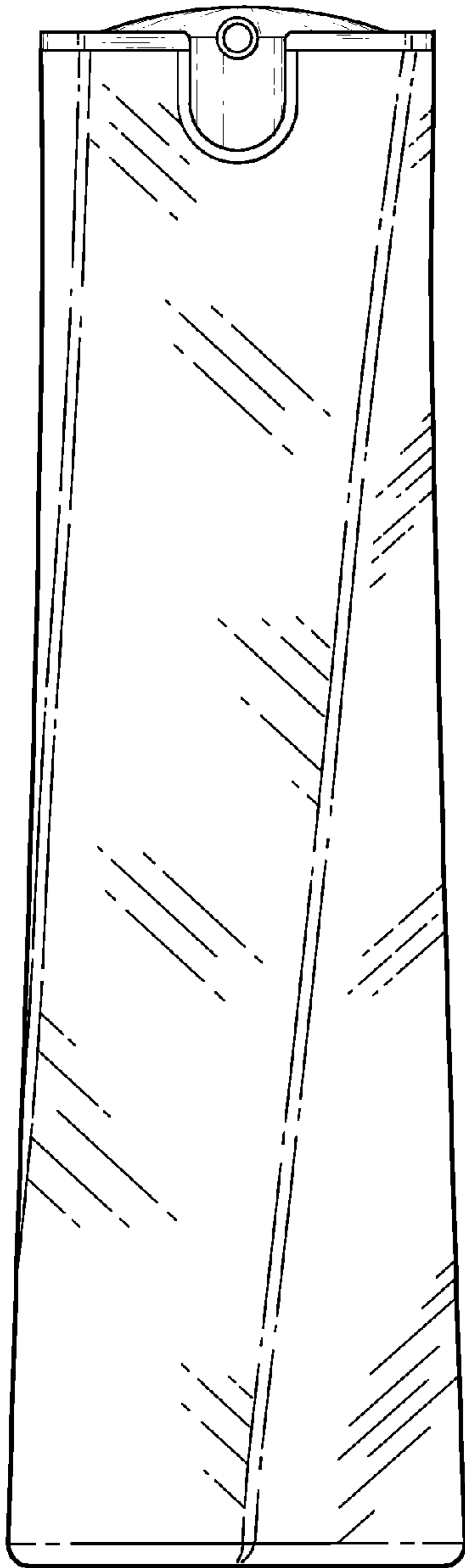

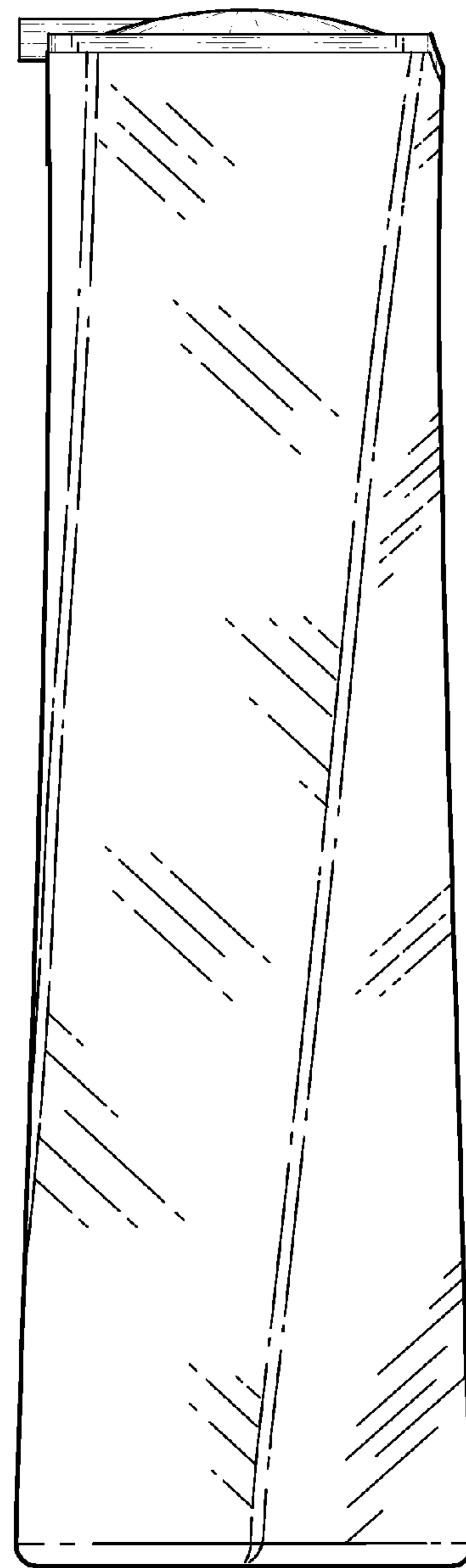

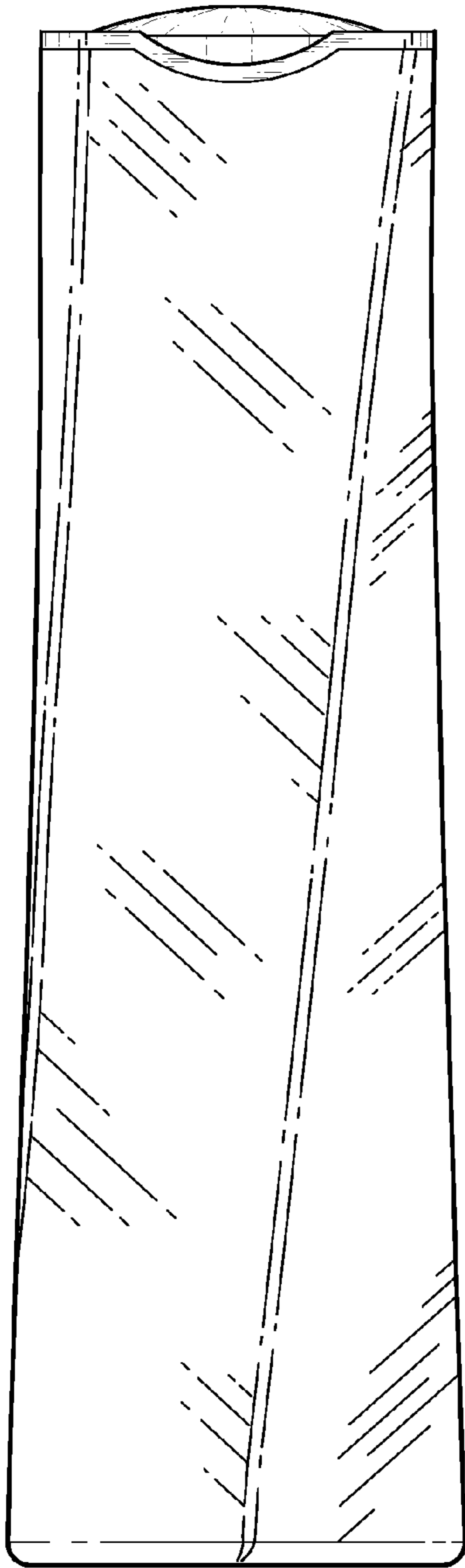

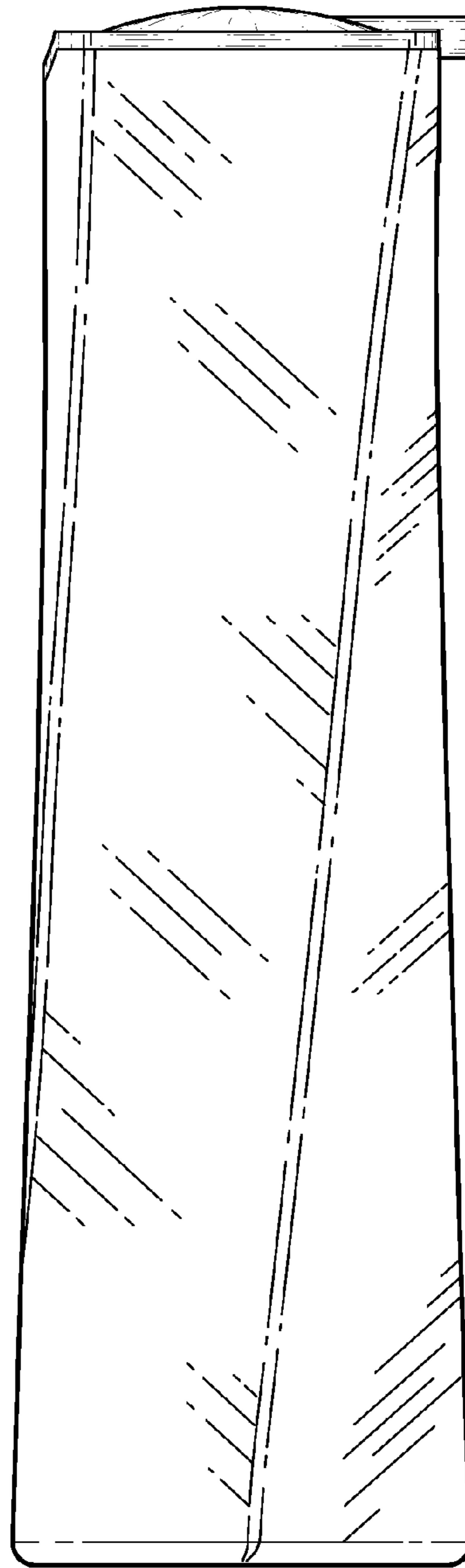

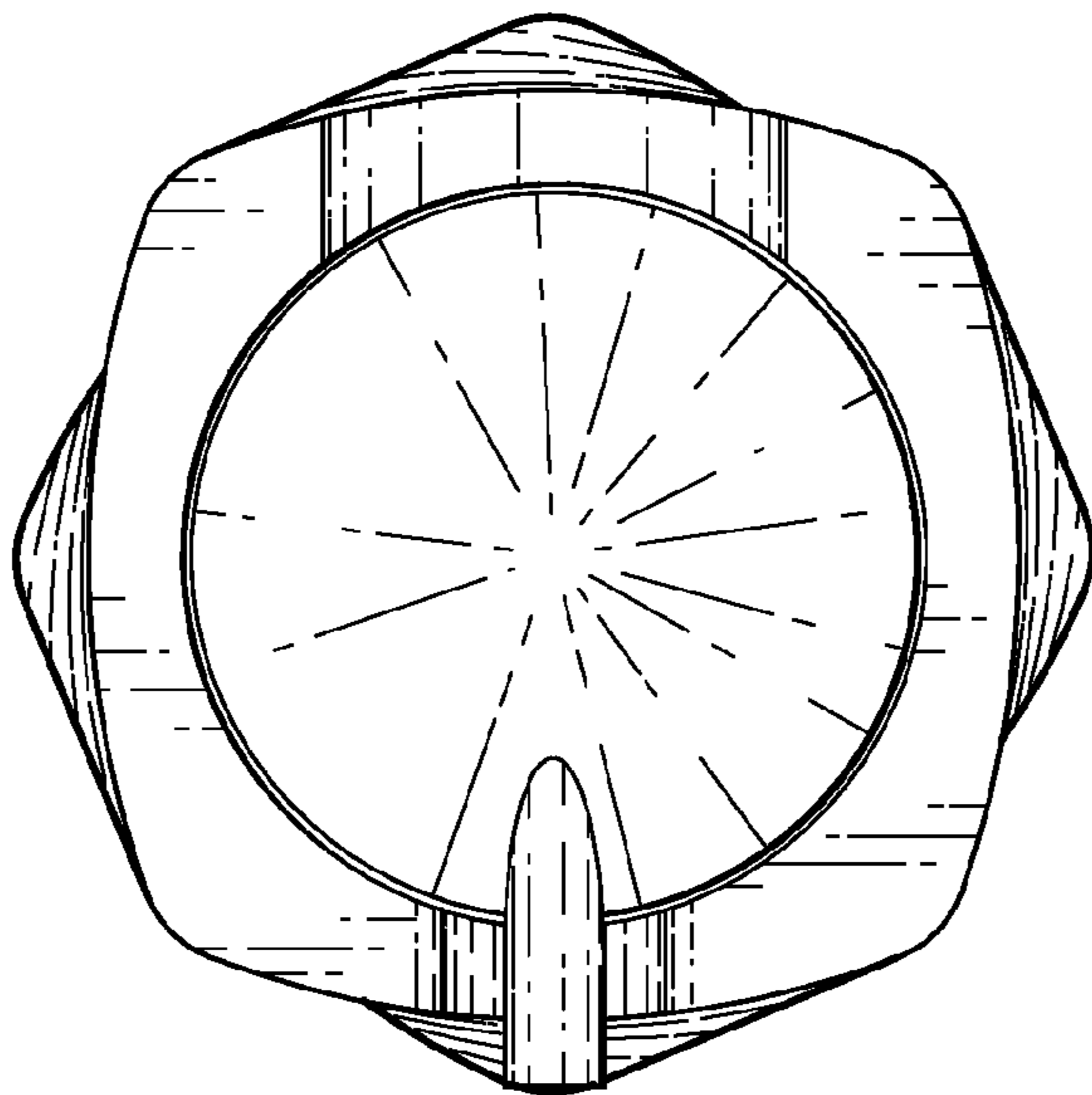

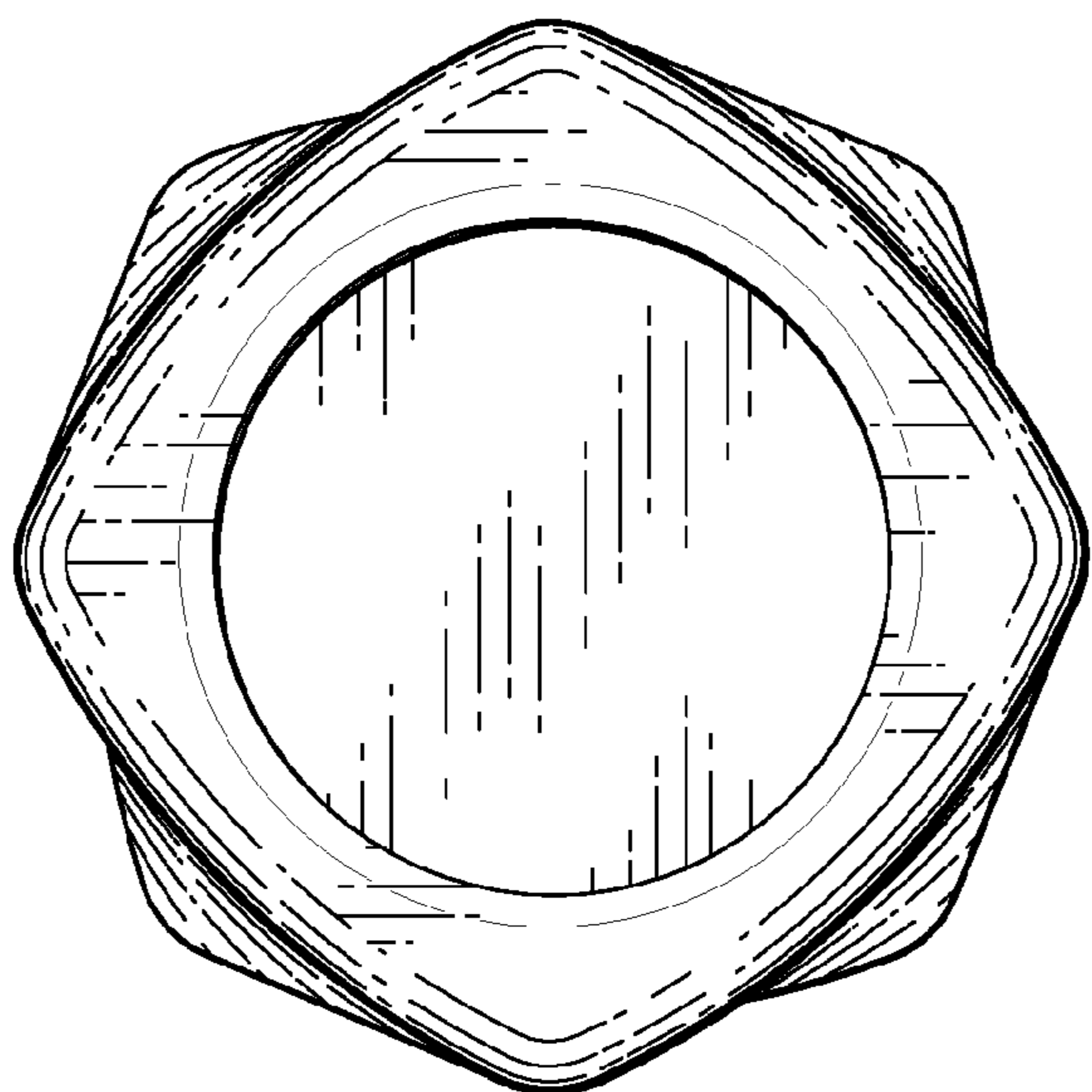
