(57) **CLAIM**

The ornamental design for an electronically controlled brake system unit with expansion module, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an electronically controlled brake system unit with expansion module showing the new design;

FIG. 2 is a right side elevational view thereof, with environmental association matter shown in broken lines for illustrative purposes only;

FIG. 3 is a top plan view thereof, with environmental association matter shown in broken lines for illustrative purposes only;

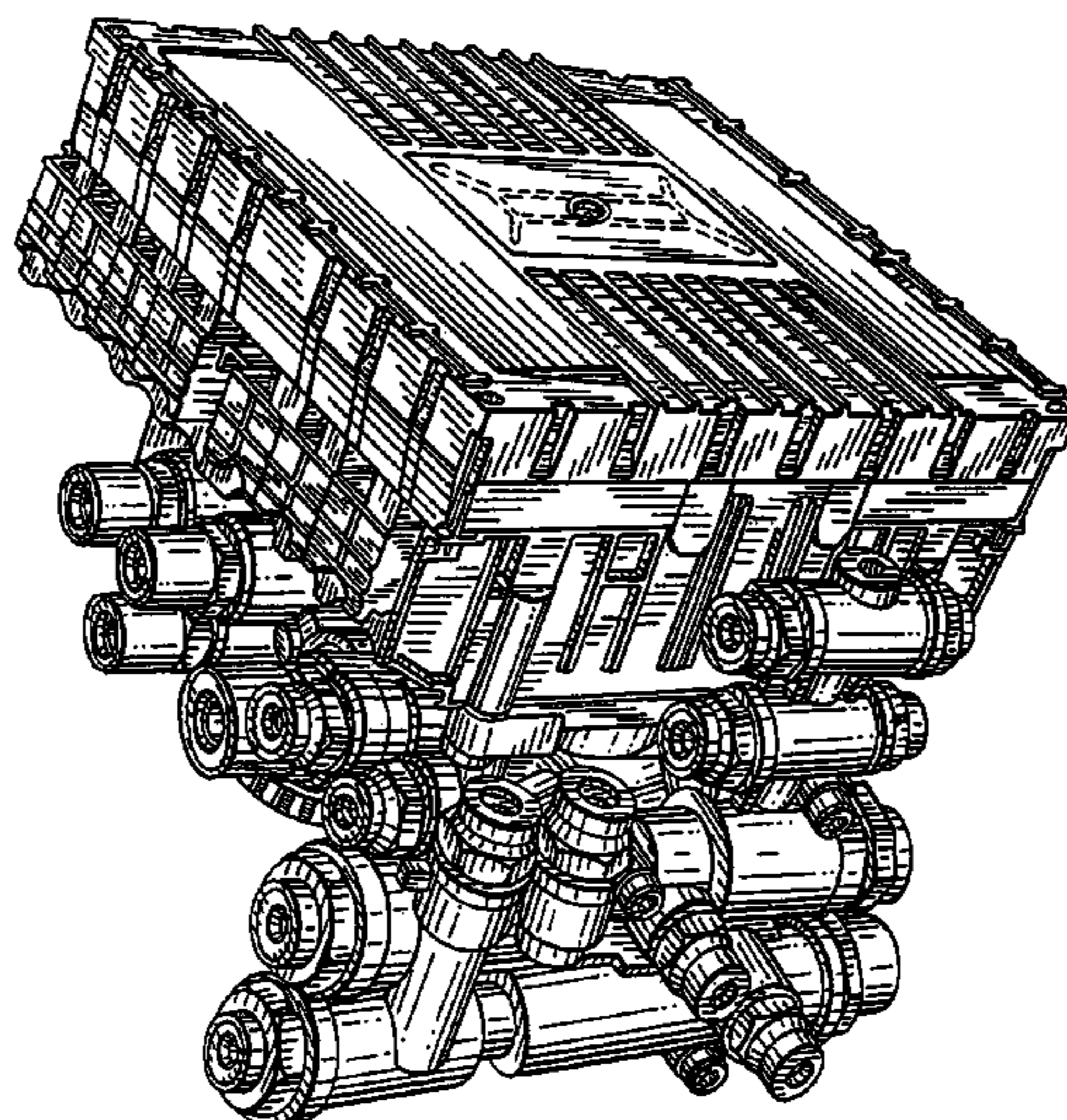
FIG. 4 is a bottom plan view thereof;

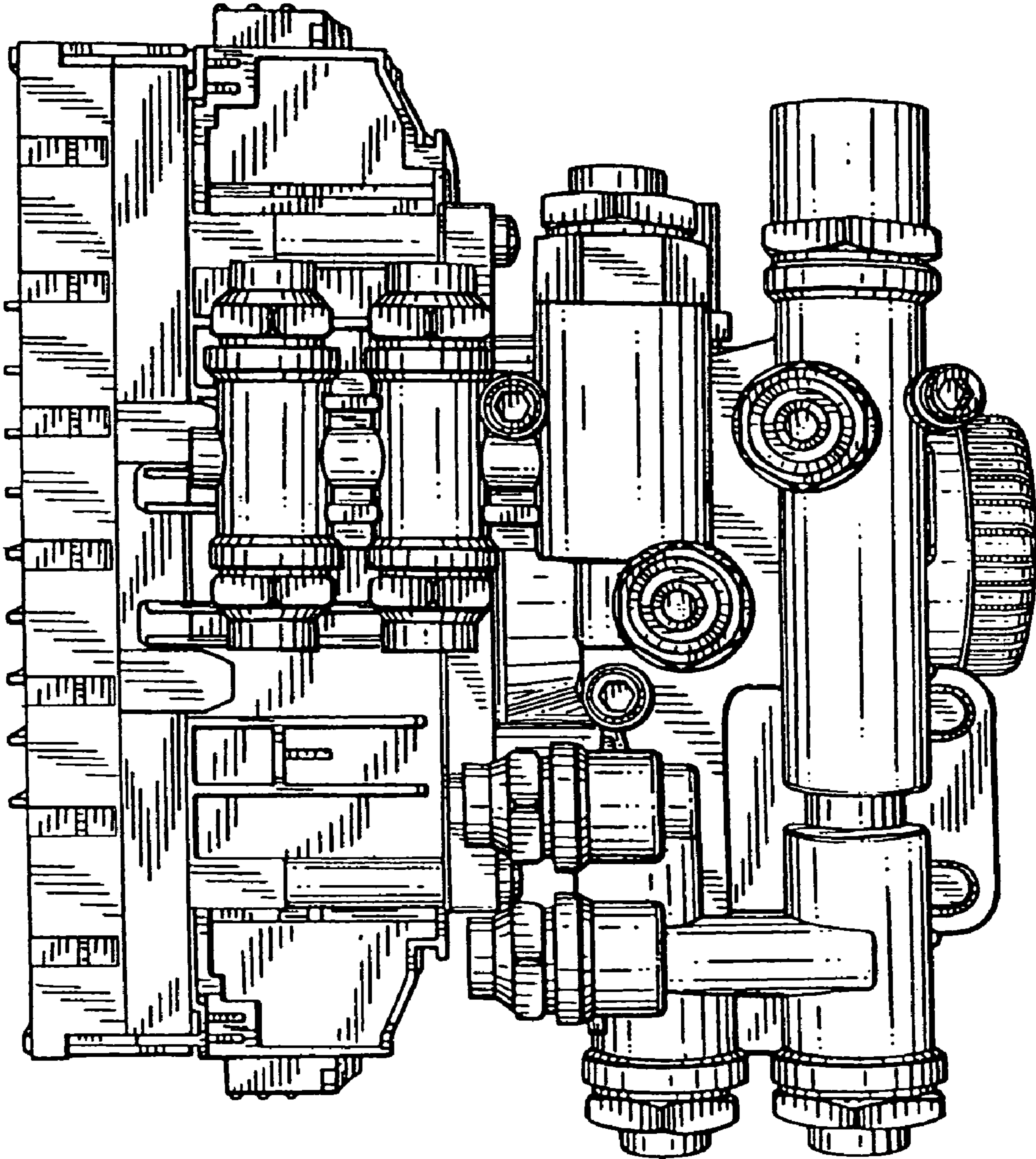

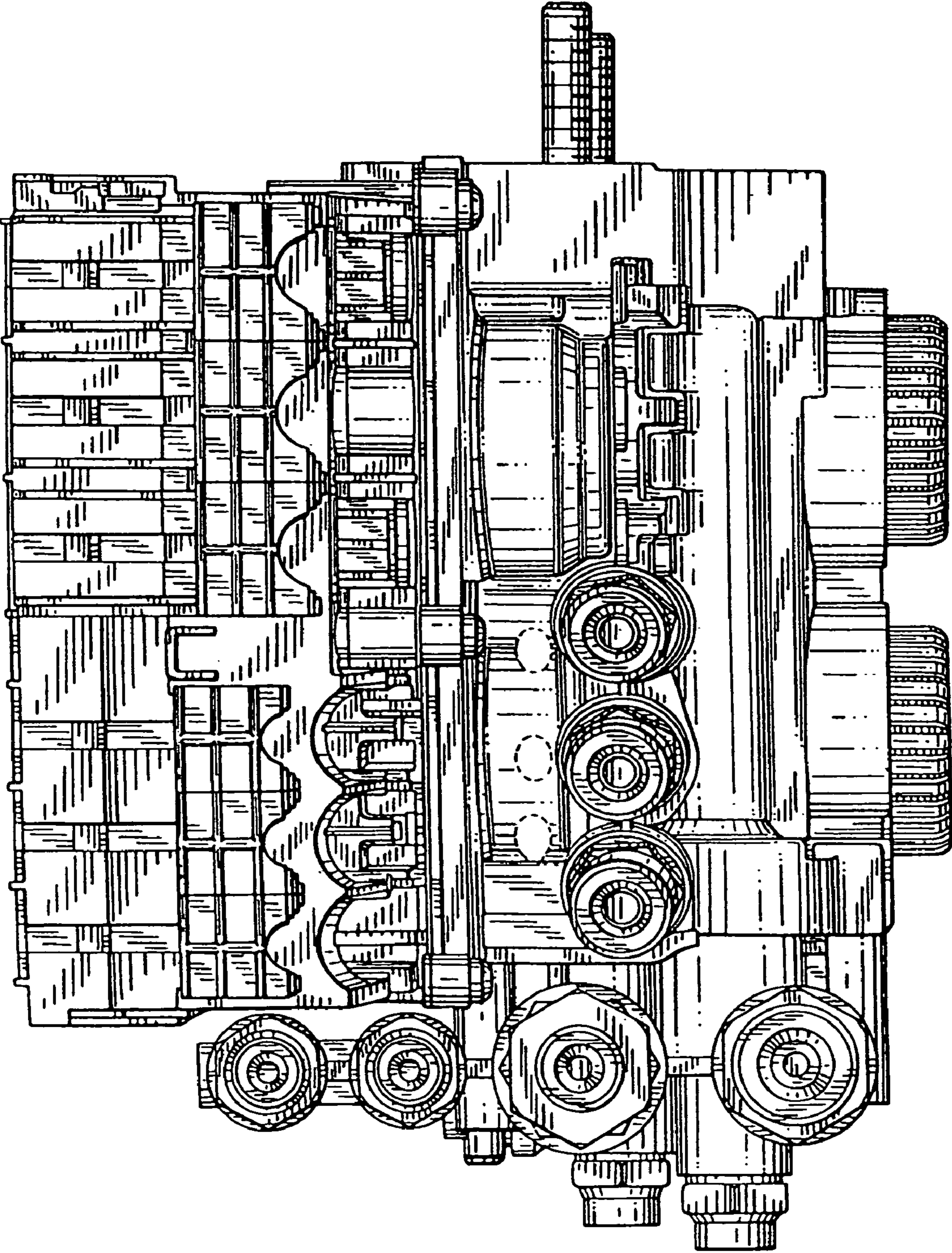

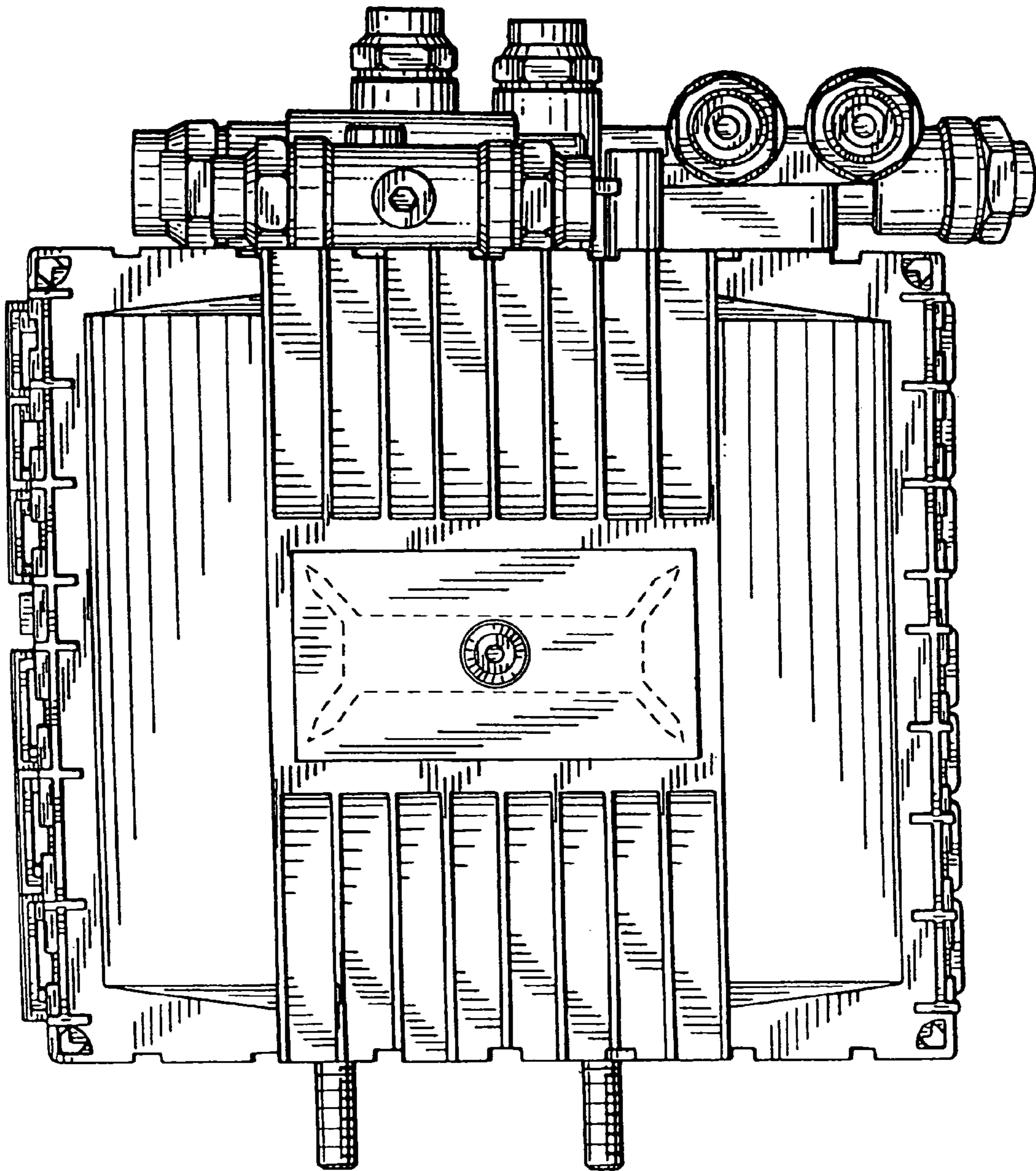

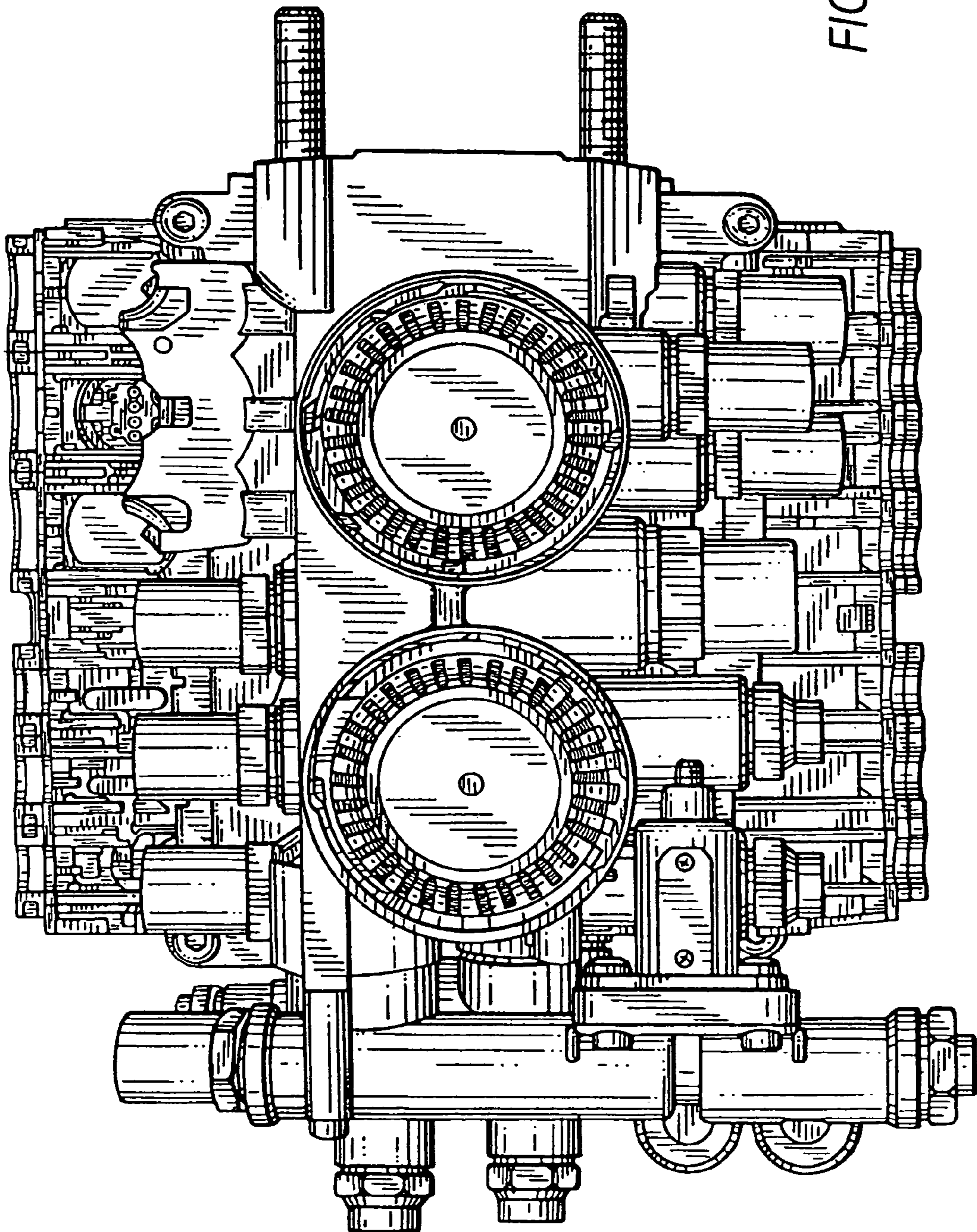

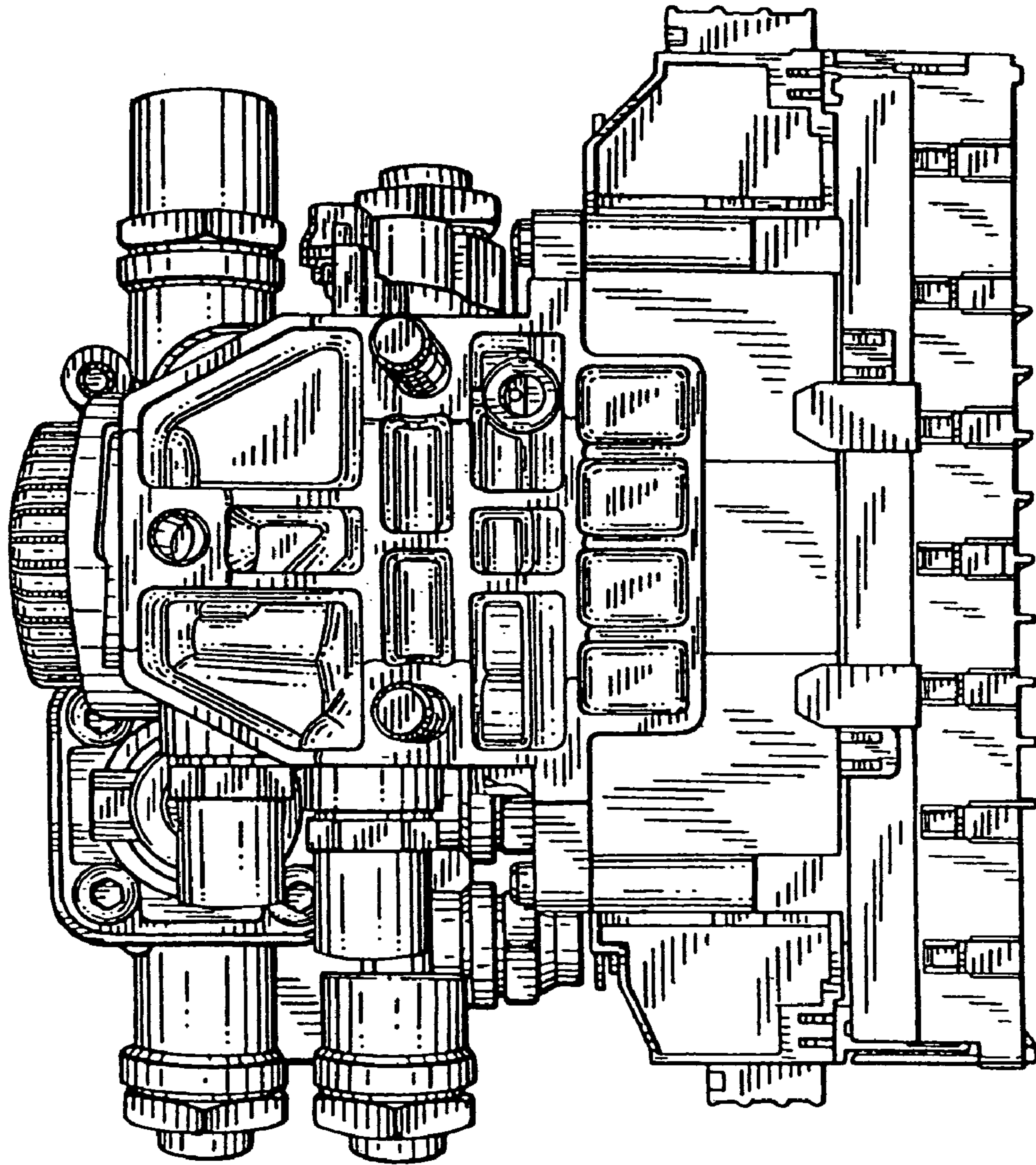

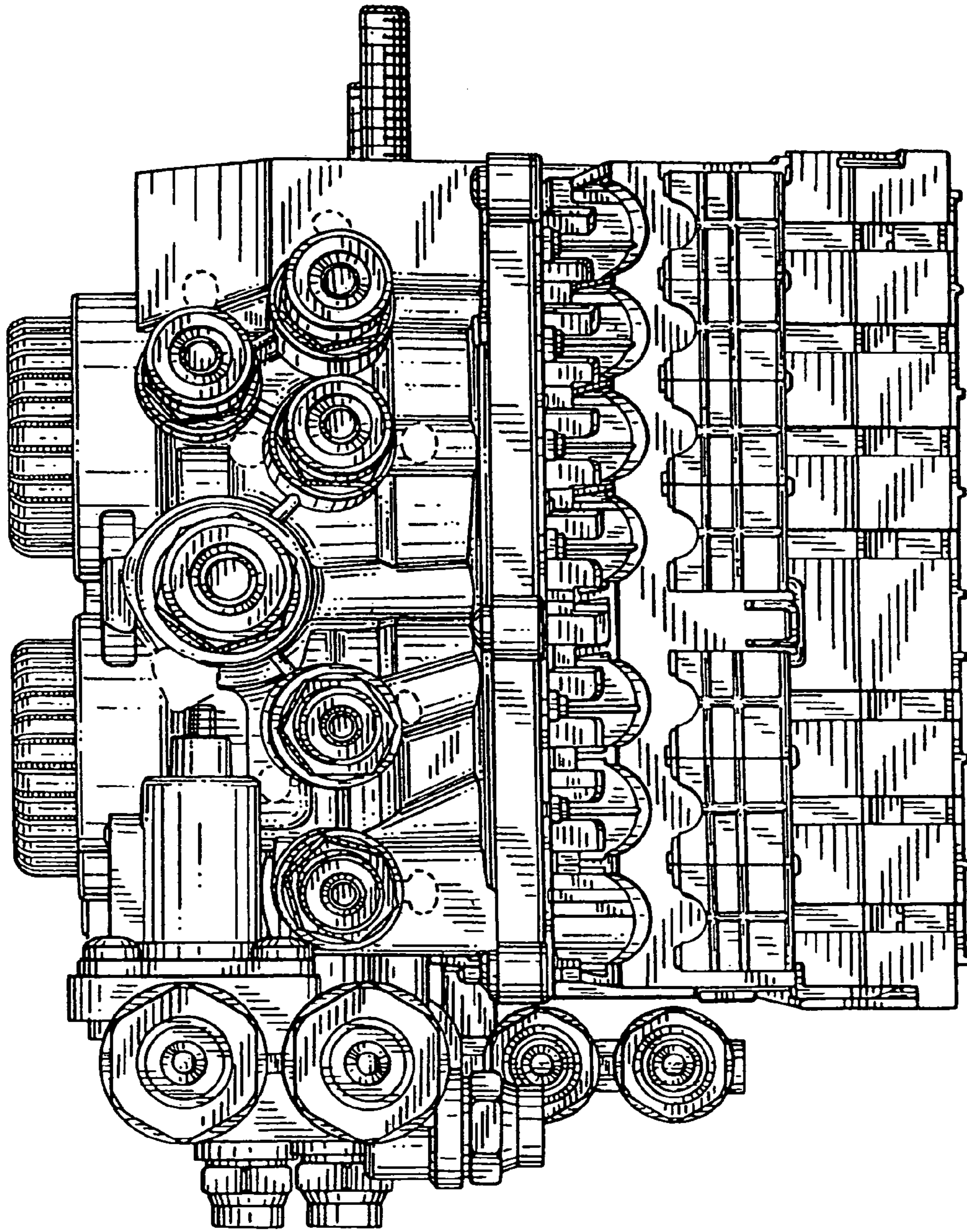

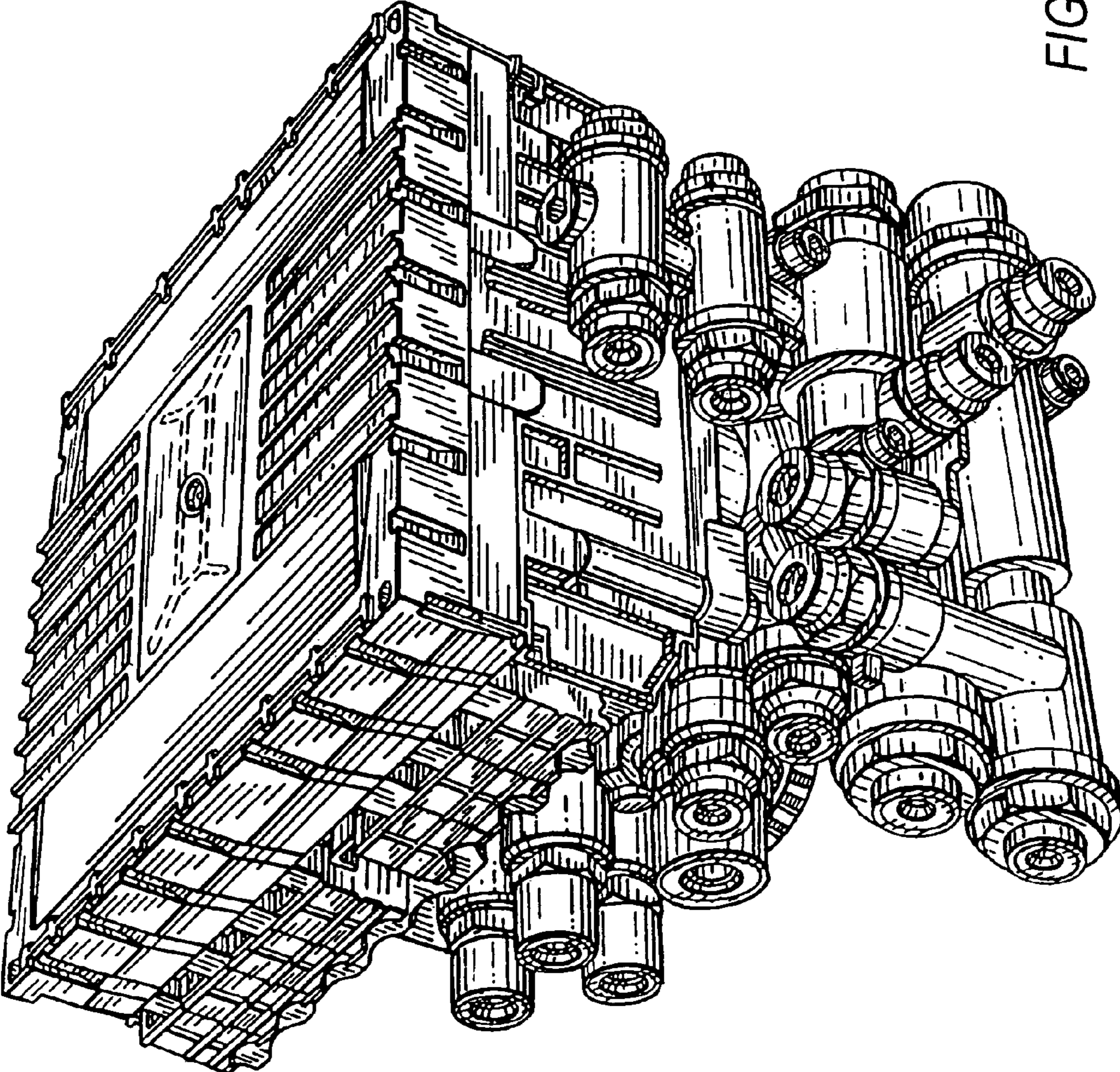
