The ornamental design for a front cover for a handset, as shown and described.

DESCRIPTION

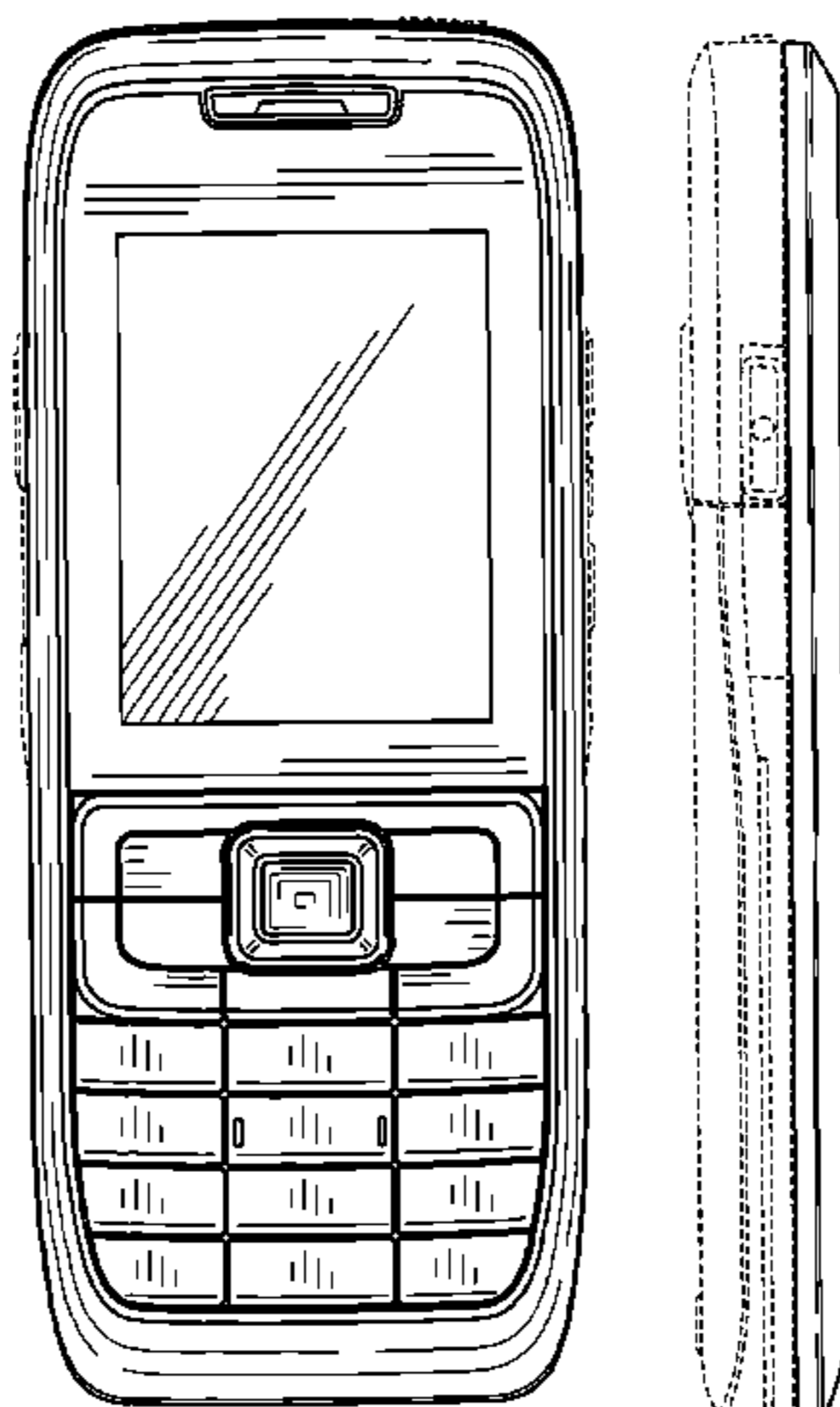

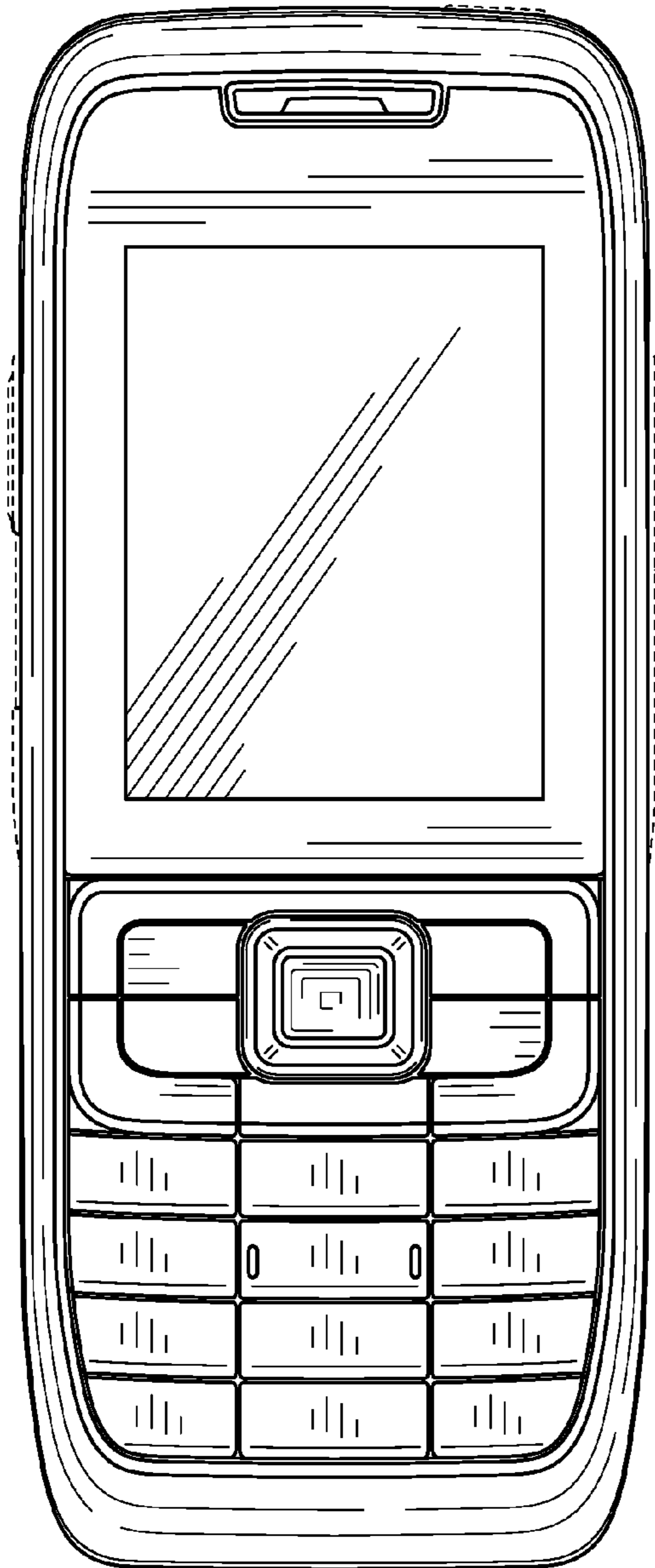

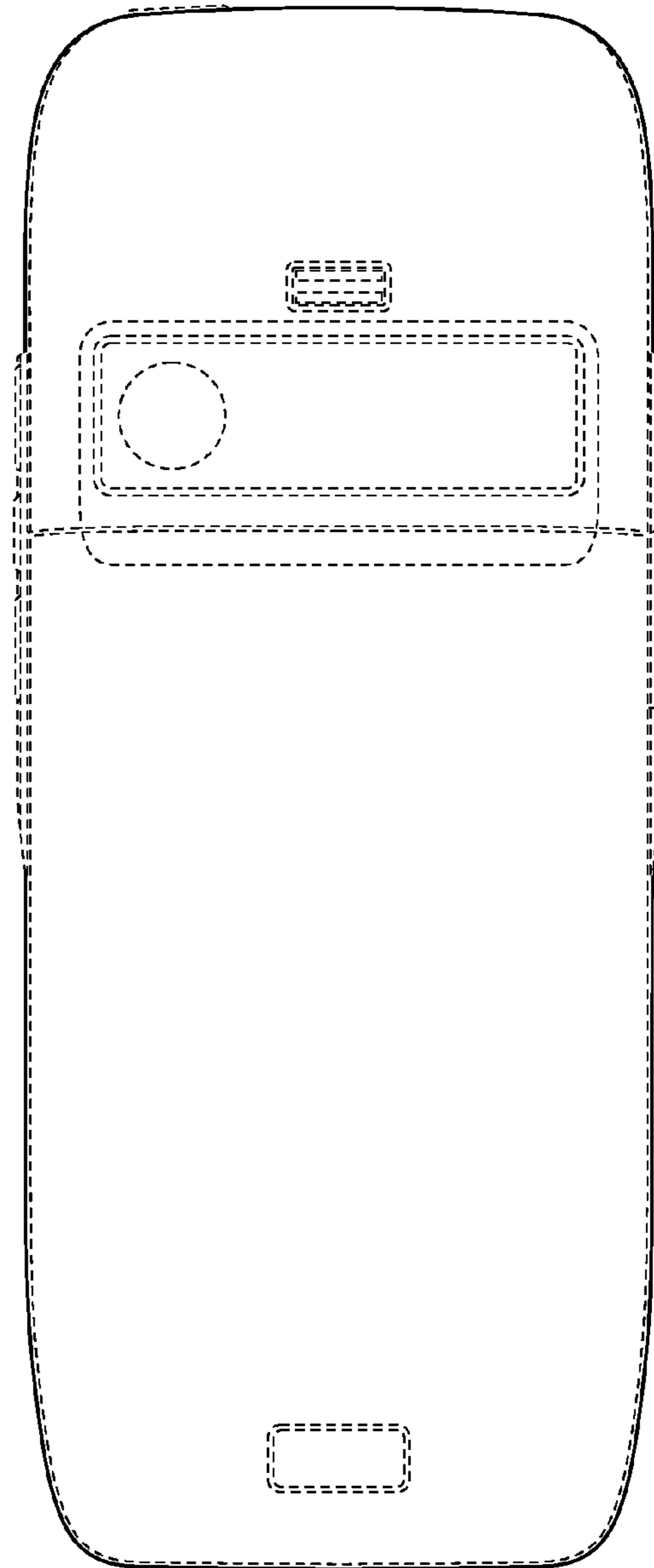

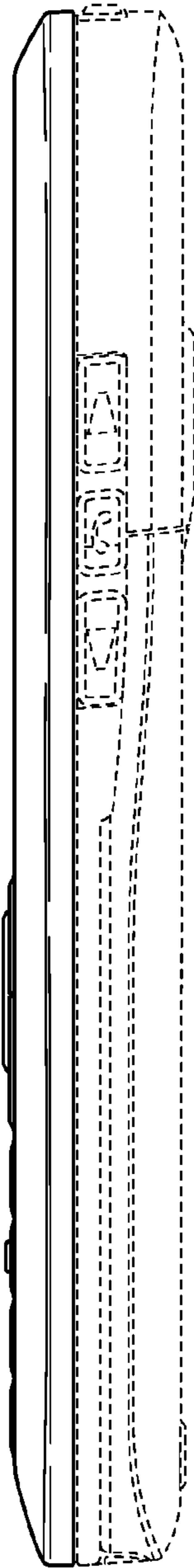

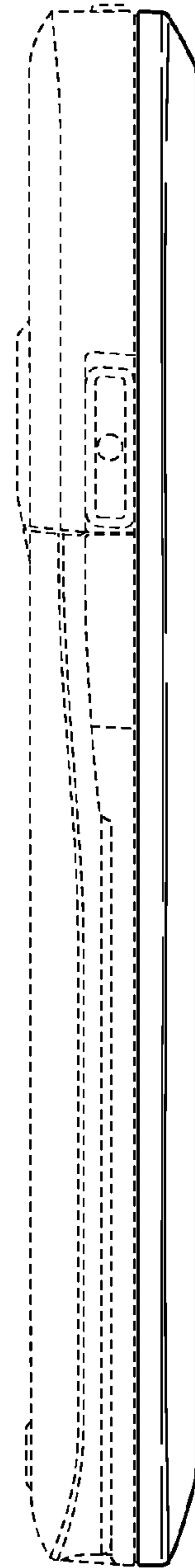

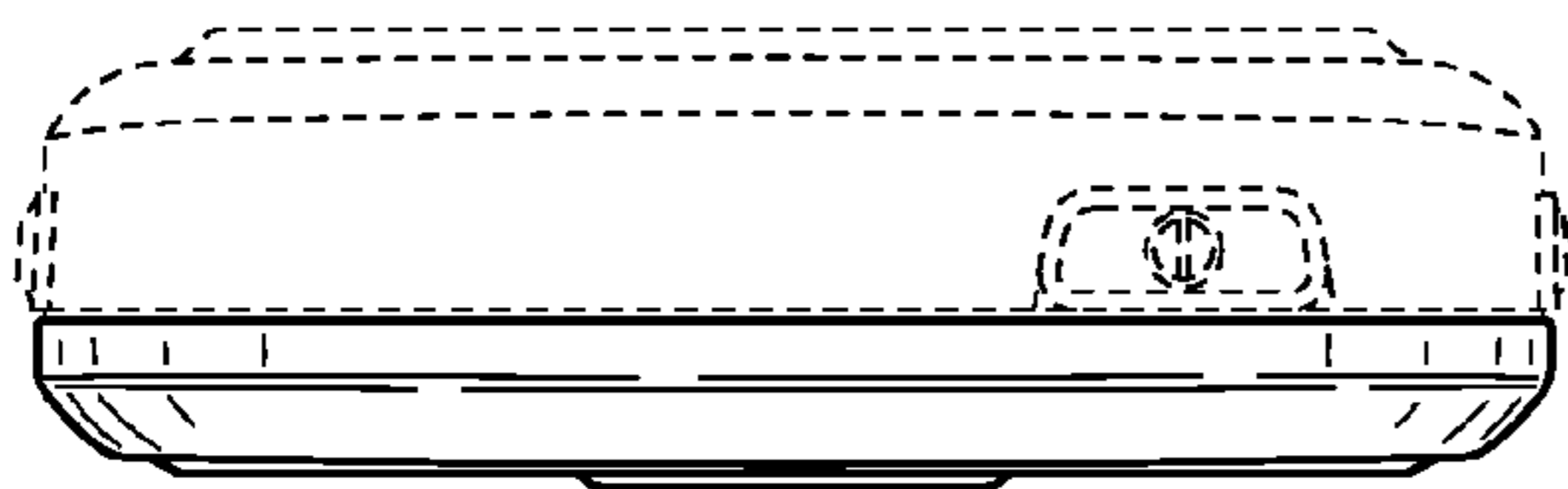

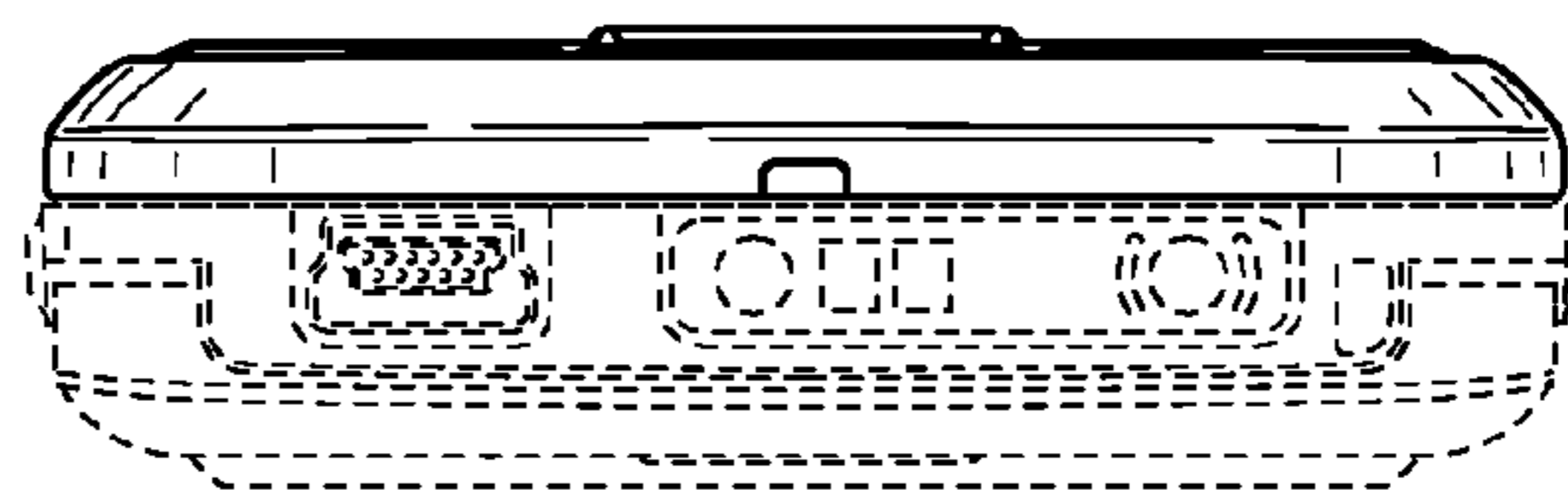

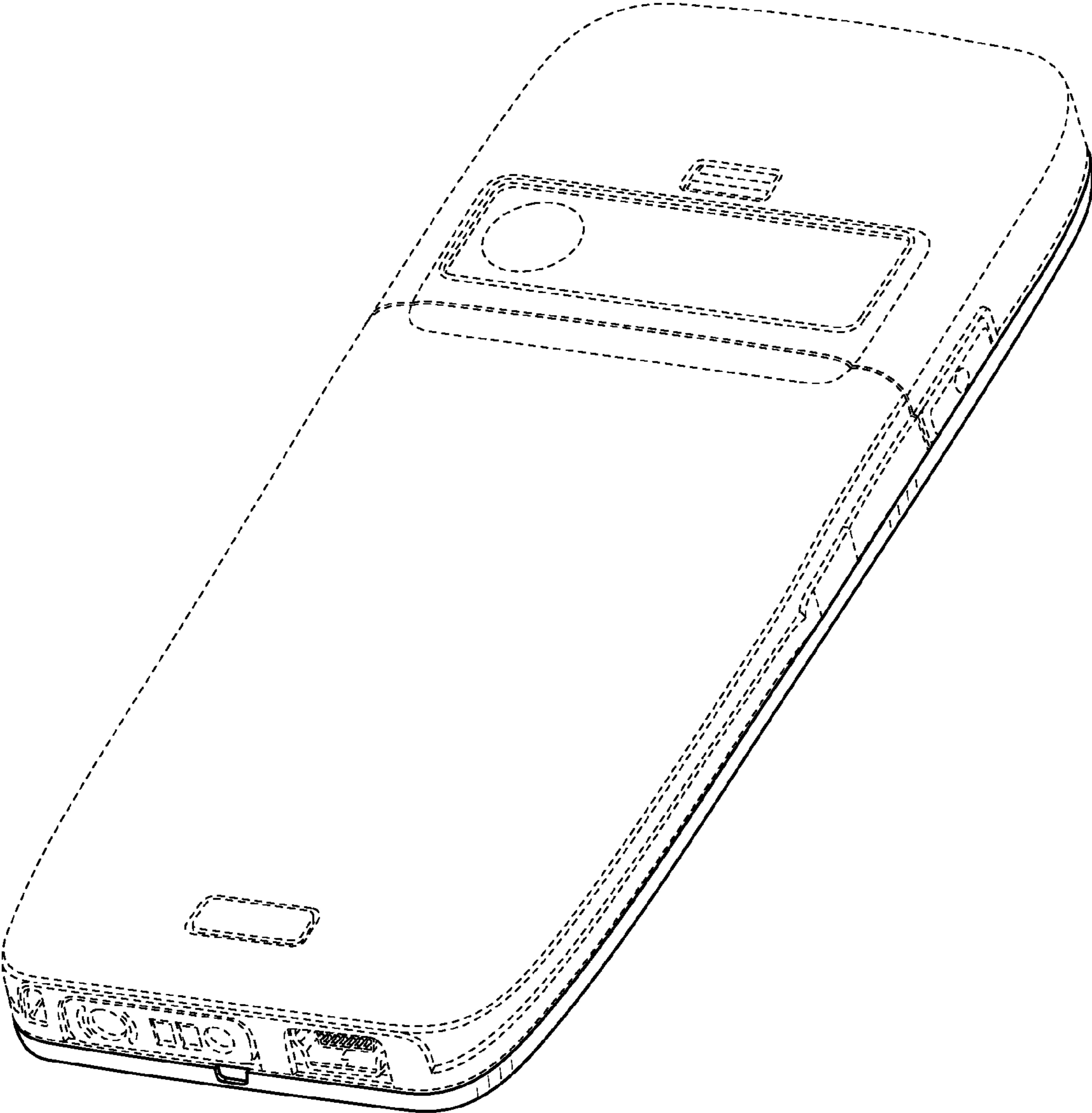
