FIG. 10 is a right side view of the marker of FIG. 8;

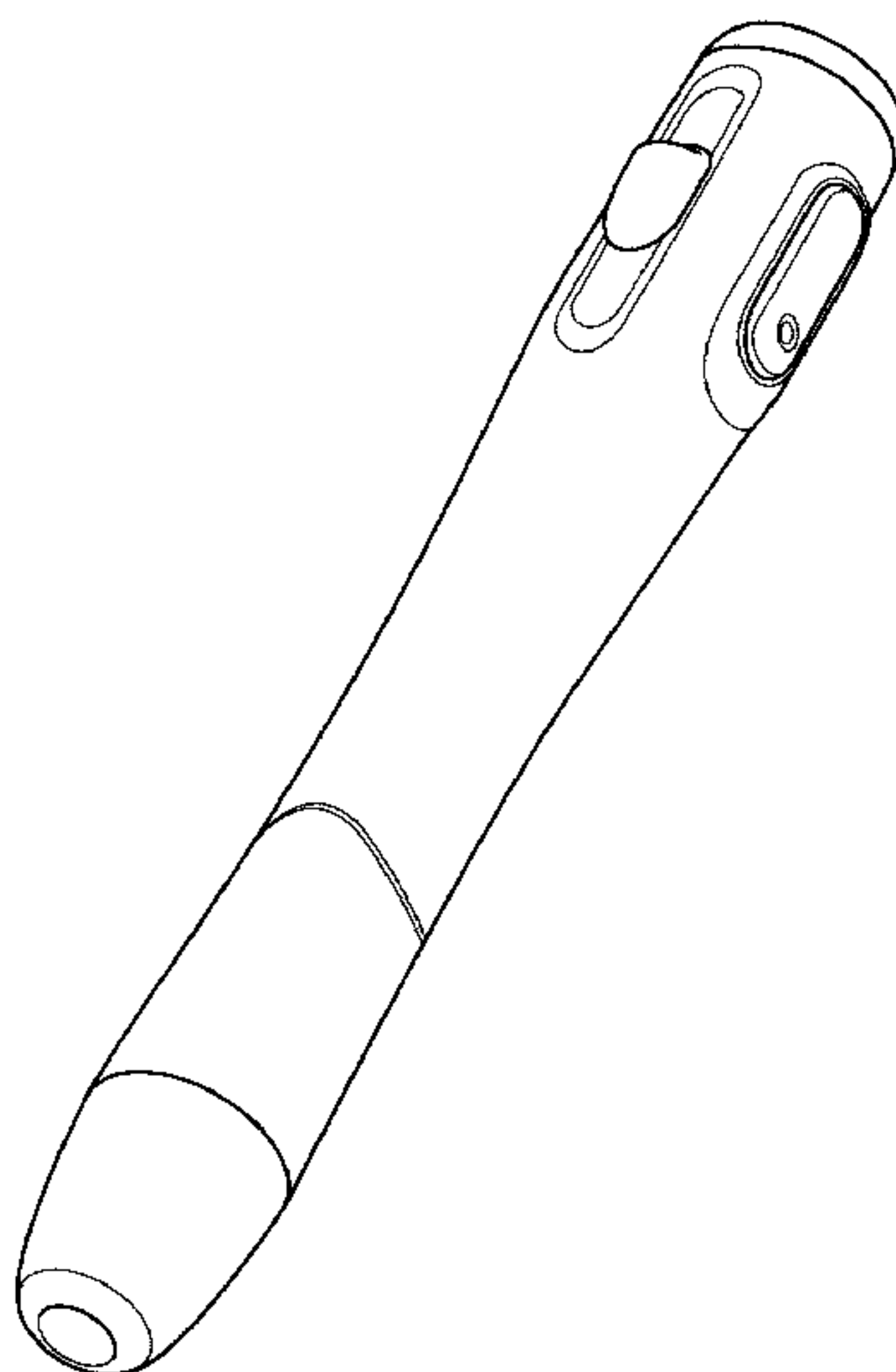
FIG. 11 is a rear view of the marker of FIG. 8;

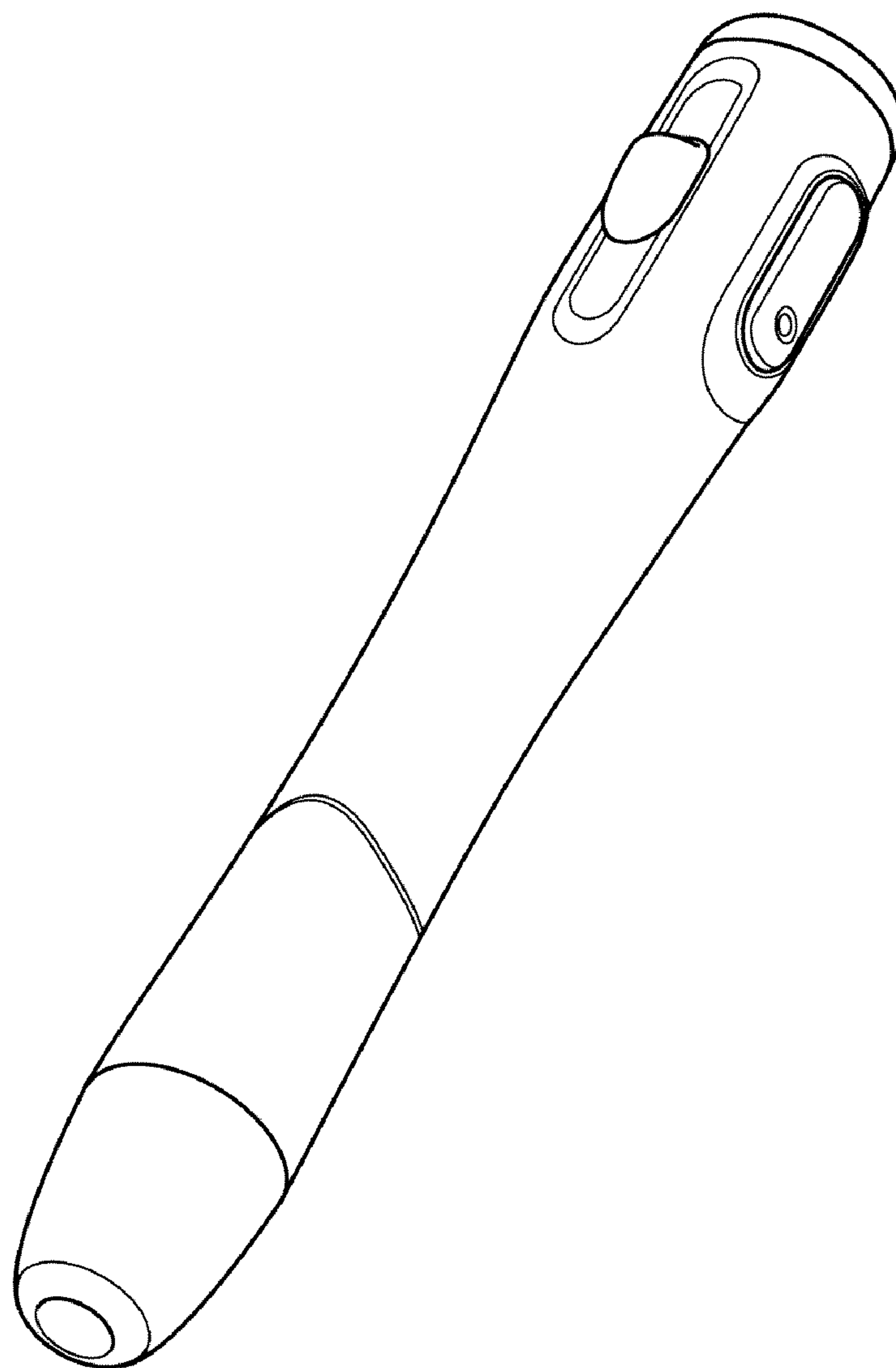

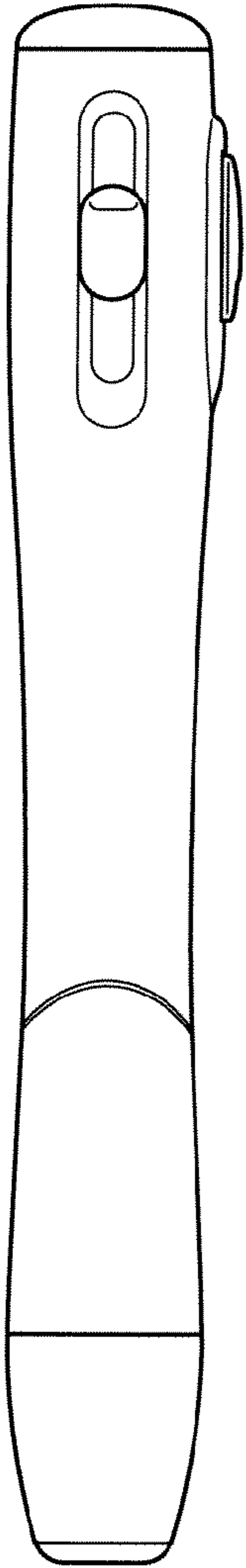

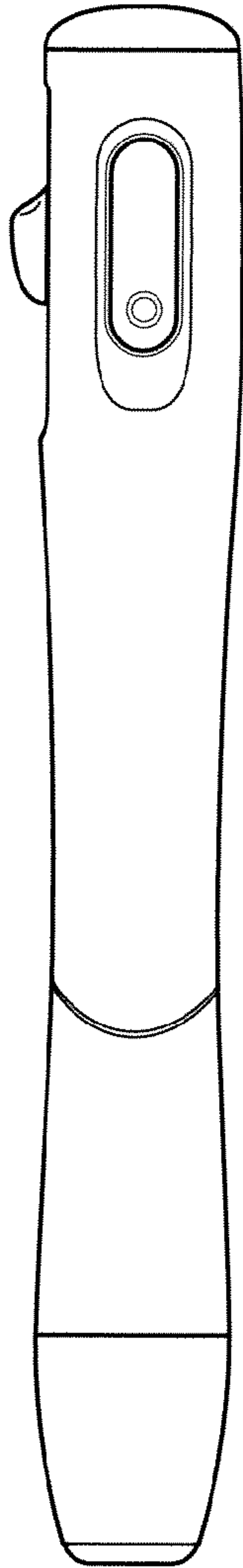

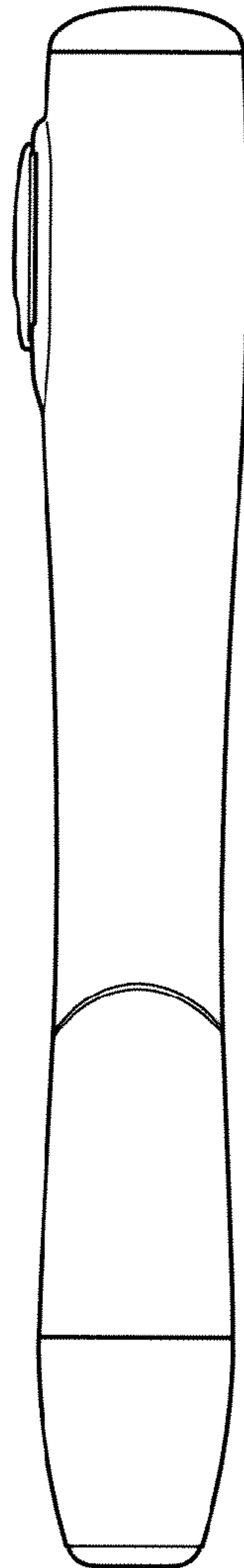

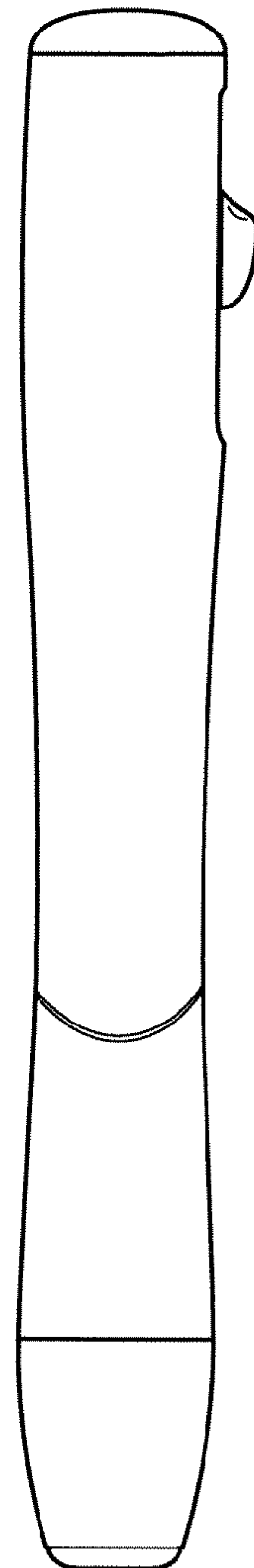

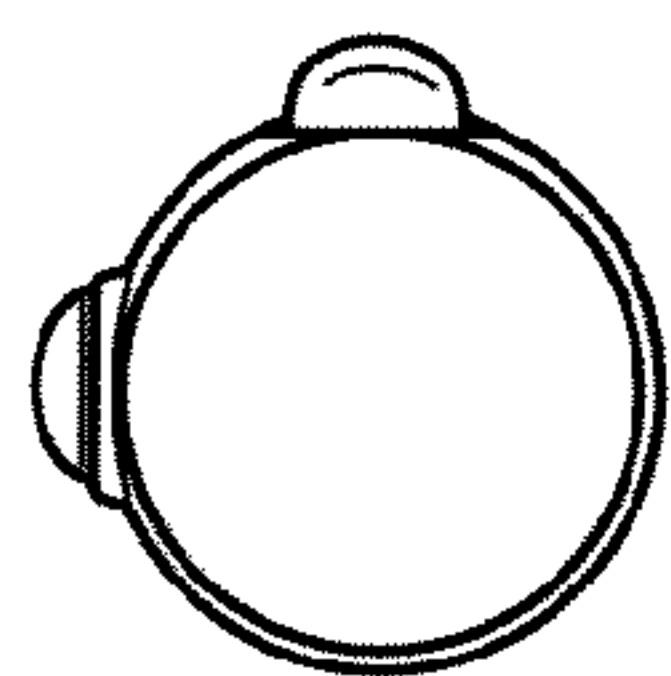

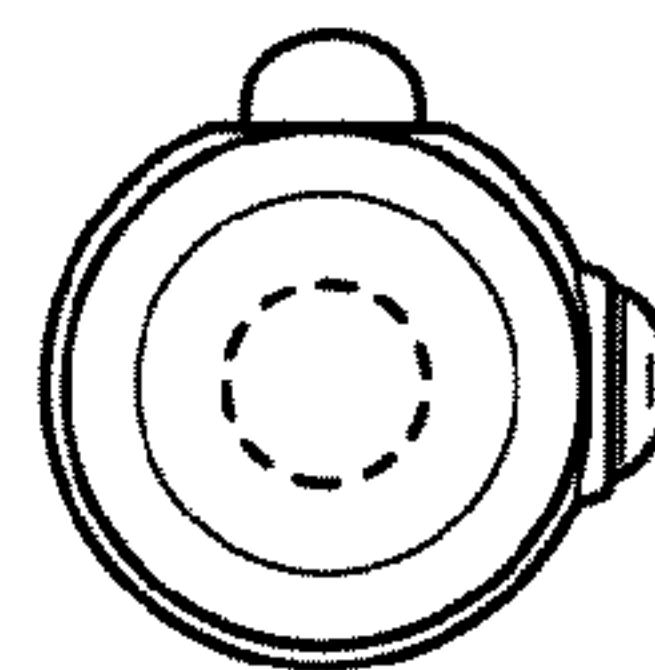

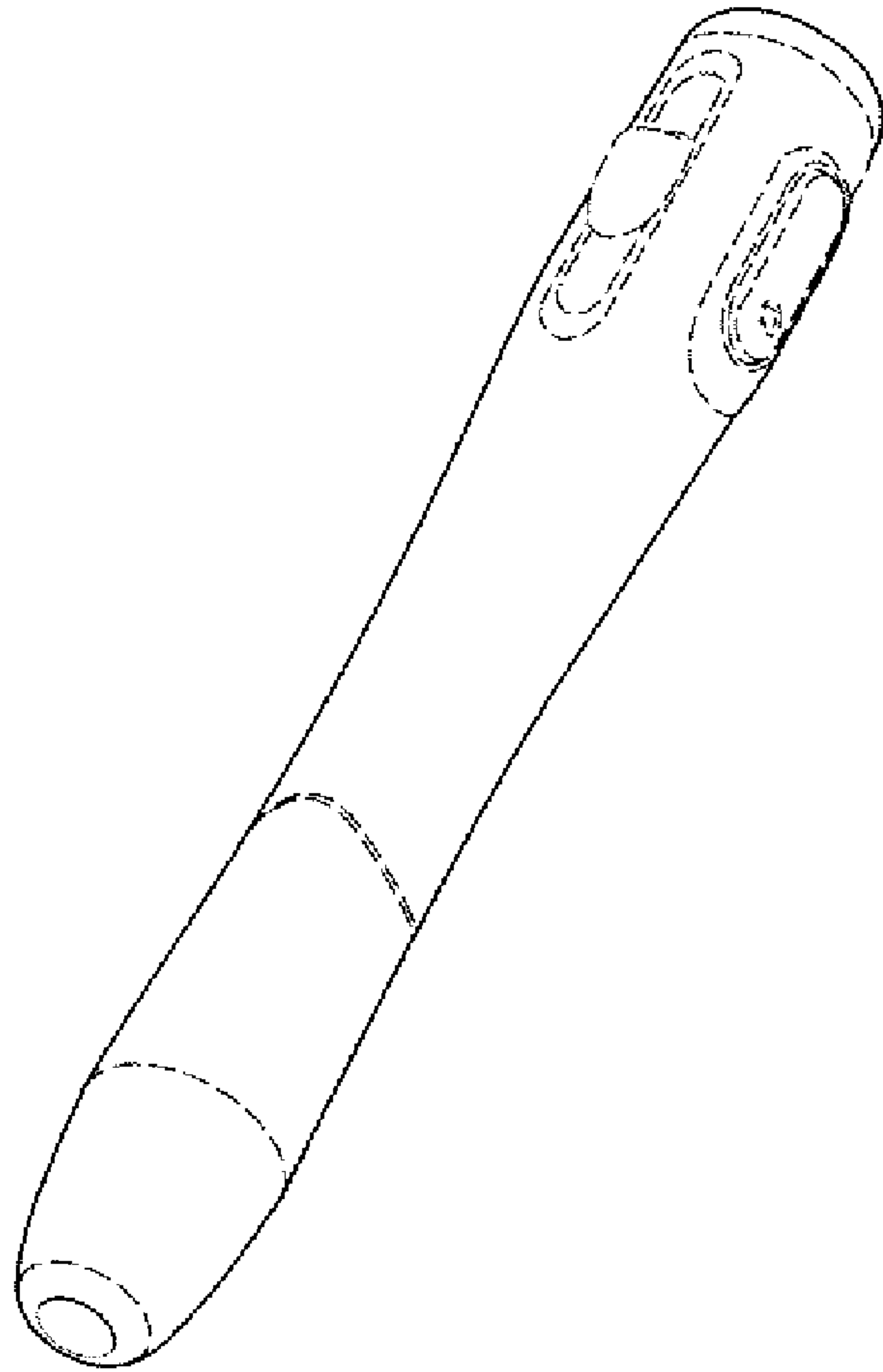

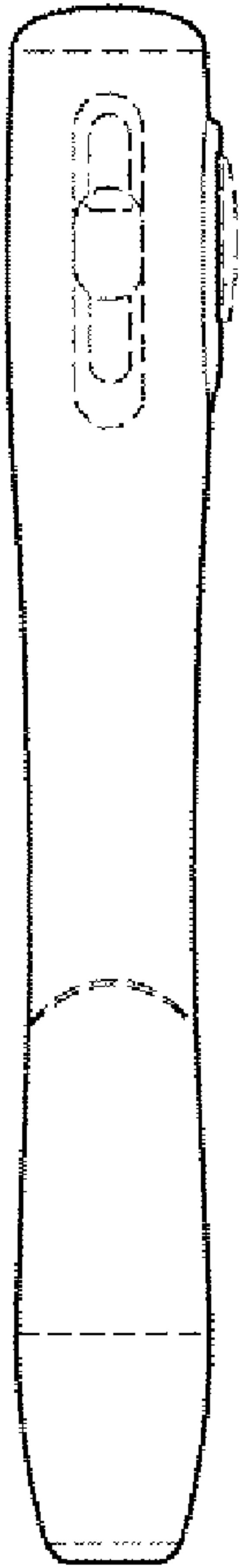

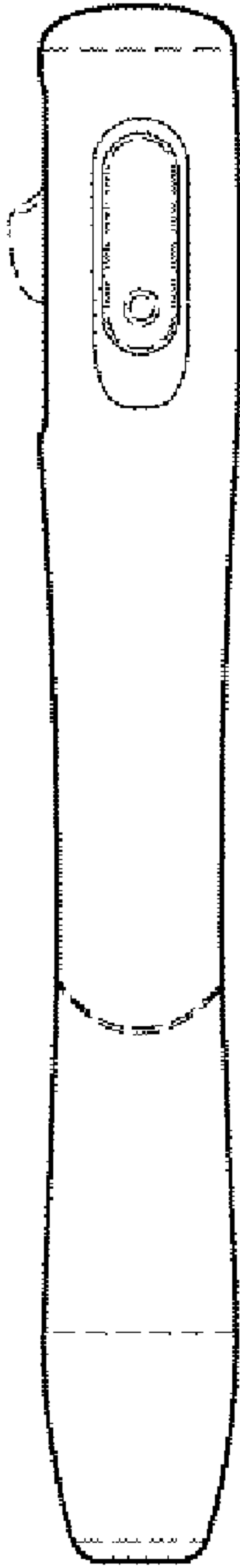

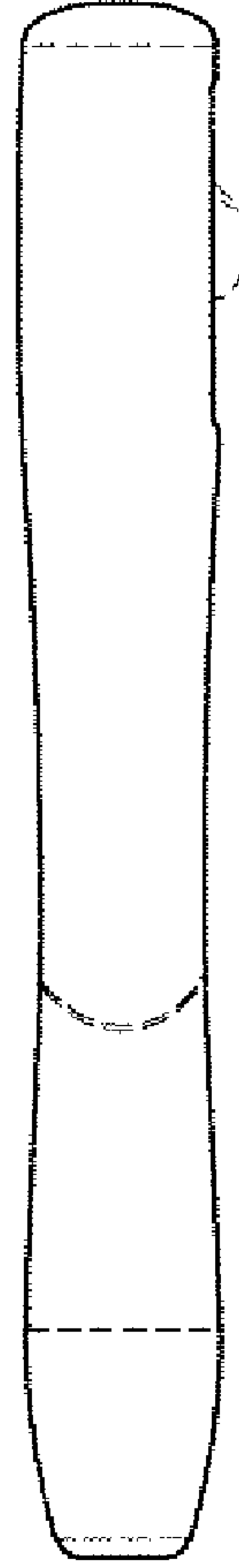

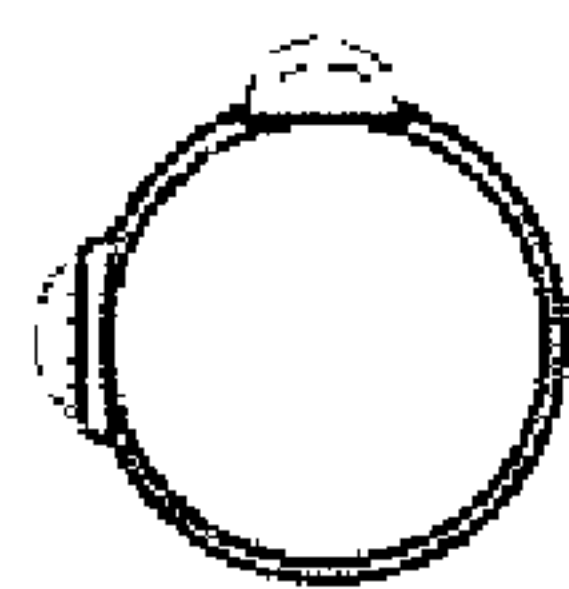

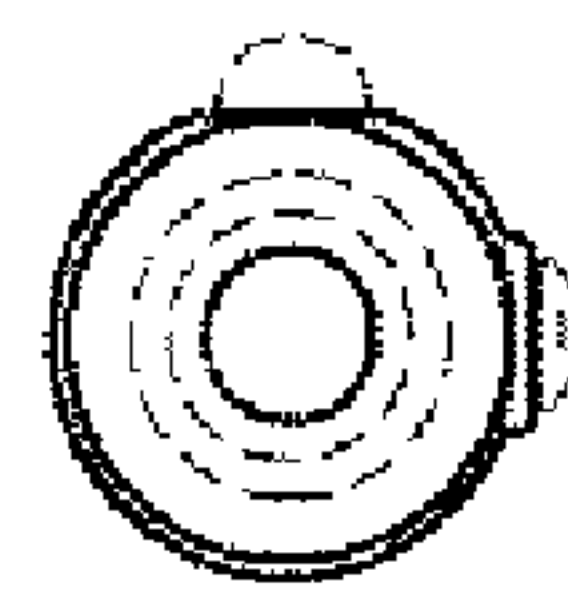

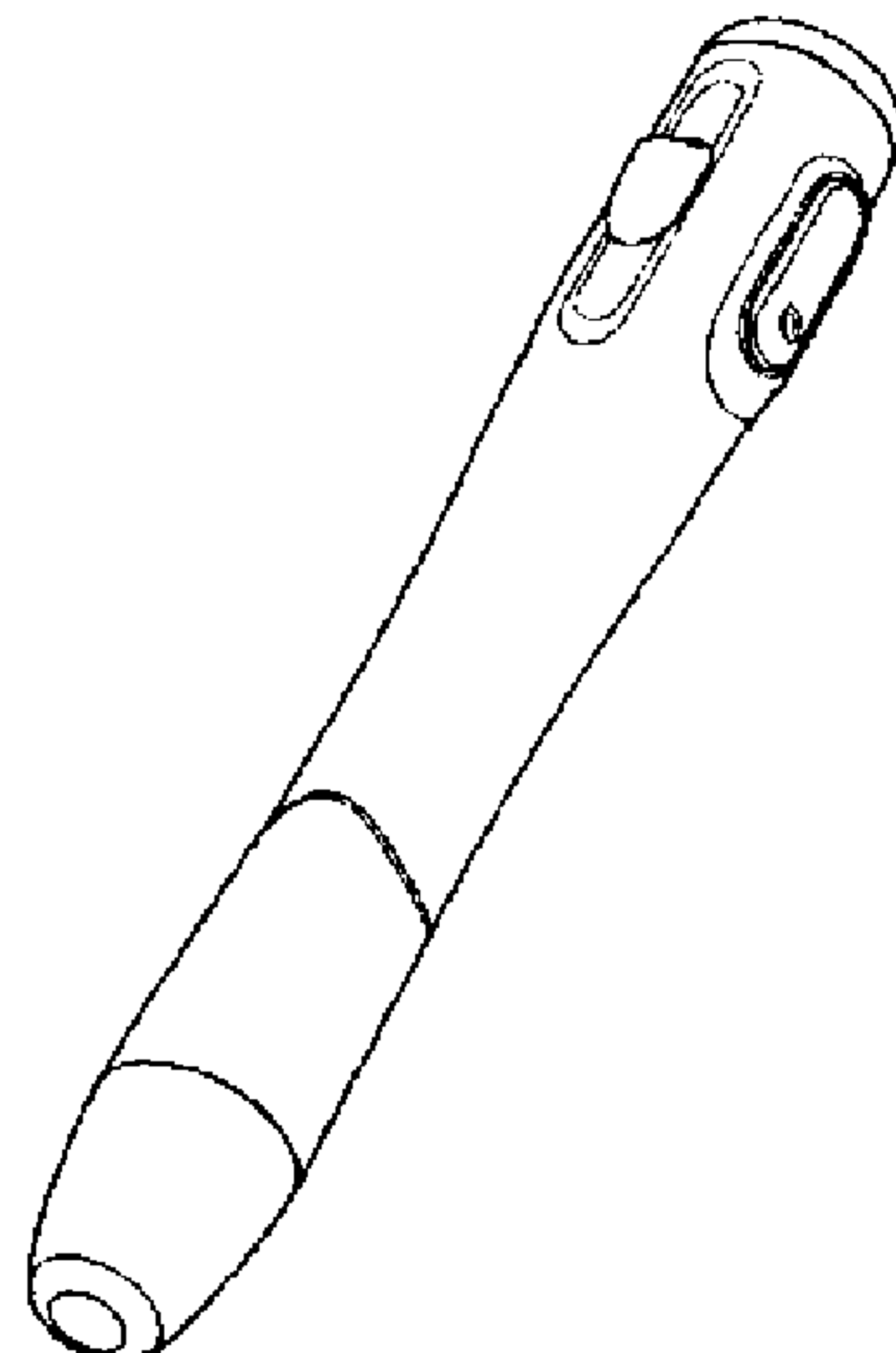

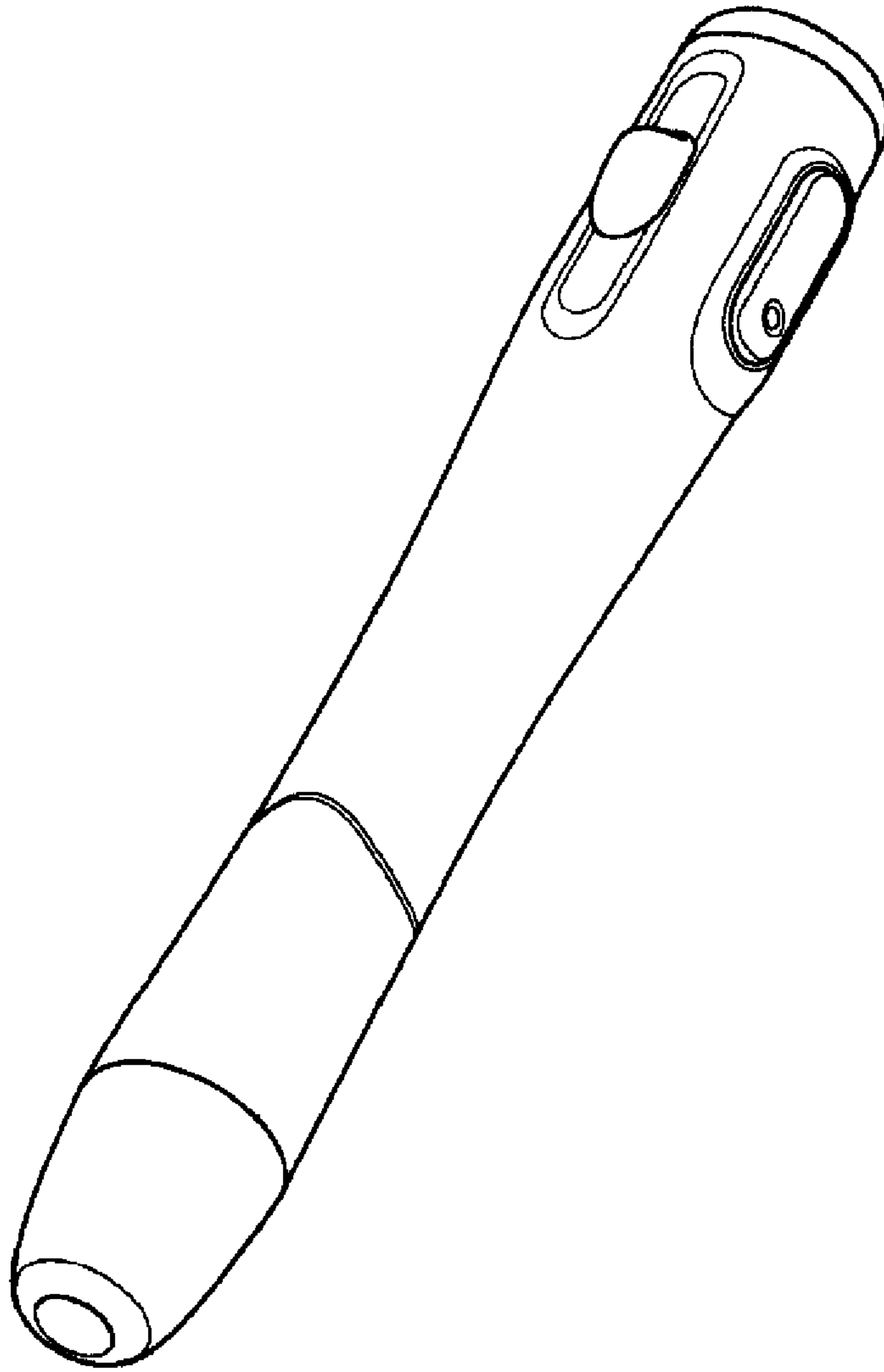

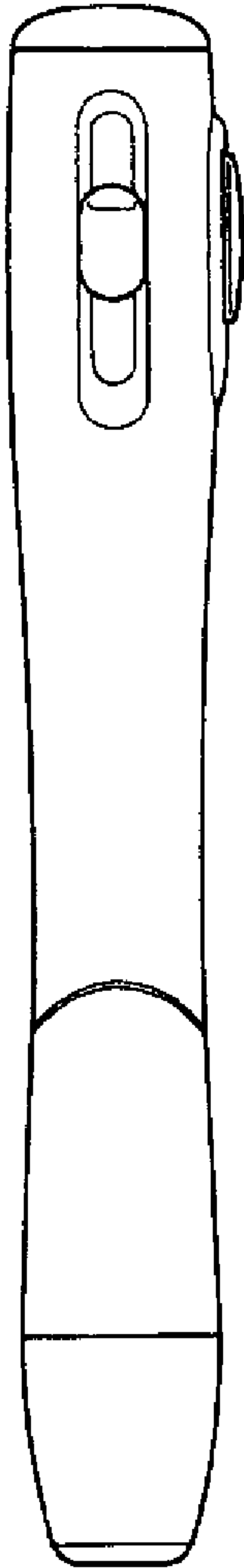

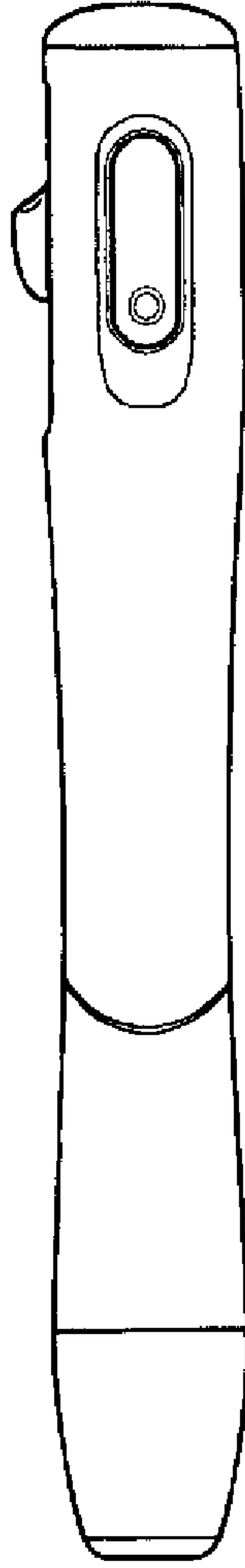

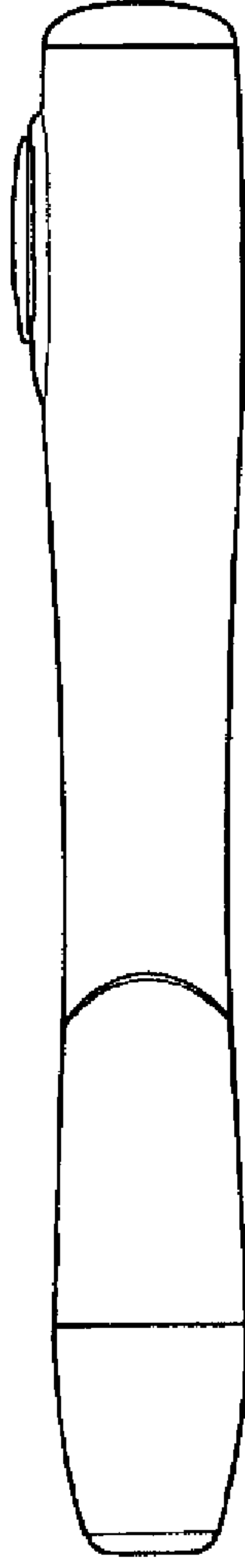

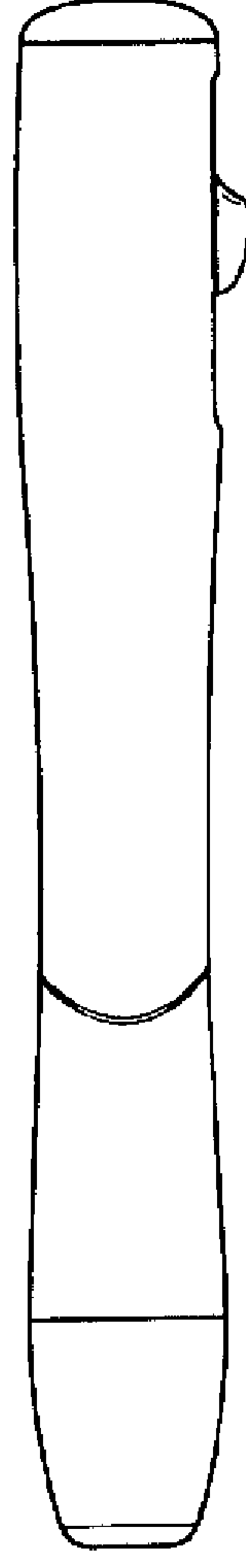

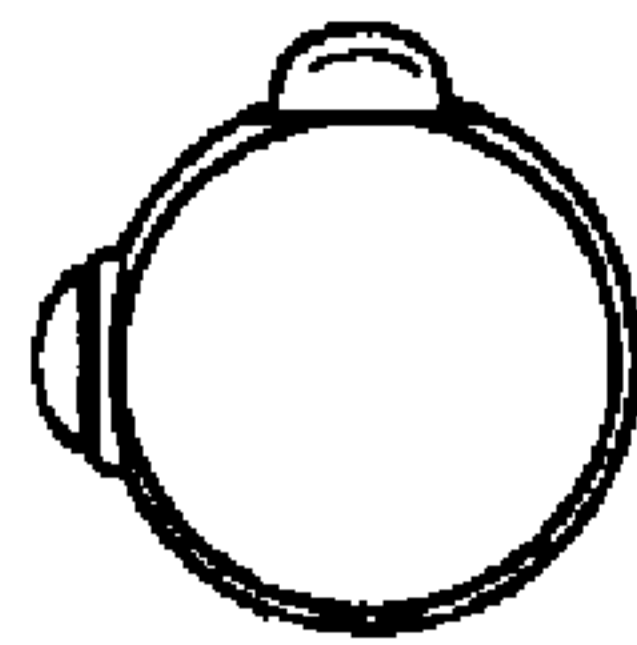
