(57) **CLAIM**

The ornamental design for a air conditioner, as shown and described.

DESCRIPTION

This application claims priority under 35 U.S.C. § 119(a) on Design patent application No. 30-2007-0033548 filed in the Republic of Korea on Aug. 3, 2007, the entire contents of which are hereby incorporated by reference. 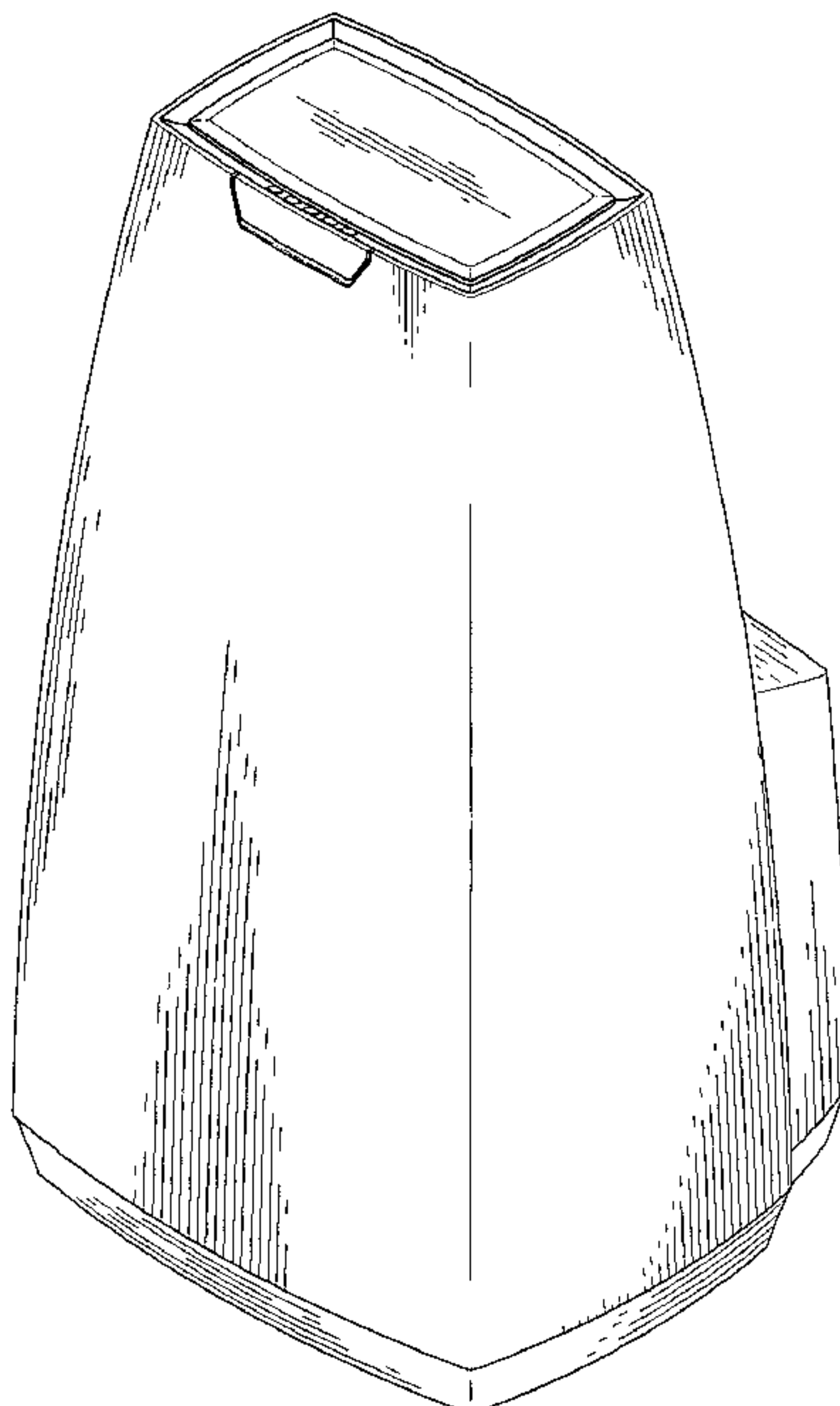

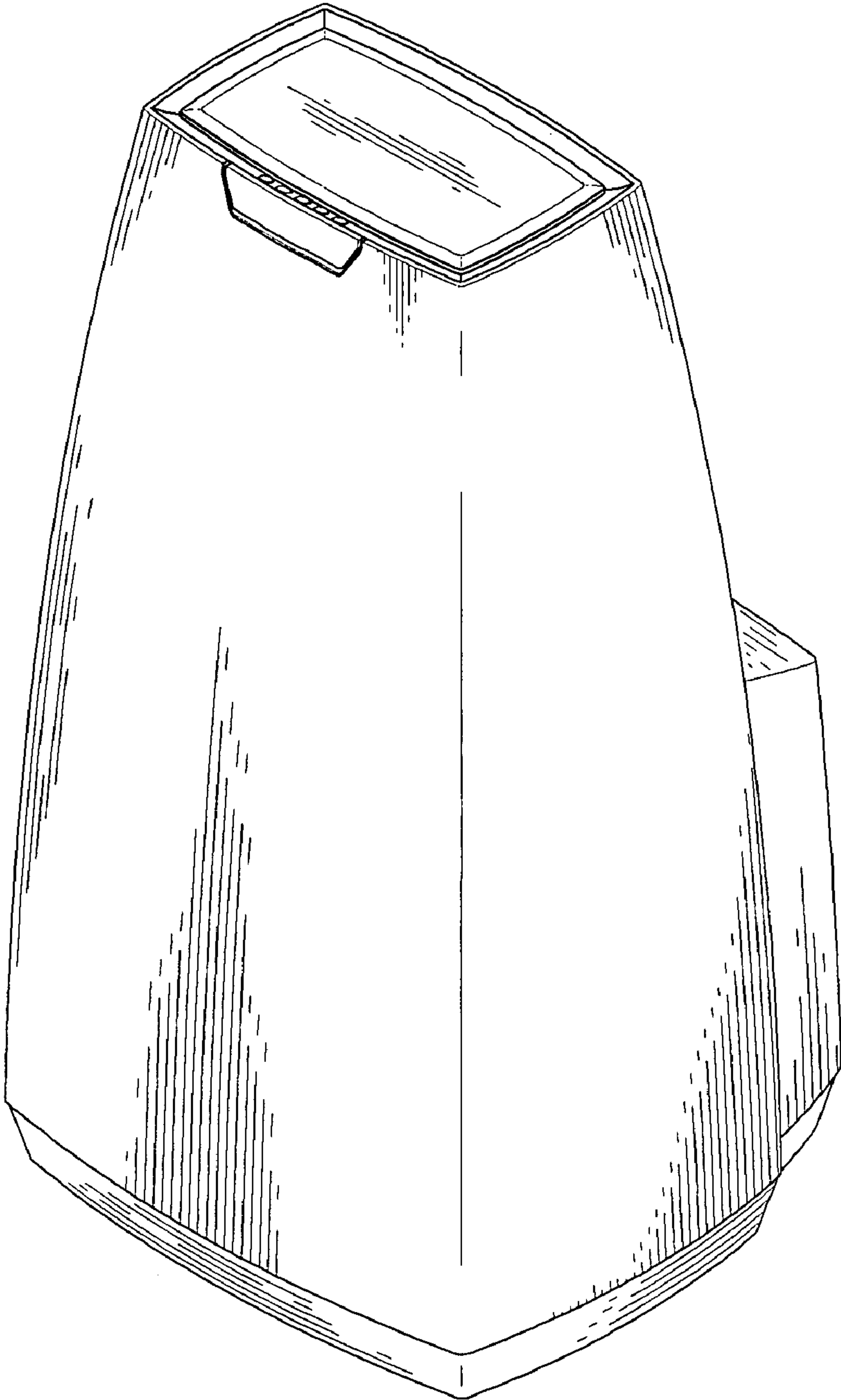

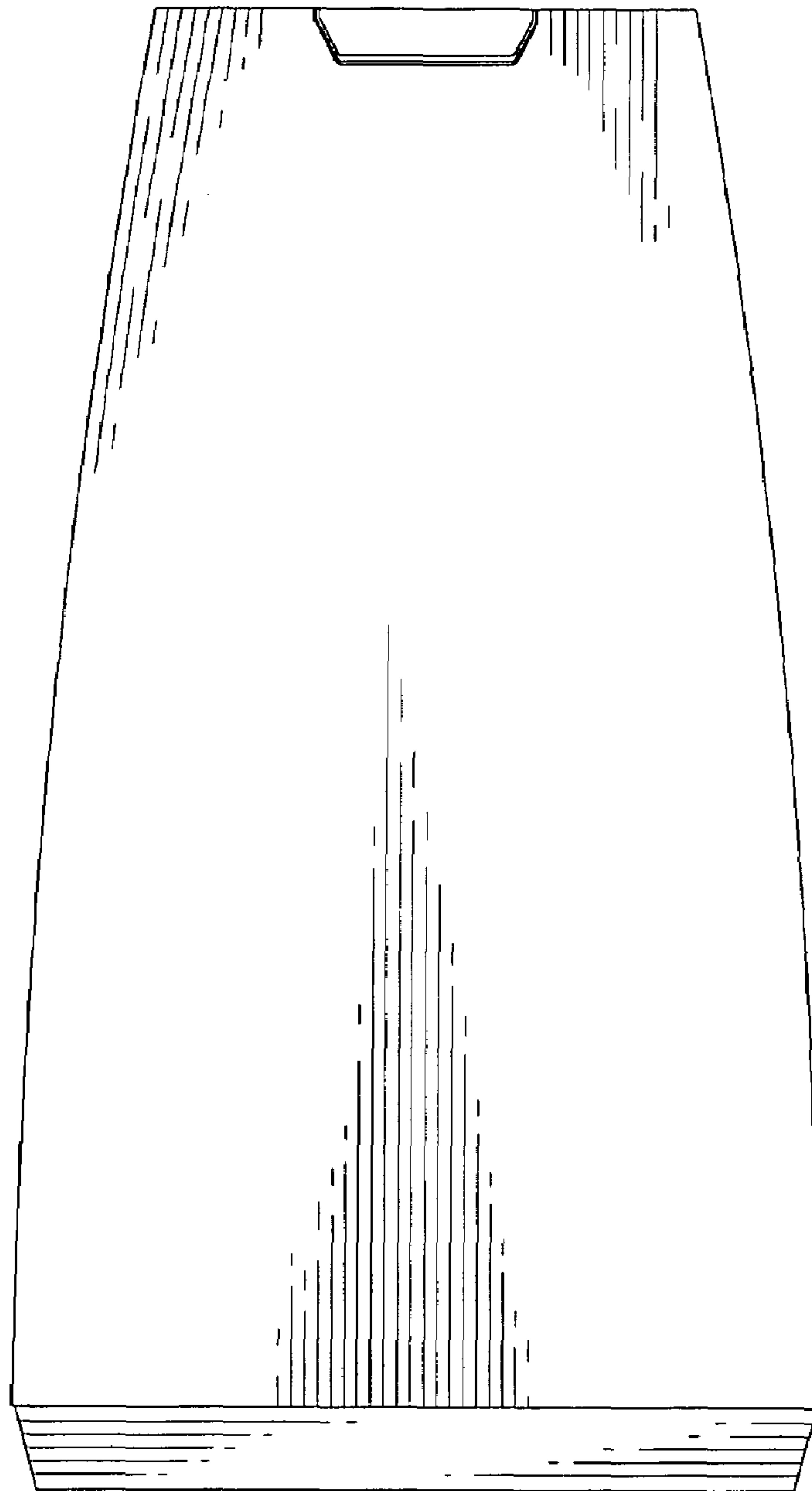

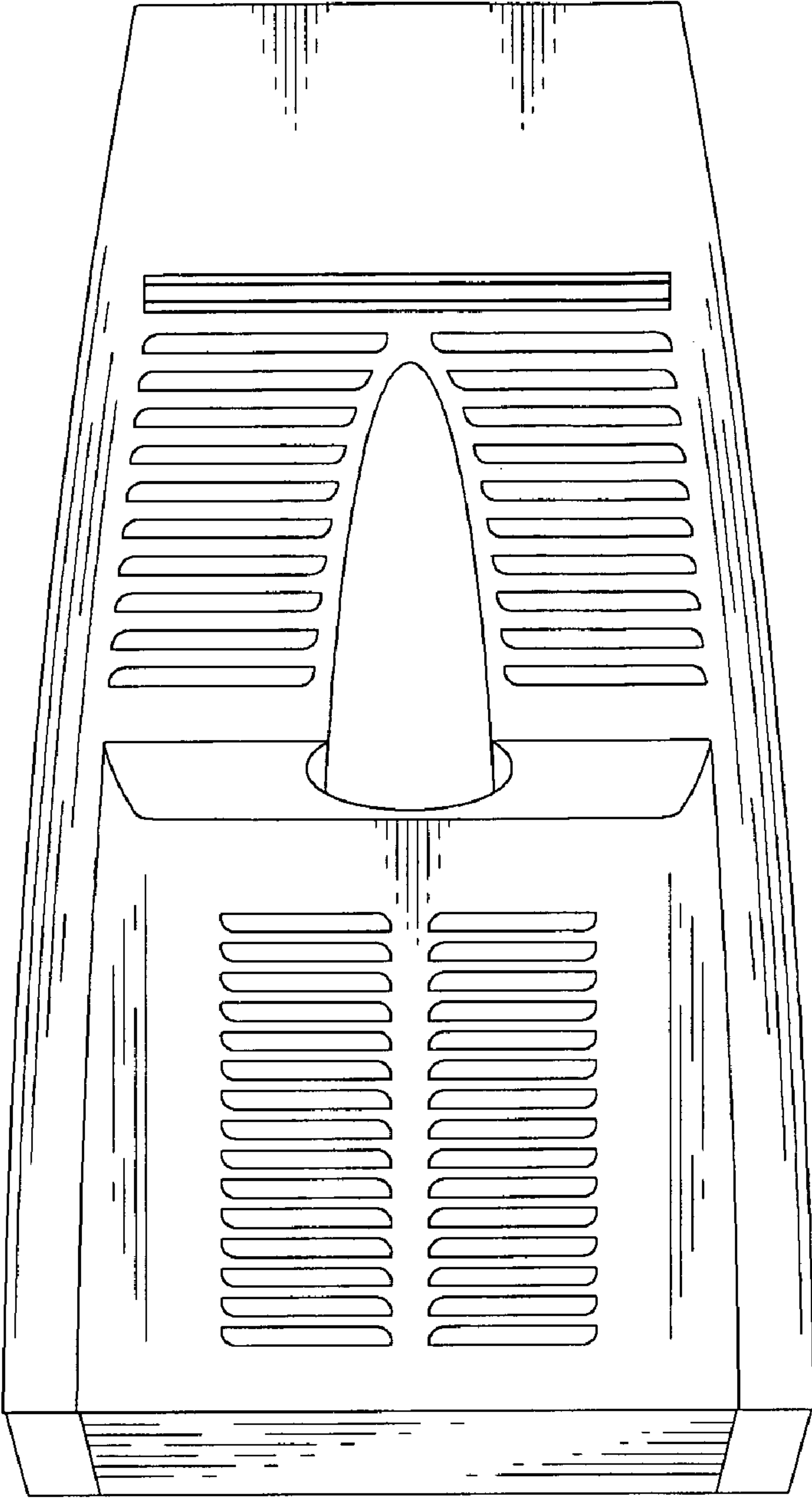

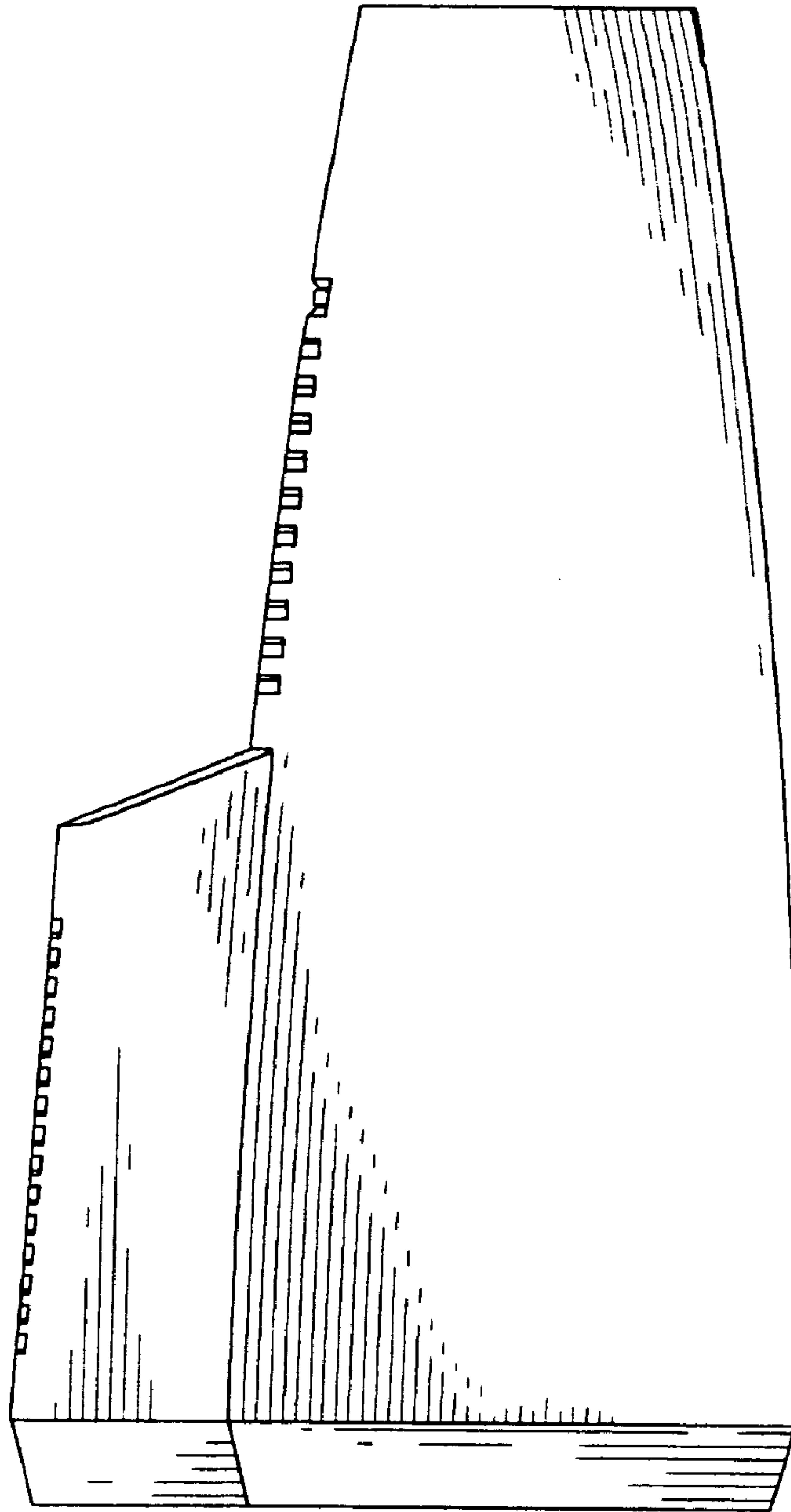

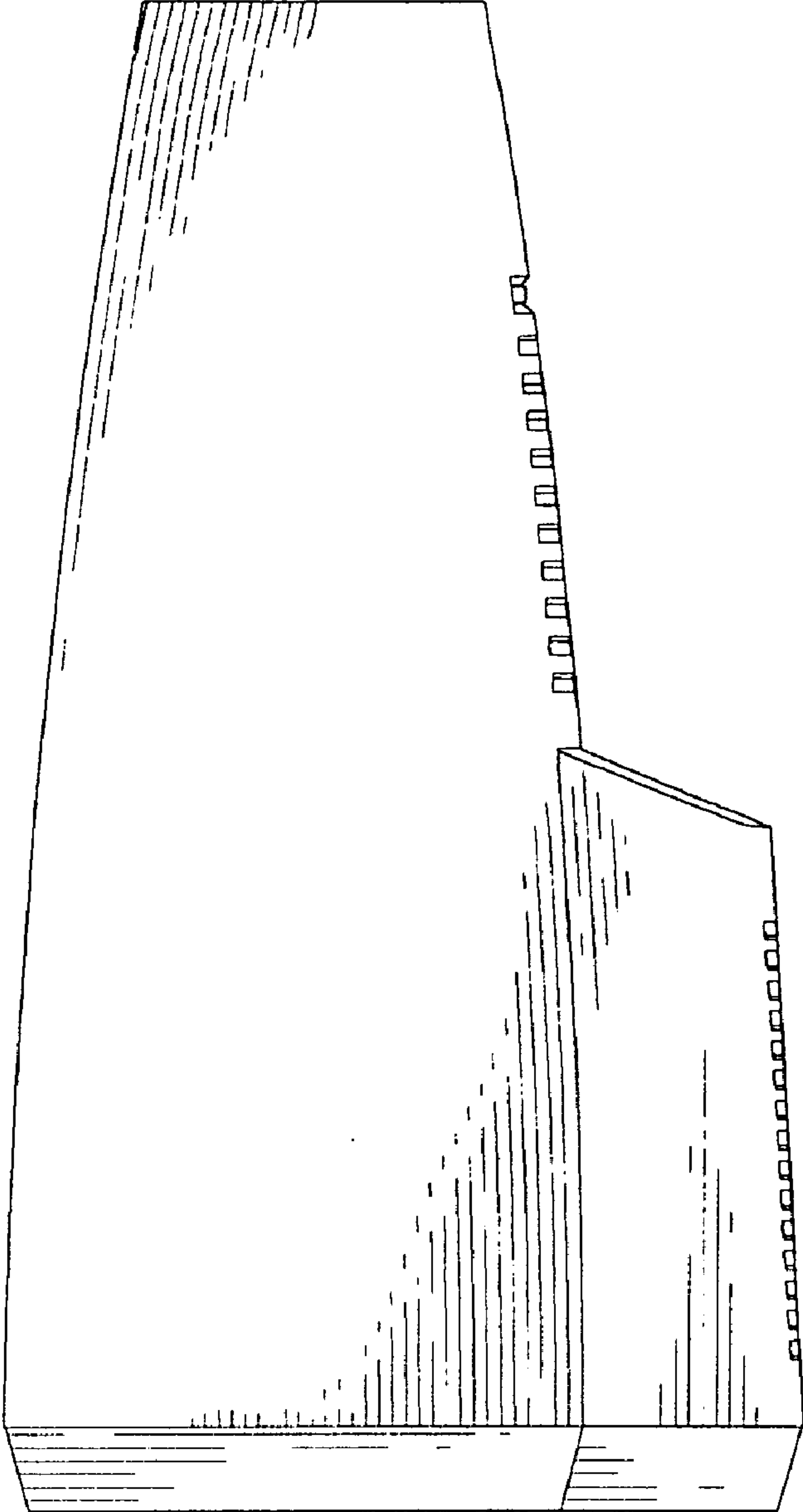

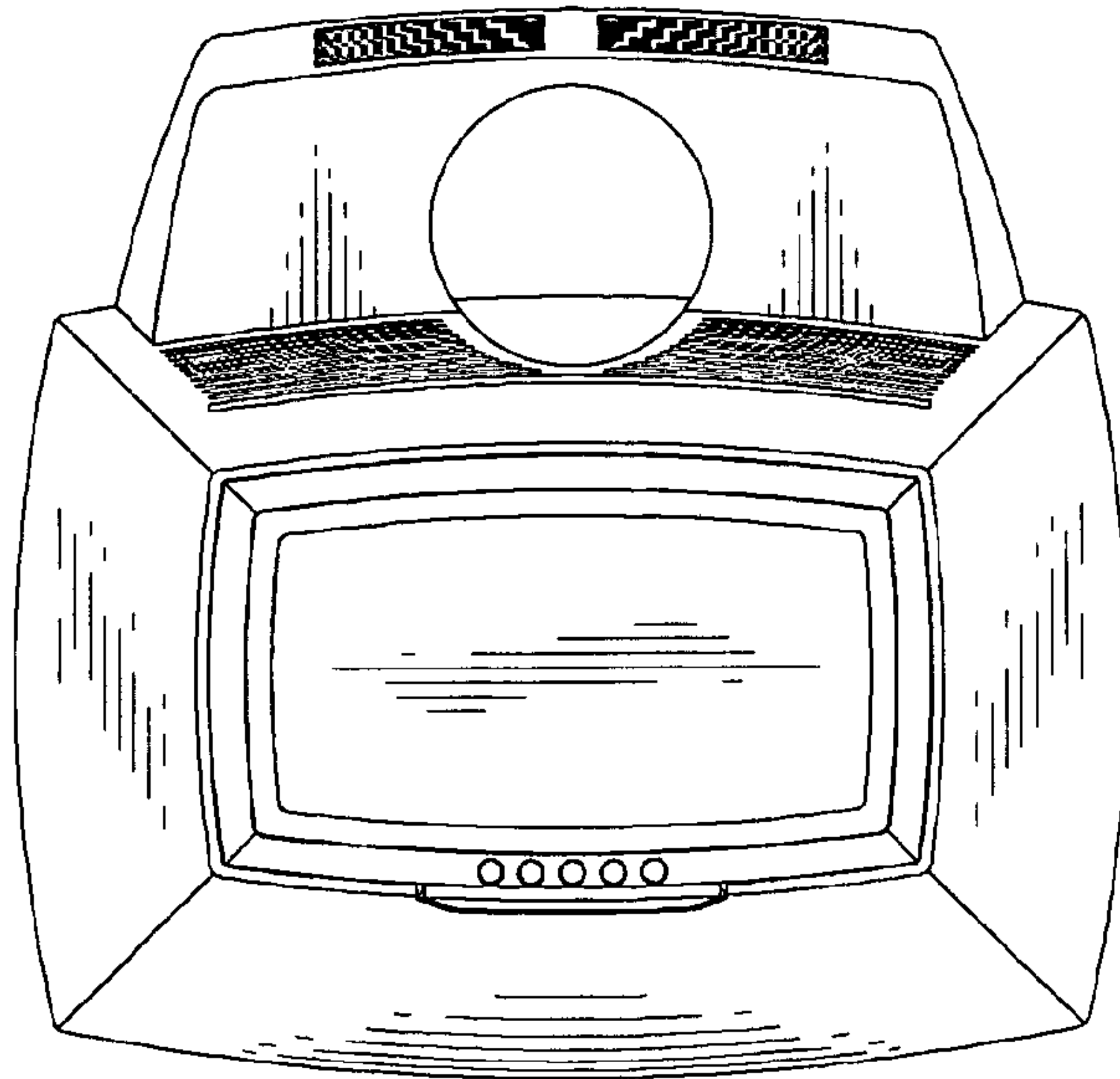

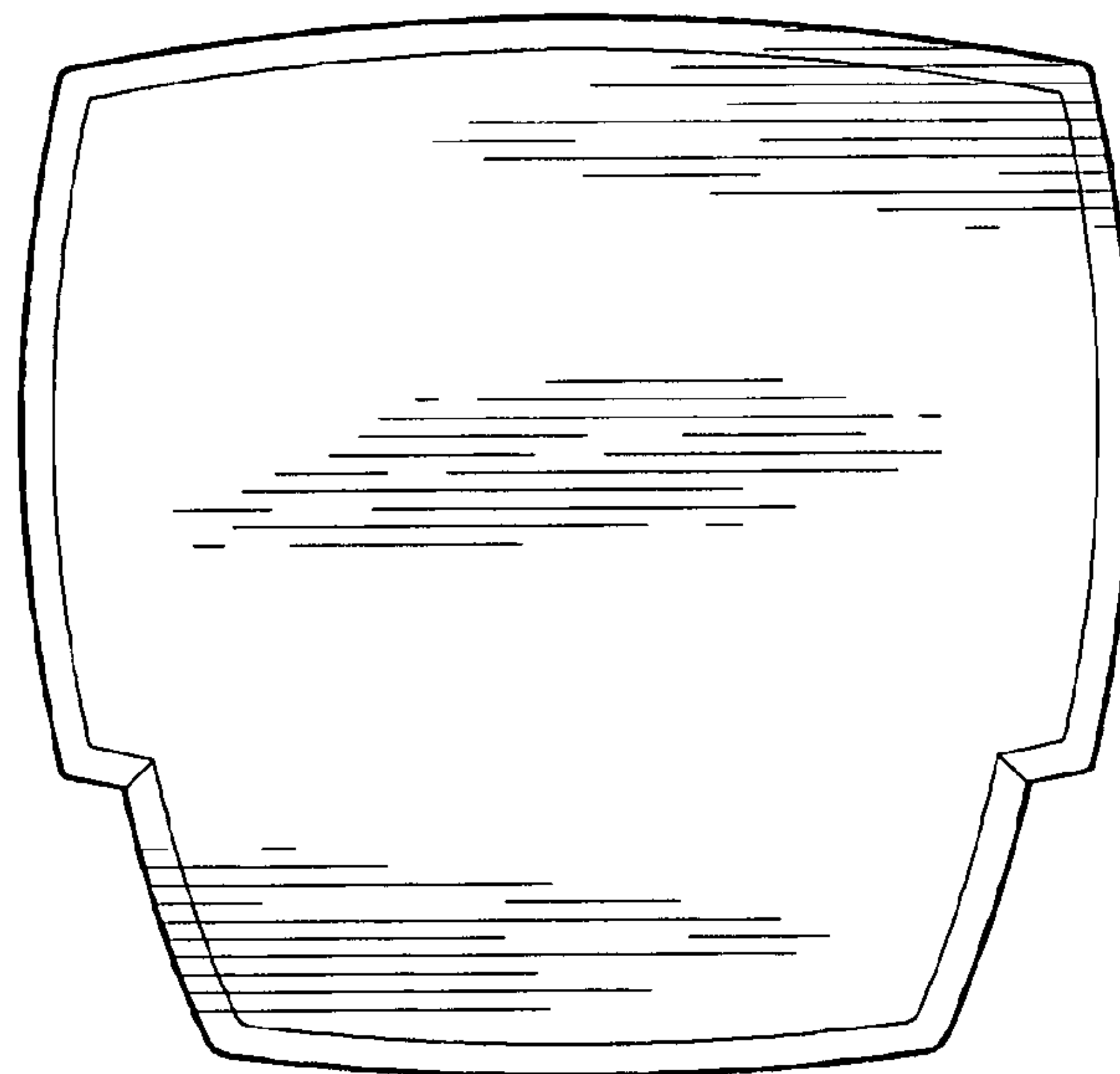
