I claim the ornamental design for a reflective dog safety vest,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a right-side view of a reflective dog safety vest  
shown in use on a dog;

FIG. 2 is another right-side view of the invention;

FIG. 3 is a left-side elevational view of the invention;

FIG. 4 is a front elevational view of the invention;

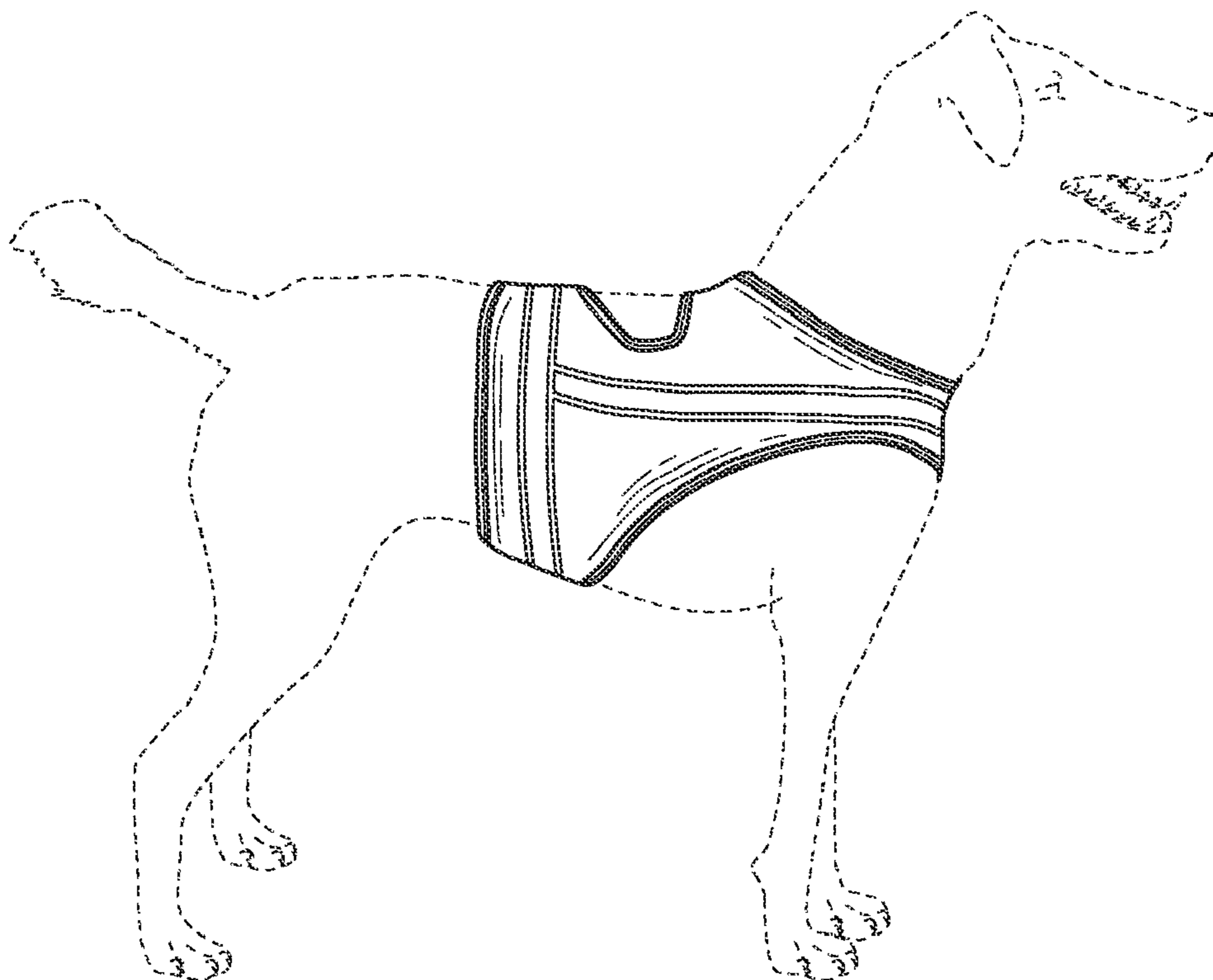
FIG. 5 is a rear elevational view of the invention;

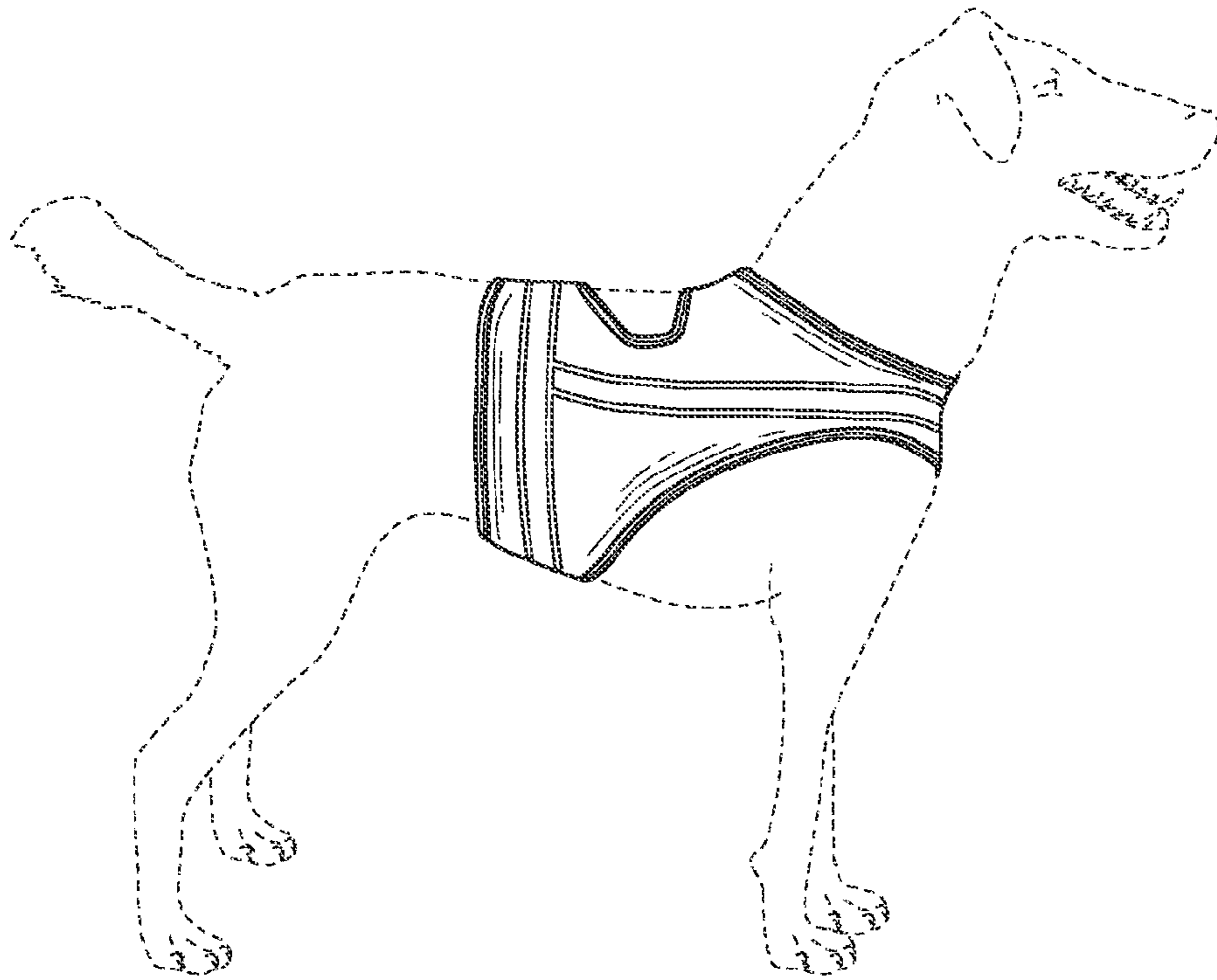

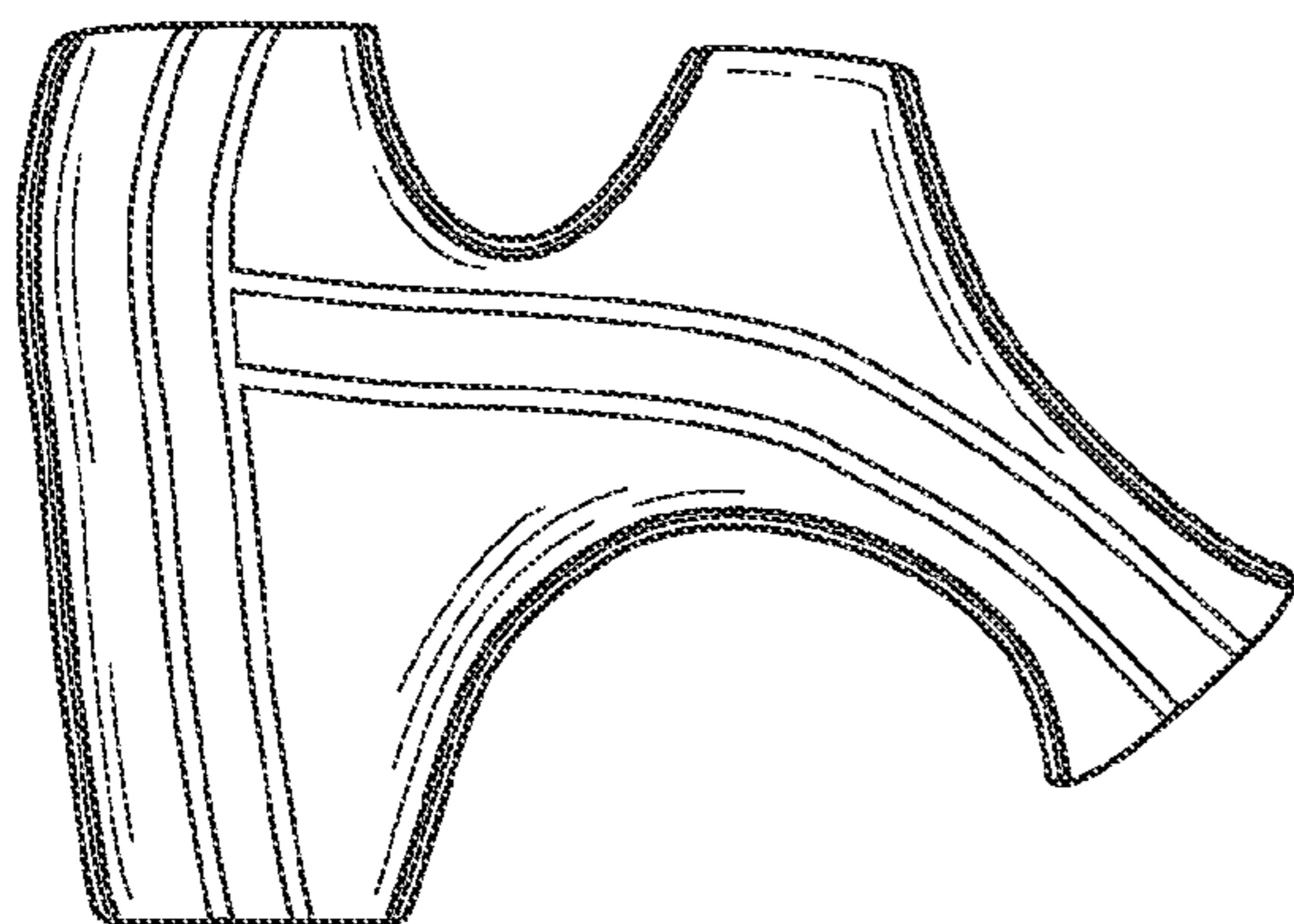

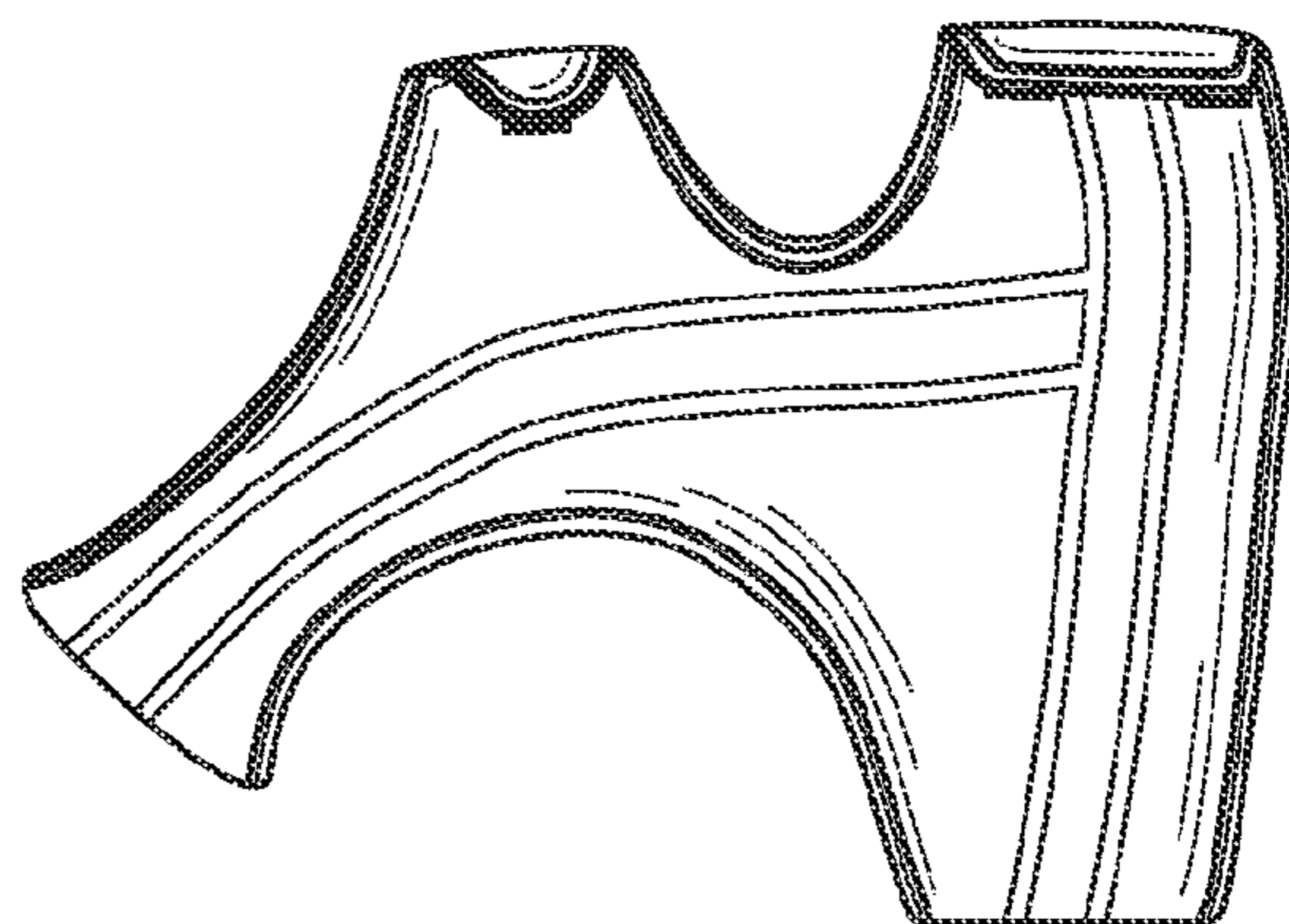

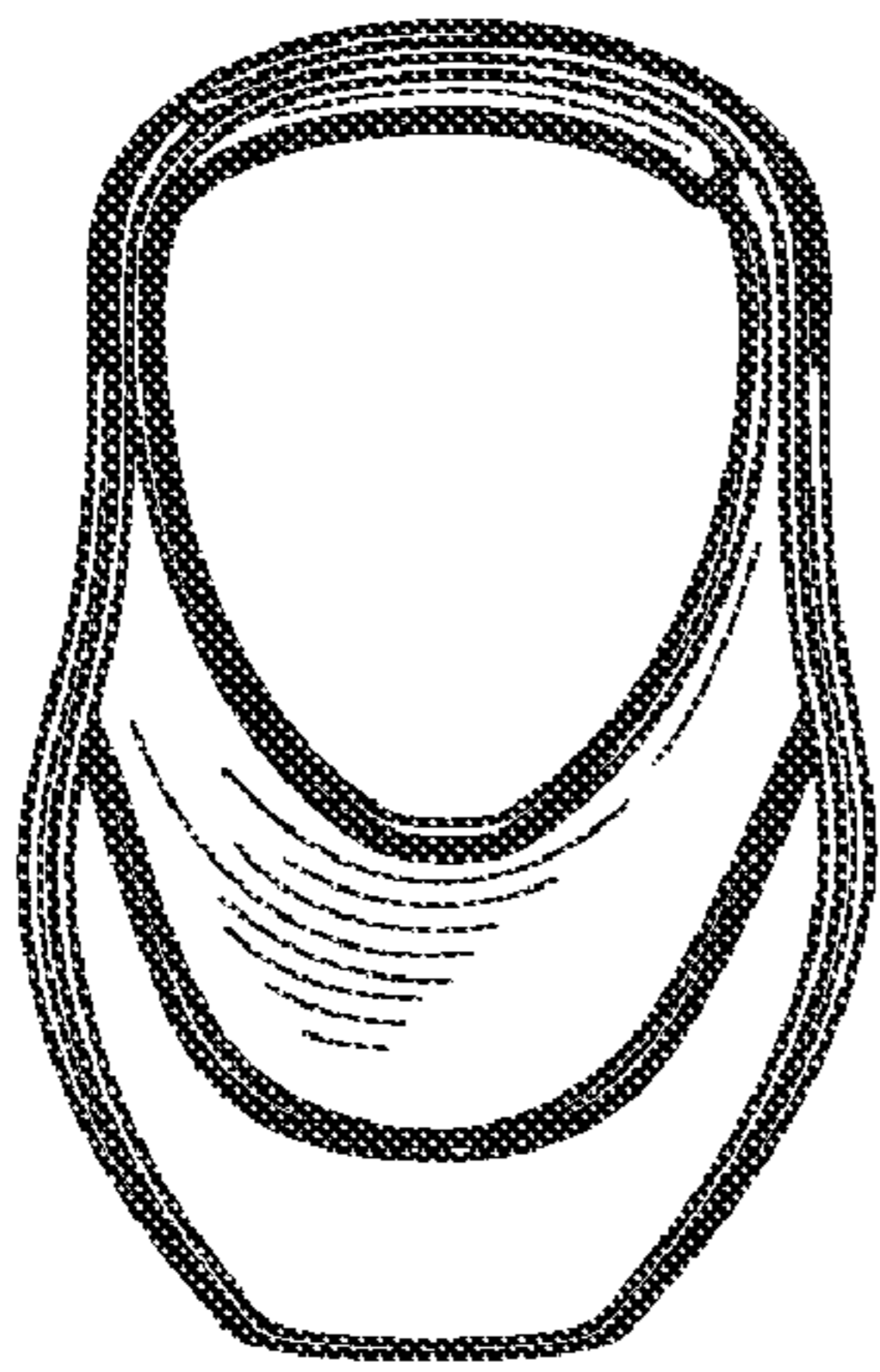

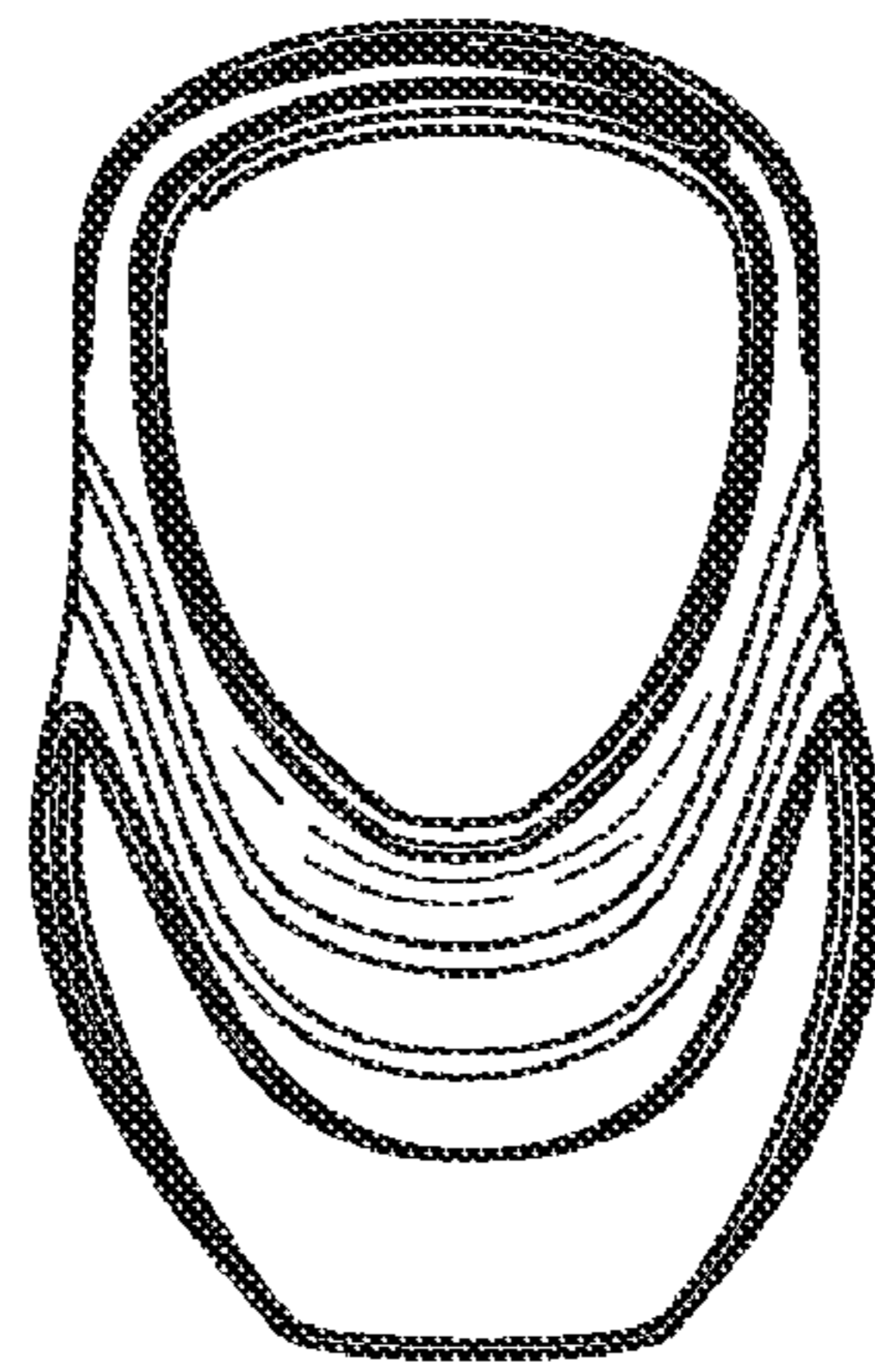

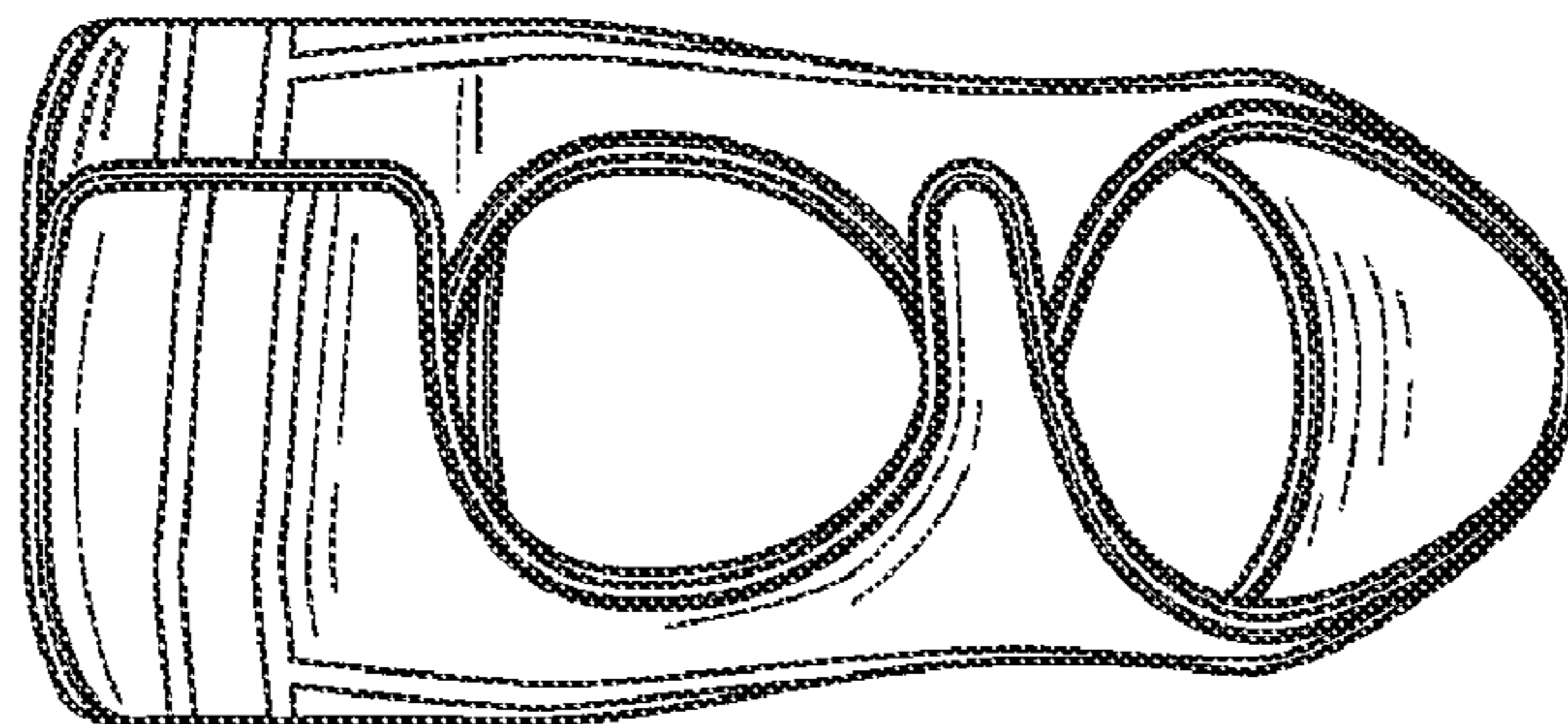

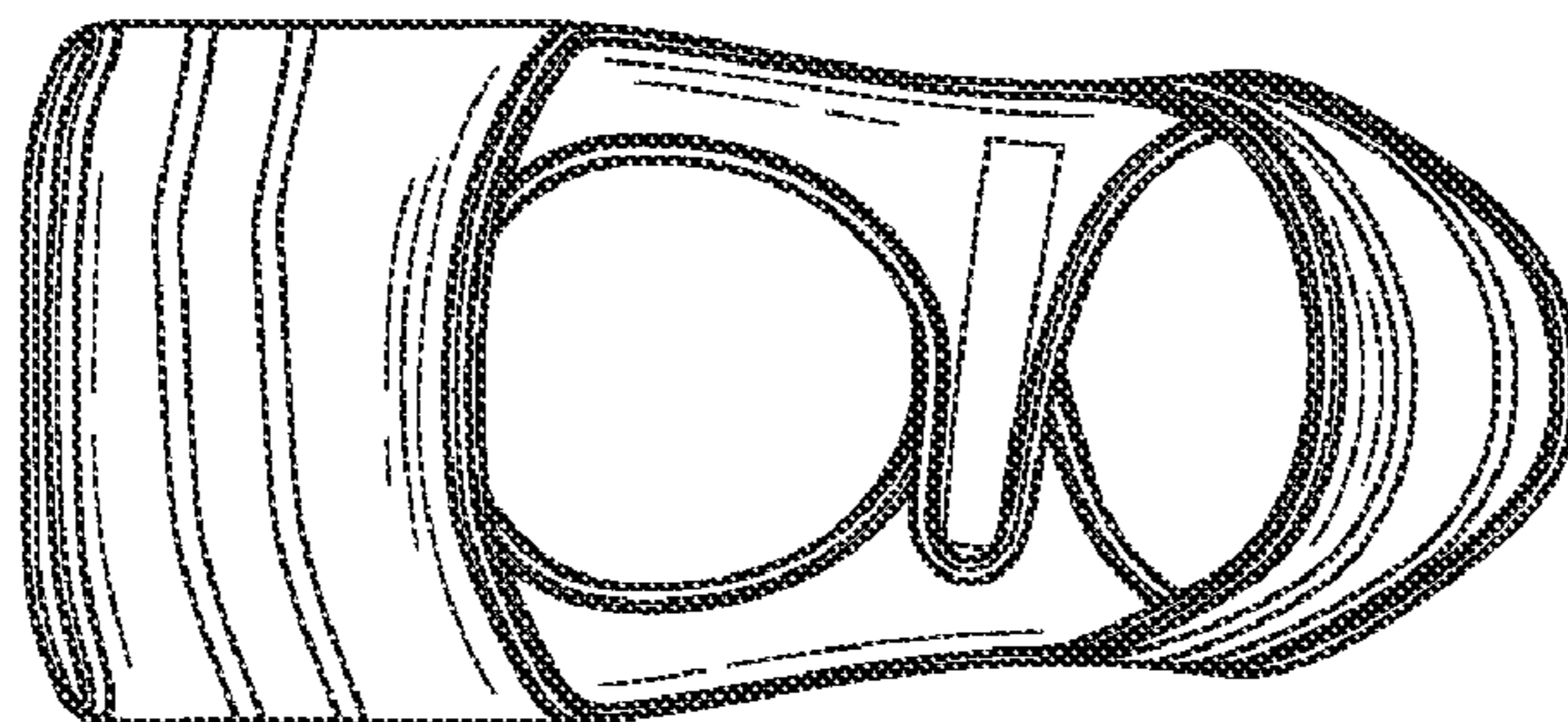
