(57) **CLAIM**

The ornamental design for a carbide paint scraper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top perspective view of a carbide paint scraper showing our new design;

FIG. 16 is a front elevational view thereof;

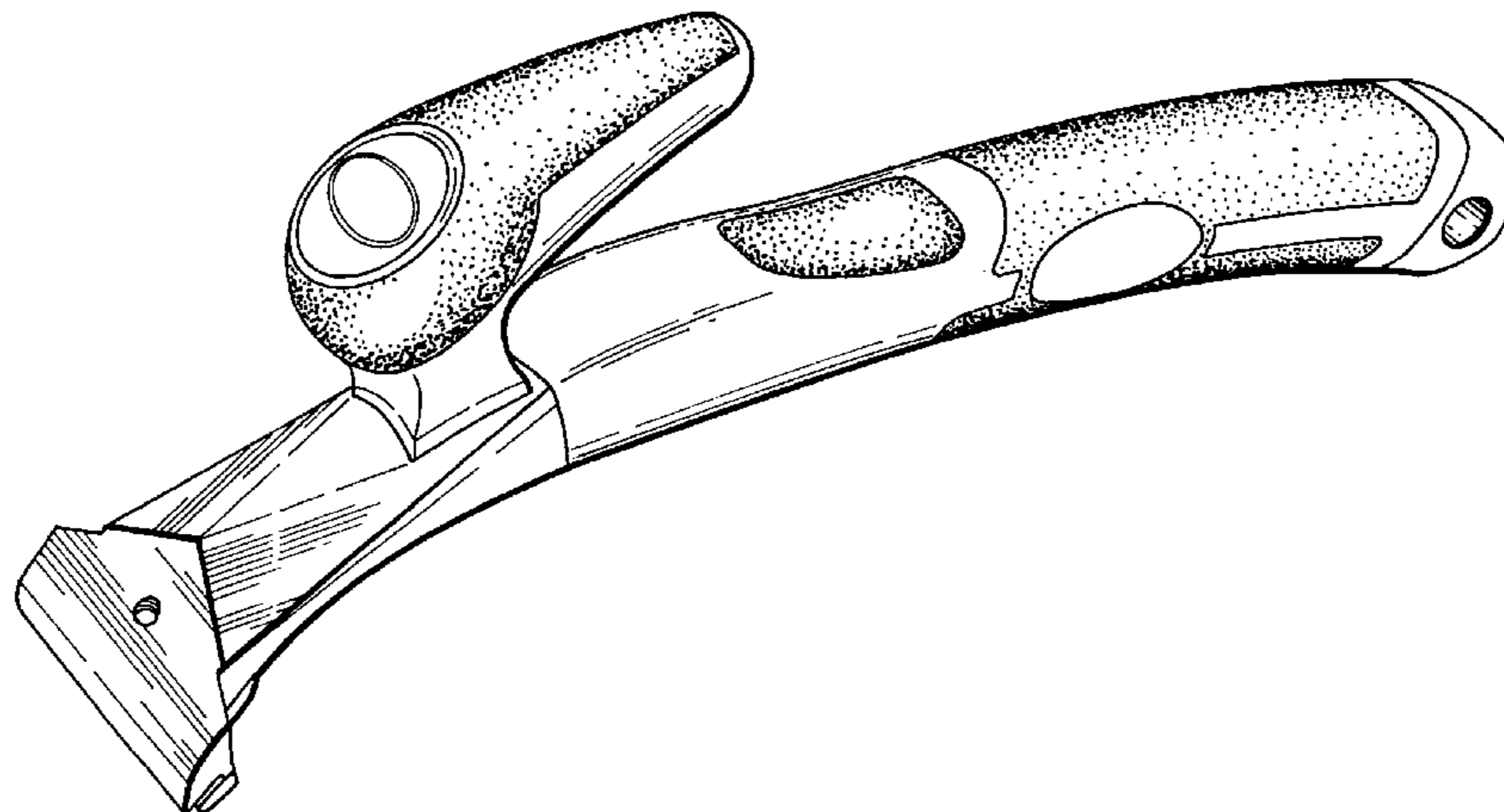
FIG. 17 is a rear elevational view thereof;

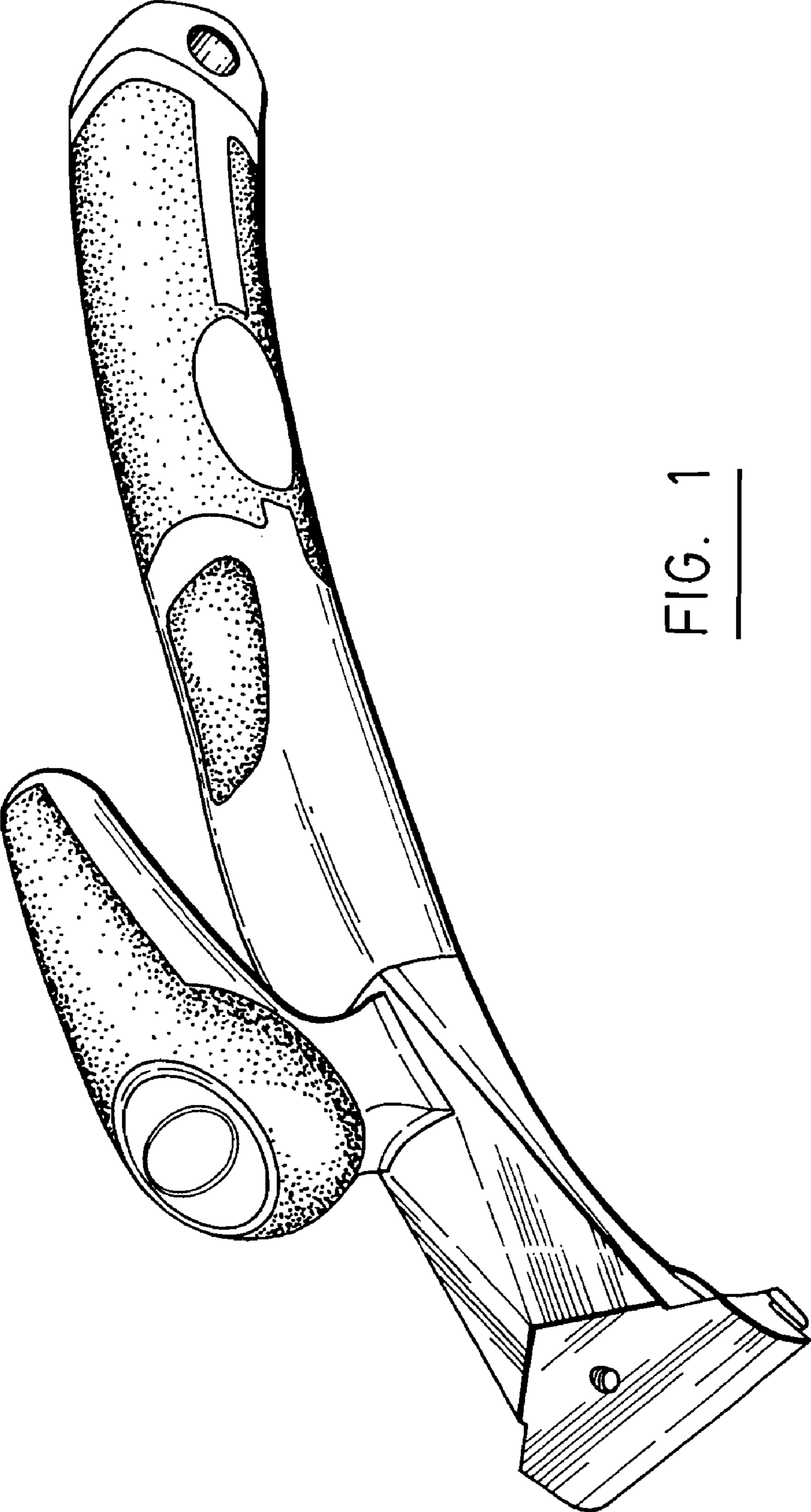

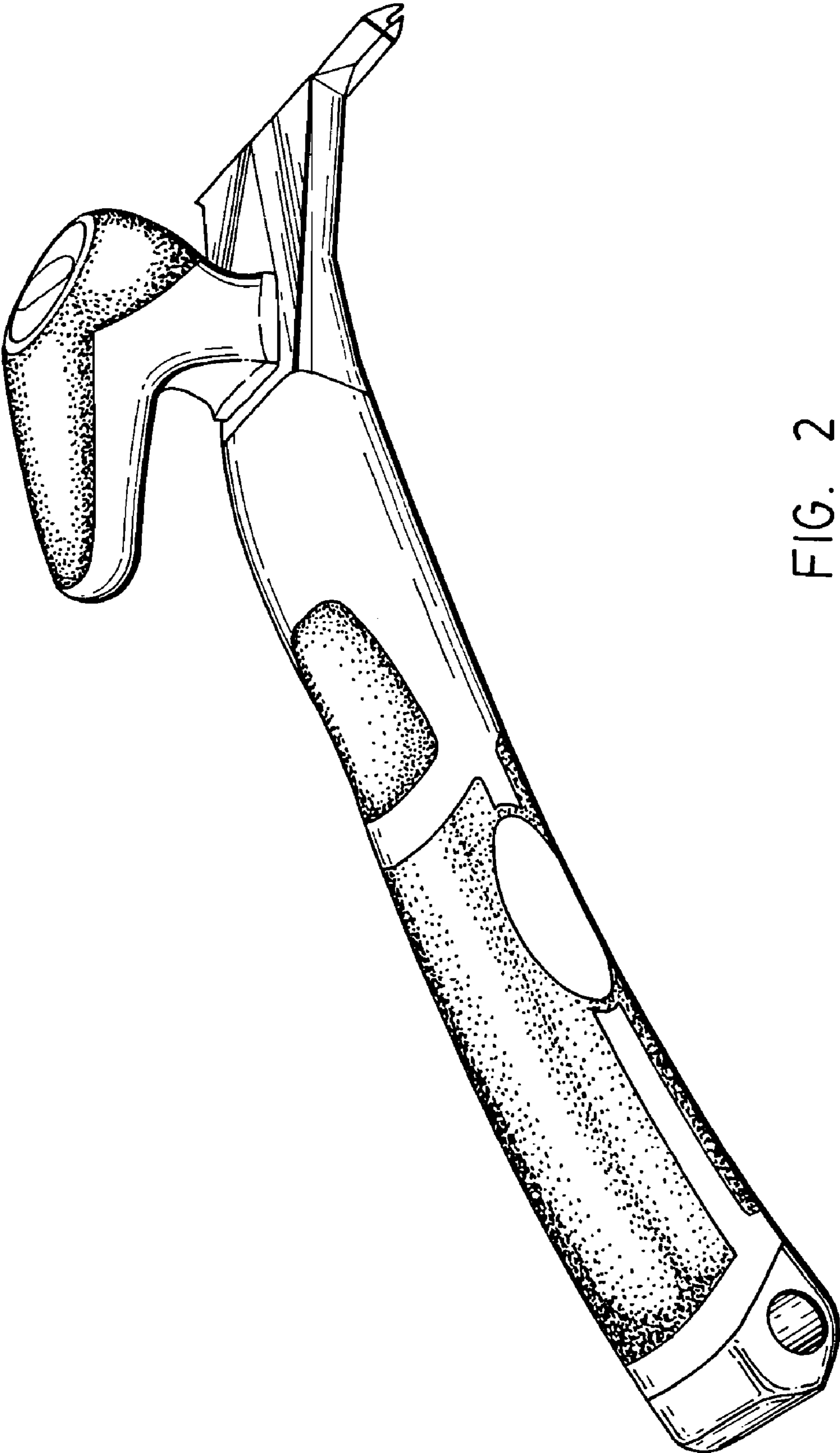

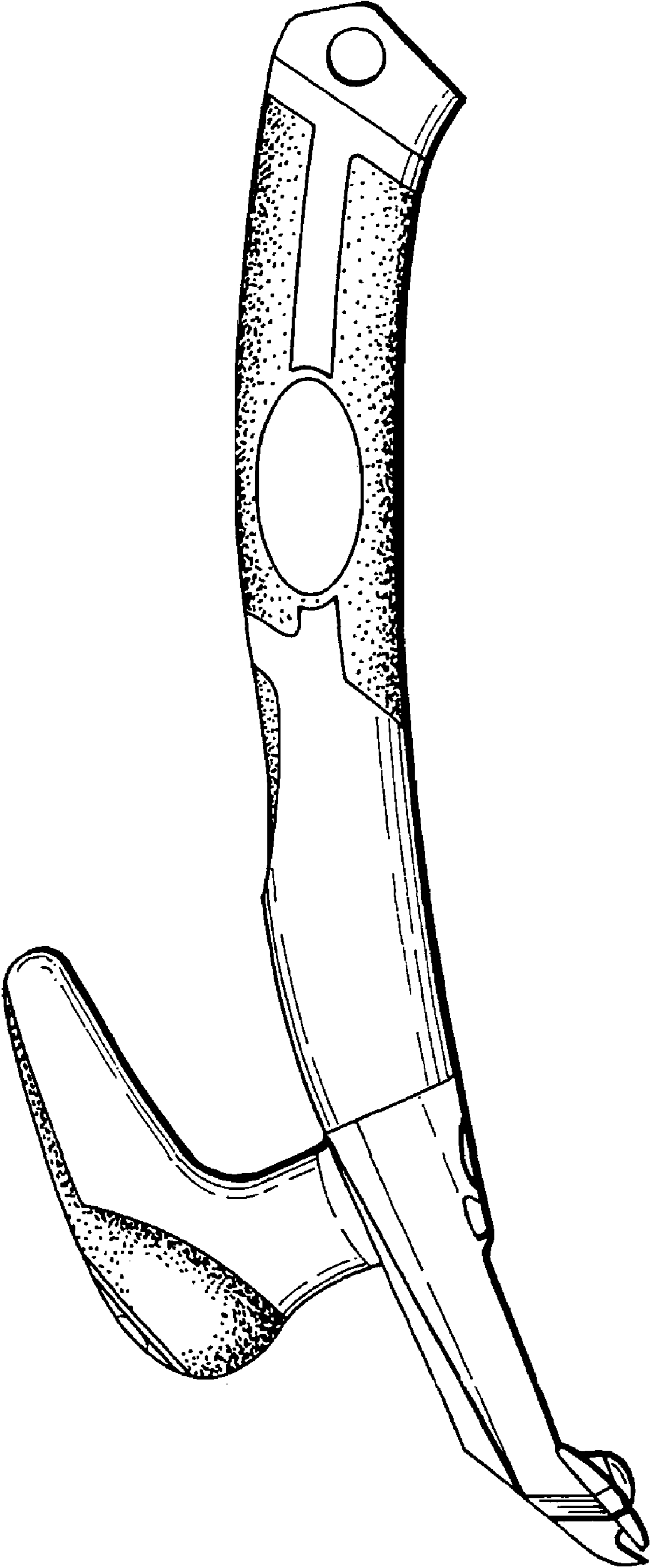

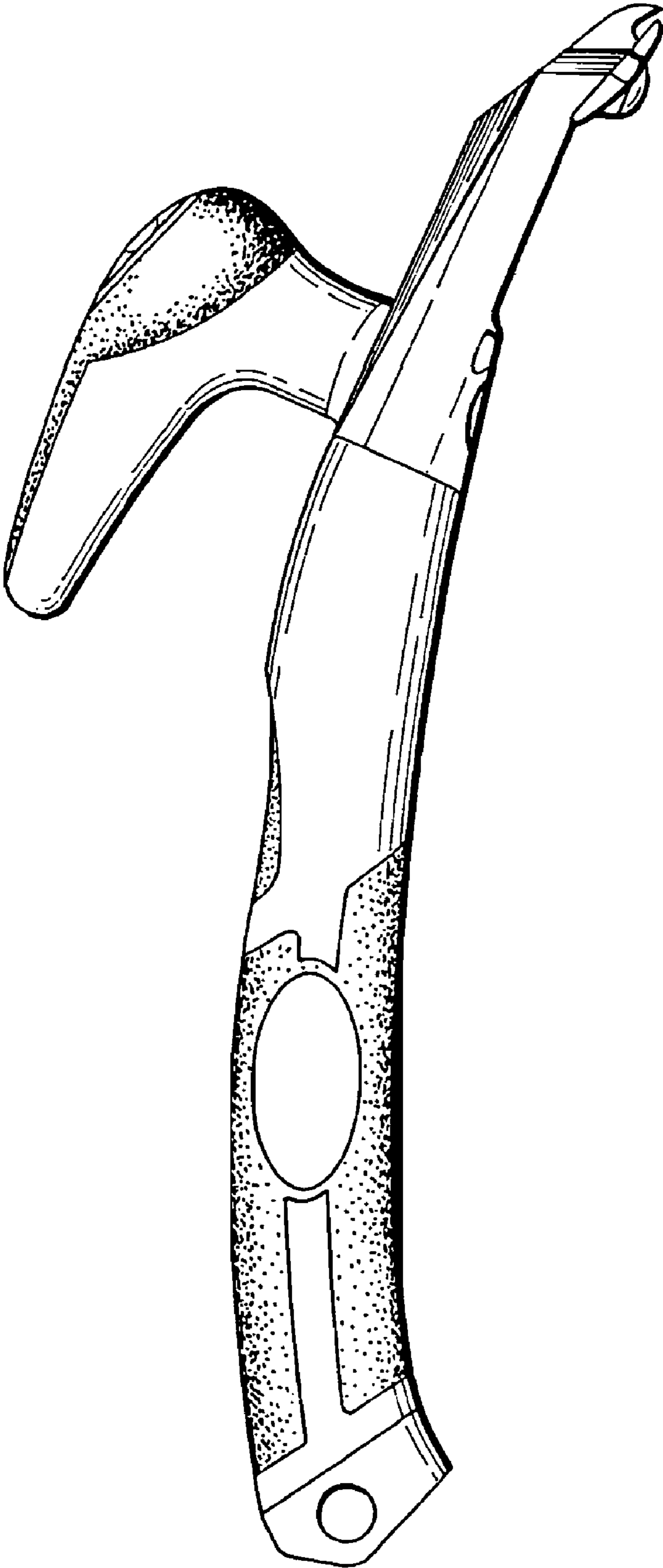

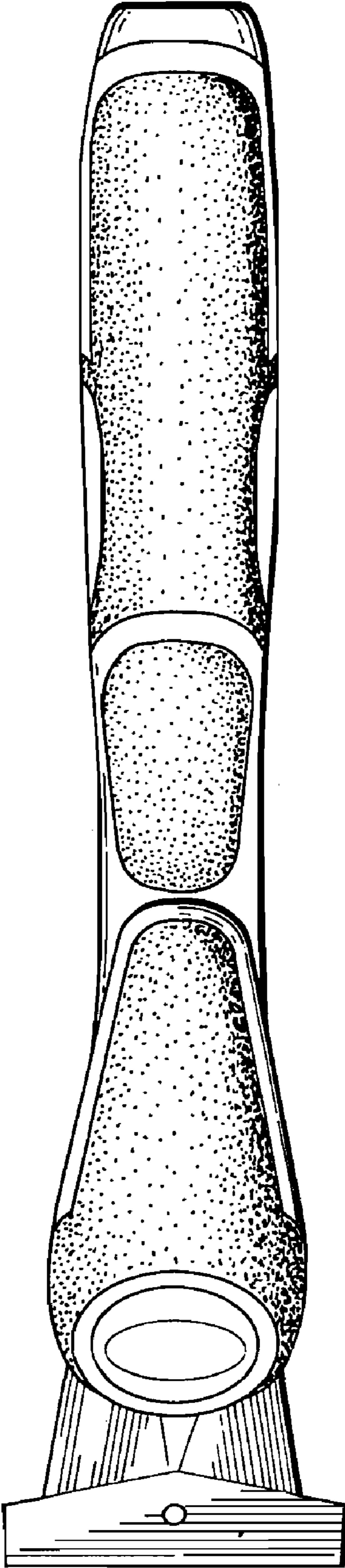

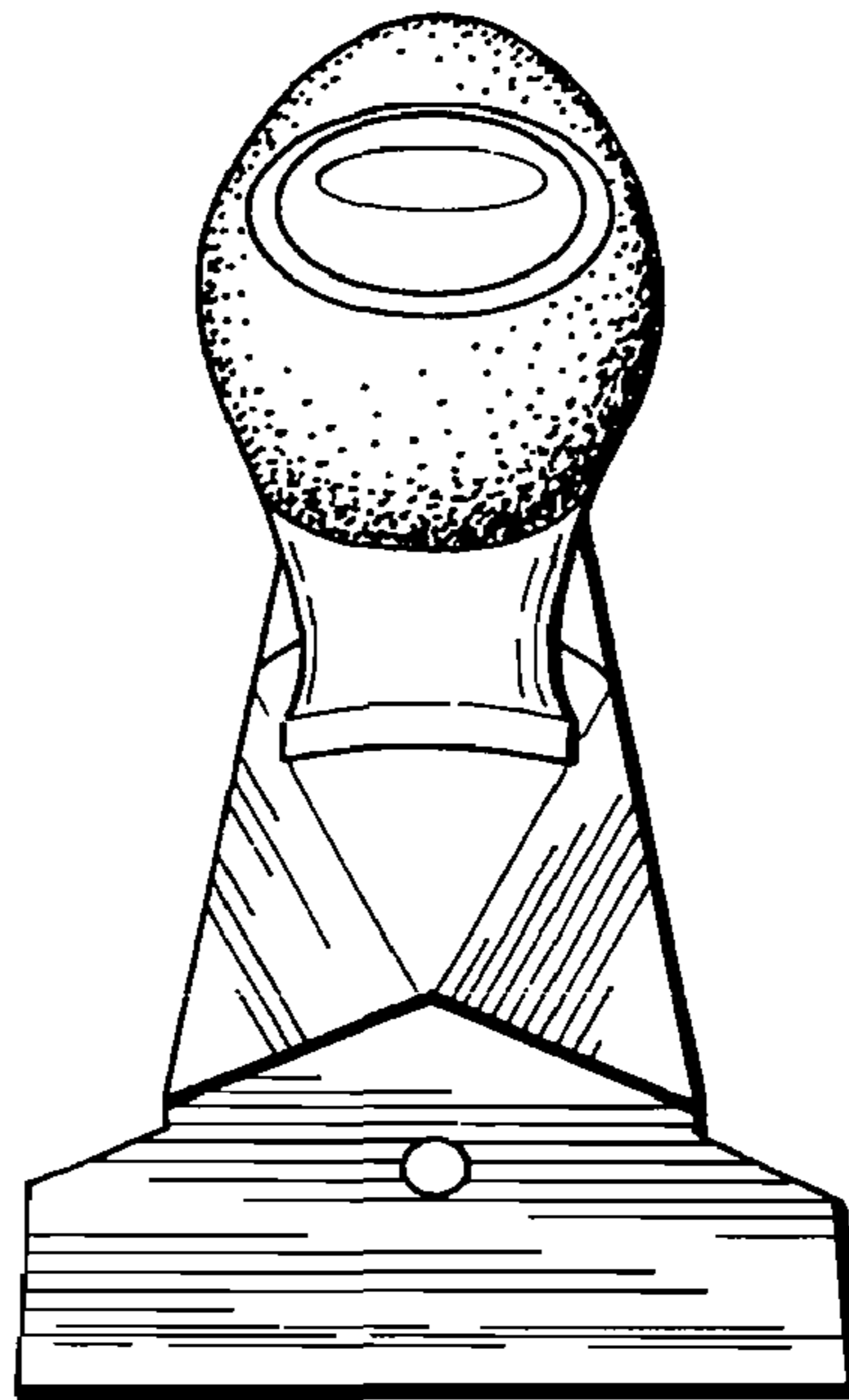

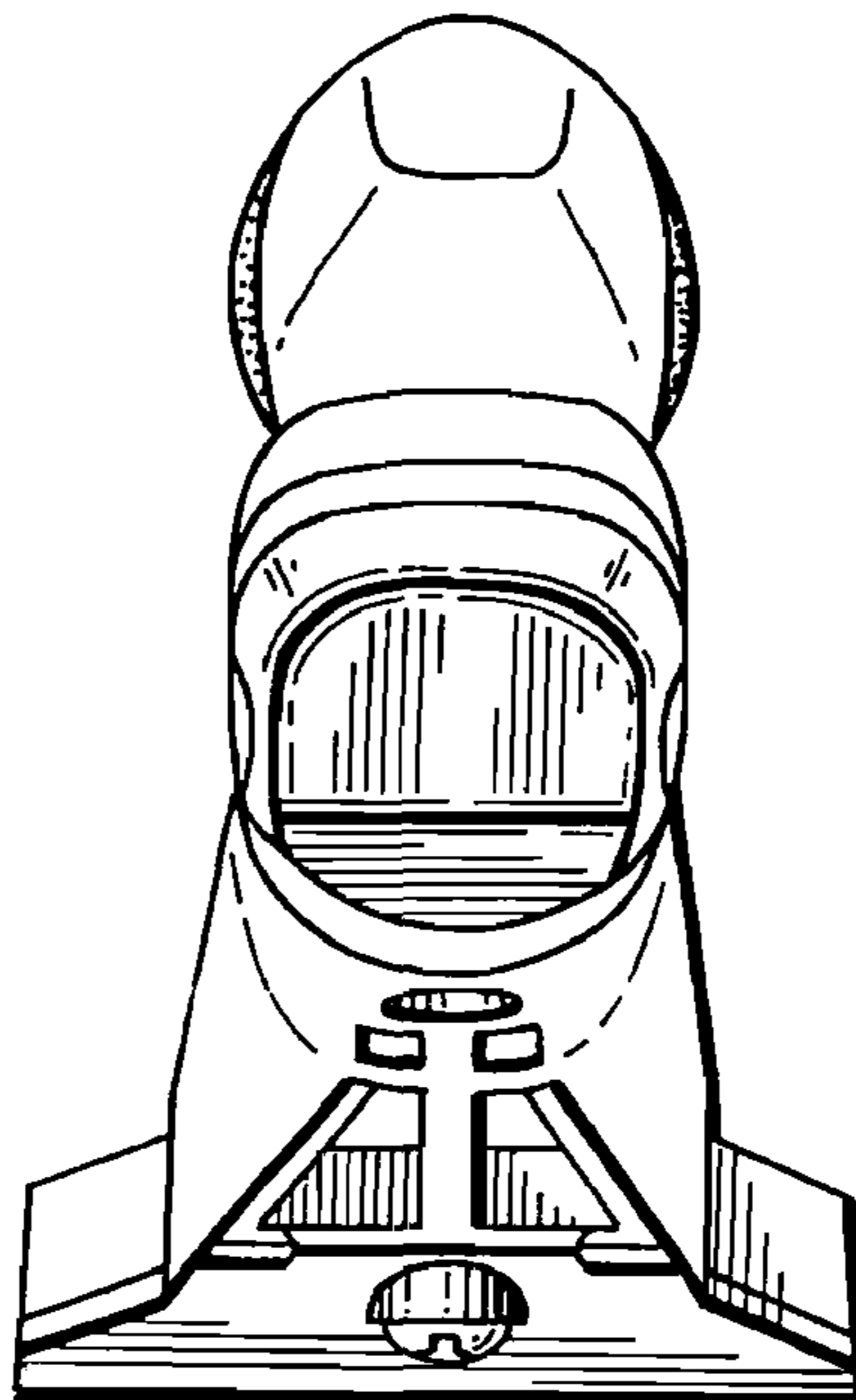

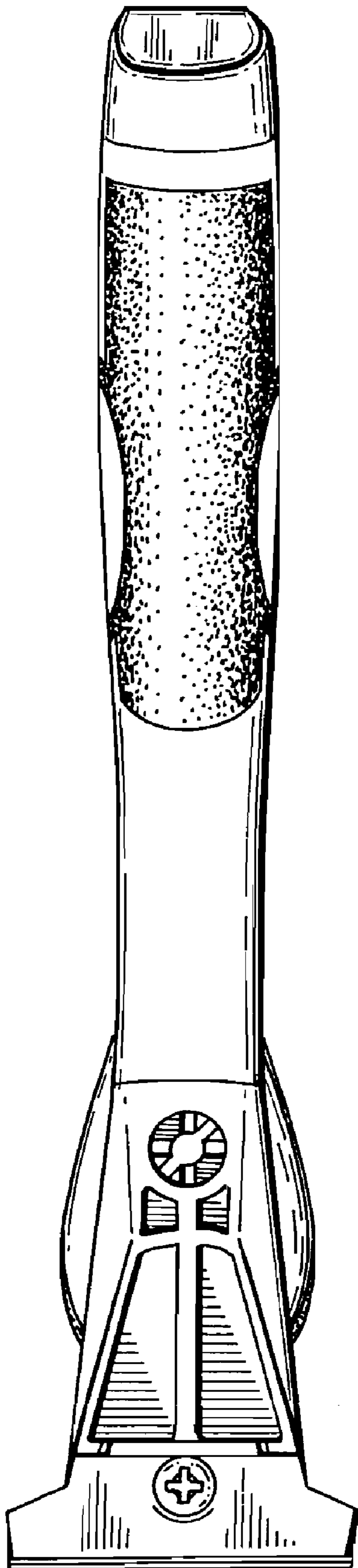

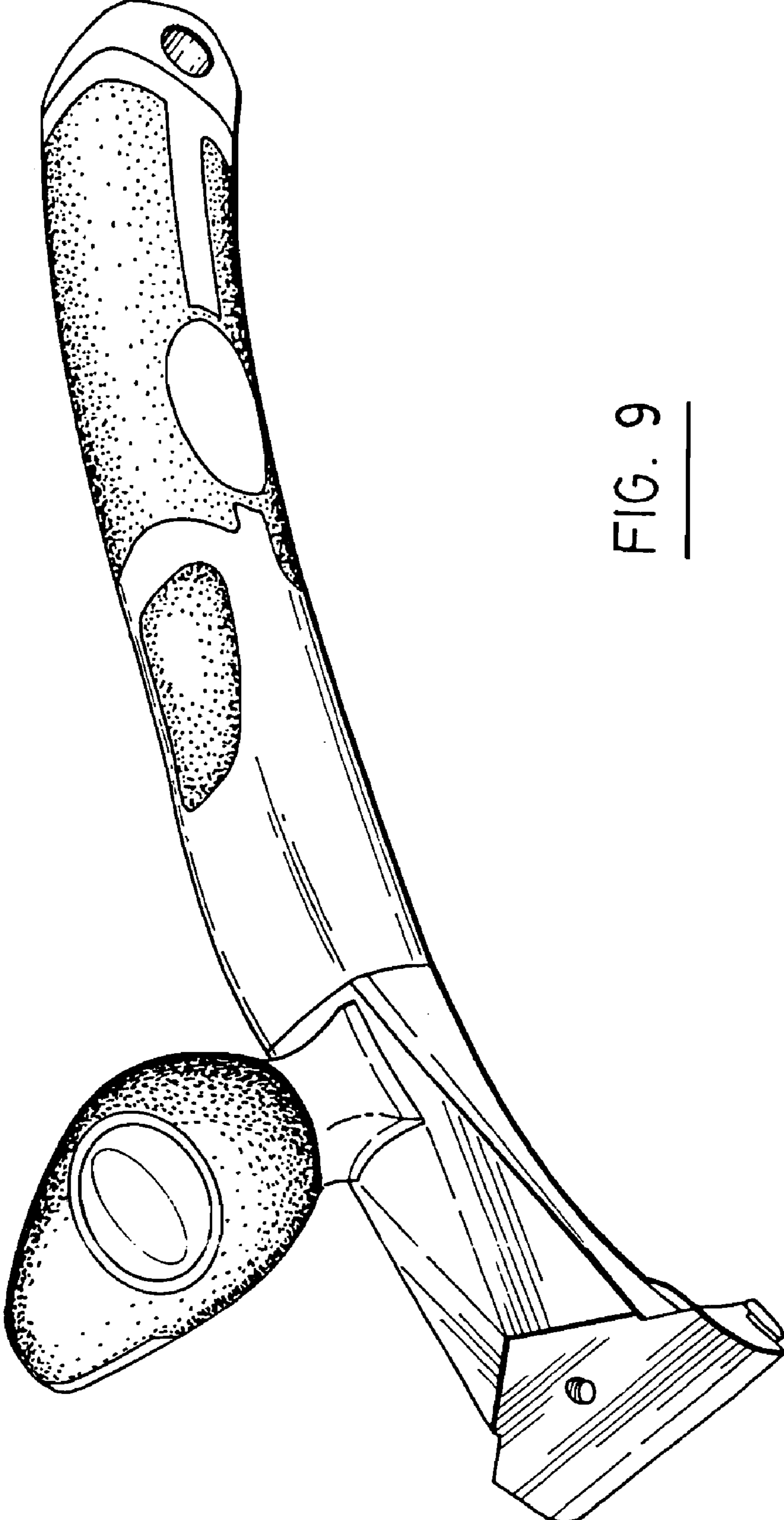

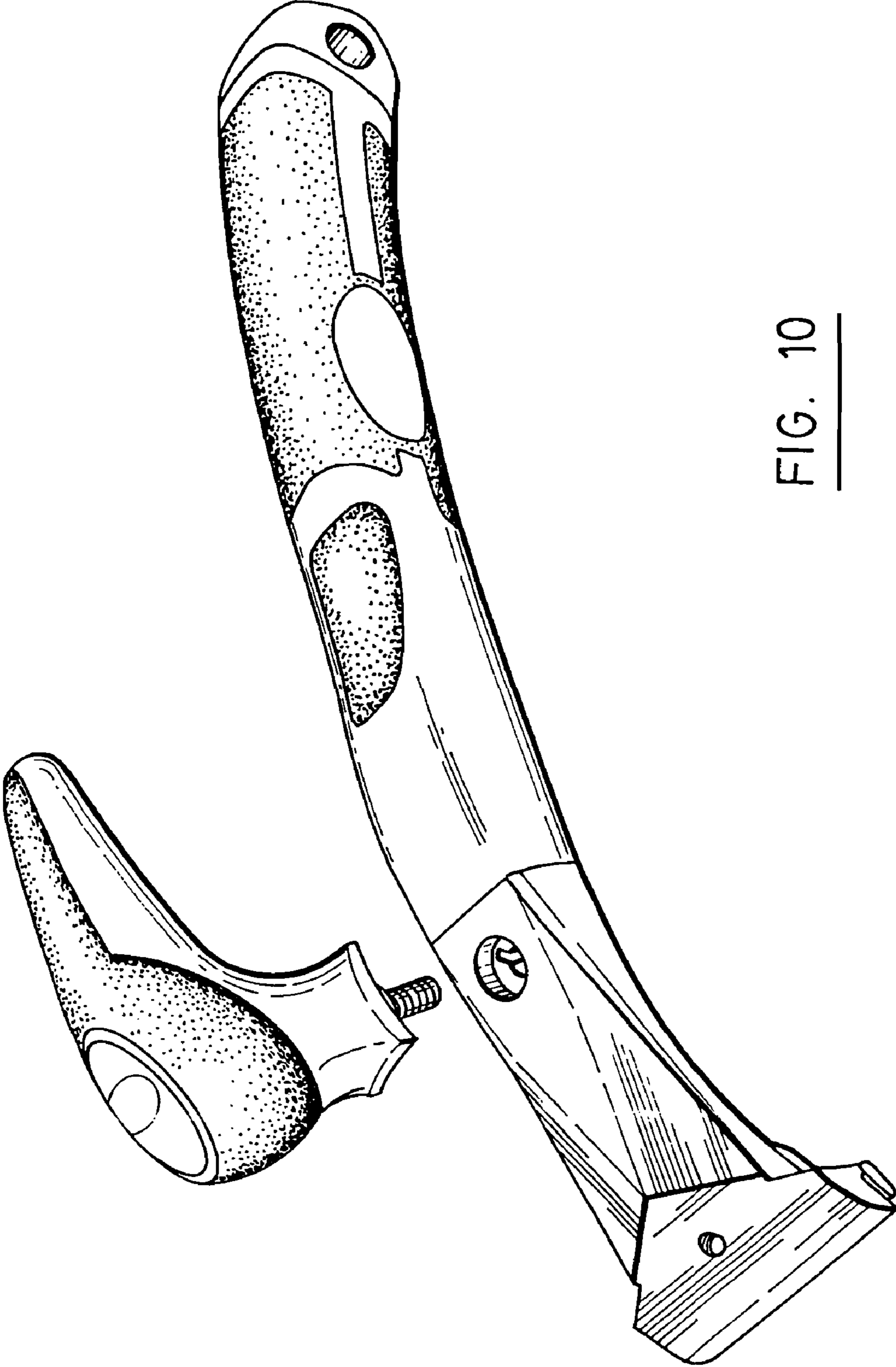

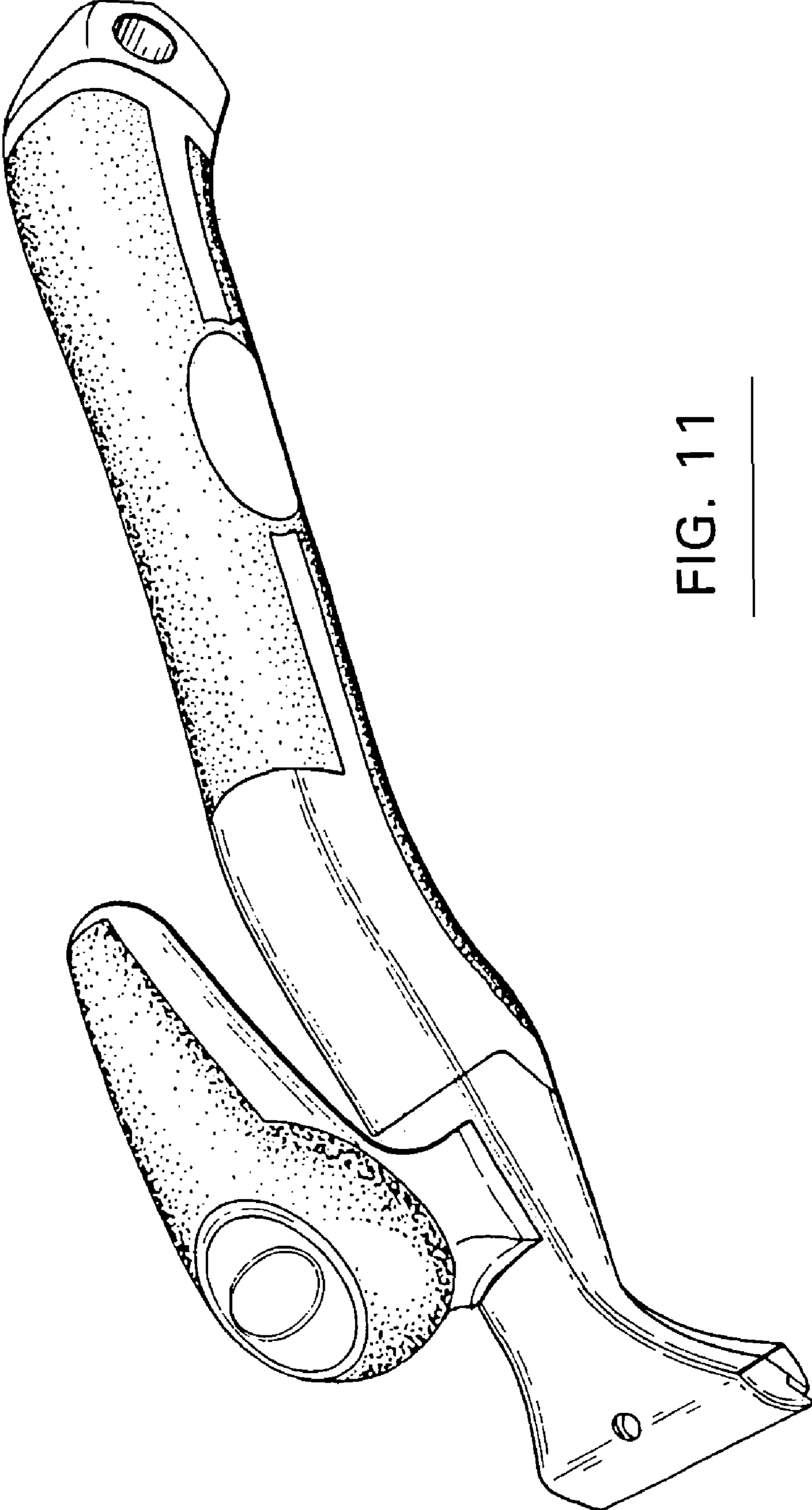

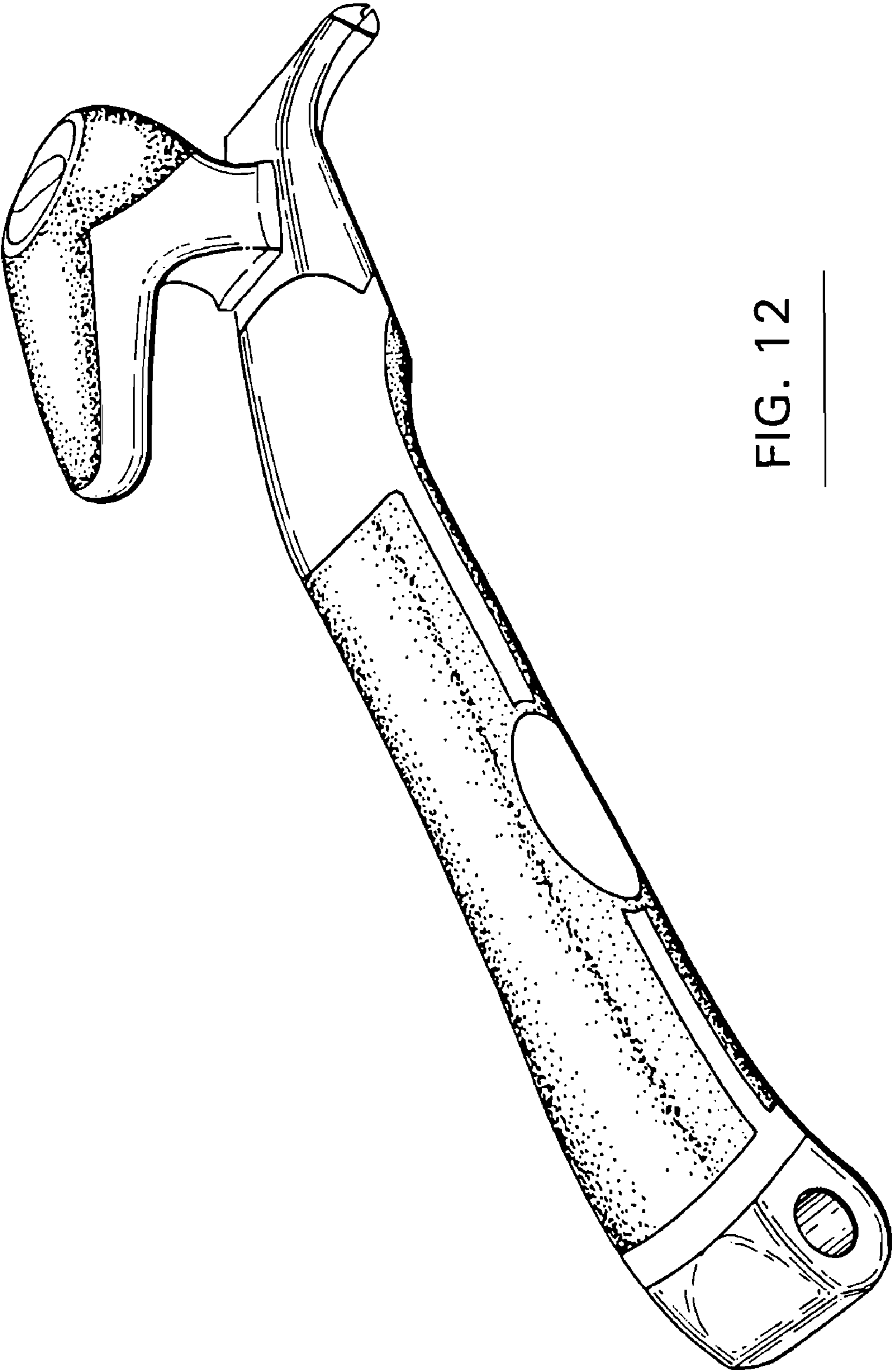

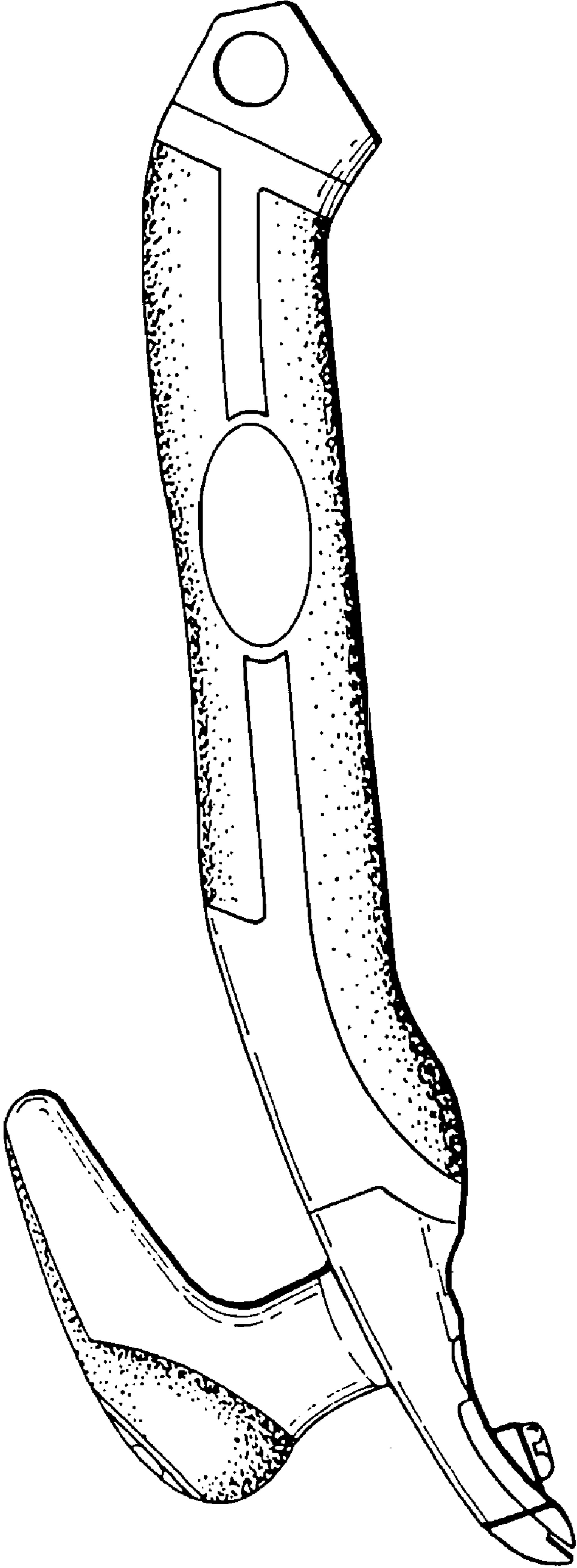

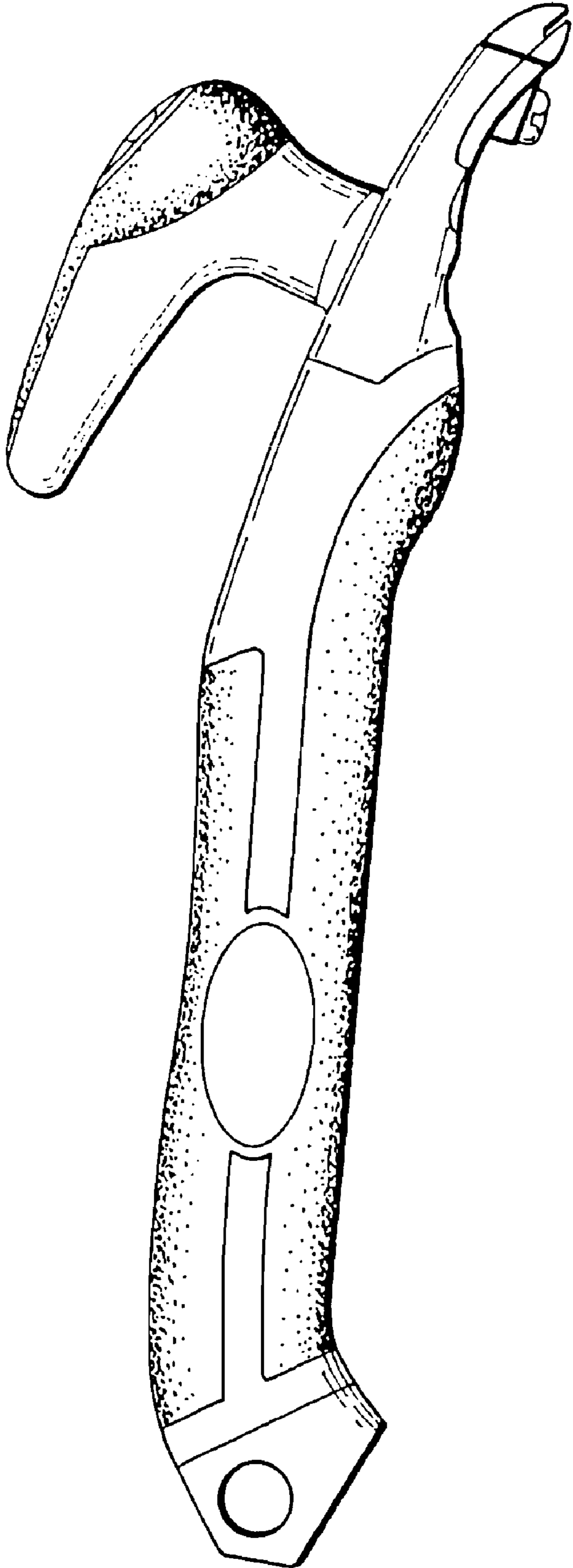

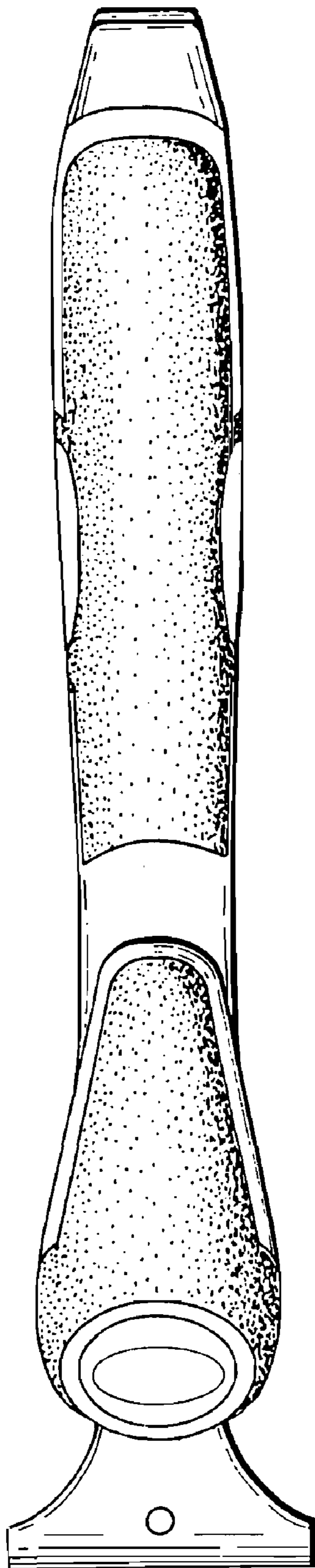

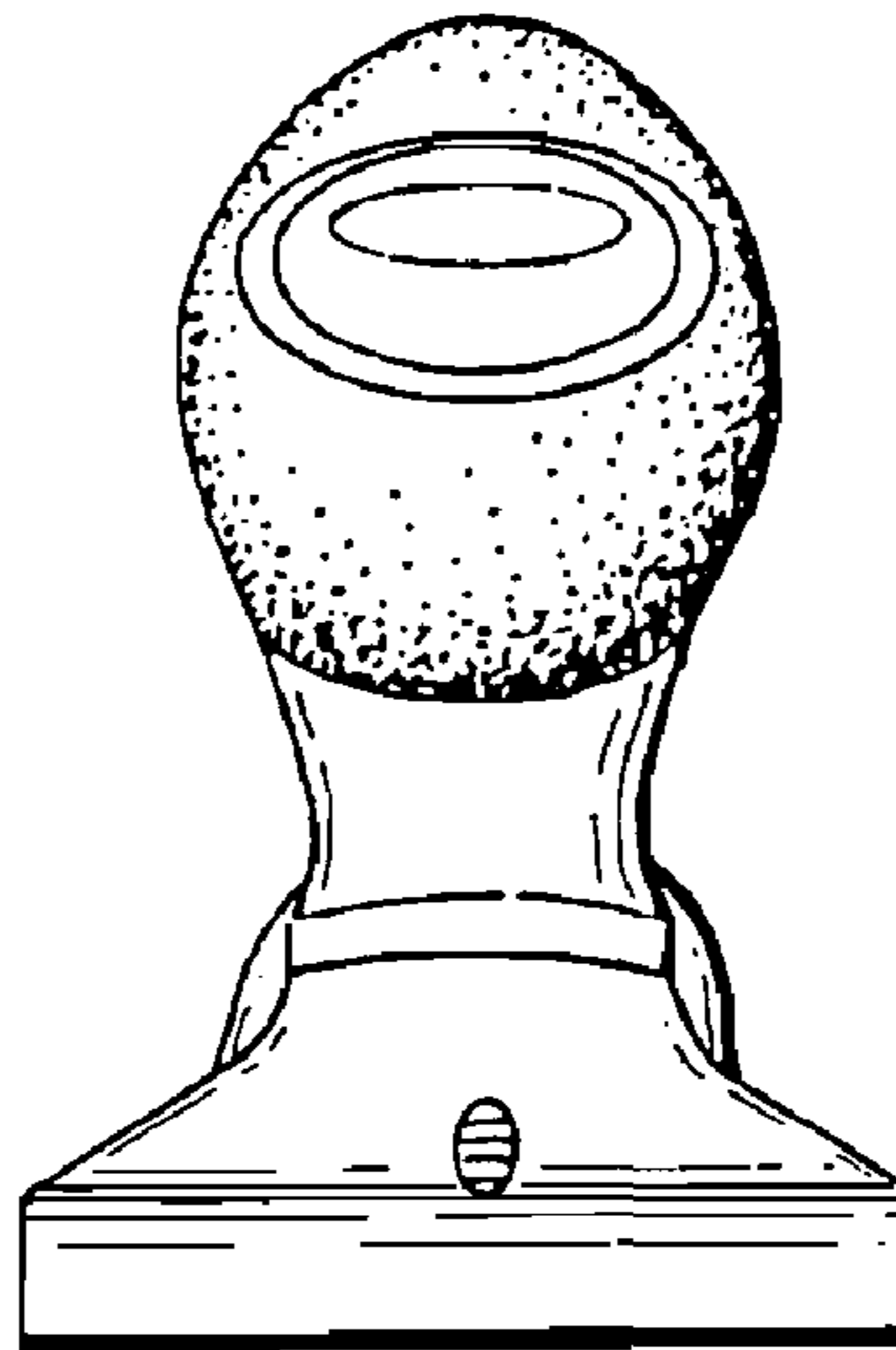

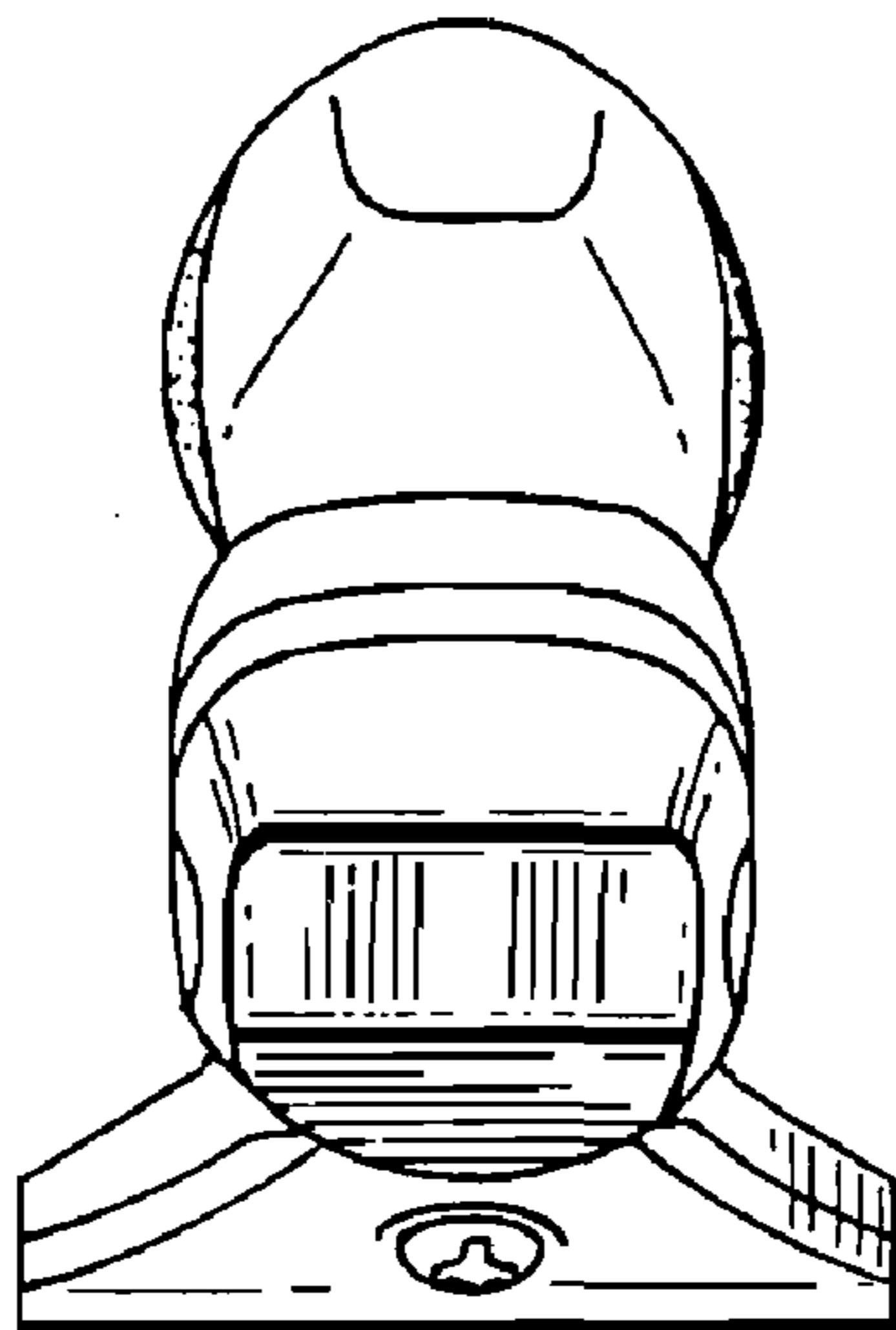

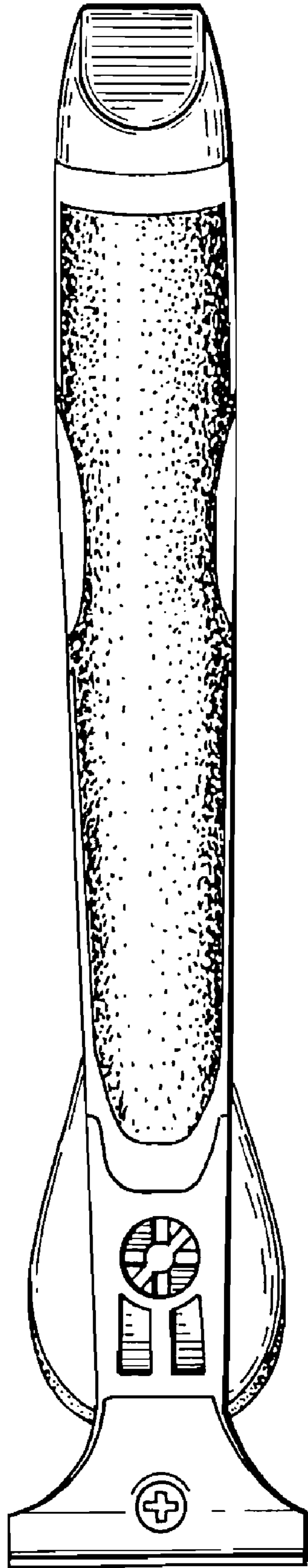

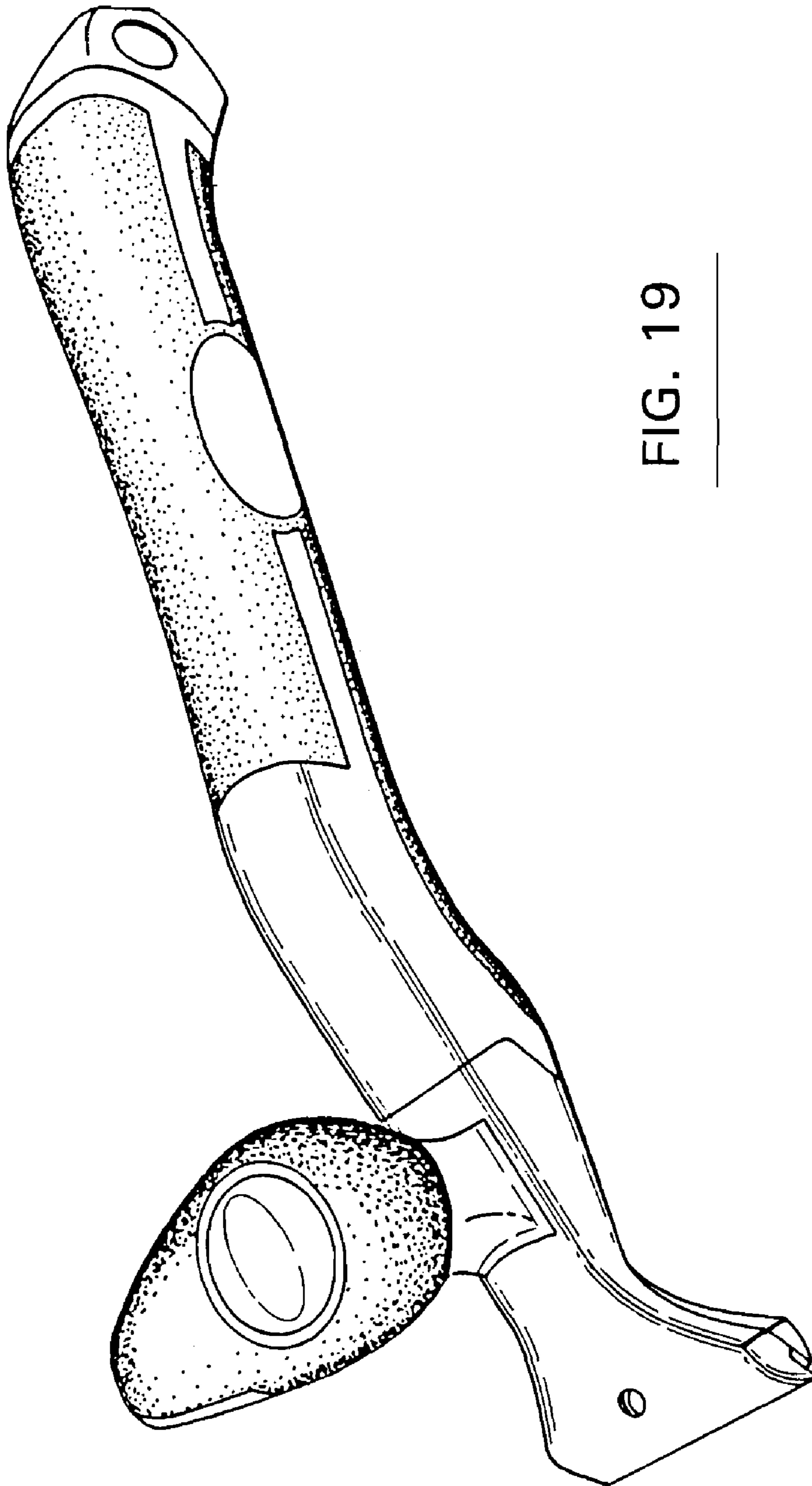

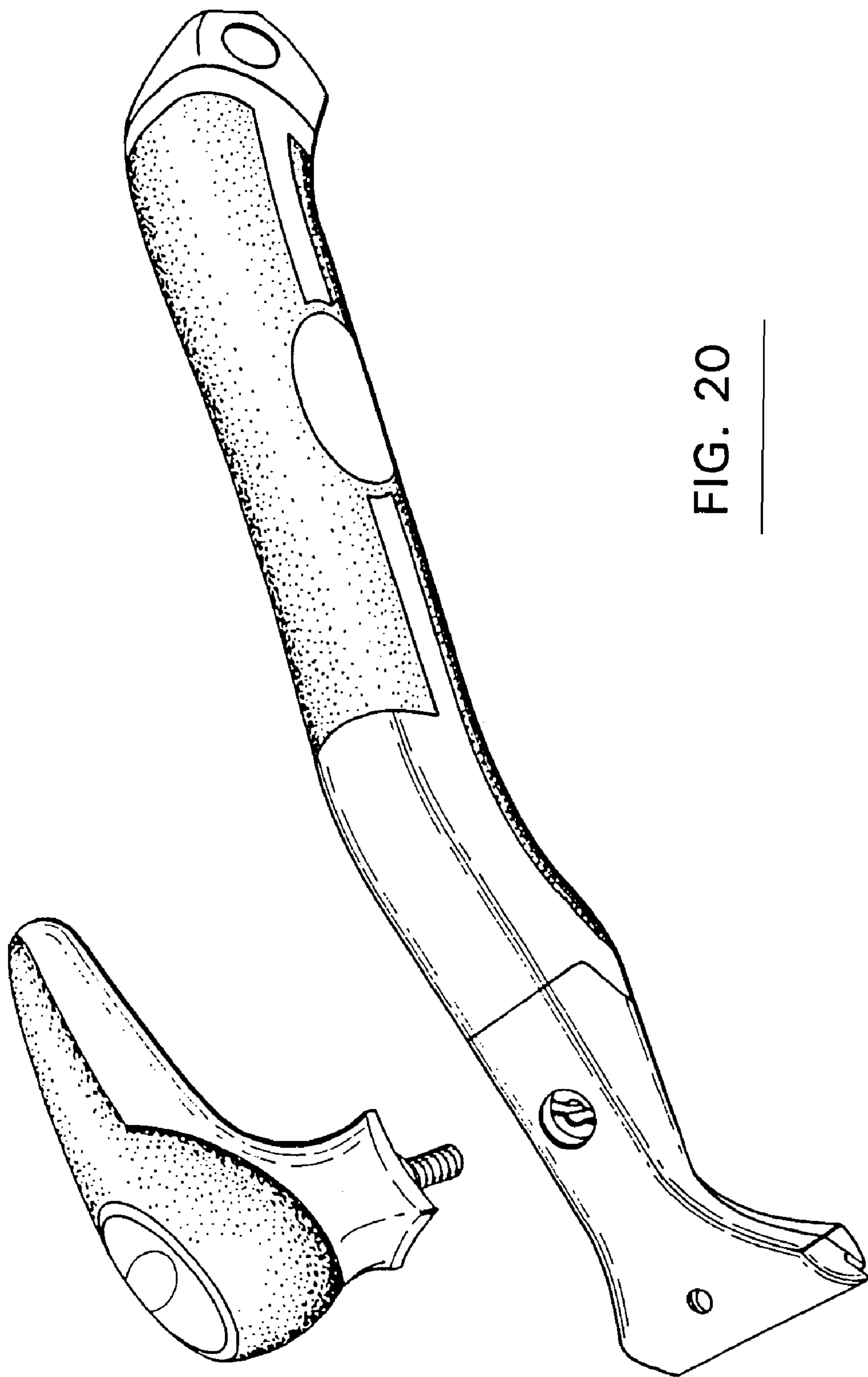
