The ornamental design for a fork lift truck, as shown and described.

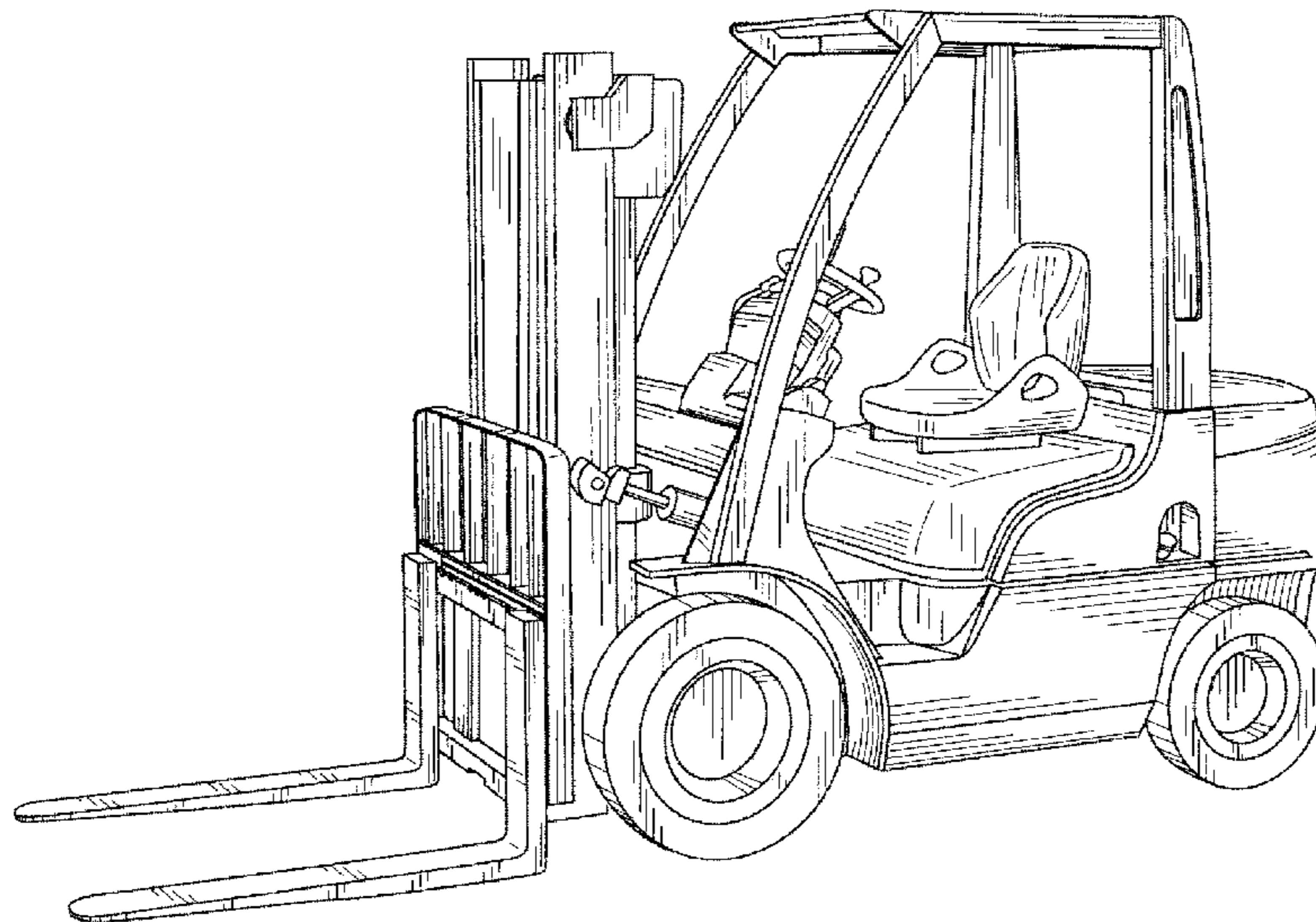

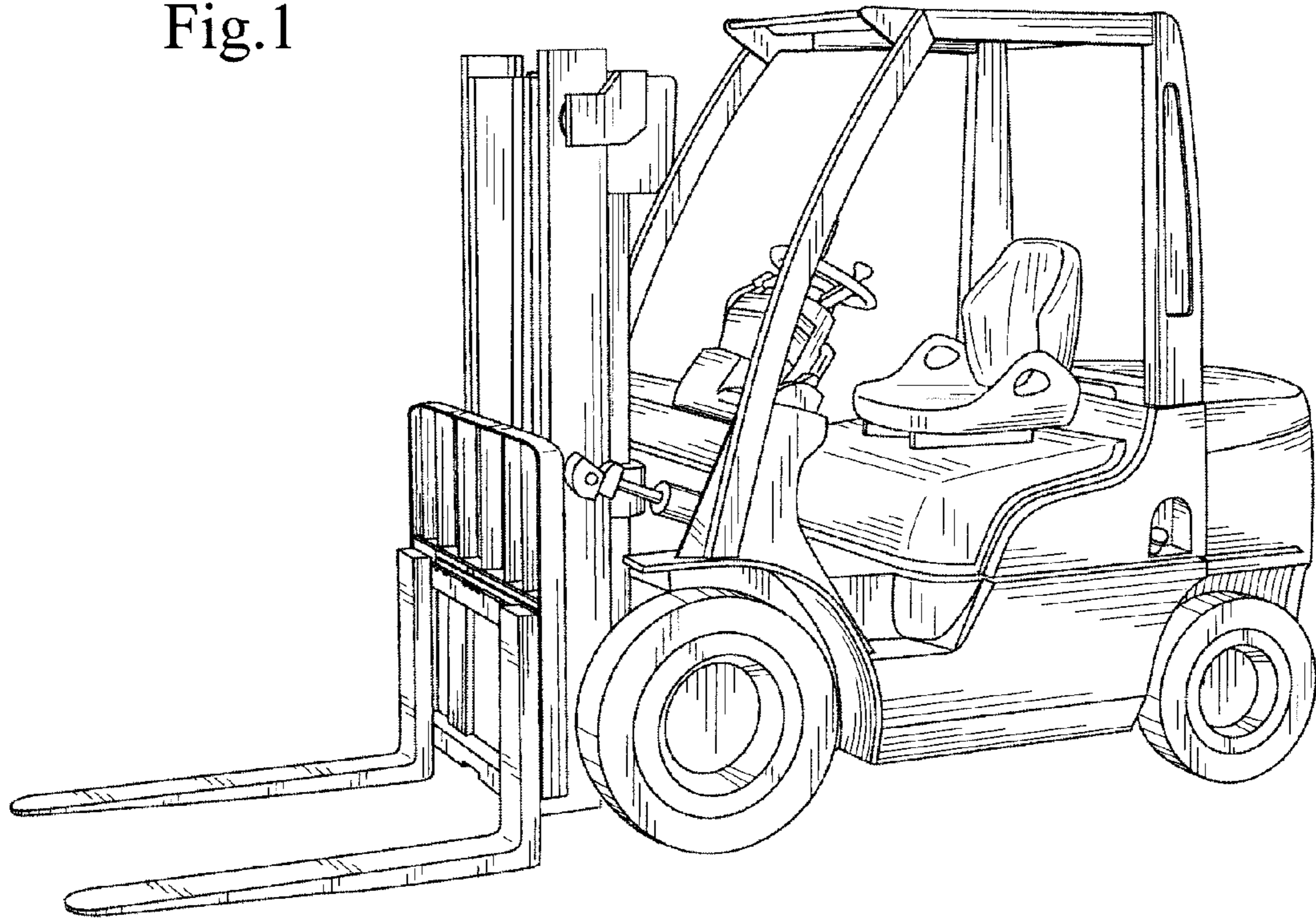

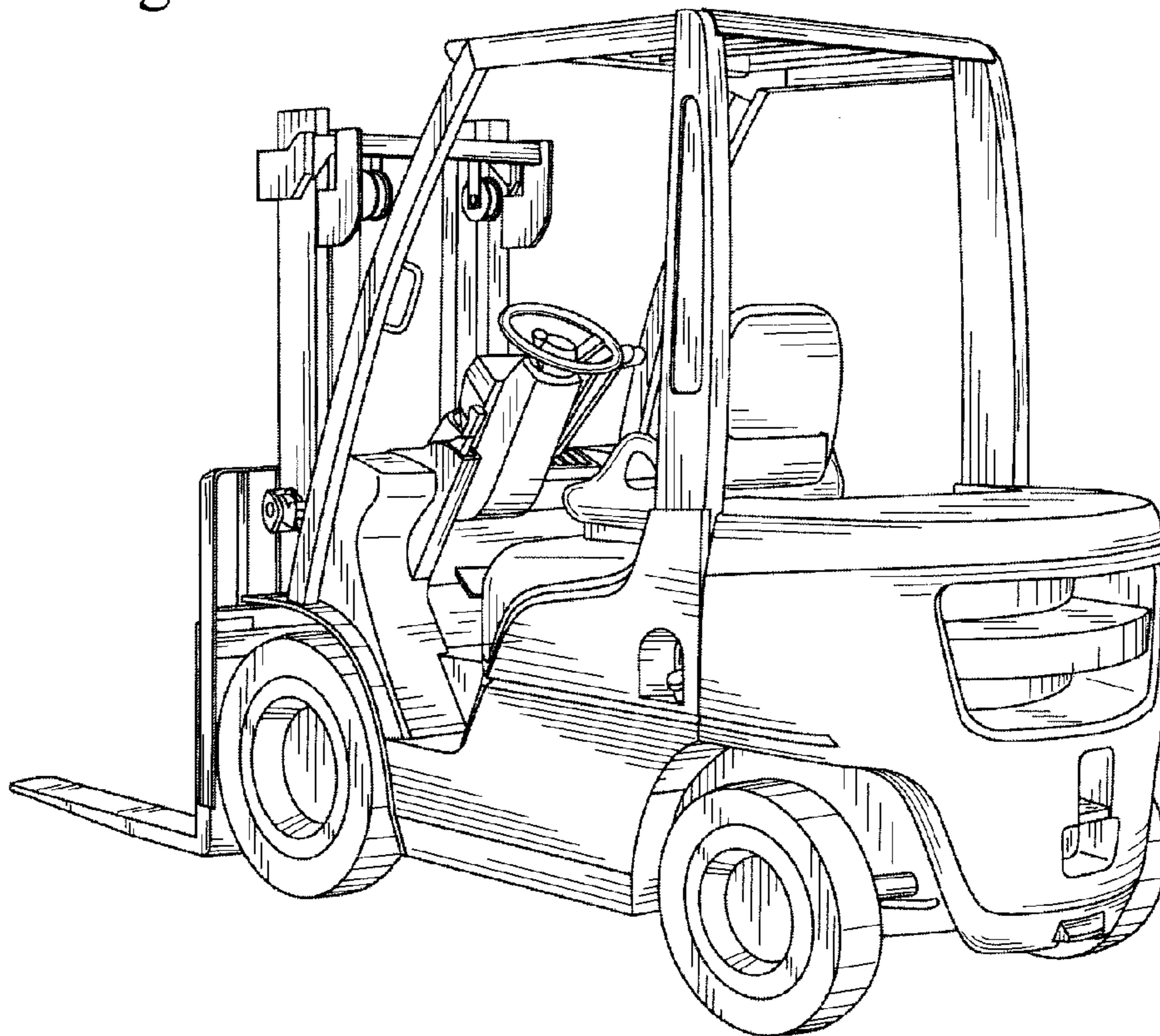

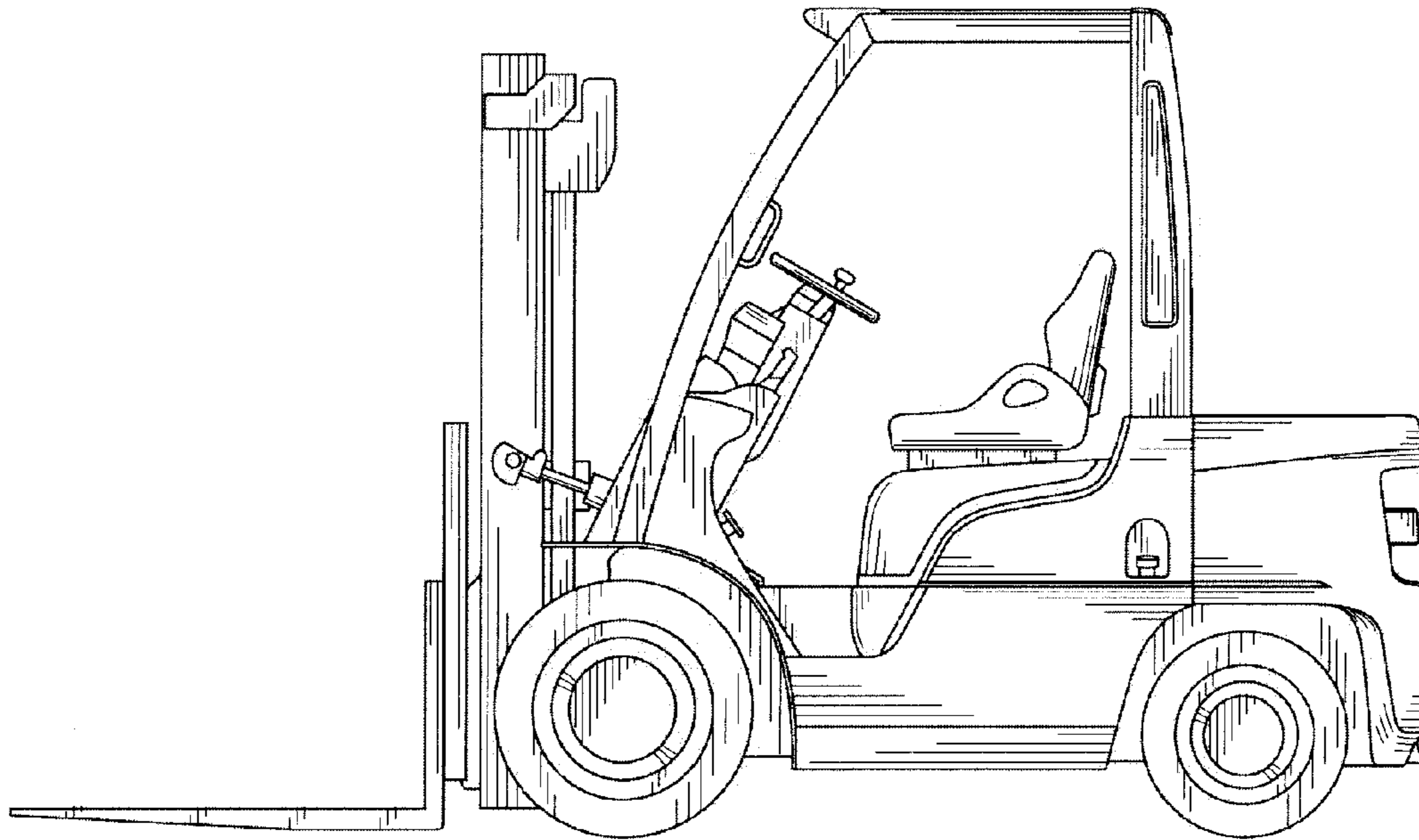

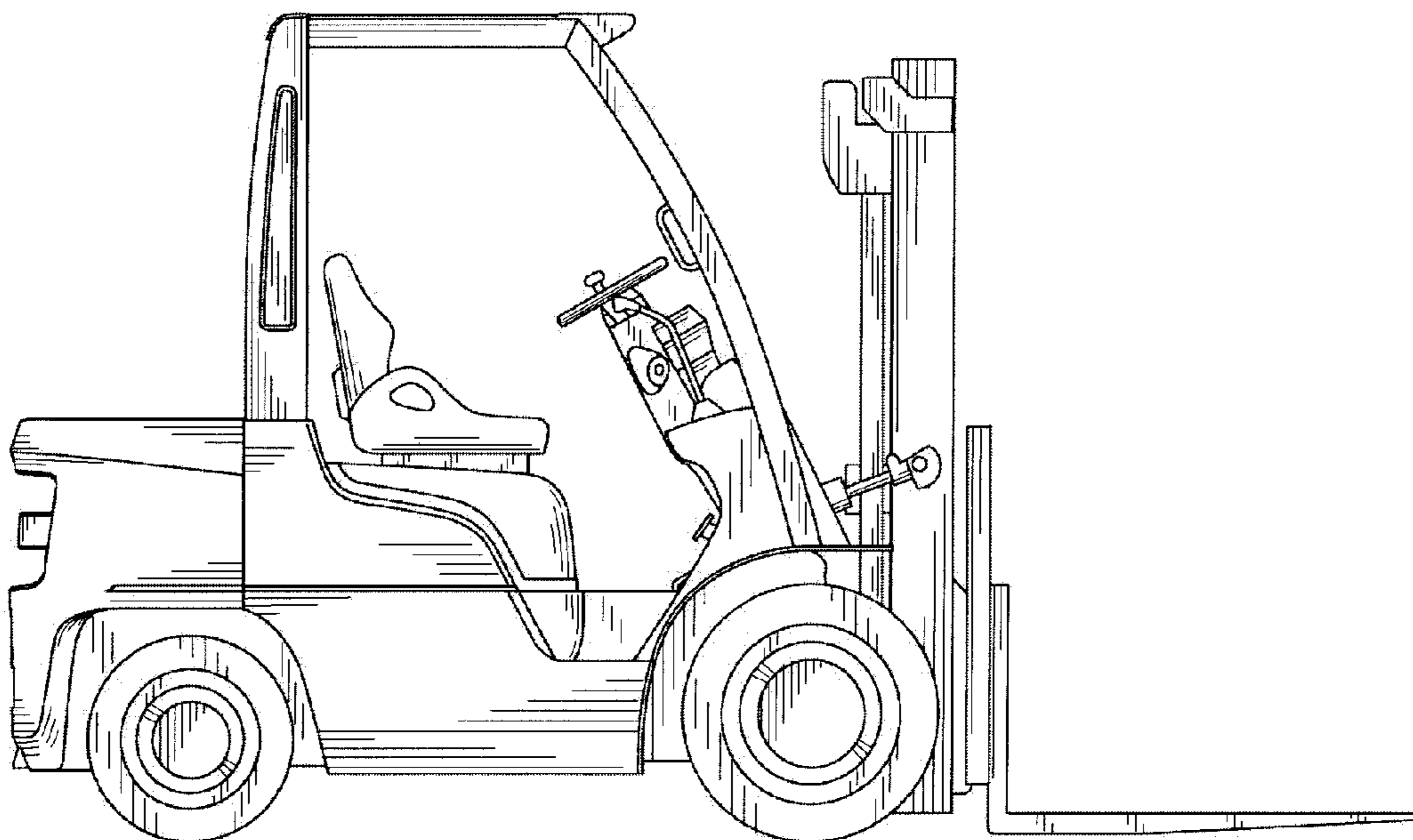

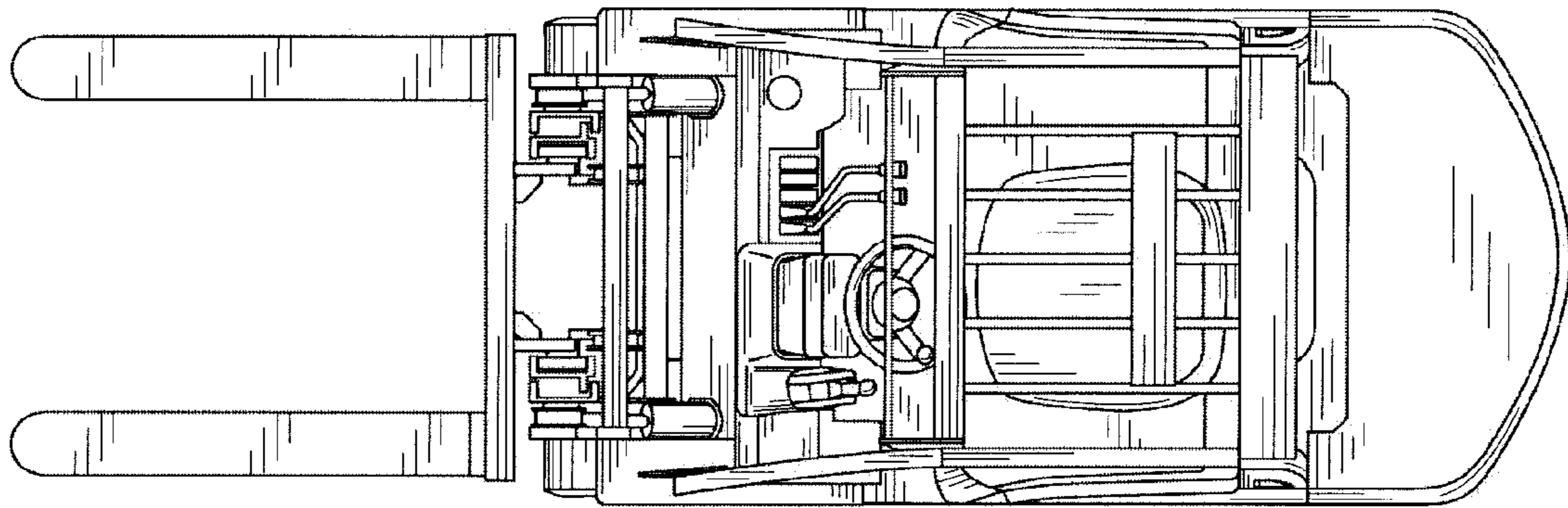

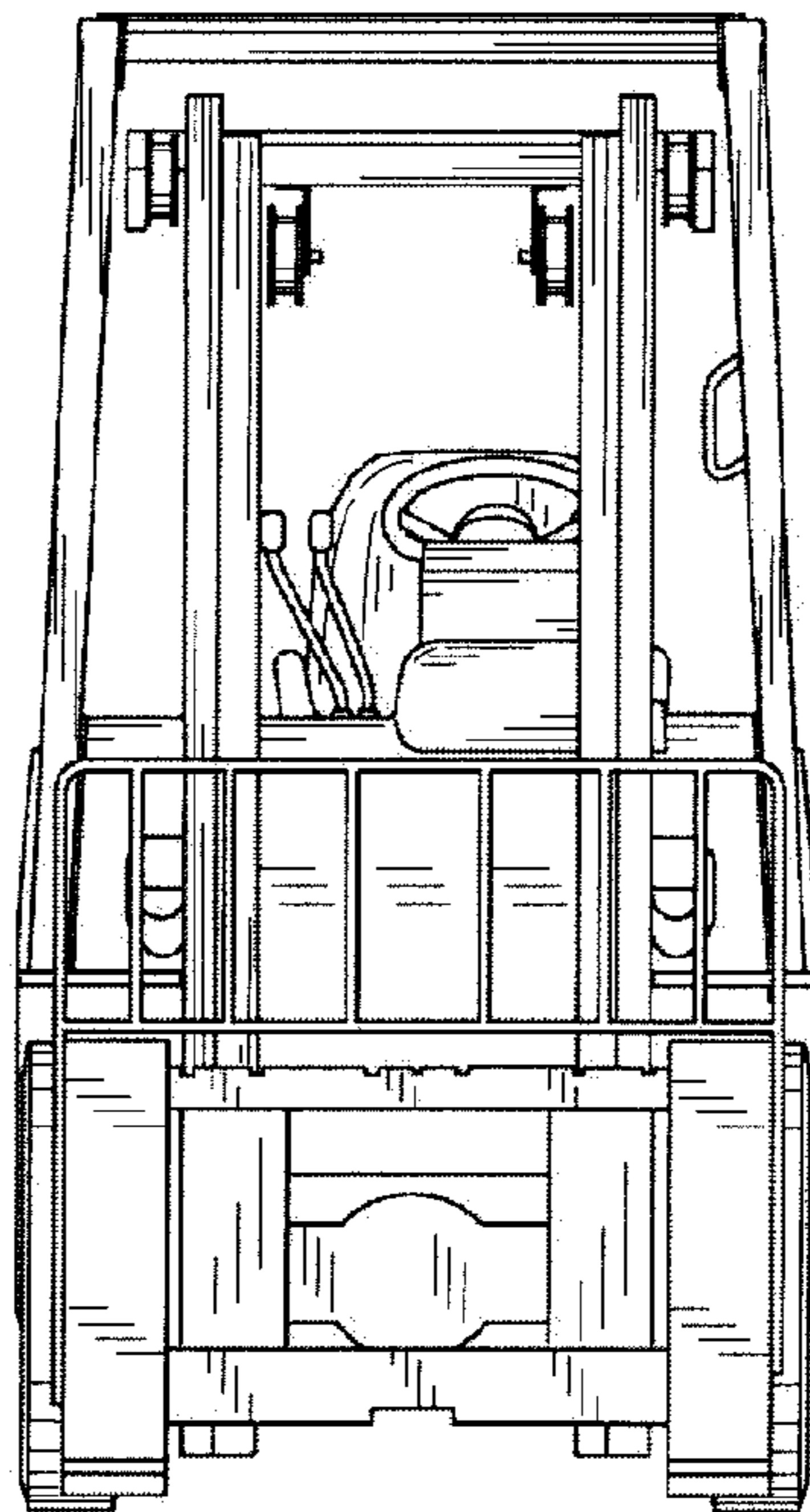
