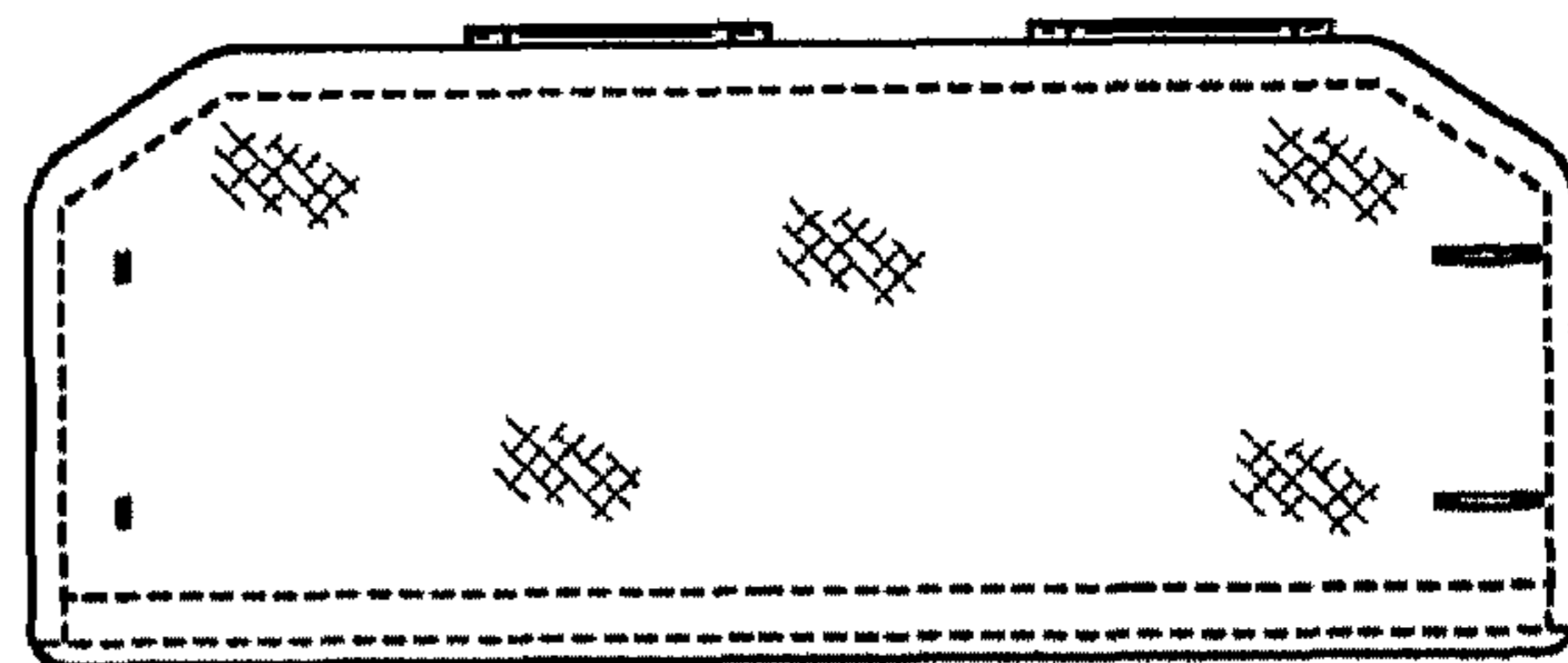
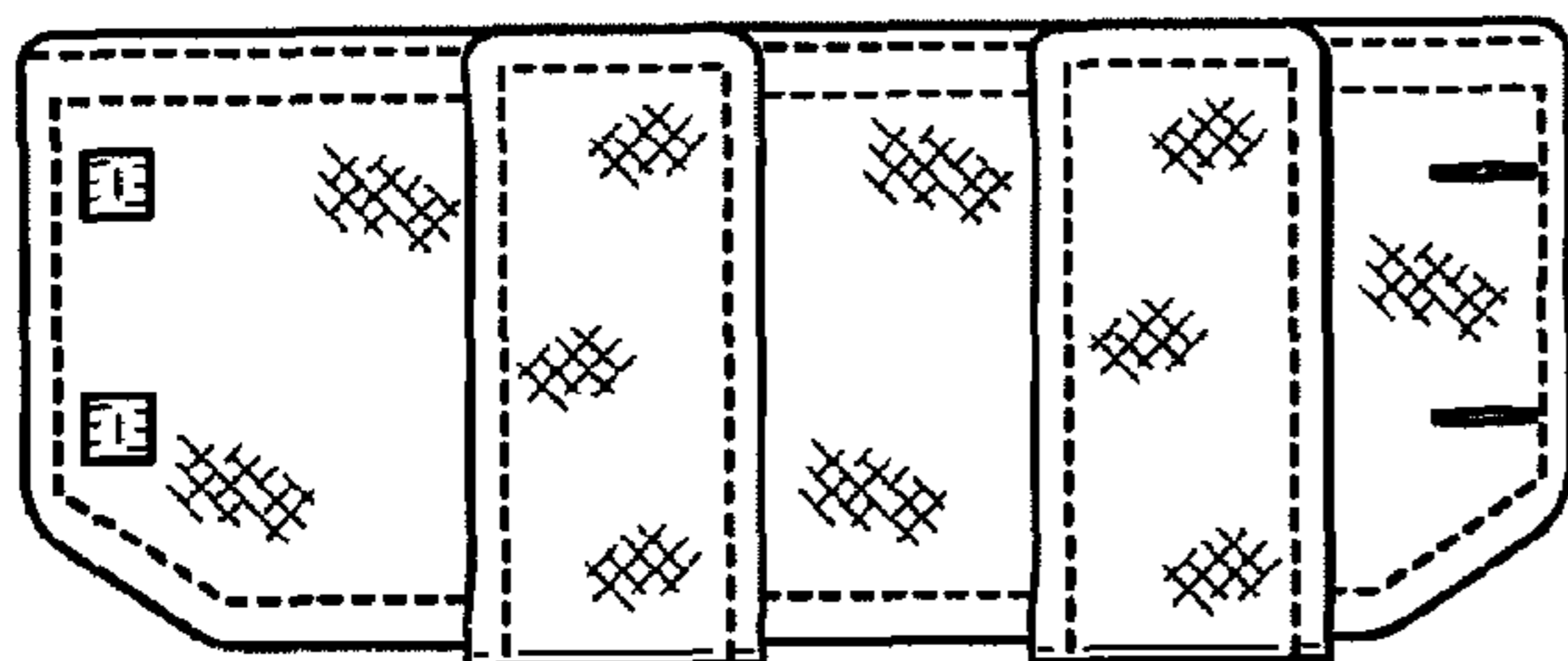
(57) **CLAIM**

The ornamental design for a cuff, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a cuff showing my new design;  
FIG. 2 is a bottom plan view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a left side elevational view thereof;  
FIG. 7 is a top perspective view thereof; and,  
FIG. 8 is a top perspective view thereof, with two flaps  
opened.  
The dotted lines in FIGS. 1, 2, 7 and 8 show sewing stitches.

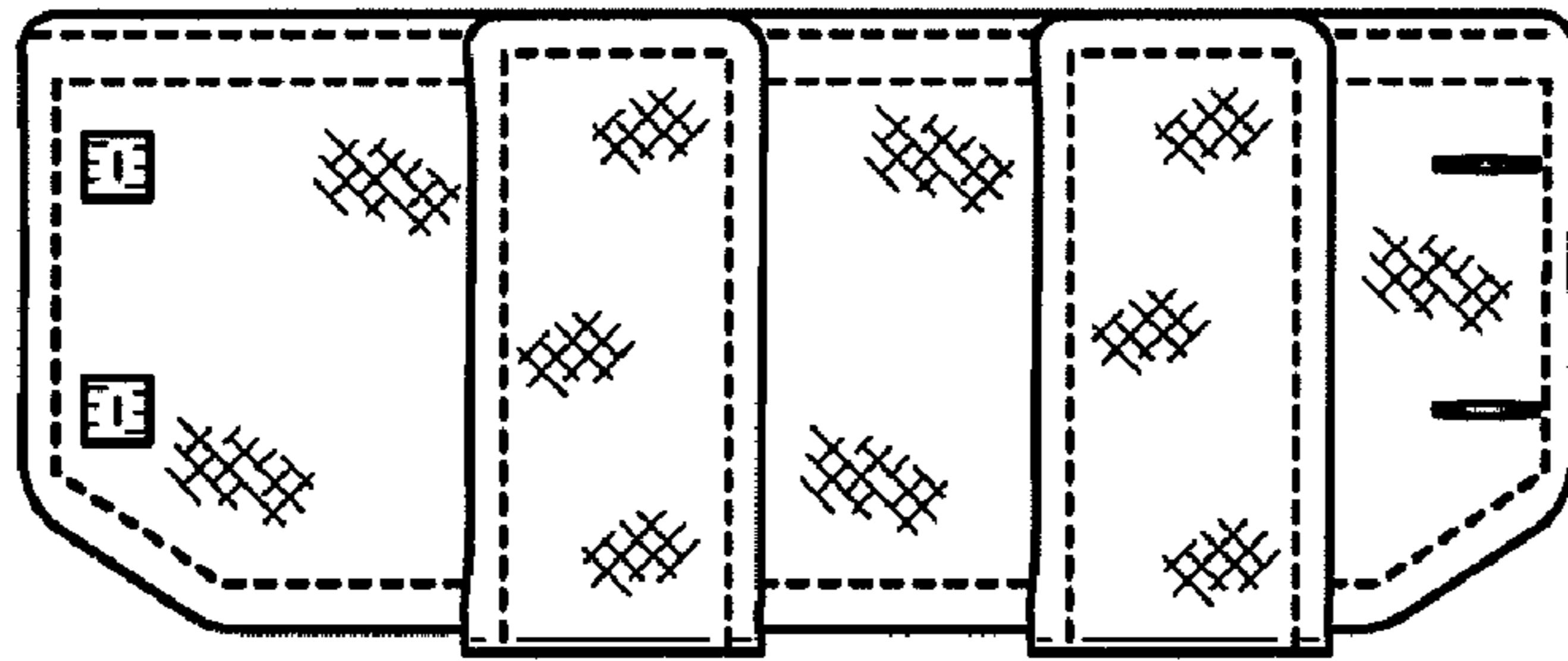

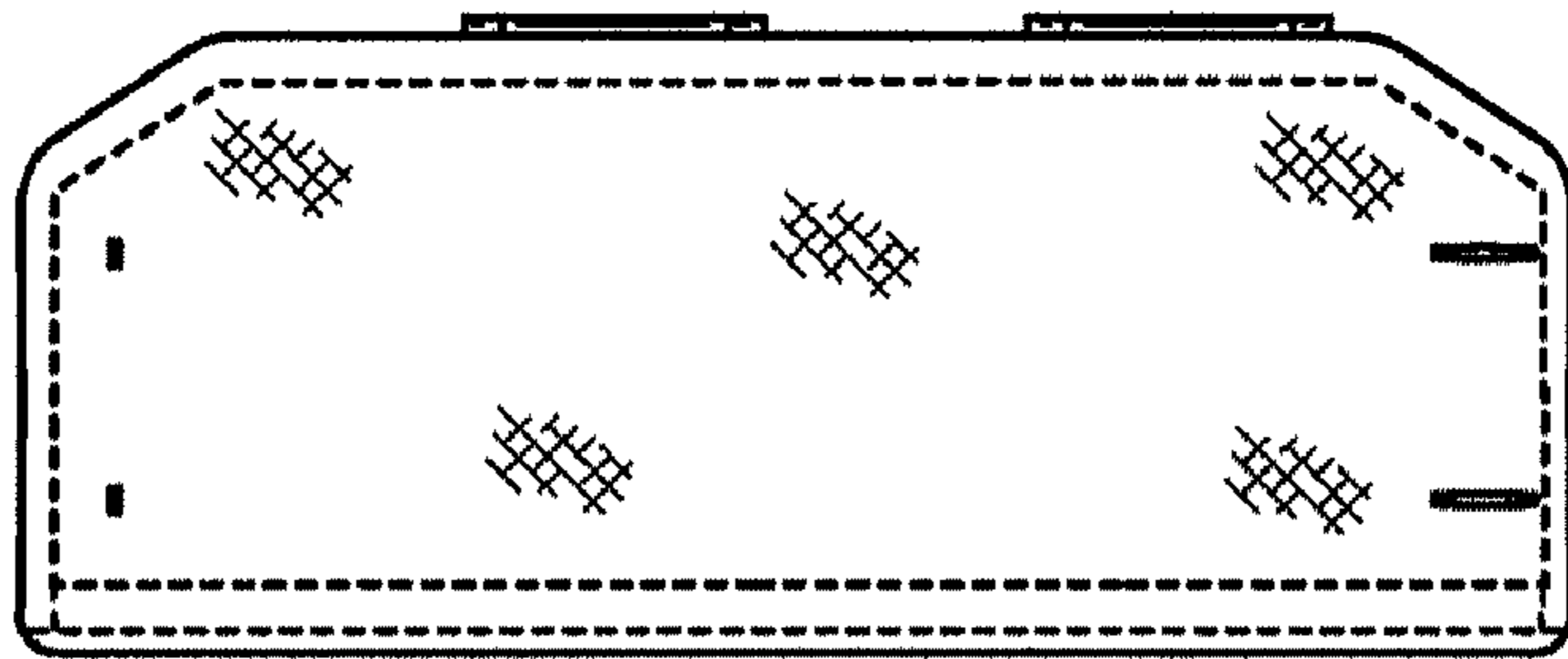

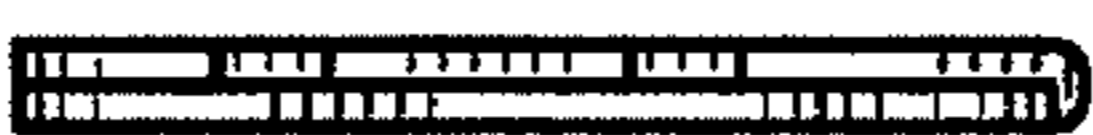

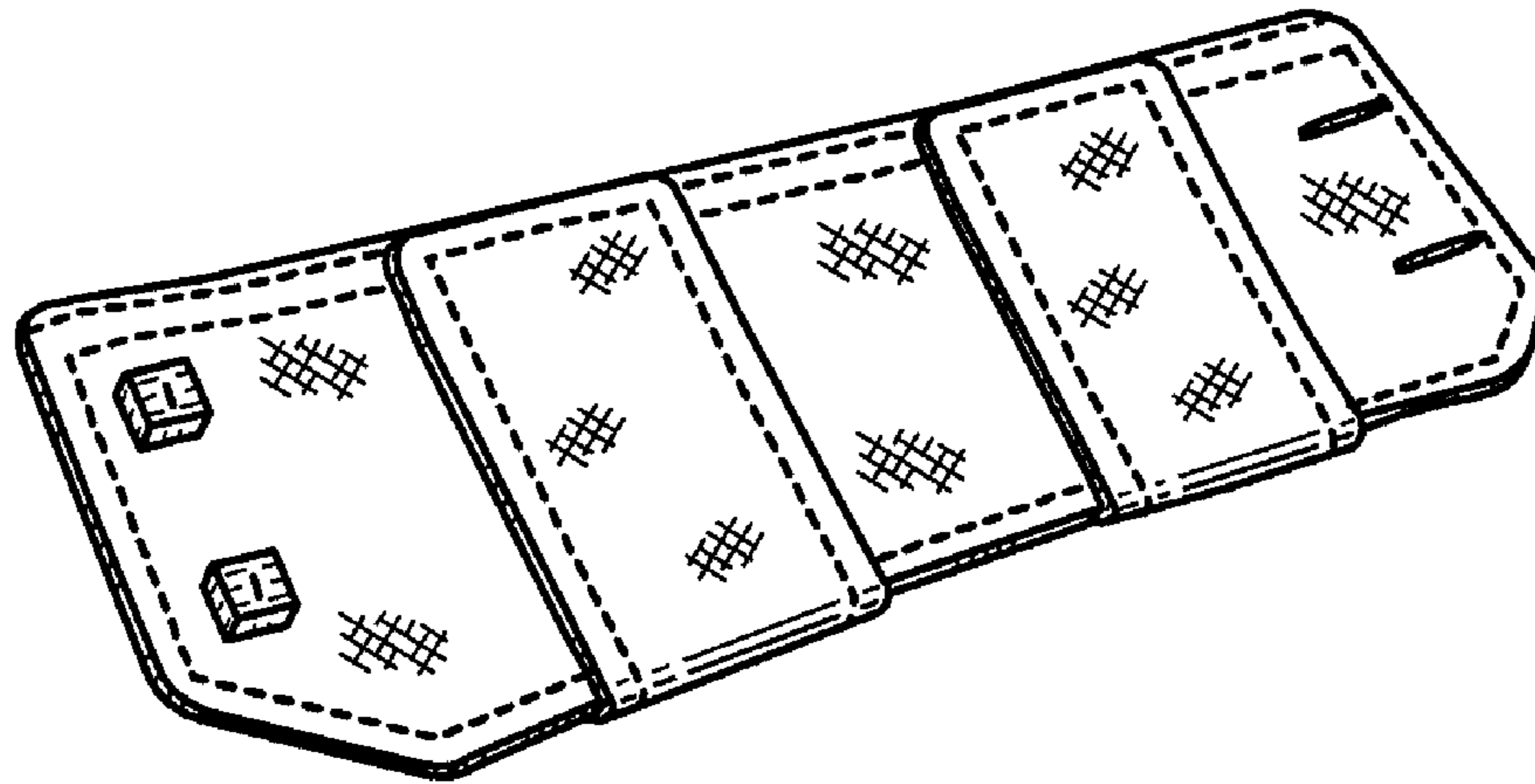

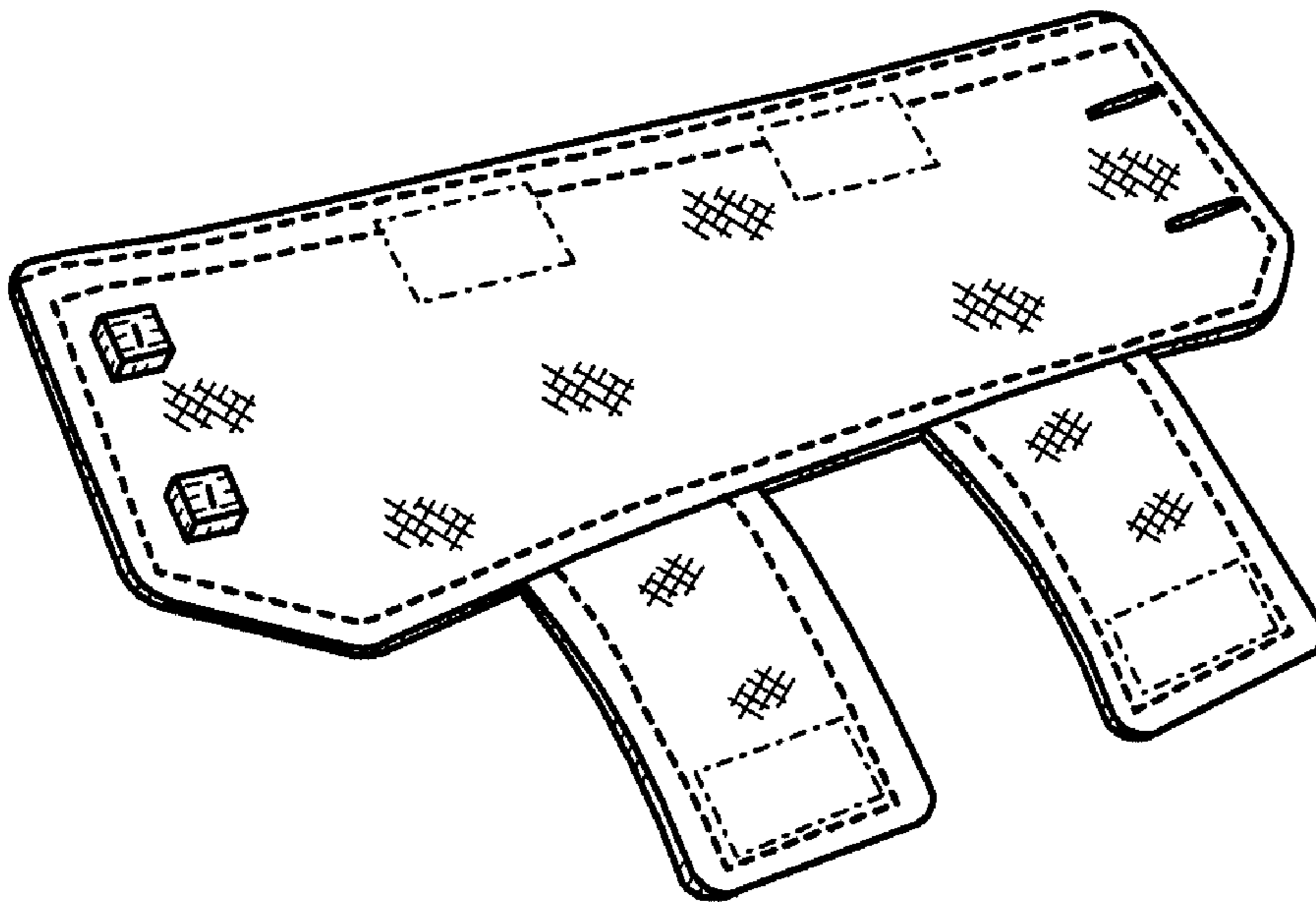
